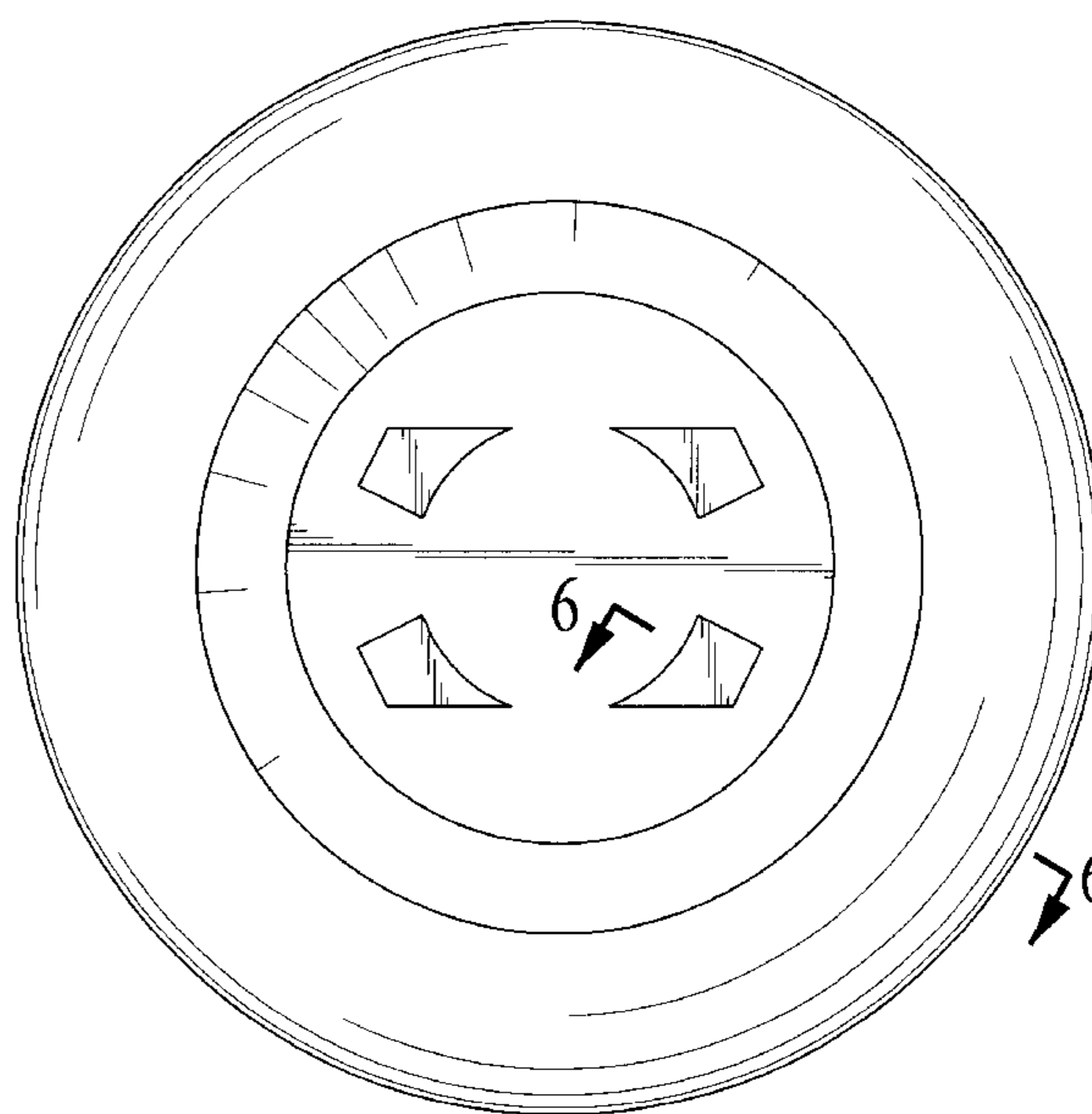
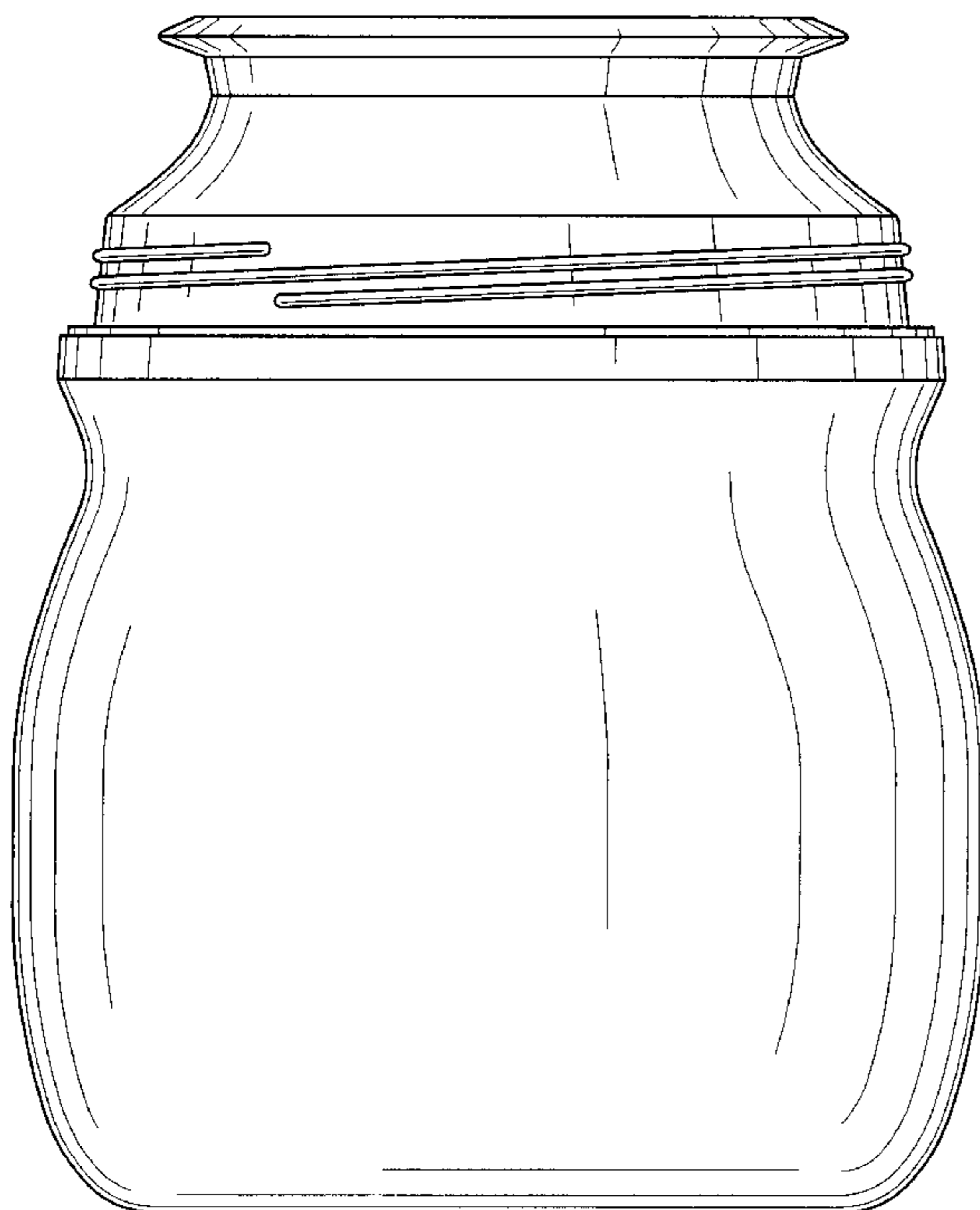
(57) **CLAIM**

The ornamental design for a jar, as shown and described.

DESCRIPTION

FIG. 1 is a side view of the jar of the invention;
FIG. 2 is a reversed side view of the jar illustrated in FIG. 1;
FIG. 3 is a top view of the jar illustrated in FIG. 1;
FIG. 4 is a bottom view of the jar illustrated in FIG. 1;
FIG. 5 is a cross-sectional detail view of the jar illustrated in FIG. 3, taken along line 5—5, shown at an enlarged scale; and,
FIG. 6 is a cross-sectional detail view of the jar illustrated in FIG. 4, taken along line 6—6, shown at an enlarged scale.

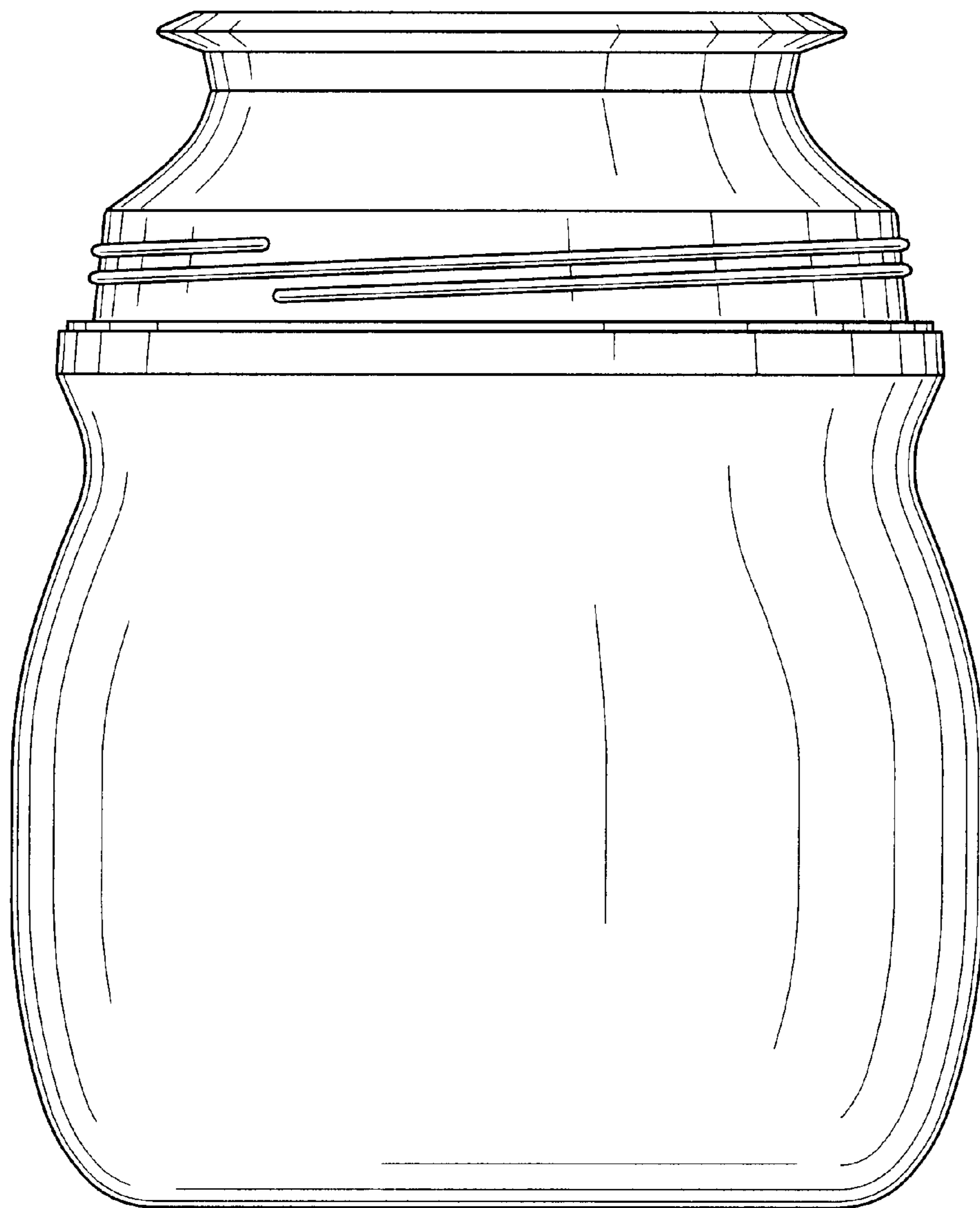

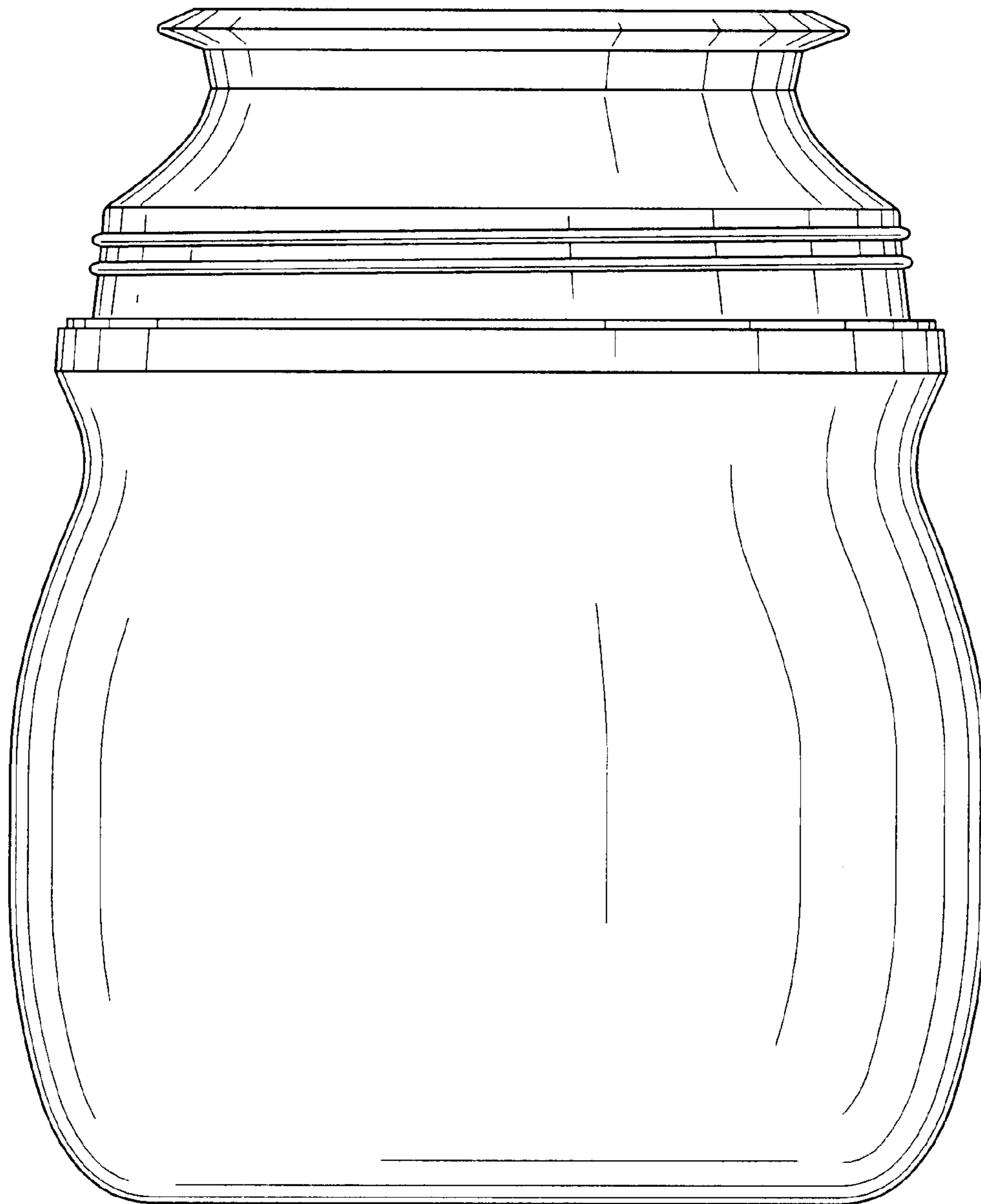
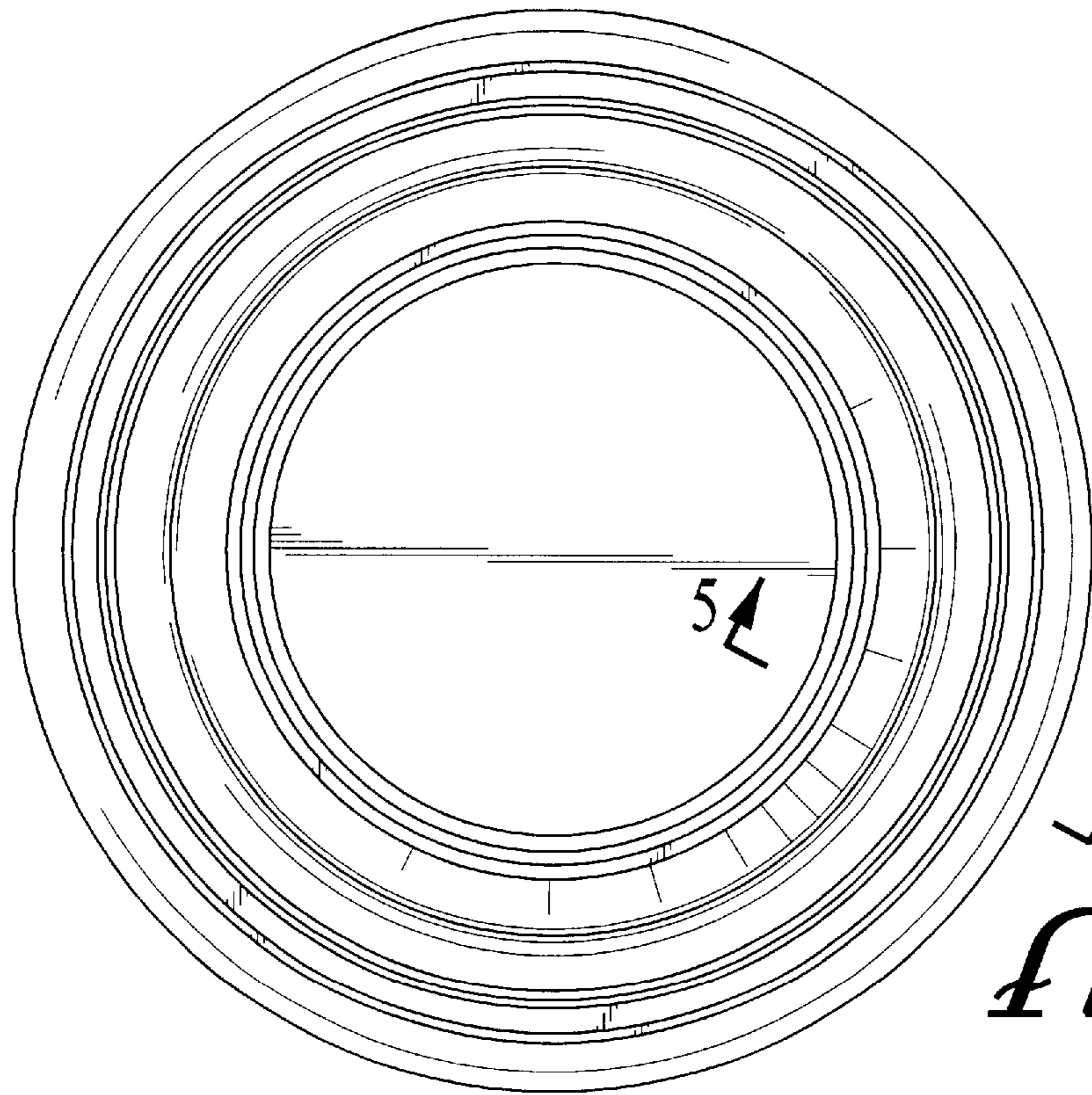
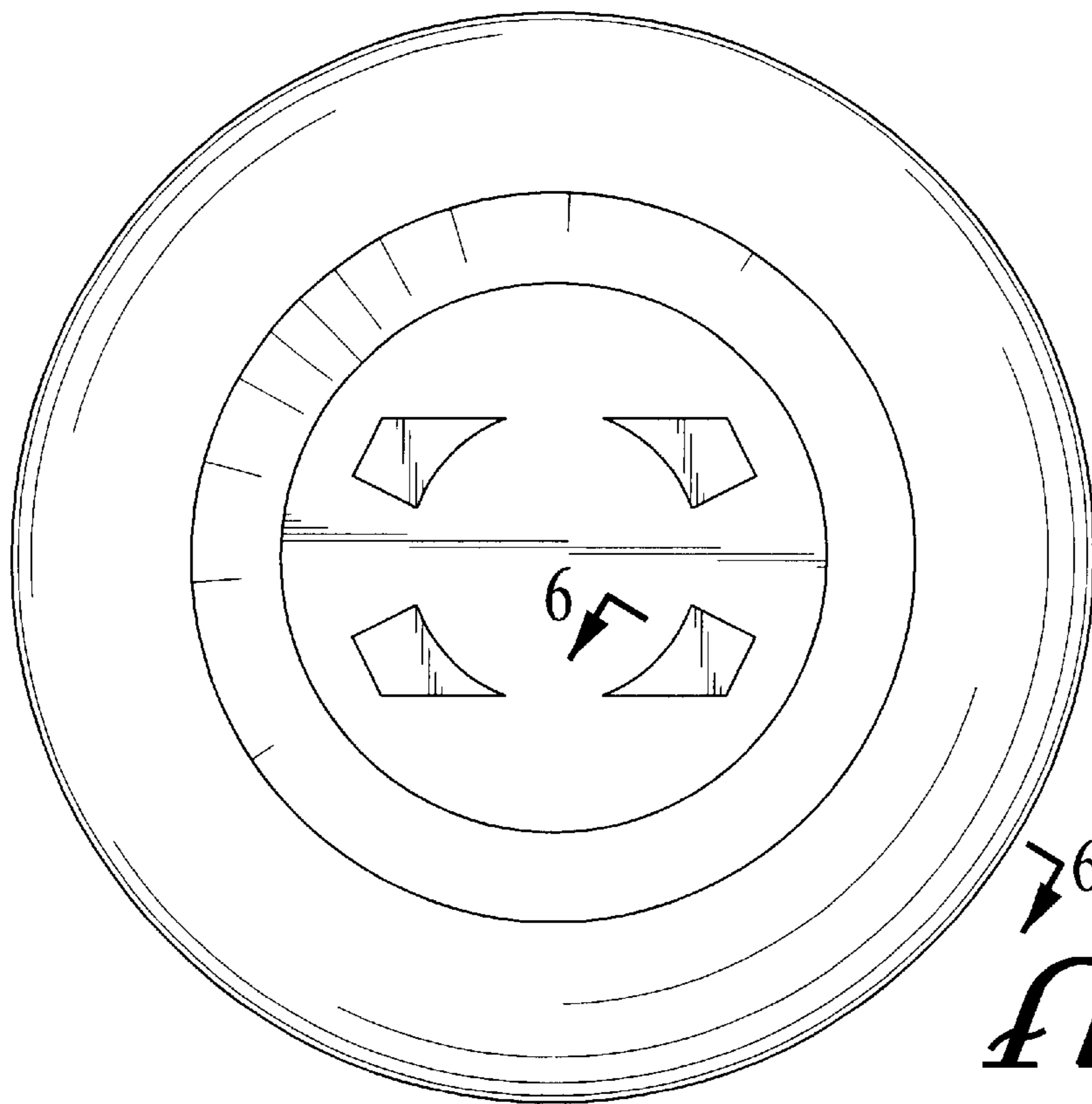

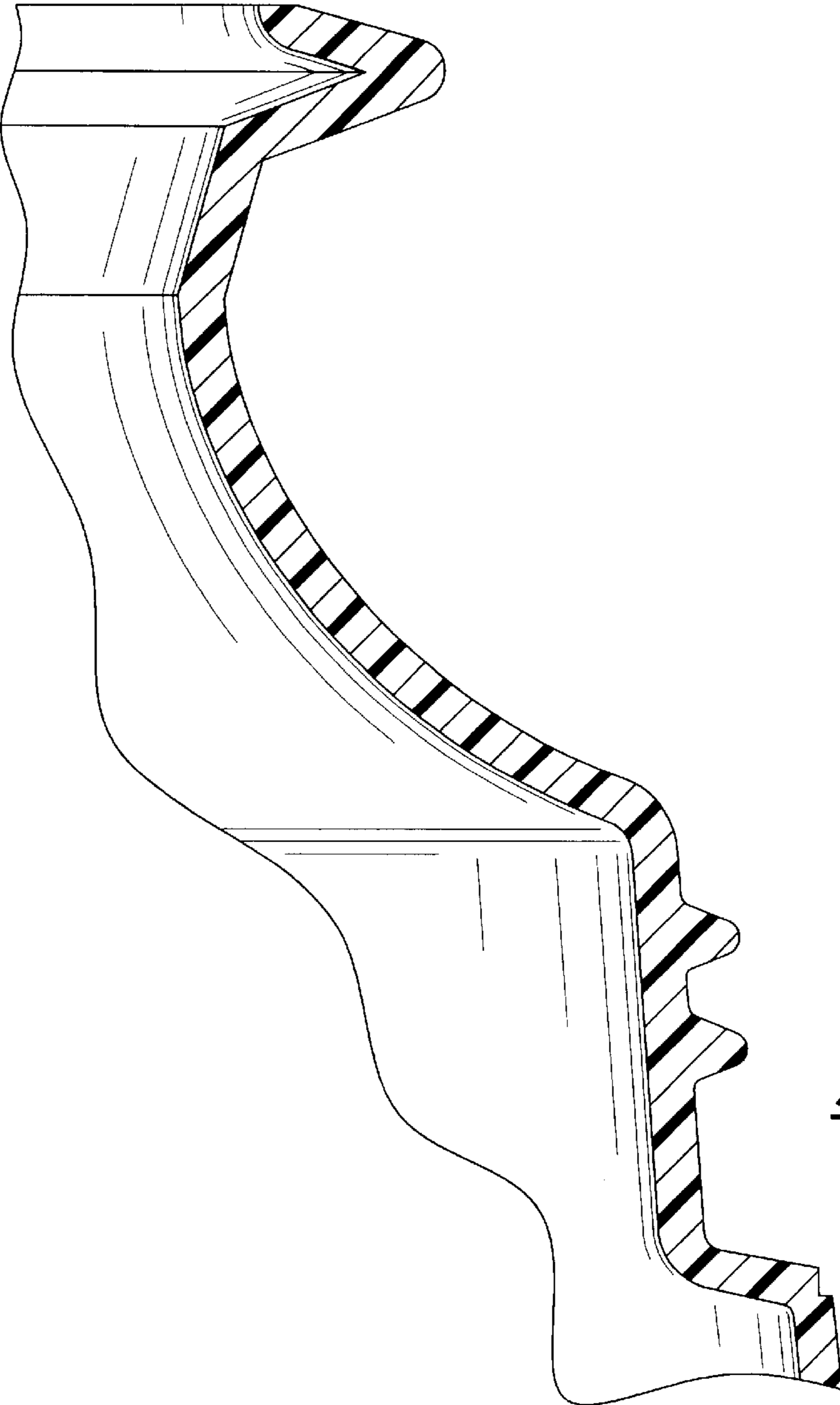

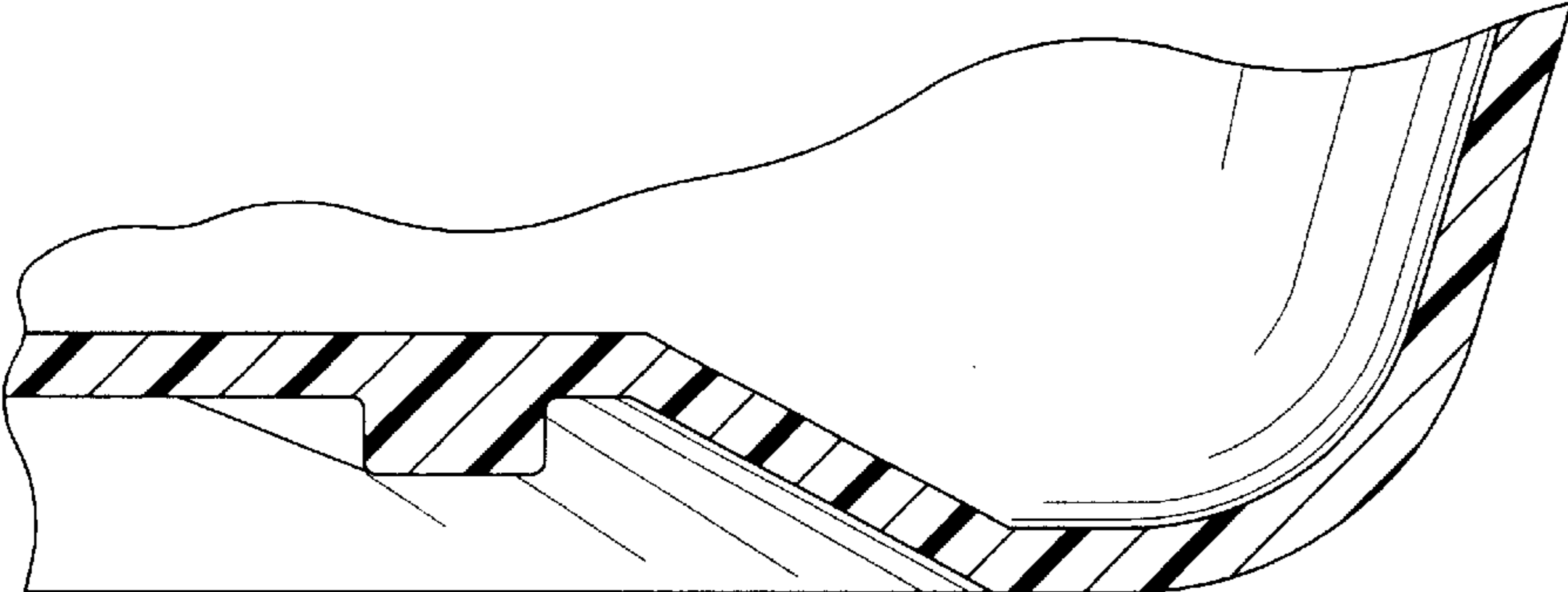
