**DESCRIPTION**

FIG. 1 is a perspective view from the front-top-right side of the battery charger showing our new design;

FIG. 4 is a left side view of the design shown in FIG. 1;

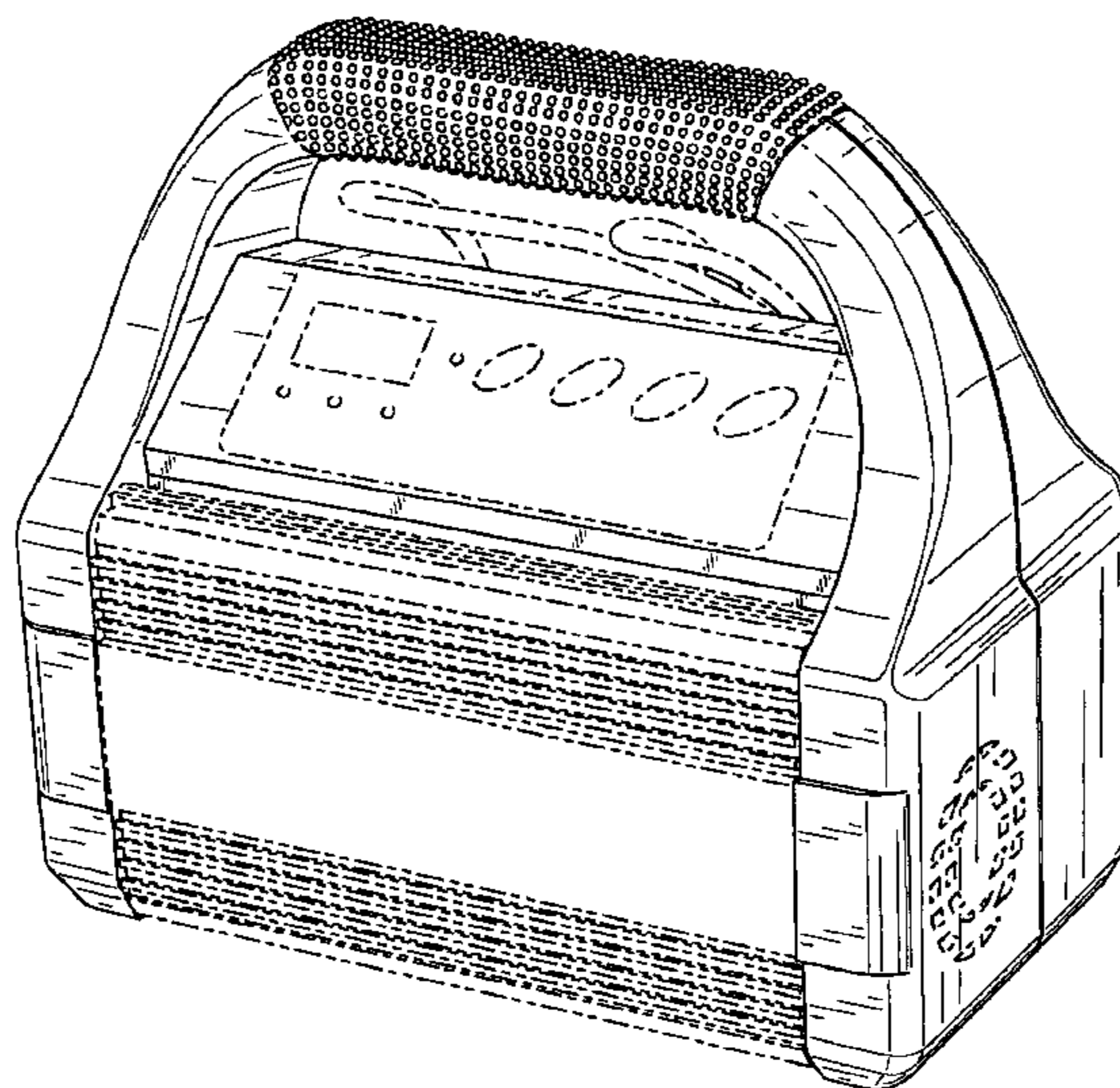
FIG. 5 is a right side view of the design shown in FIG. 1;

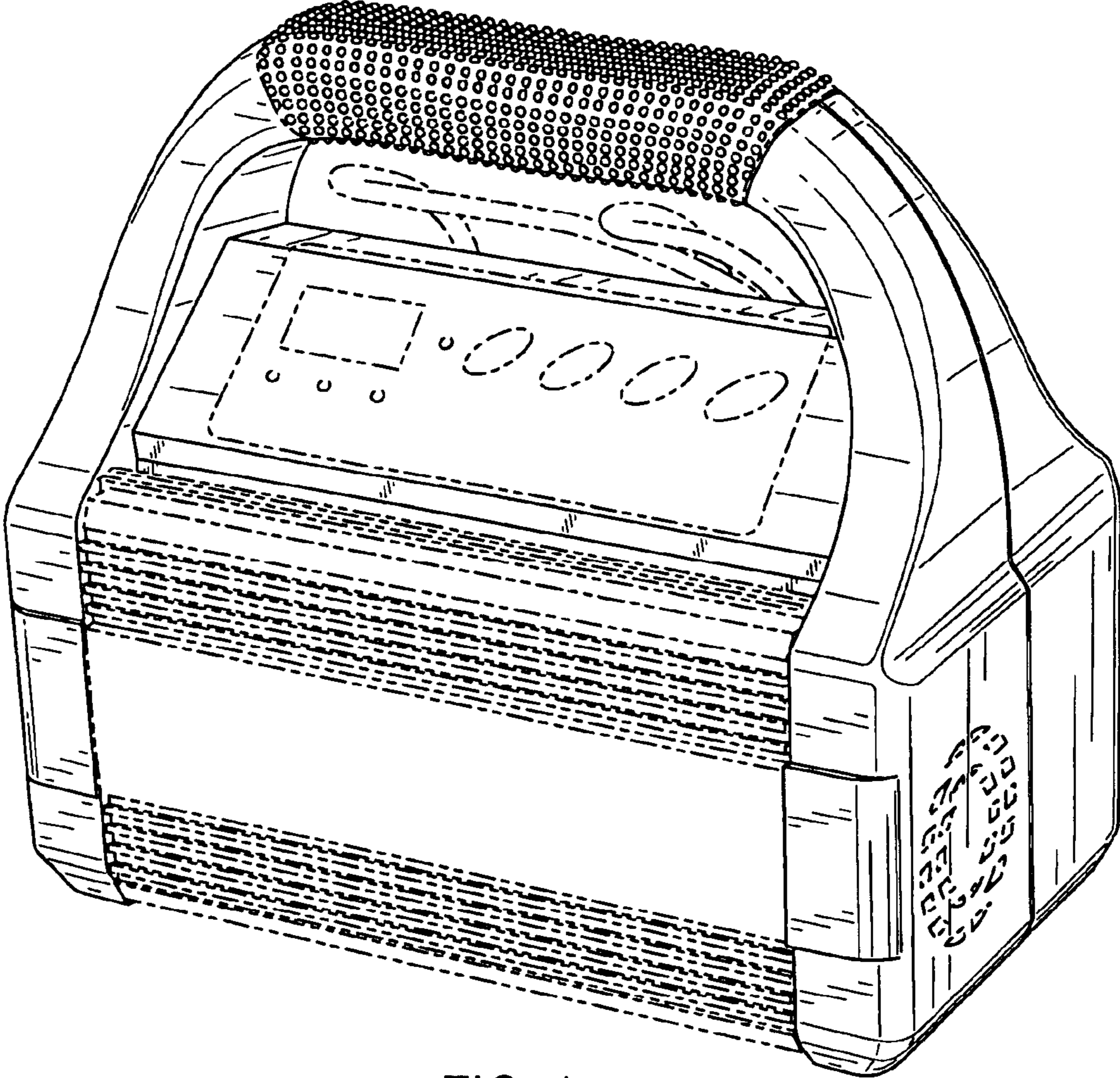

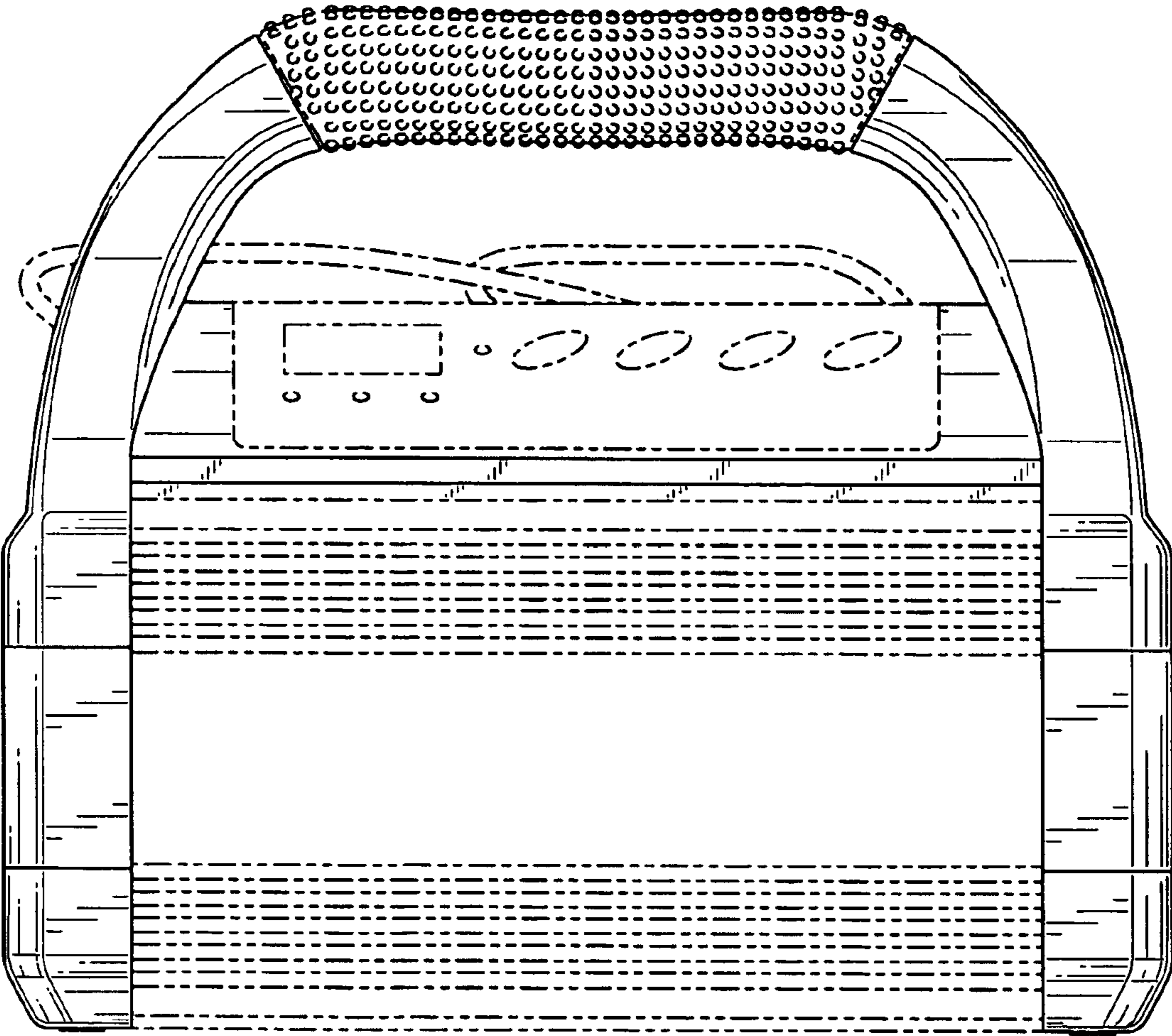

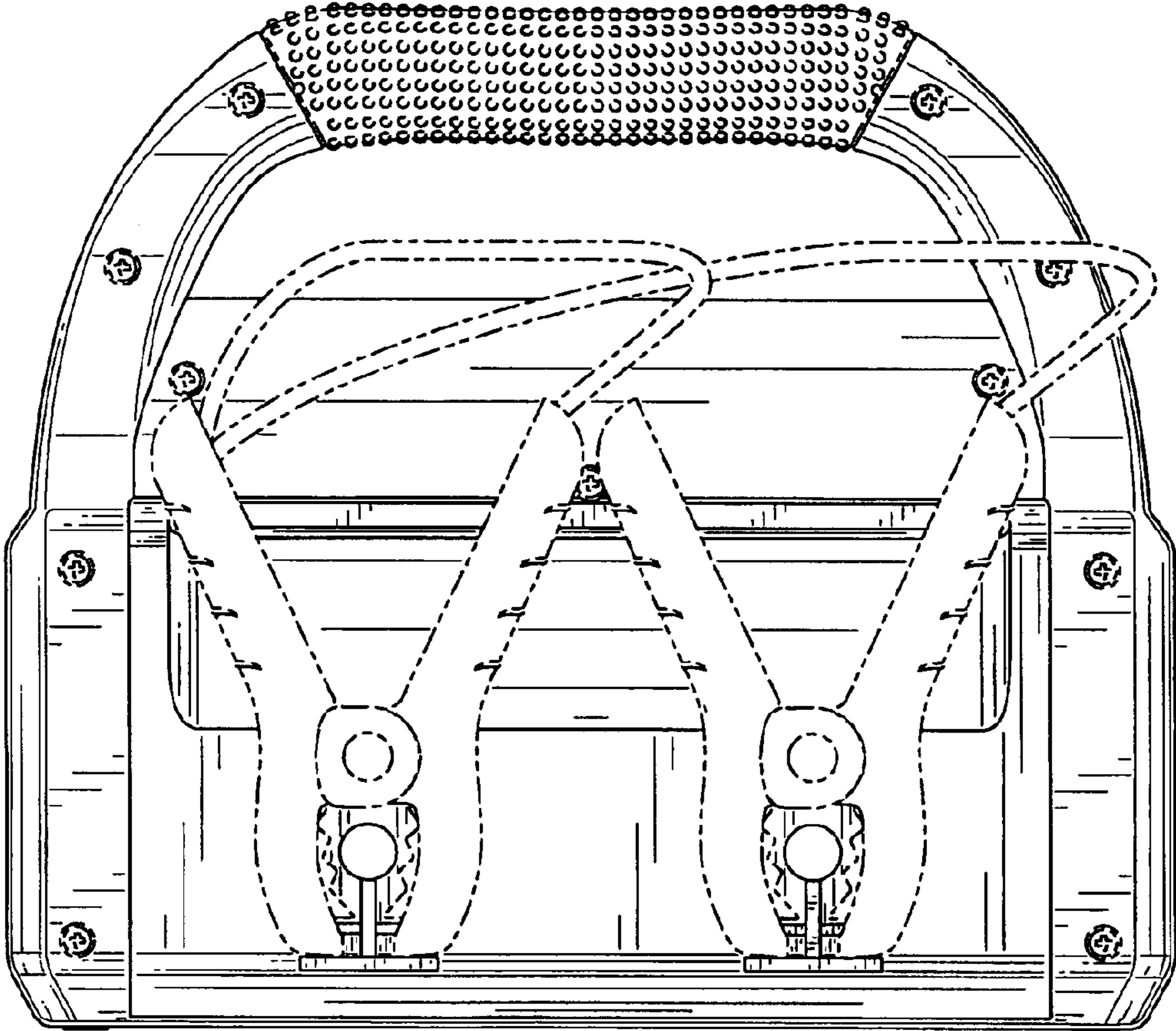

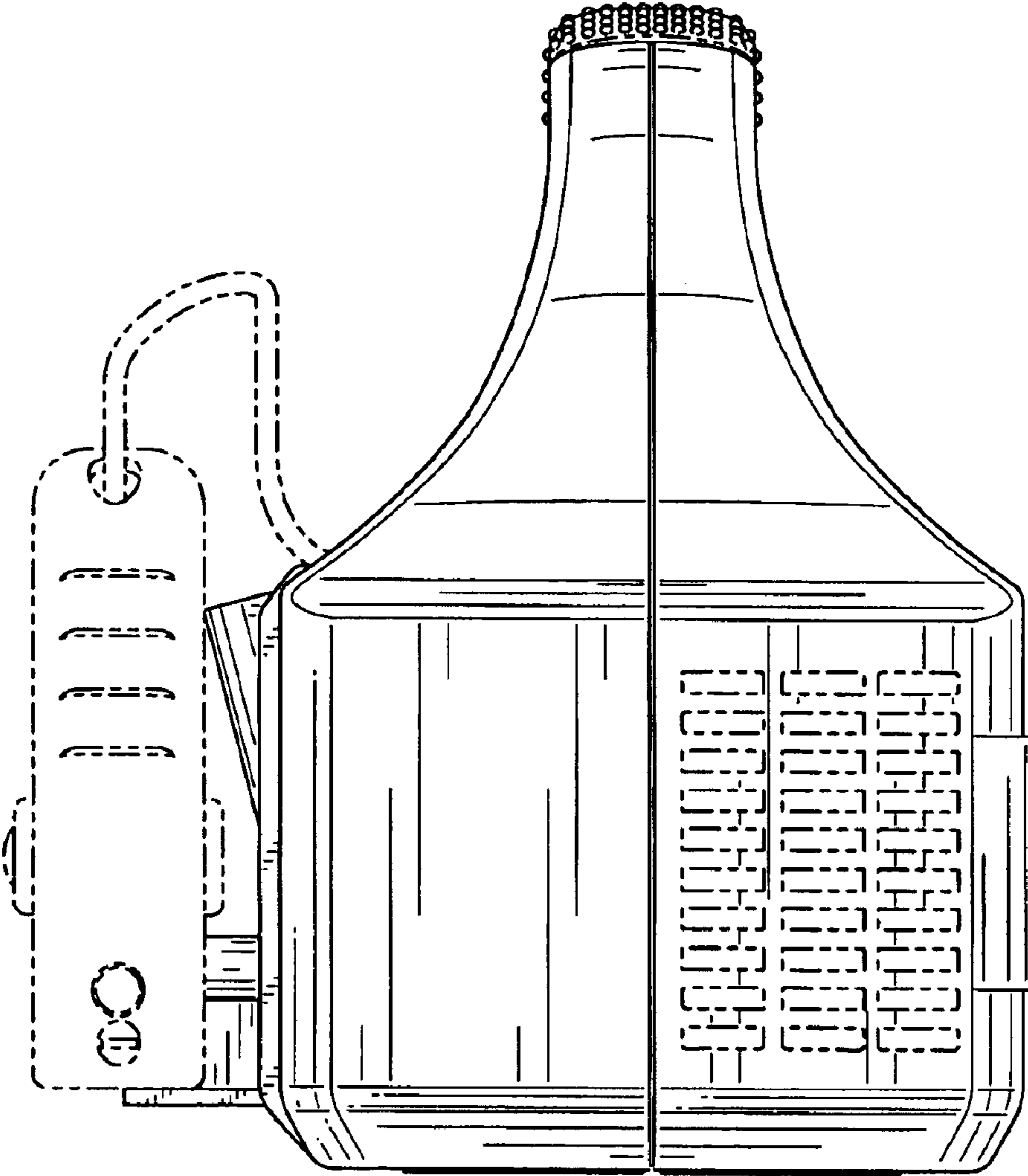

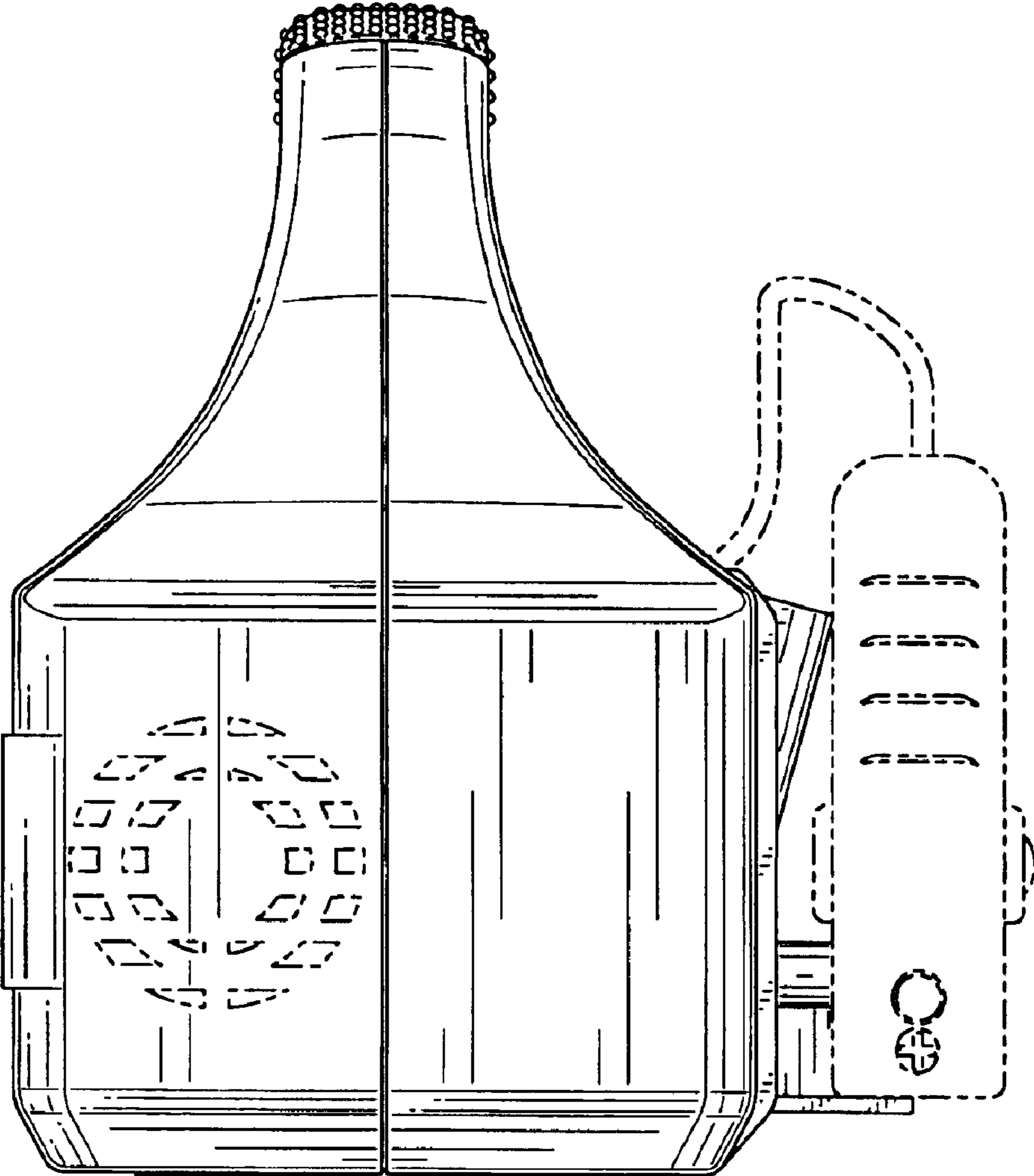

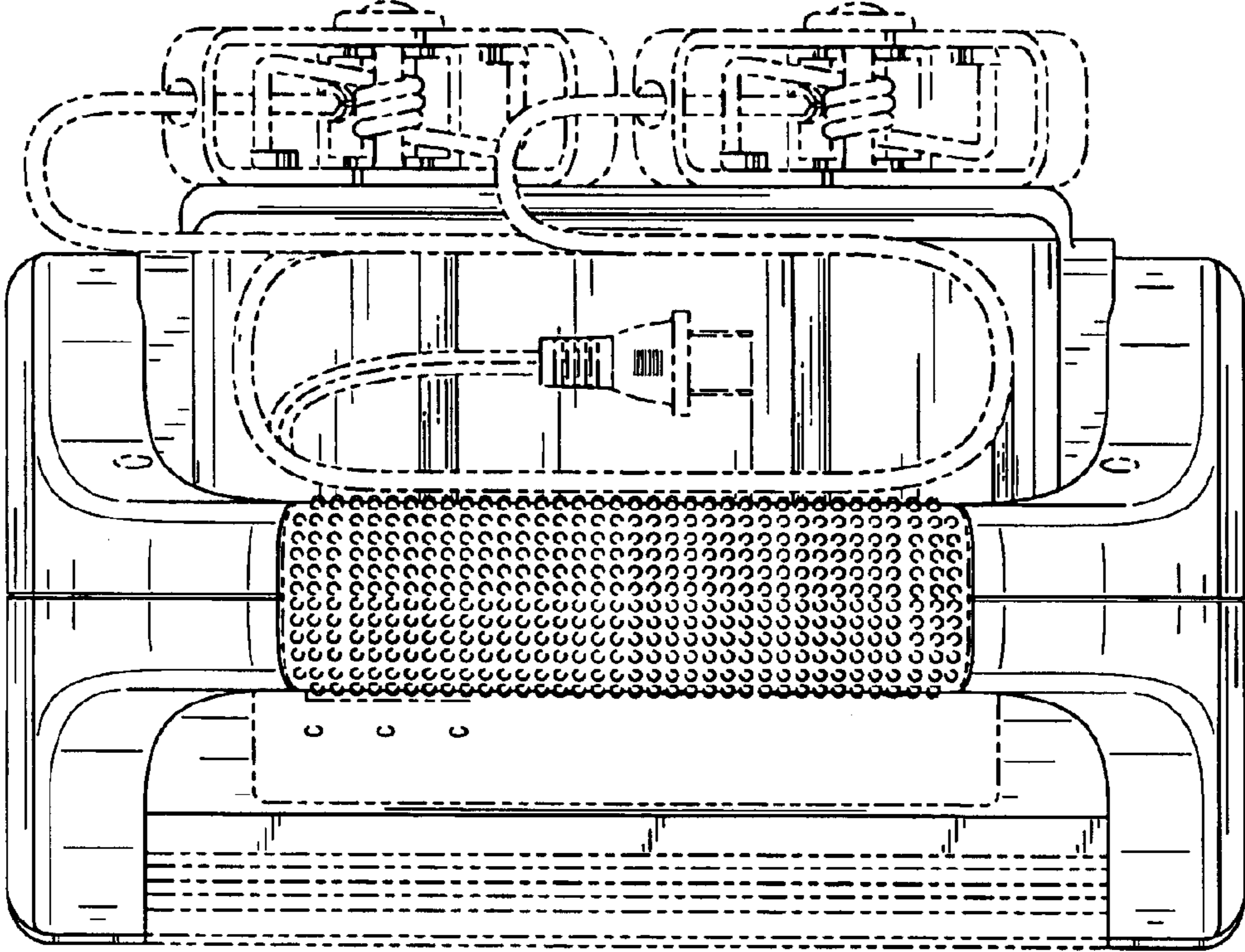

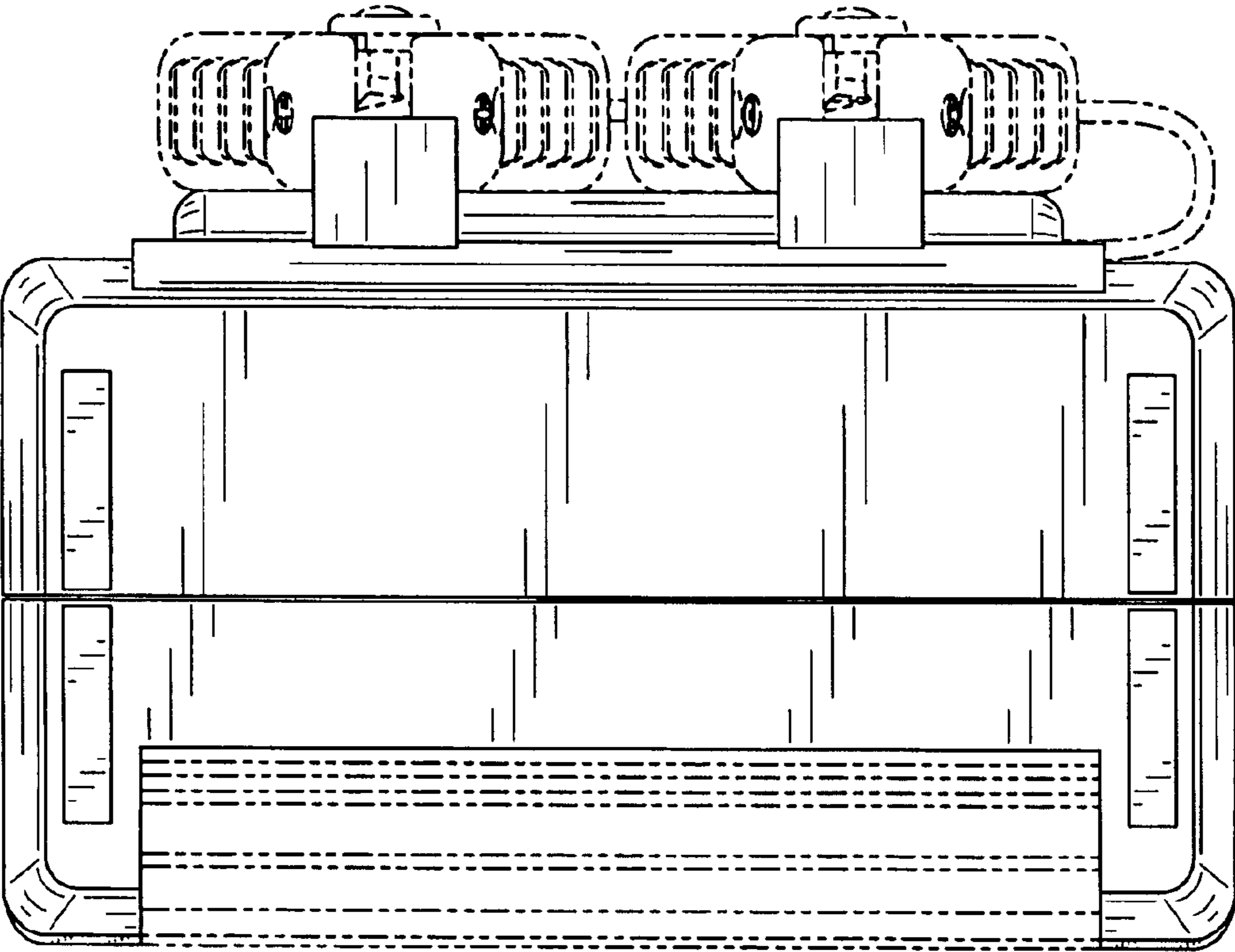
