**DESCRIPTION**

FIG. 1 is a perspective view of a disc player showing my new design;

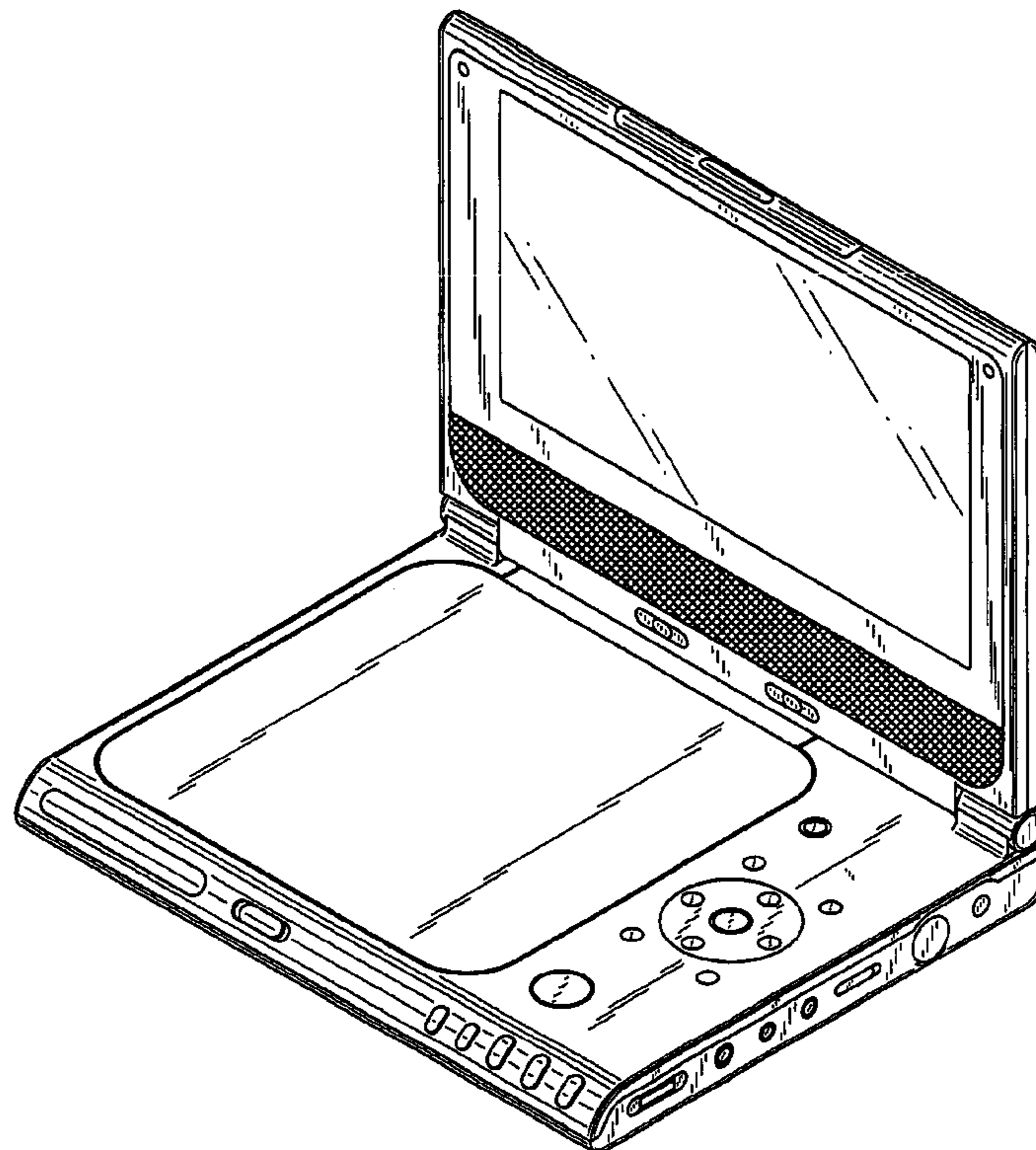

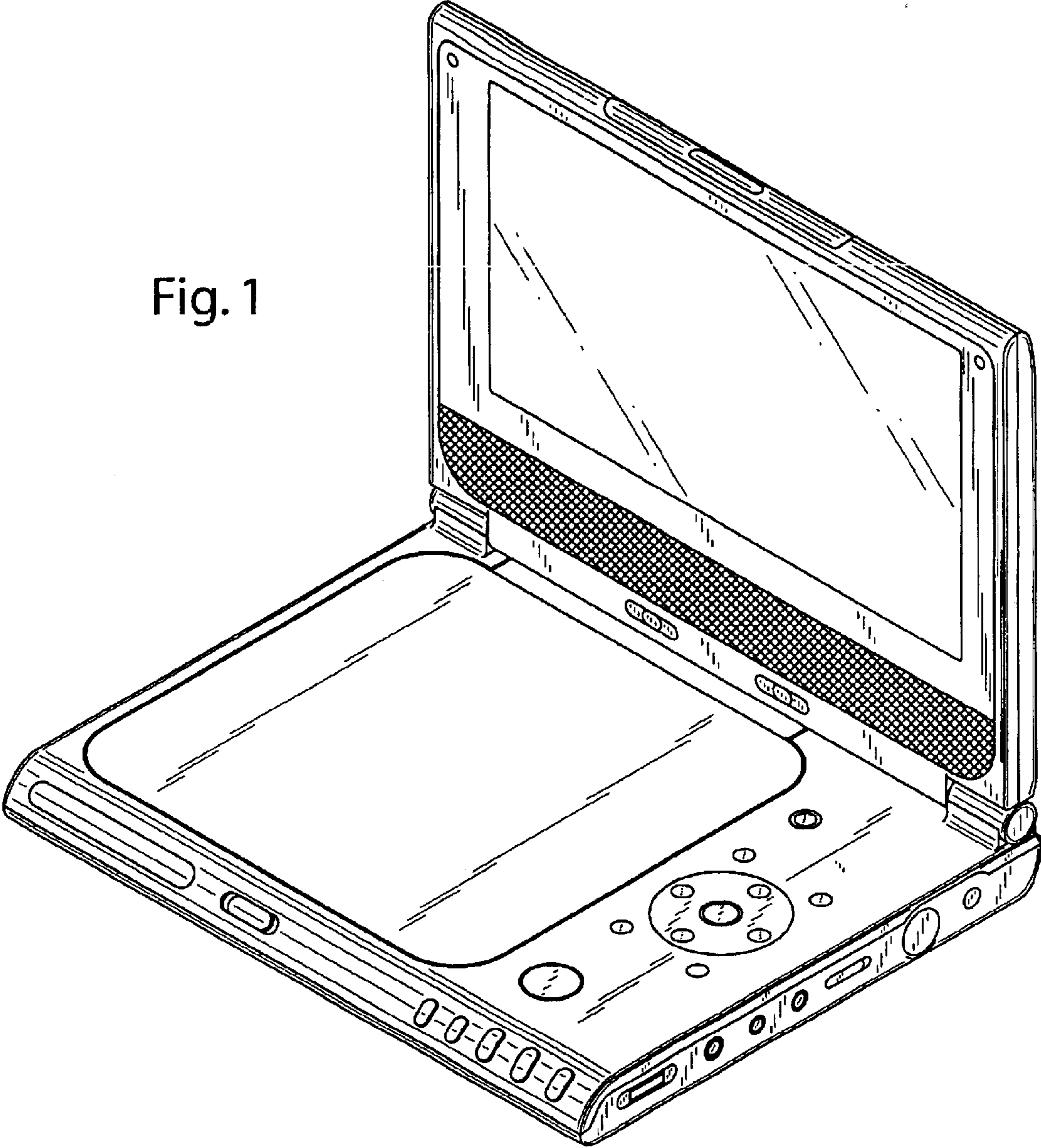

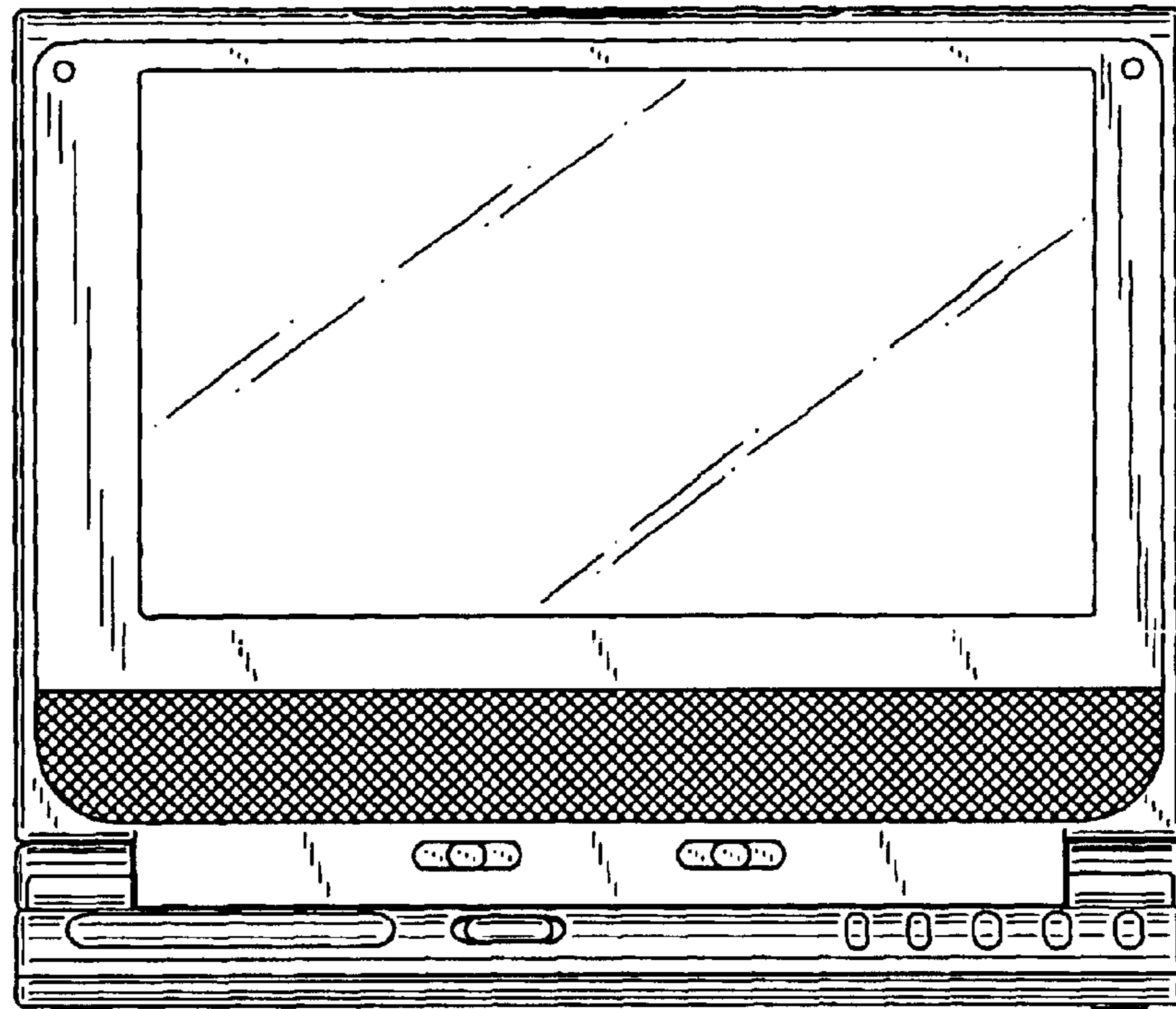

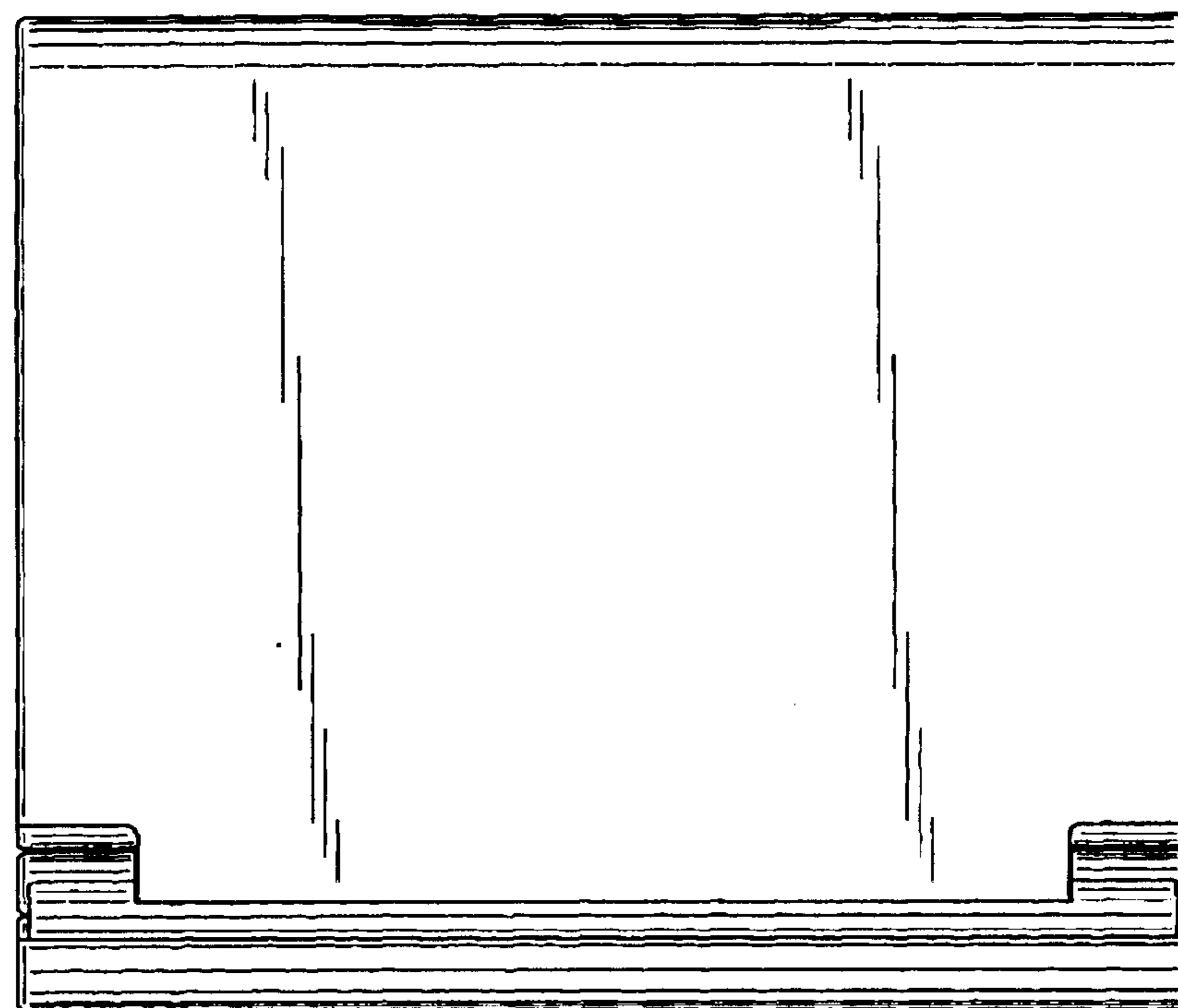

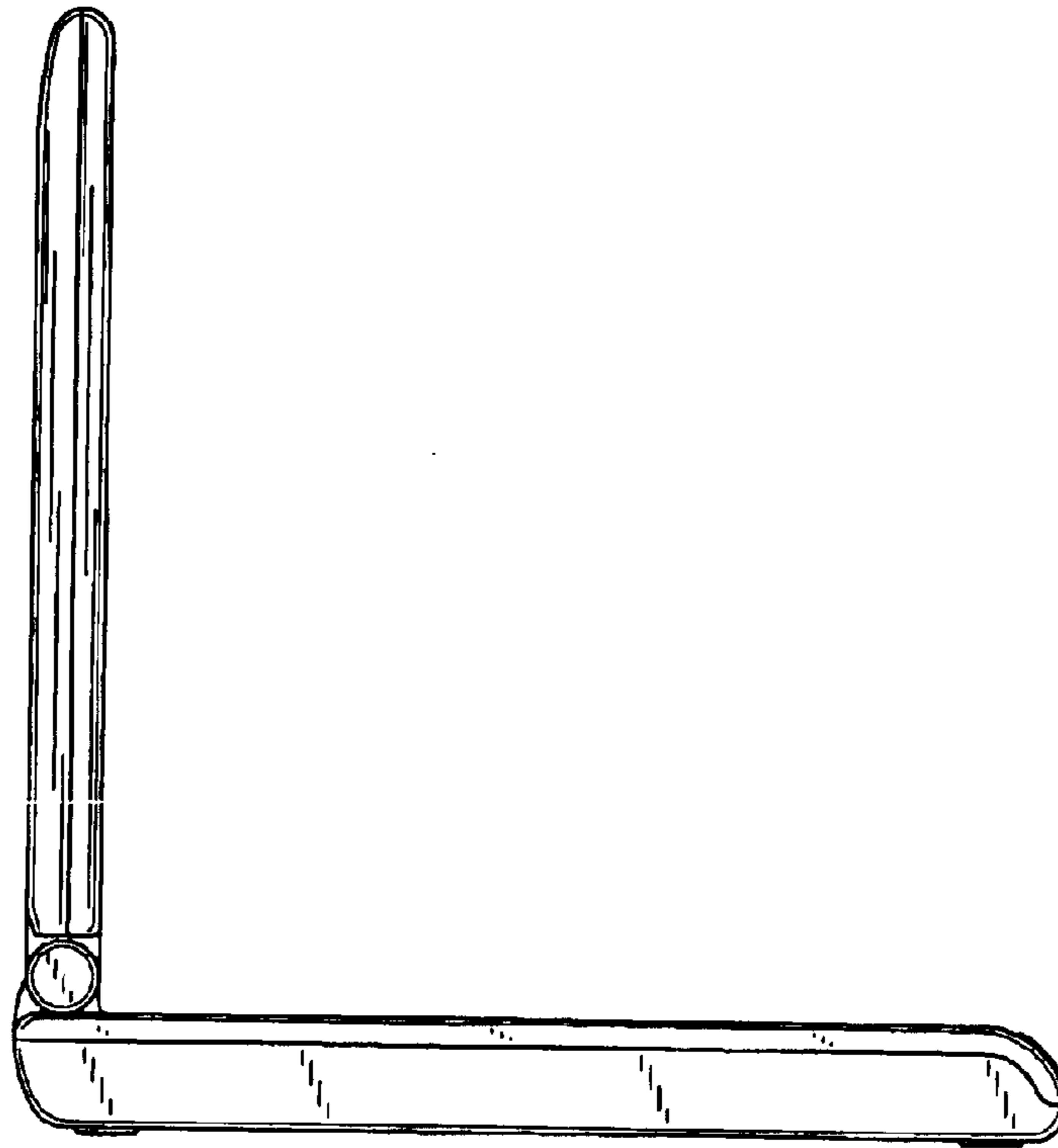

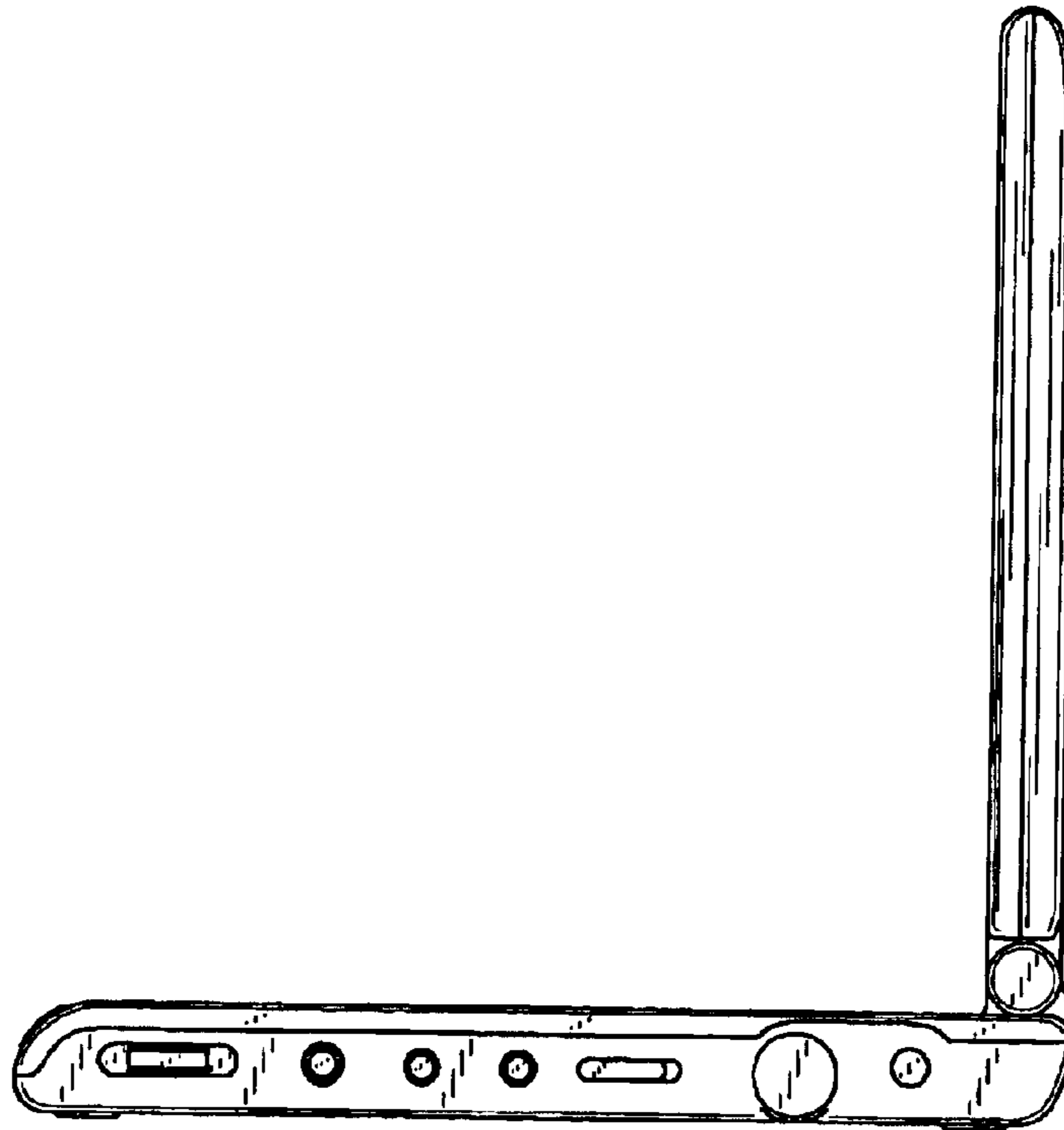

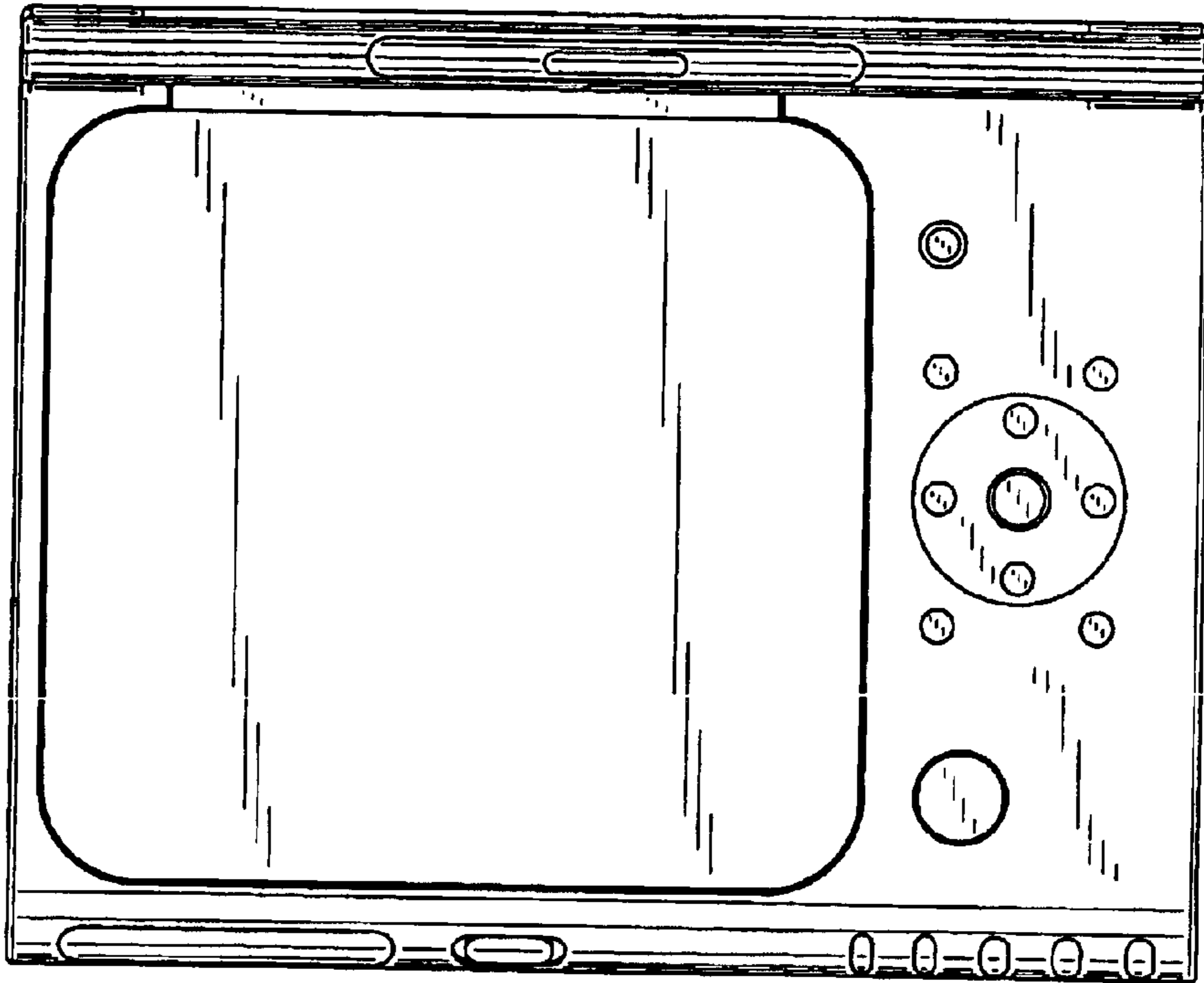
