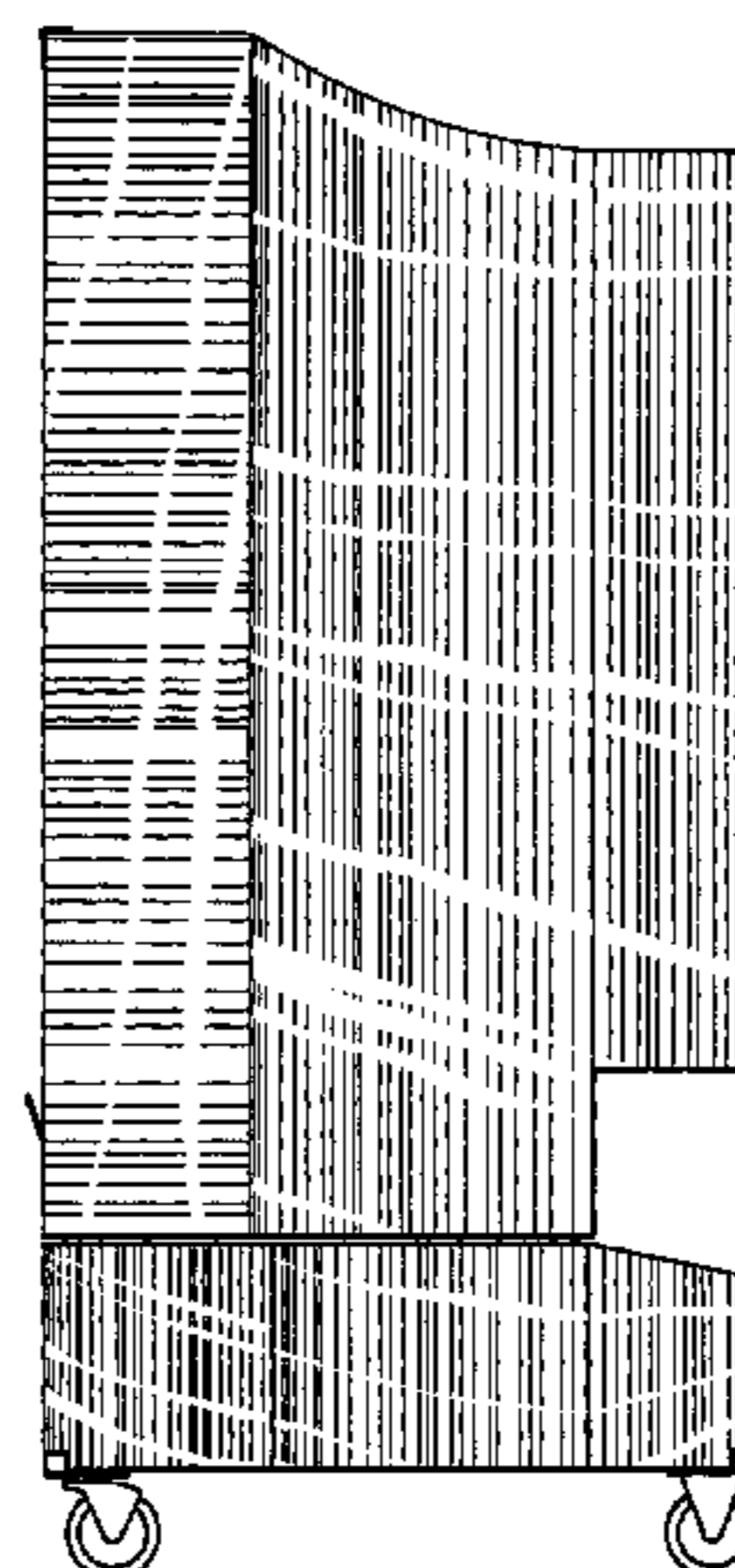
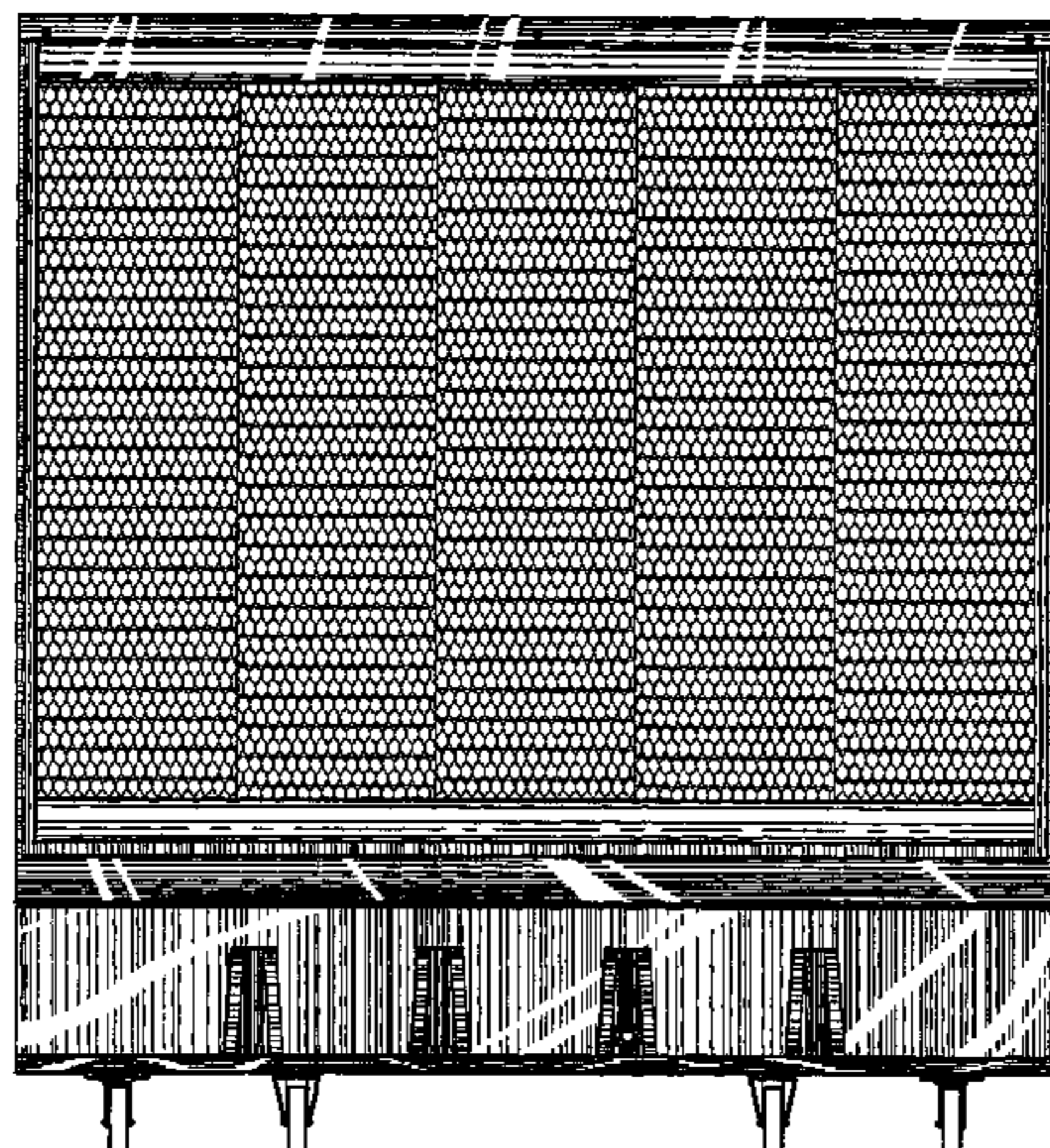
(57) **CLAIM**

The ornamental design for an evaporative cooler, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear elevational view of an evaporative cooler showing my new design;  
FIG. 2 is a right side elevational view thereof; and  
FIG. 3 is a left side elevational view thereof; and  
FIG. 4 is a front elevational view thereof, as shown in one environment, the environment being in broken lines, the environment not being a part of the disclosed and claimed design; and

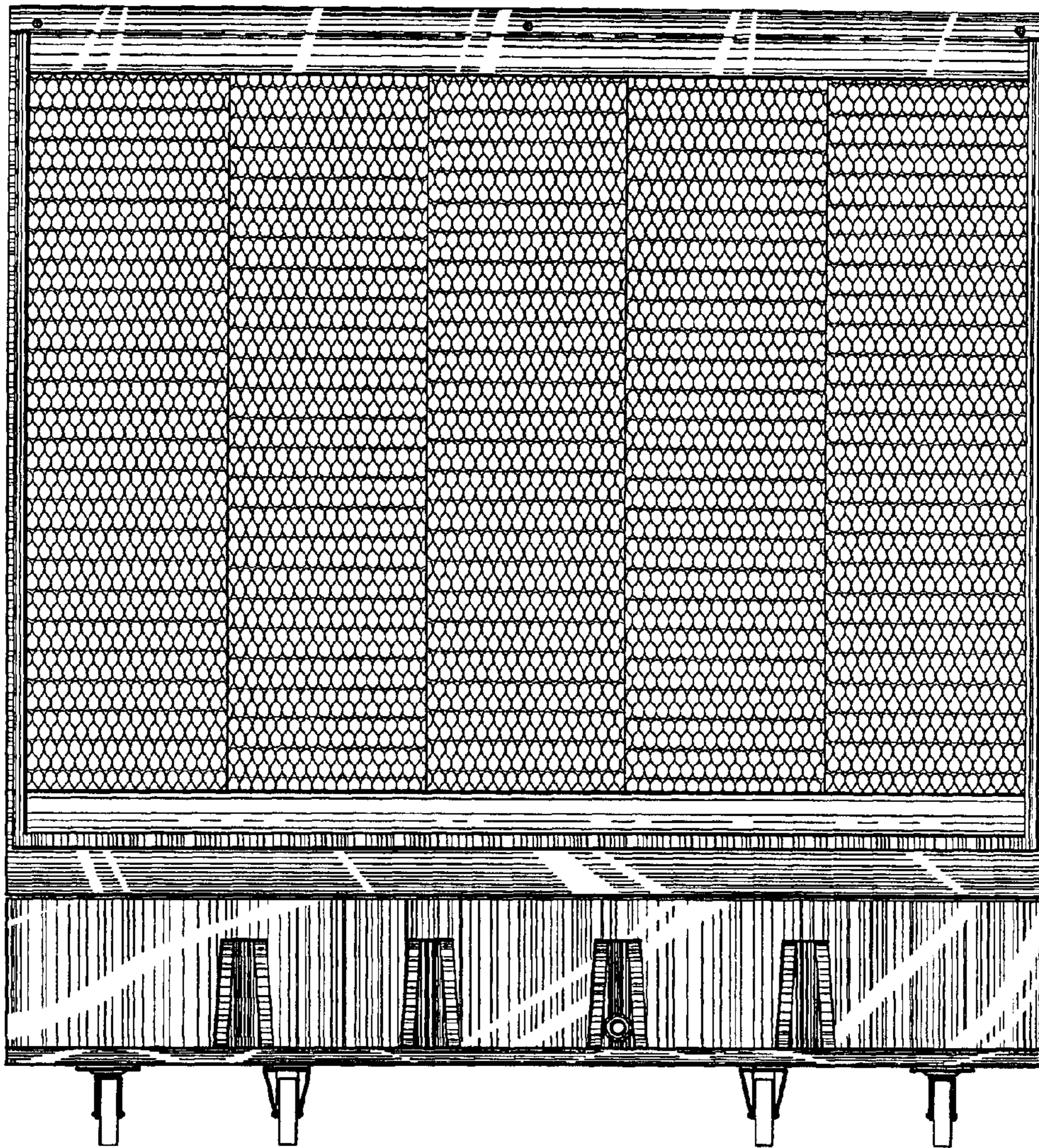

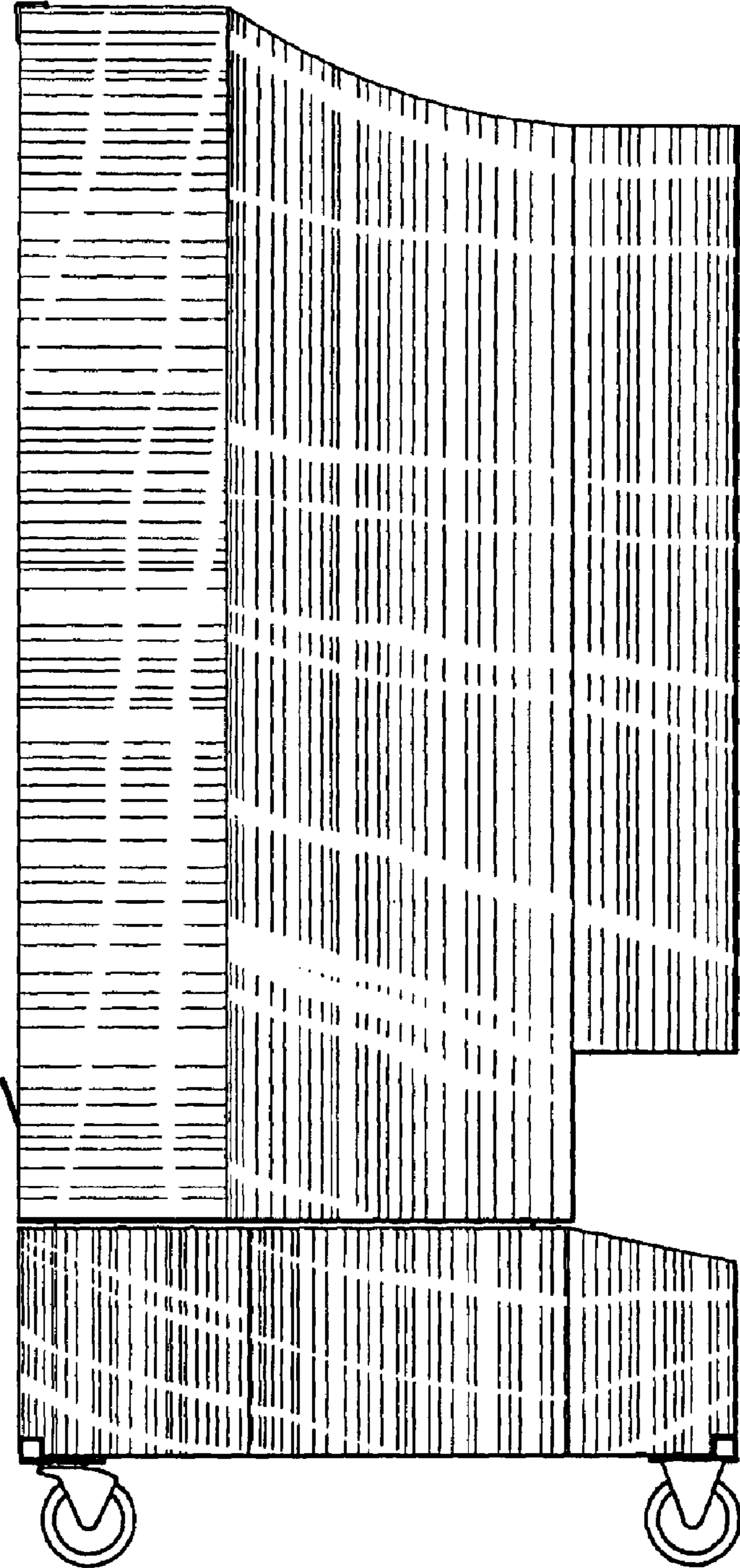

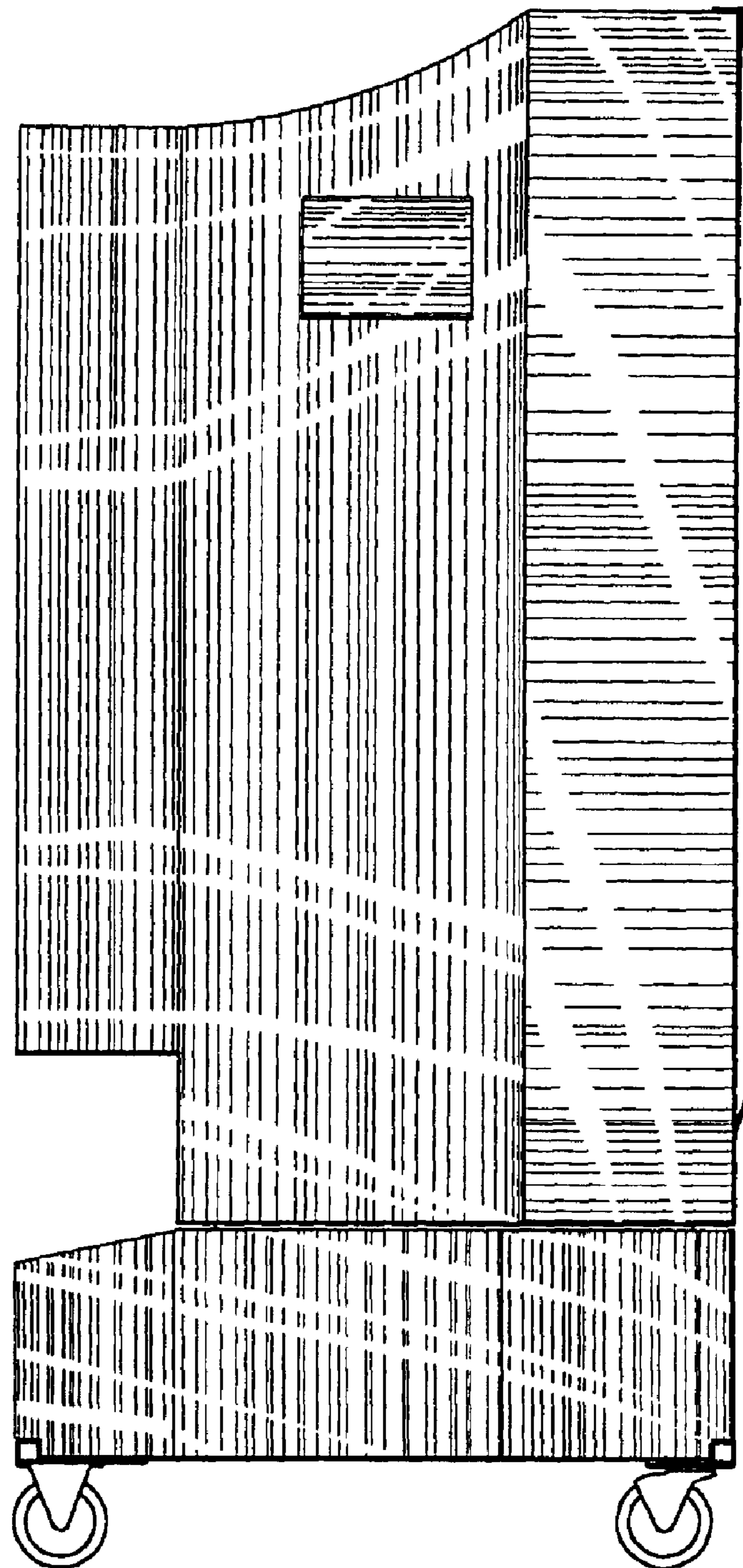

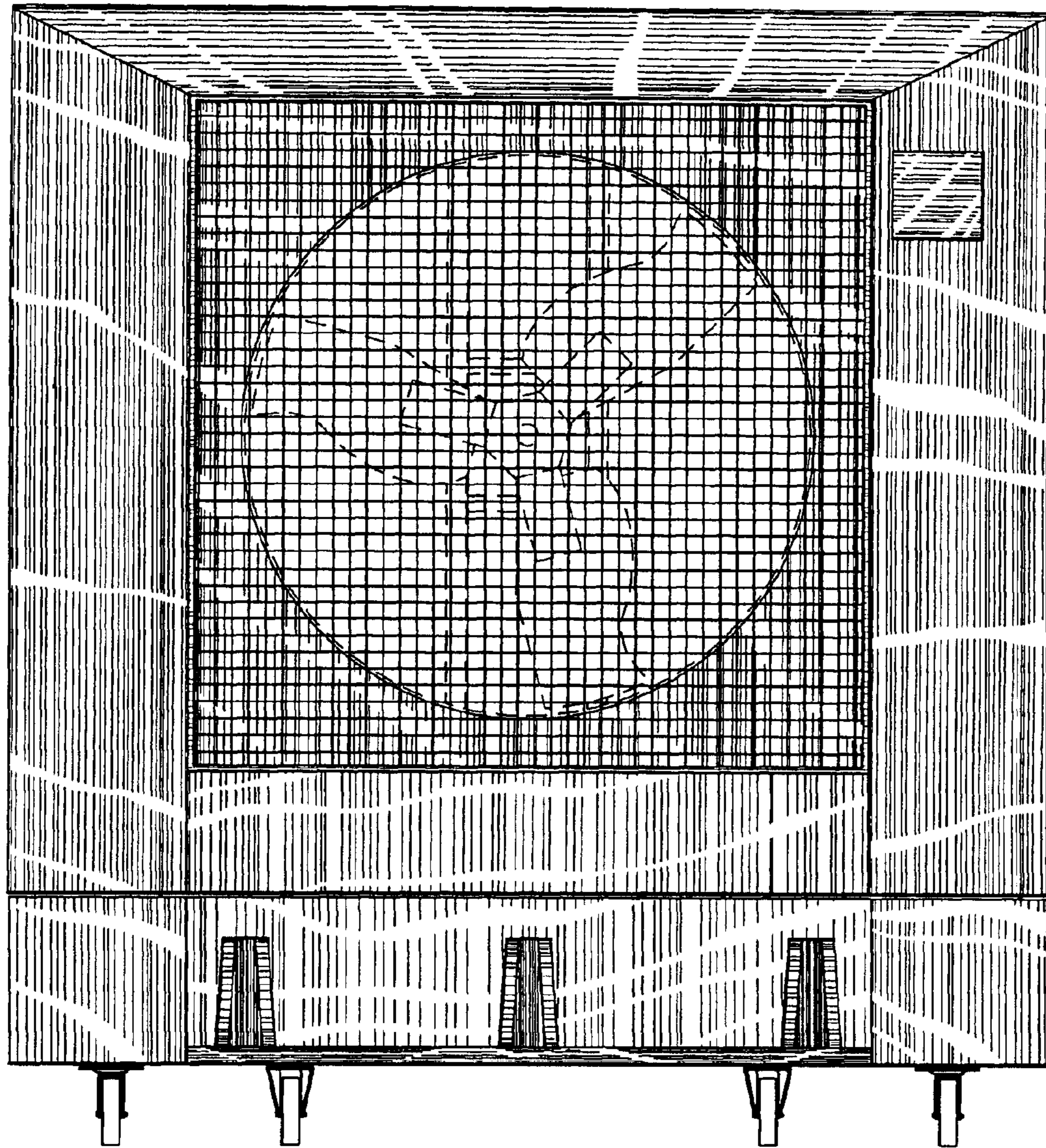

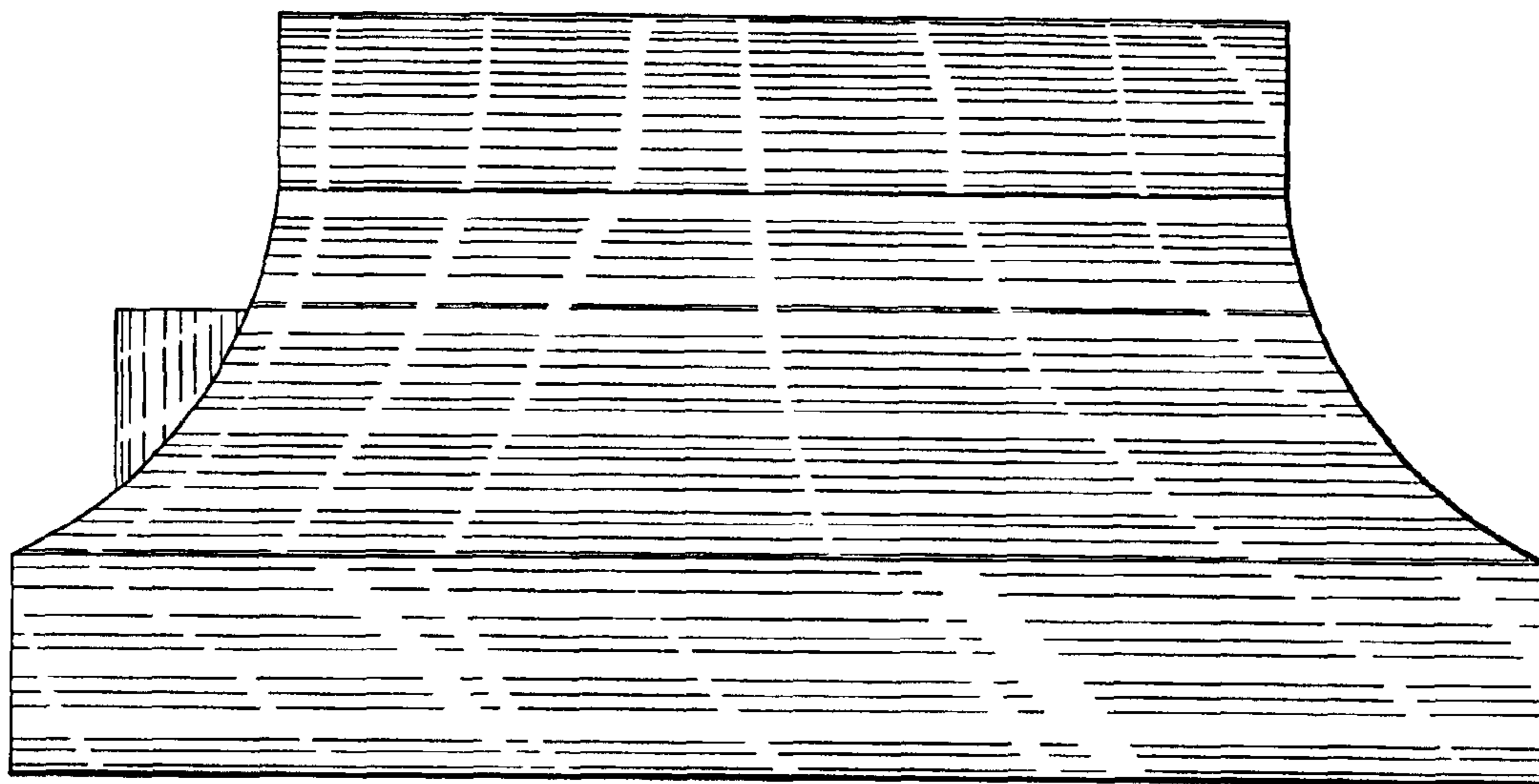

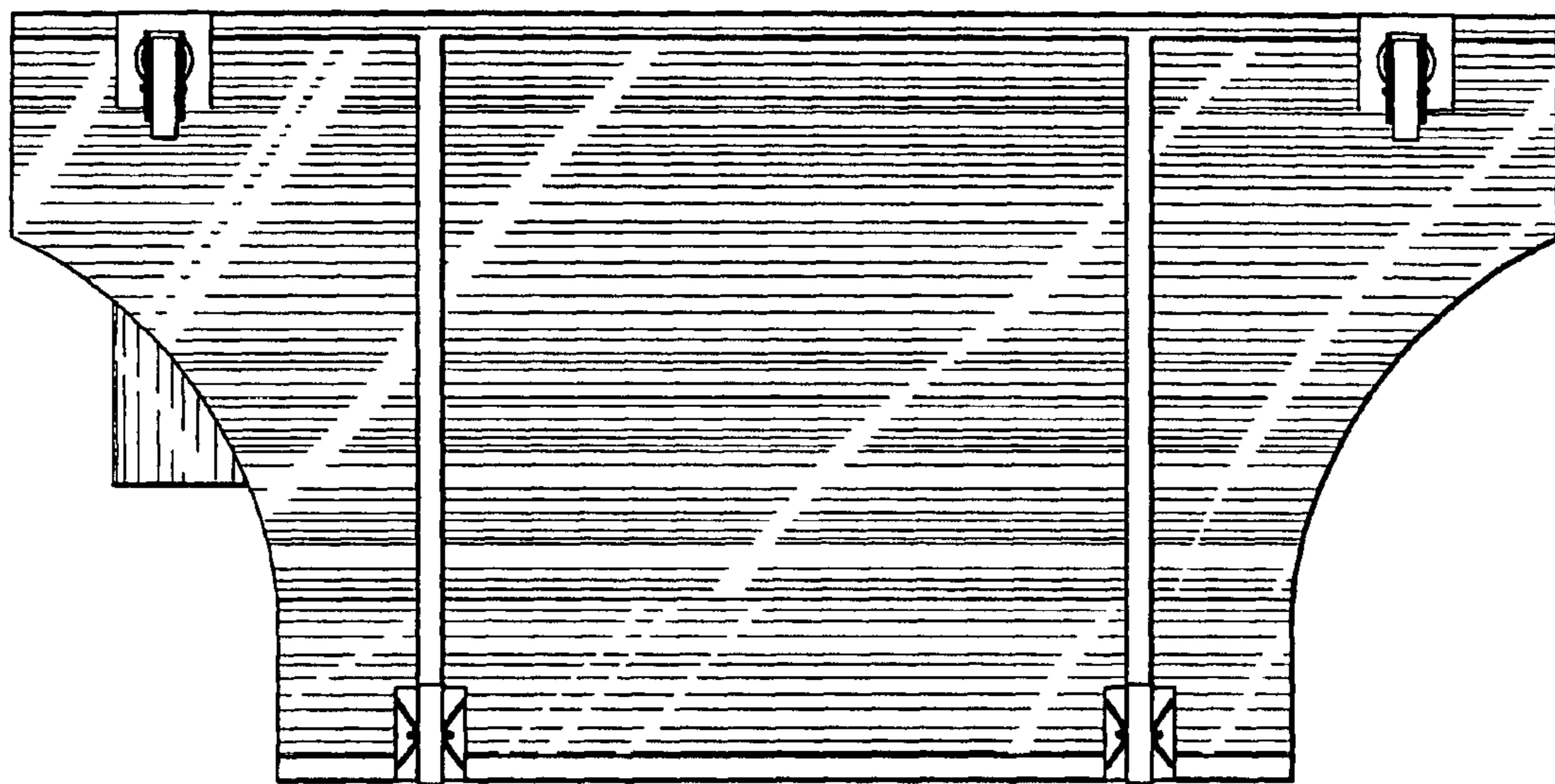
