(57) **CLAIM**

We claim the ornamental design for a hemostatic compression pad, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, left side, frontal perspective view of a hemostatic compression pad showing an embodiment of our new design;  
 FIG. 2 is a rear elevation view thereof;  
 FIG. 3 is a front elevation view of the embodiment of our new design for a compression pad shown in use;  
 FIG. 4 is a left side elevation view thereof;  
 FIG. 5 a top plan view thereof; and,  
 FIG. 6 is a bottom plan view thereof.
