(57) **CLAIM**

The ornamental design for a stapler, as shown and described.

DESCRIPTION

FIG. 1 is a left-side perspective view, taken from the front, of a stapler embodying the present invention.

FIG. 2 is a right-side perspective view taken from the front of the stapler.

FIG. 3 is a left-side perspective view taken from the rear of the stapler.

FIG. 4 is a left side view of the stapler.

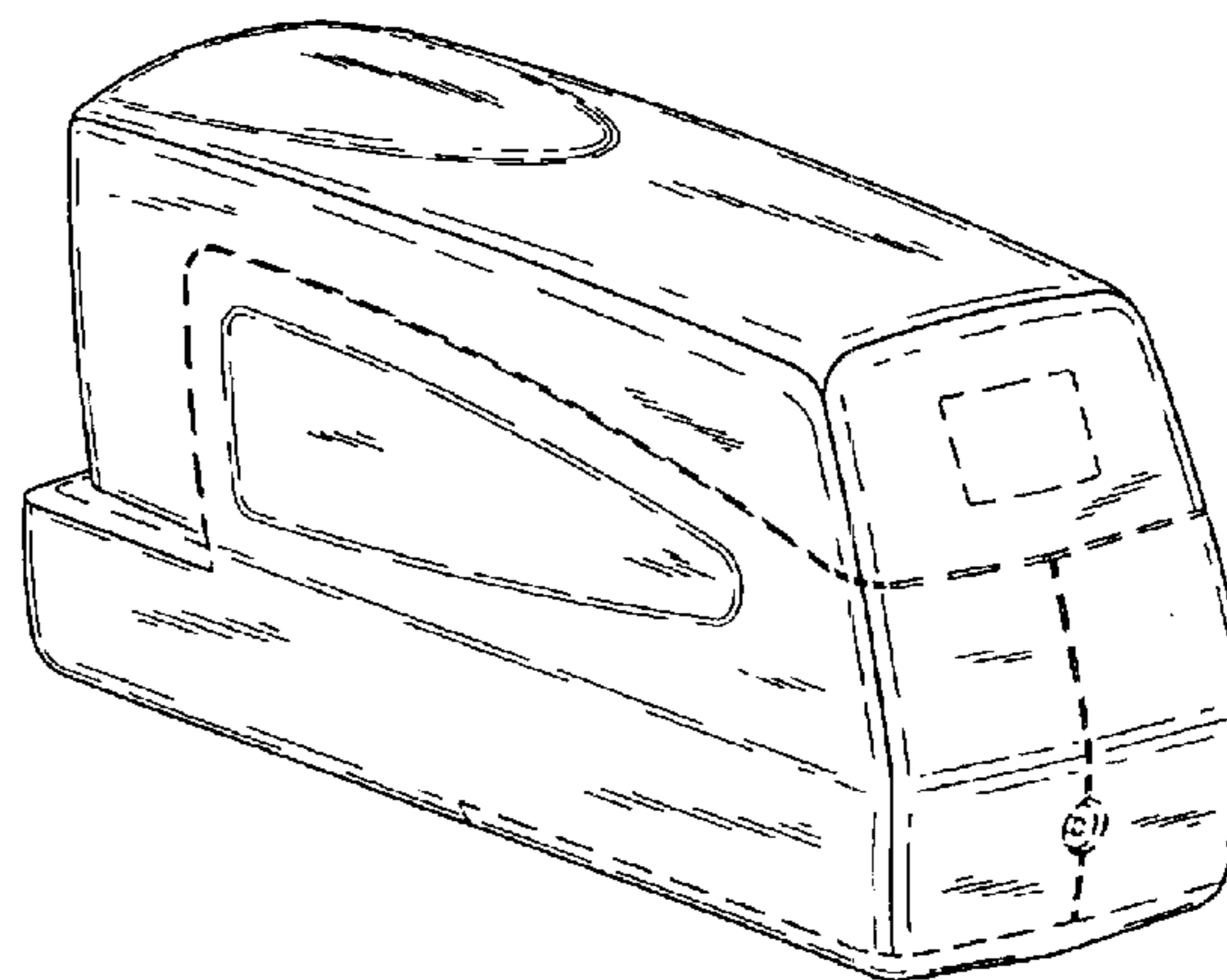
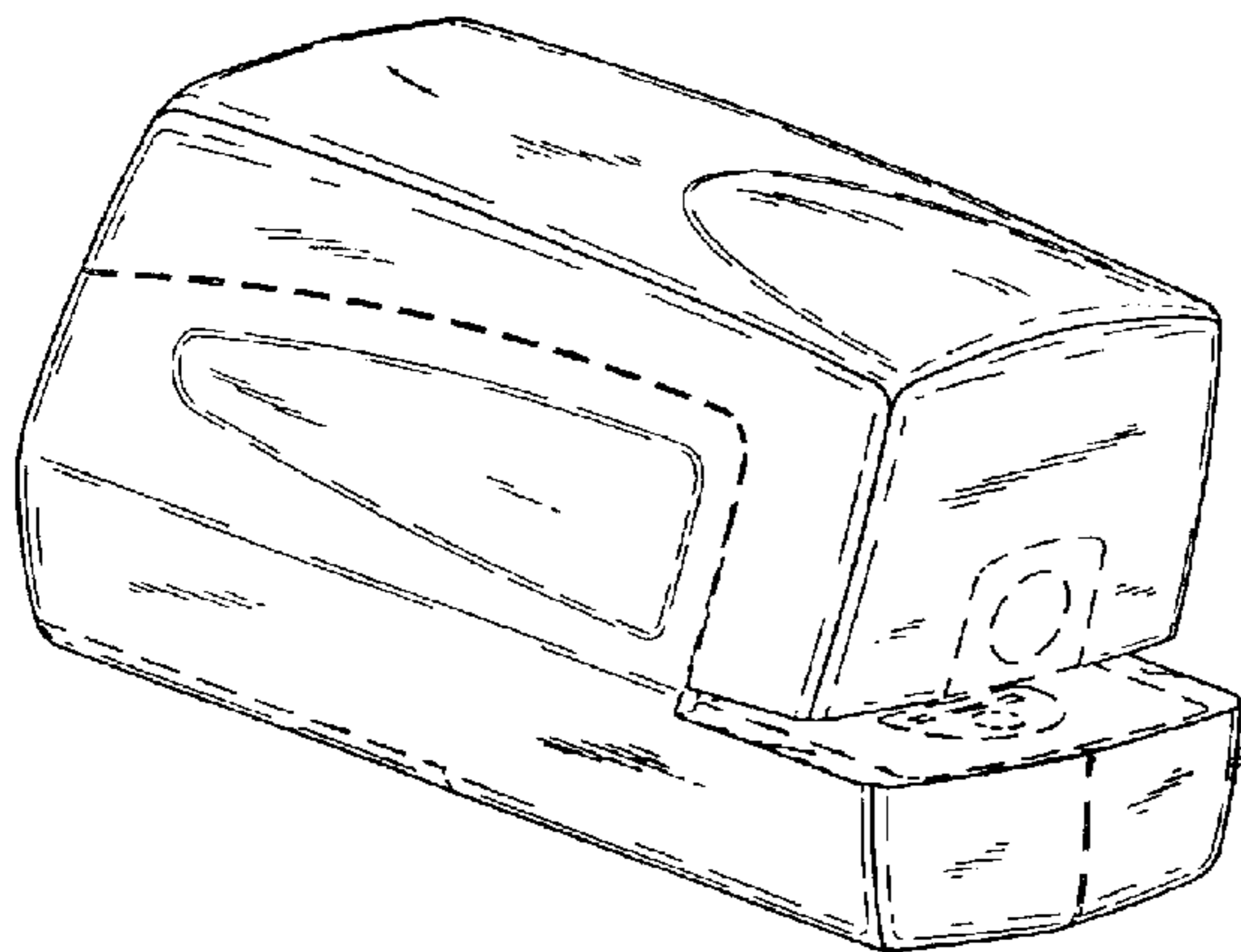
FIG. 5 is a front view of the stapler.

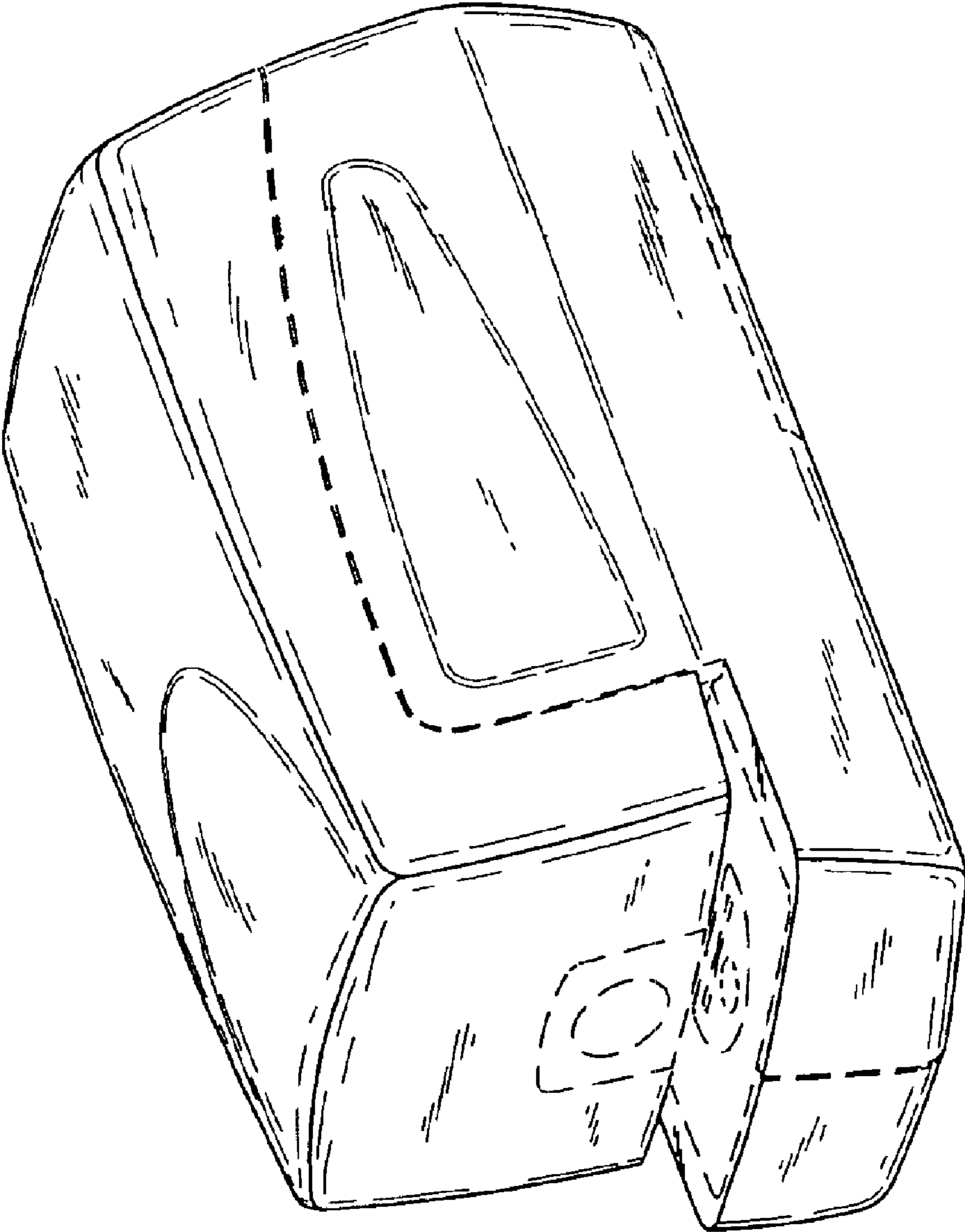

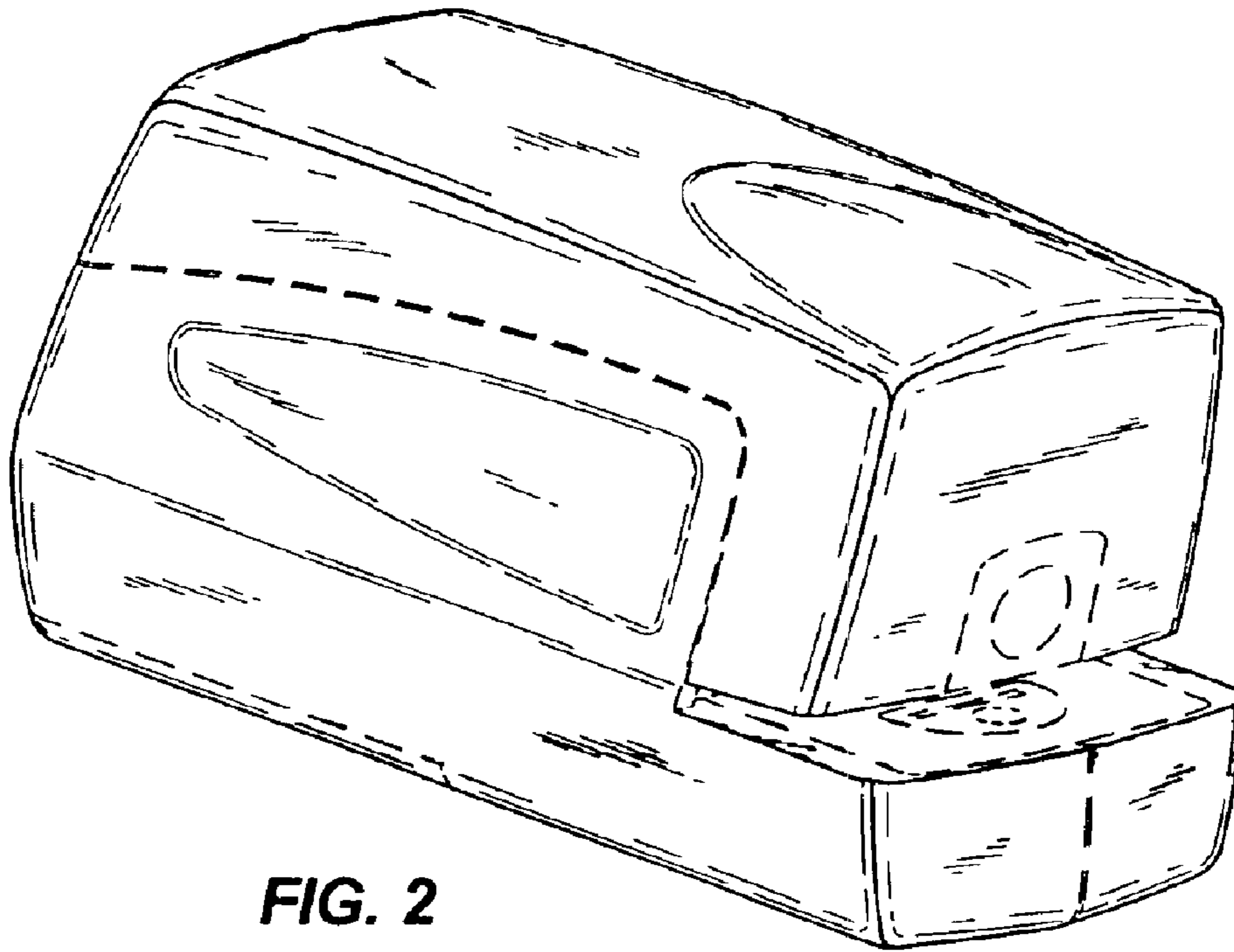

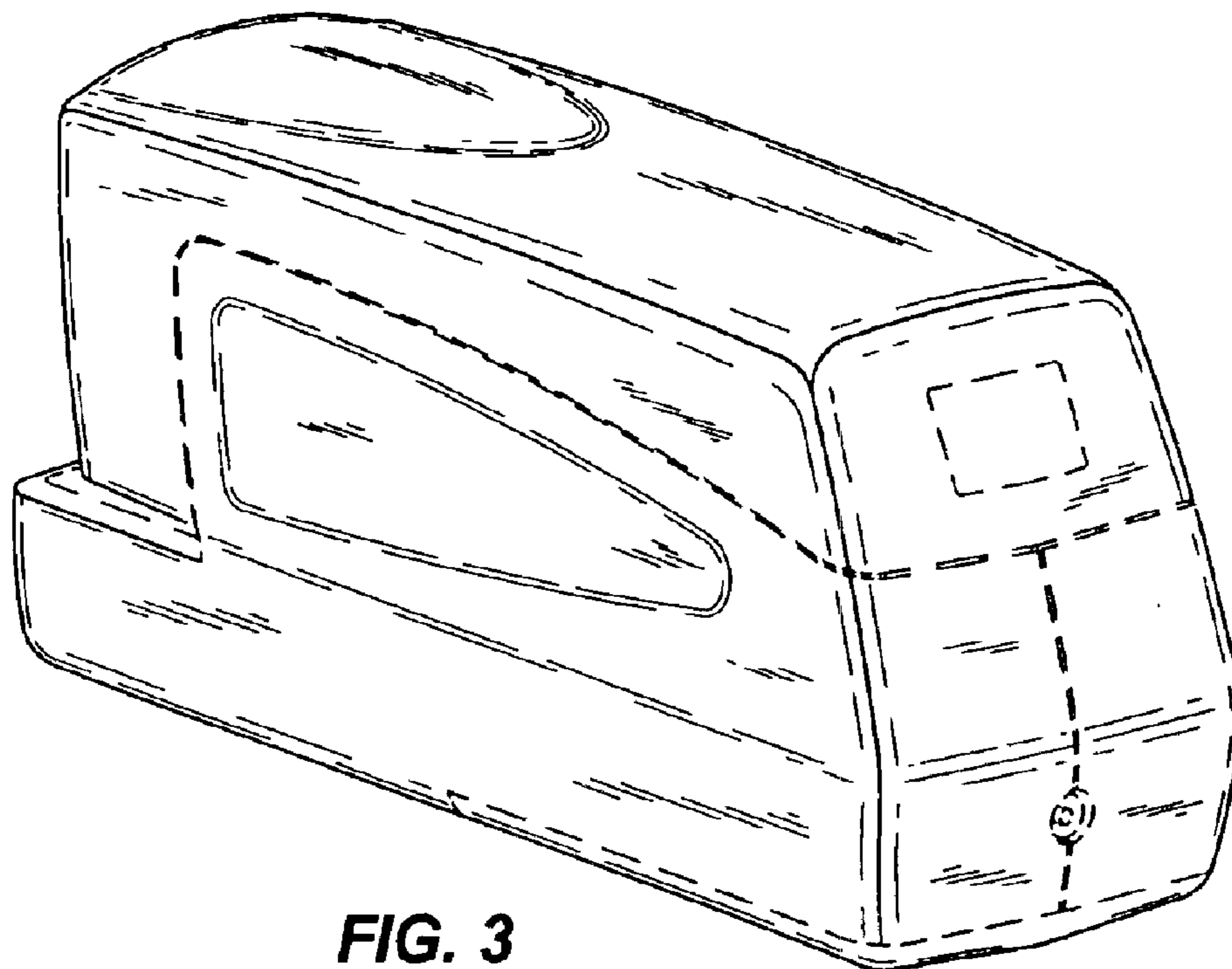

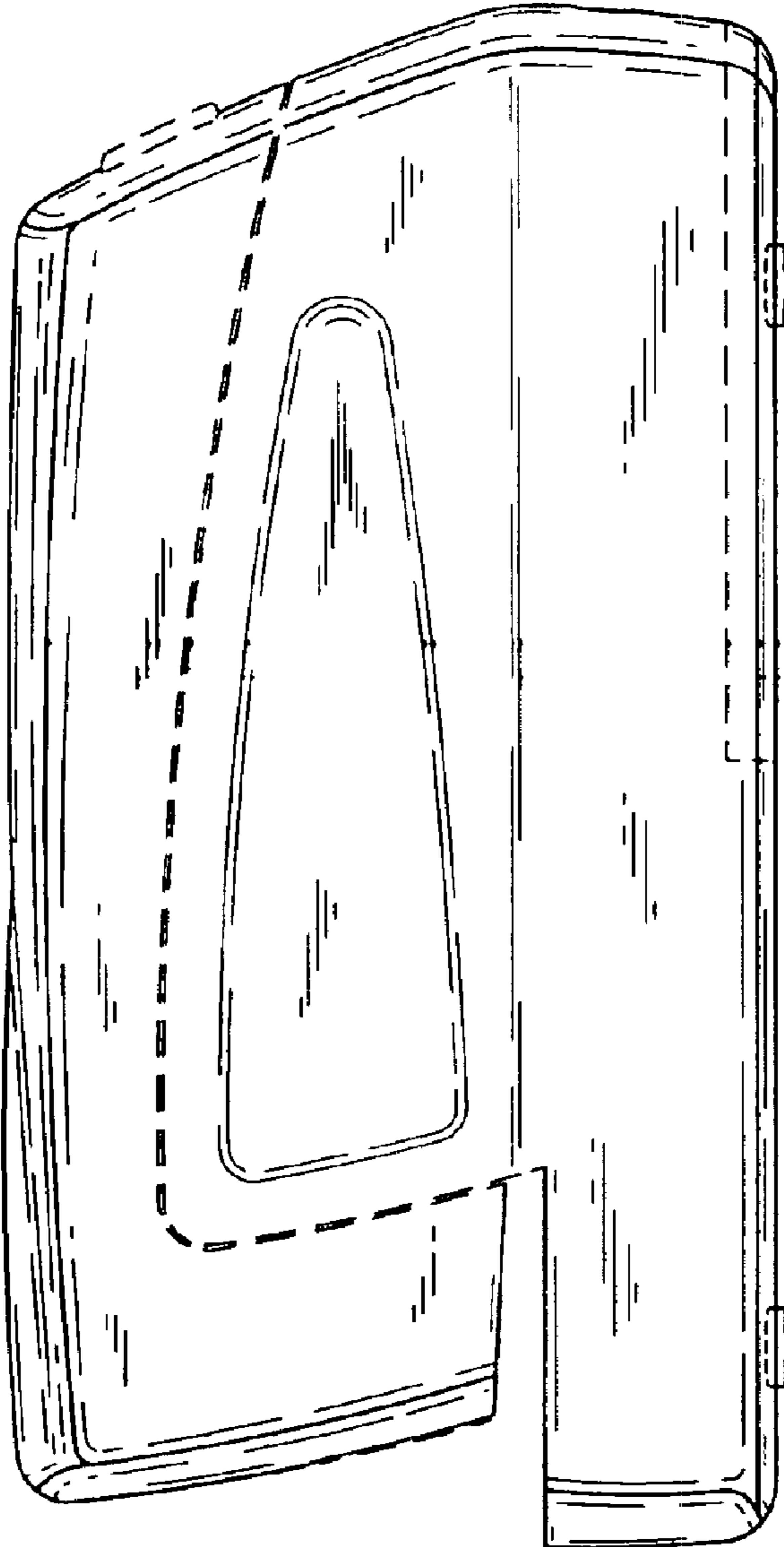

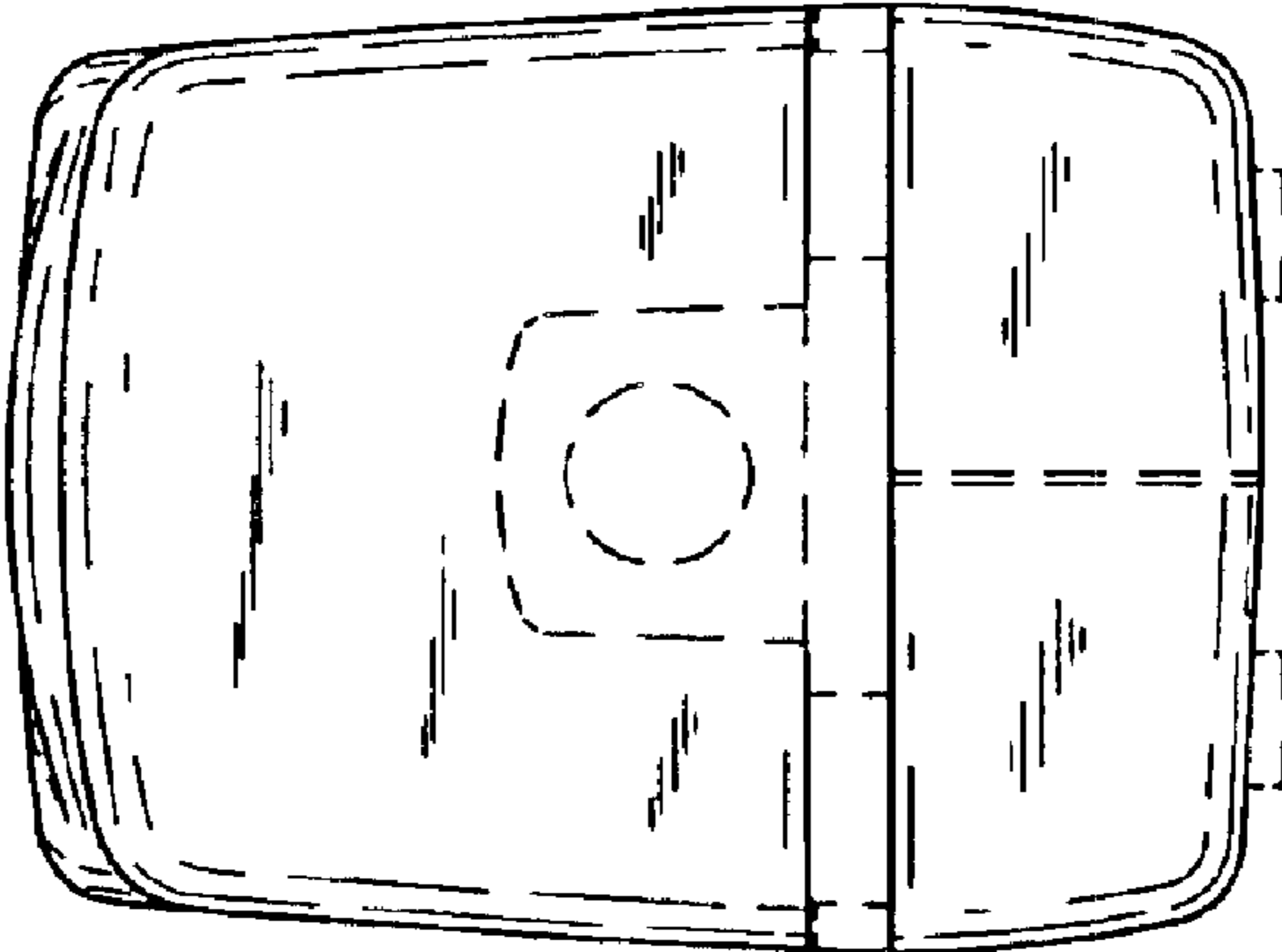

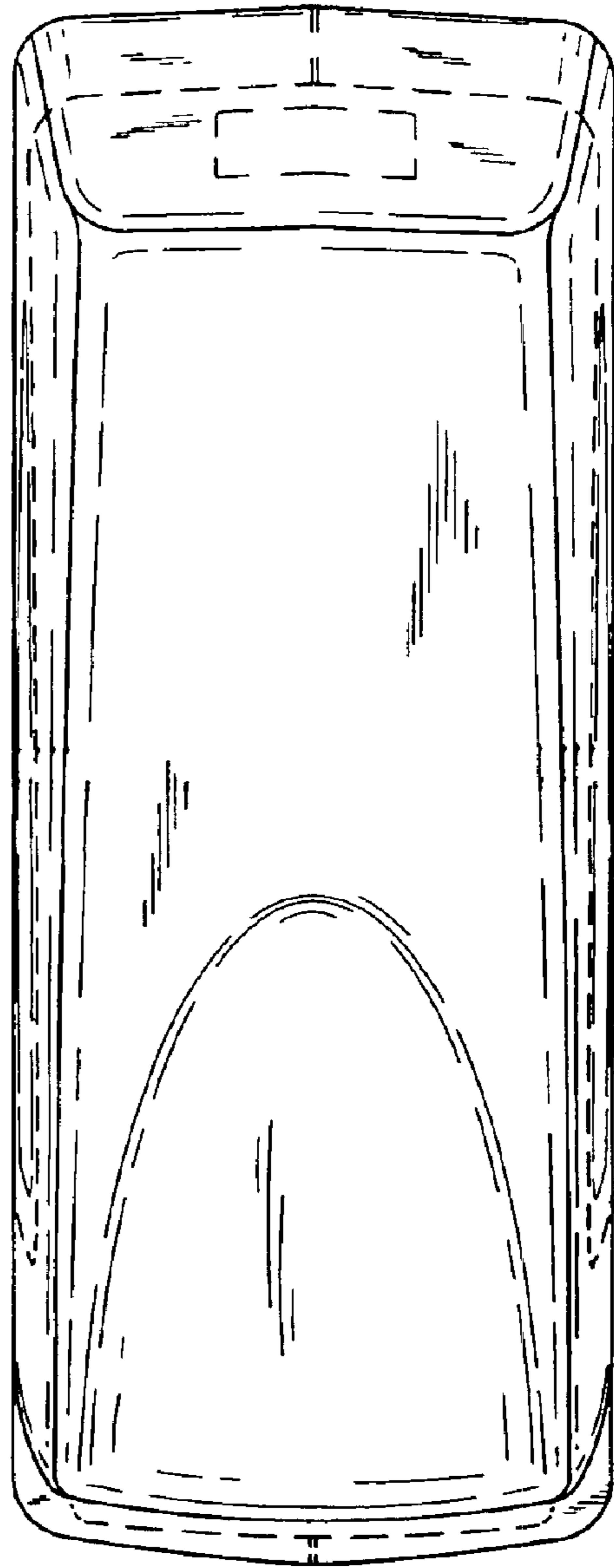

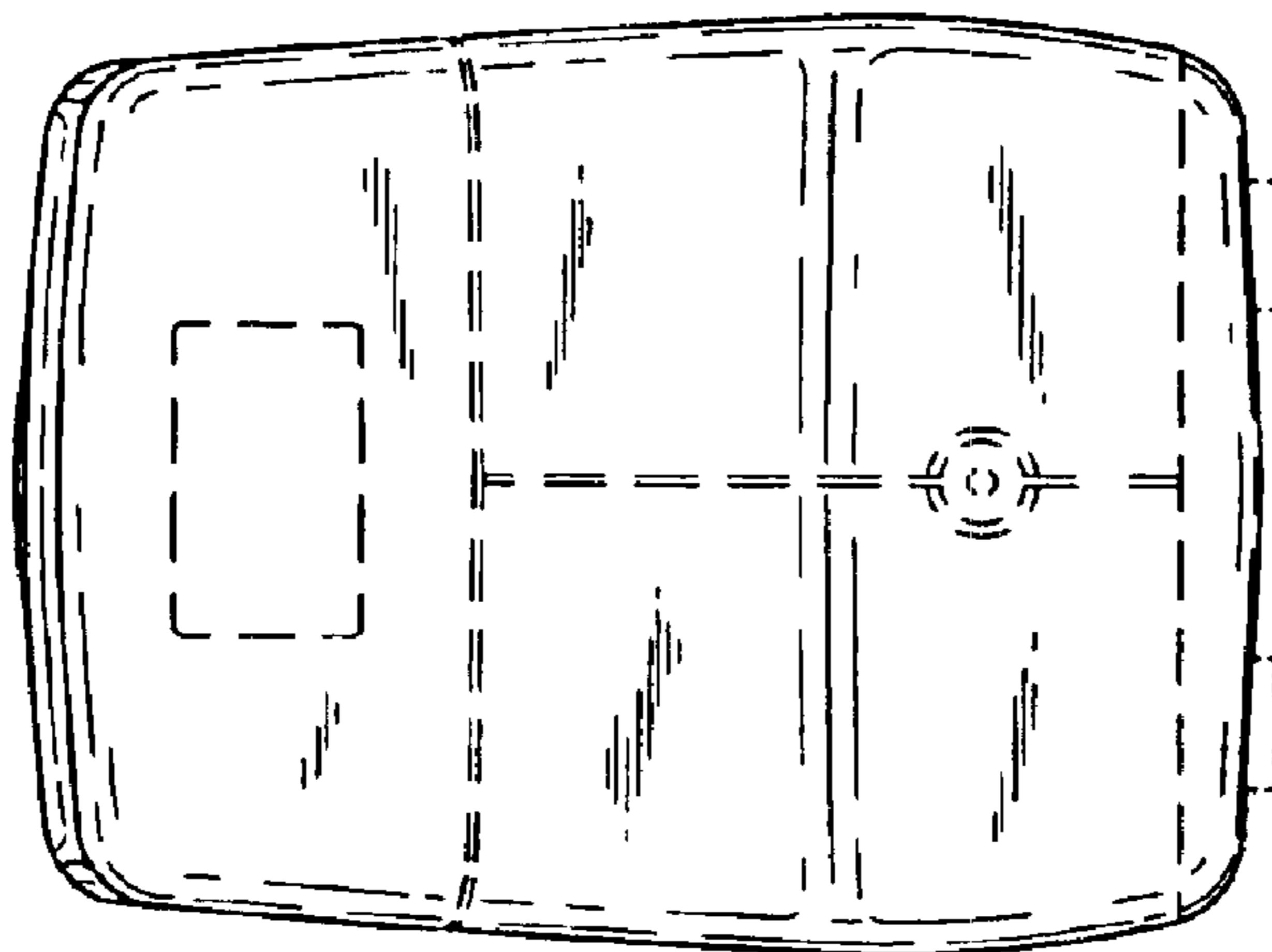
