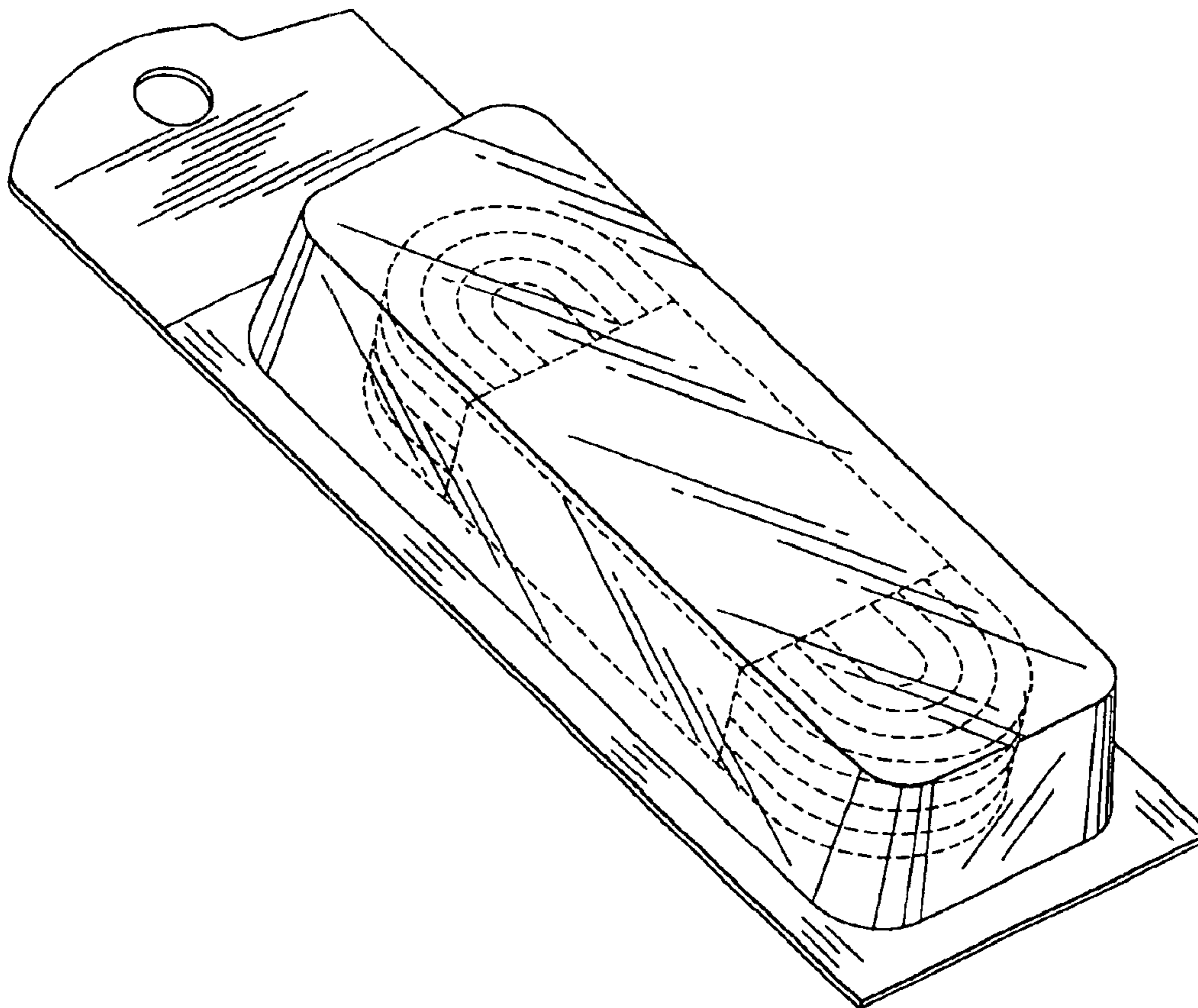
FIG. 4 is a right side elevational view of the hanging package of the present invention;

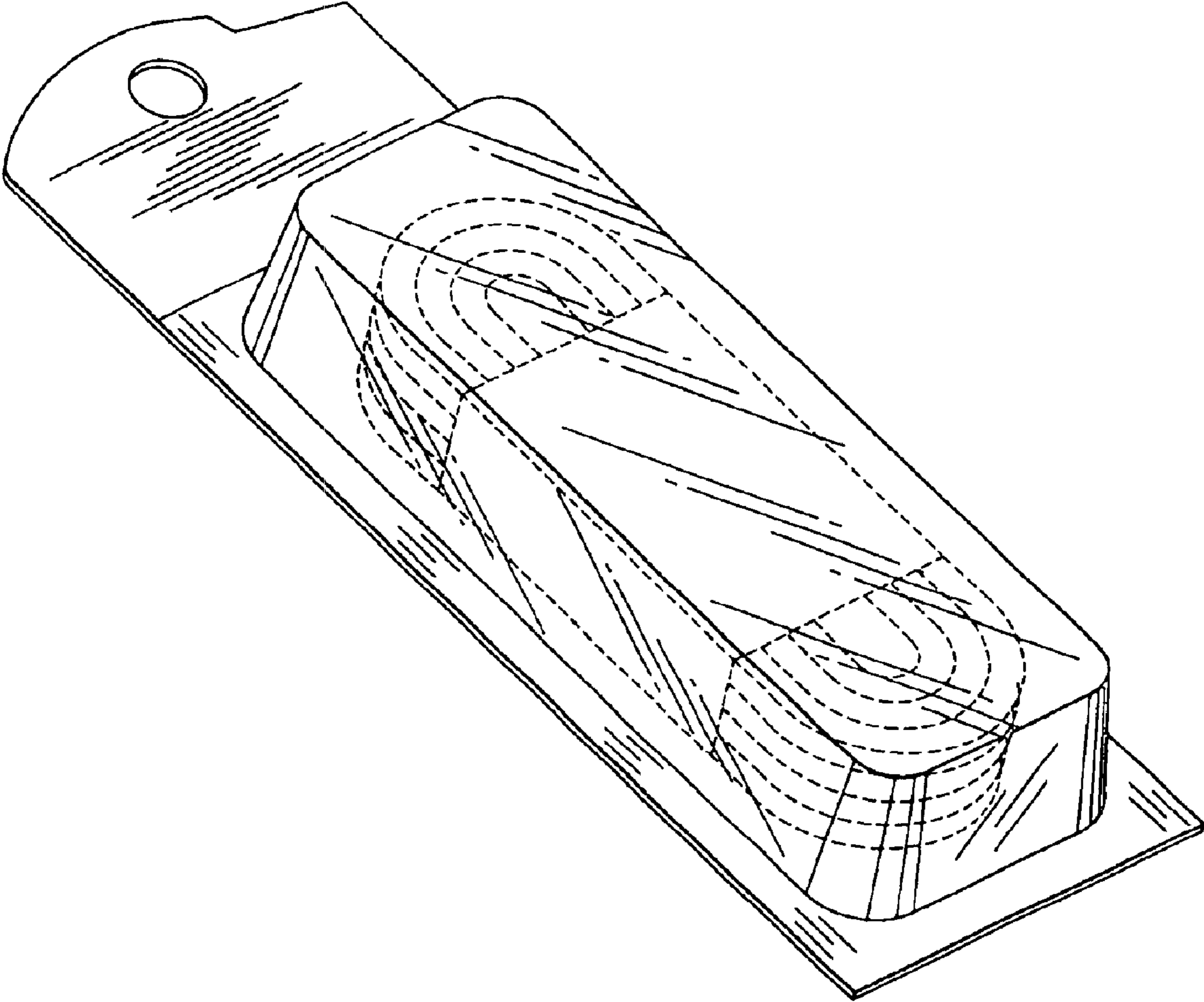

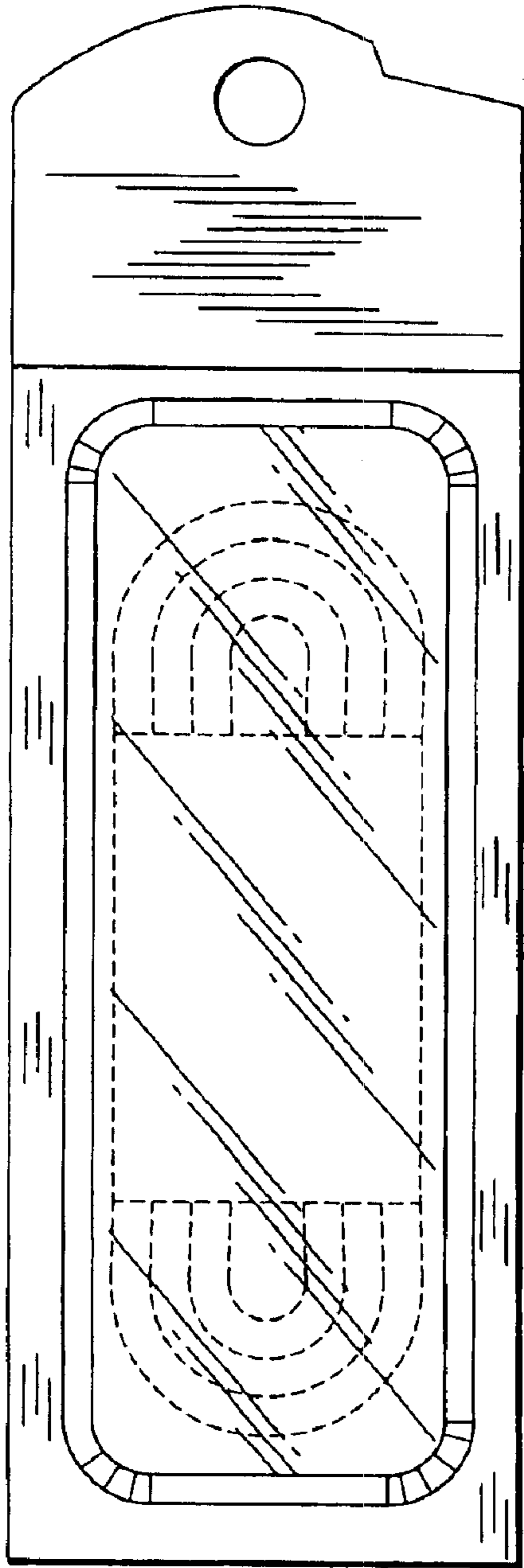

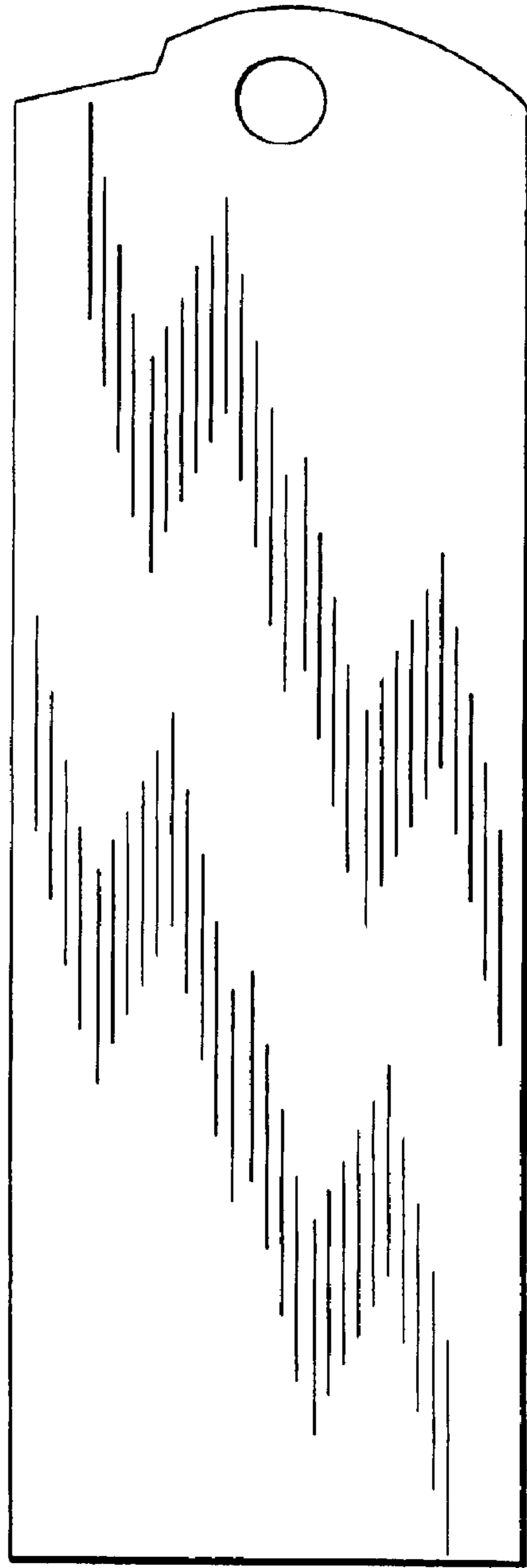

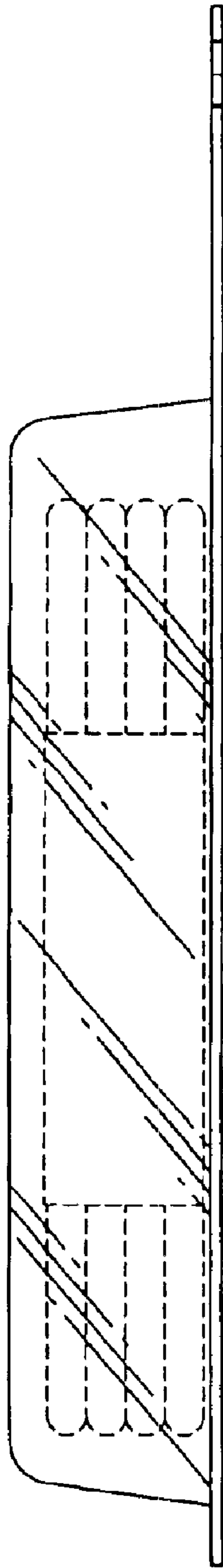

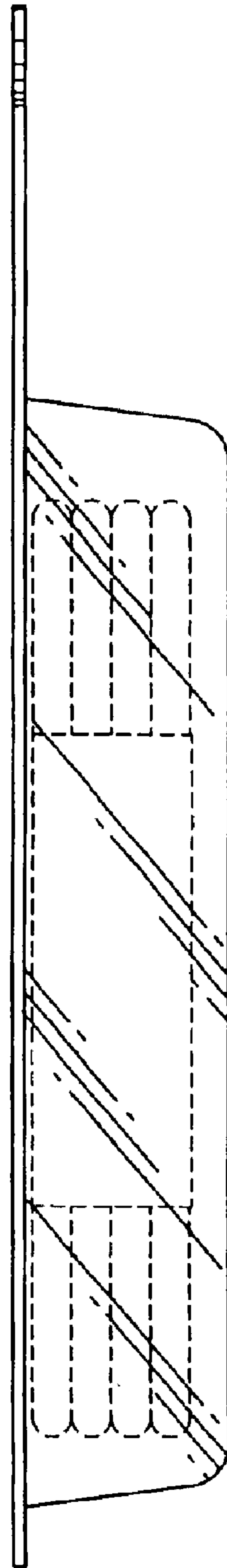

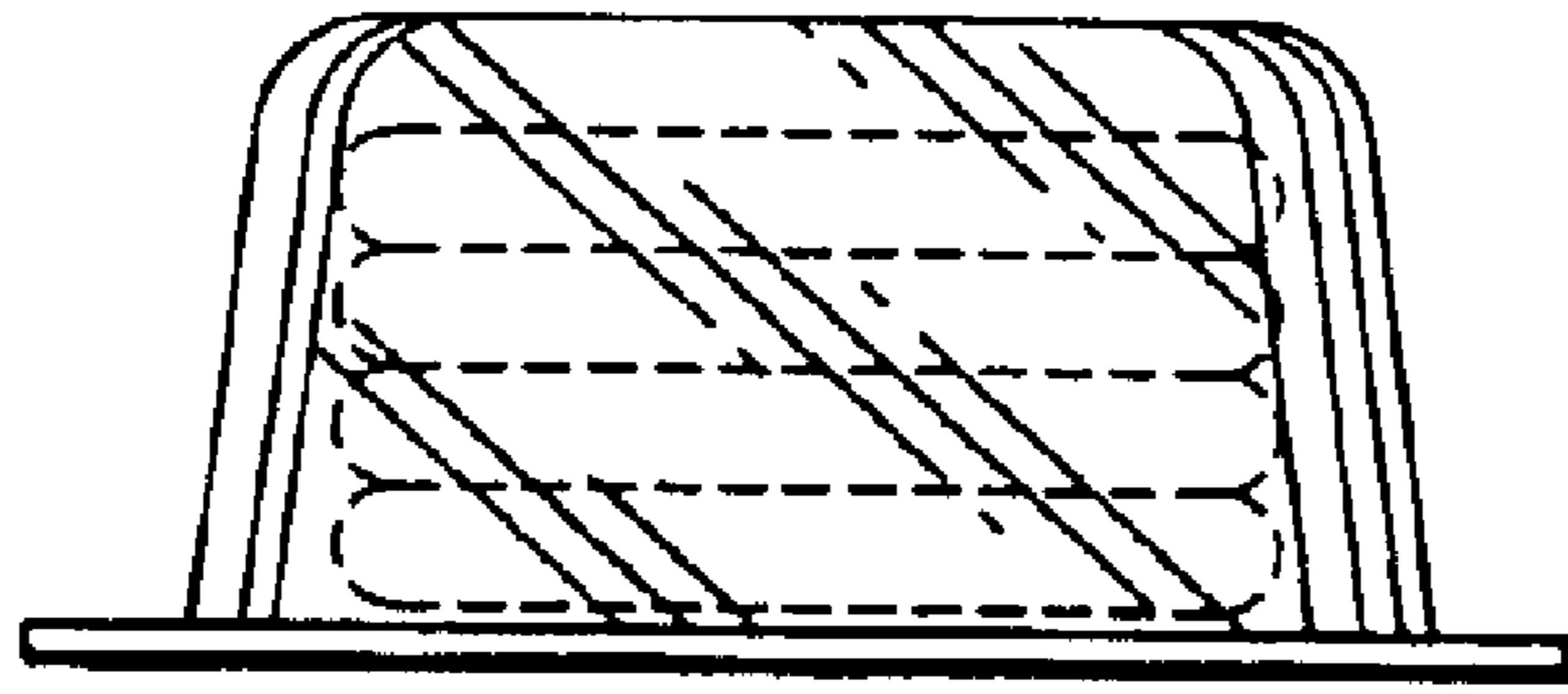

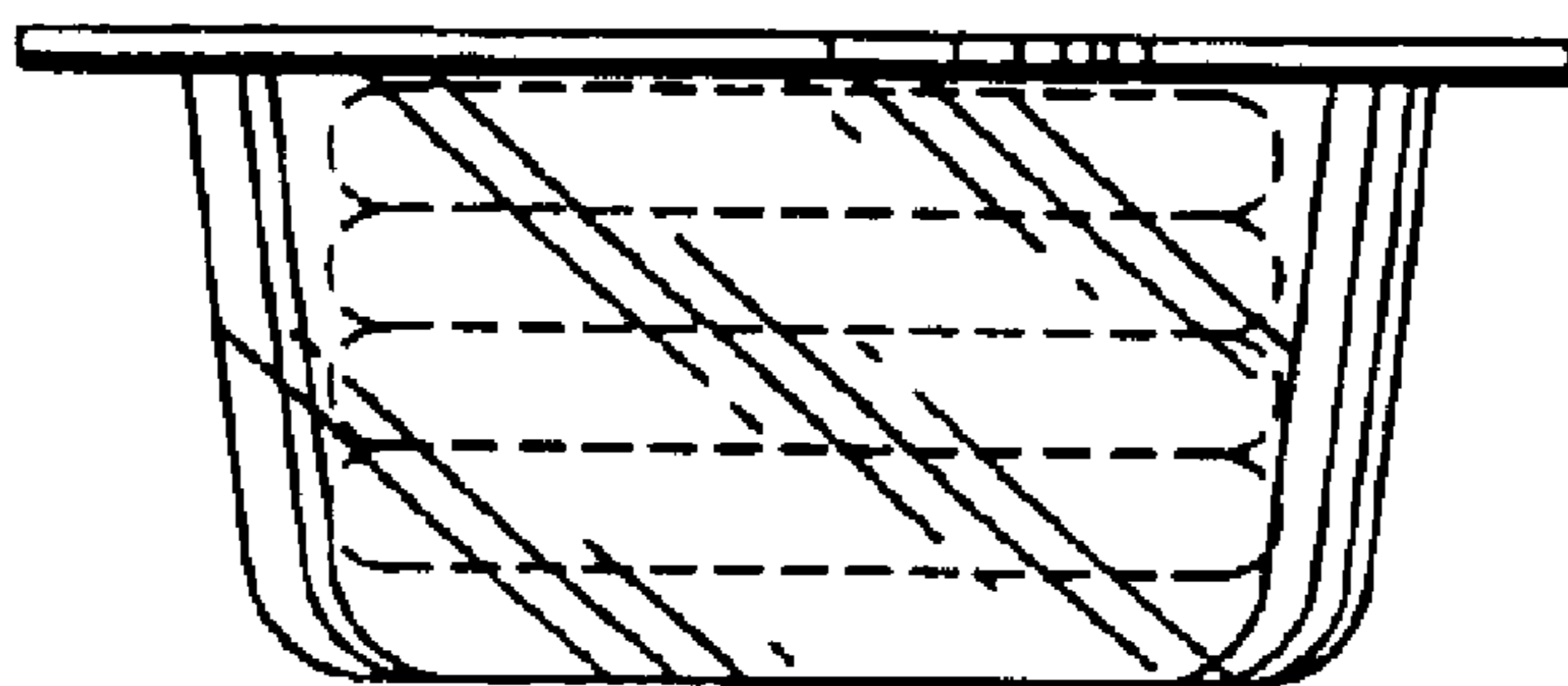
