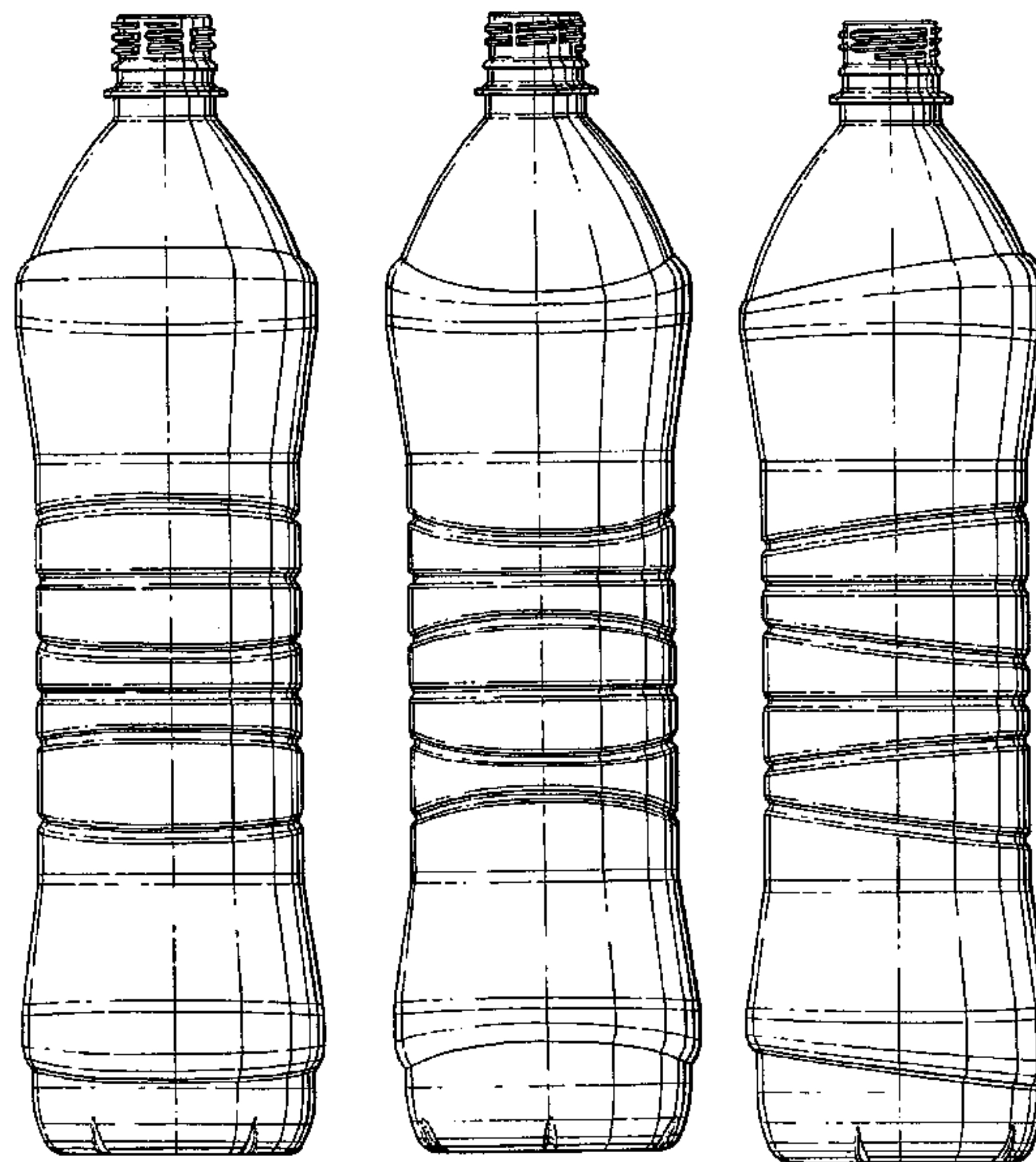
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view from above of a bottle in accordance with my new design,
FIG. 2 is a front view of a bottle in accordance with my new design,
FIG. 3 is a rear view of a bottle in accordance with my new design,
FIG. 4 is a view of a bottle in accordance with my new design from one side; and,
FIG. 5 is a view of a bottle in accordance with my new design from the other side.

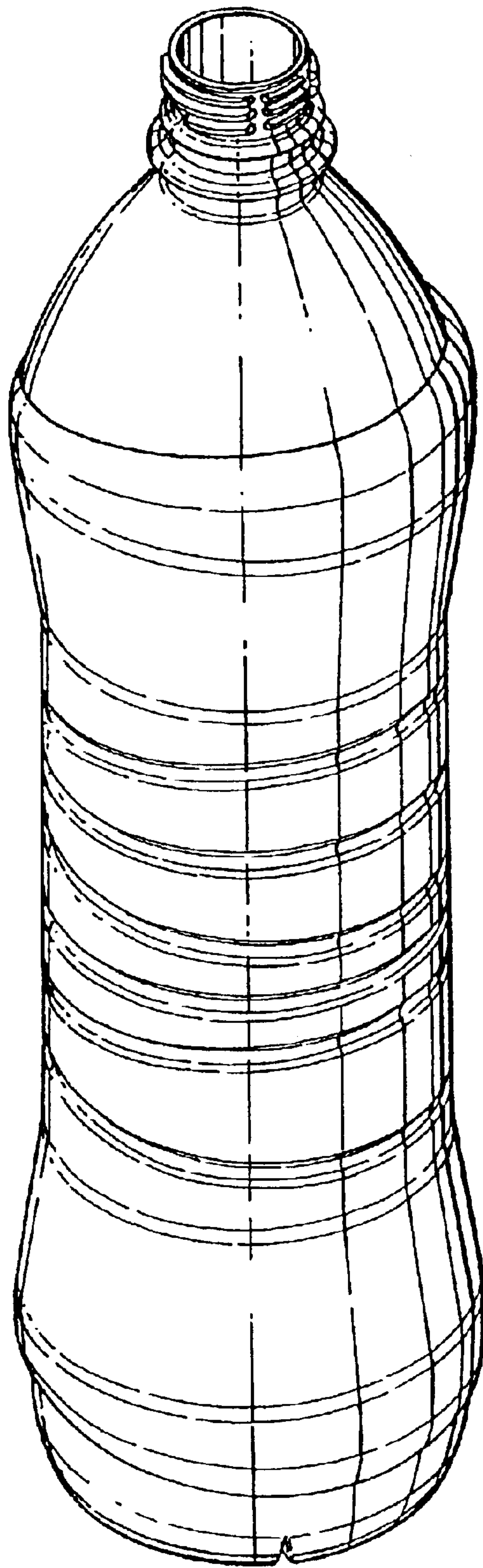

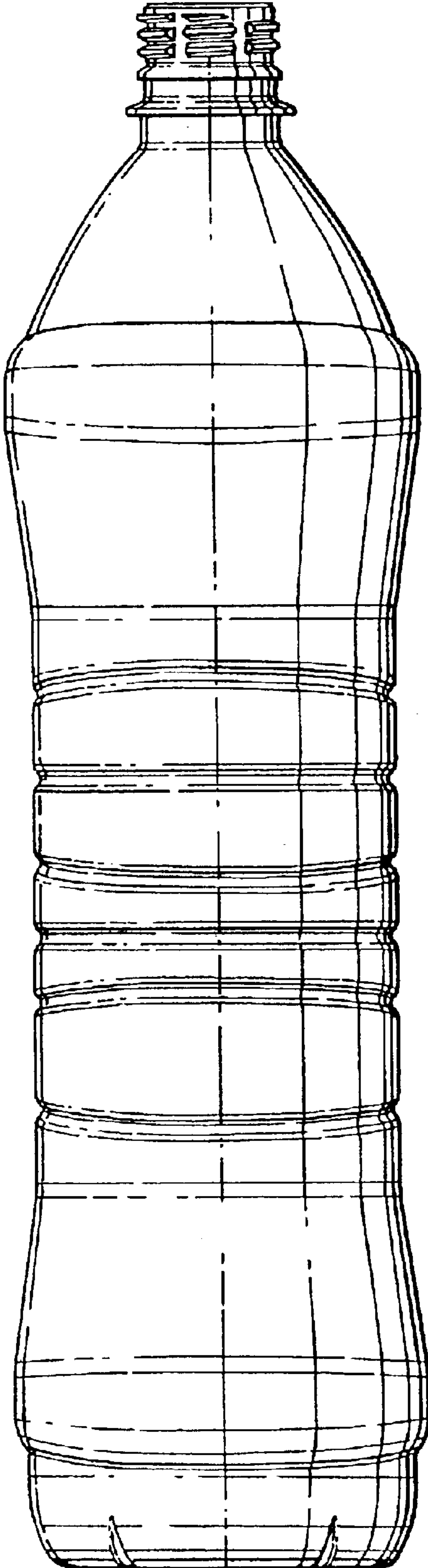

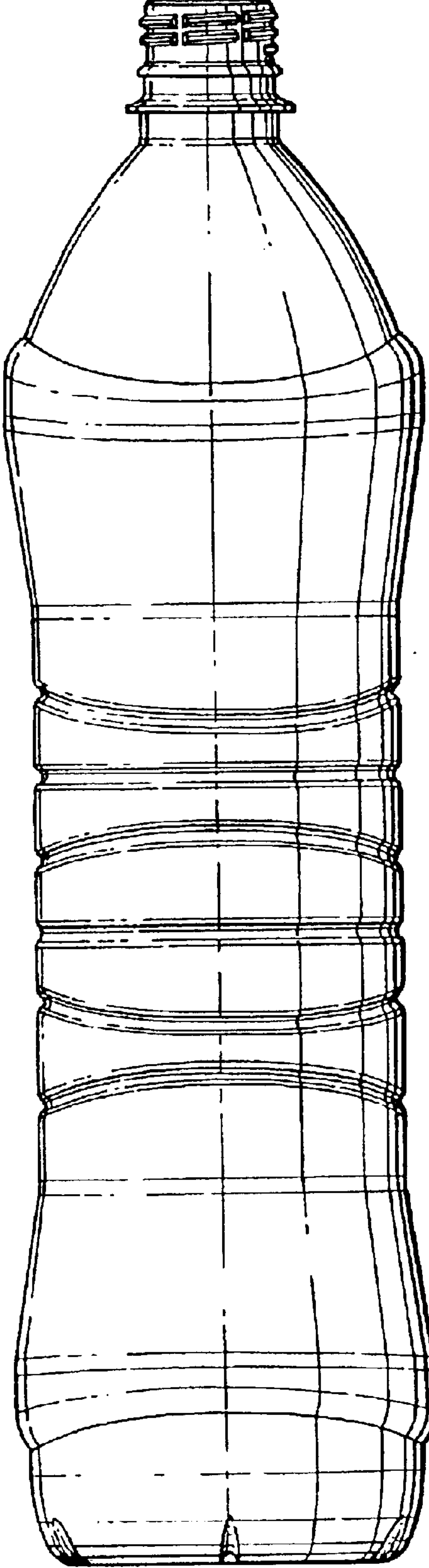

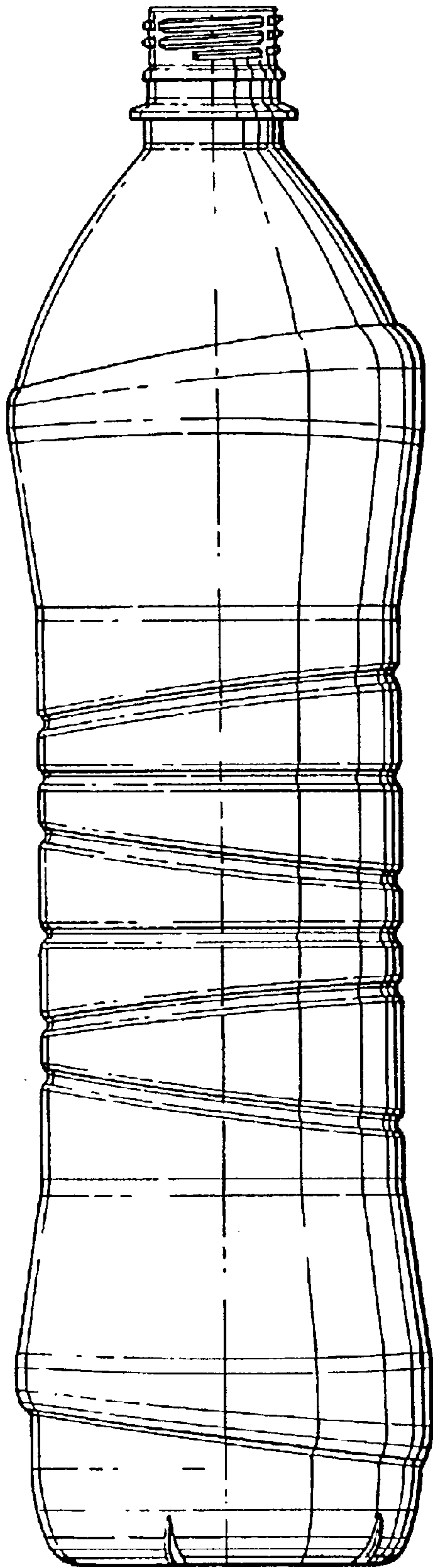

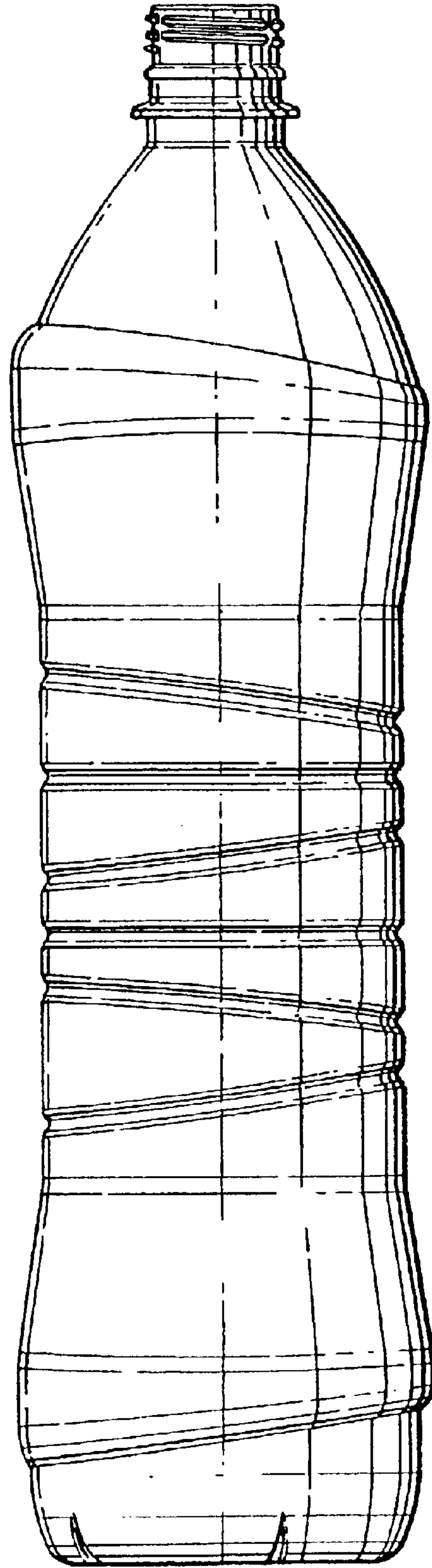
