(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of the bottle of the claimed design; FIG. 2 is a front elevational view thereof, the rear elevational view being identical;

FIG. 3 is a side elevational view thereof, the opposite side elevational view being identical;

FIG. 4 is a top plan view thereof, shown without the cap; and,

FIG. 5 is a front elevational view shown in exploded view to show the unclaimed pour spout and threads.

The broken line showing in the drawings is for illustrative purposes only and forms no part of the claimed design.

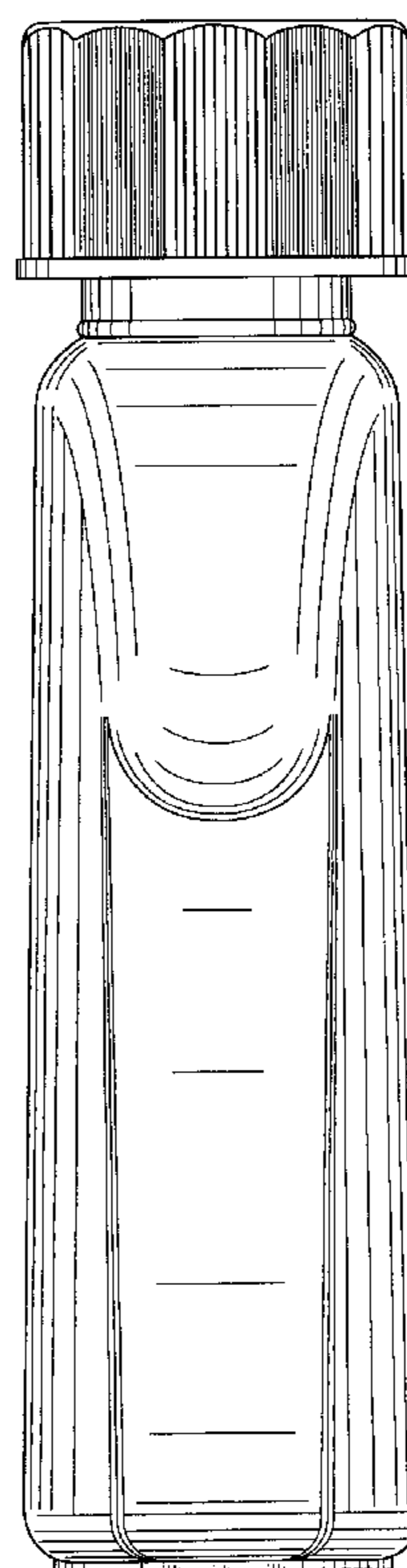
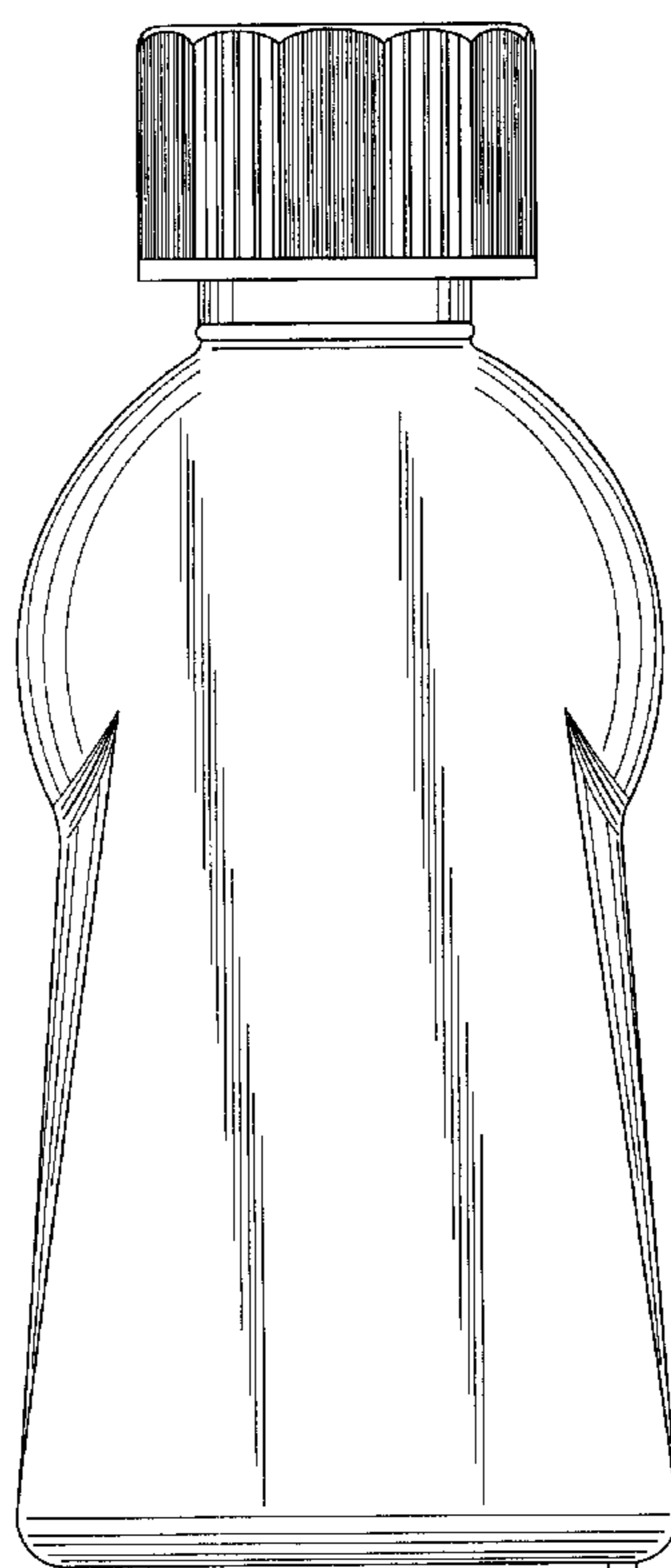

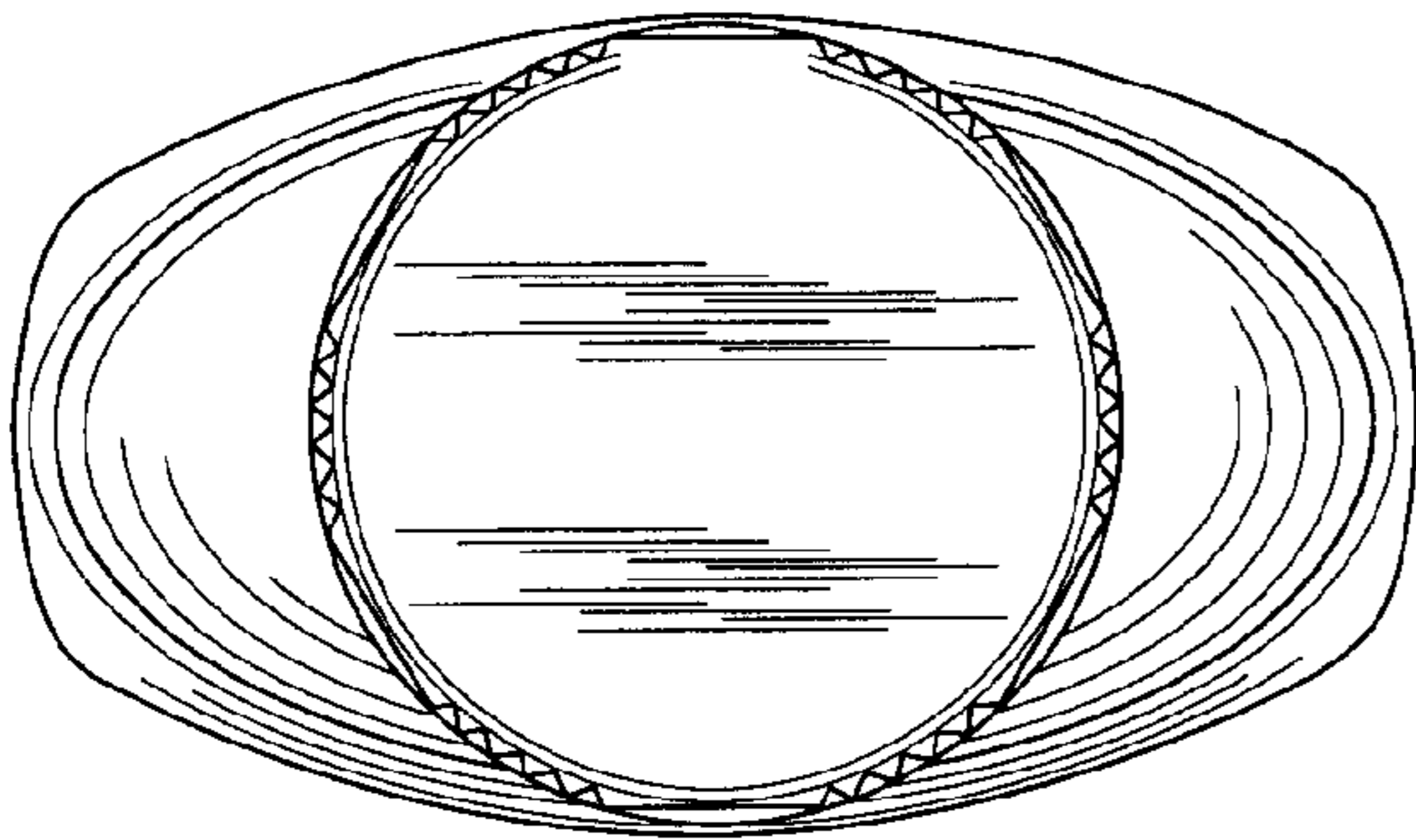

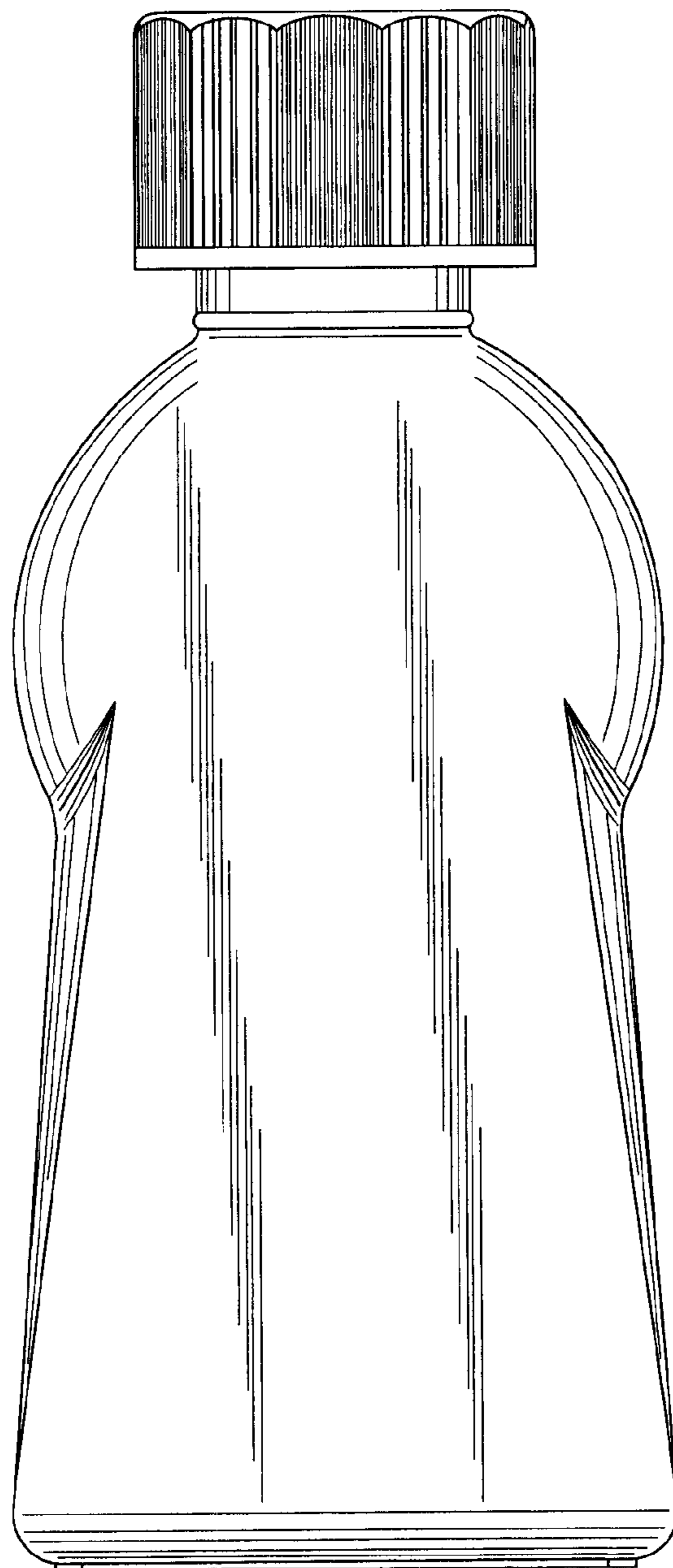

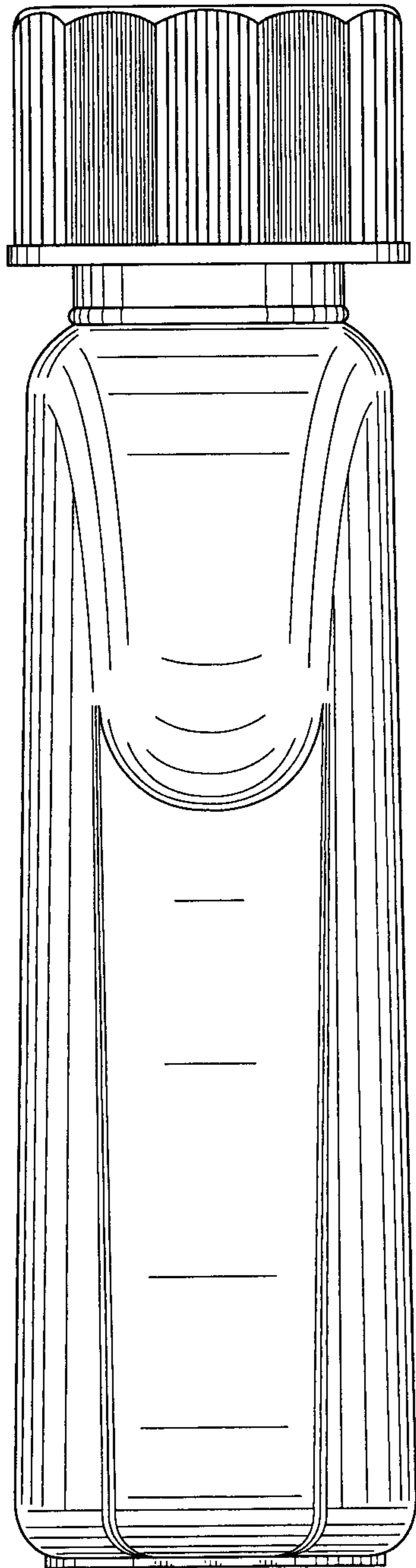

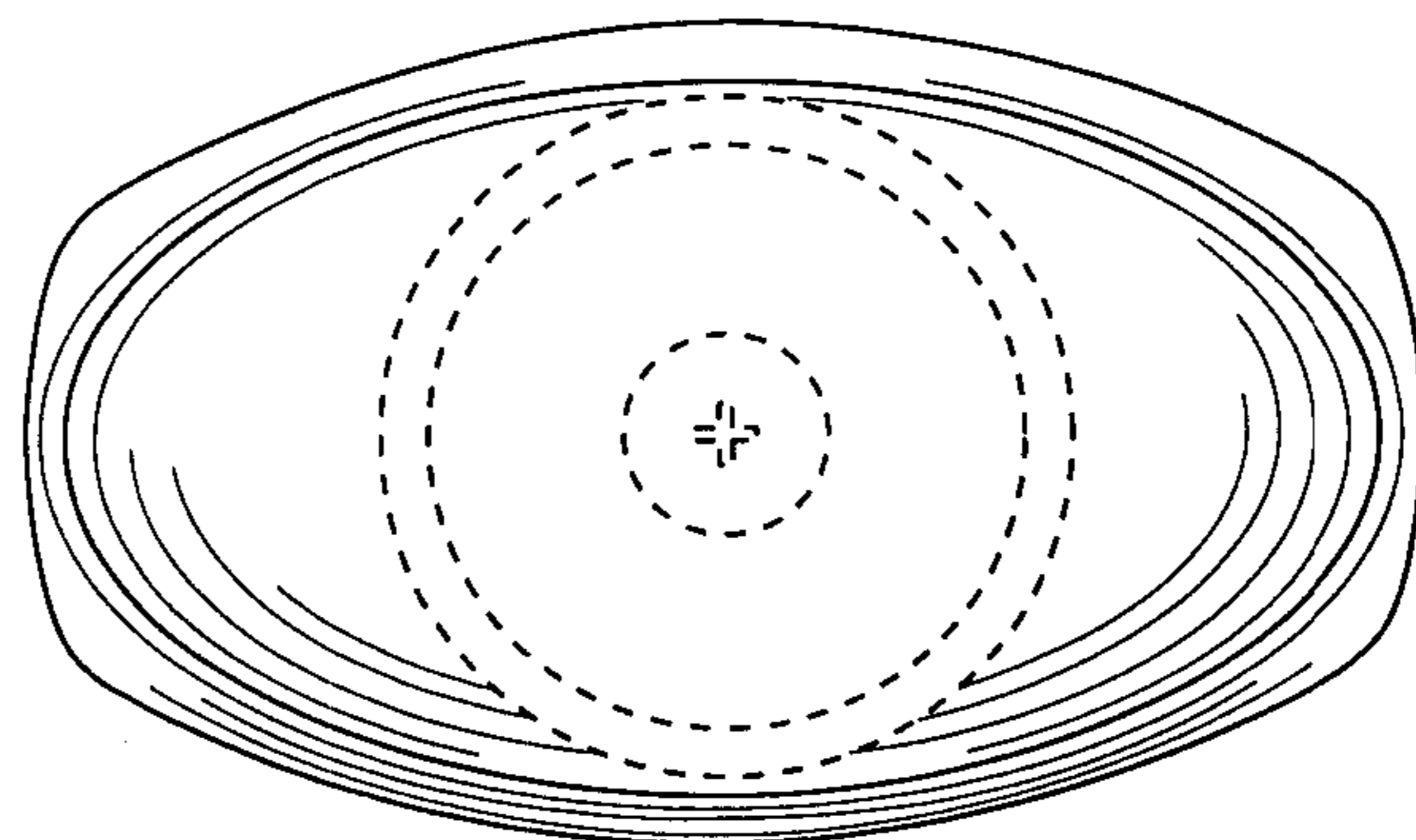
