The ornamental design for a paperboard bottle, as shown and described.

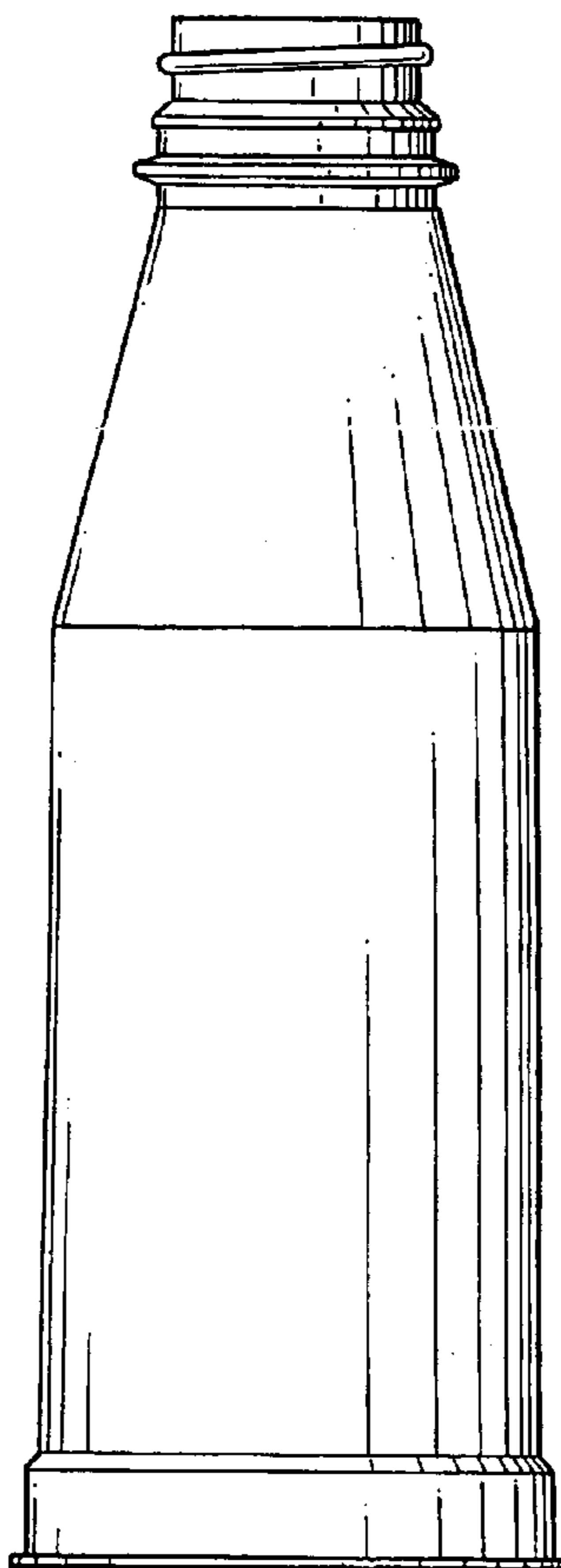
**DESCRIPTION**

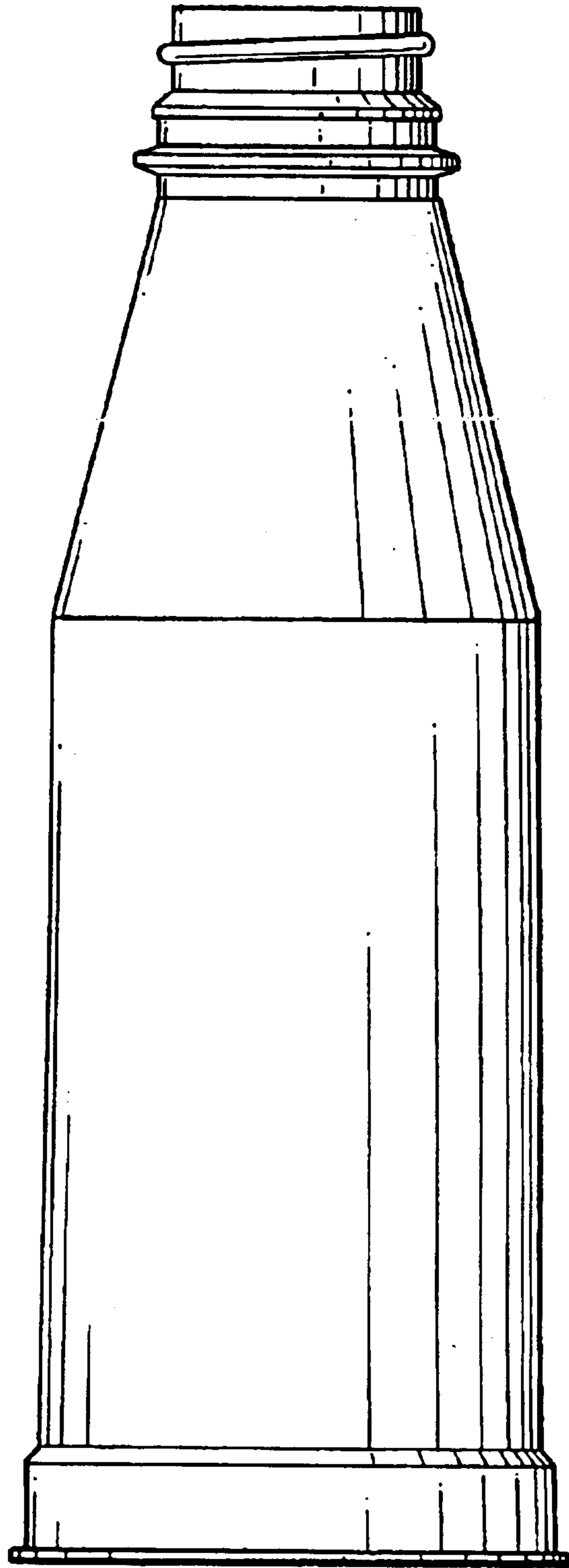

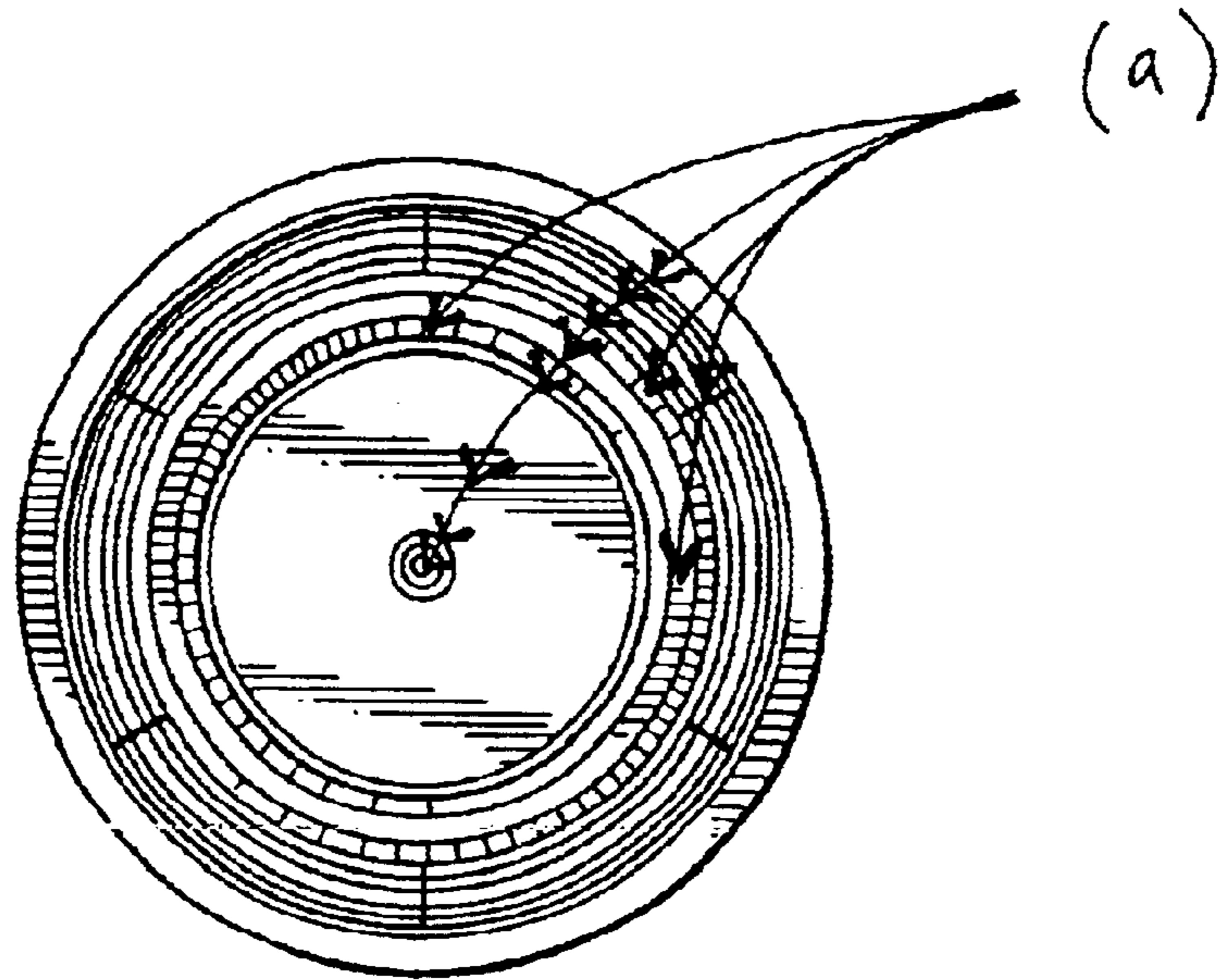

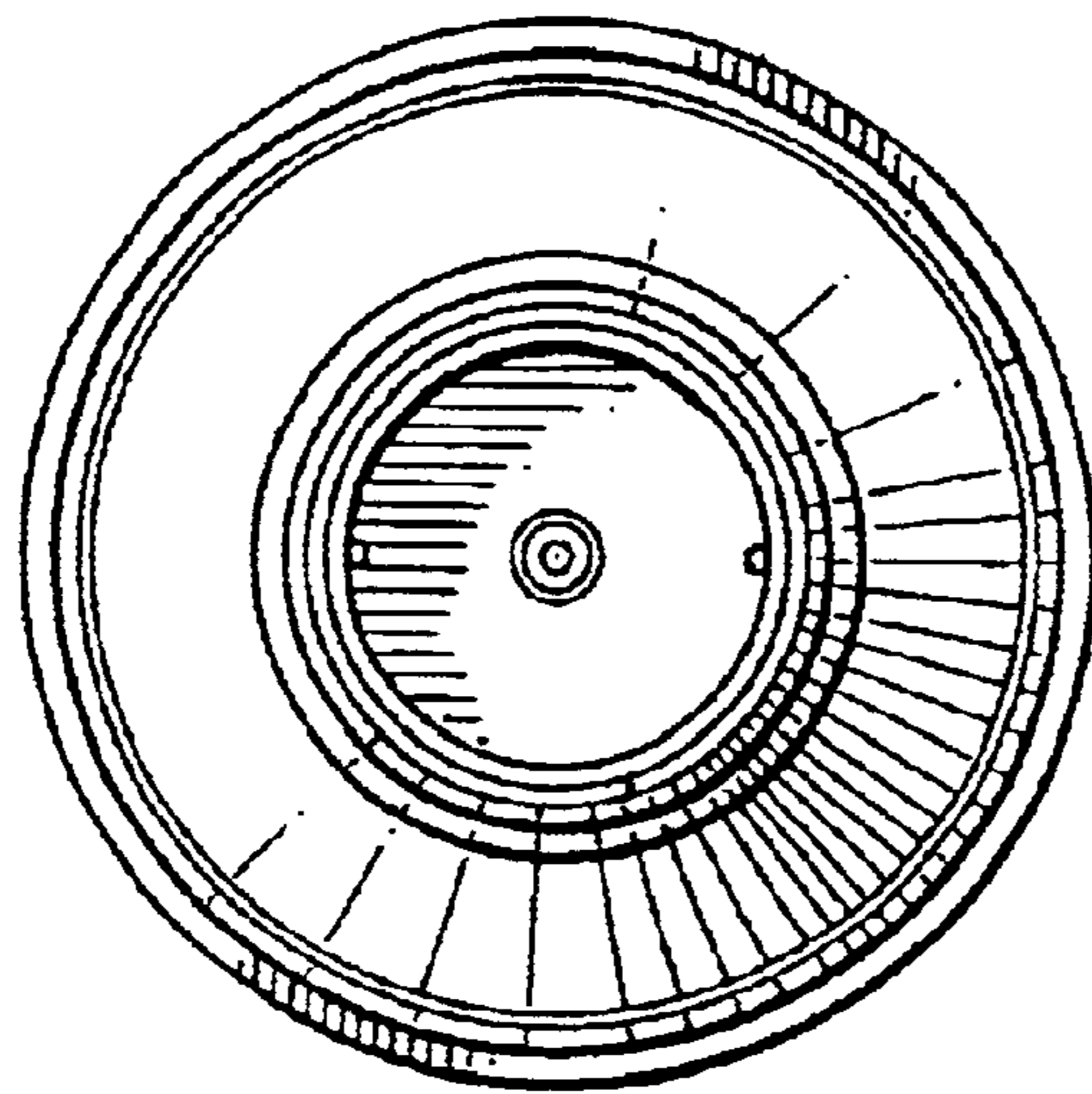

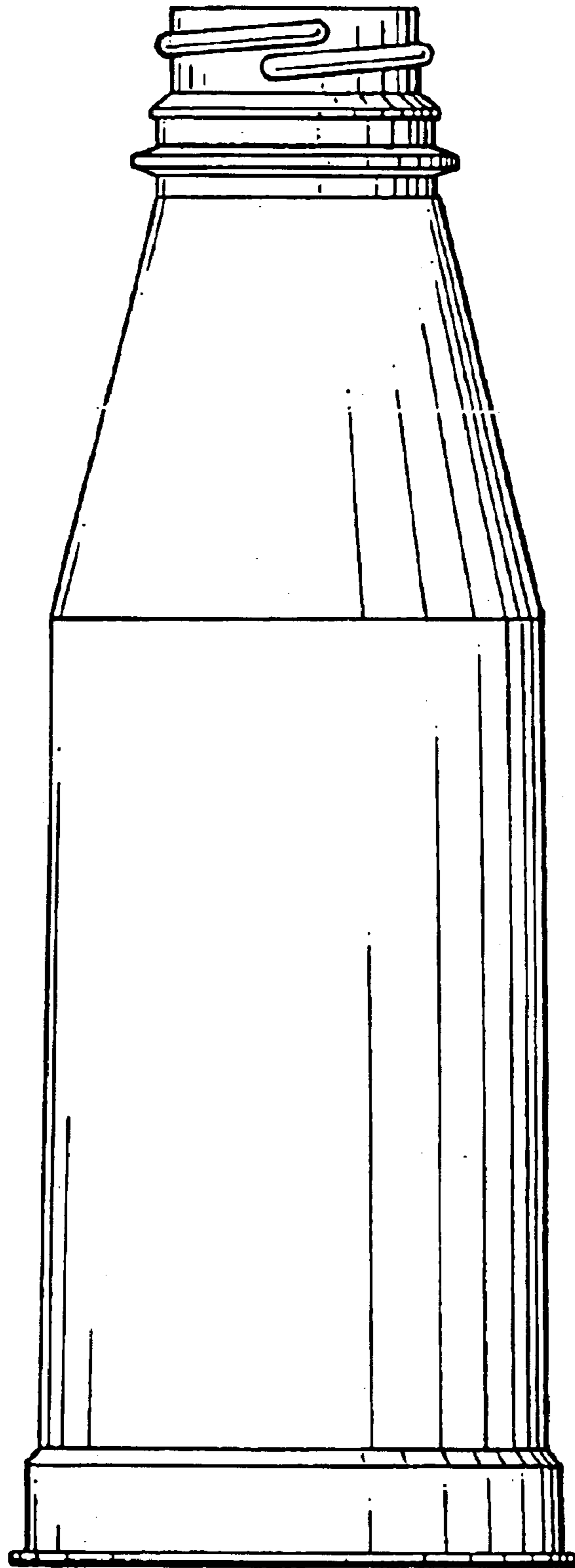
