The ornamental design for a surface configuration of a center console for a vehicle, as shown and described.

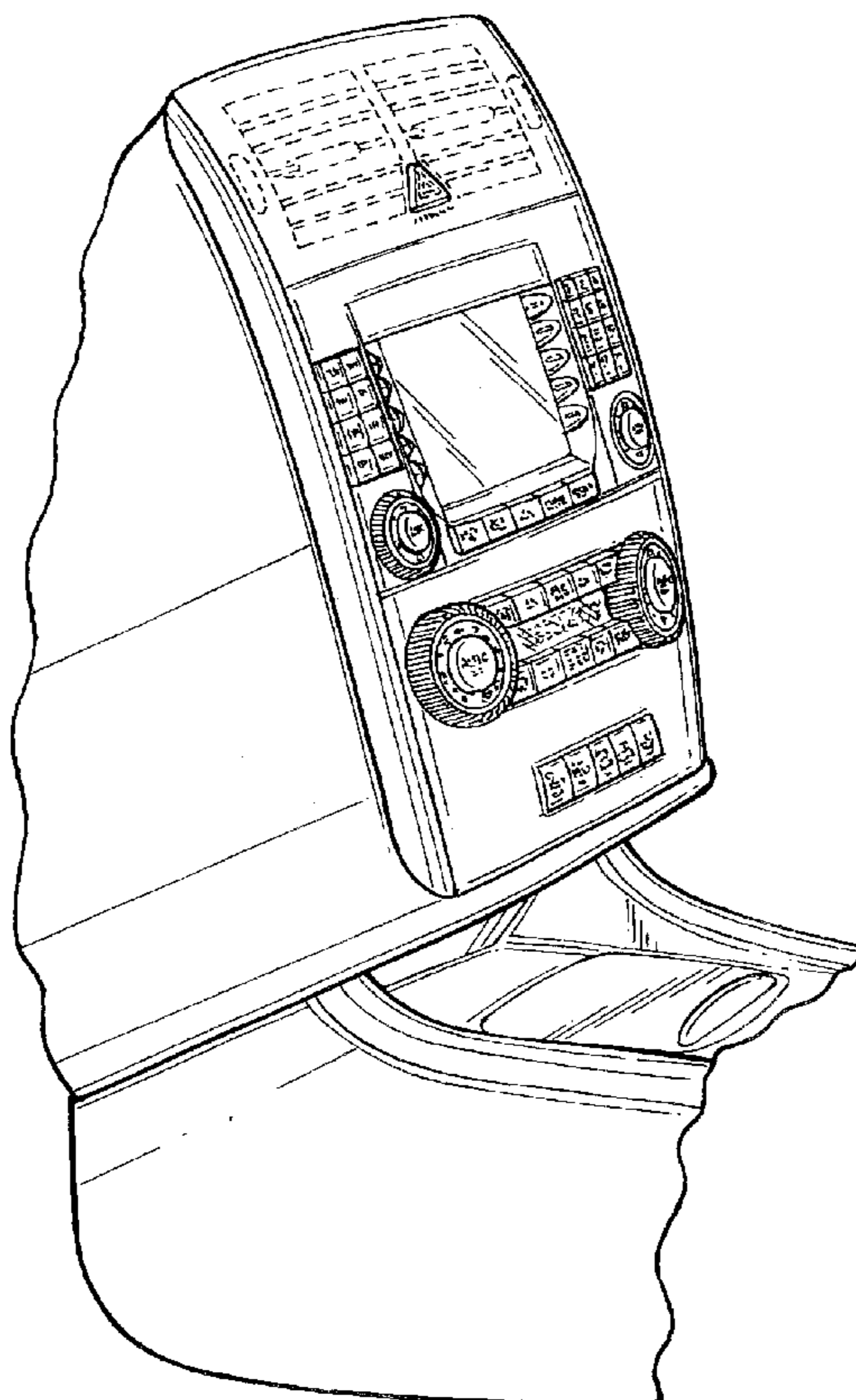
**DESCRIPTION**

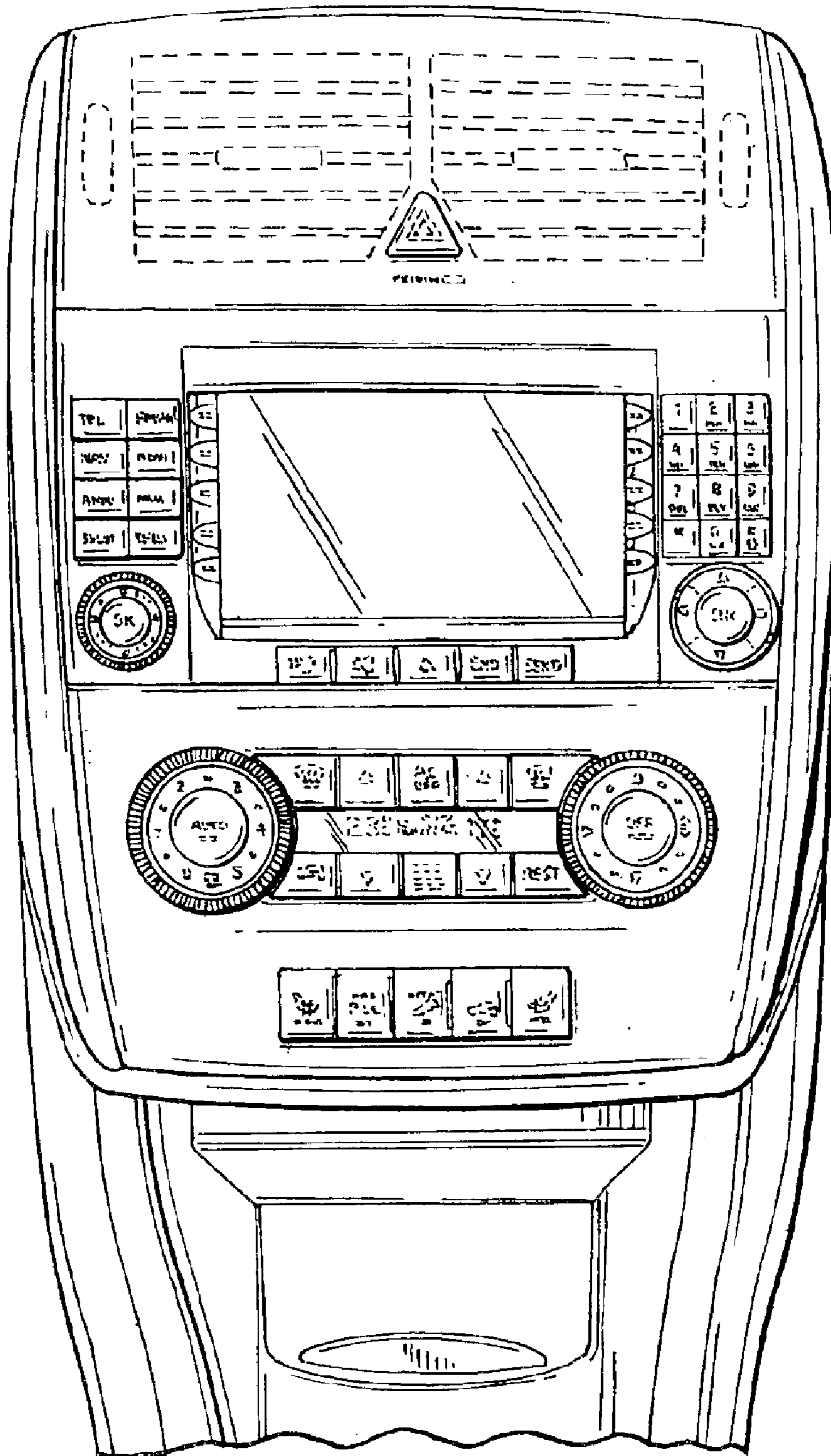

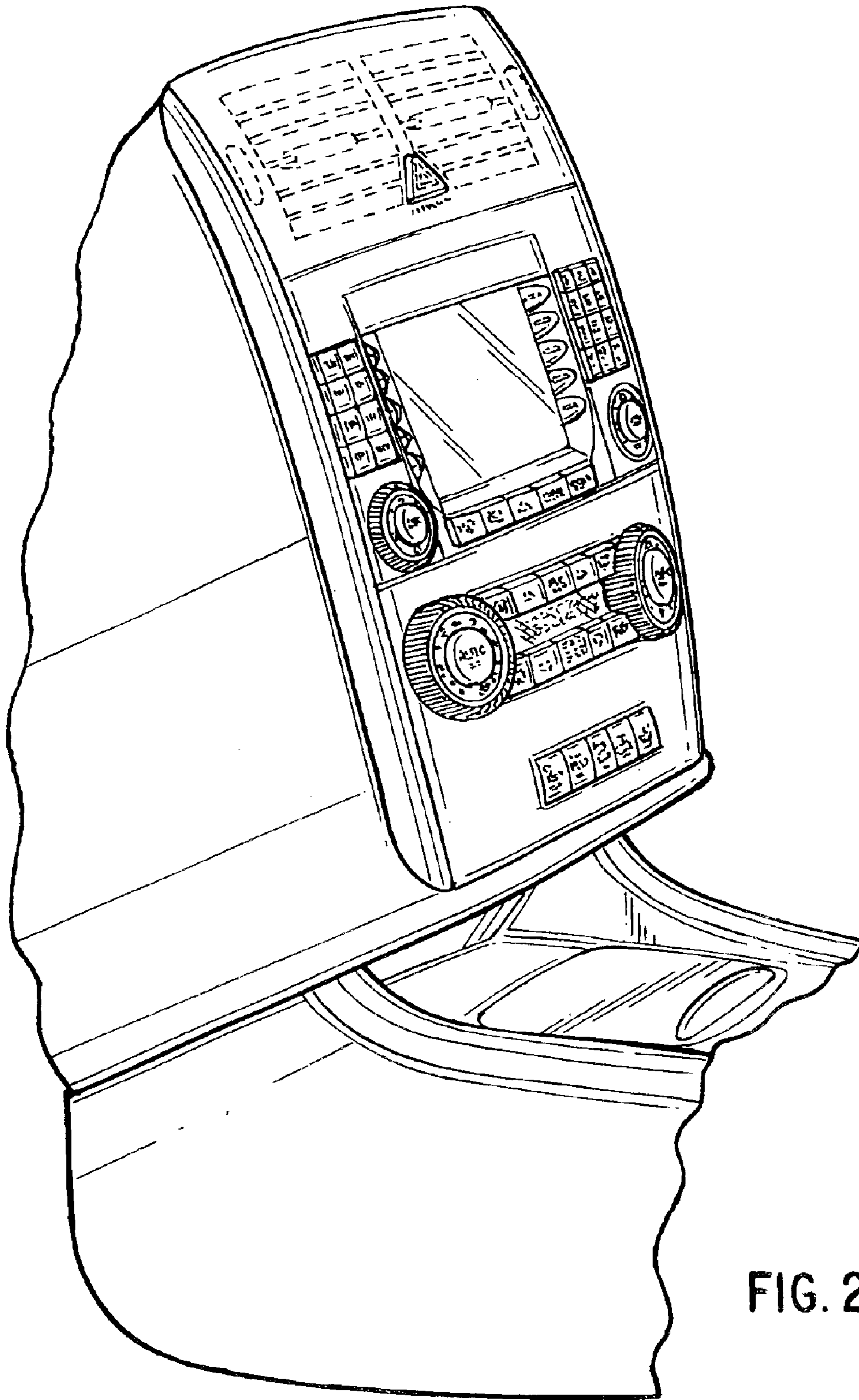
