(57) **CLAIM**

The ornamental design for the medical device for injecting
fluid medicaments, as shown and described.

DESCRIPTION

FIG. 1 is a right-side view of a medical device for injecting
fluid medicaments of our new design, the left-side view
being a mirror image thereof;

FIG. 2 is a right-side view of our new design, with an end
cap removed, the portion of the device shown in dashed lines
forming no part of the claimed design;

FIG. 3 is a front view of our new design;

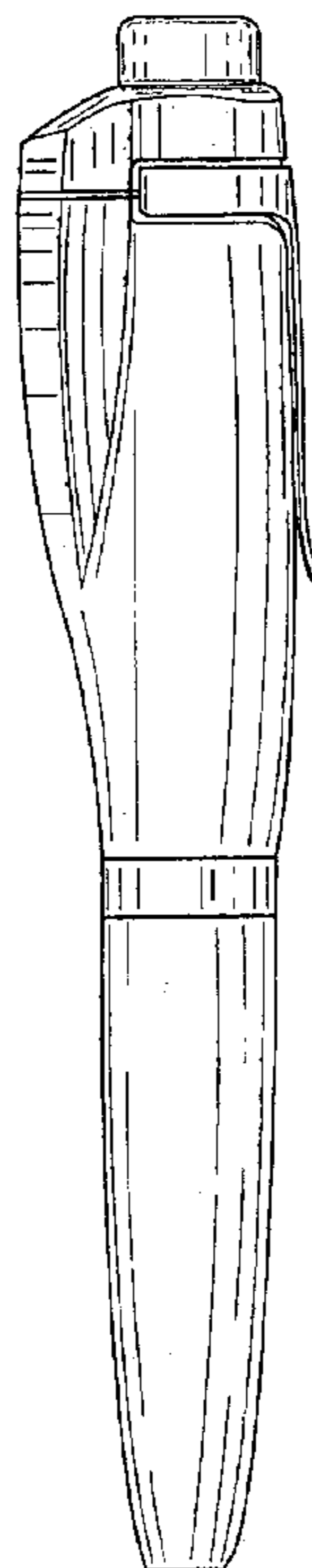
FIG. 4 is a rear view of our new design;

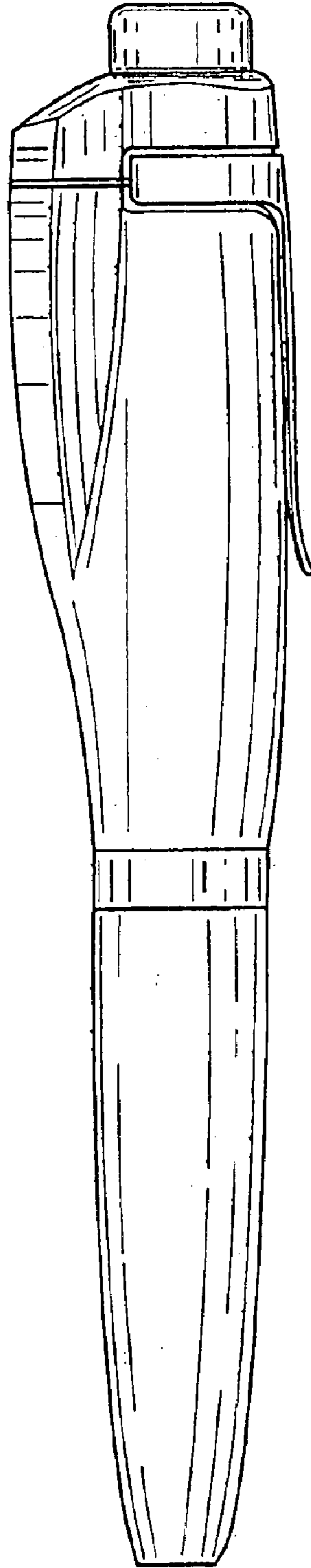

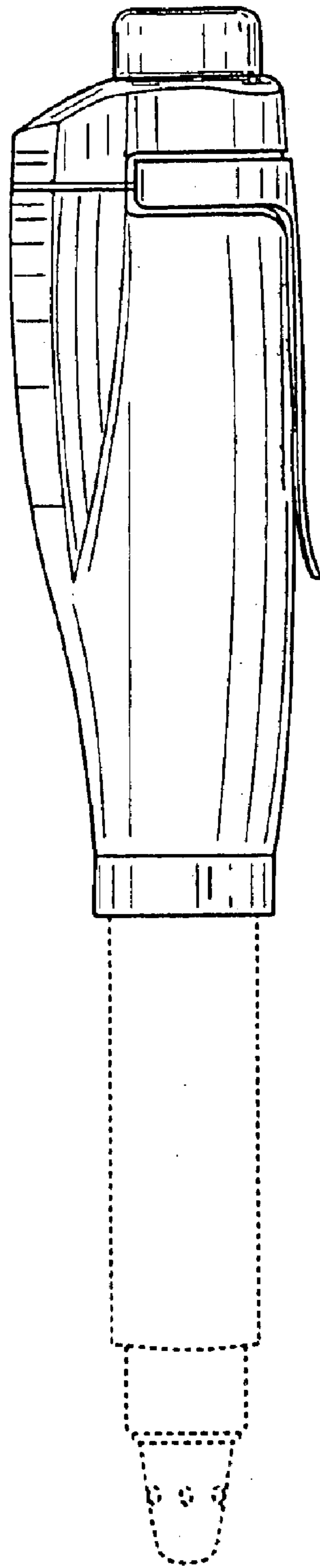

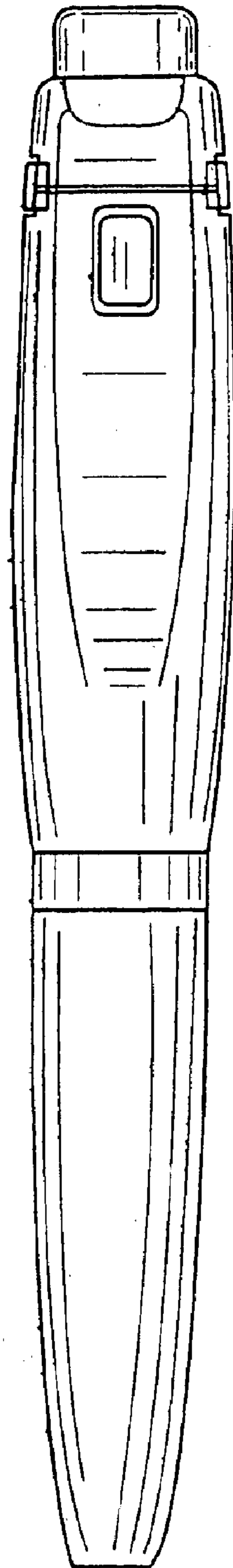

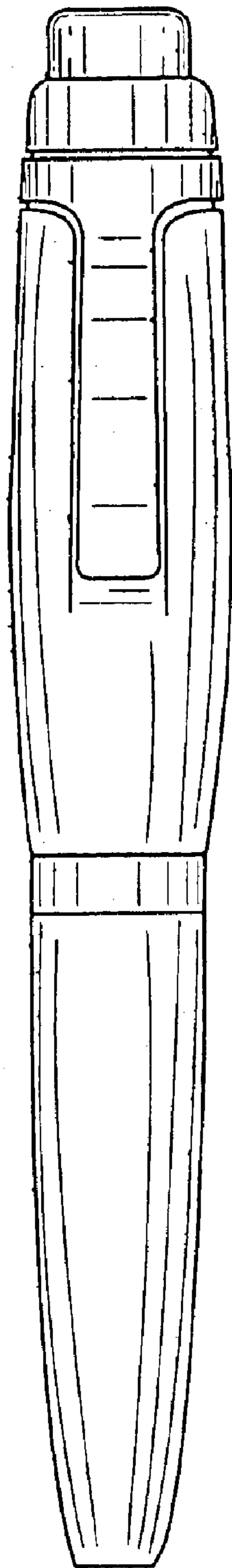

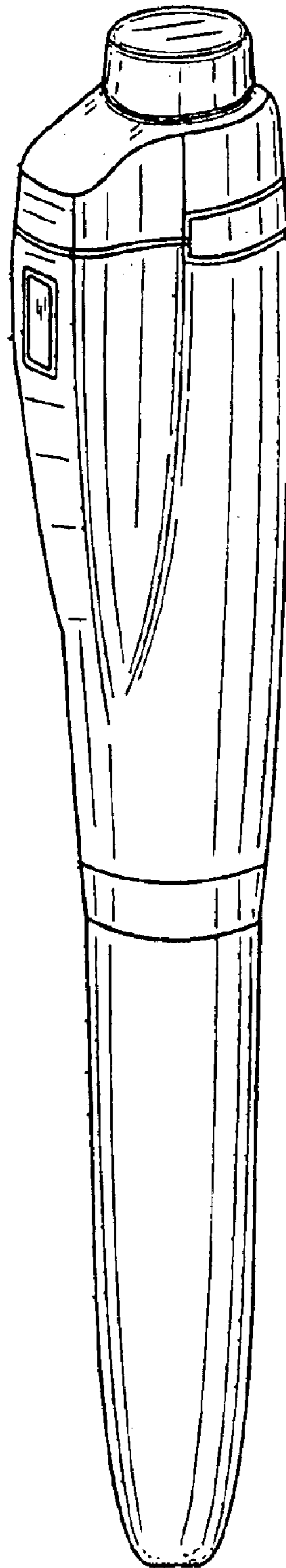

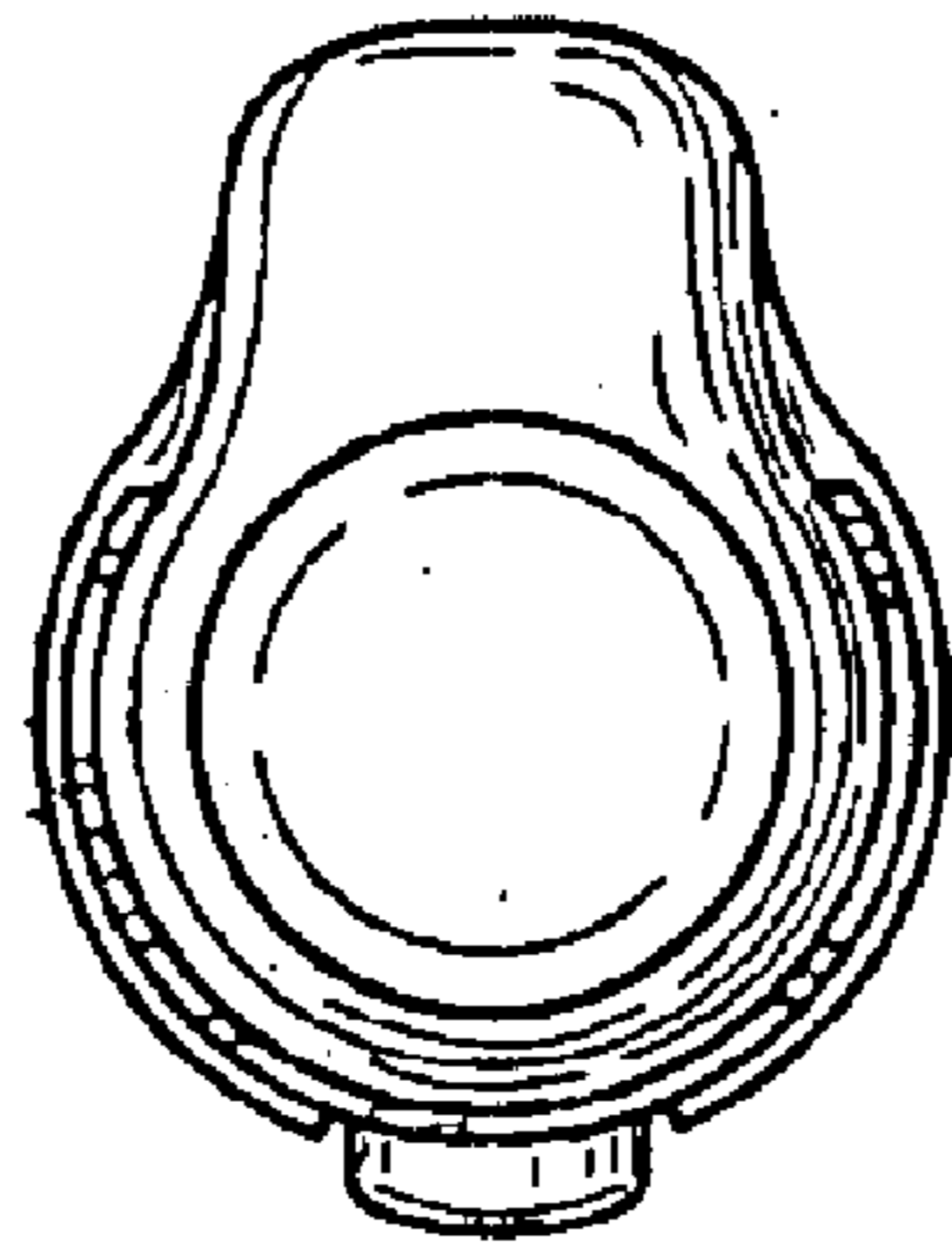

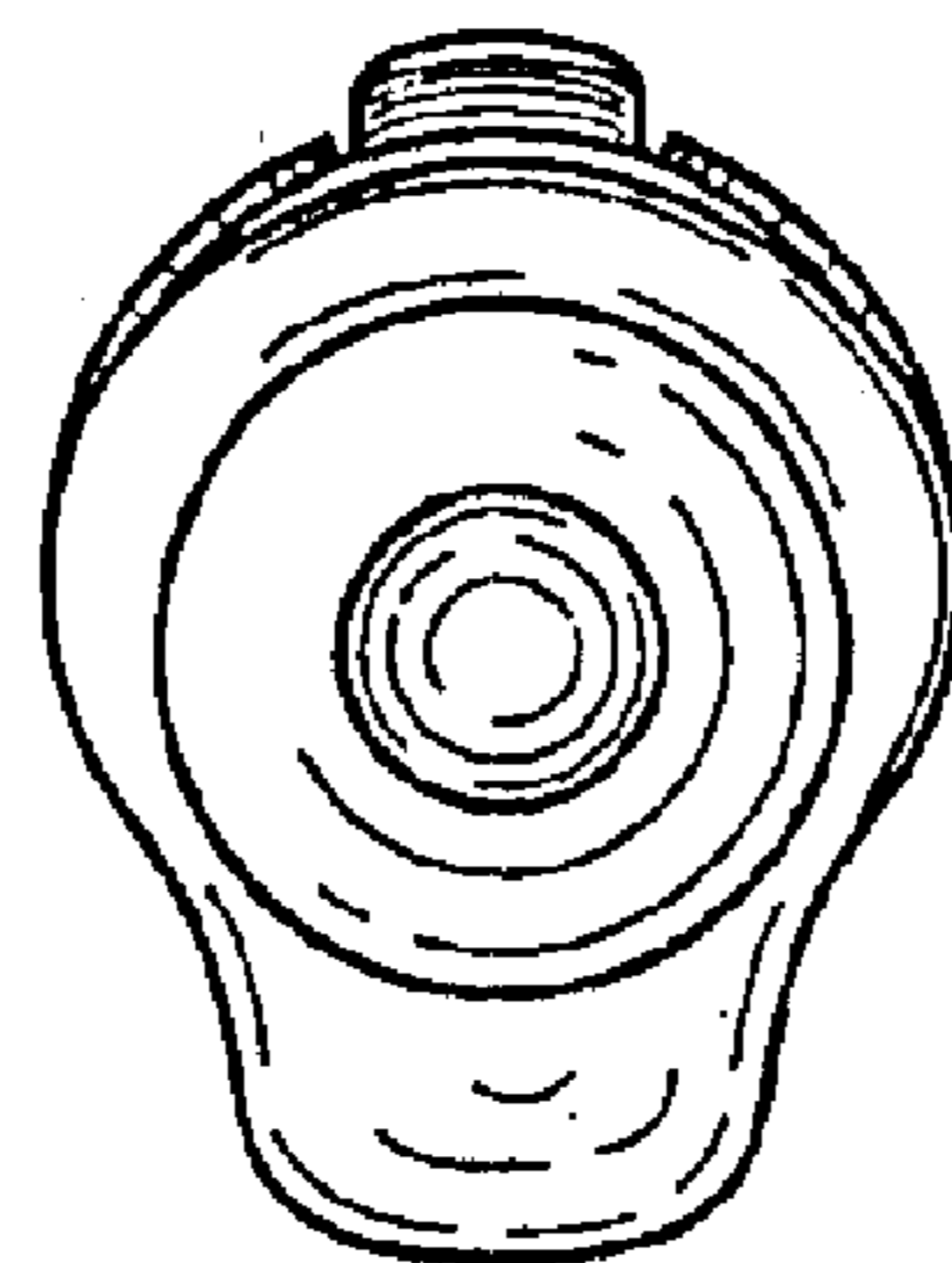
