DESCRIPTION

FIG. 1 is a perspective view of an ankle-foot orthosis, showing our new design;

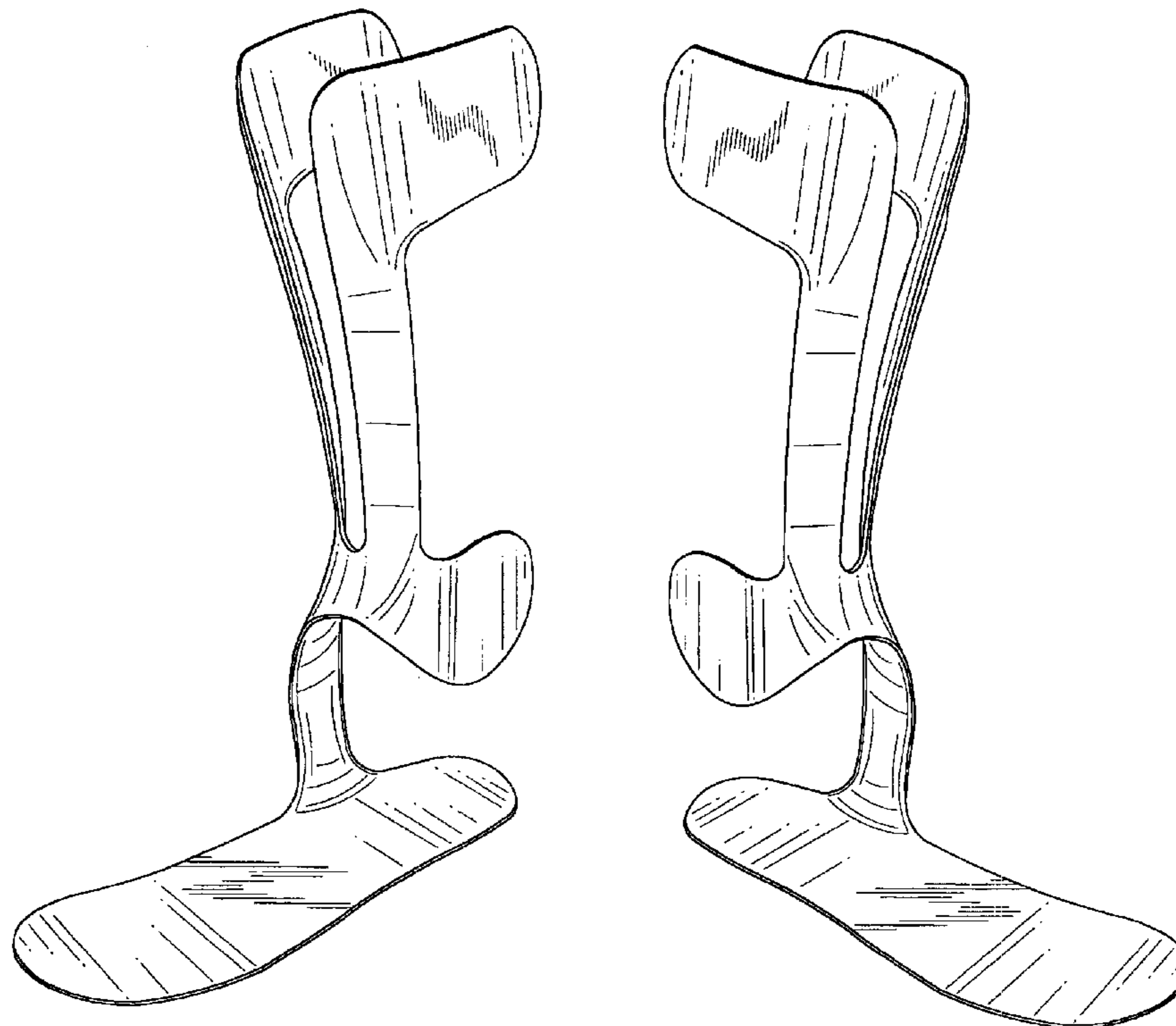

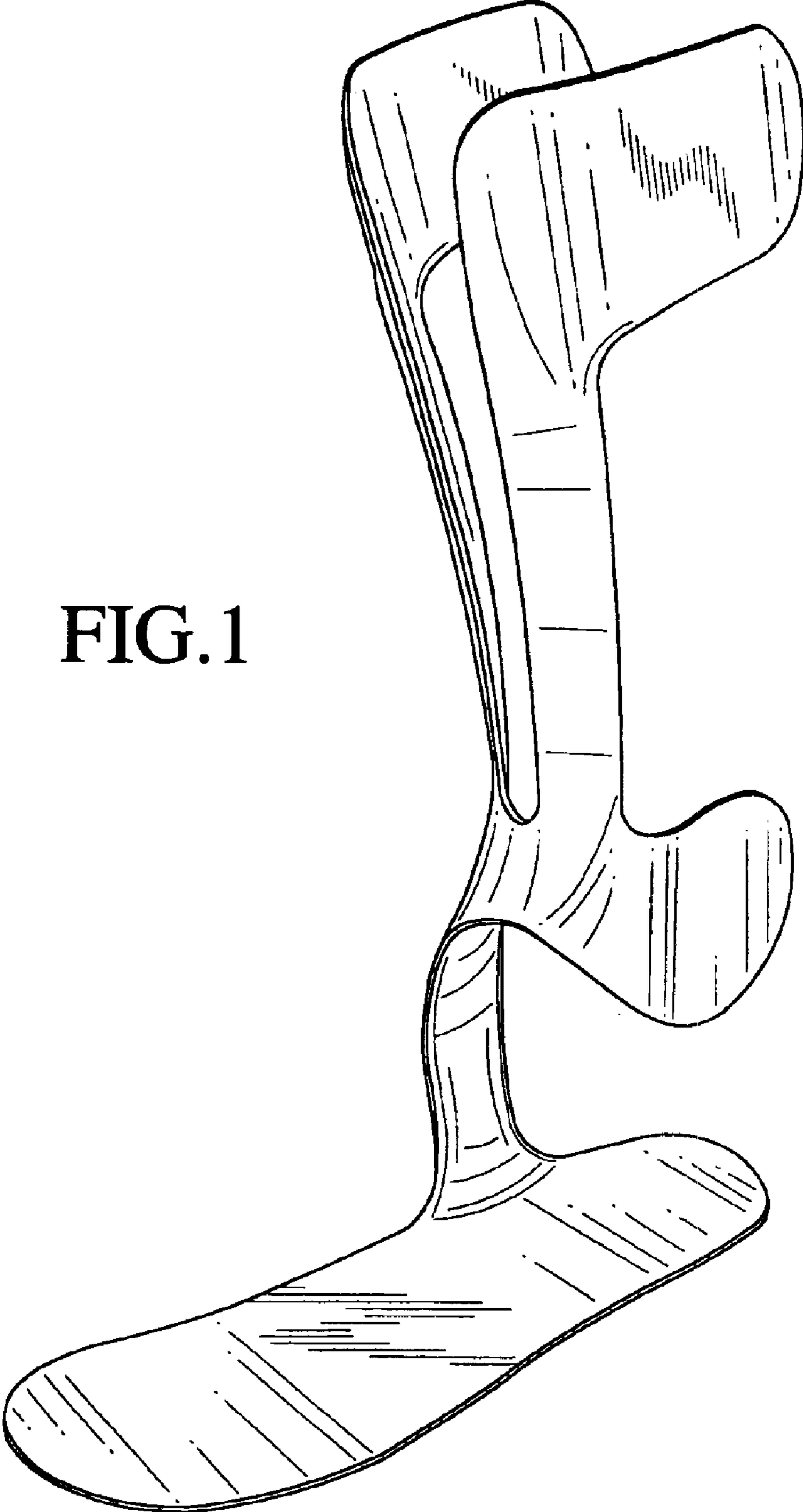

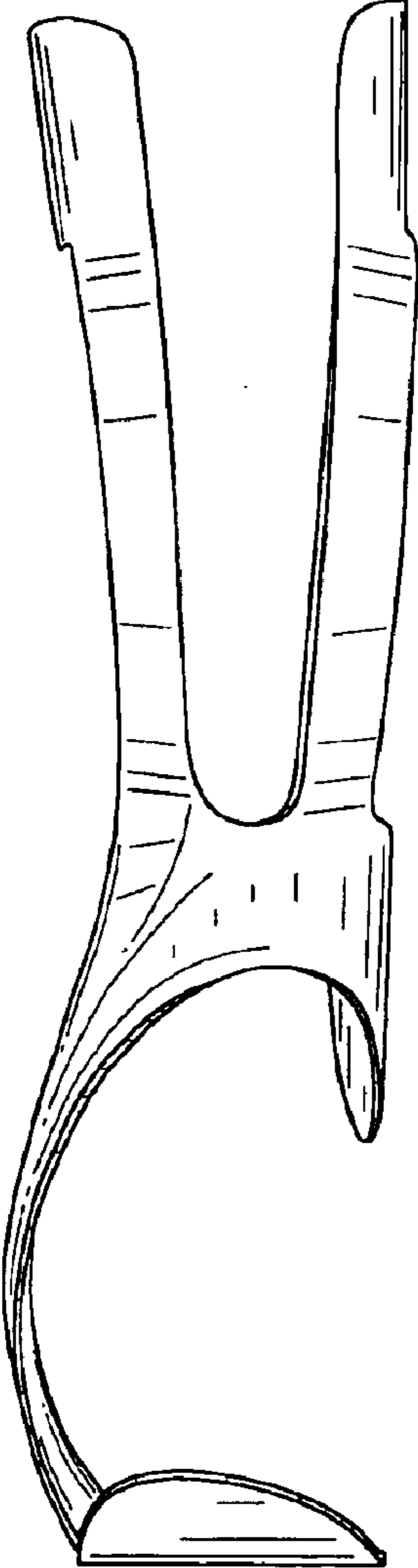

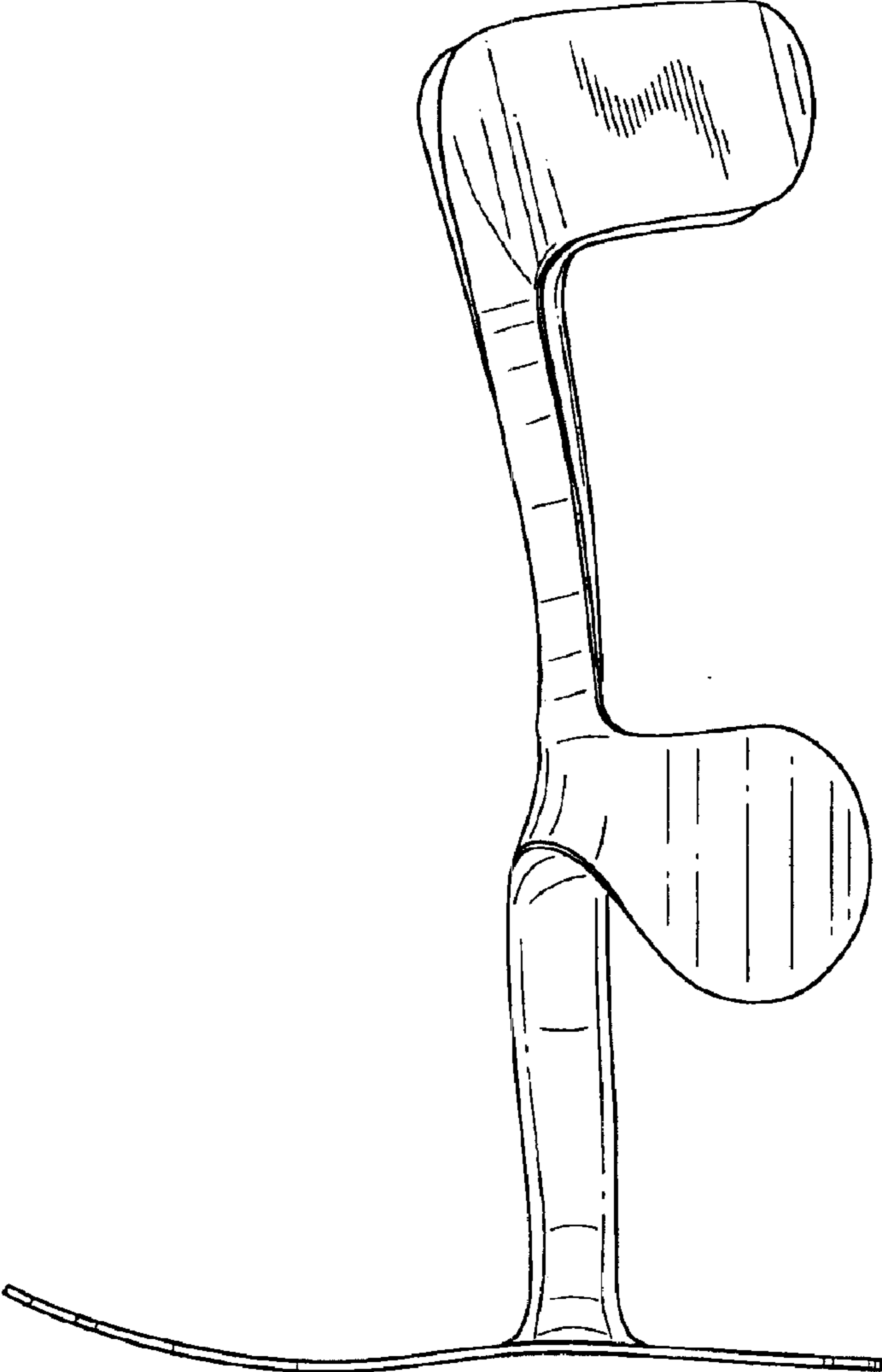

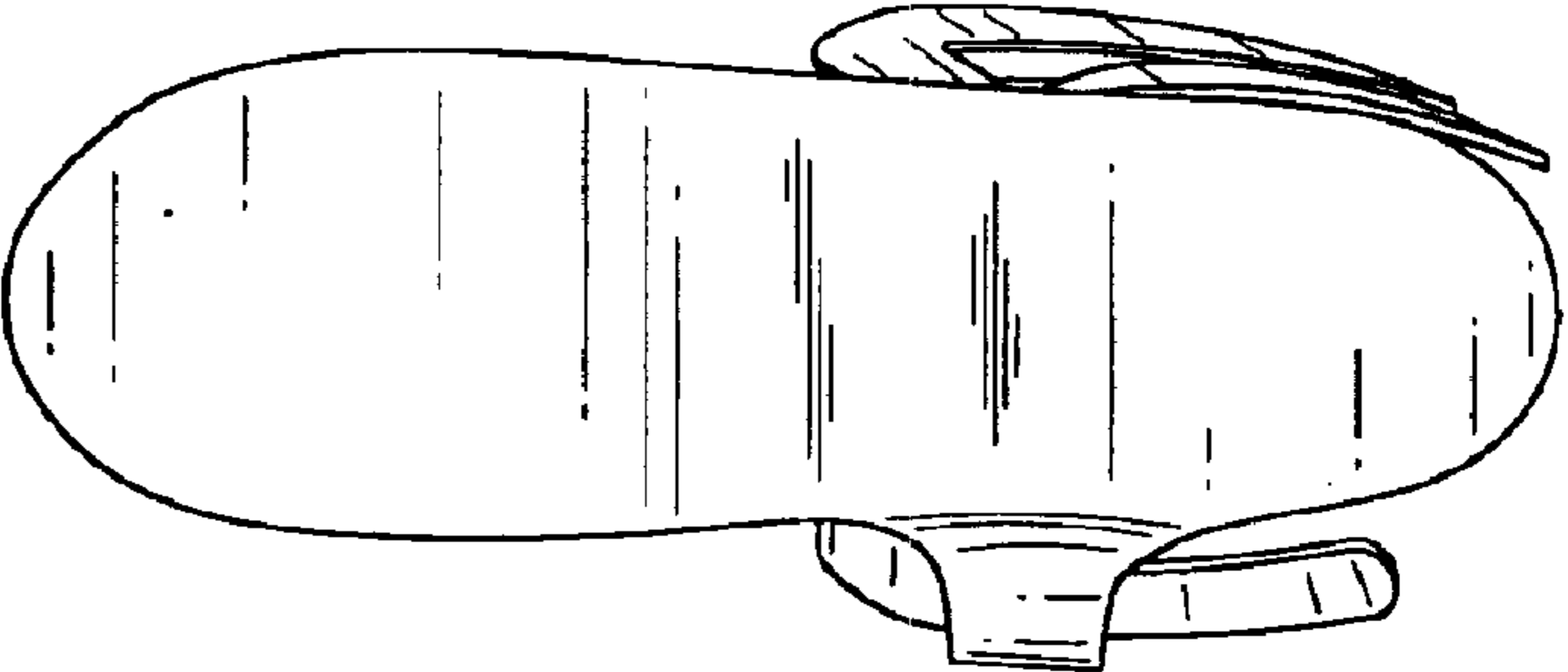

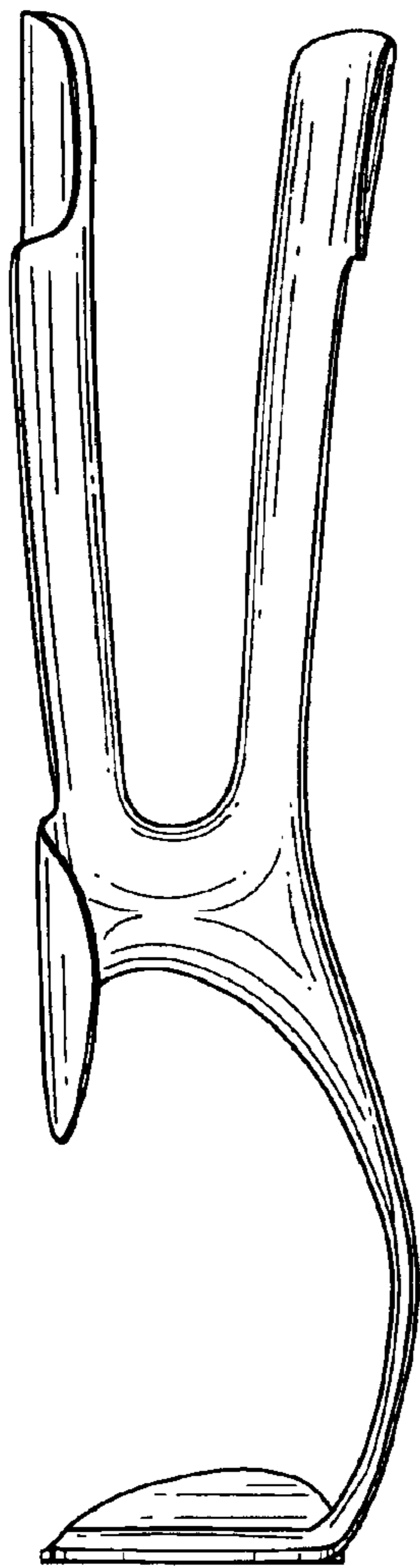
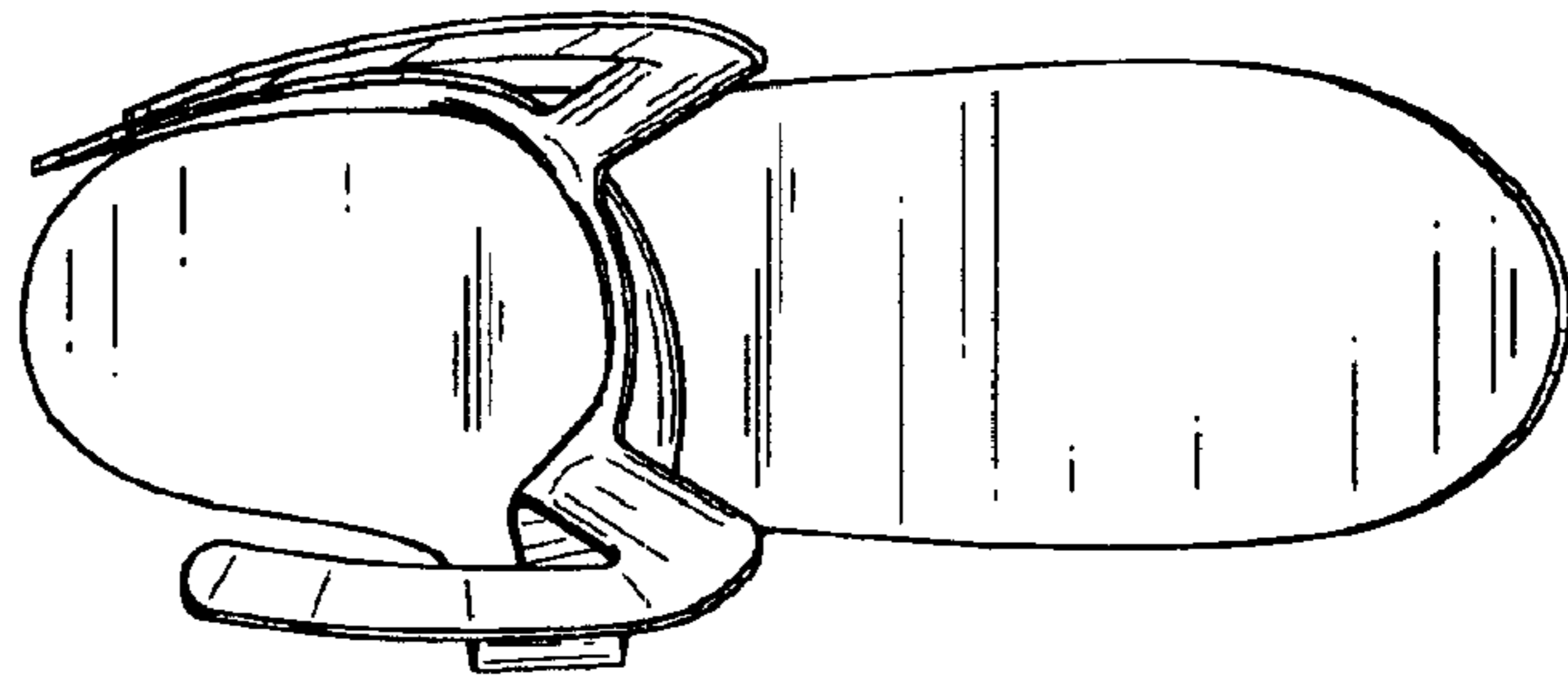

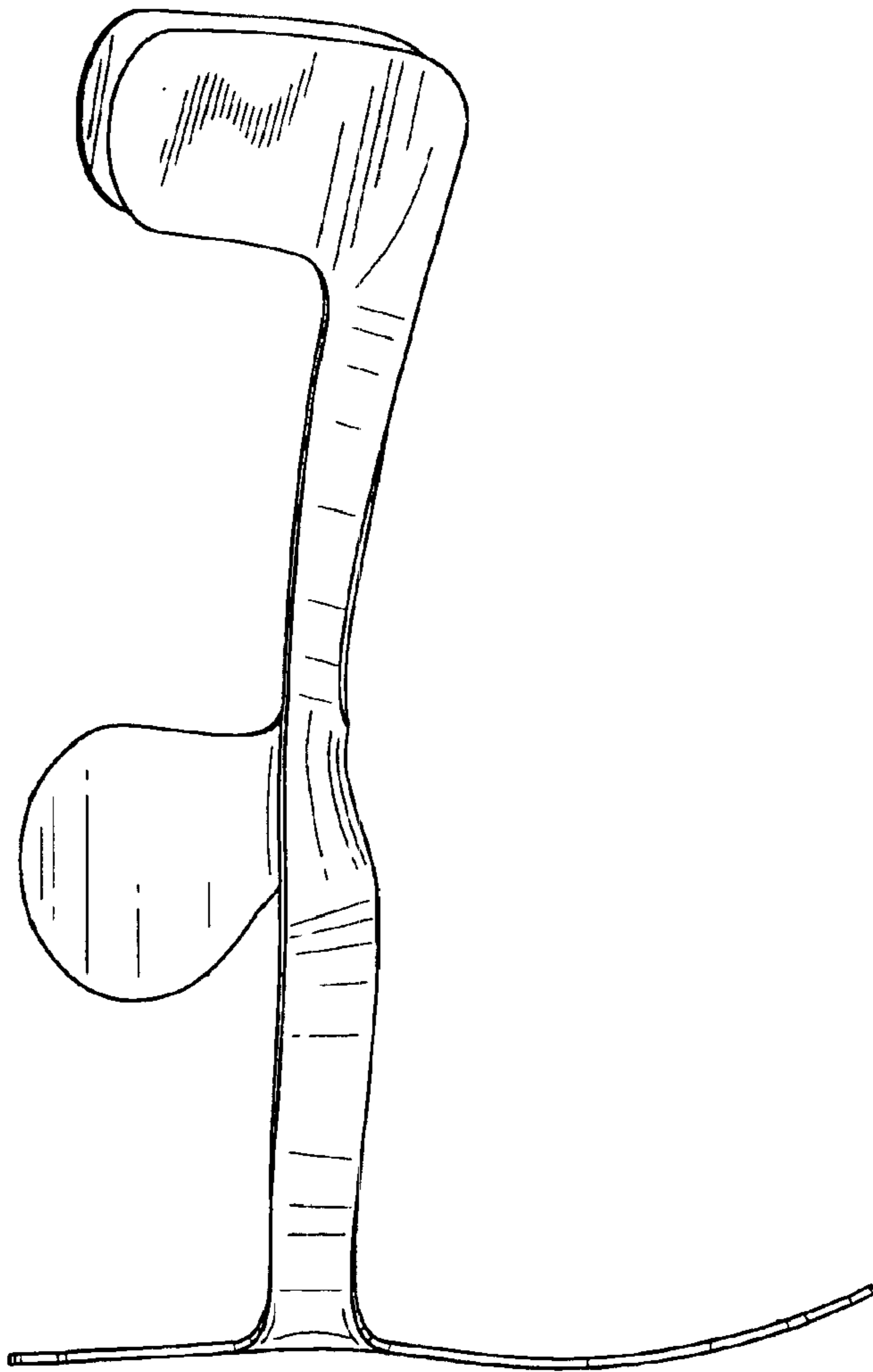

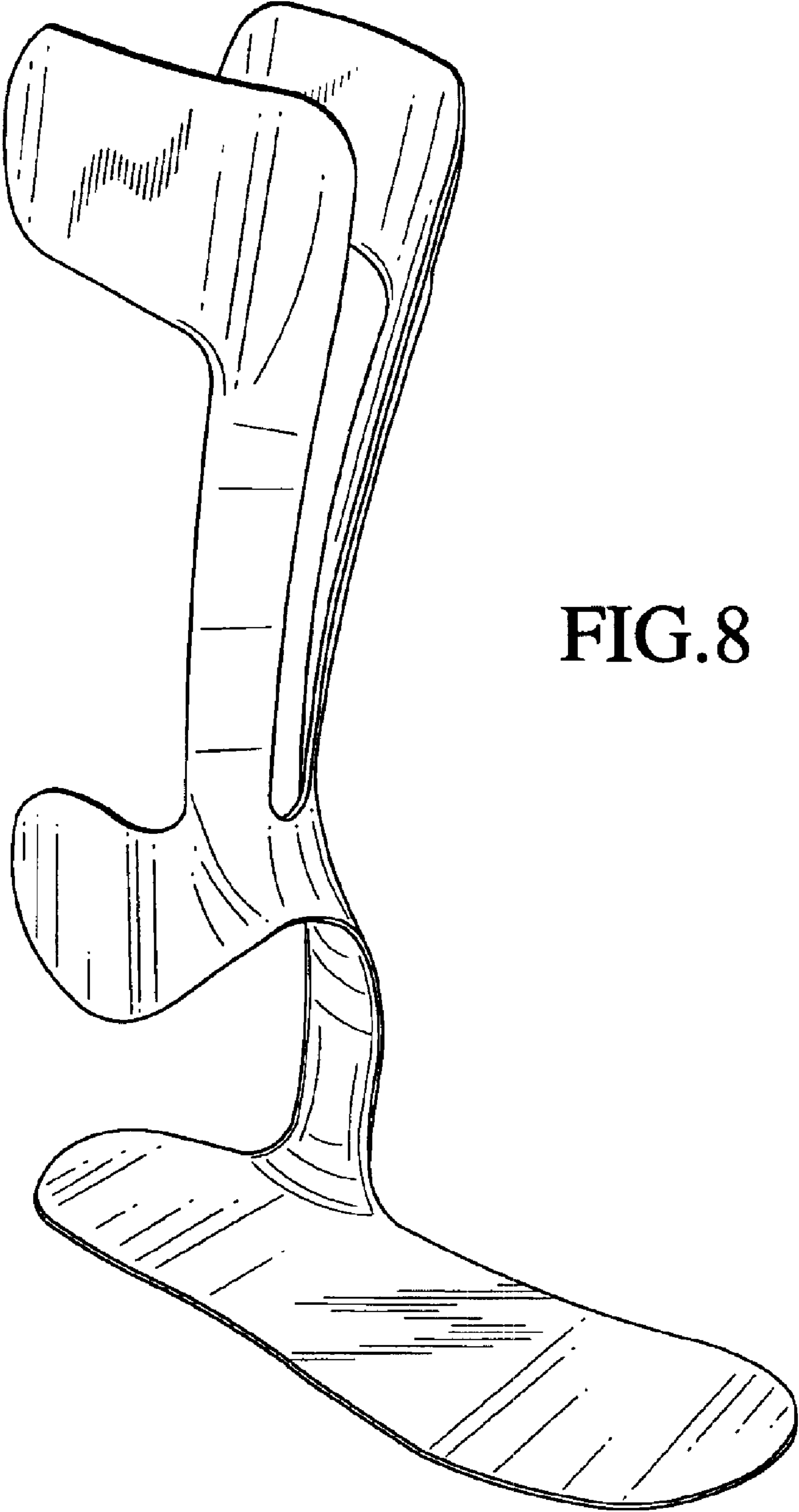

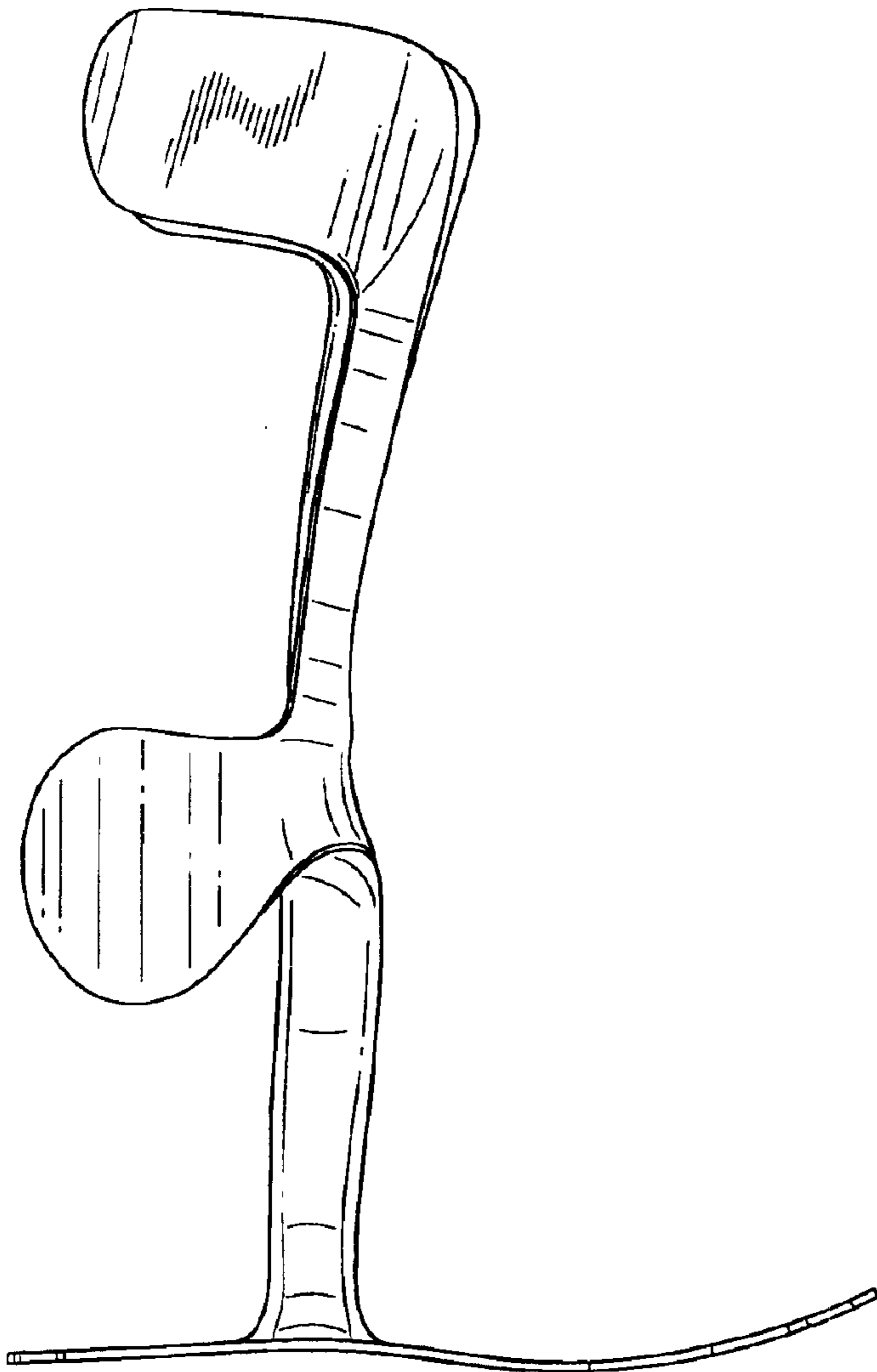

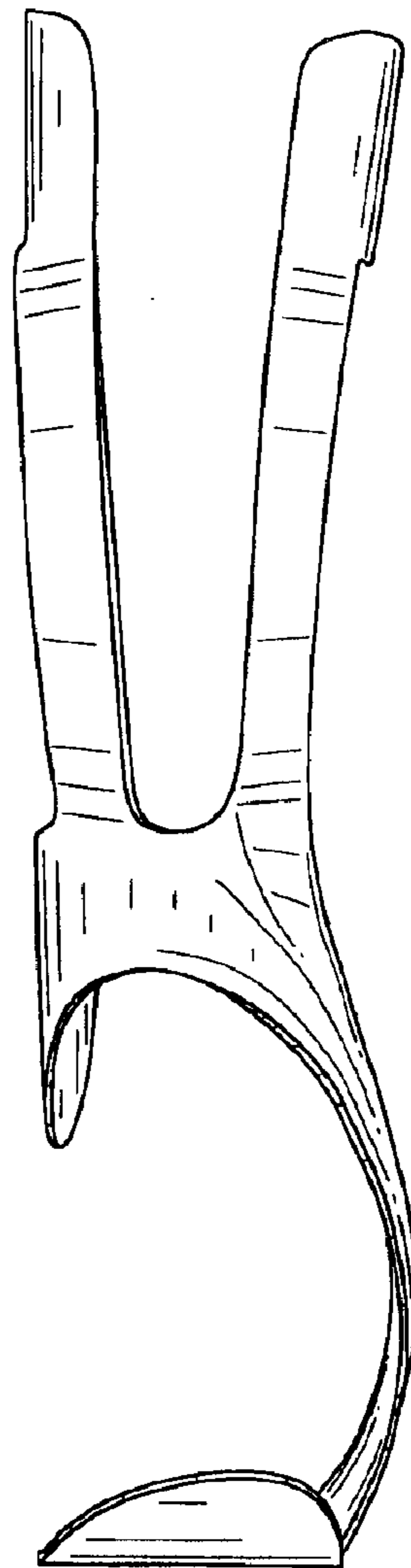

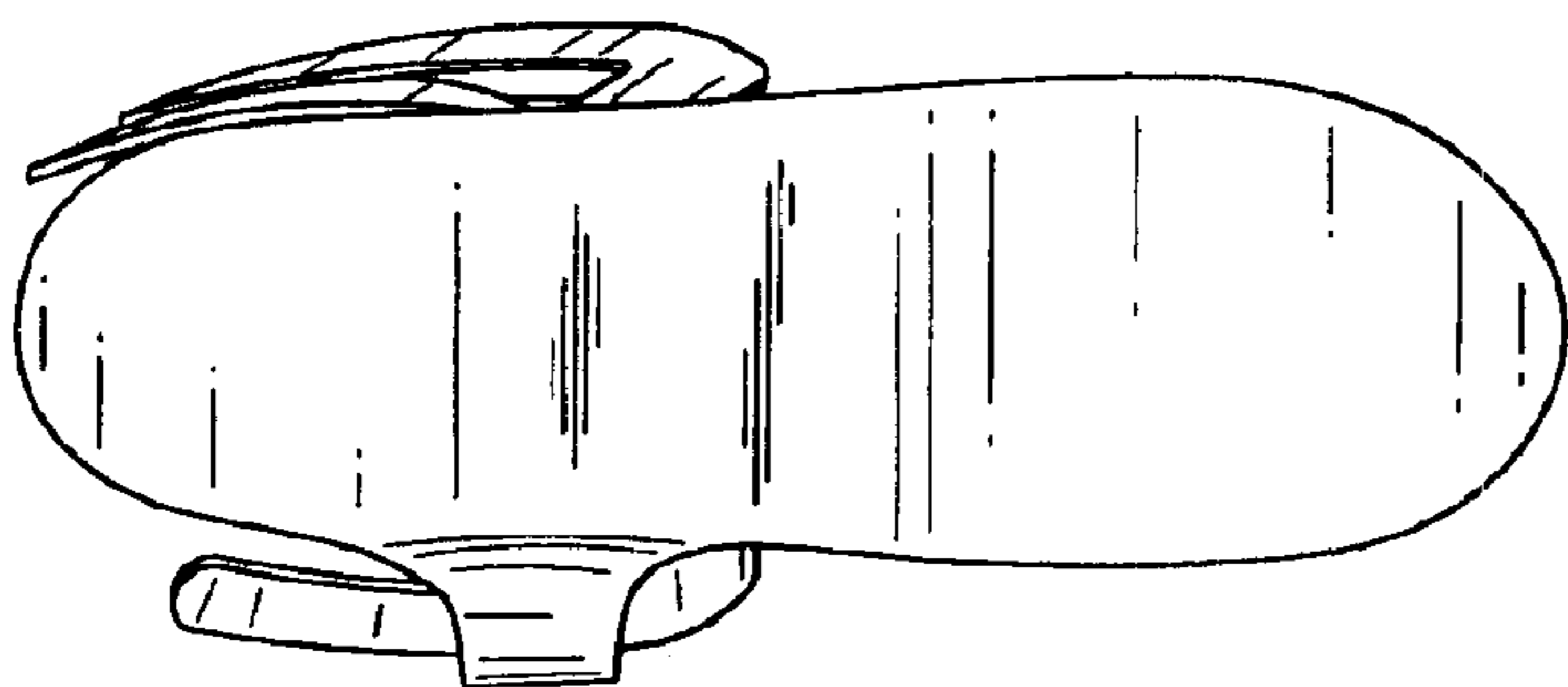

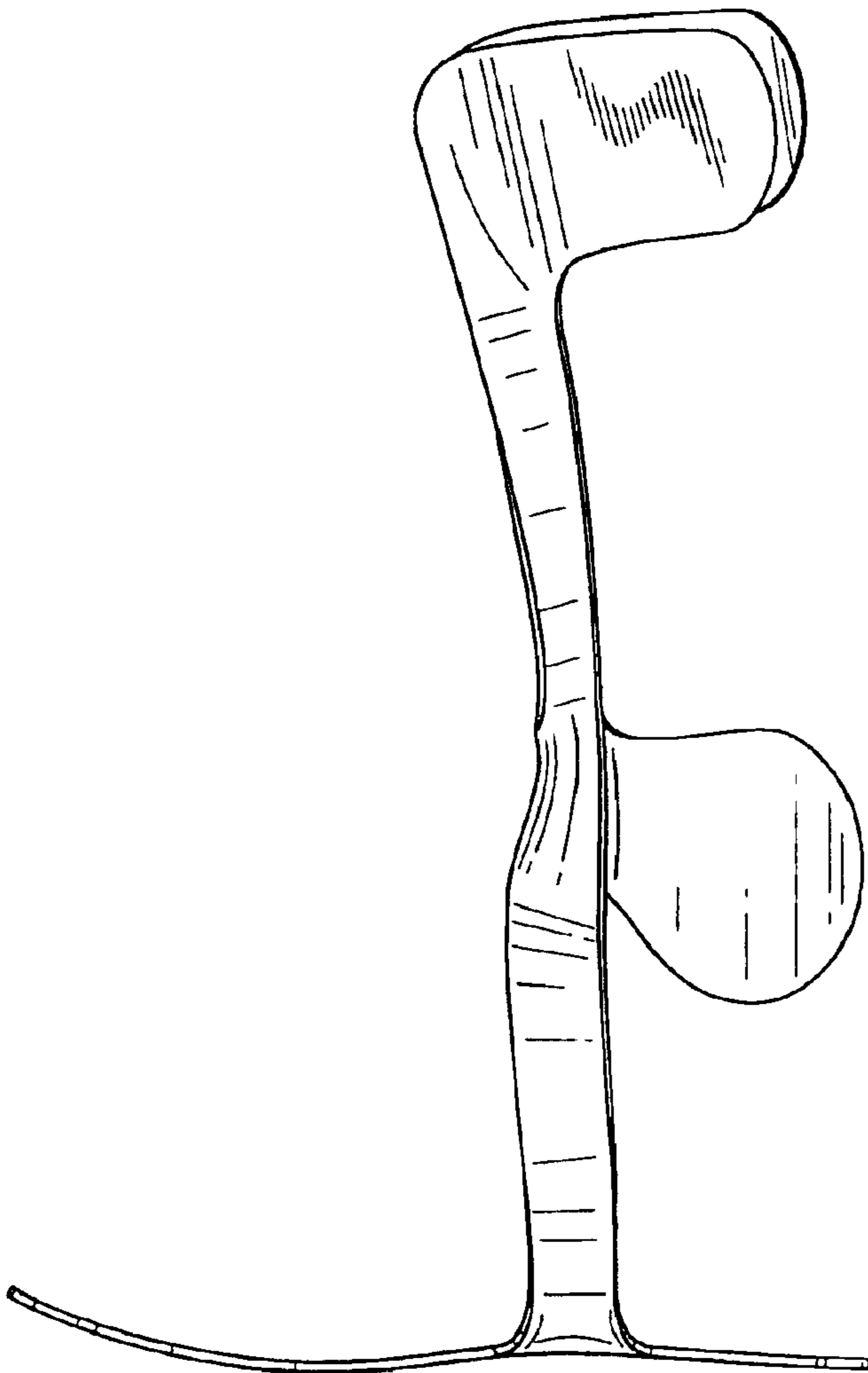
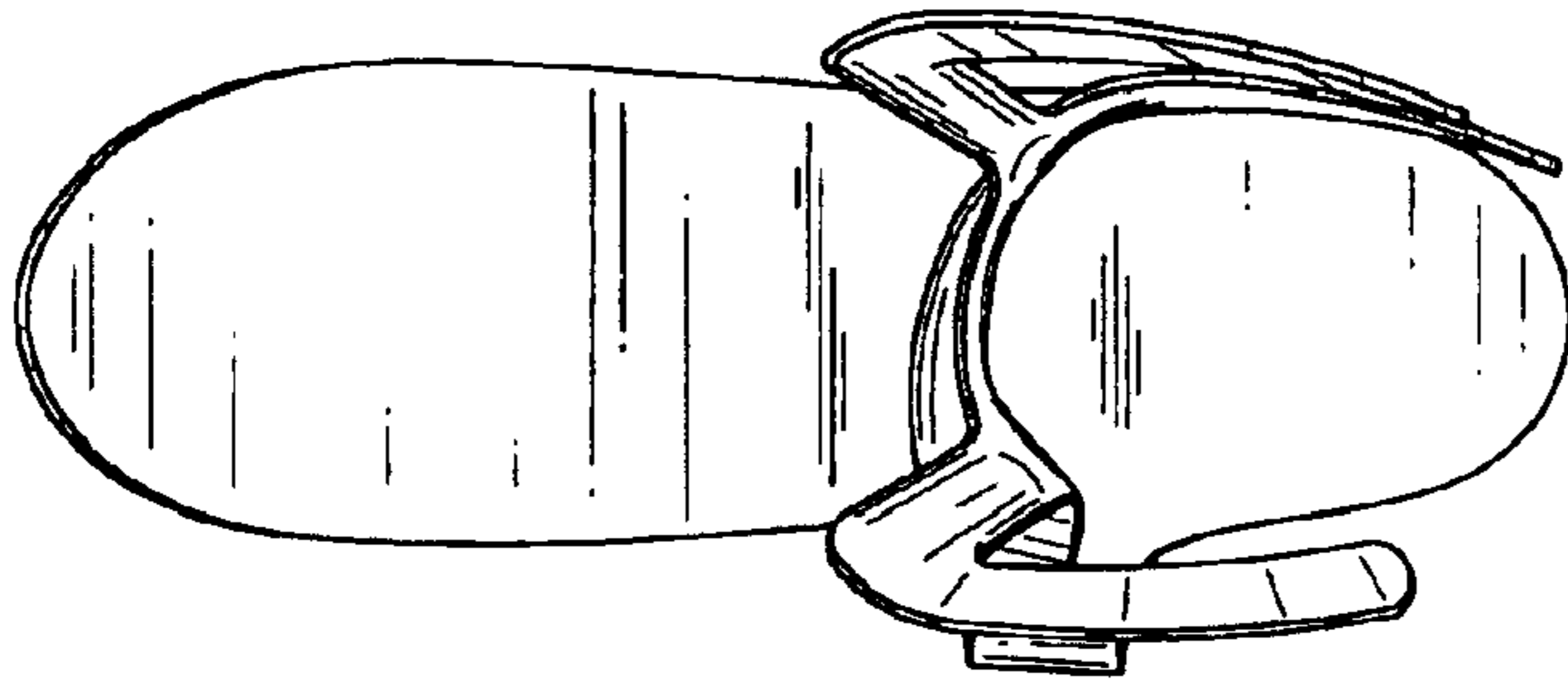

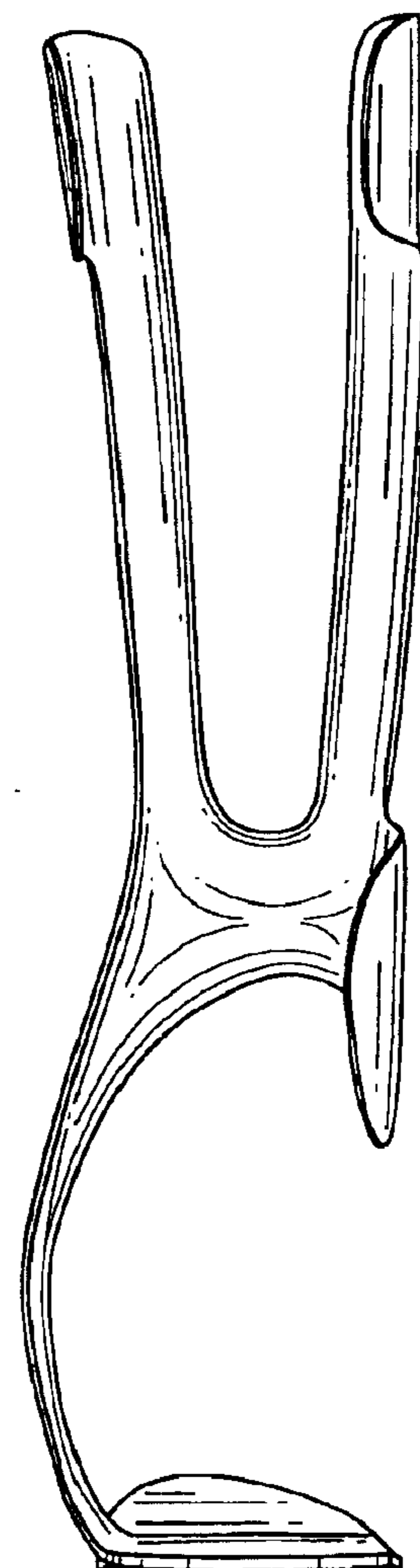
