
(57) **CLAIM**

The ornamental design for a lipstick shape motion lamp, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a lipstick shape motion lamp showing my new design, there are 3 rings on the middle section of the main body for decoration purpose;

FIG. 2 is a right side elevation view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a front elevation view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a left side elevation view;
FIG. 7 is a rear elevation view thereof;
FIG. 8 is a perspective view similar to FIG. 1, showing the lipstick shape motion lamp on a base and with a plug;
FIG. 9 is a perspective view similar to FIG. 8, showing the lipstick shape motion lamp with a bubbling liquid inside the transparent container;
FIG. 10 is a perspective view similar to FIG. 8, showing the lipstick shape motion lamp with floating foil fragments inside the transparent container;
FIG. 11 is a perspective view of a lipstick shape motion lamp showing my new design, there are 2 rings on the middle section of main body for decoration purpose;
FIG. 12 is a right side elevation view thereof;
FIG. 13 is a top plan view thereof;
FIG. 14 is a front elevation view thereof;
FIG. 15 is a bottom plan view thereof;
FIG. 16 is a left side elevation view;
FIG. 17 is a rear elevation view thereof;
FIG. 18 is a perspective view similar to FIG. 11, showing the lipstick shape motion lamp on a base and with a plug;
FIG. 19 is a perspective view similar to FIG. 18, showing the lipstick shape motion lamp with a bubbling liquid inside the transparent container; and,
FIG. 20 is a perspective view similar to FIG. 18, showing the lipstick shape motion lamp with floating foil fragments inside the transparent container.








































