FIG. 2 is an exploded rear perspective view thereof,

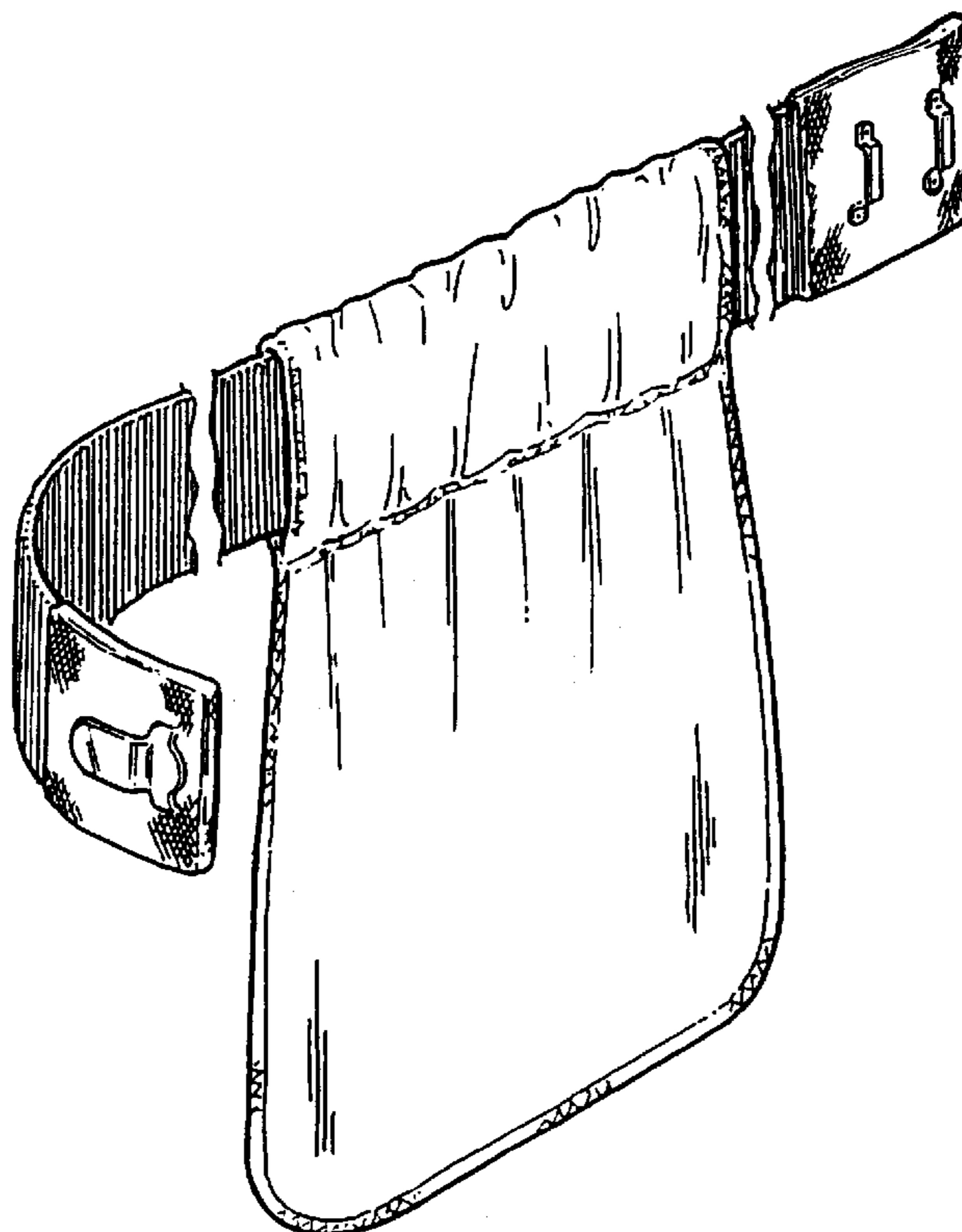
FIG. 3 is a front perspective view thereof shown separately for purposes of illustration;

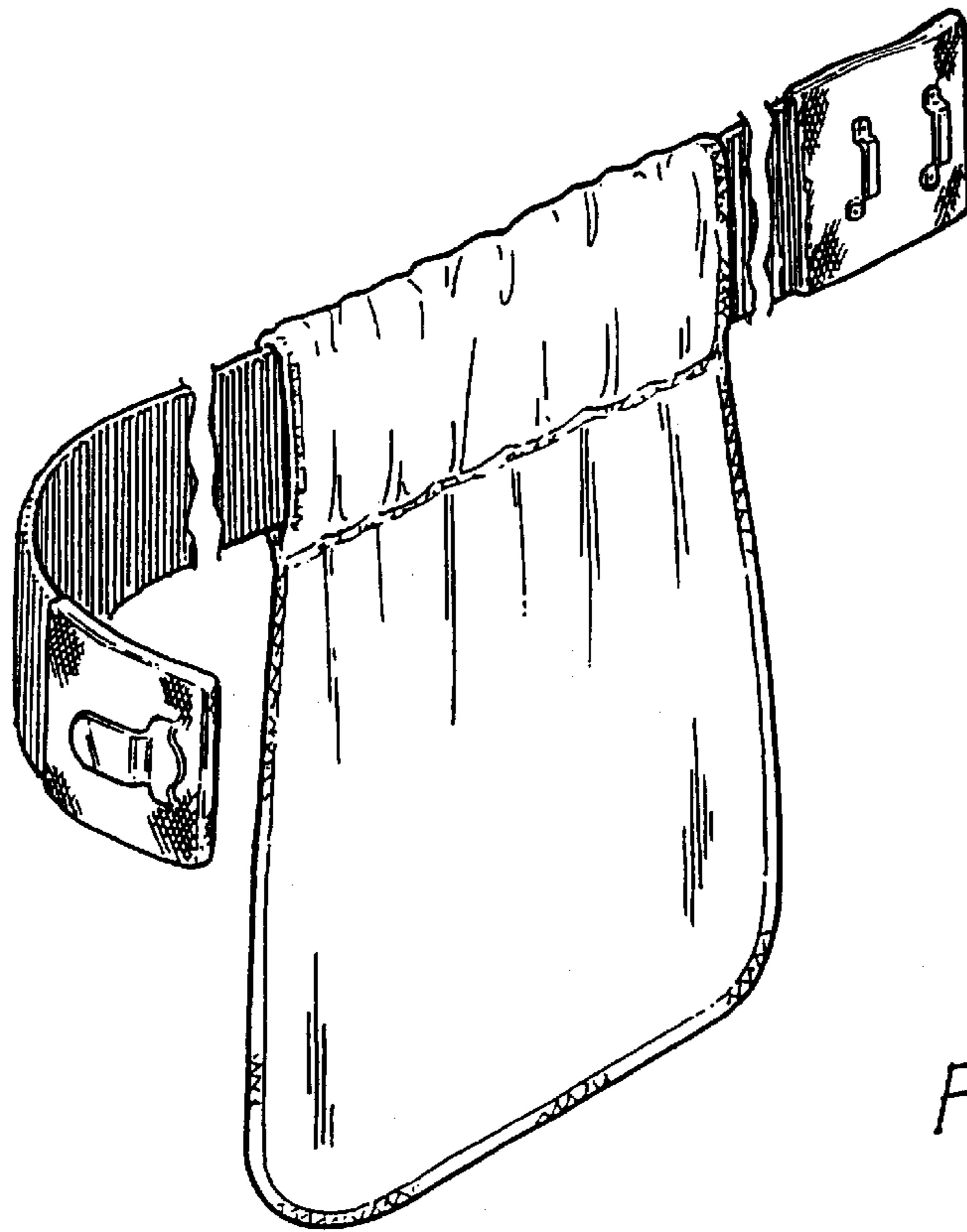

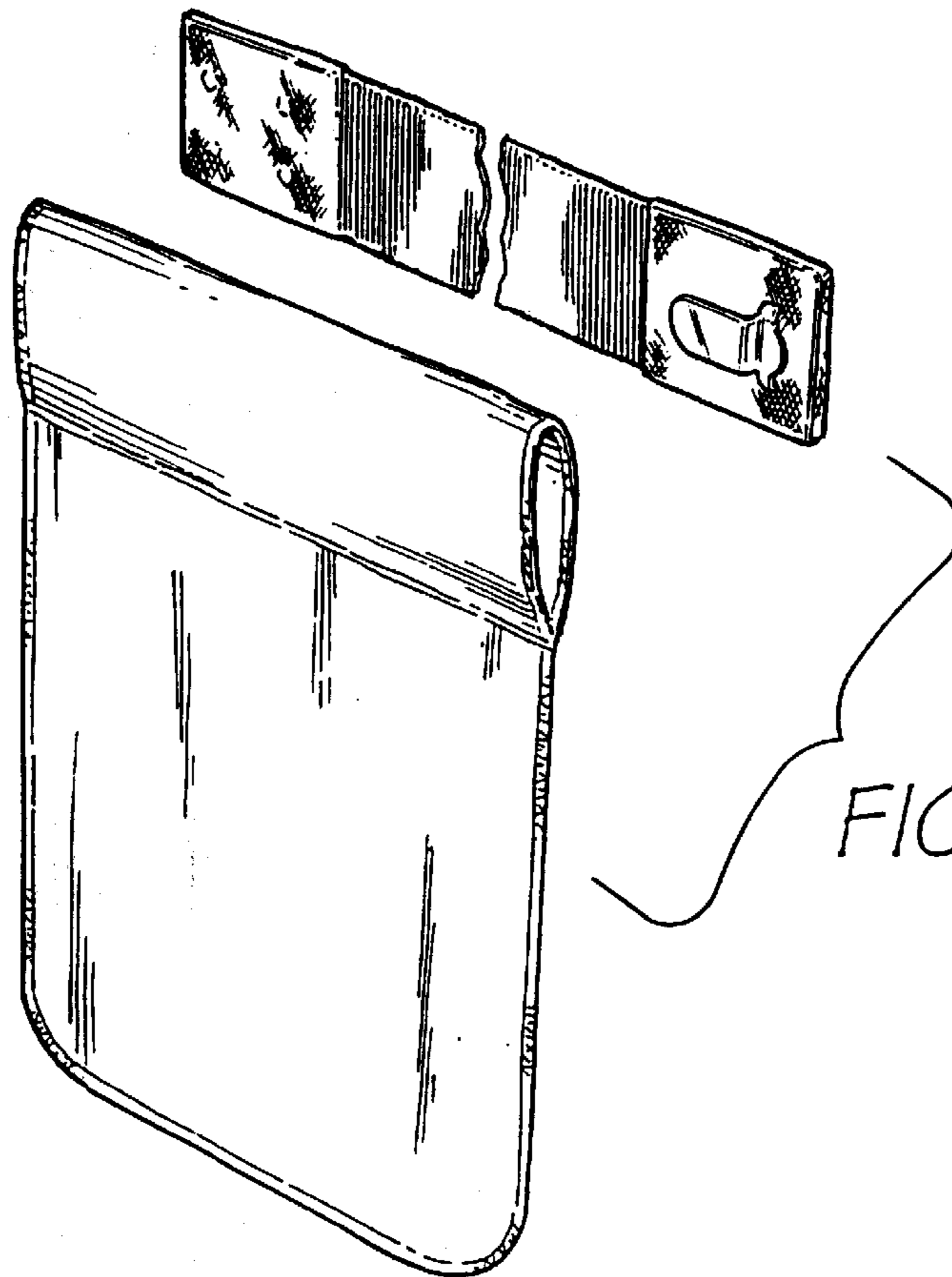

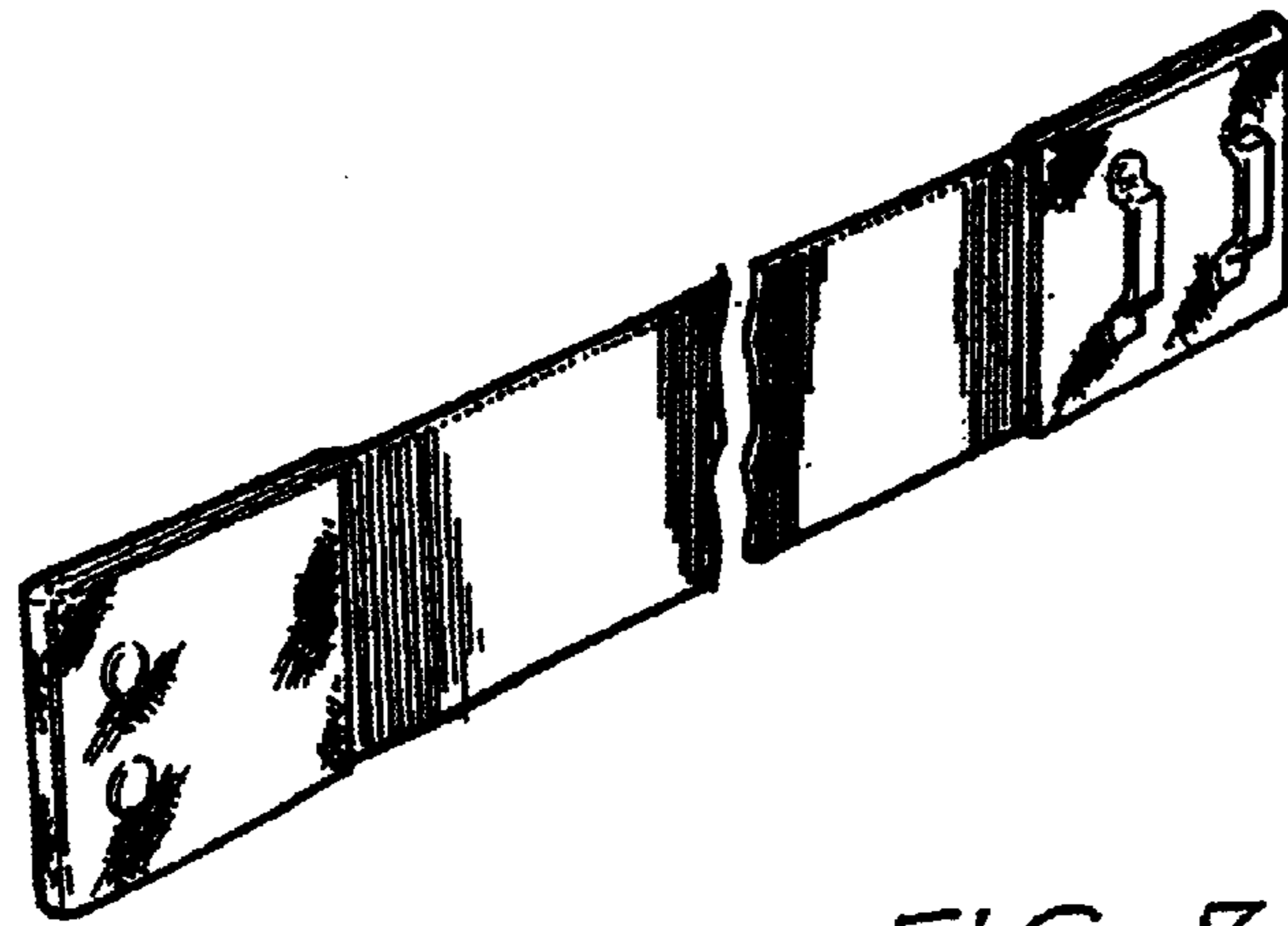

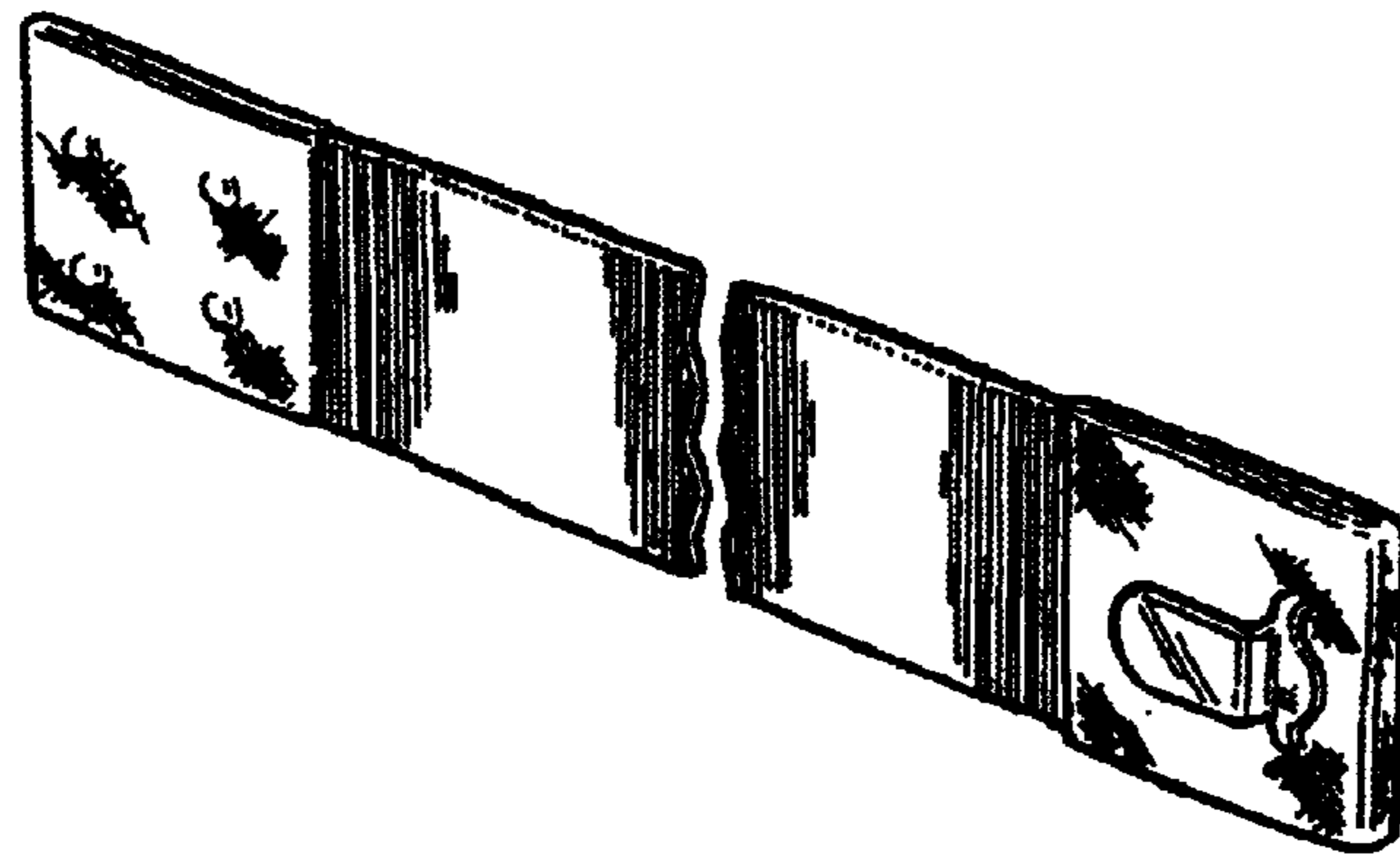

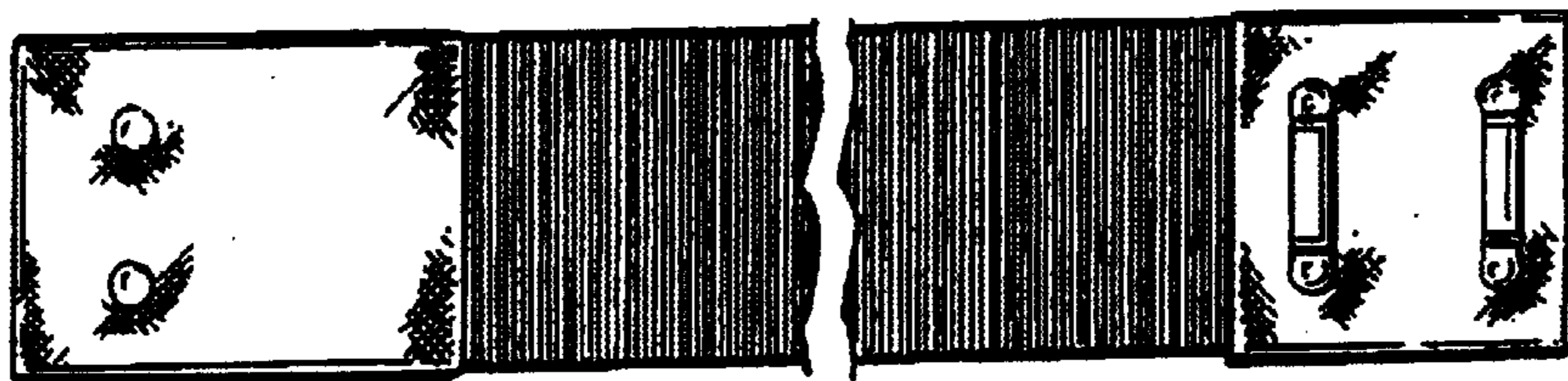
