(57) **CLAIM**

The ornamental design for an upright luggage having side access compartment, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and left side perspective view with parts shown in dash lines for environmental purposes, of our new design for upright luggage having side access compartment; FIG. 2 is a right side elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; and, FIG. 5 is a top perspective view of the upright luggage having side access compartment of FIG. 1 shown lying on its side, with the side access compartment in the fully opened condition with an exemplary lap top computer shown in dash lines and intended for storage in said compartment.

The broken line portions of the disclosure are for illustrative purposes only and form no part of the claimed design.

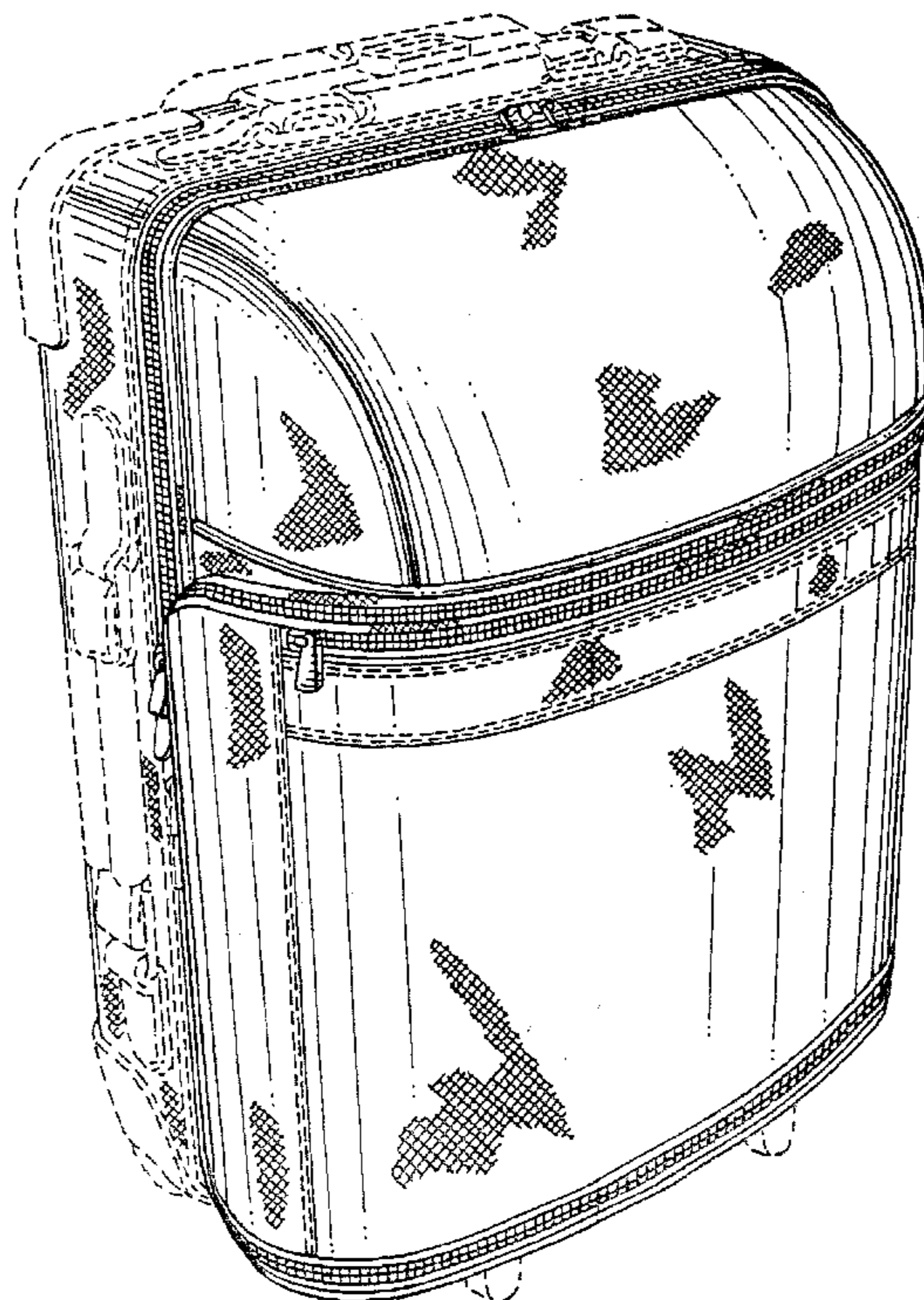

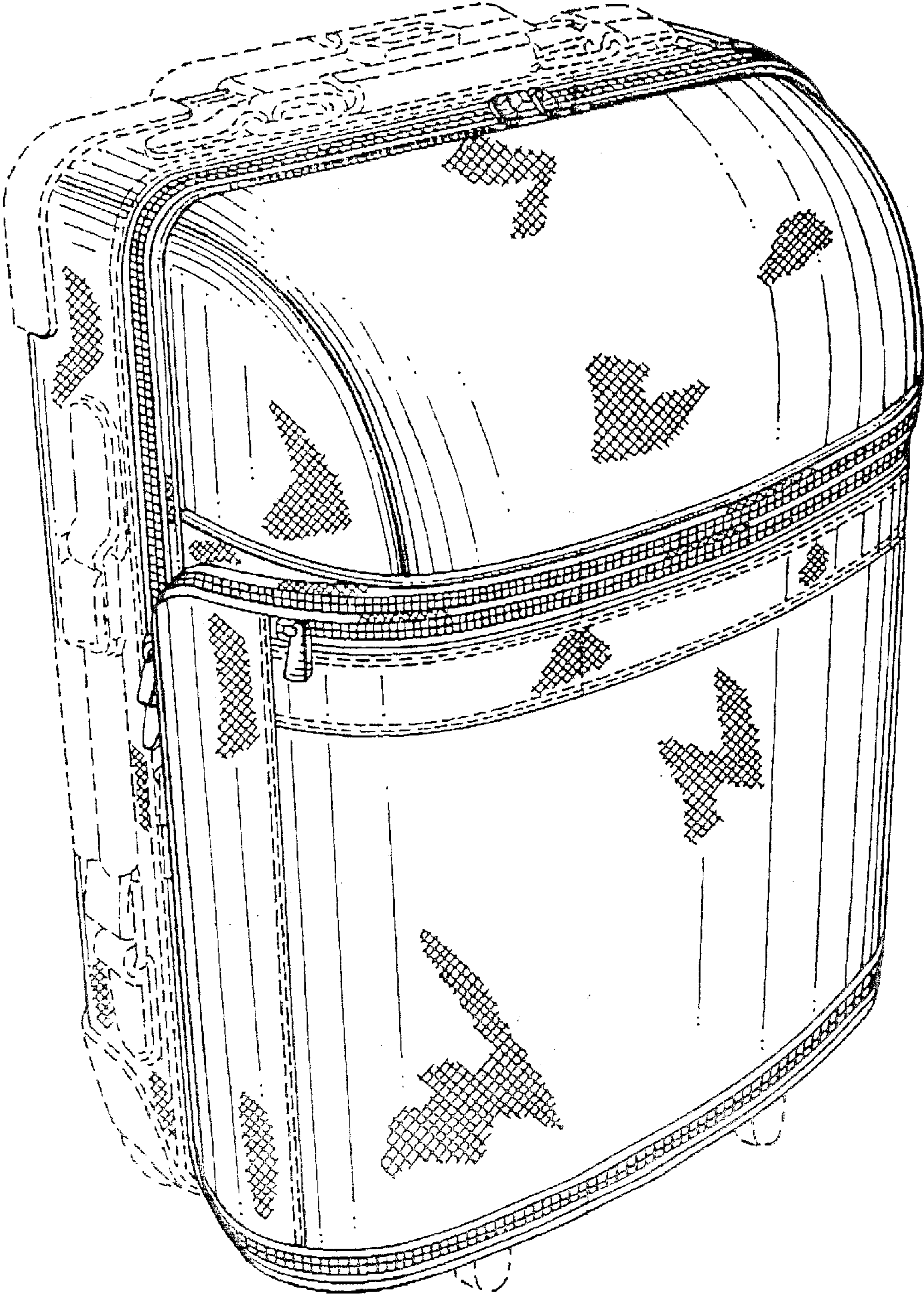

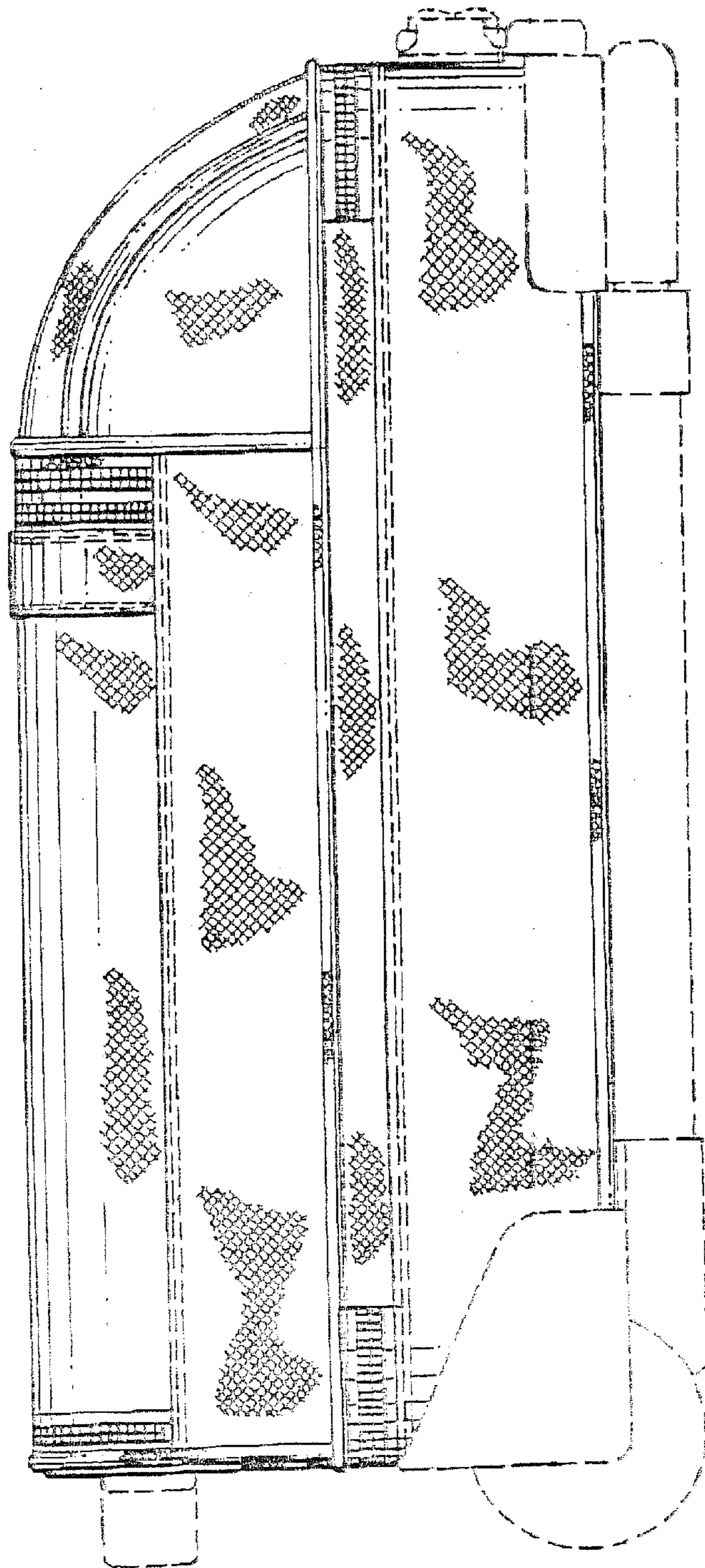

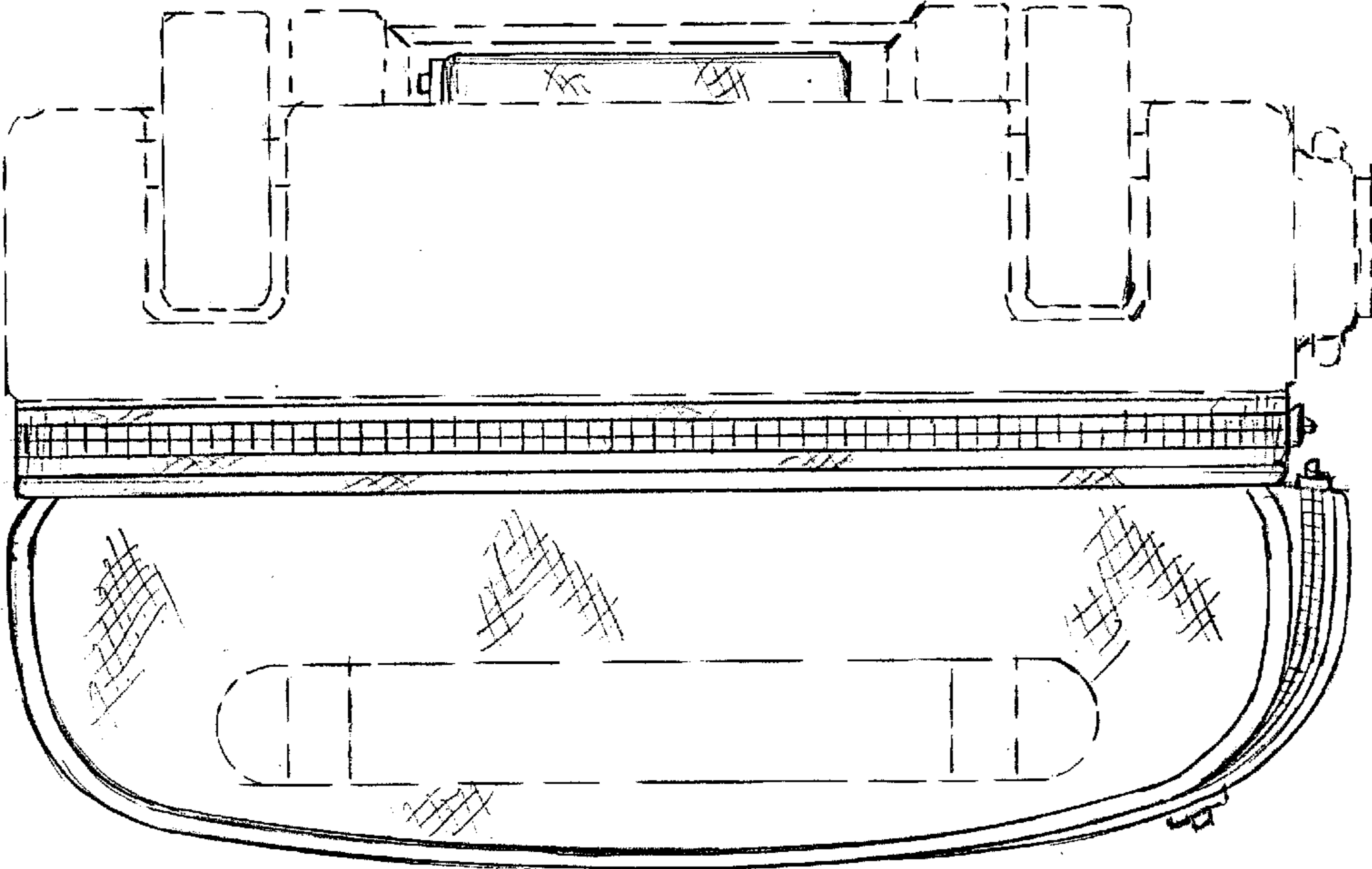
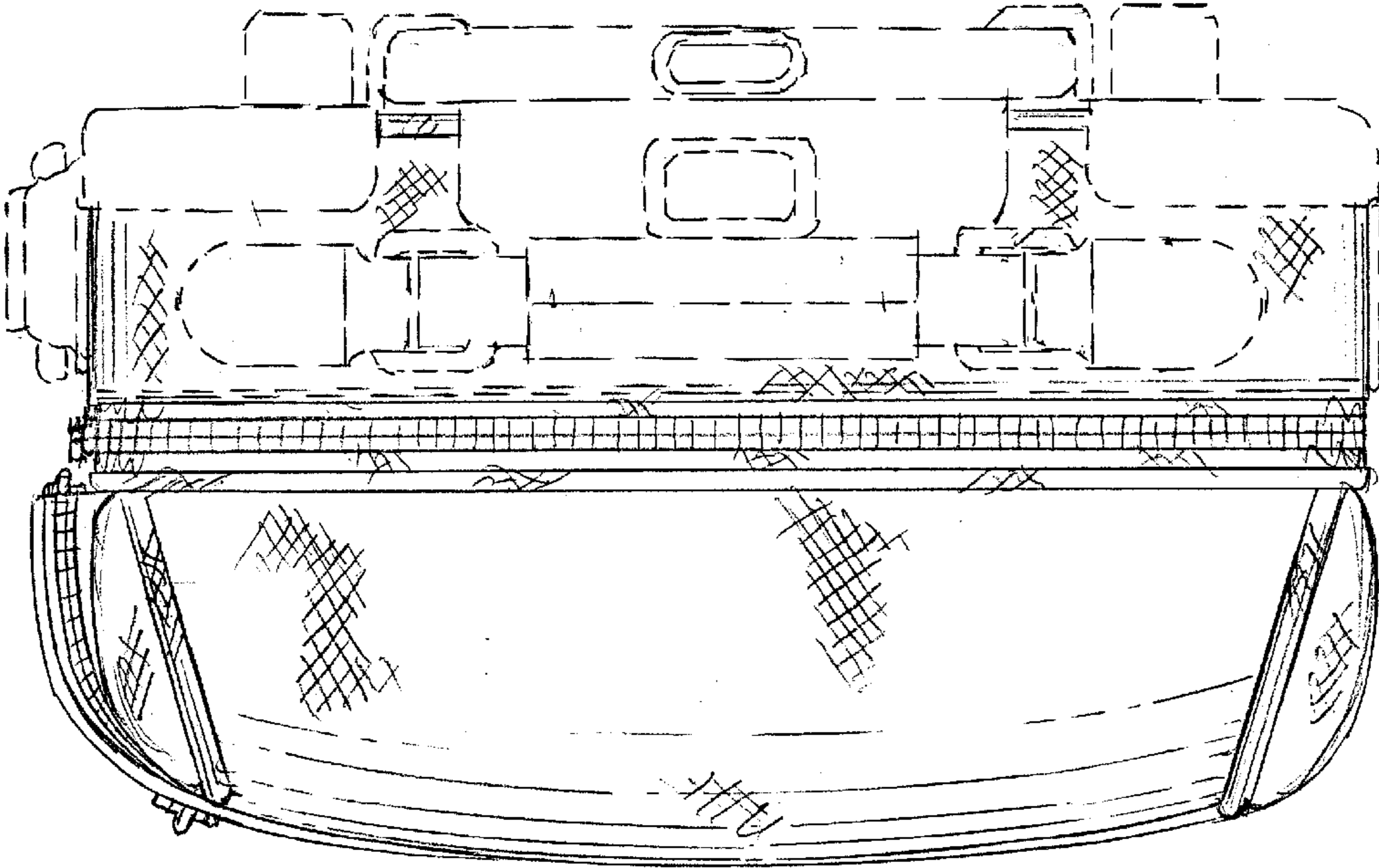
