We claim the ornamental design for a faceplate, as shown and described.

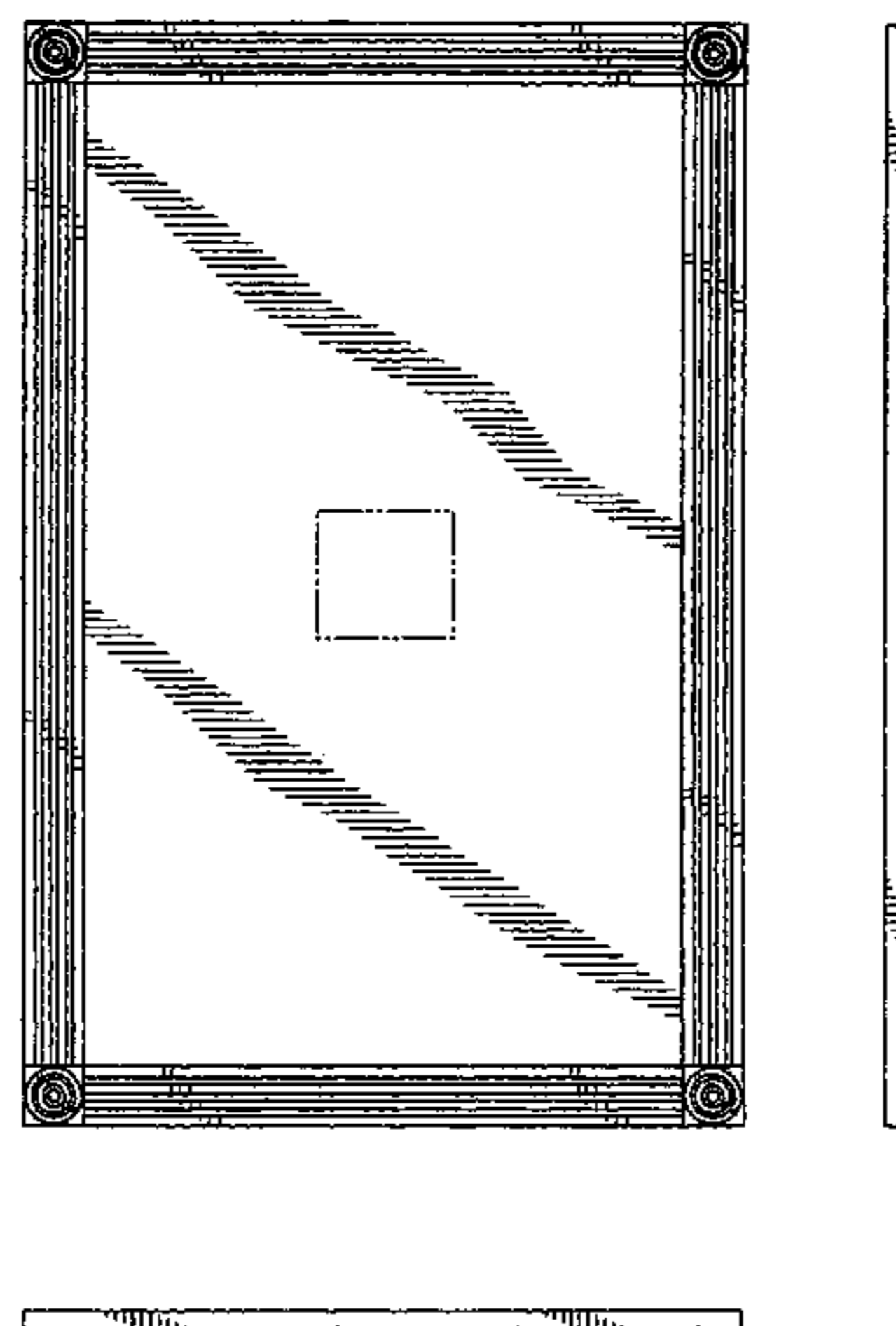
DESCRIPTION

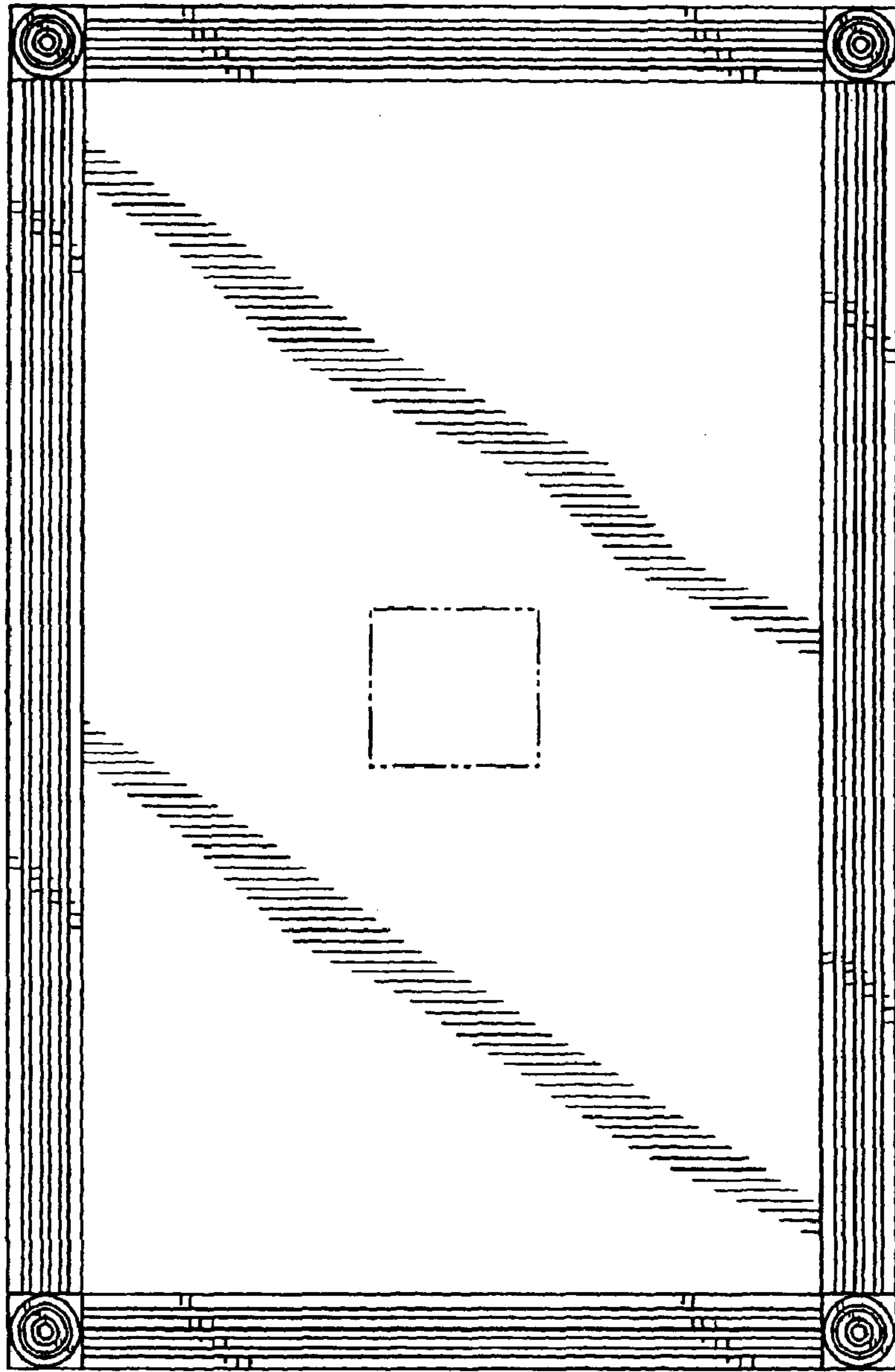
