FIG. 2 is a rear view showing the tractor of FIG. 1;

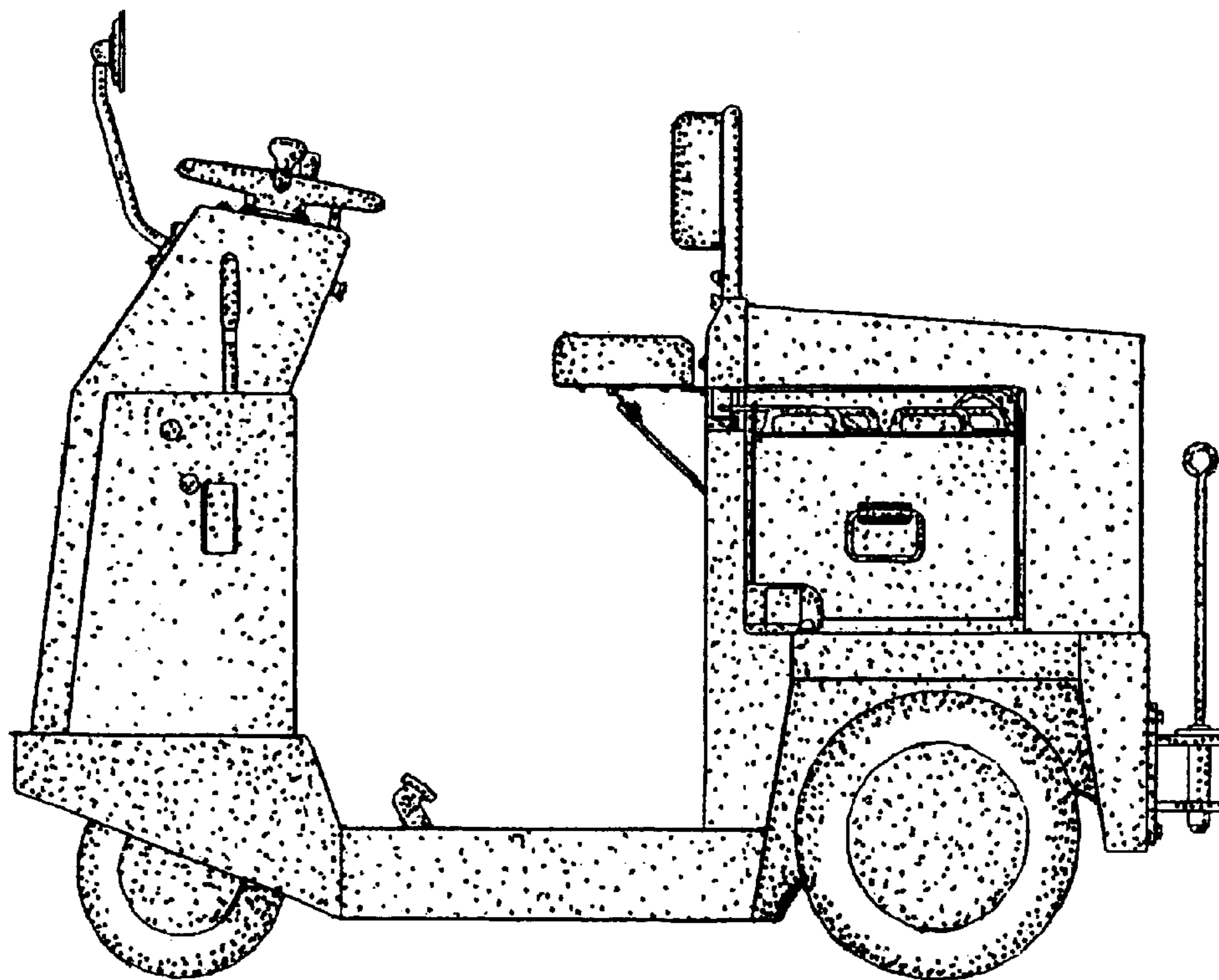
FIG. 3 is a top plan view showing the tractor of FIG. 1;

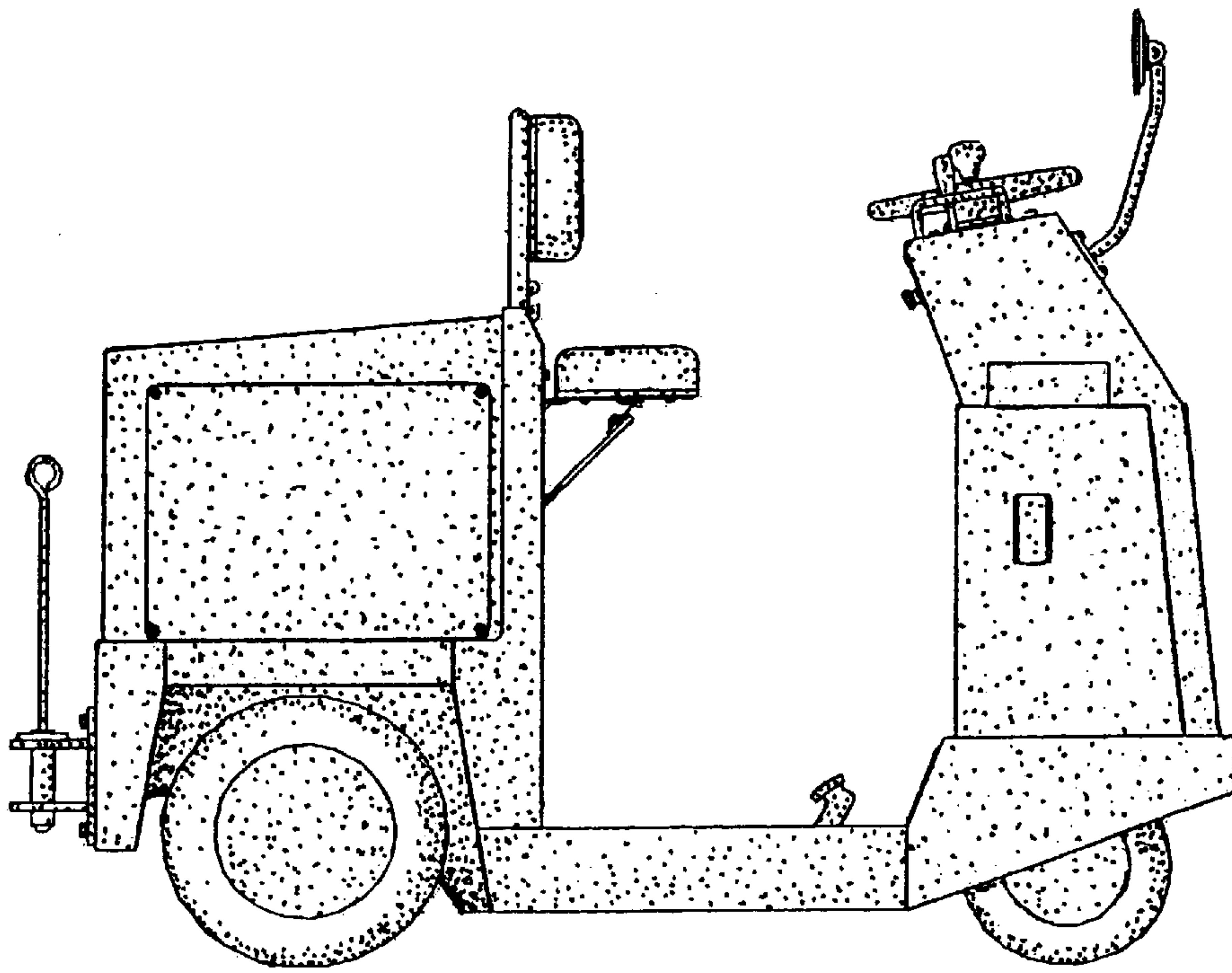

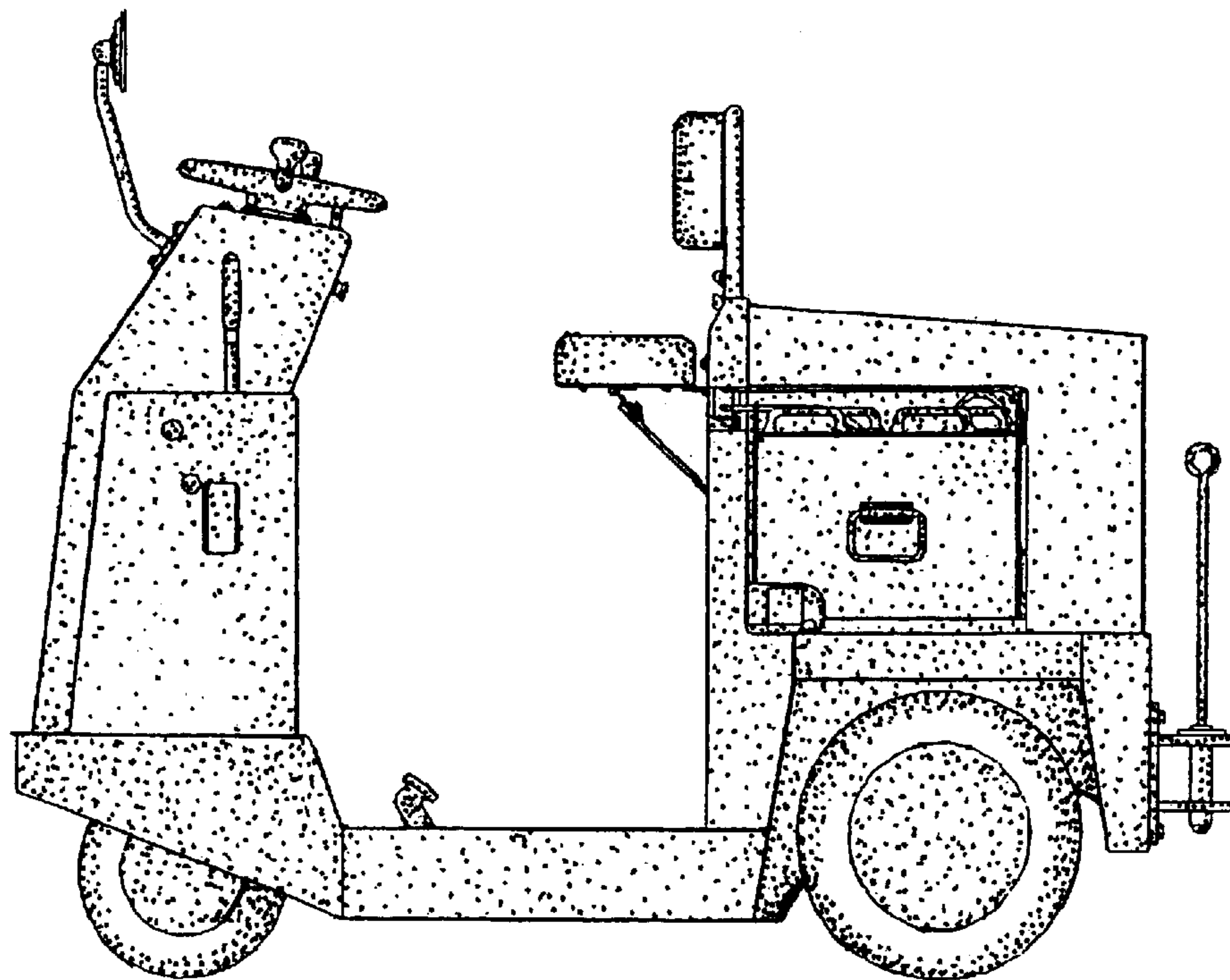

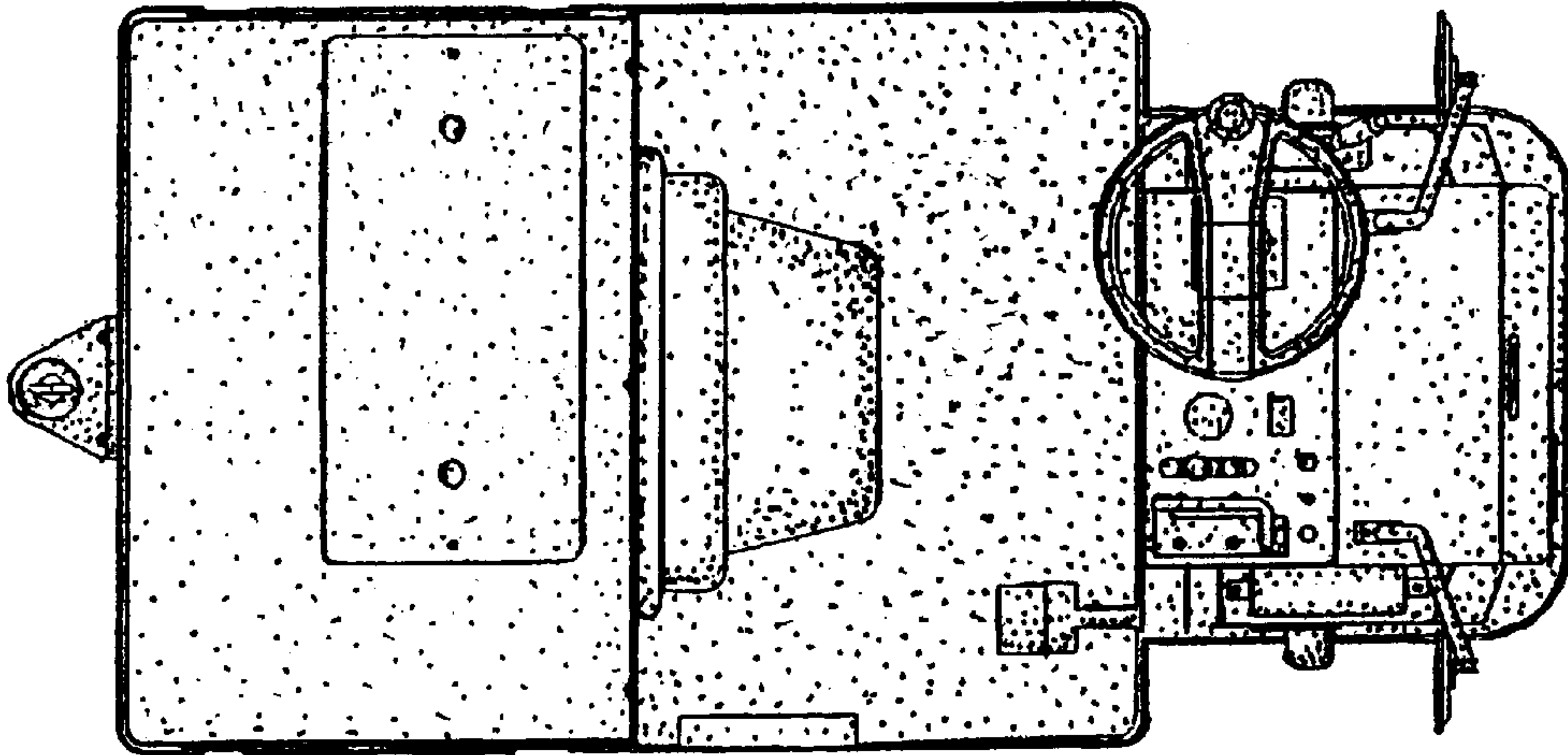

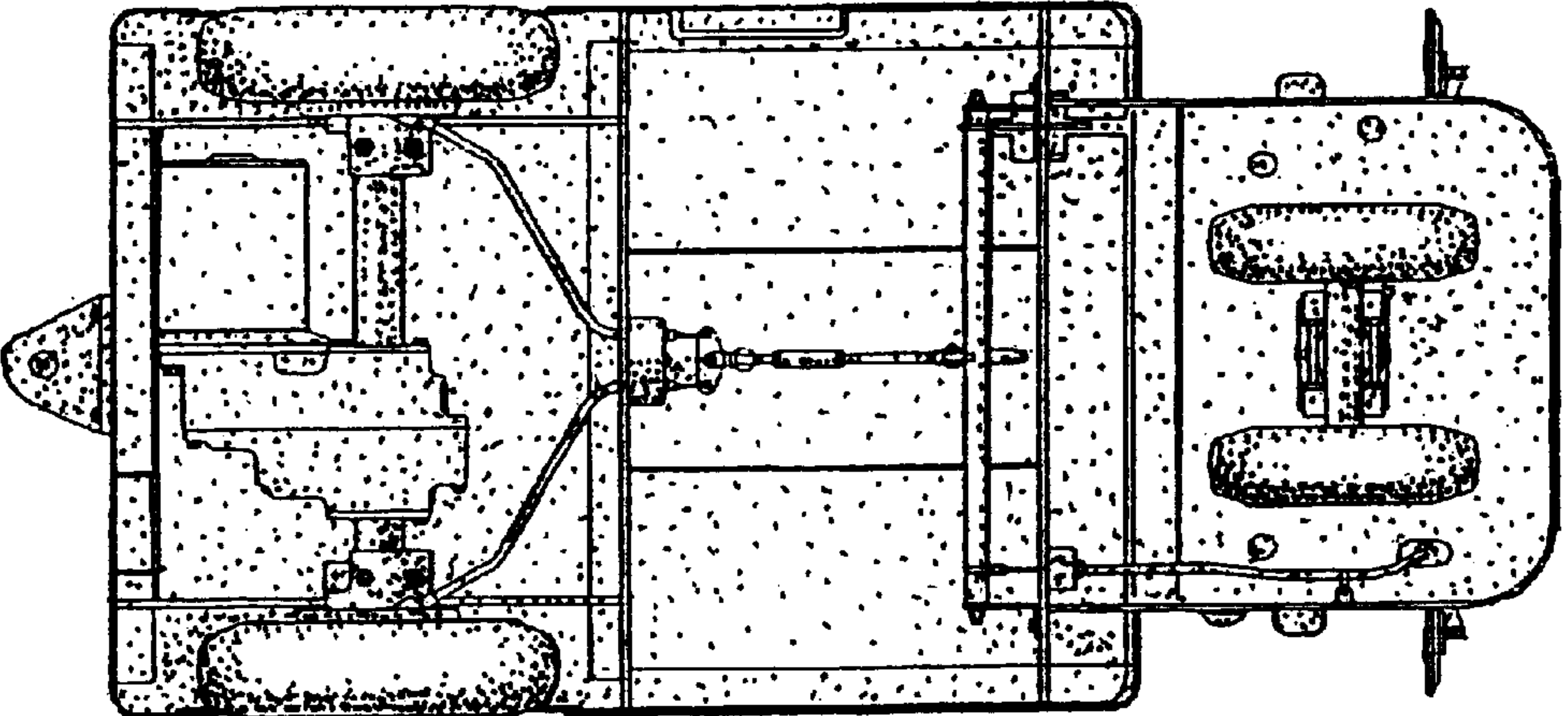

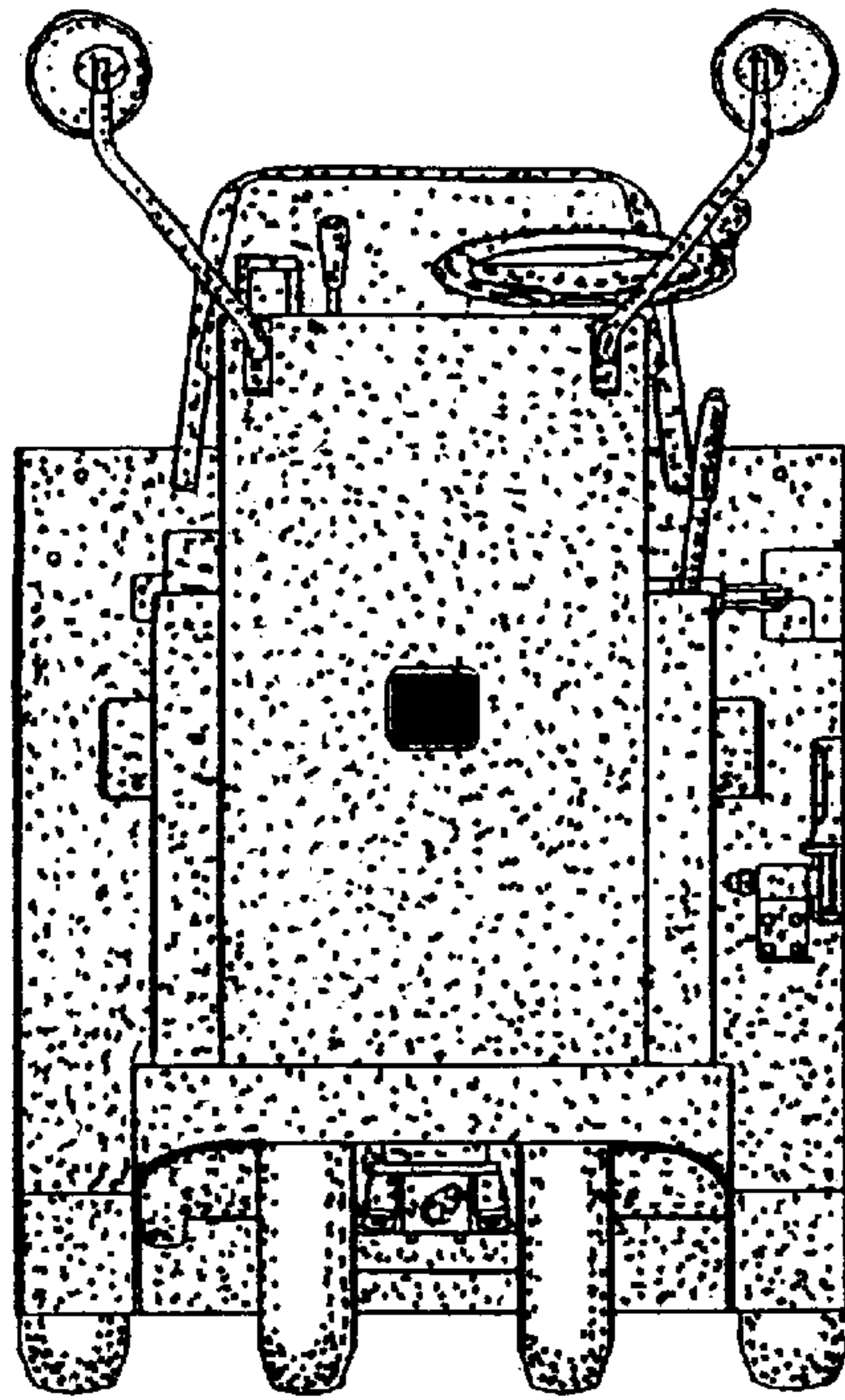

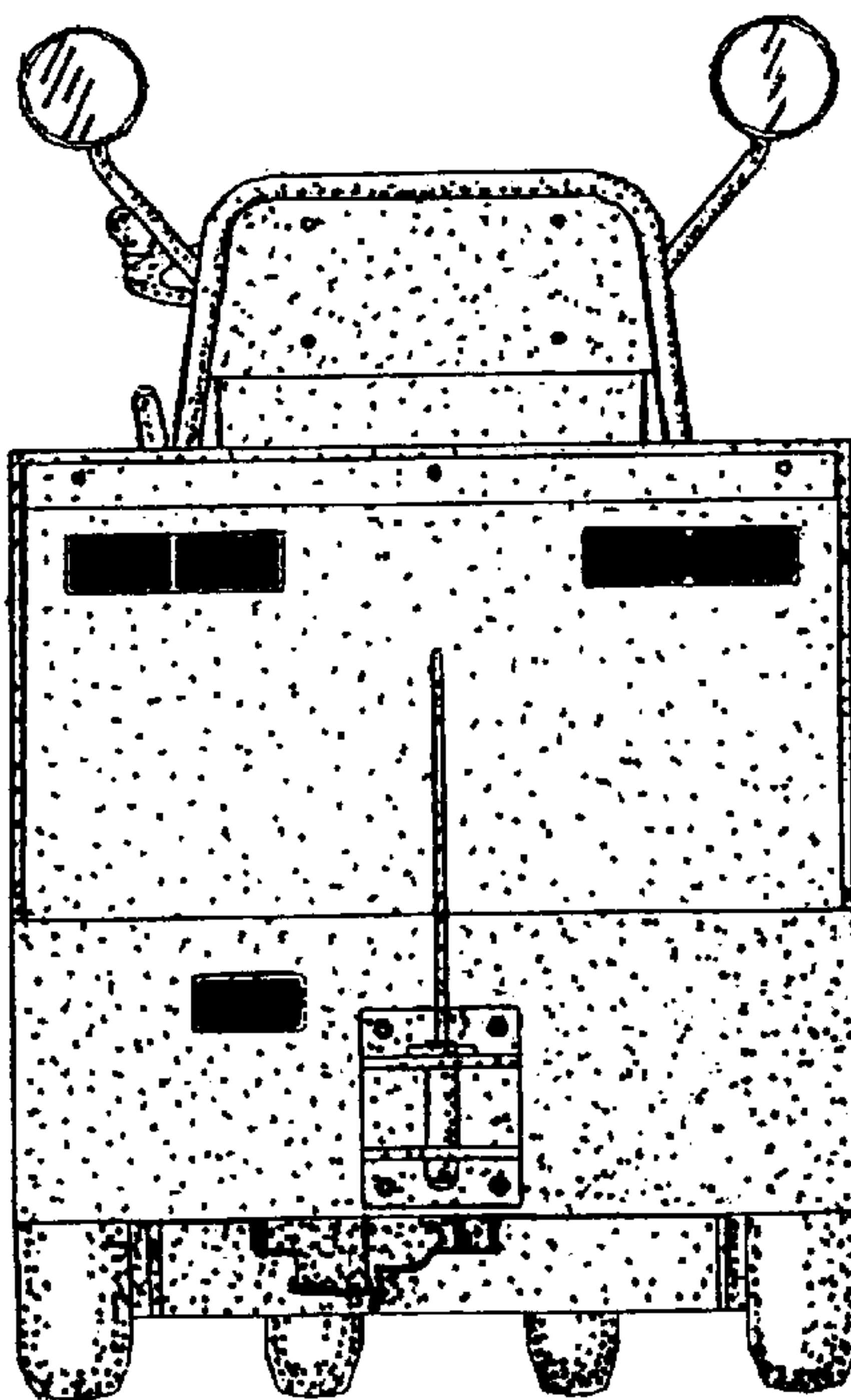
