**DESCRIPTION**

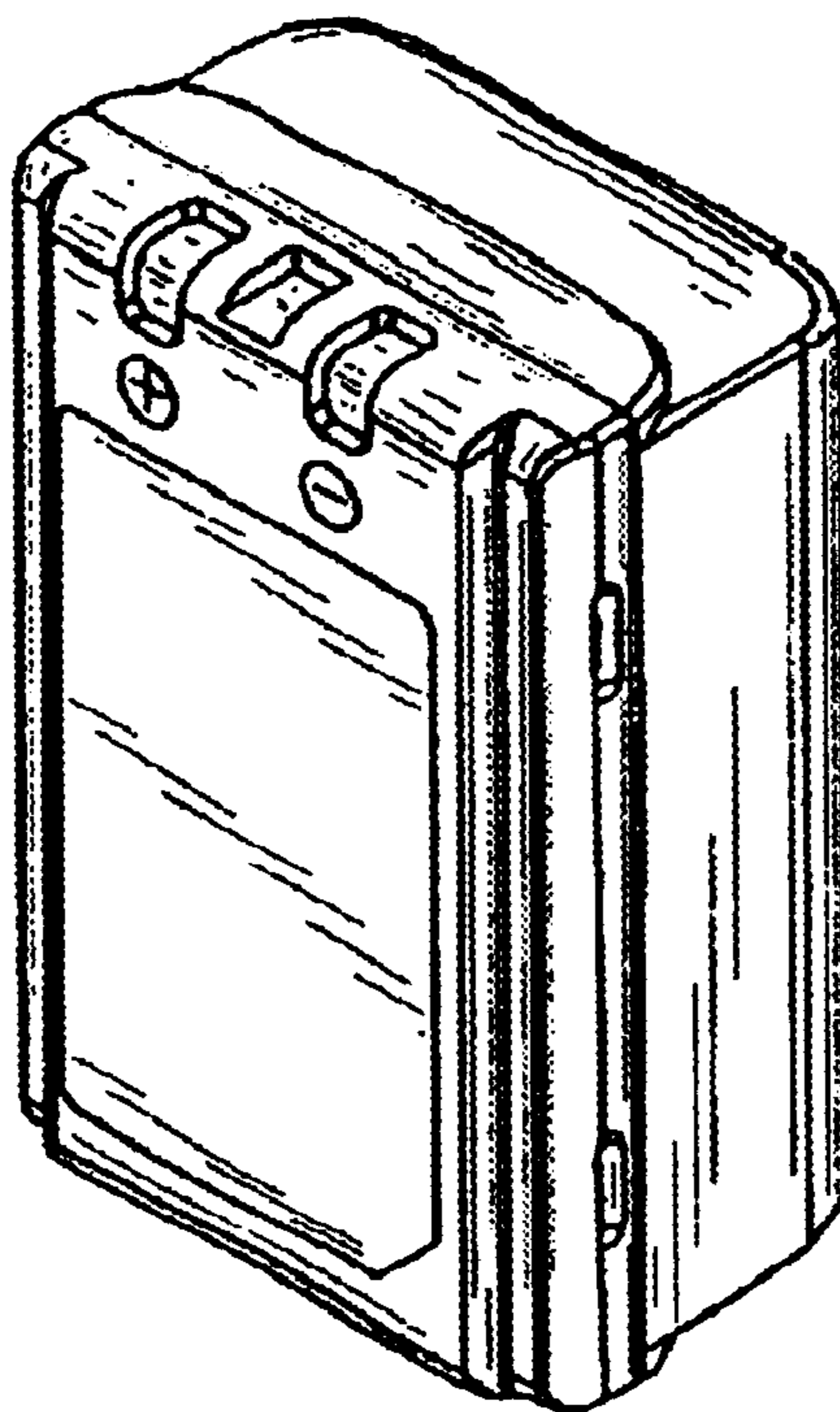

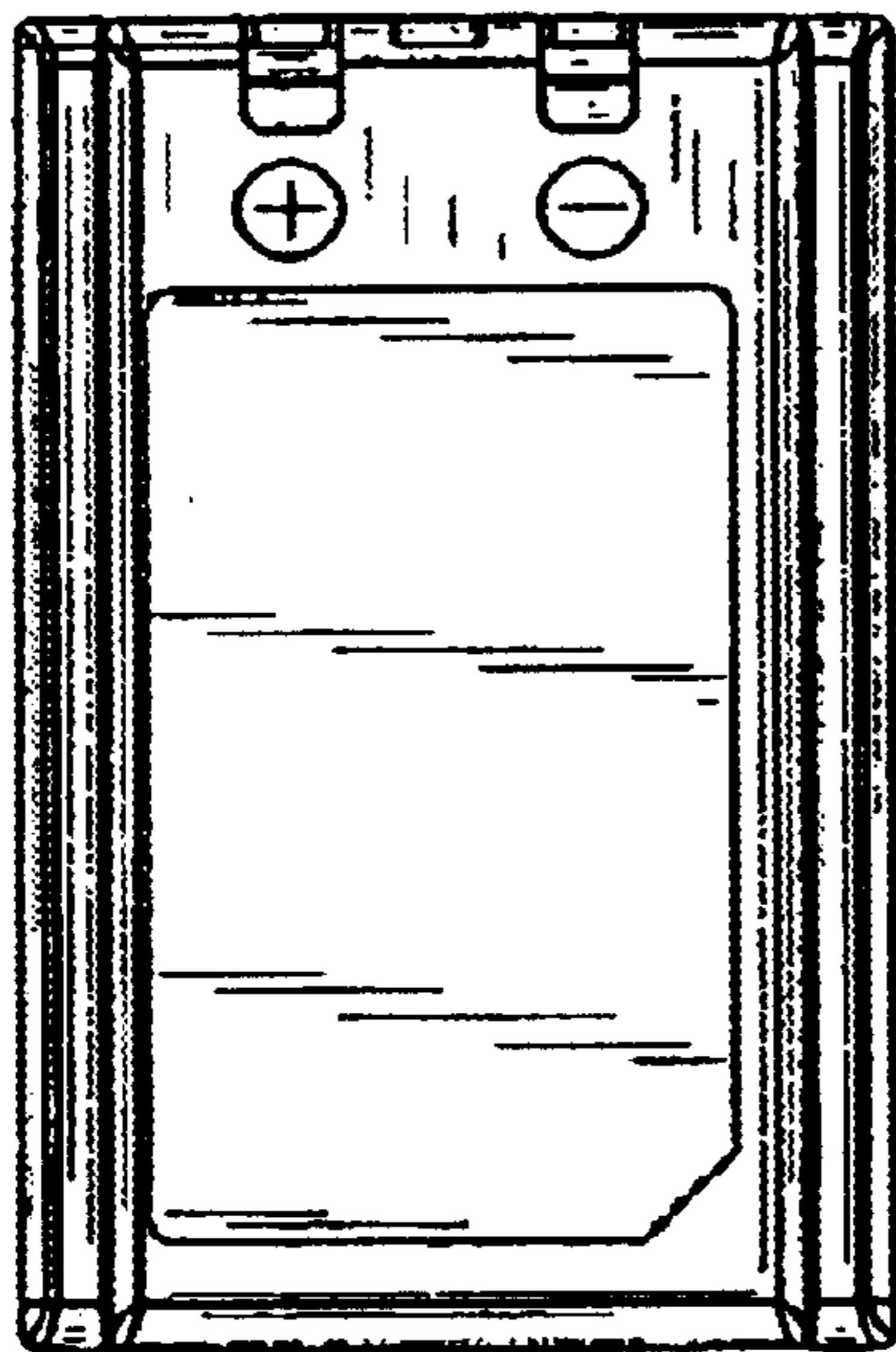
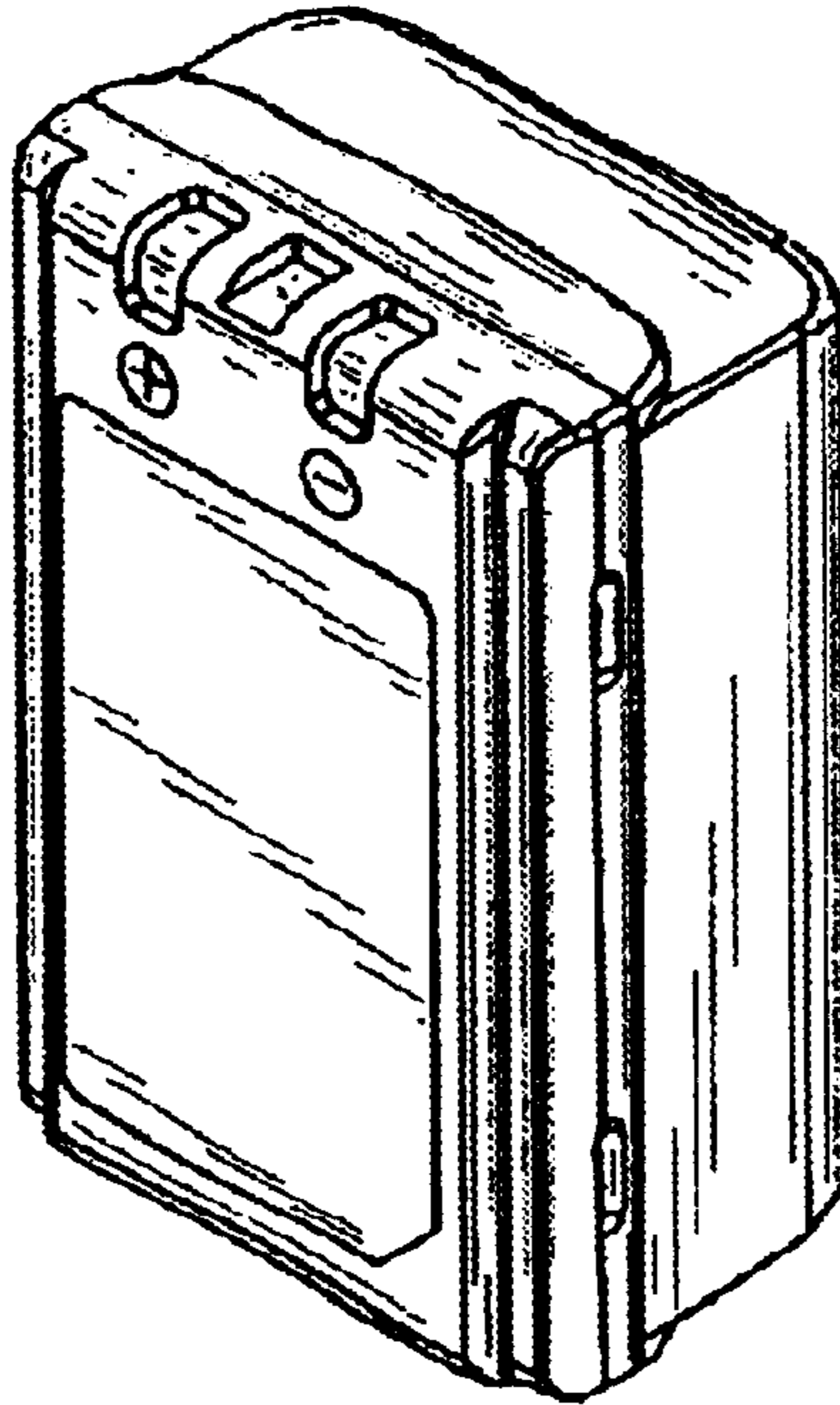

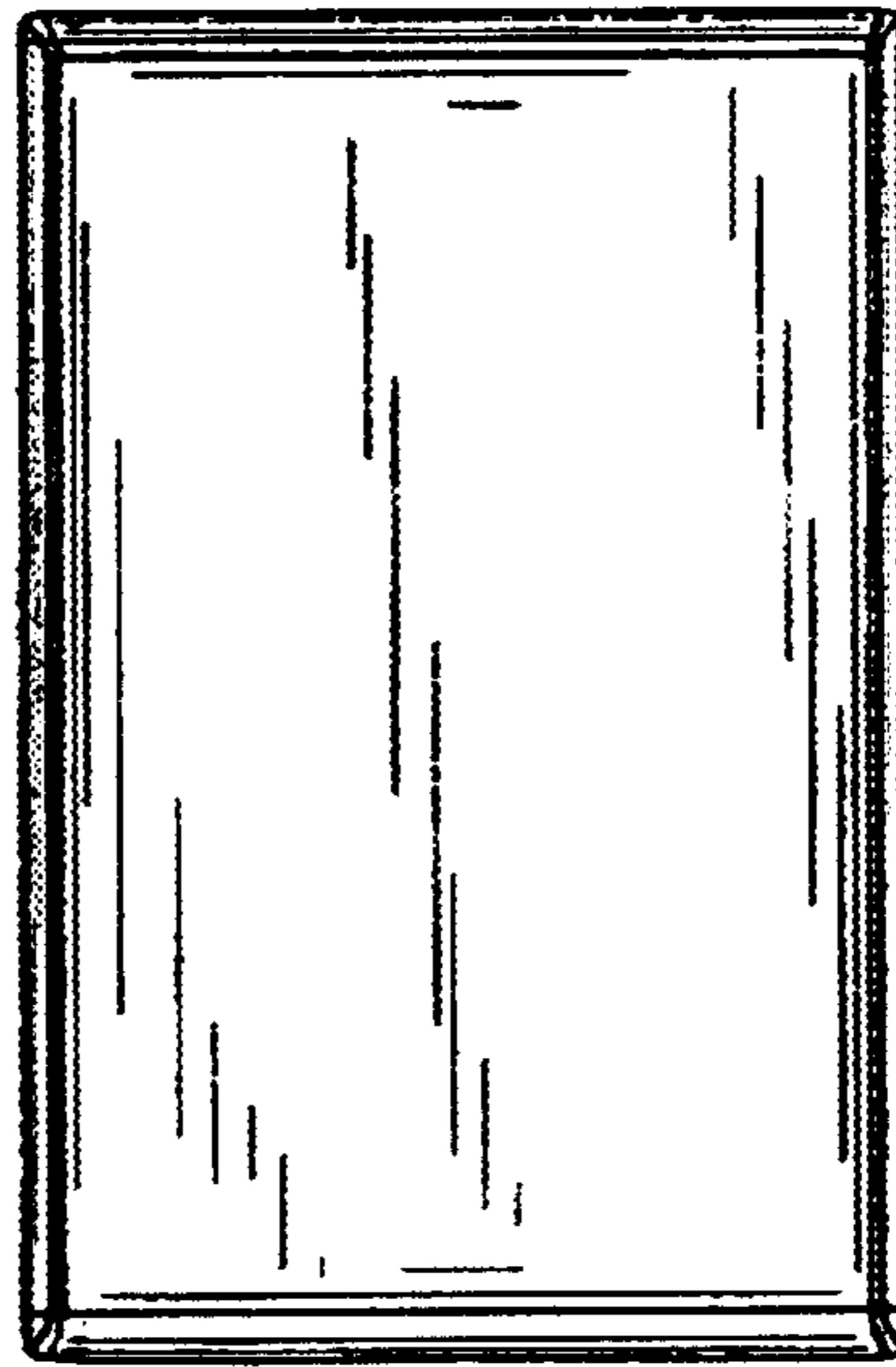

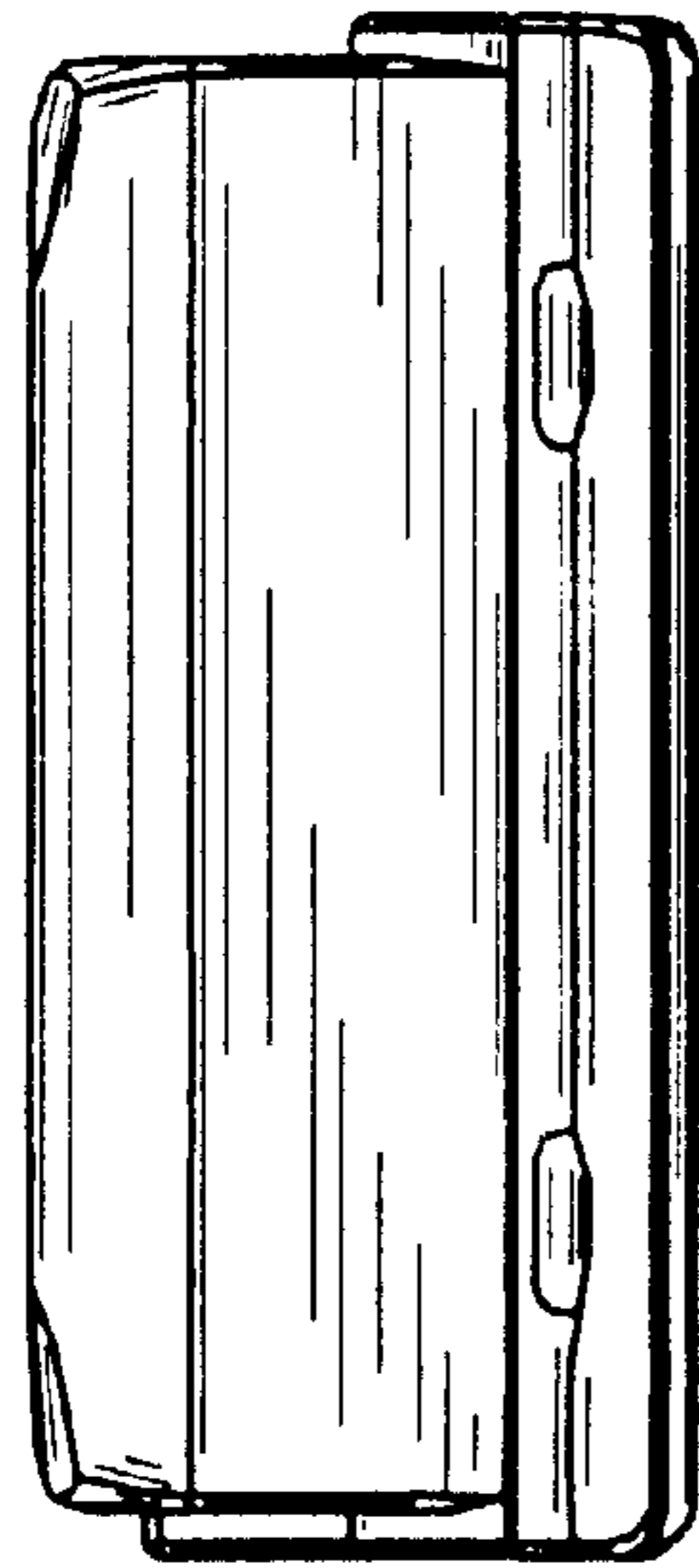

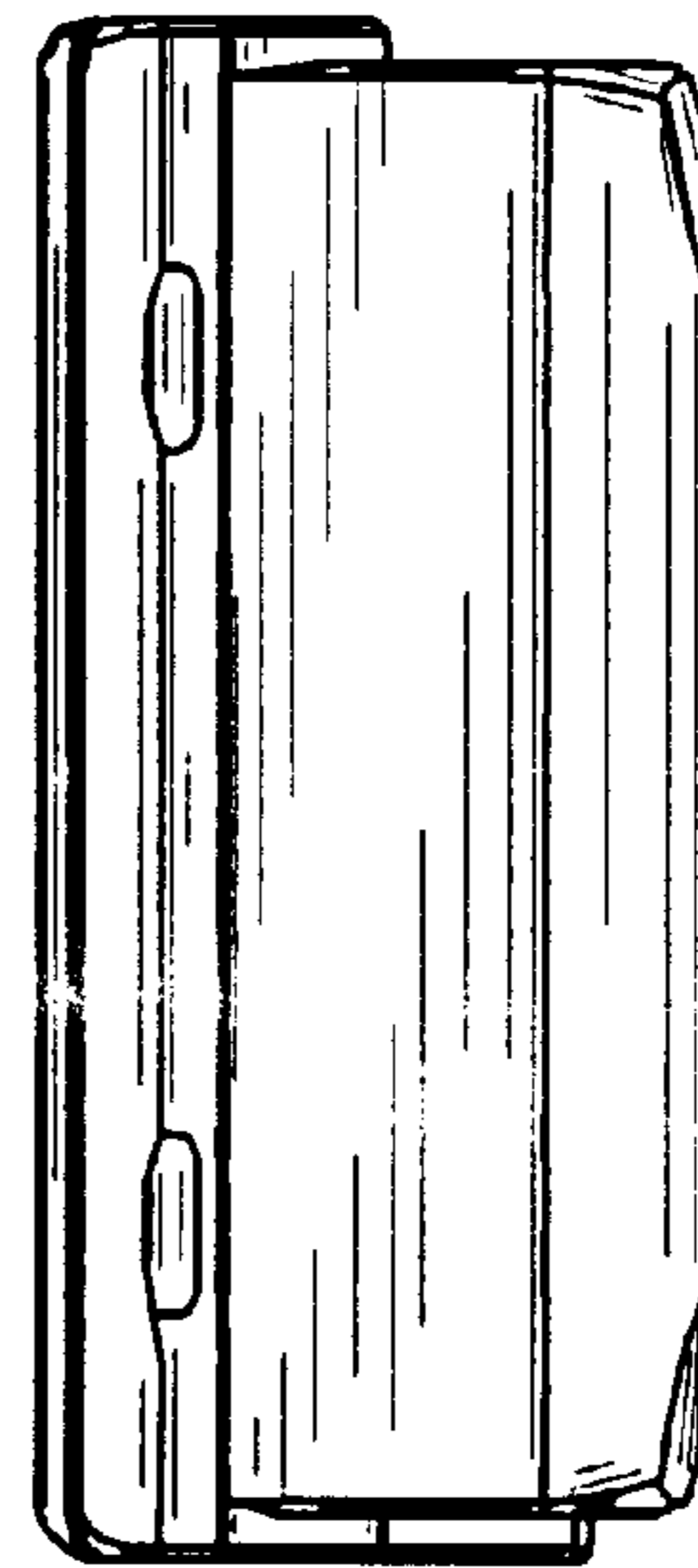

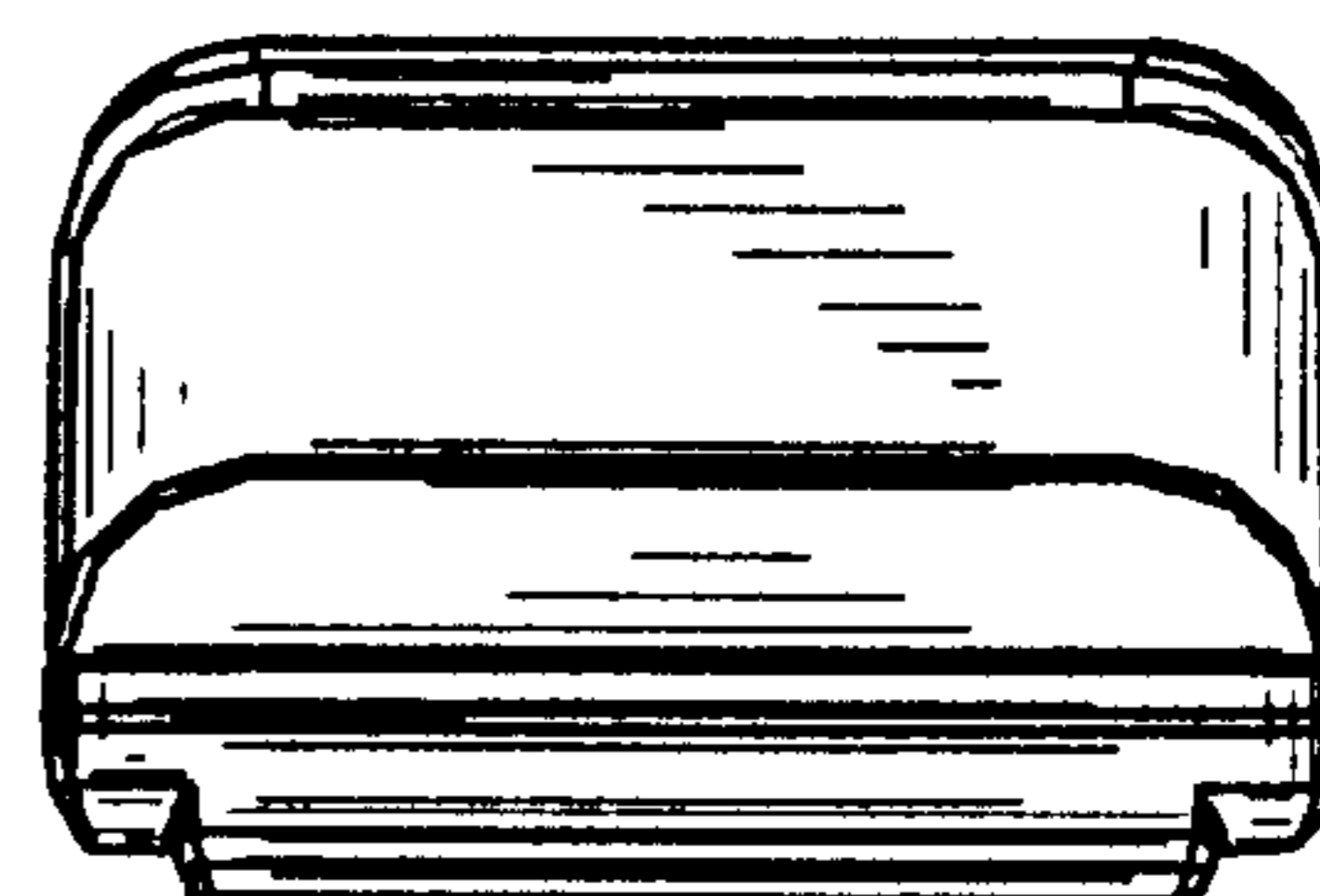
