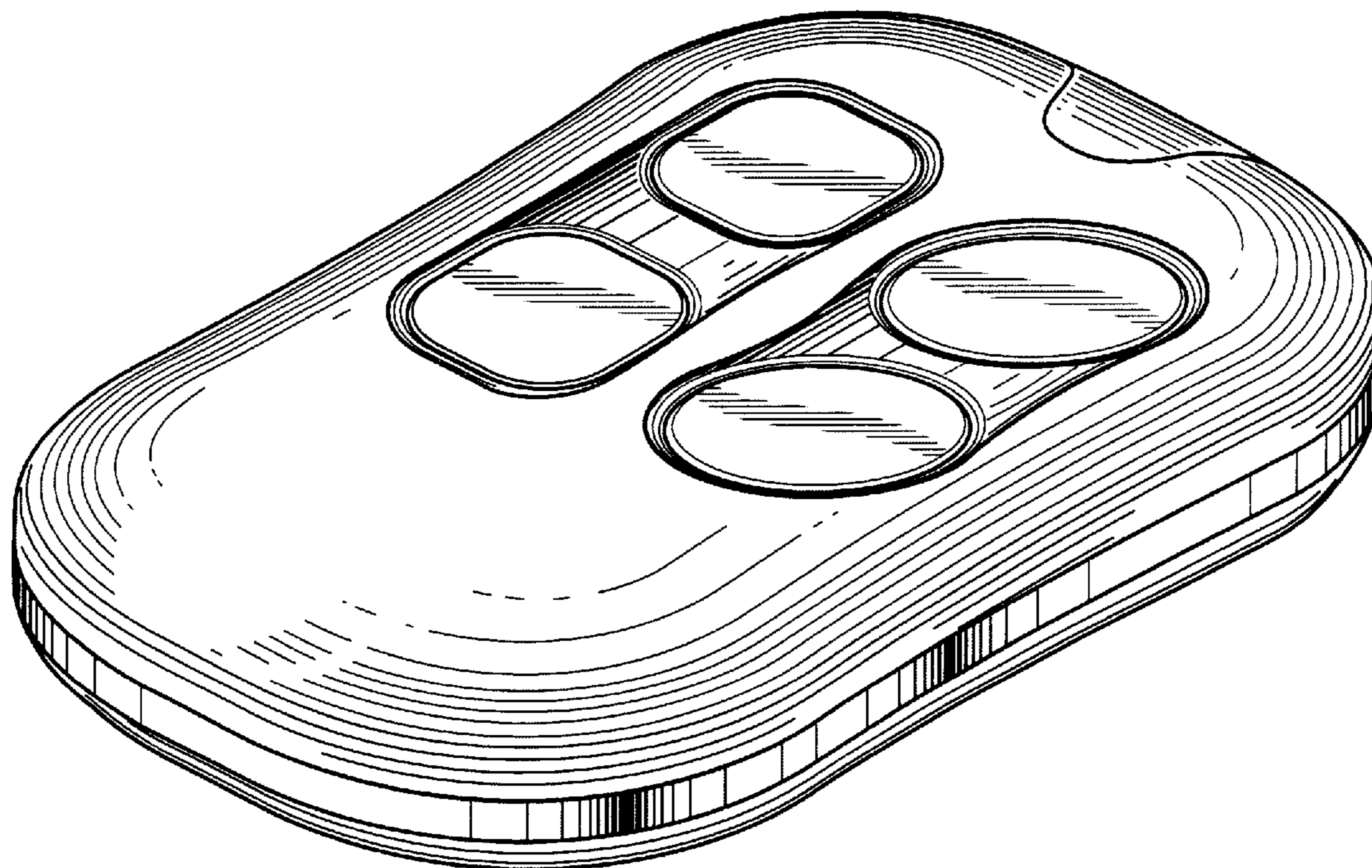
The ornamental design for an illuminated remote control device, as shown.

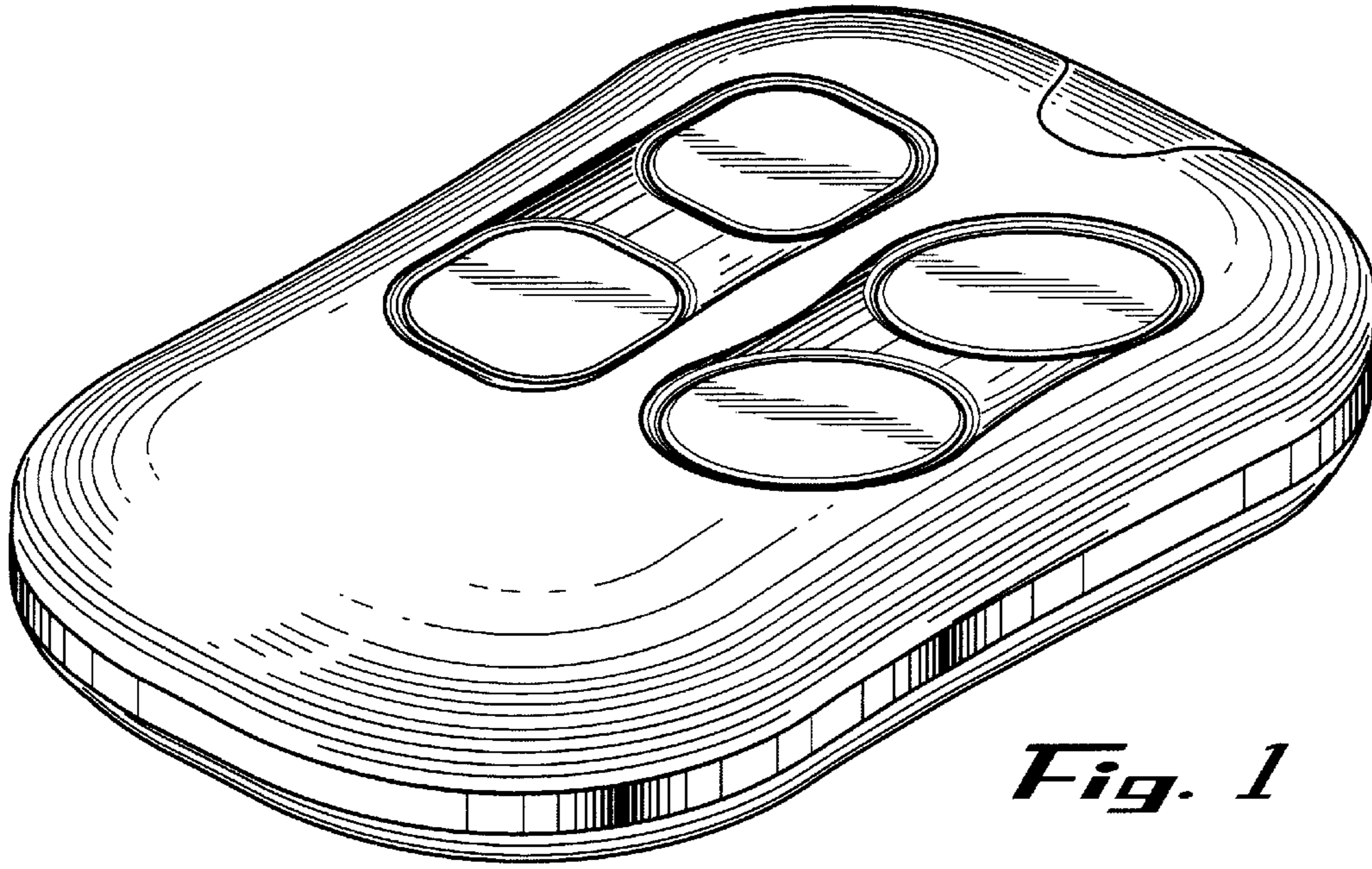
**DESCRIPTION**

FIG. 8 is a bottom perspective view thereof.

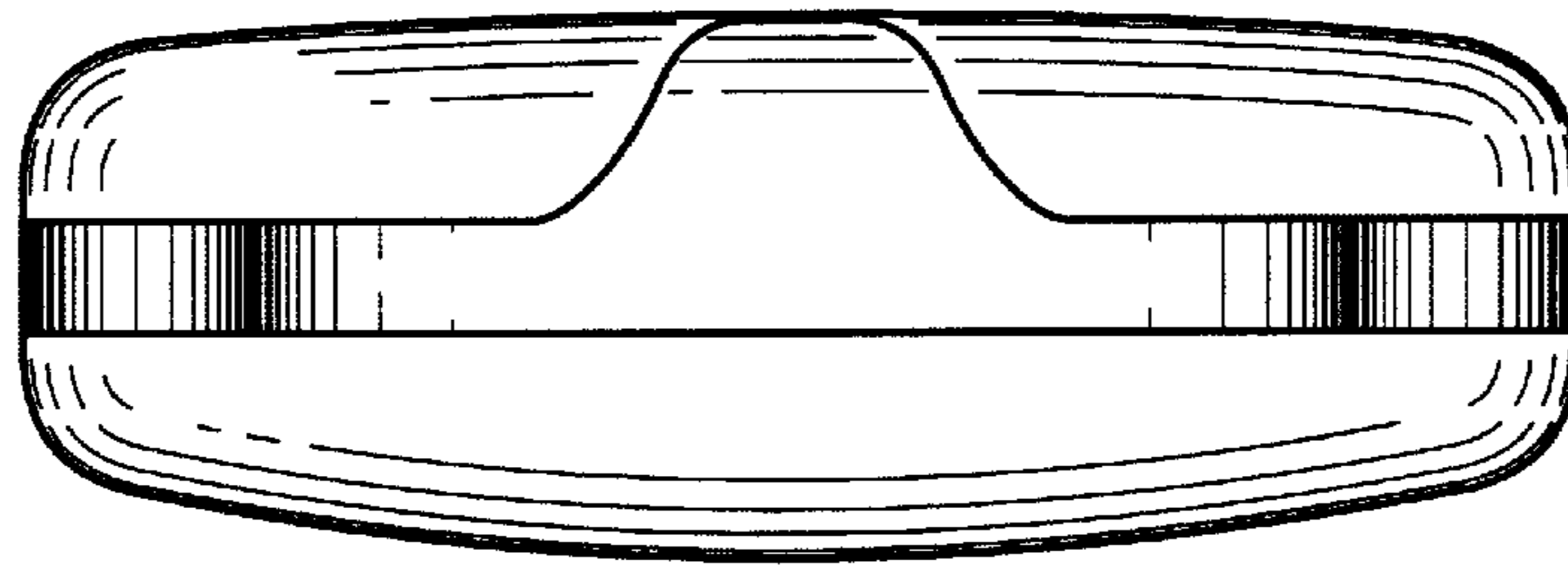

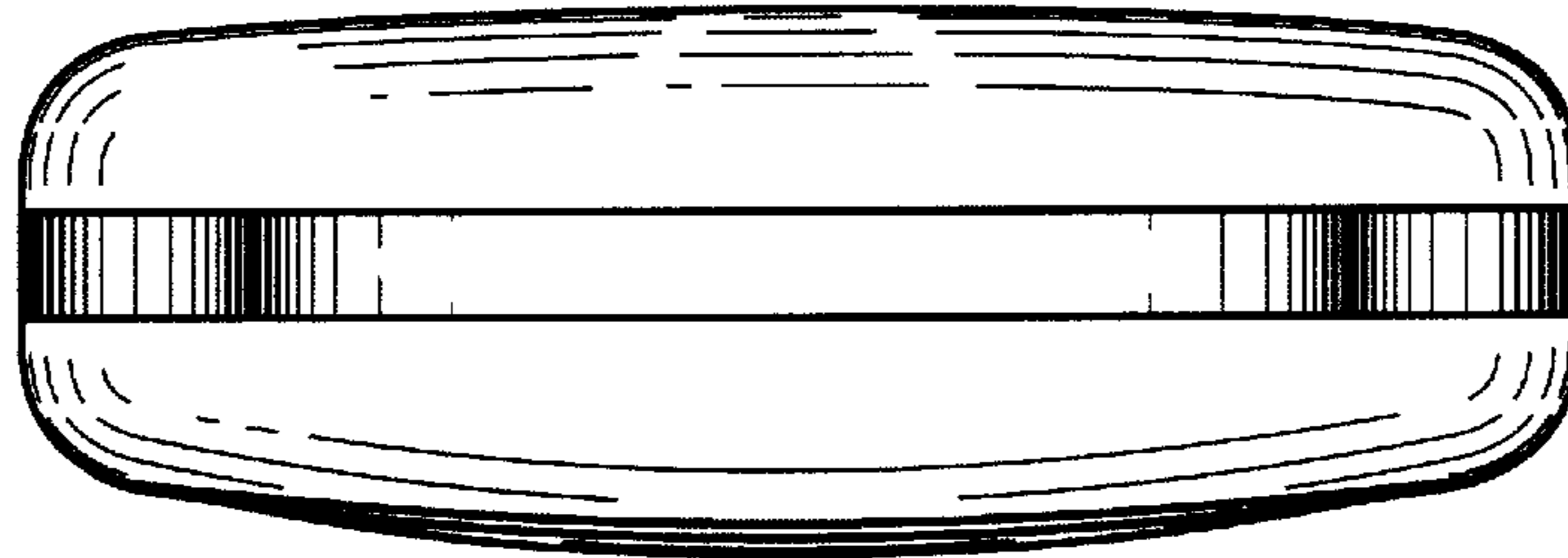




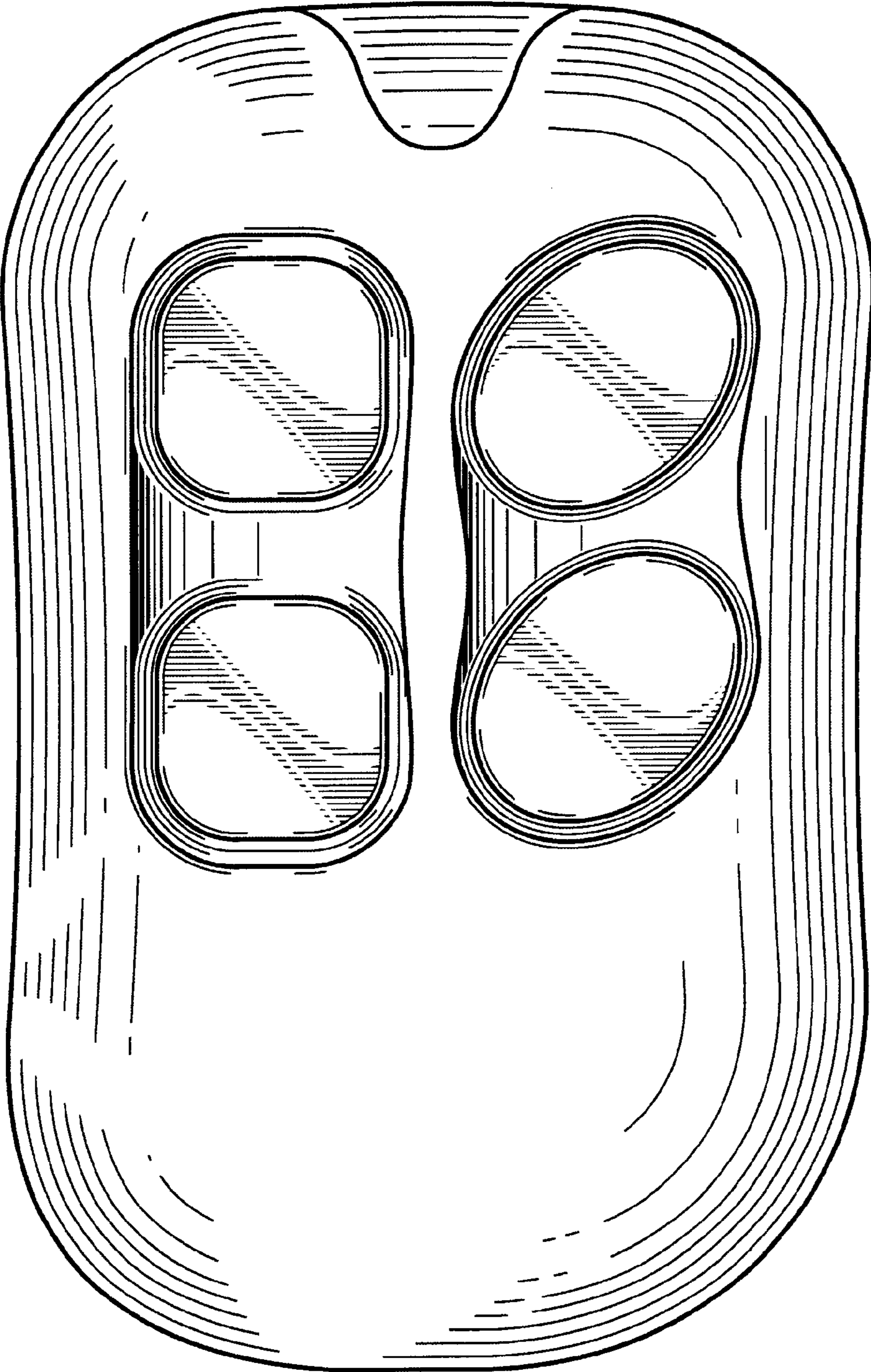

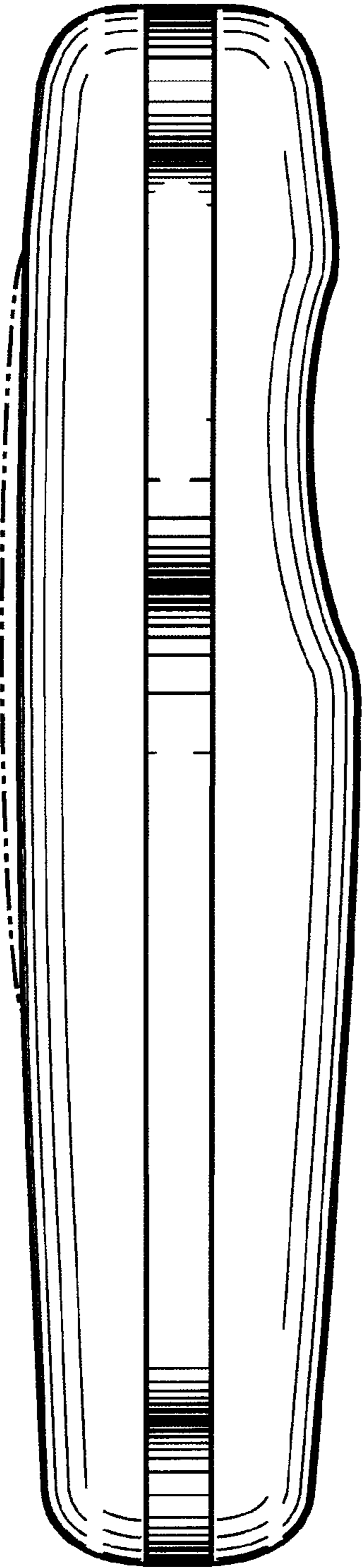

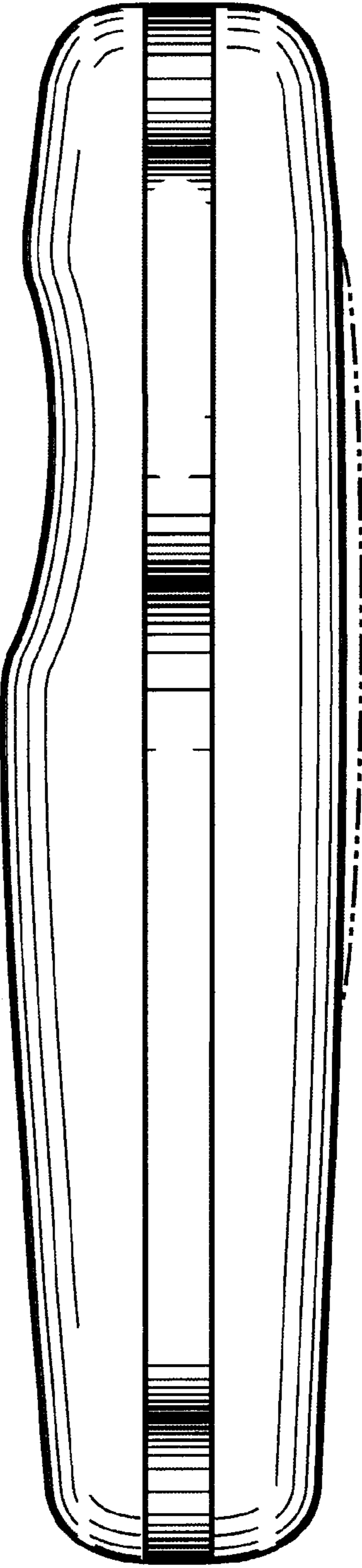

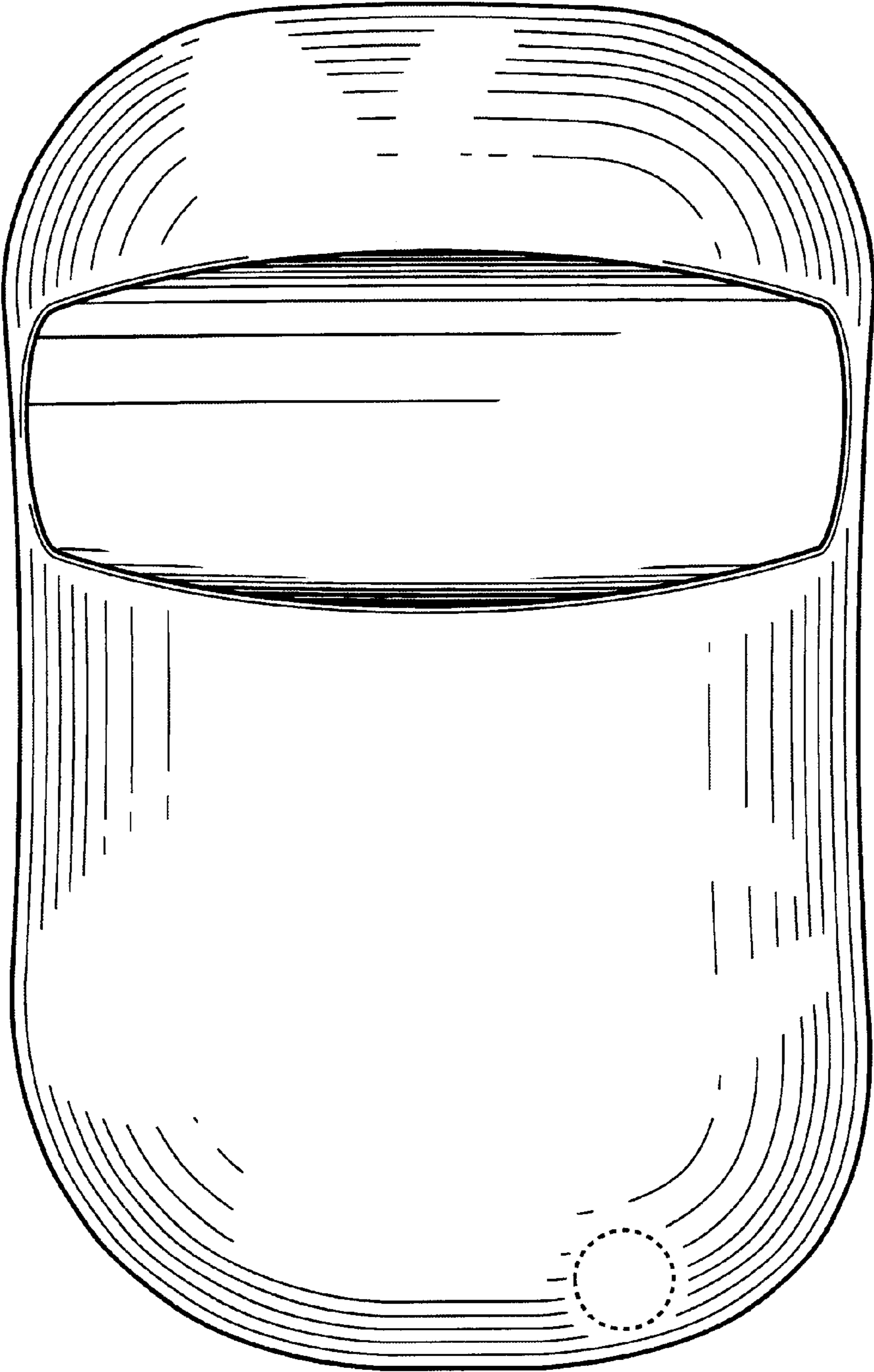

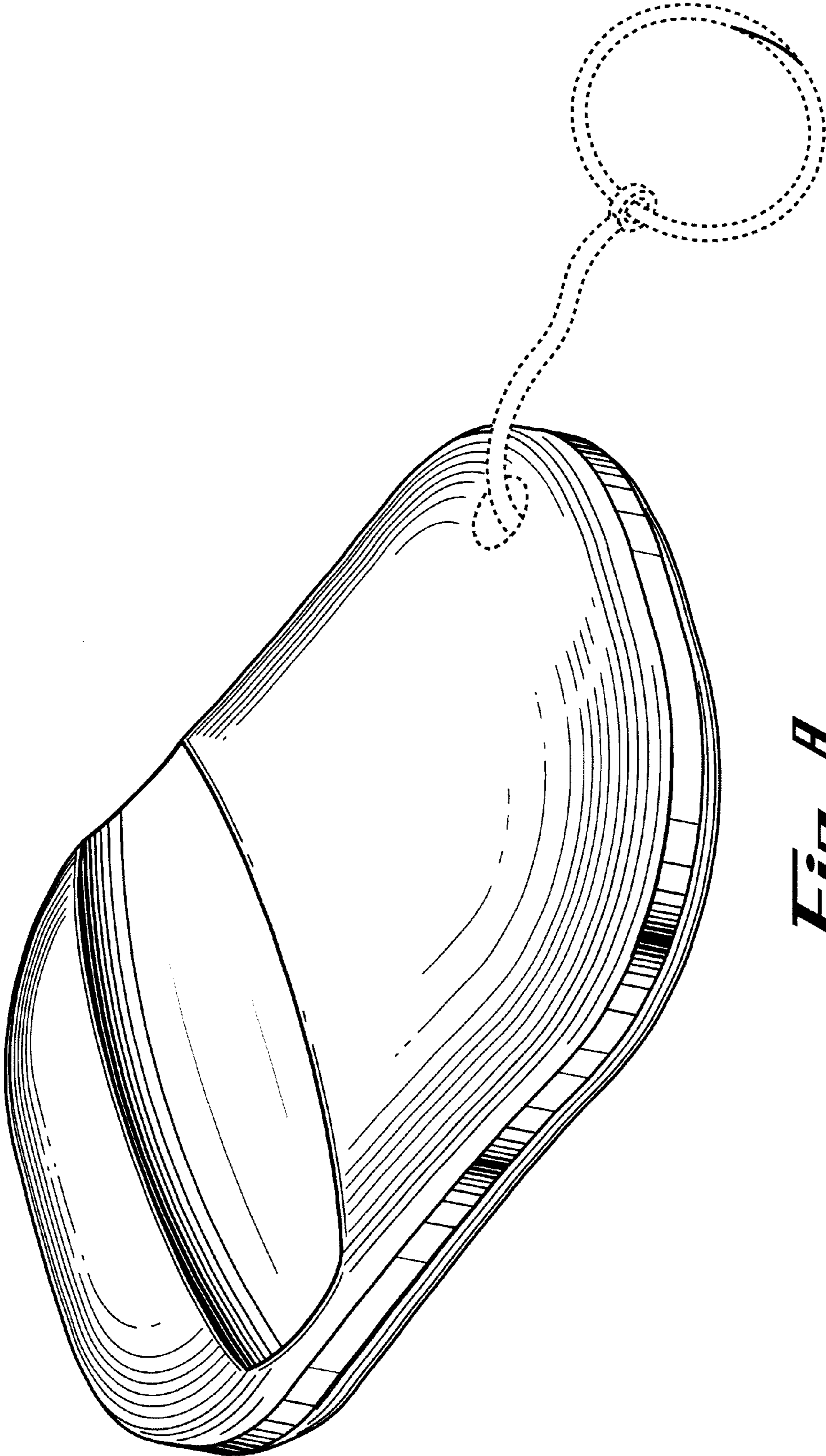
