FIG. 5 is a rear view thereof.

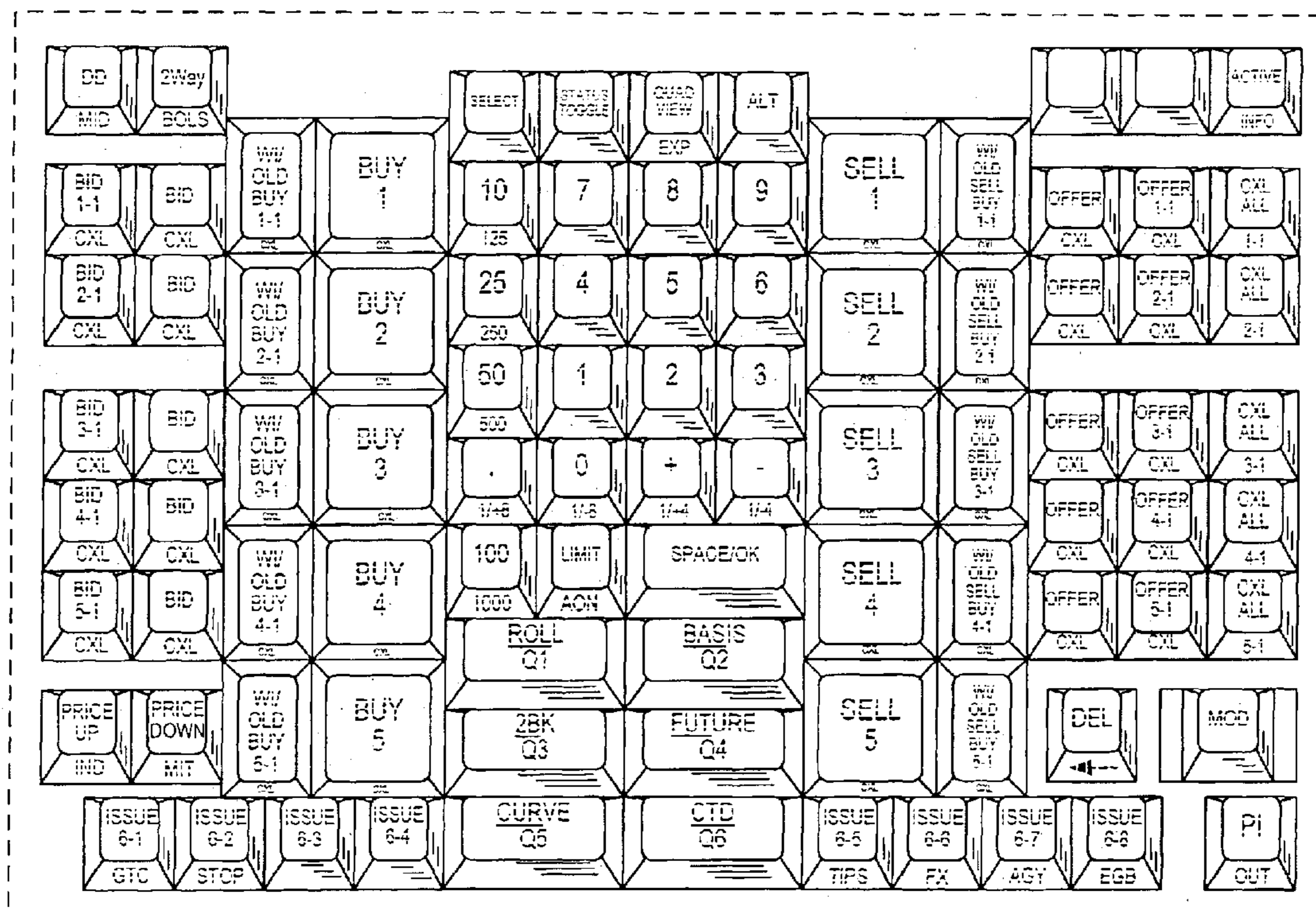

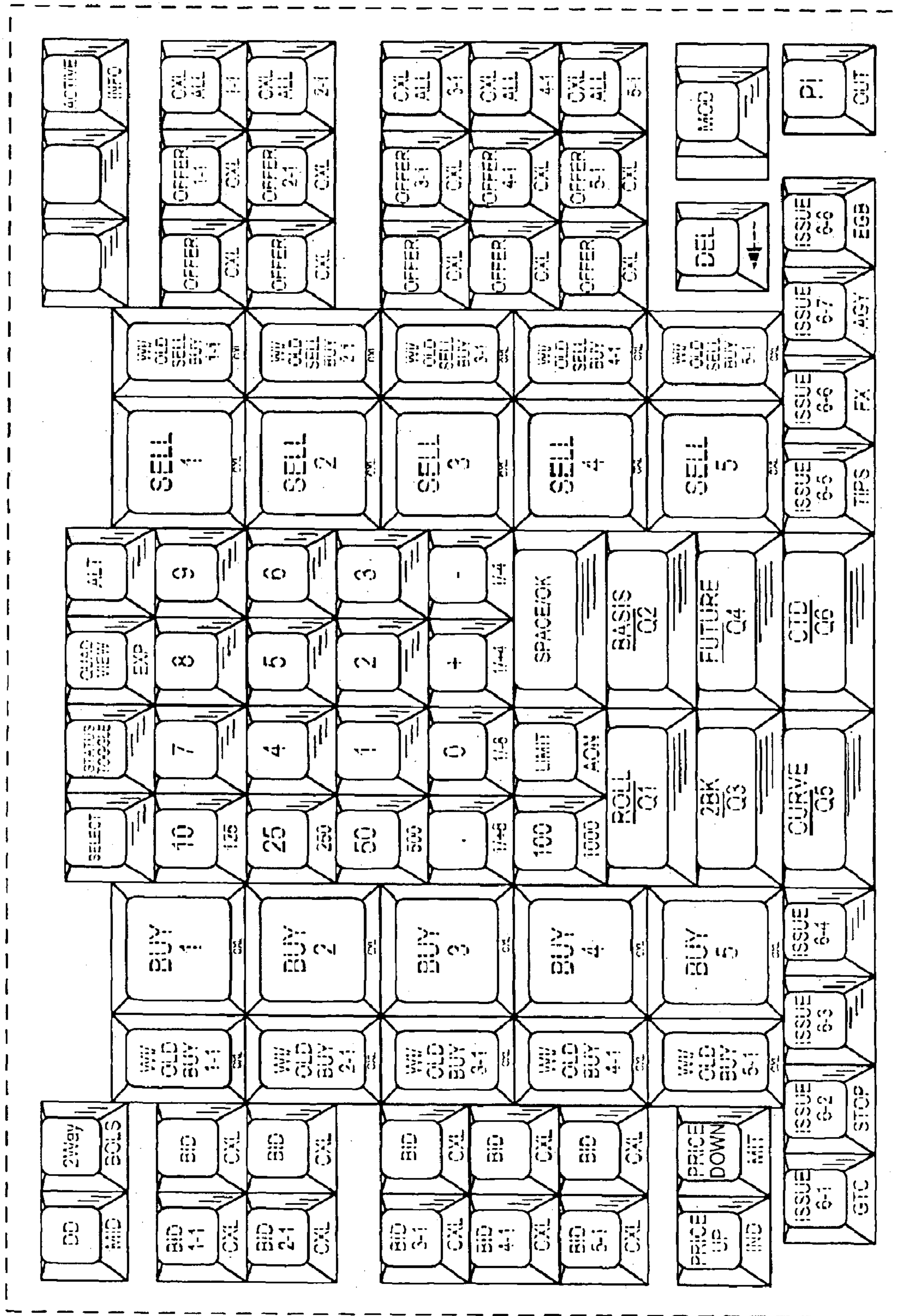

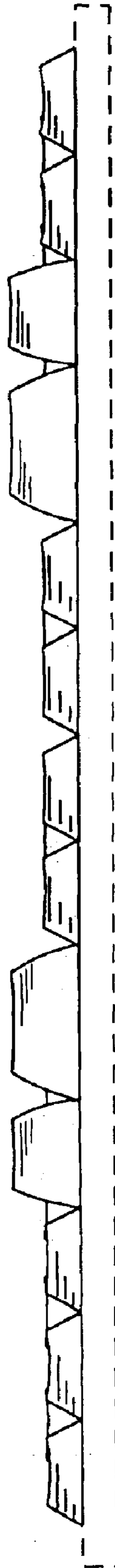
