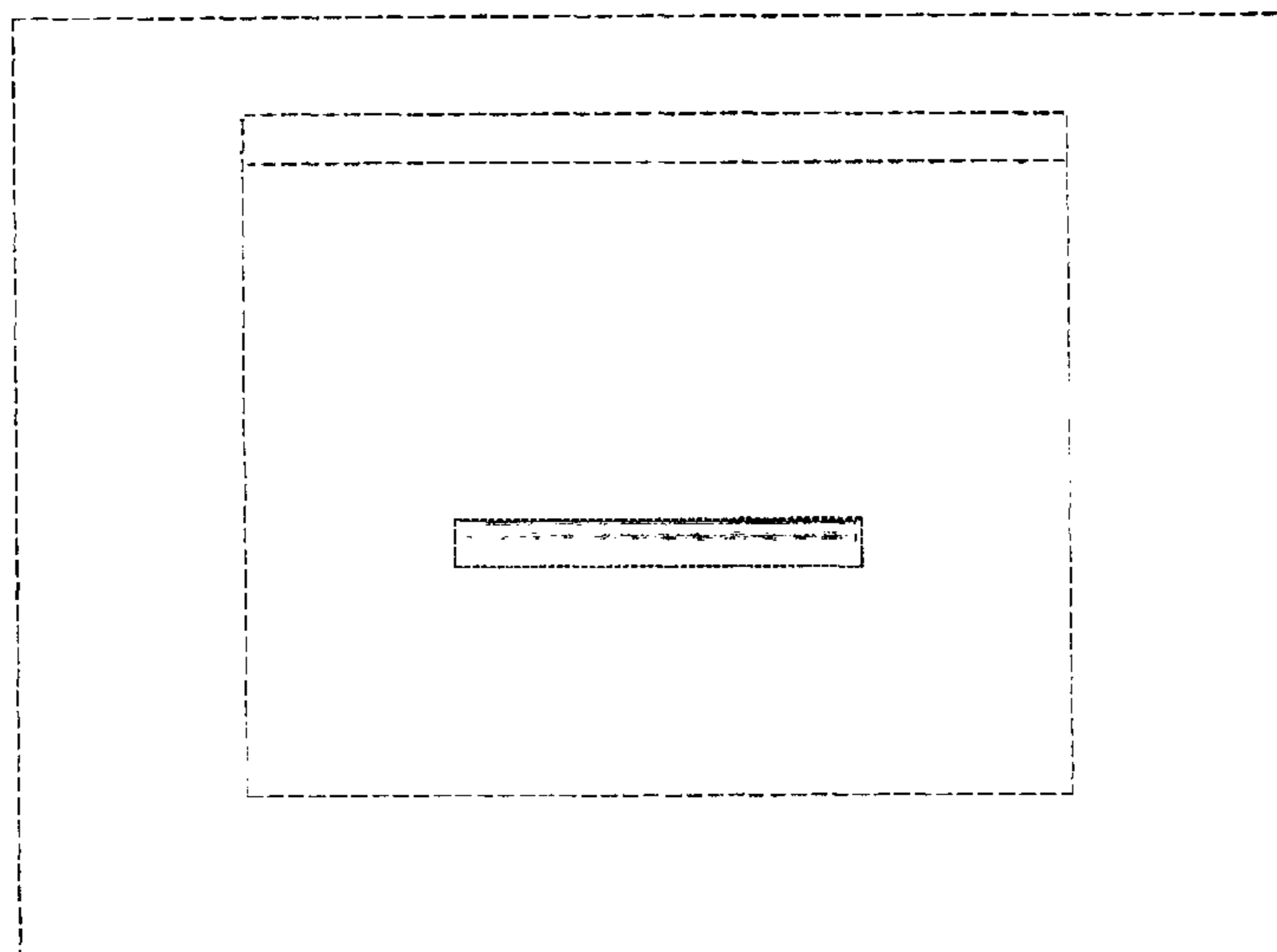

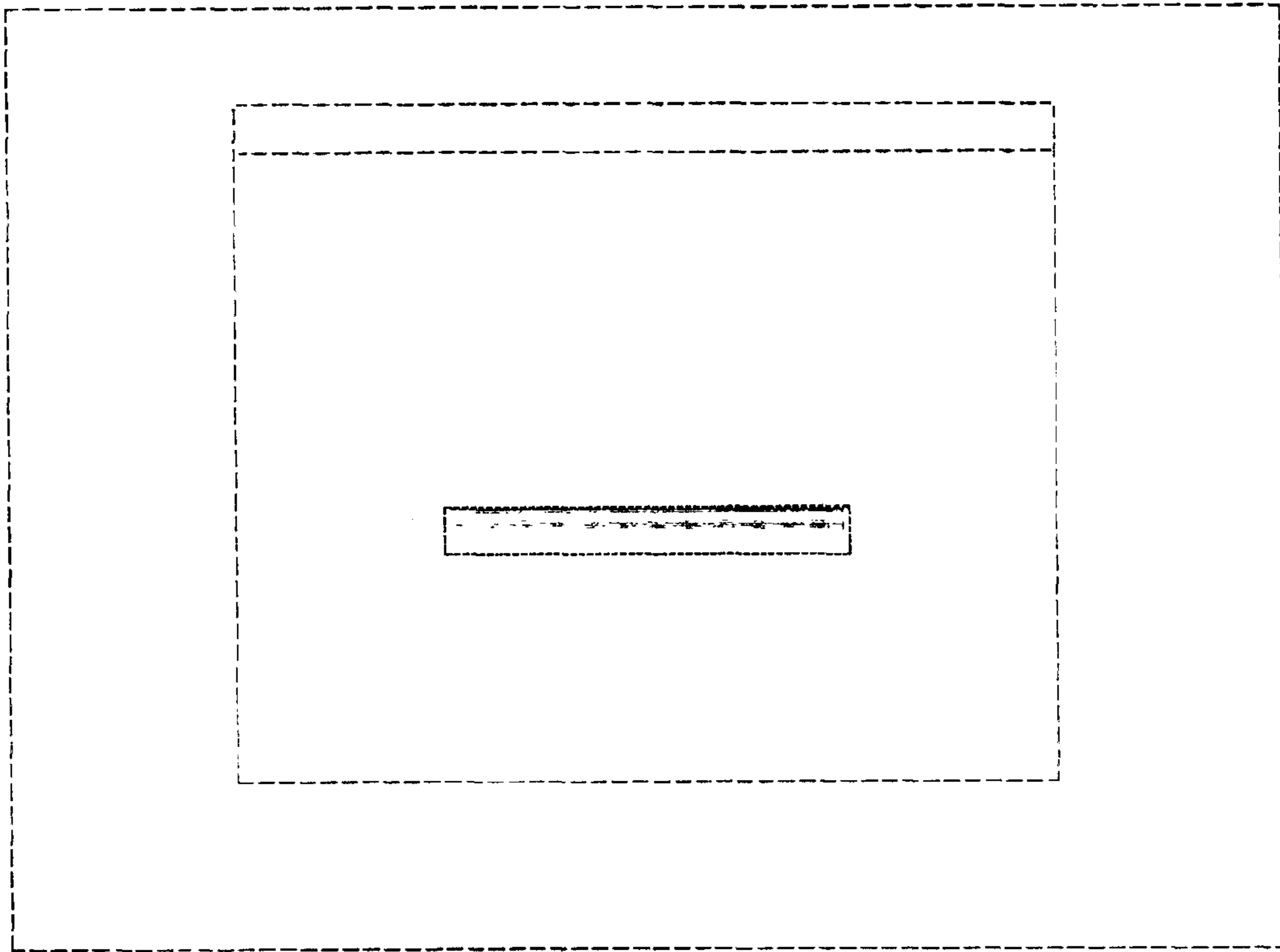
FIG. 1 is a front view of a user interface for a computer display showing our new design; and,

FIG. 2 is a front view of a second embodiment thereof.

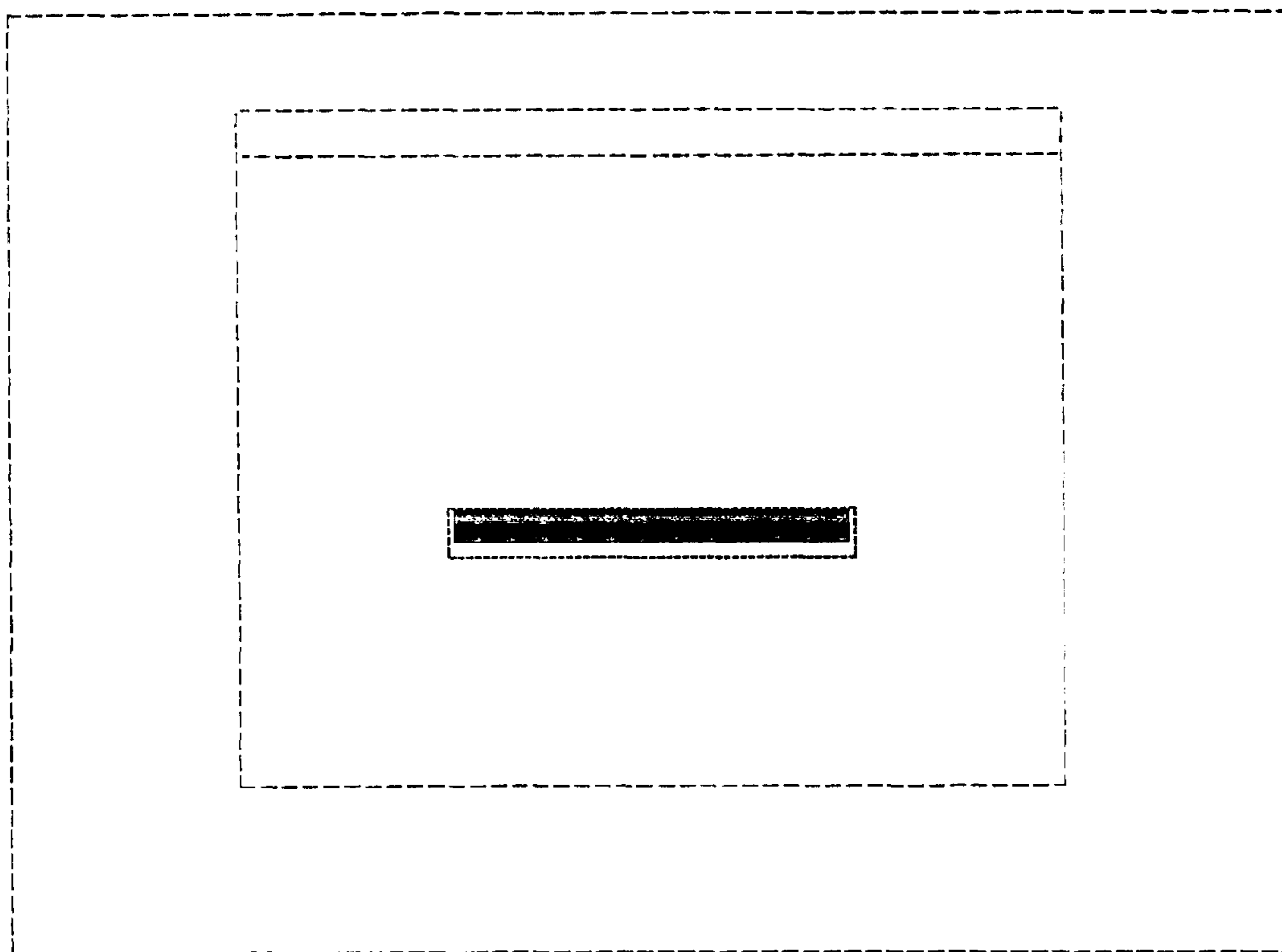
The broken line drawings of the computer display and window in all views are for illustrative purposes only and form no part of the claimed design.
