(57) **CLAIM**

The ornamental design for a liquid crystal projector, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a liquid crystal projector showing my new design, FIG. 2 is a front elevational view thereof, FIG. 3 is a rear elevational view thereof, FIG. 4 is a left side elevational view thereof, FIG. 5 is a right side elevational view thereof, FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

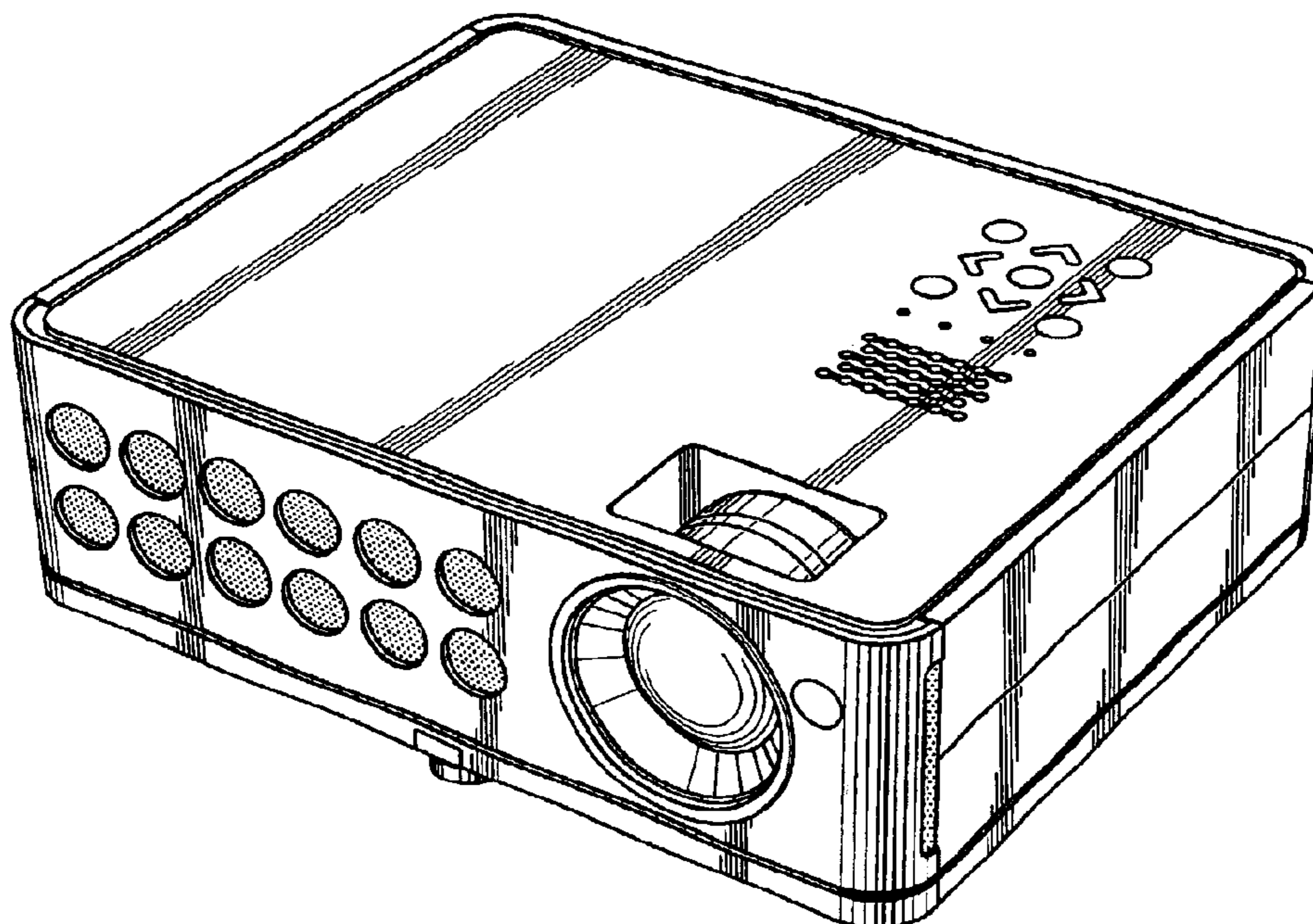

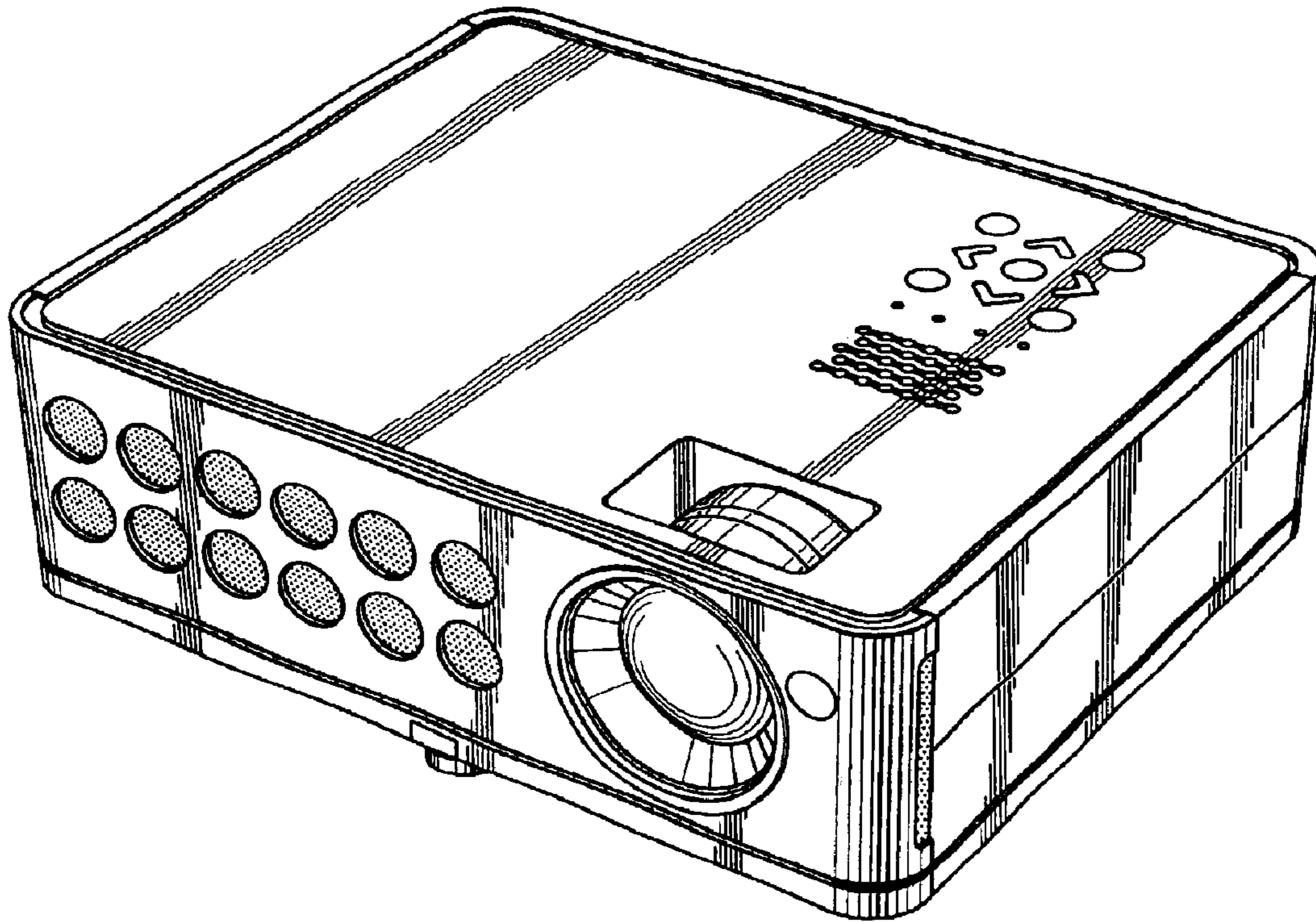

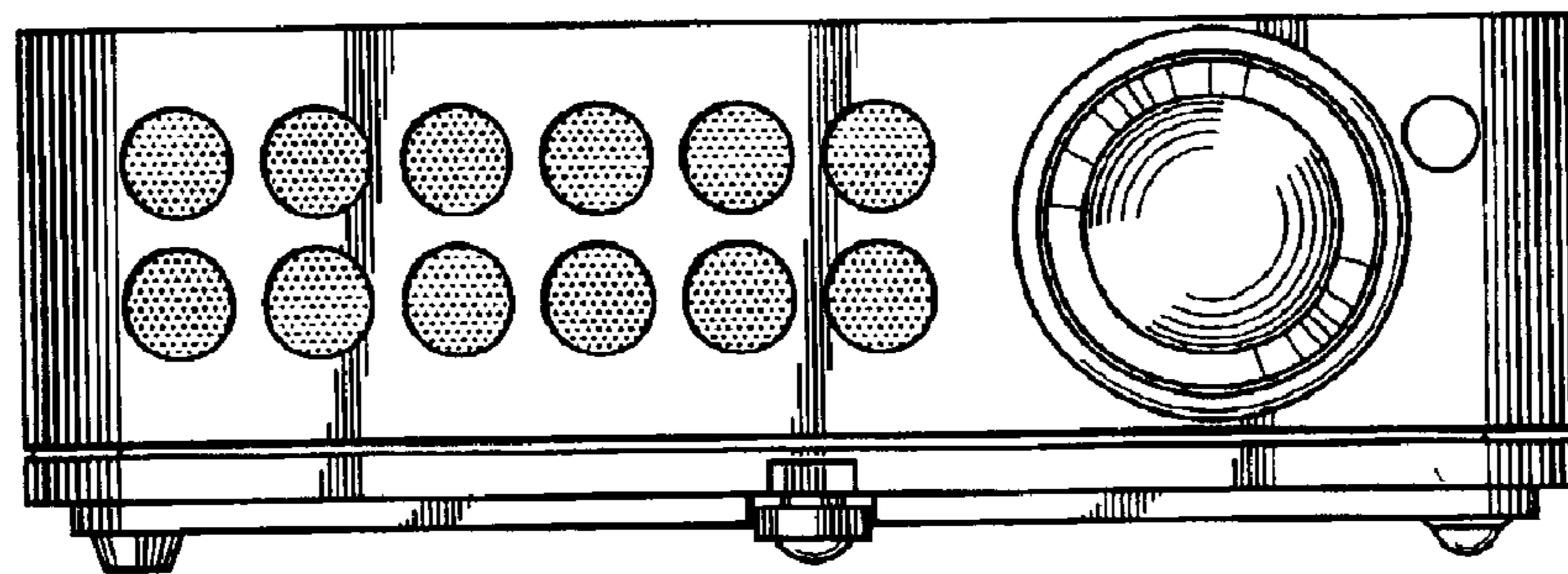

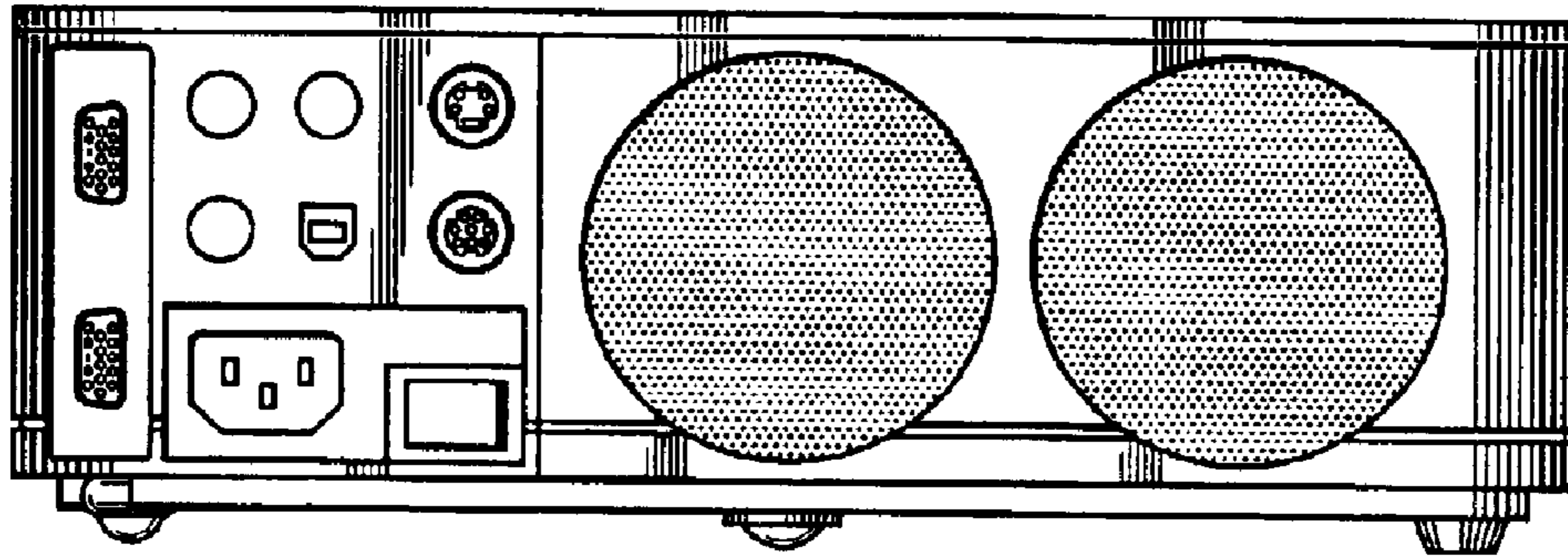

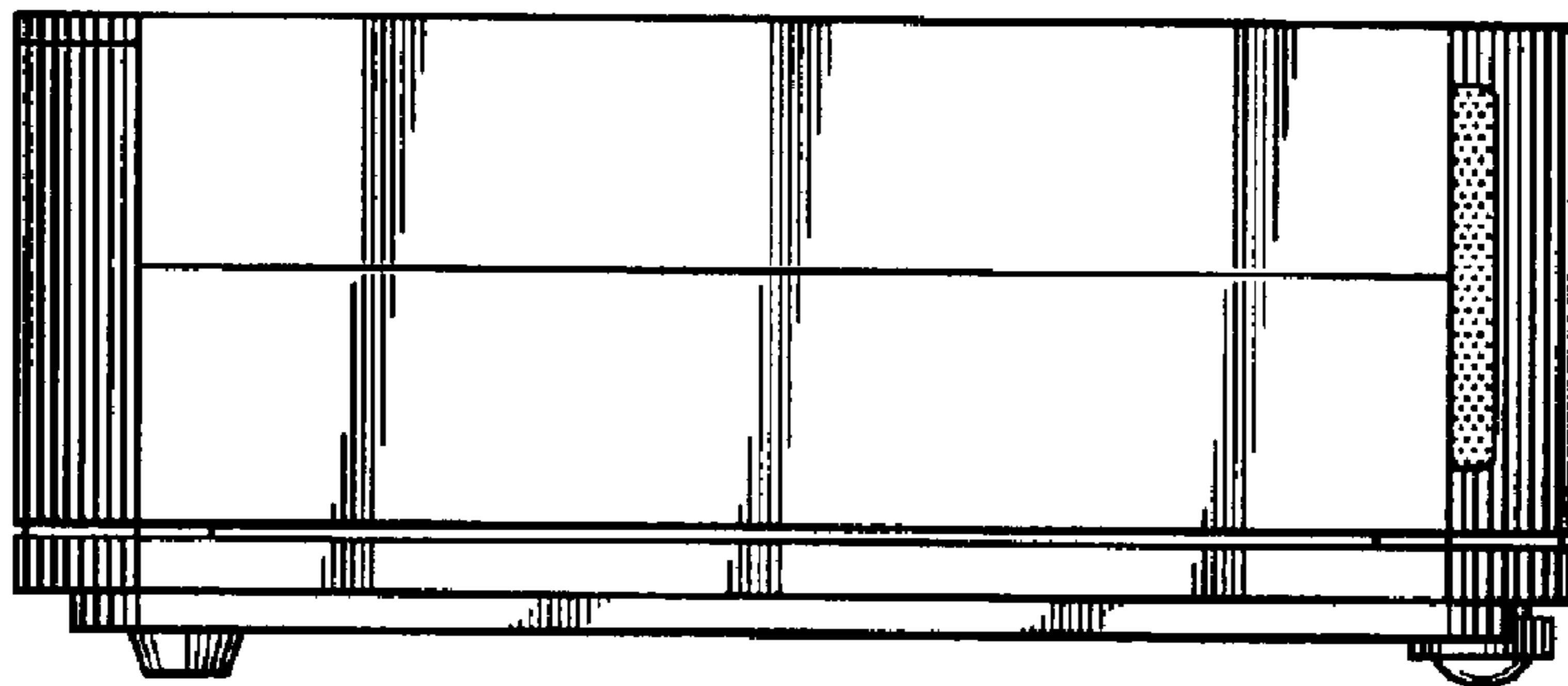

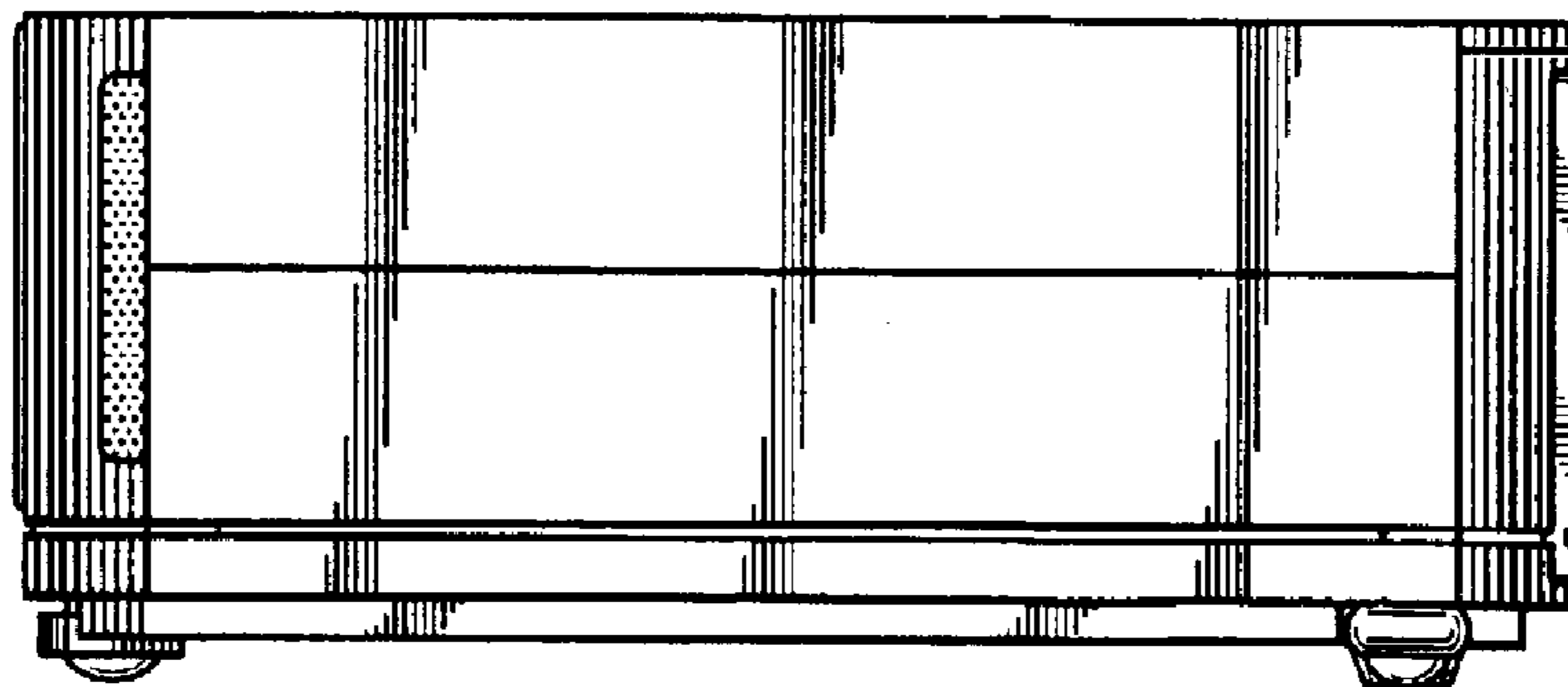

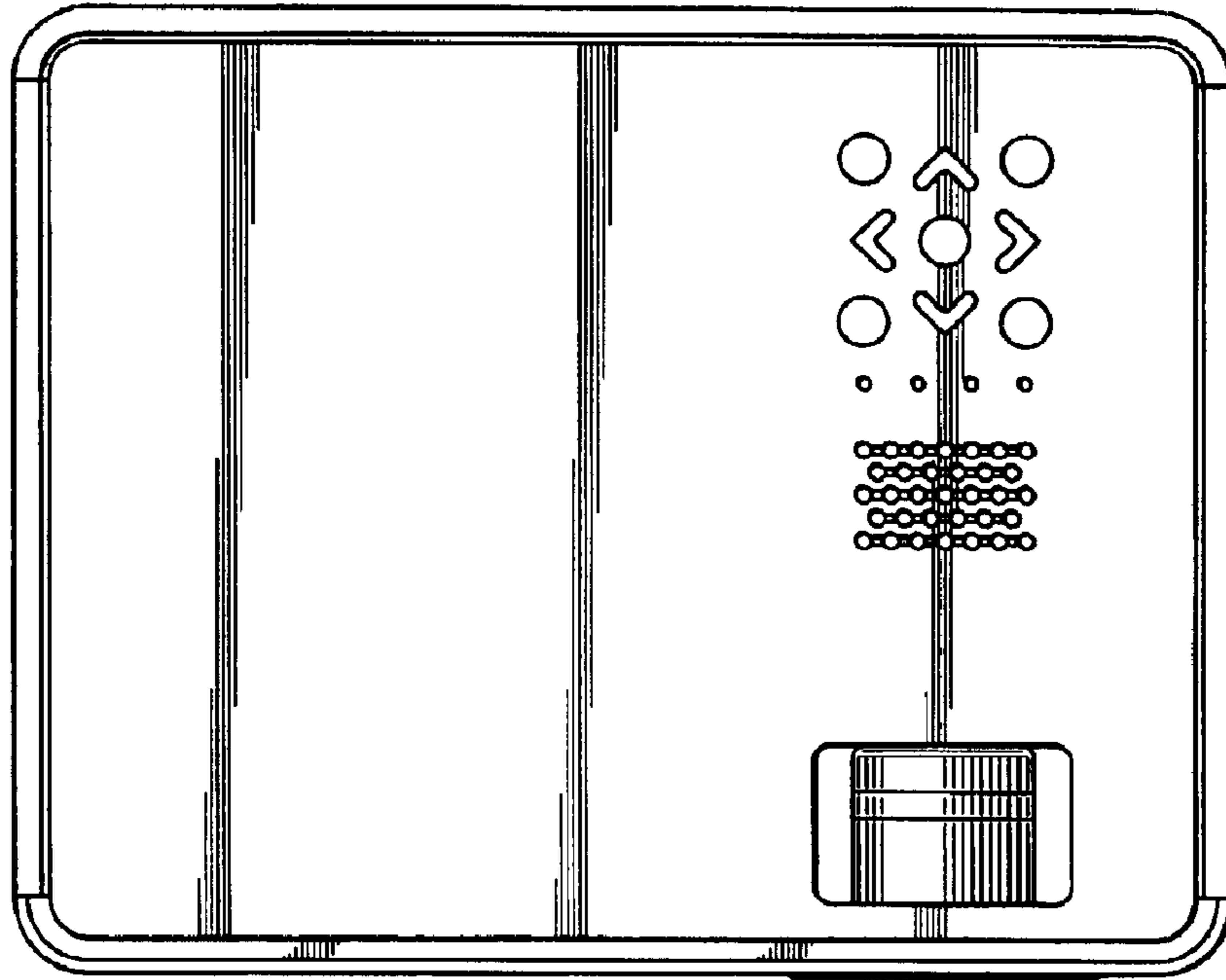
