(57) **CLAIM**

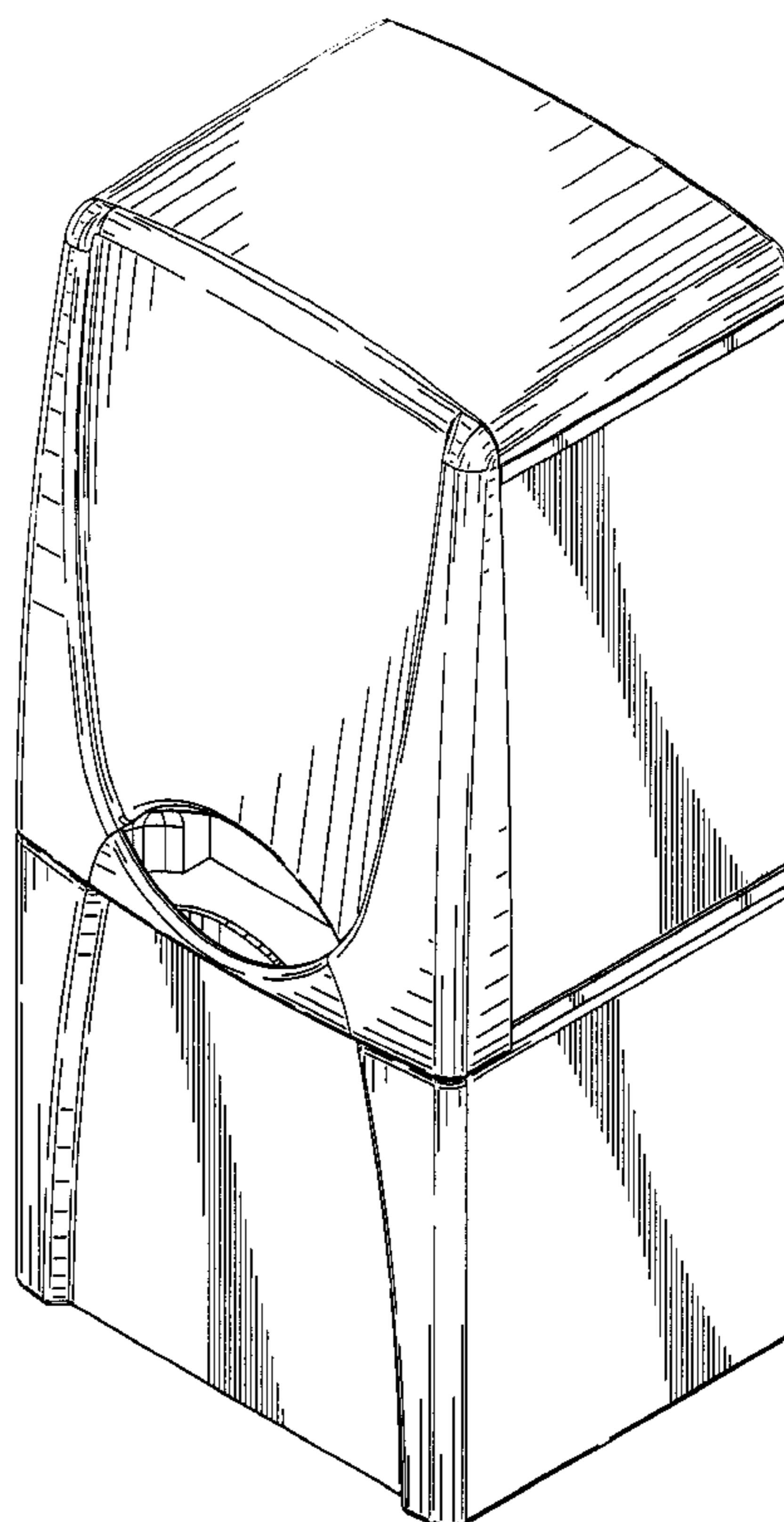
We claim the ornamental design for a vending machine and stand, substantially as shown and described.

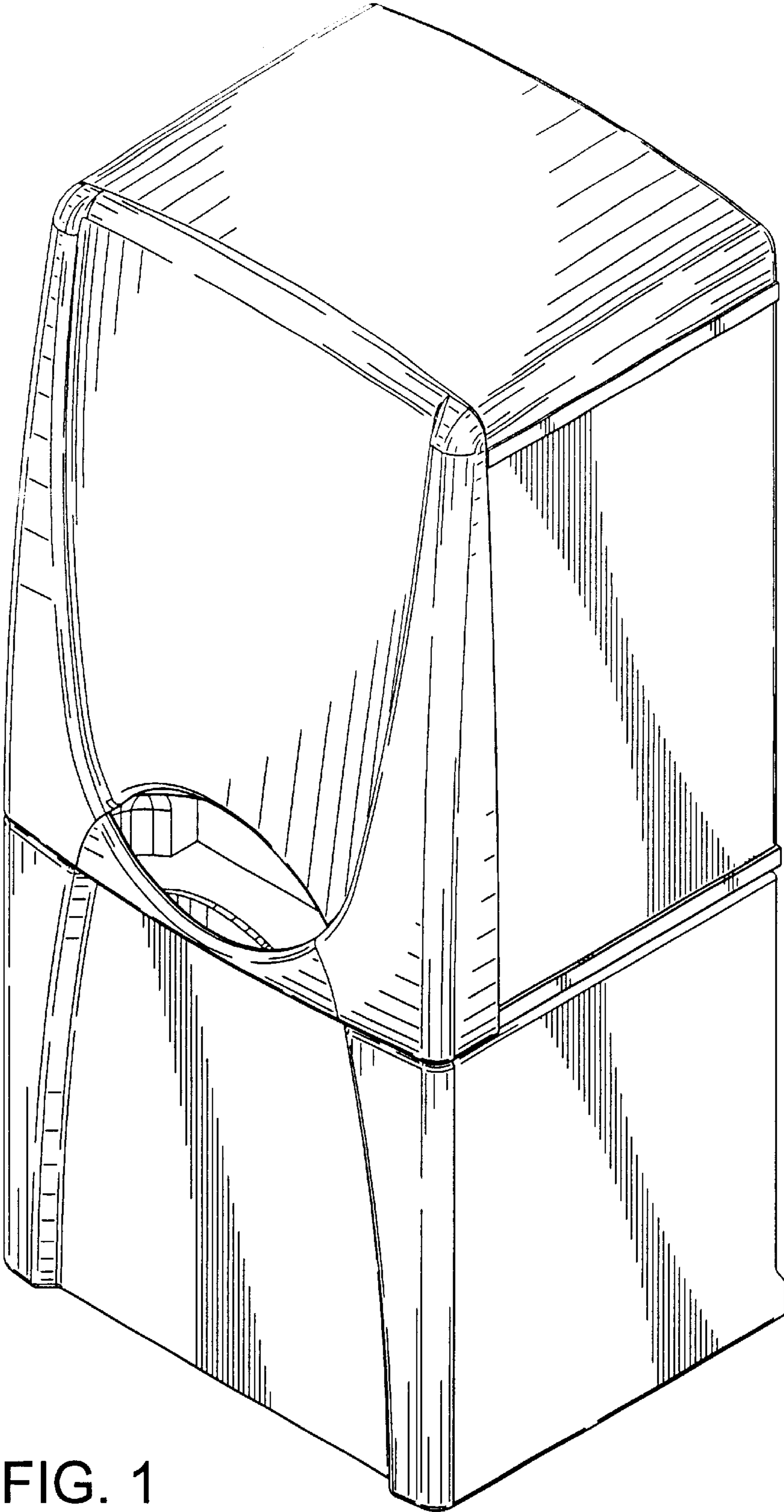

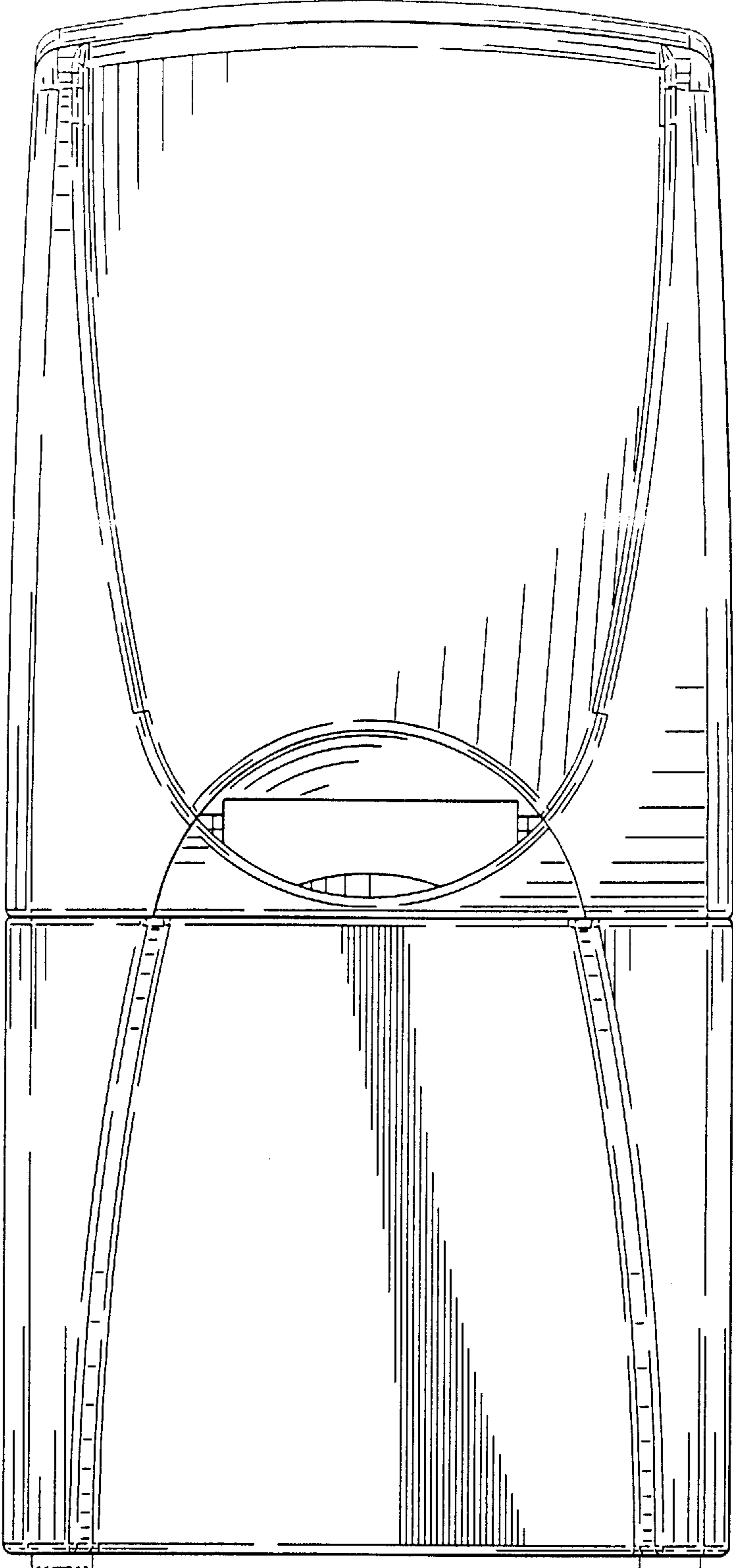
