The ornamental design of a table, as shown and described.

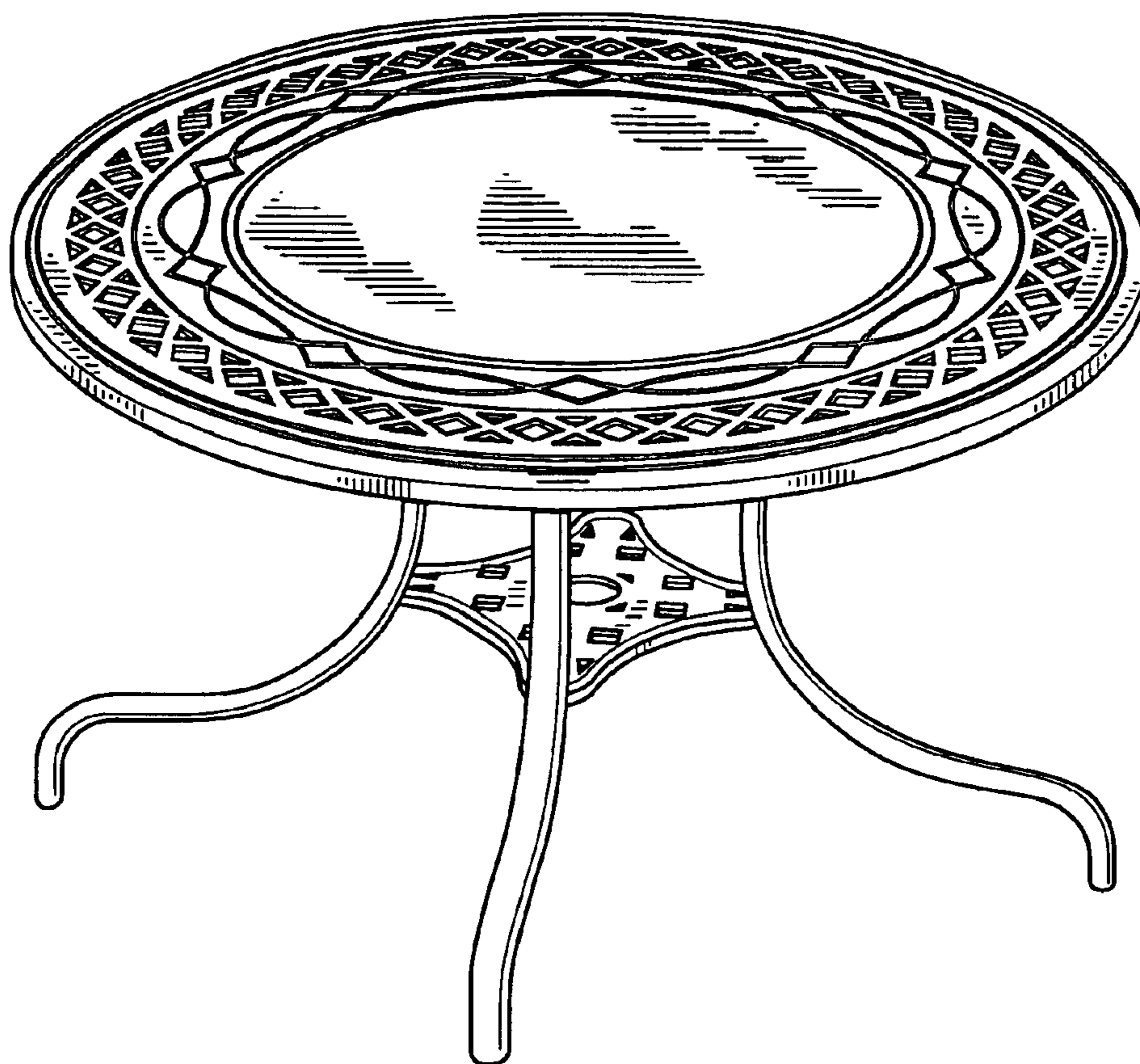
**DESCRIPTION**

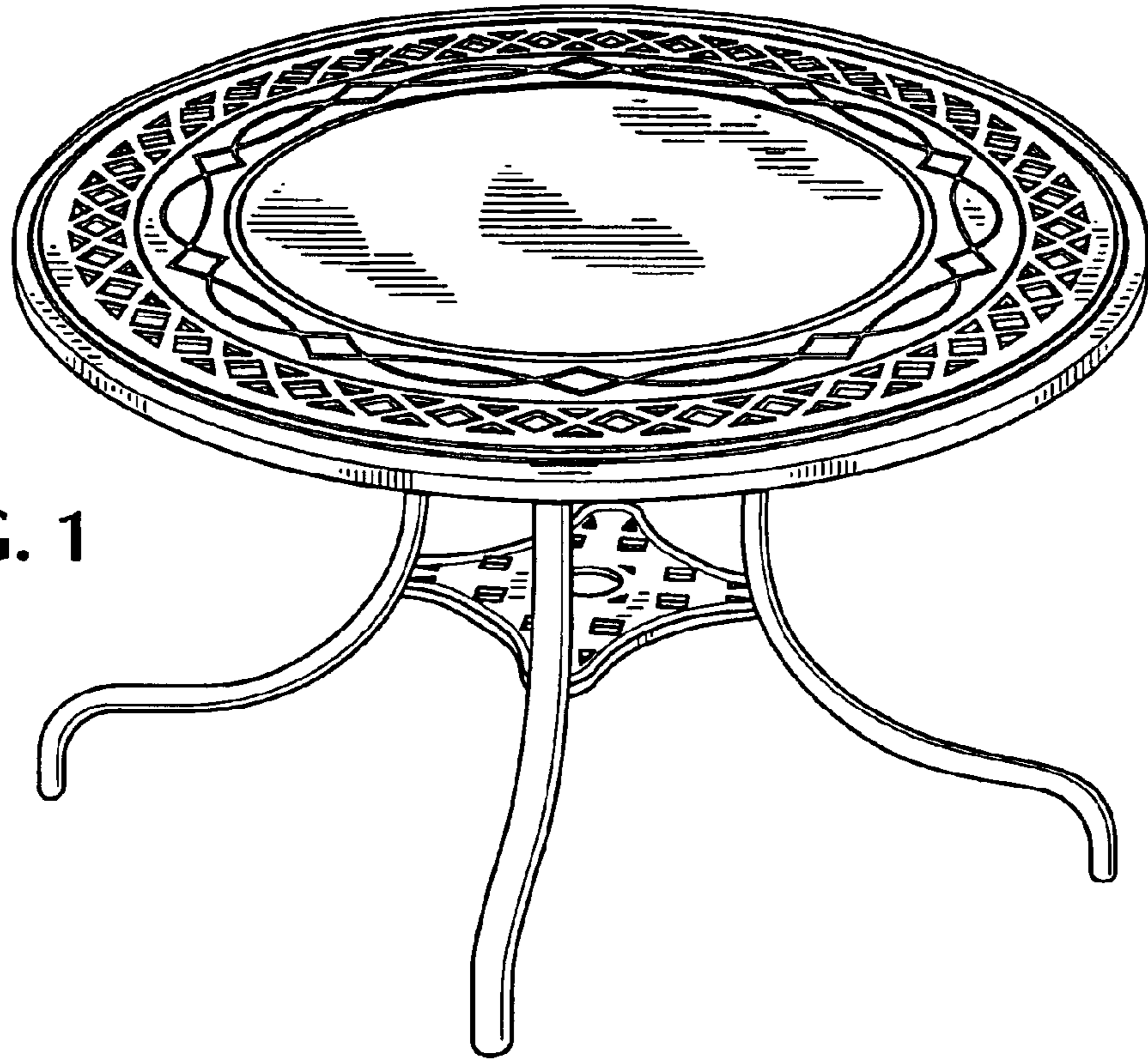

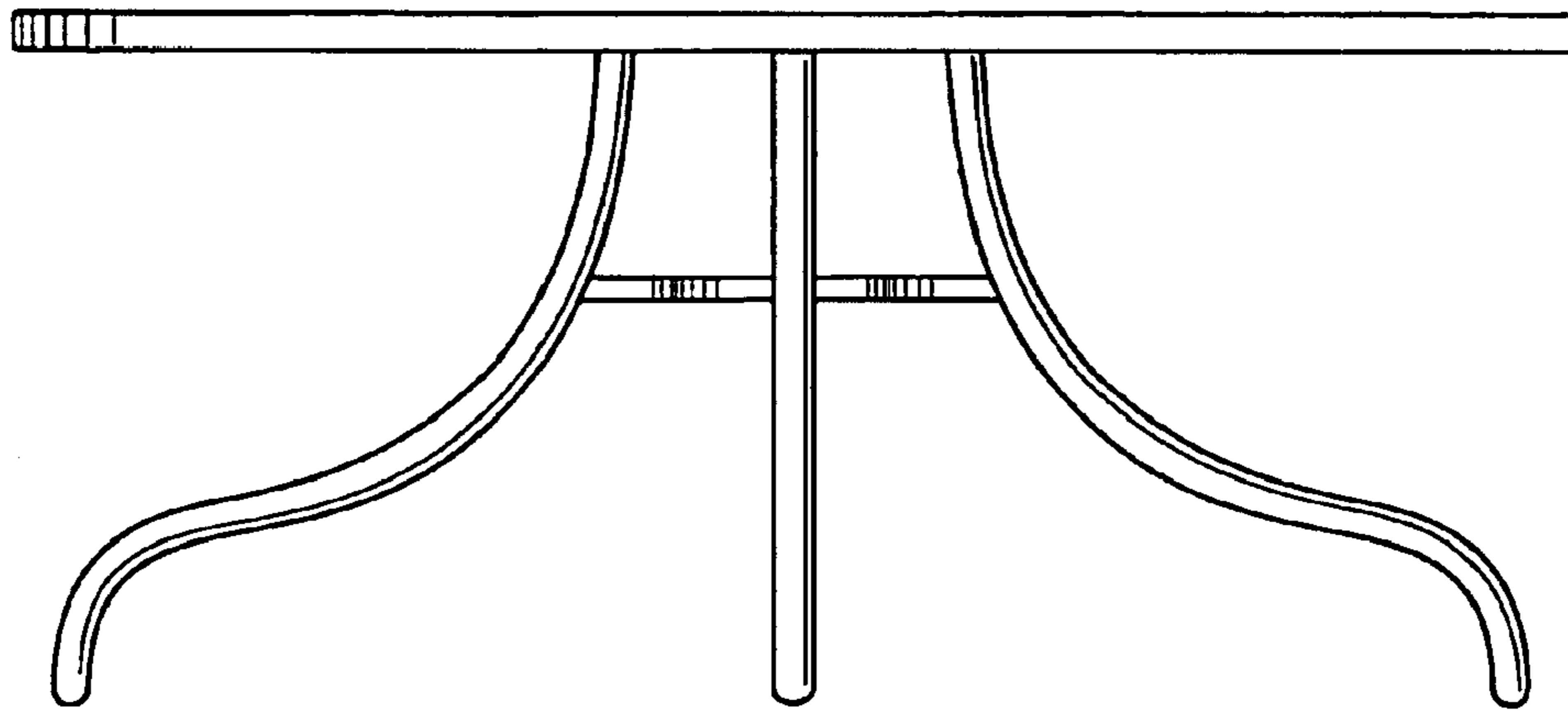
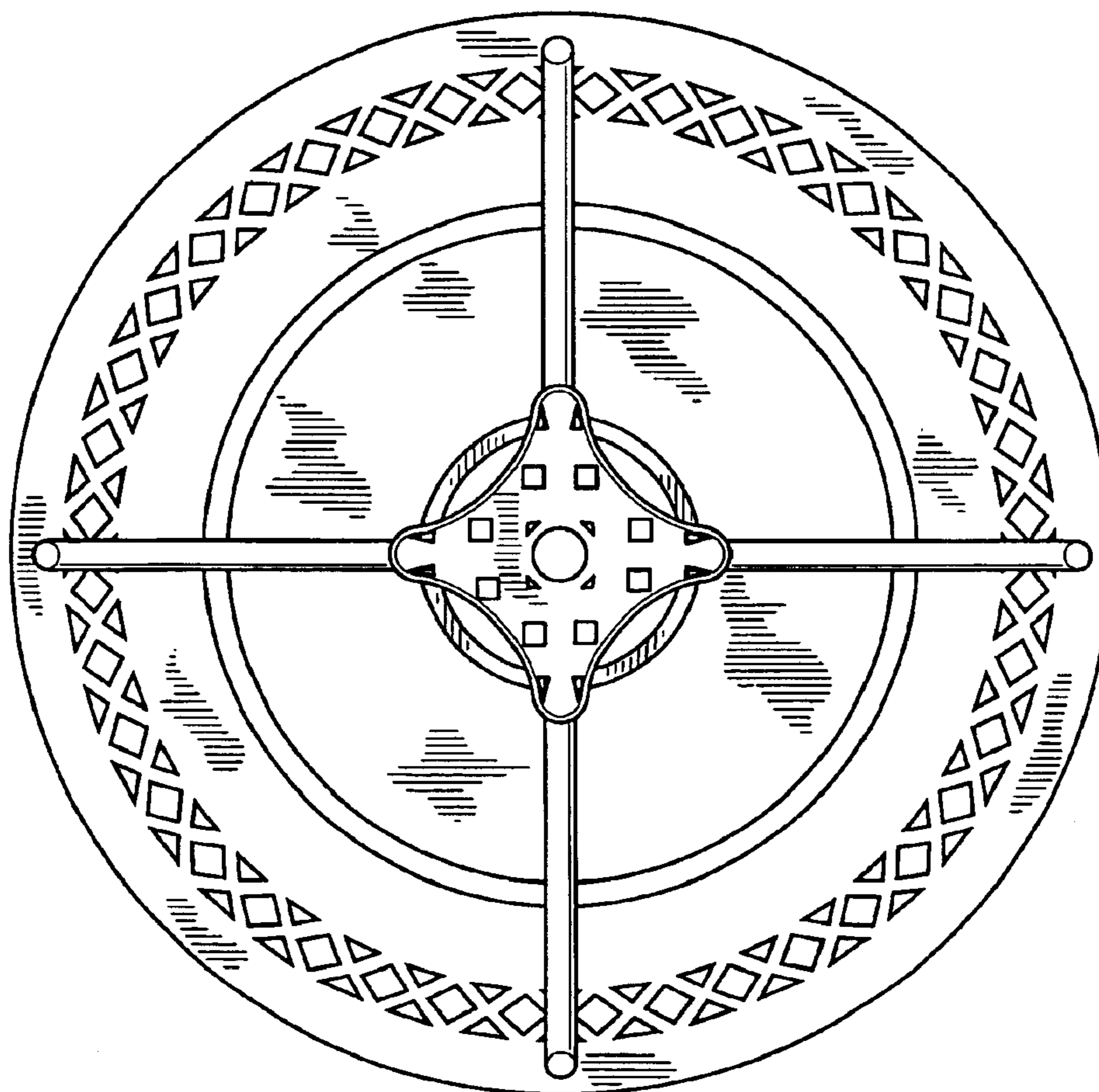

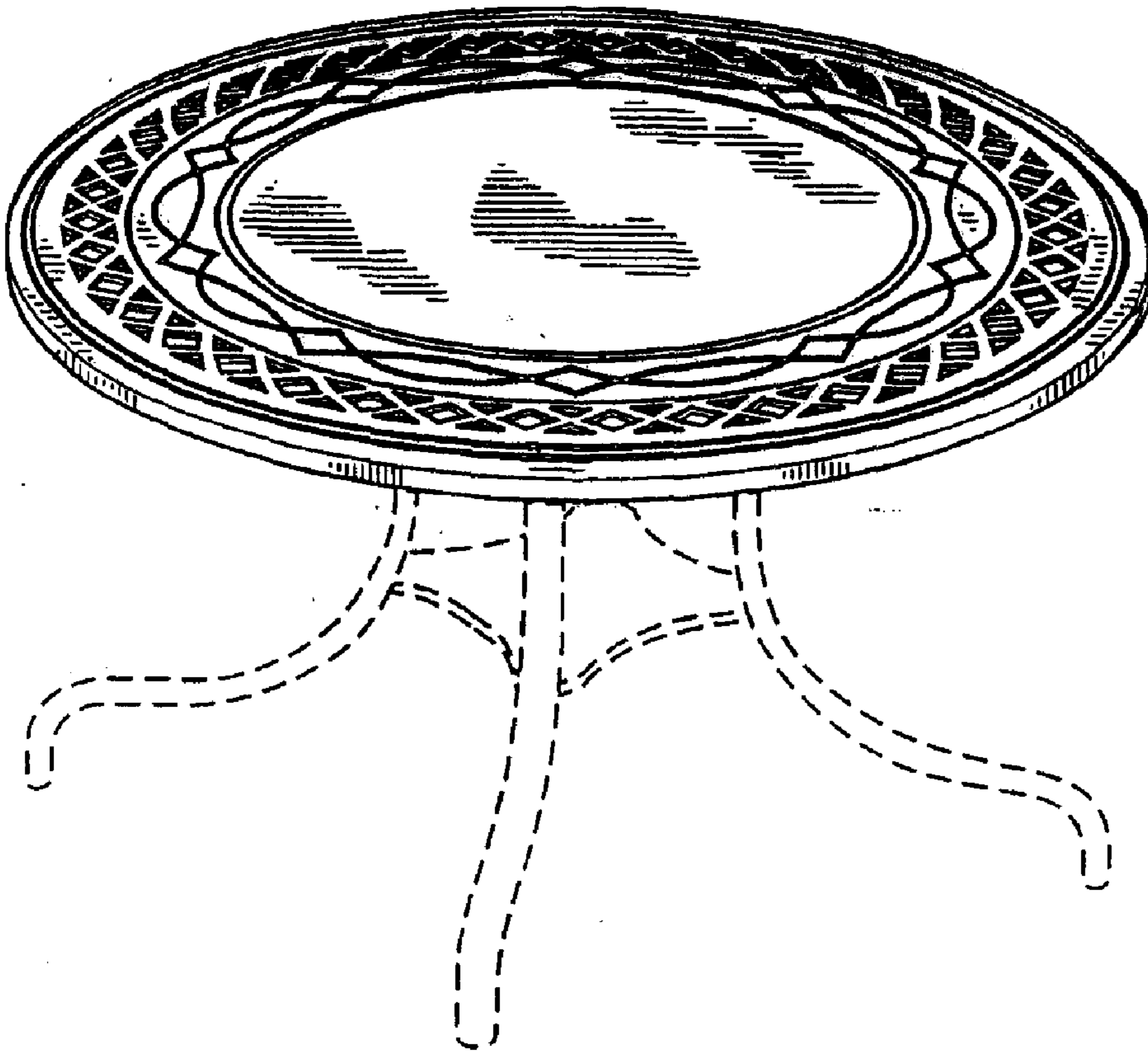

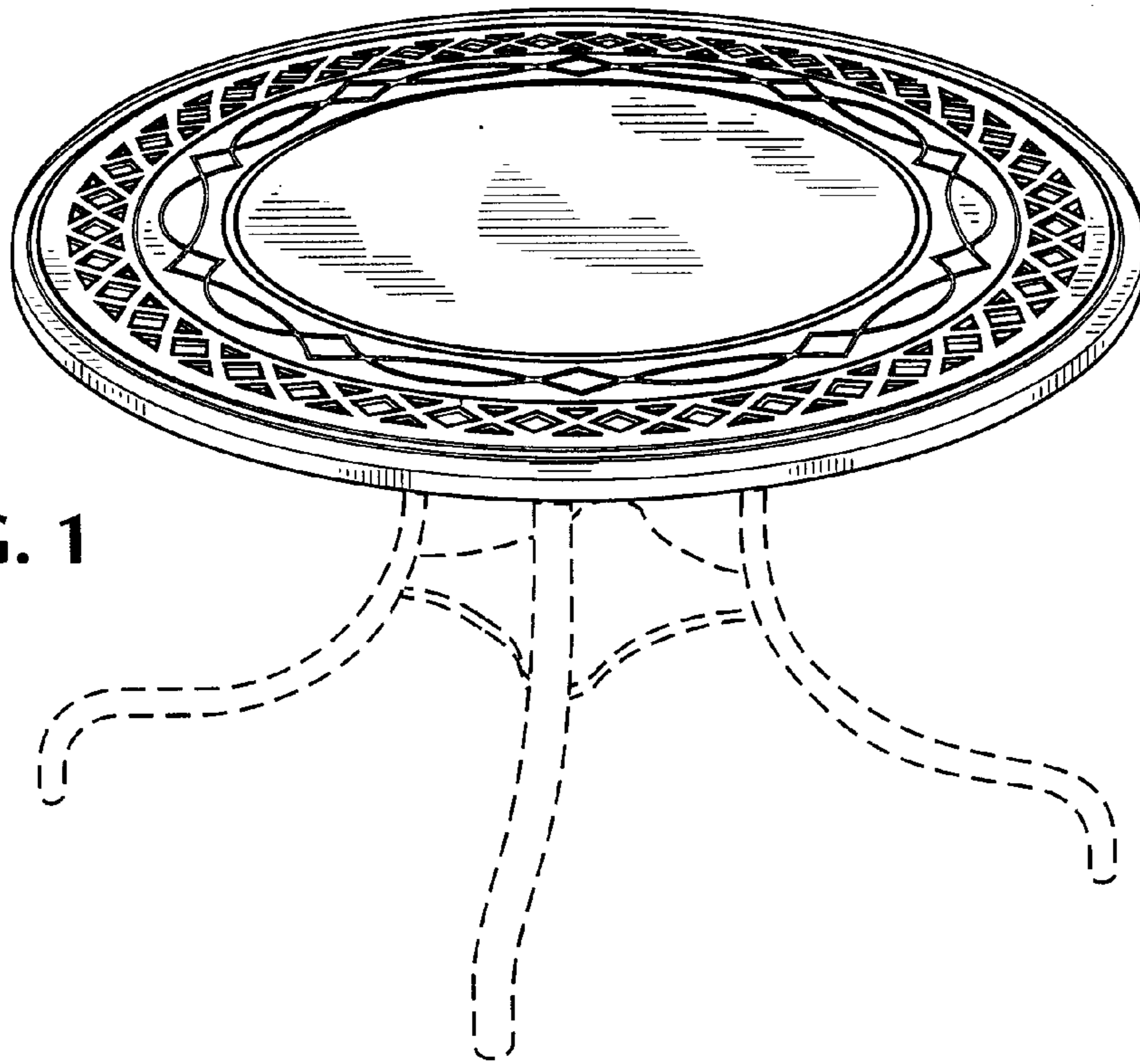

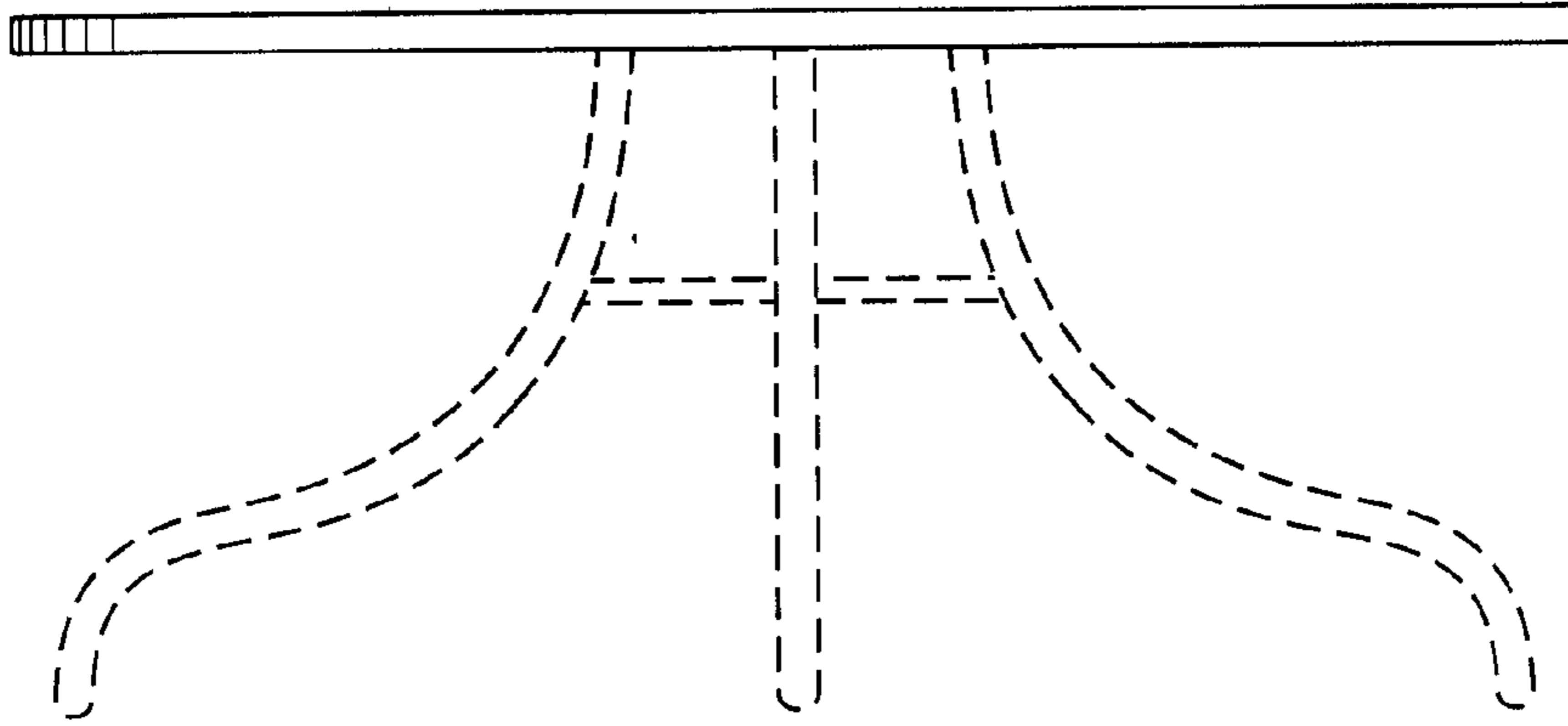
