The ornamental design for, door lining for an automobile, as shown and described.

DESCRIPTION

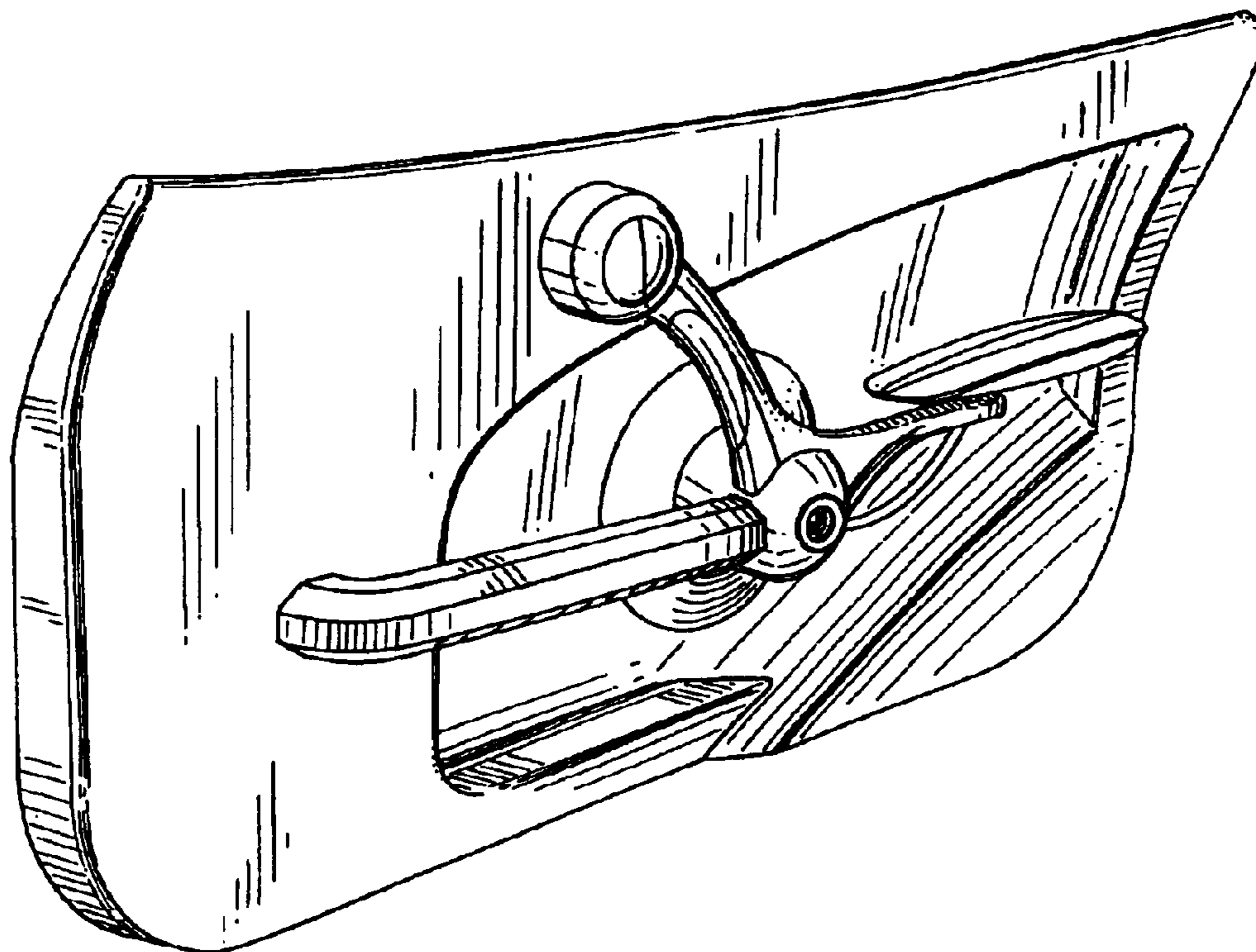

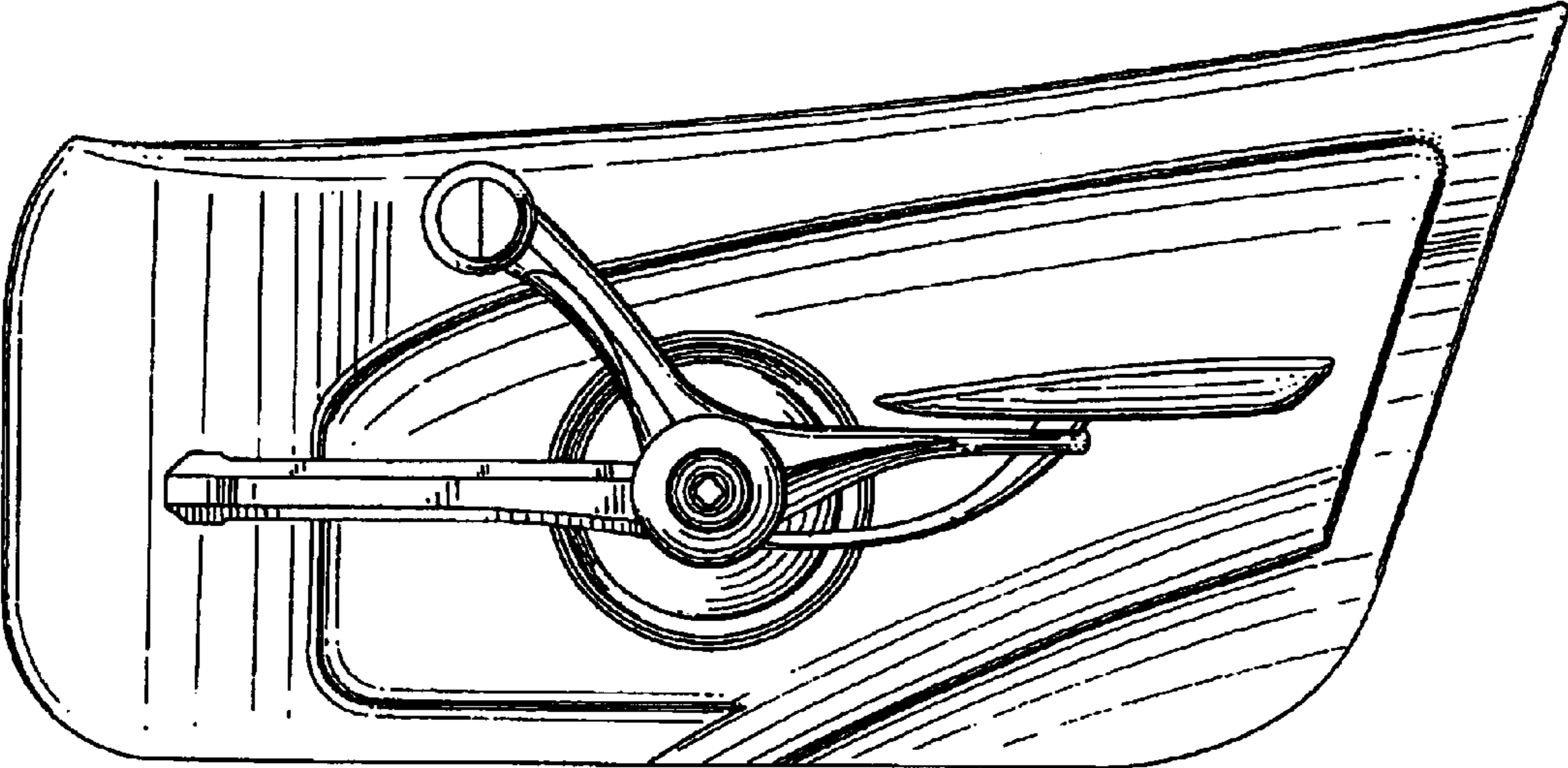

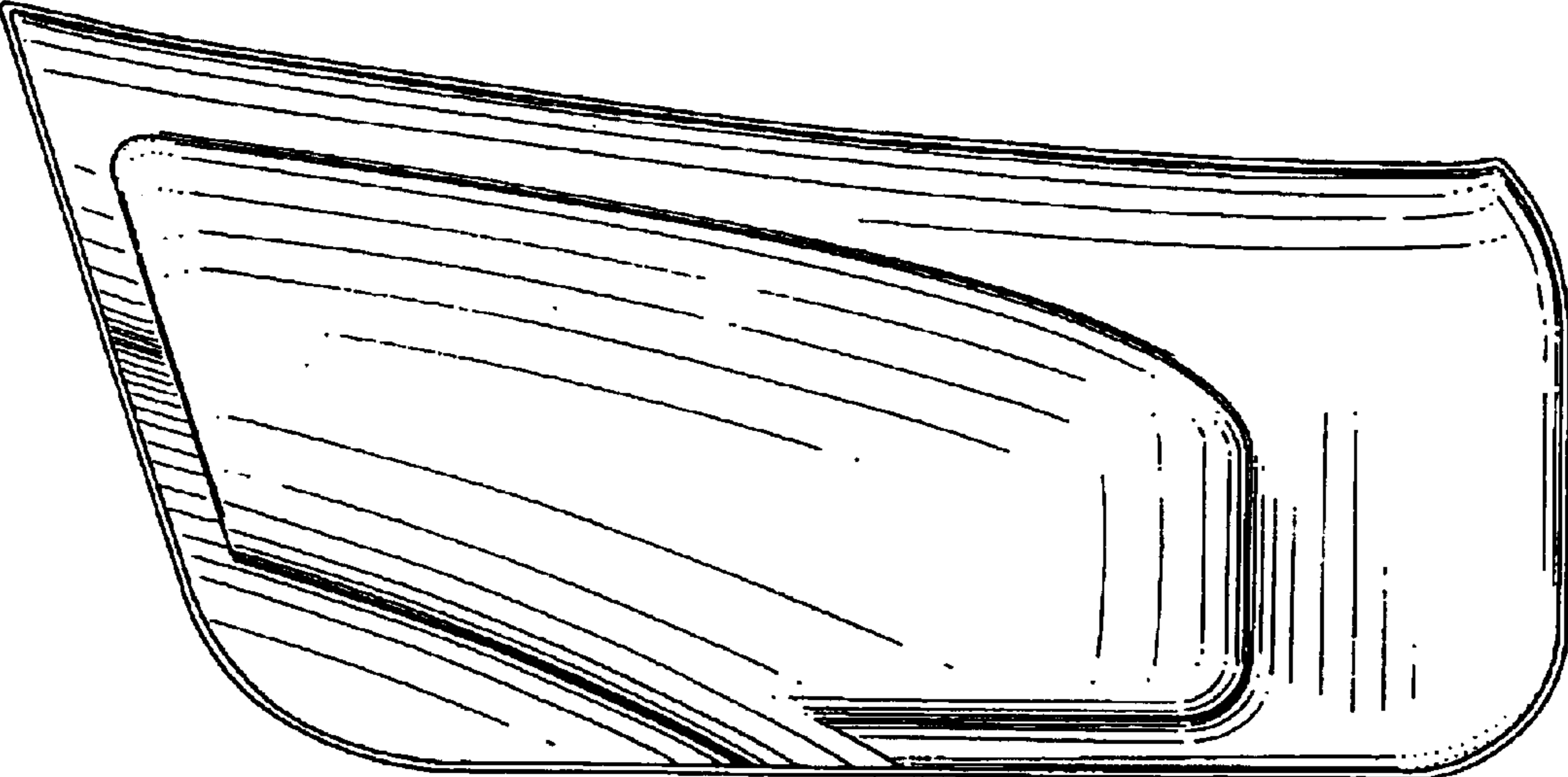

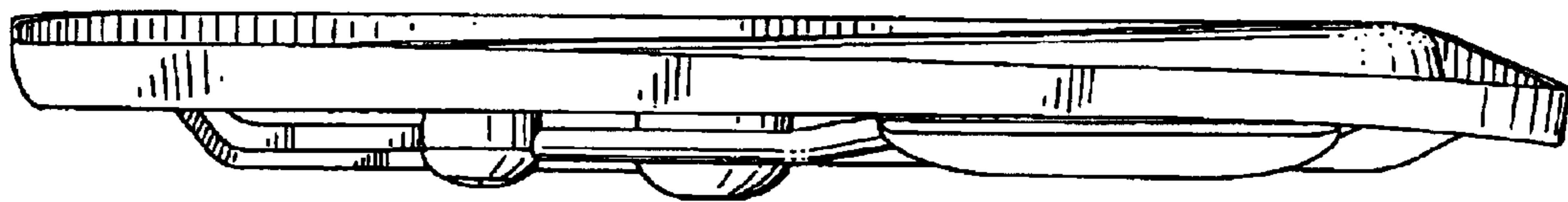

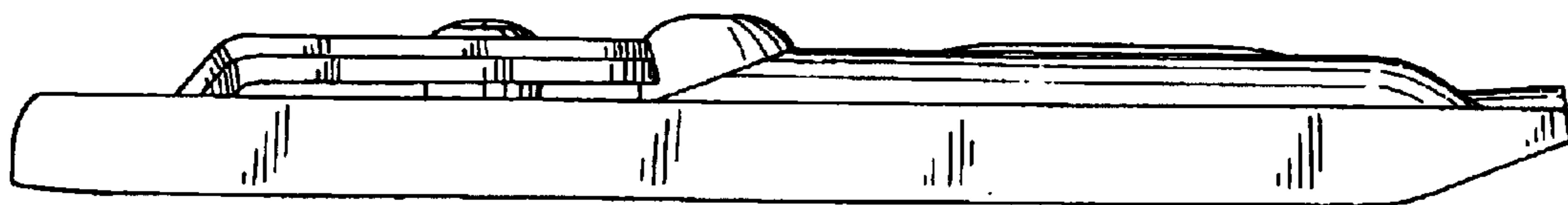

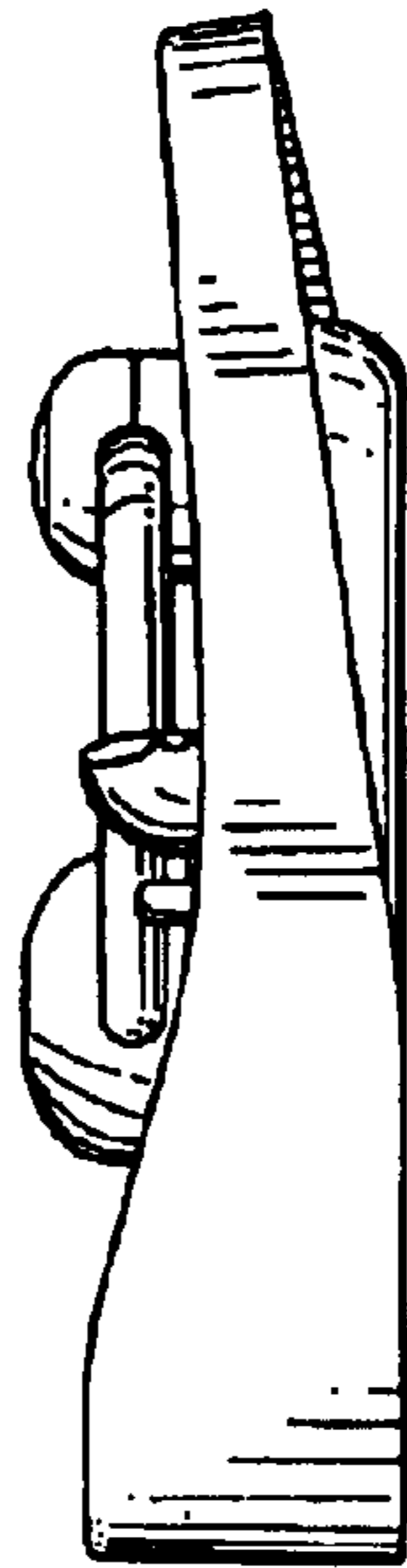

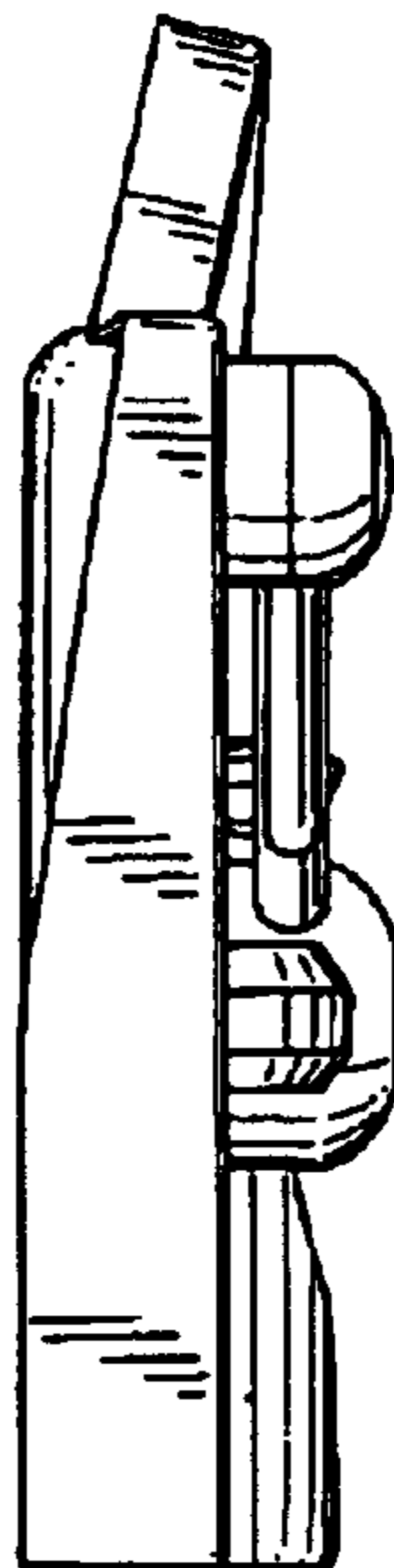
