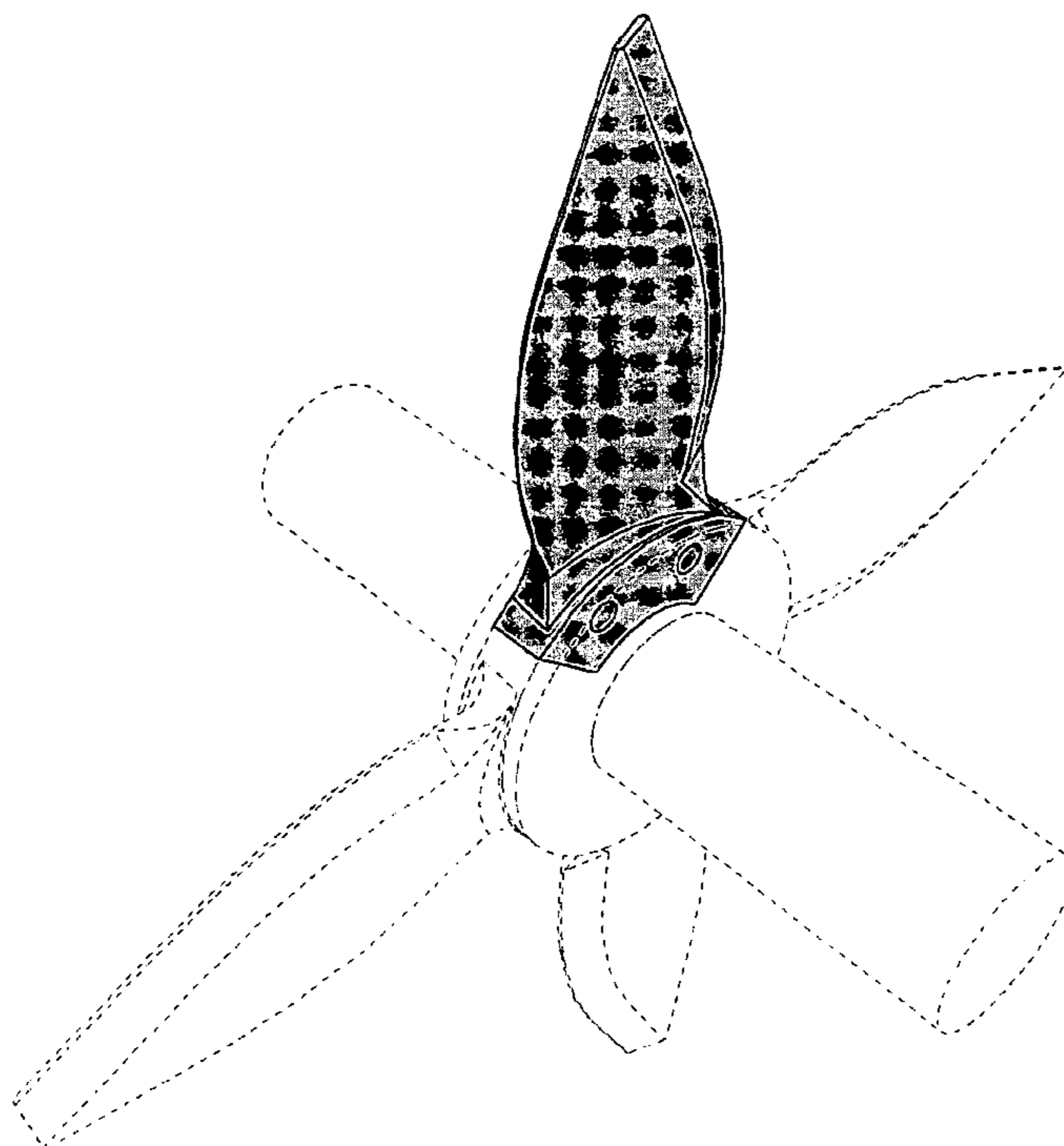
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of the tine of our new design, having no offset;

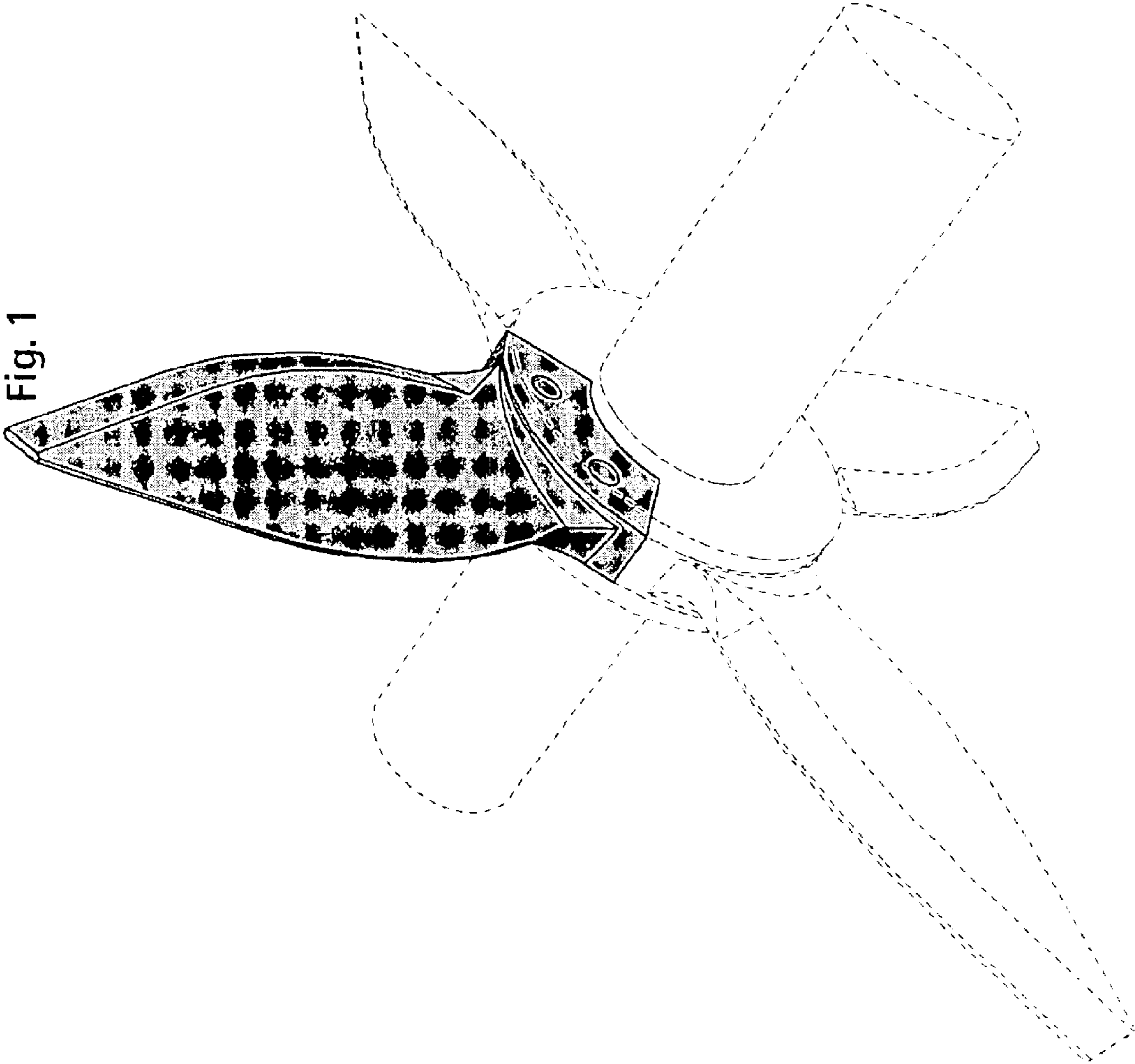

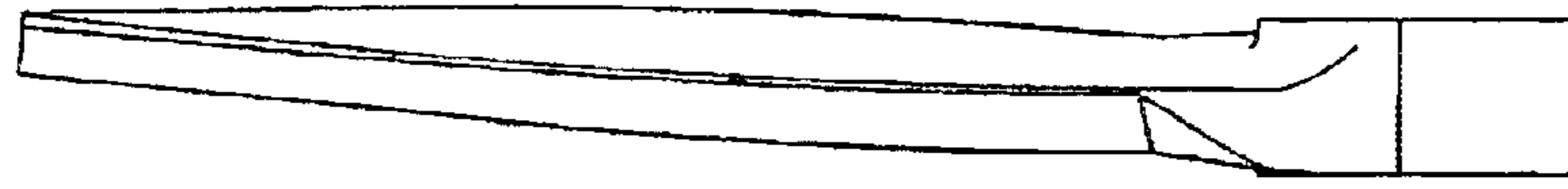

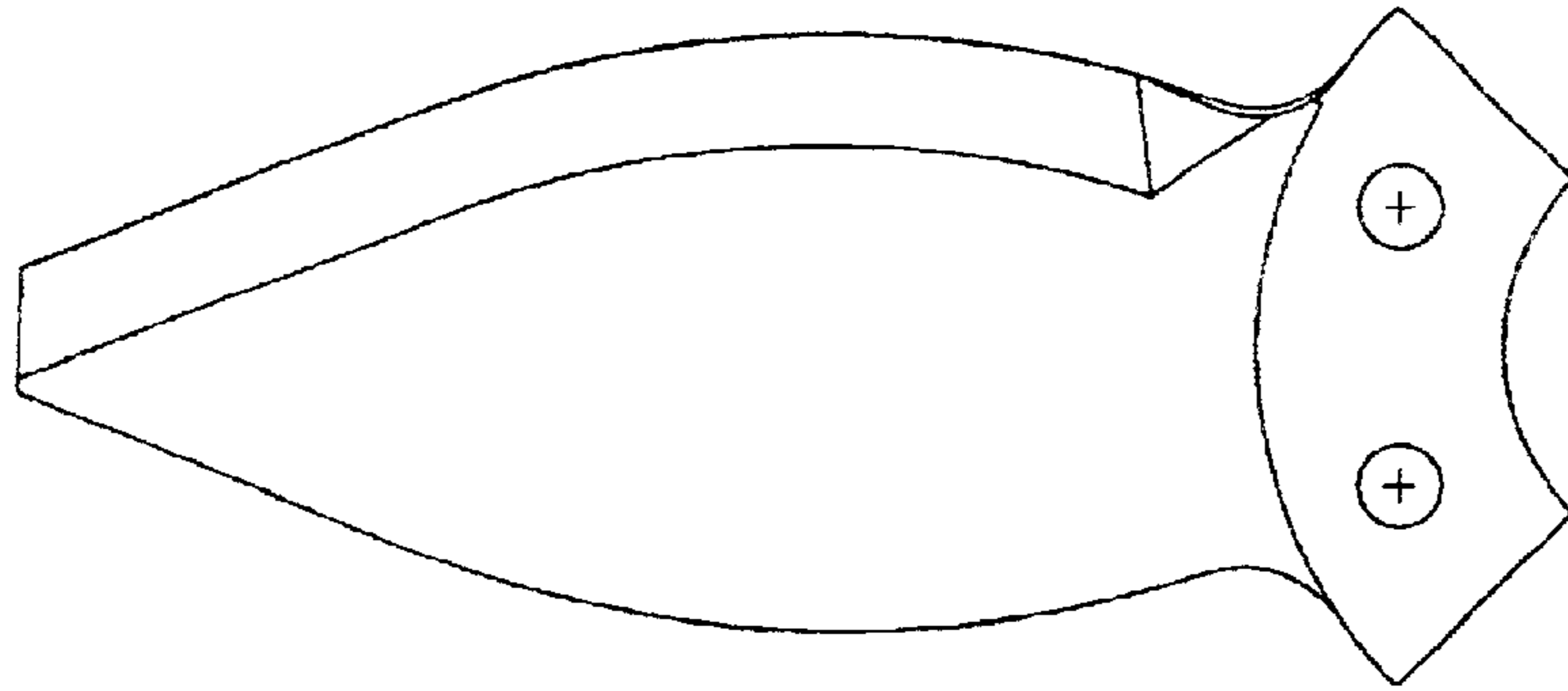

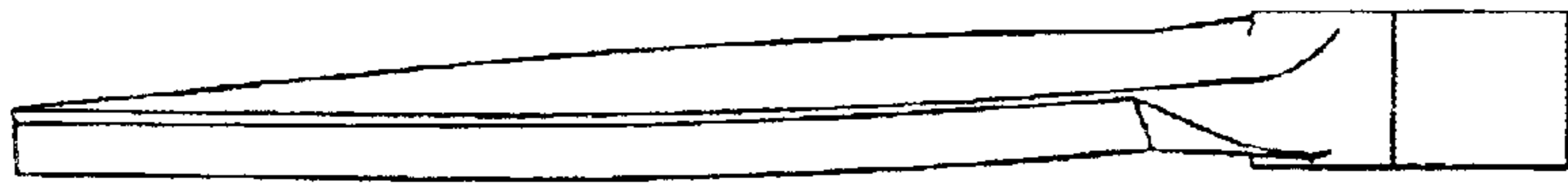

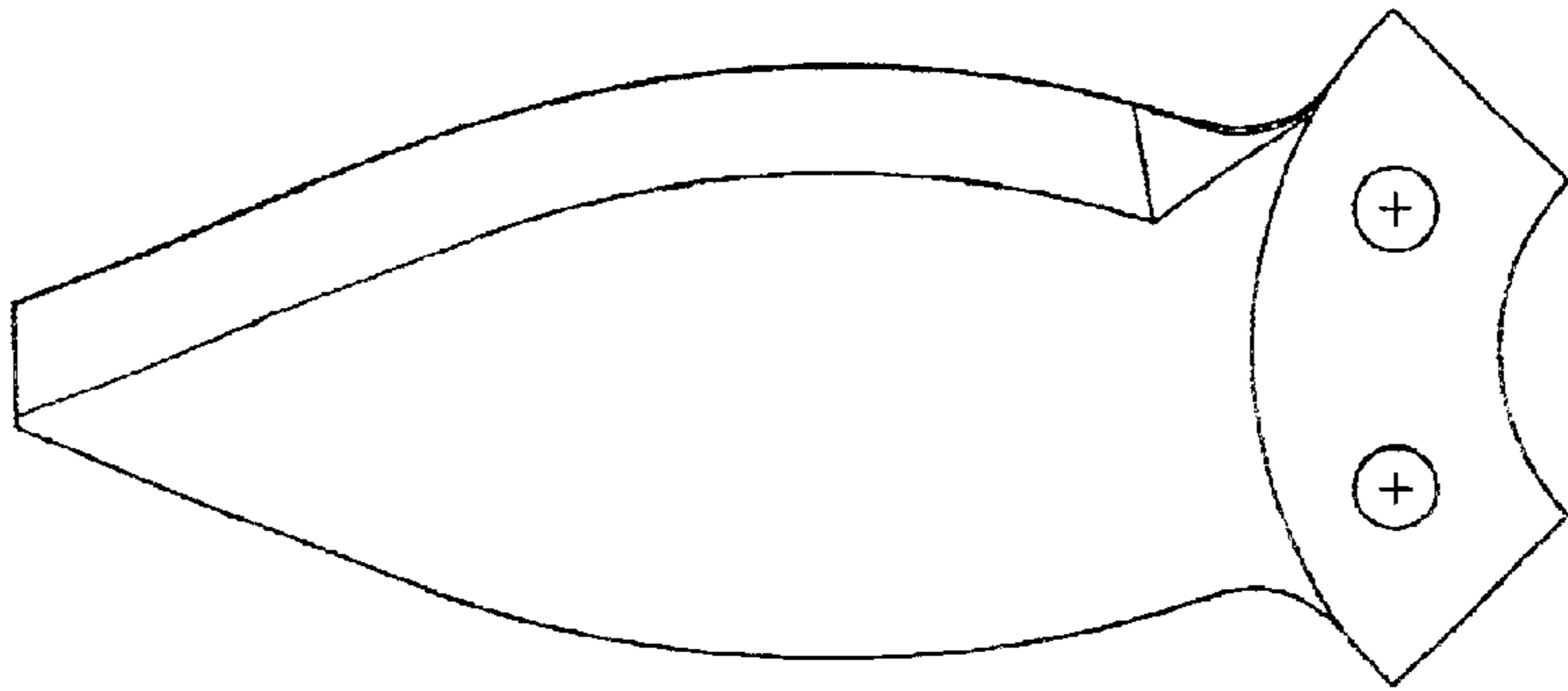
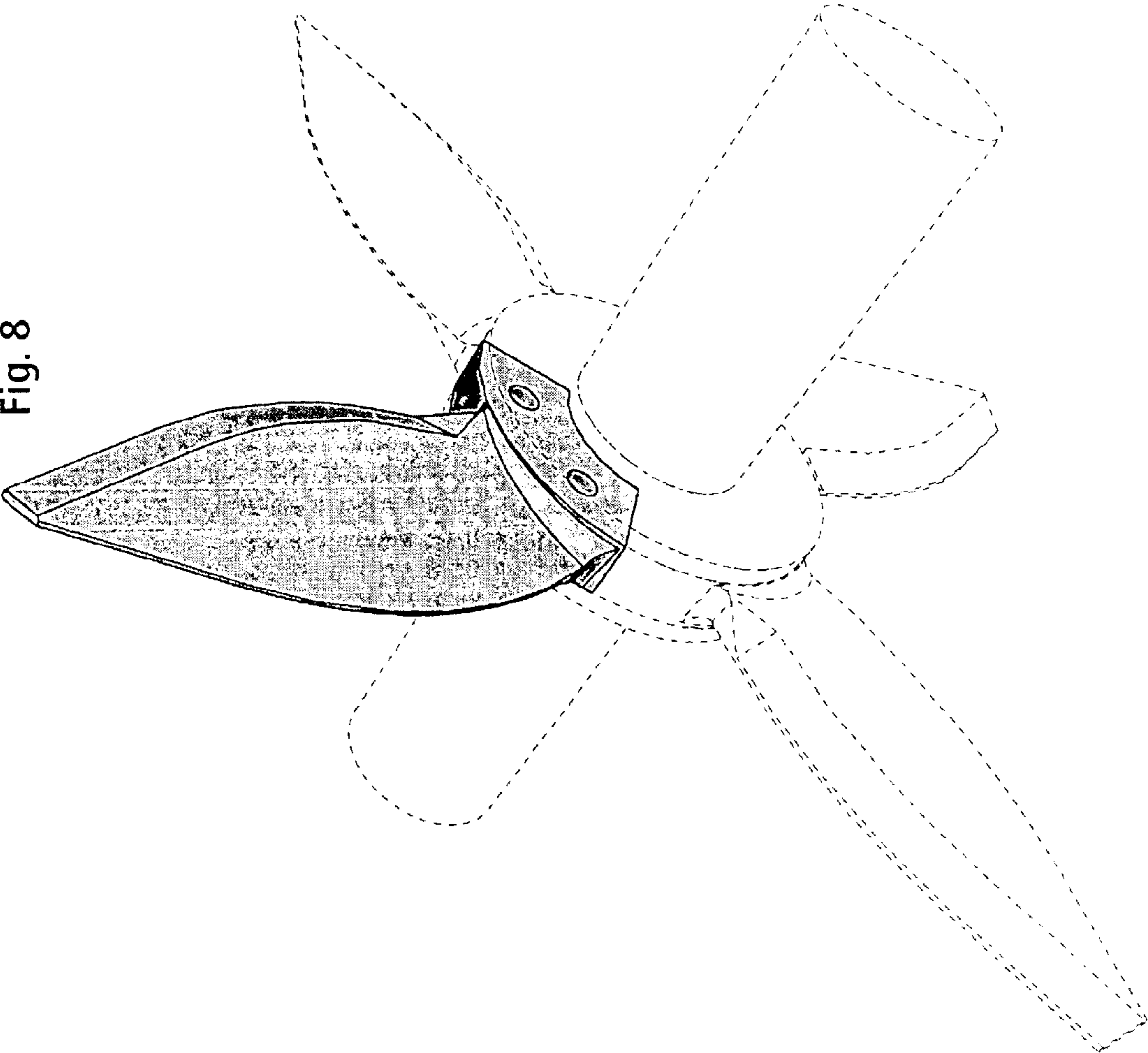

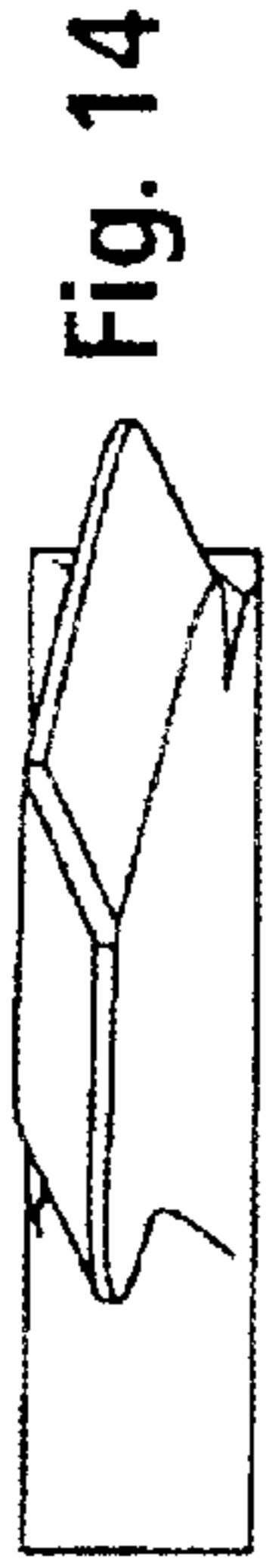

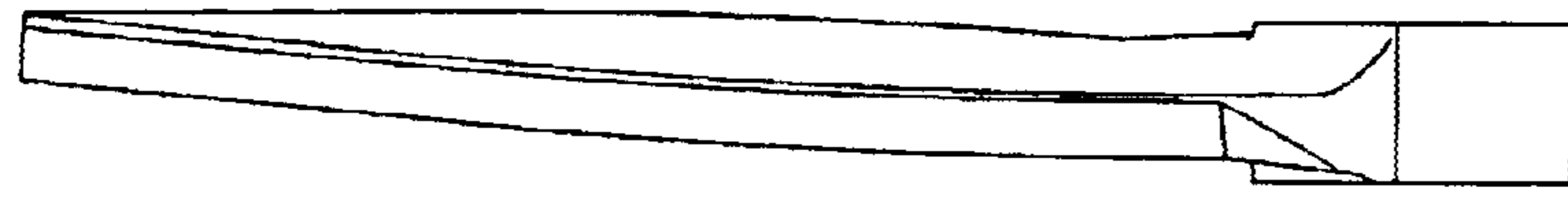

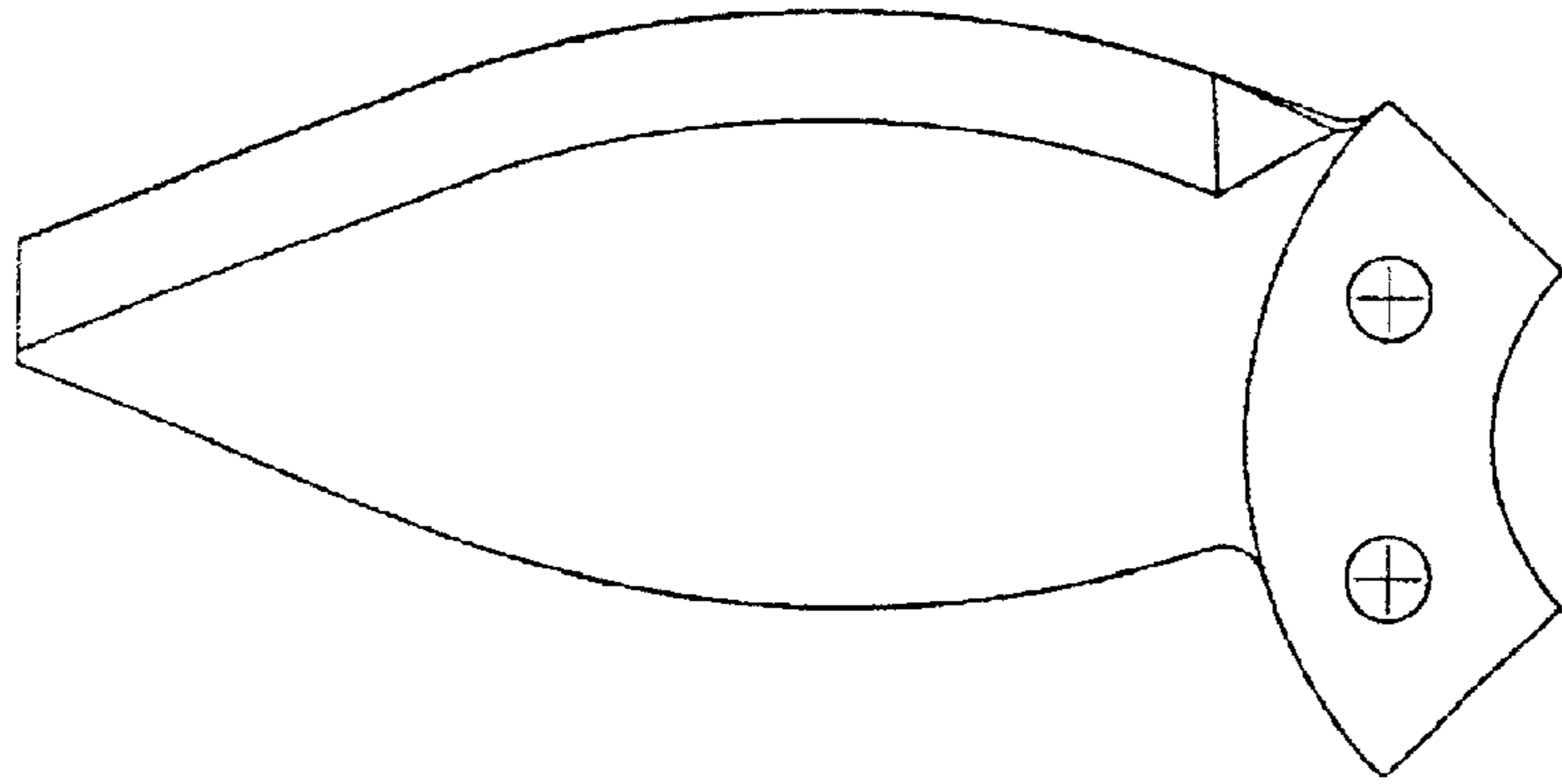

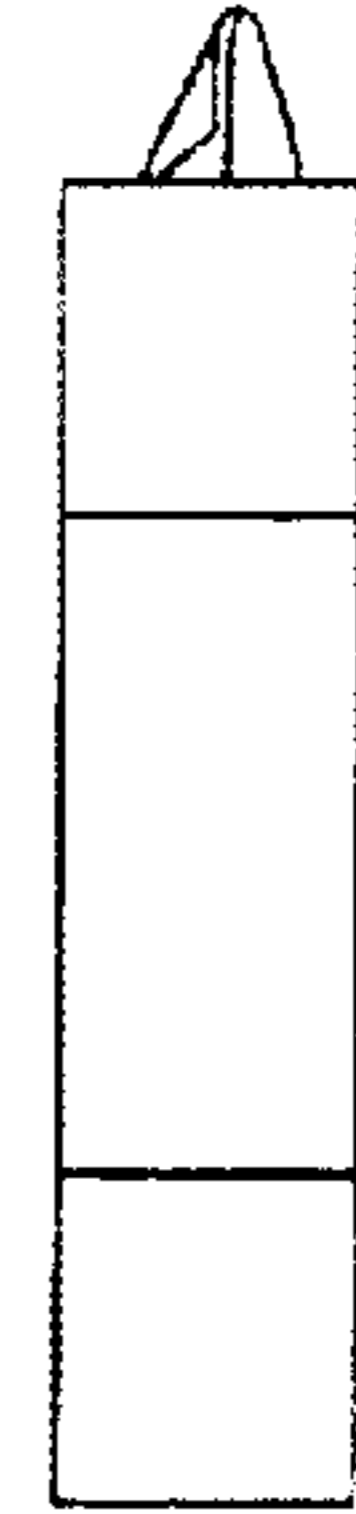

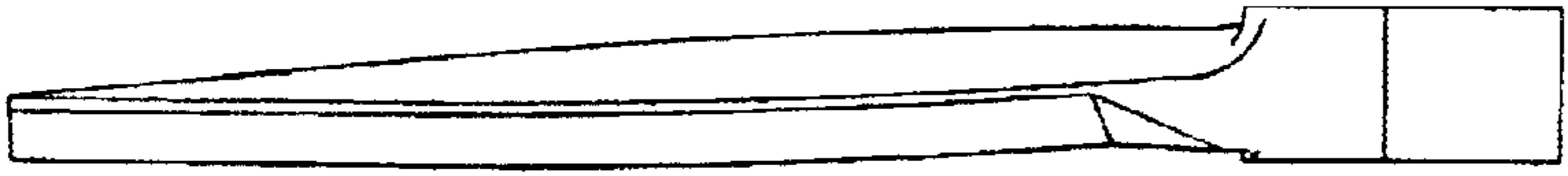

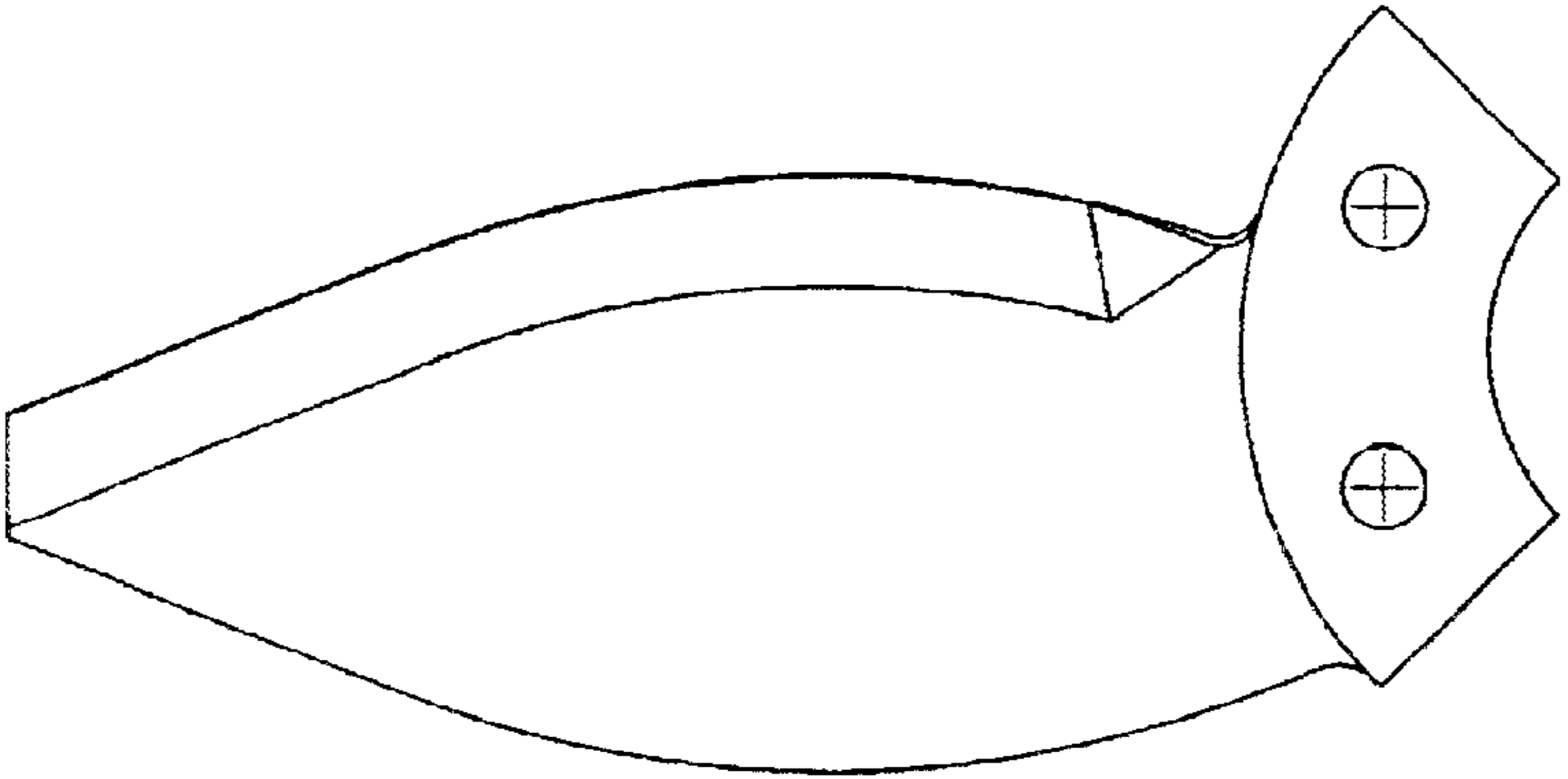
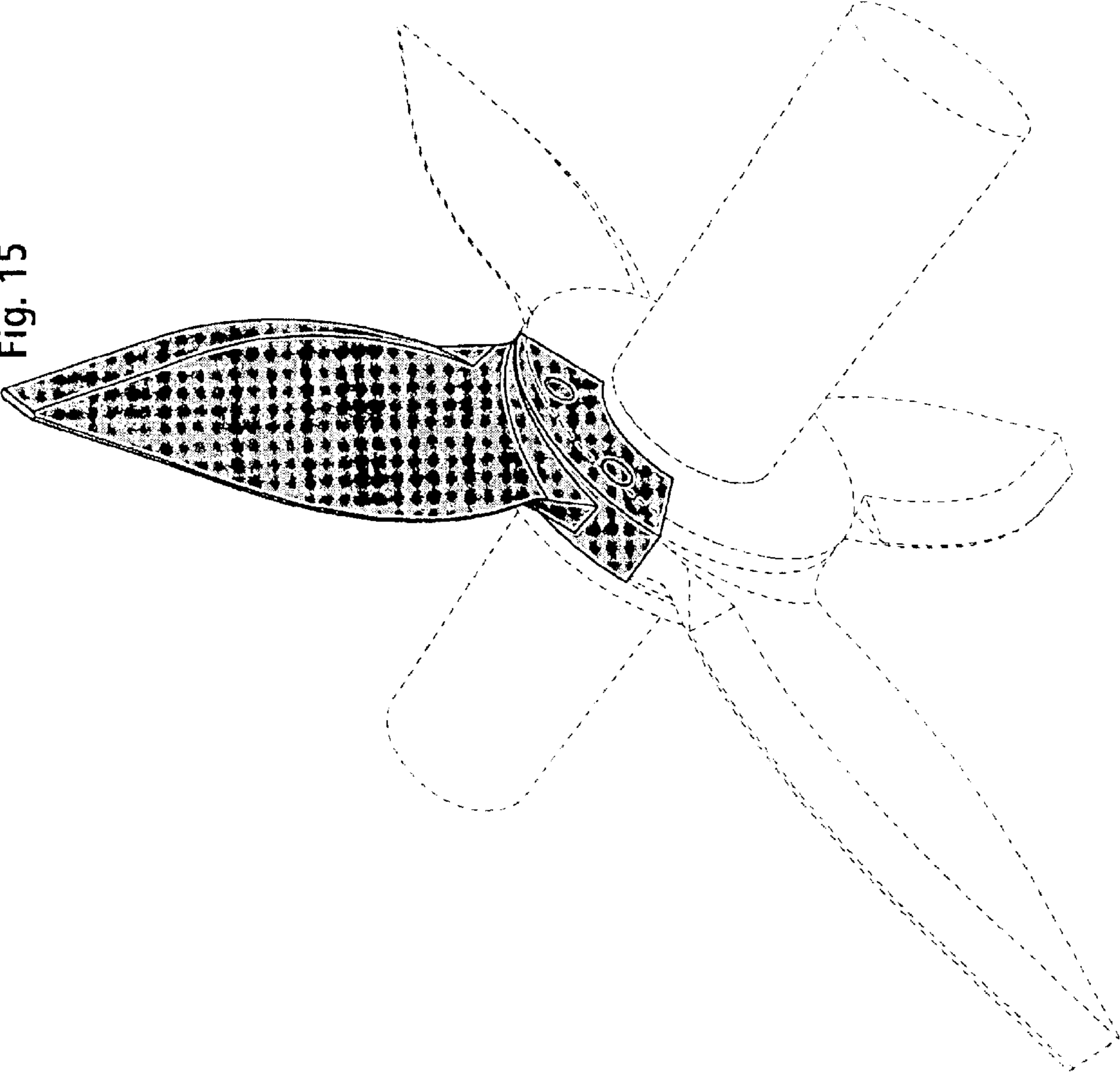

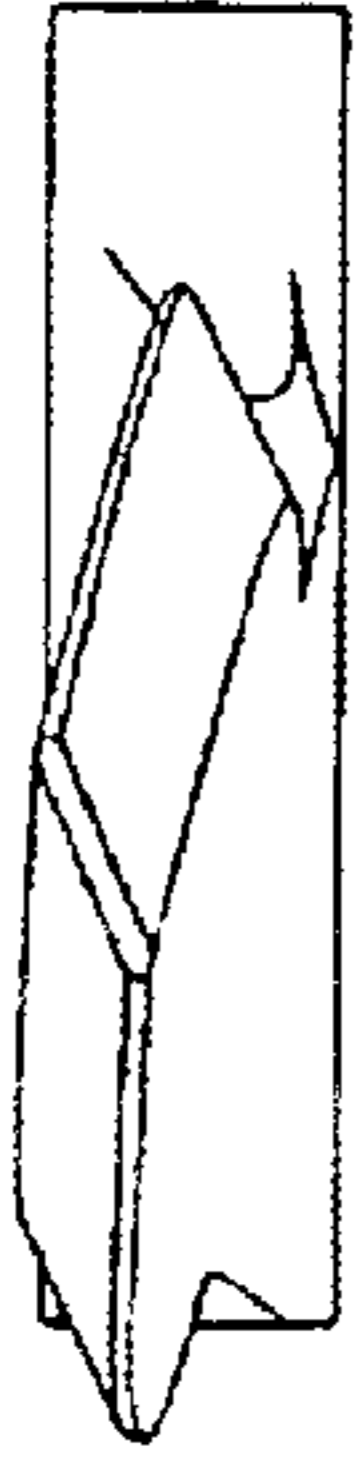

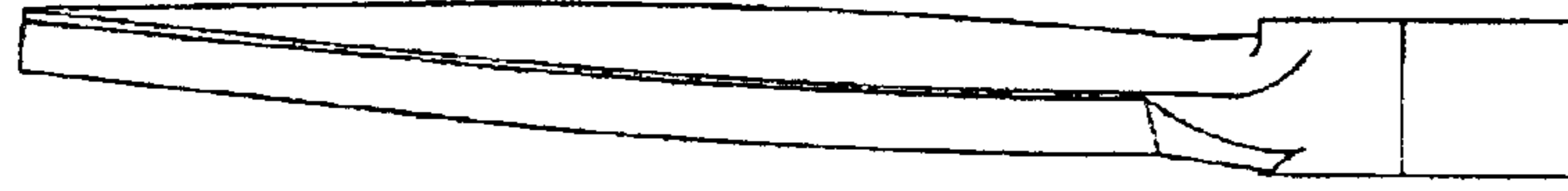

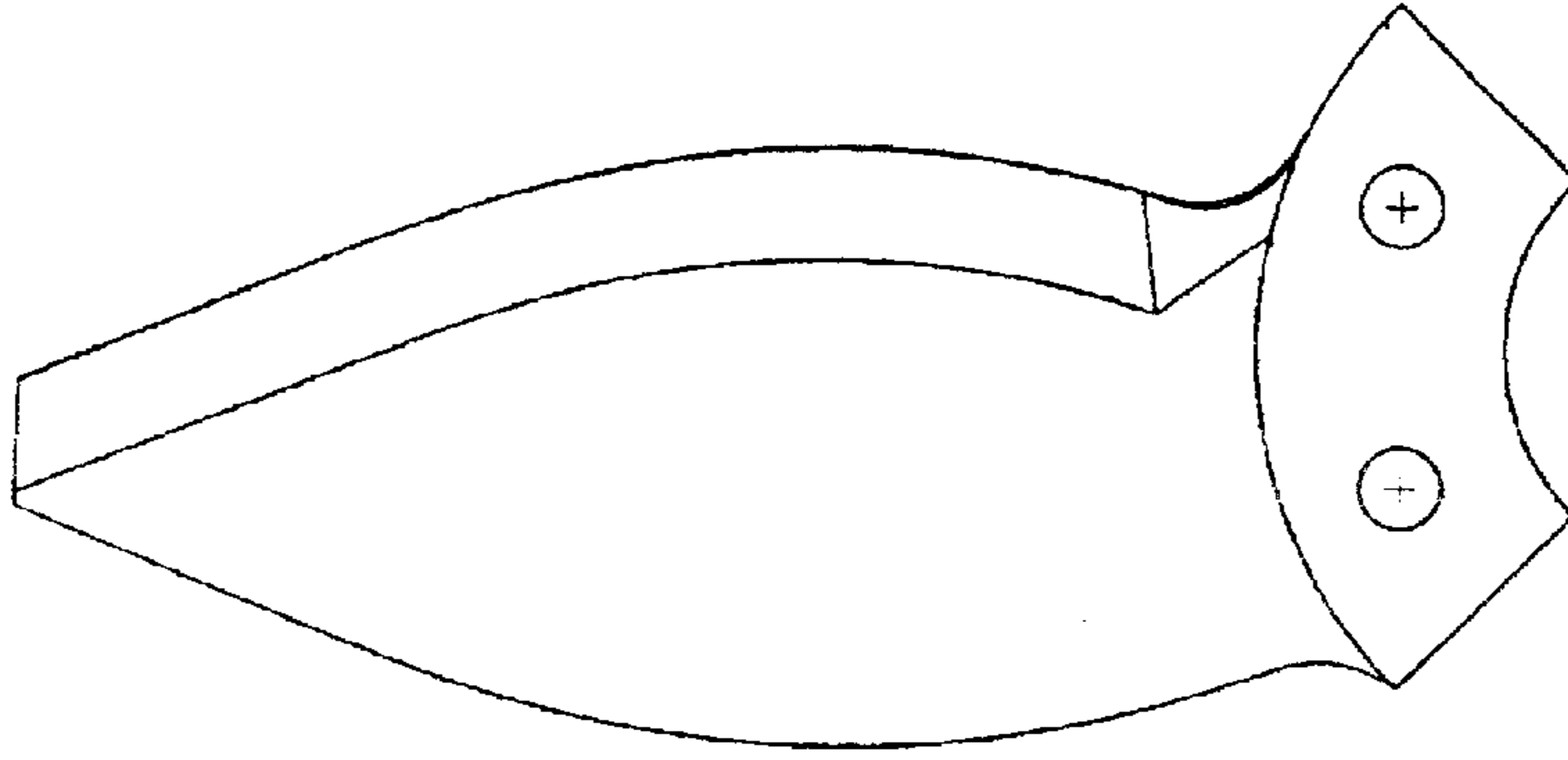

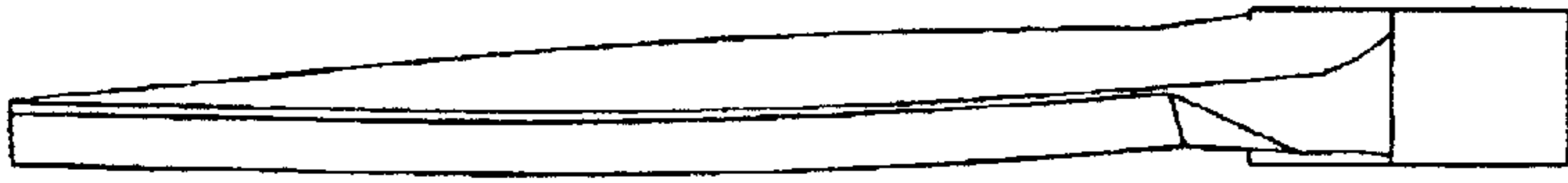

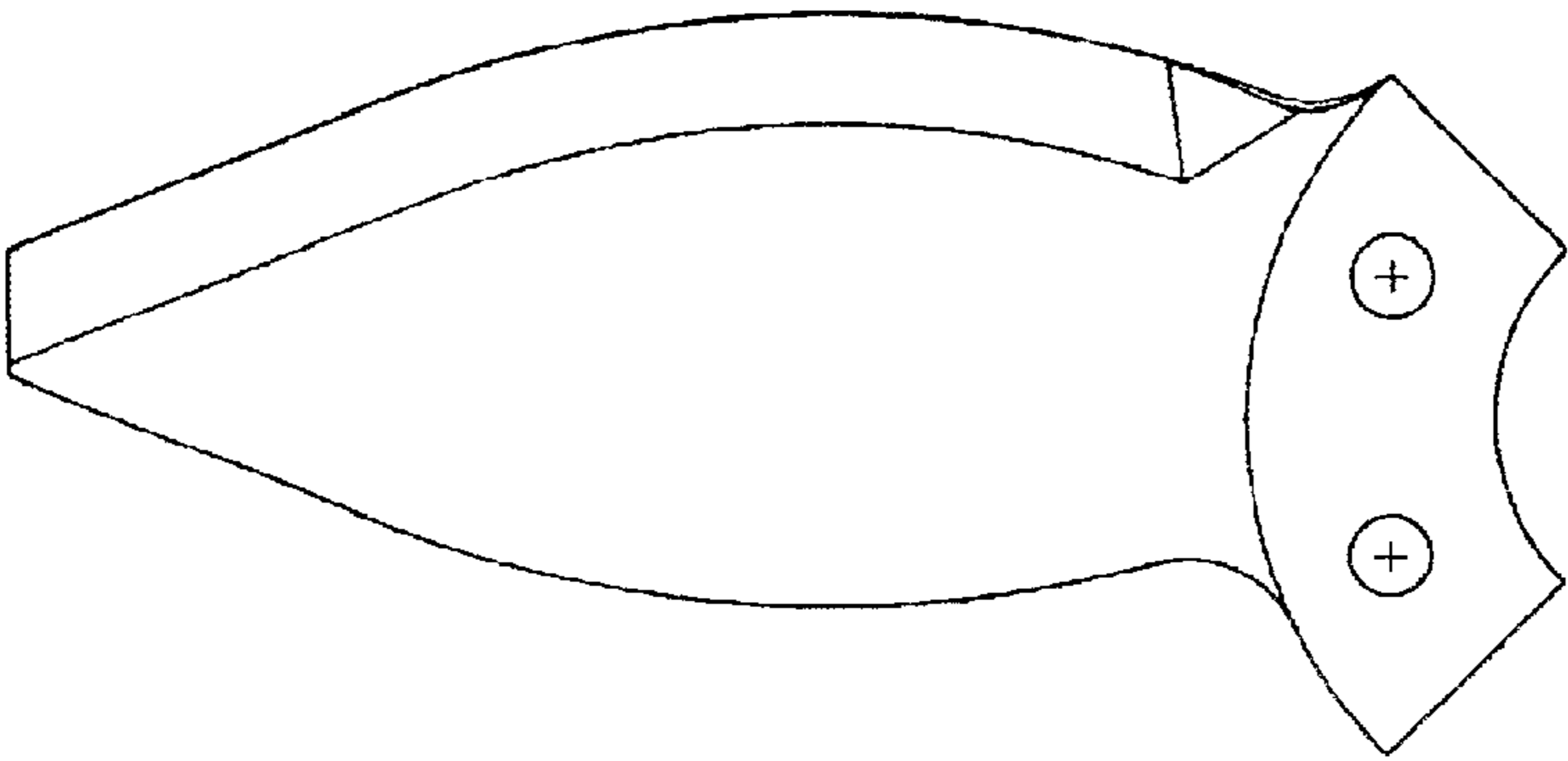

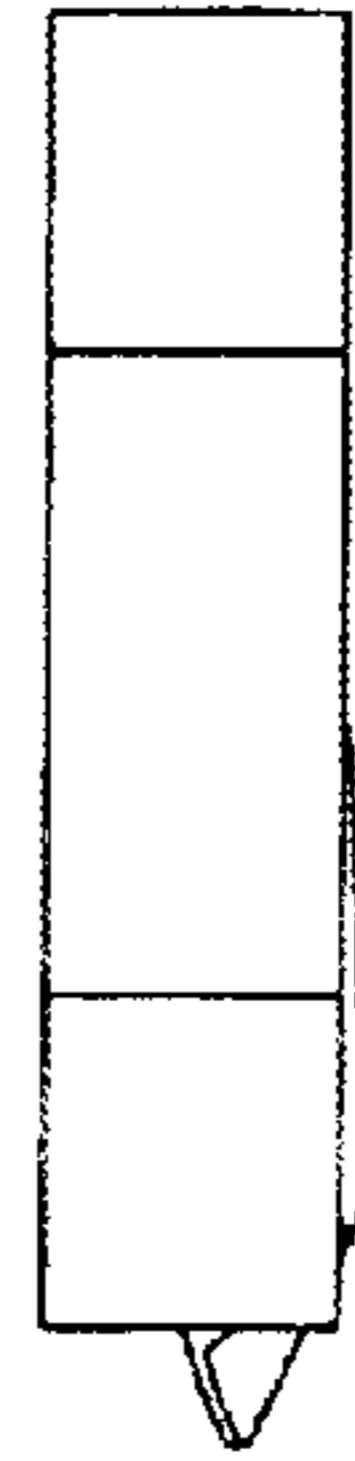
