(57) **CLAIM**

The ornamental design for a gaming device having a display with multiple indicators, as shown and described herein.

**DESCRIPTION**

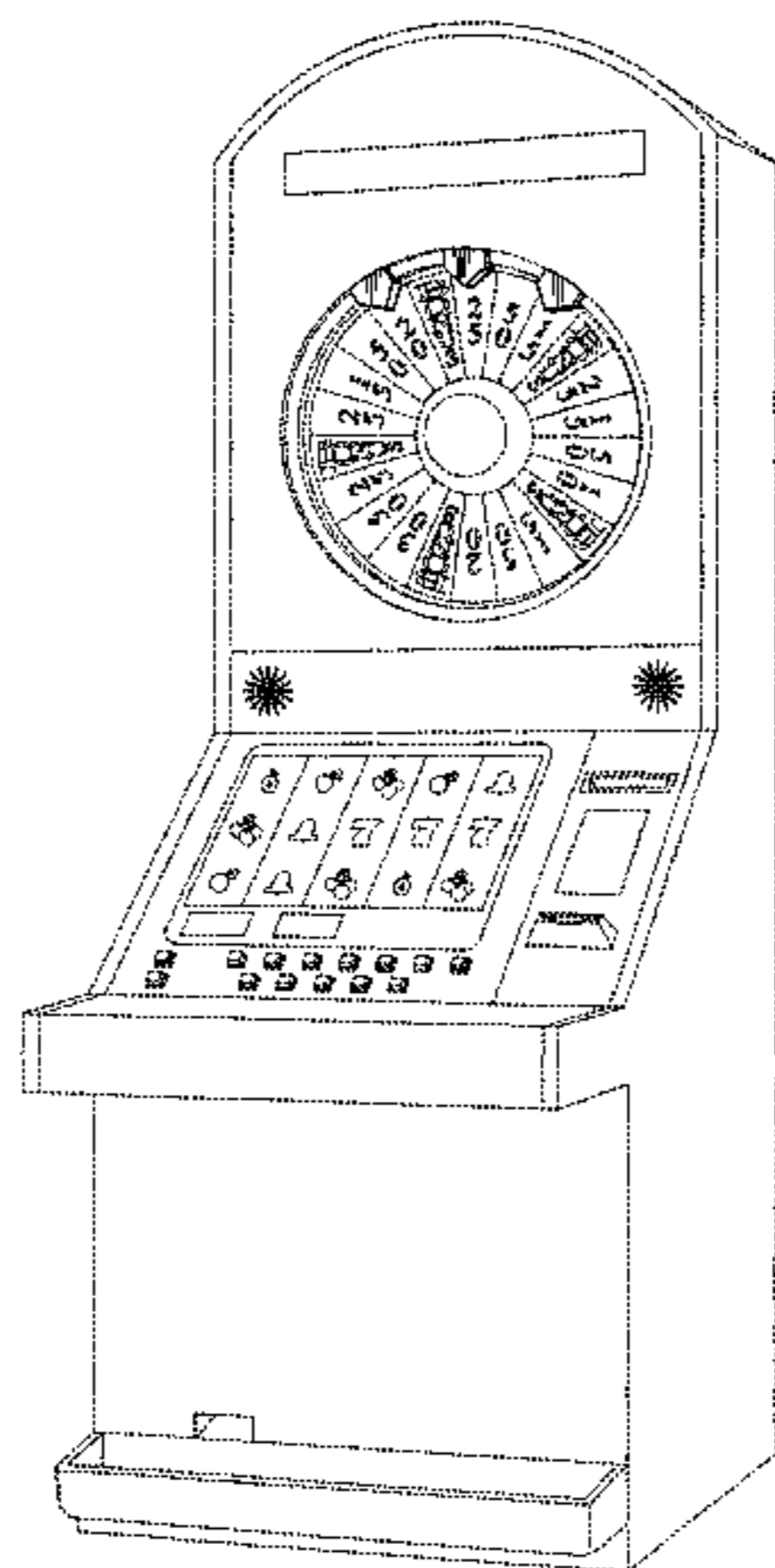

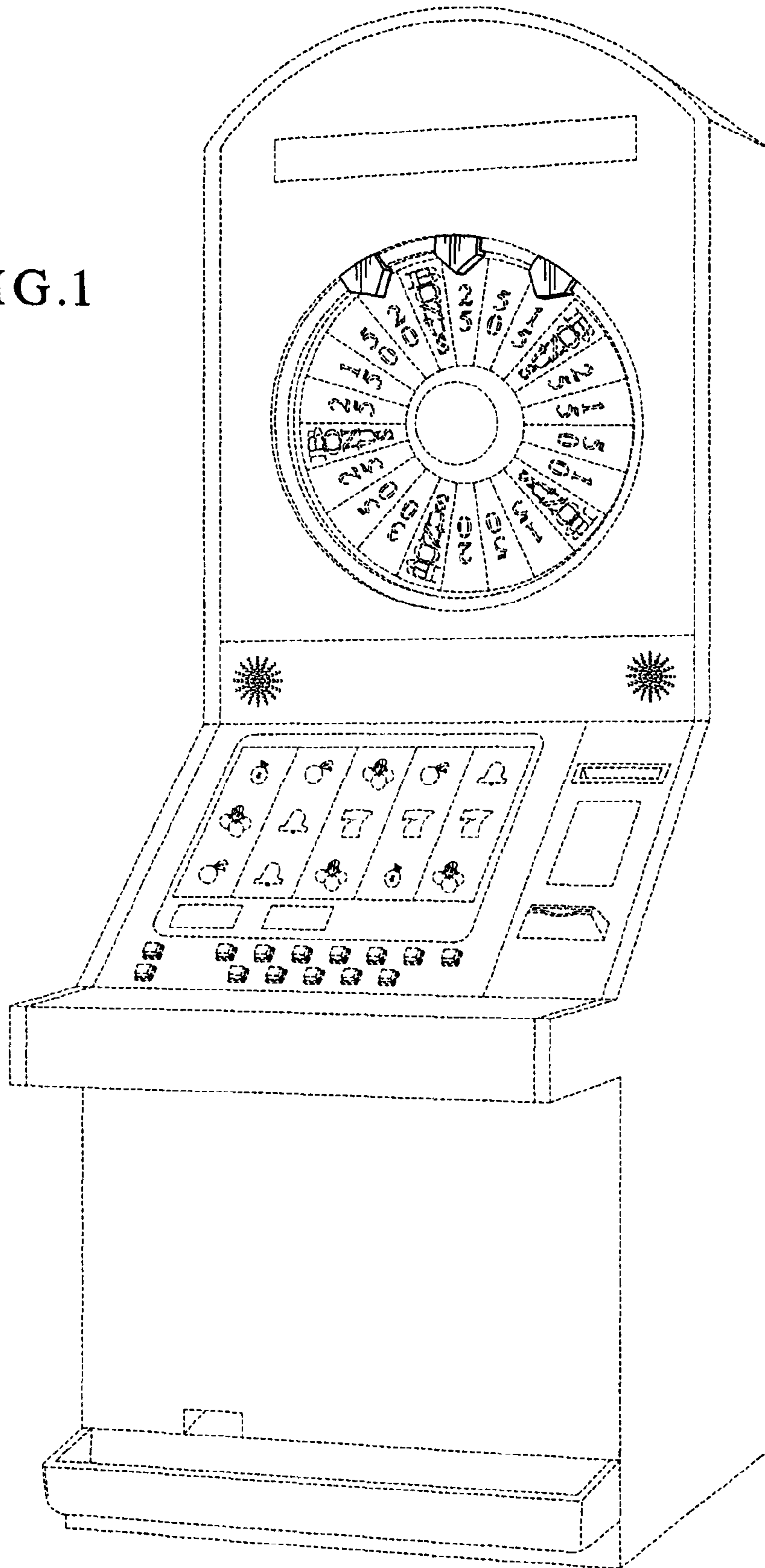

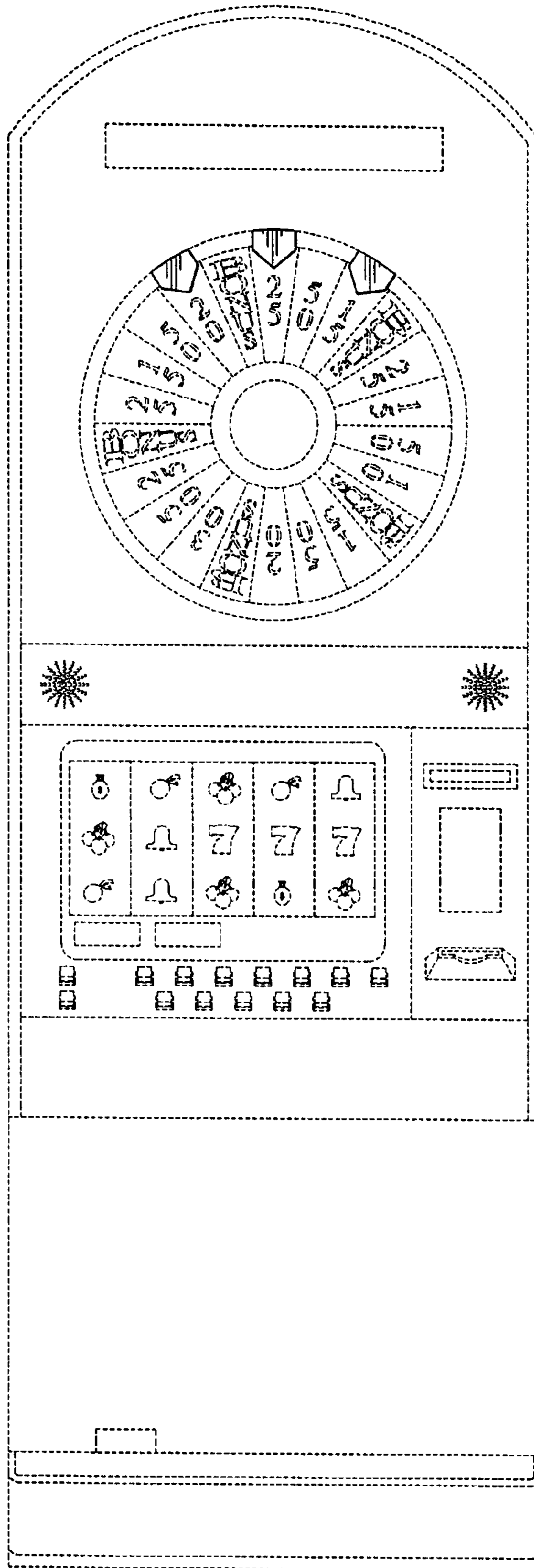

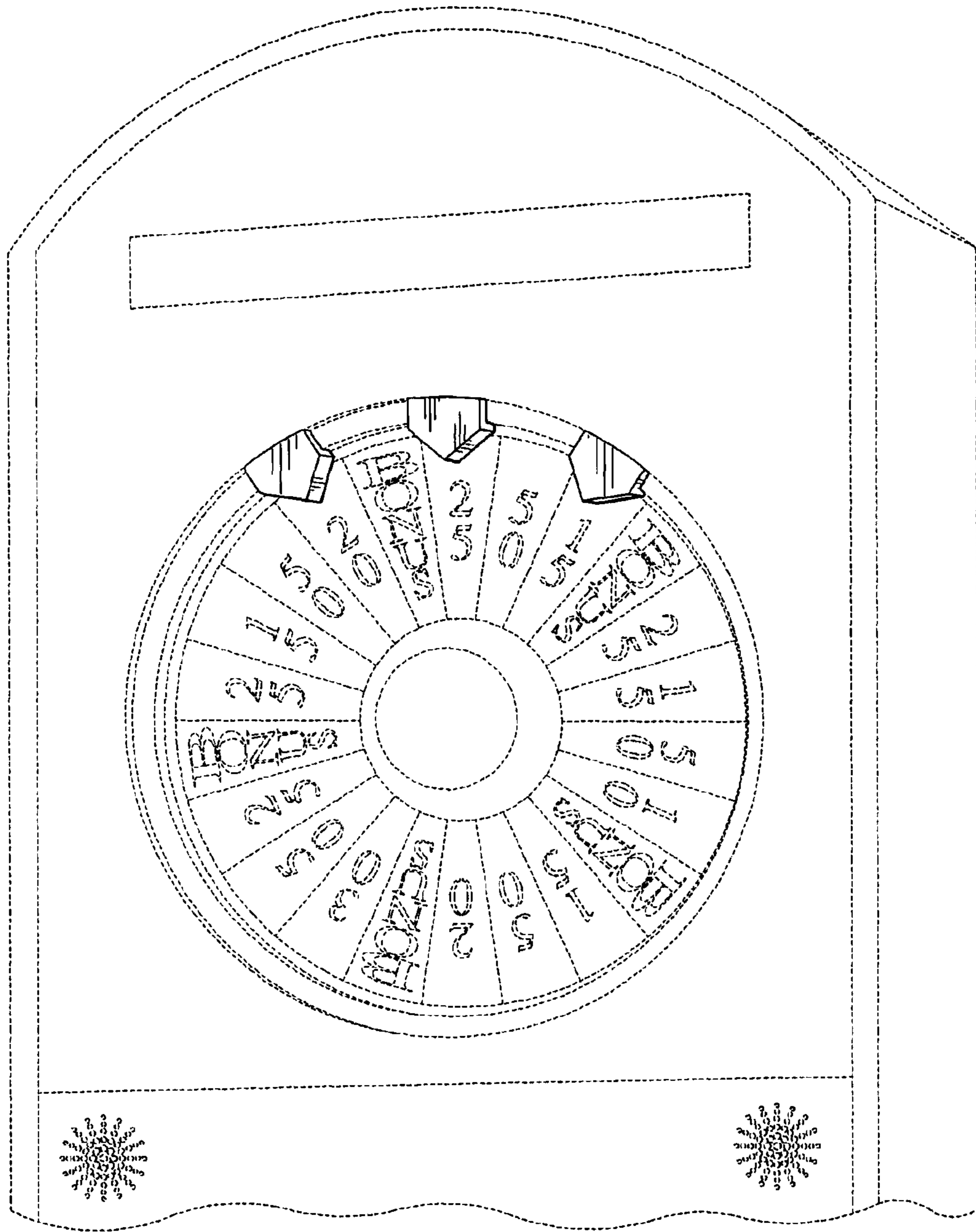

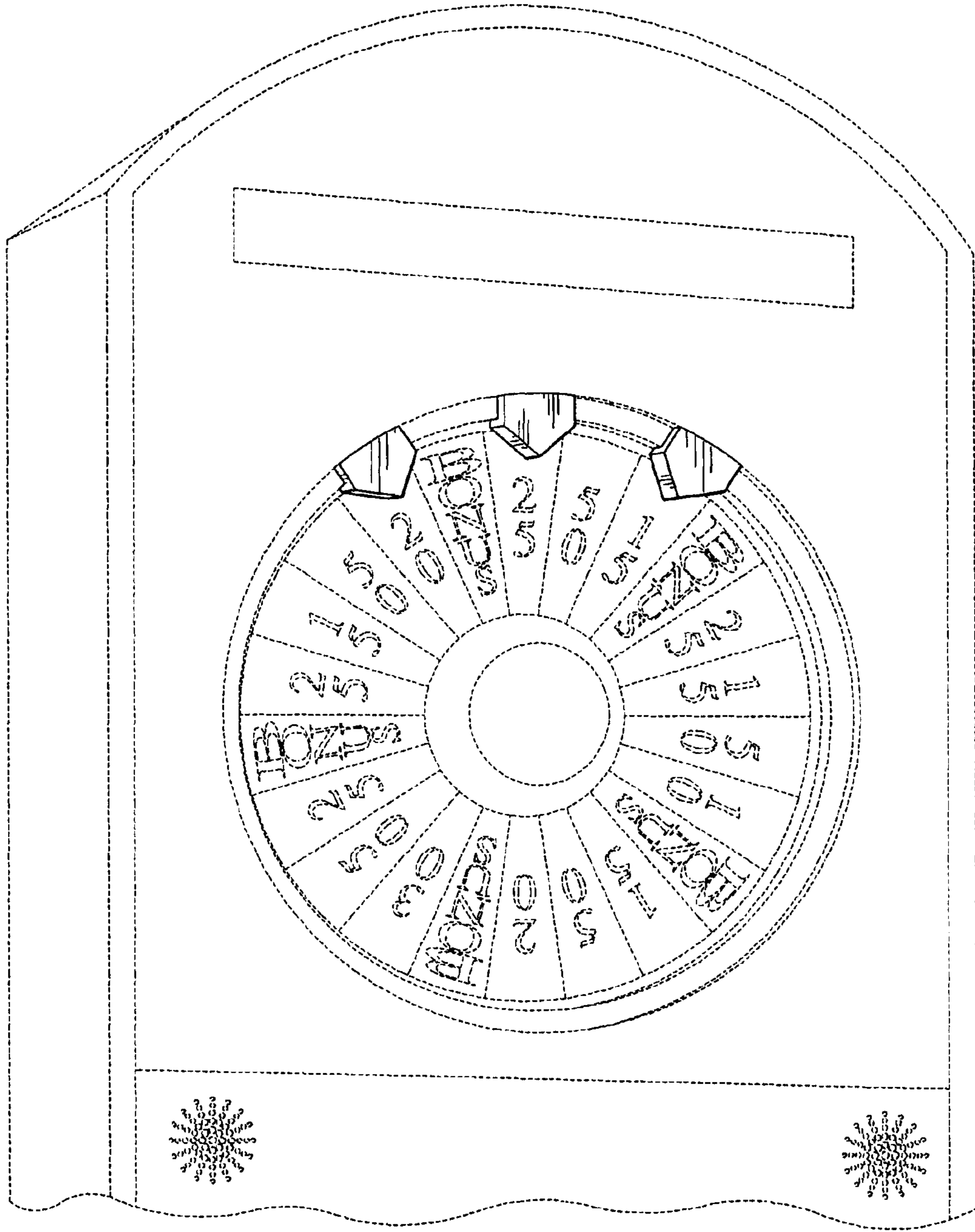

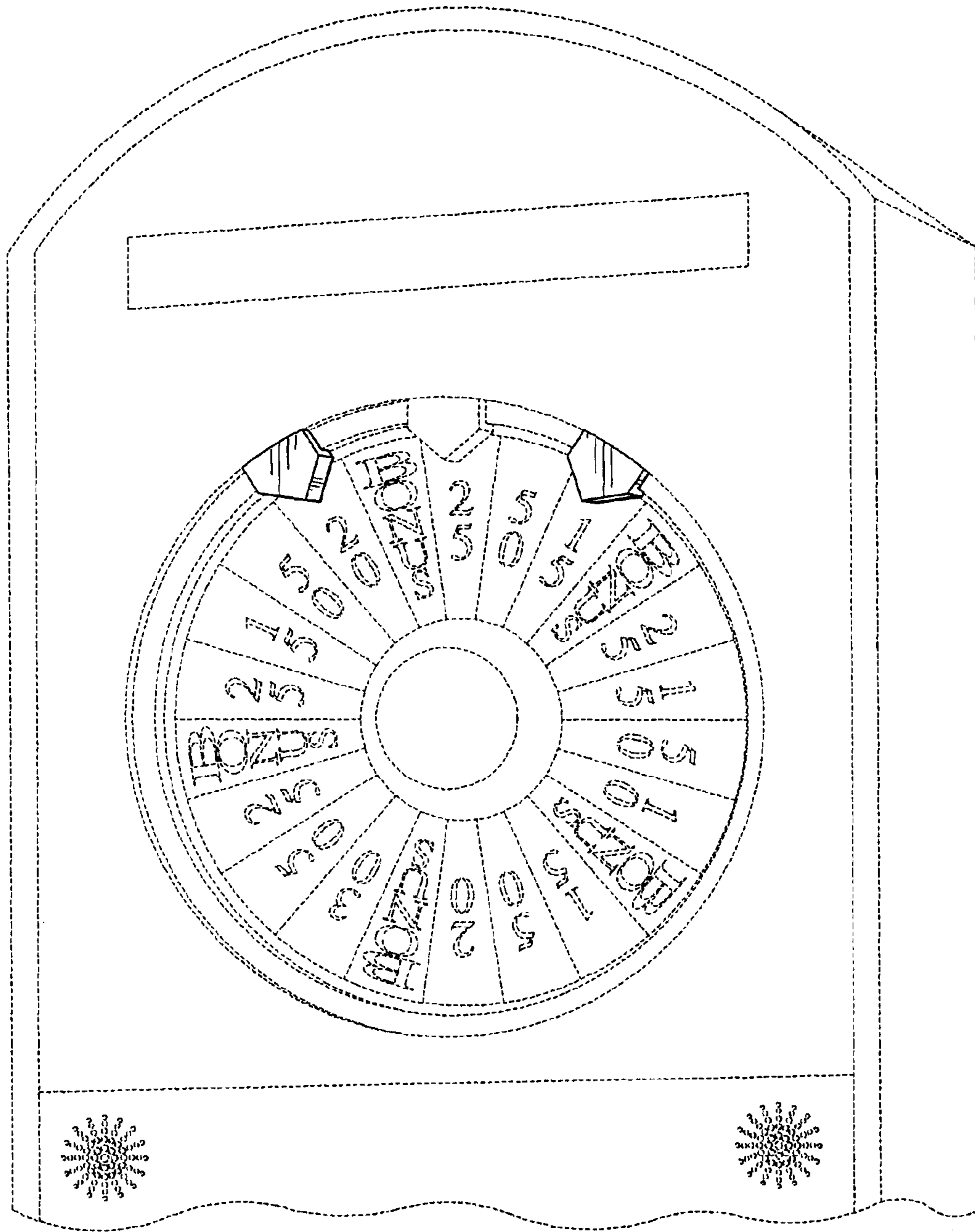

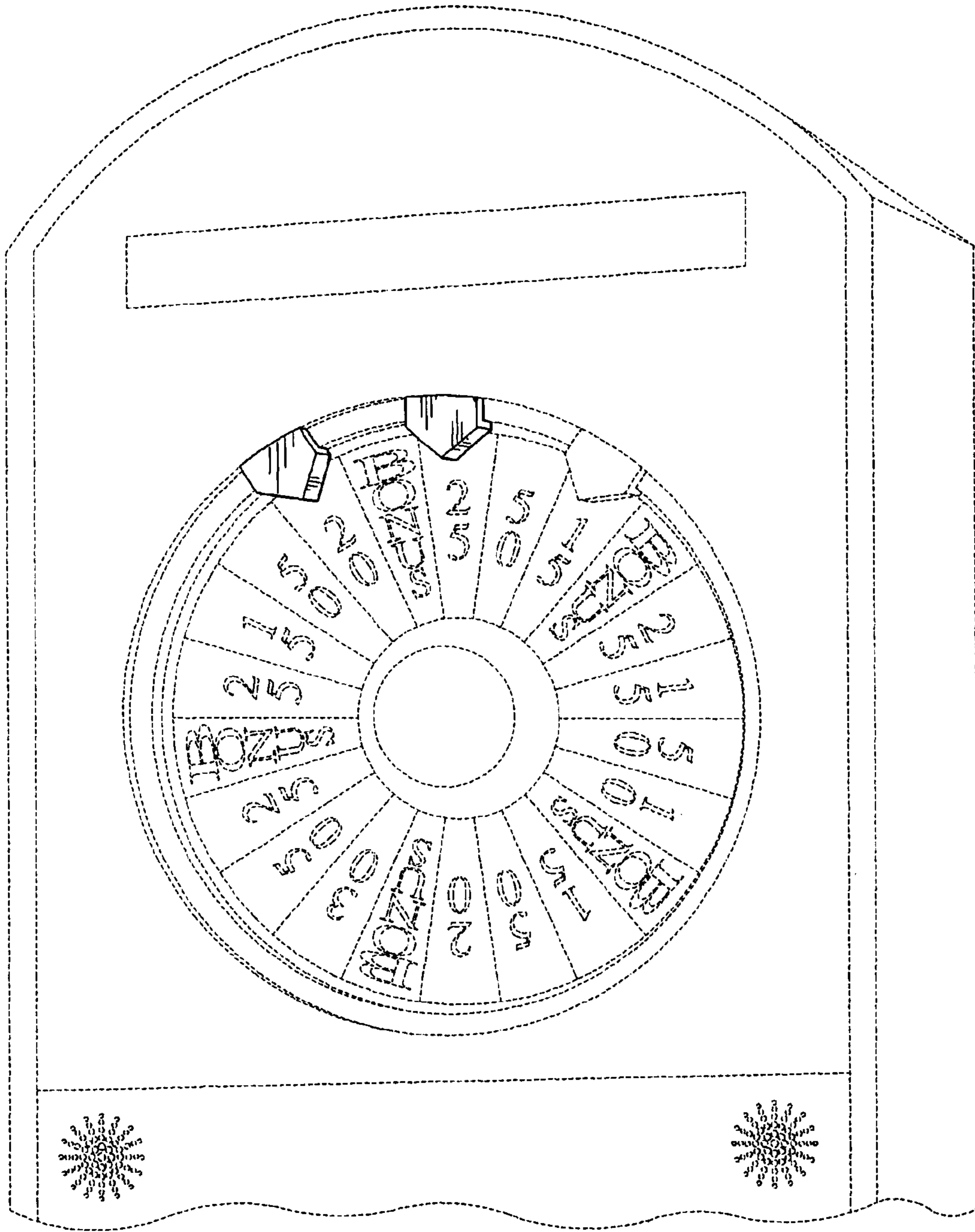

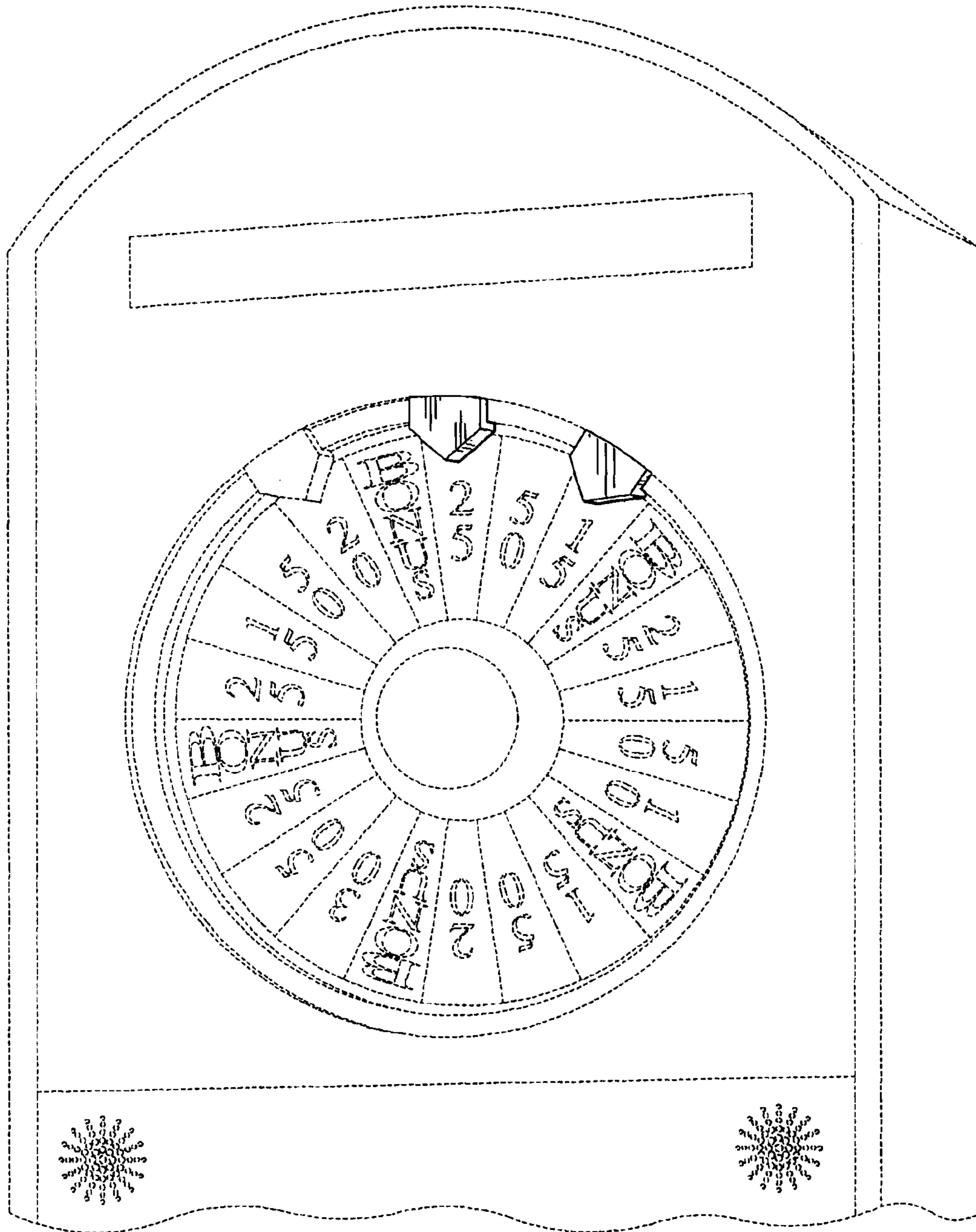

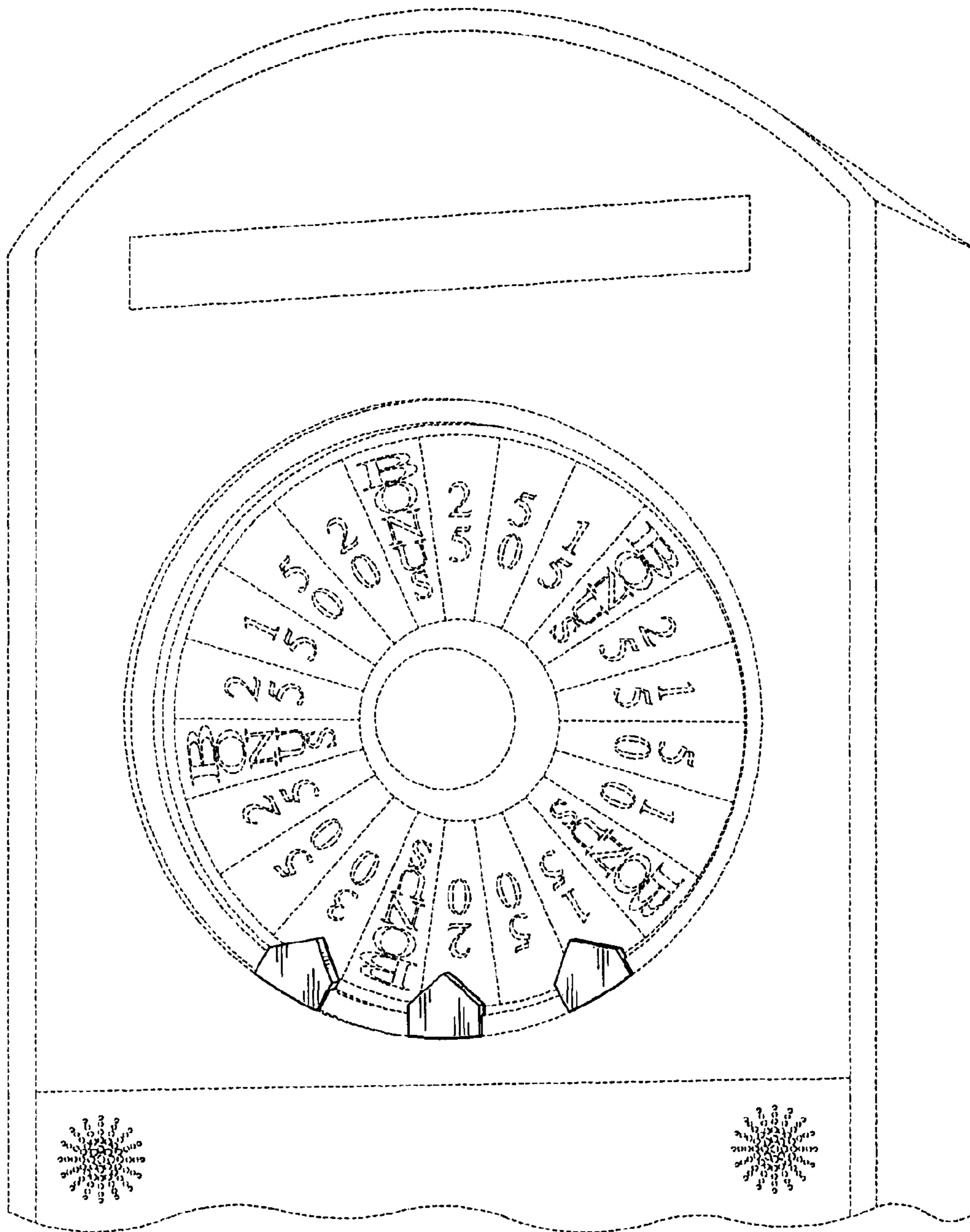

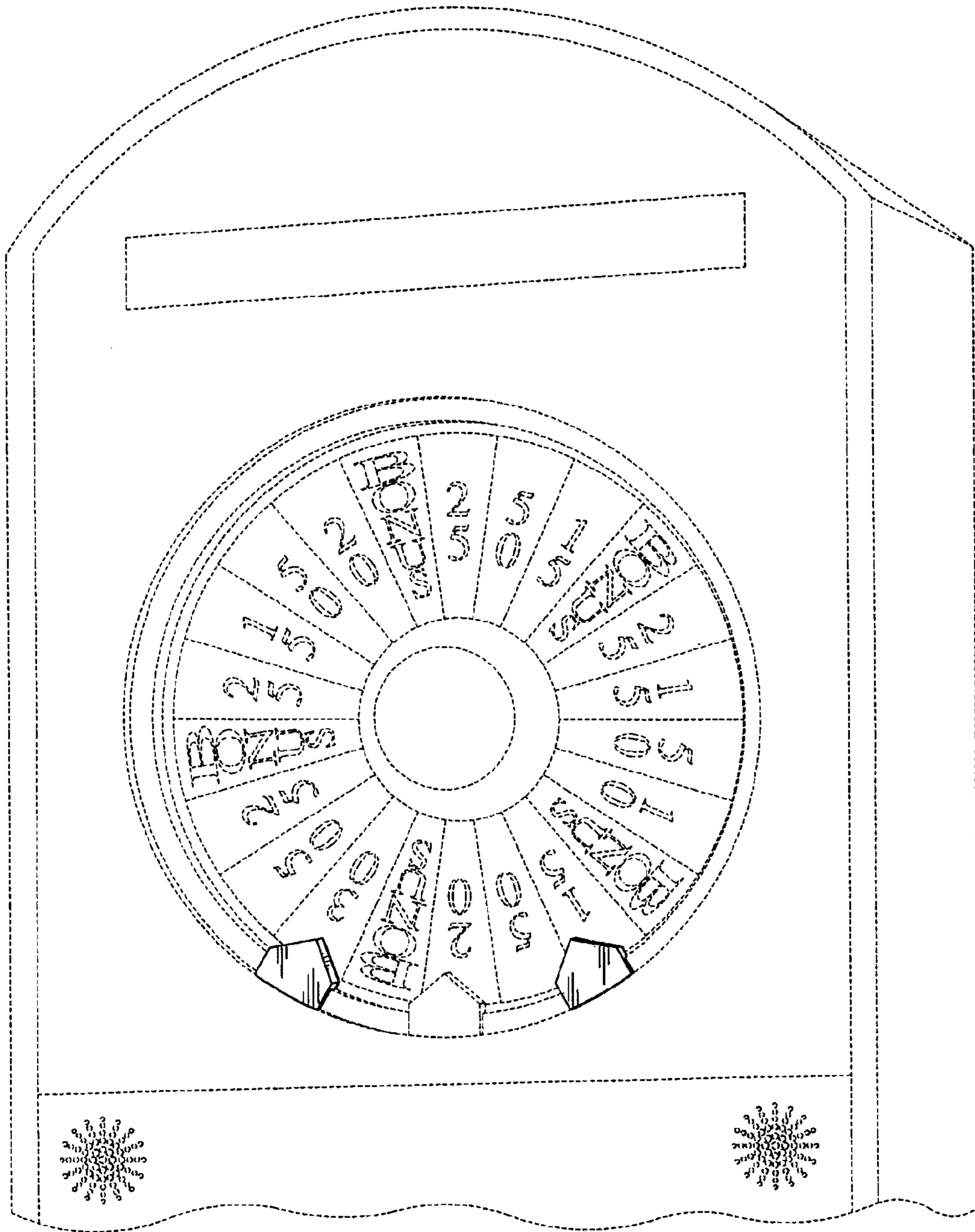

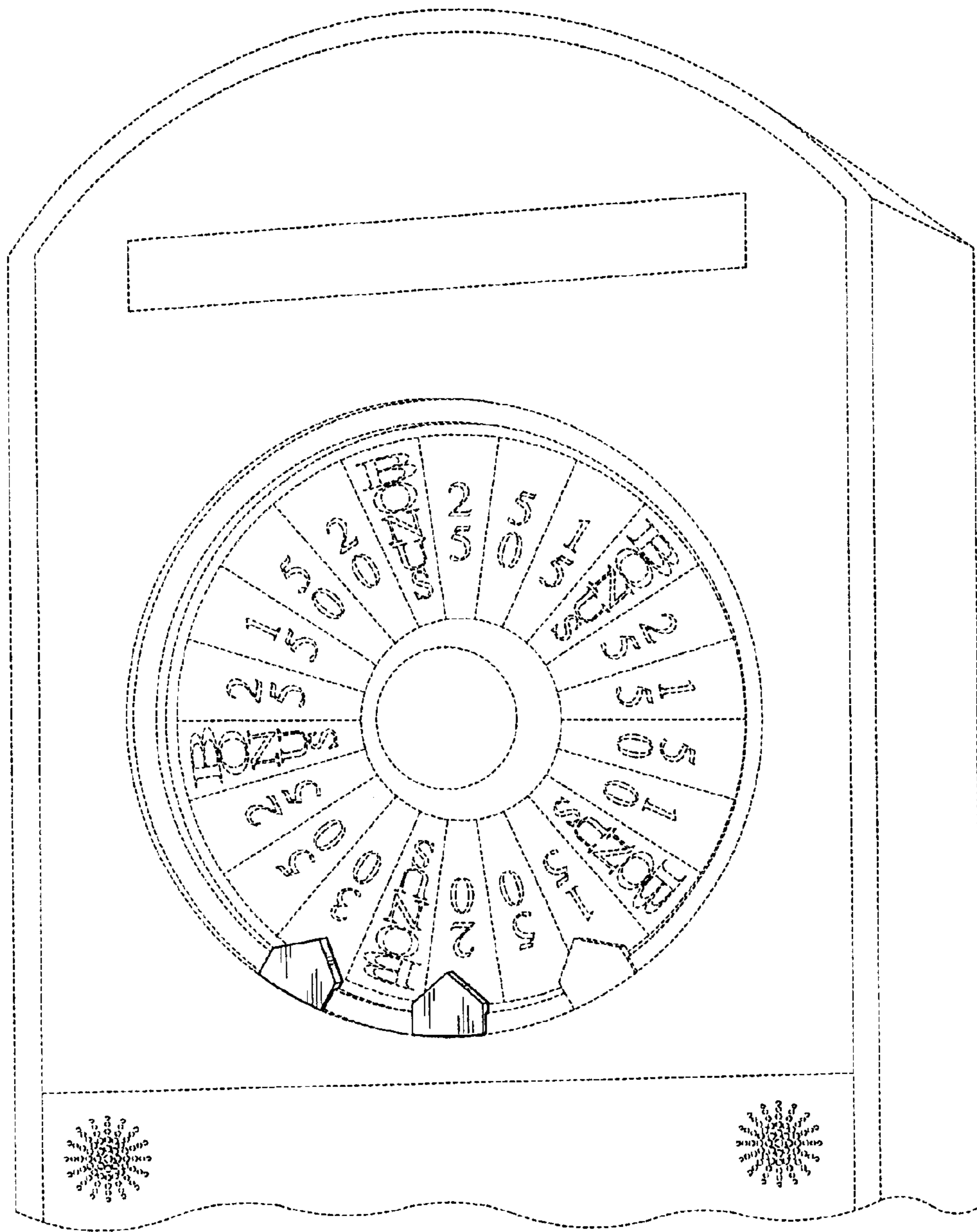

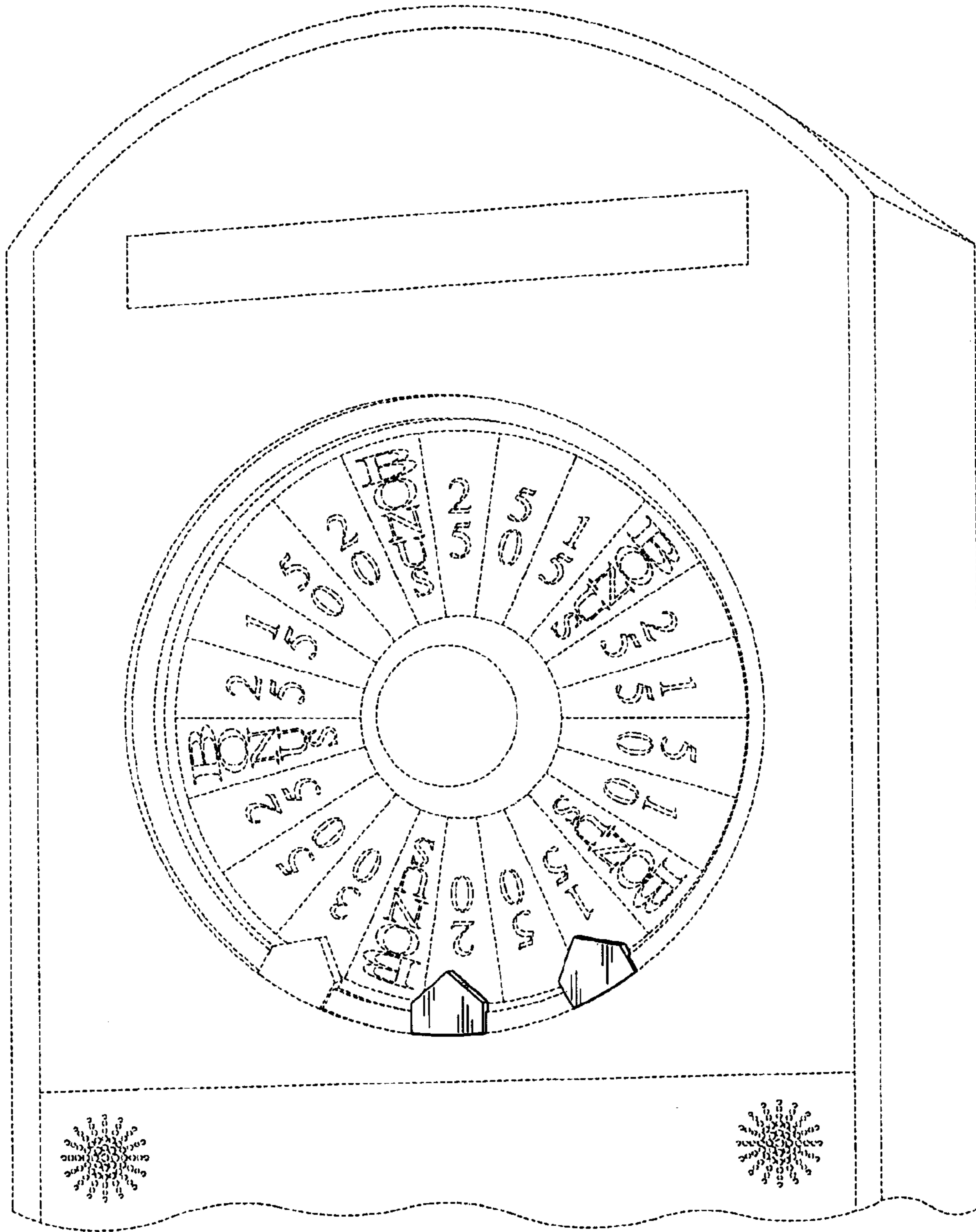

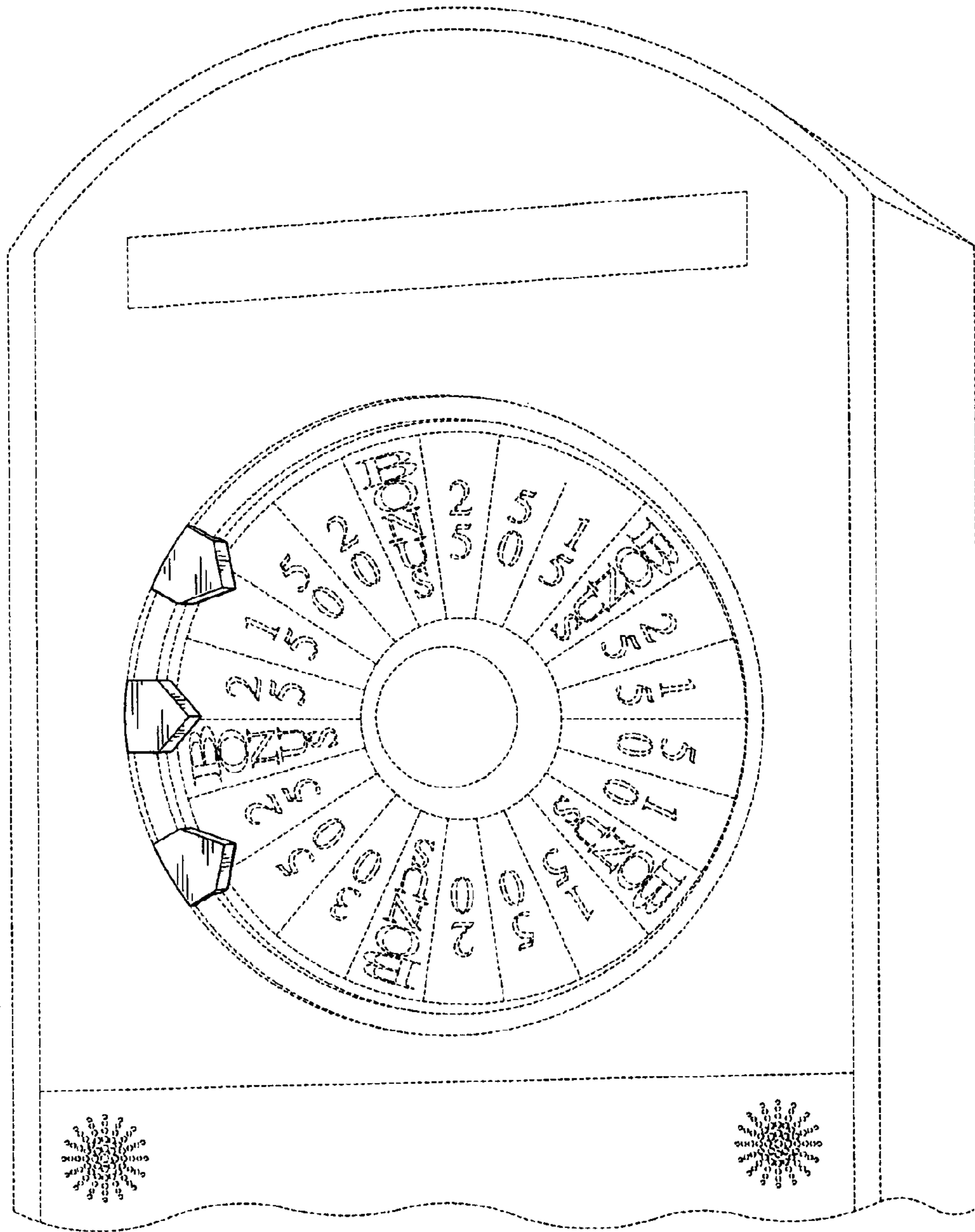

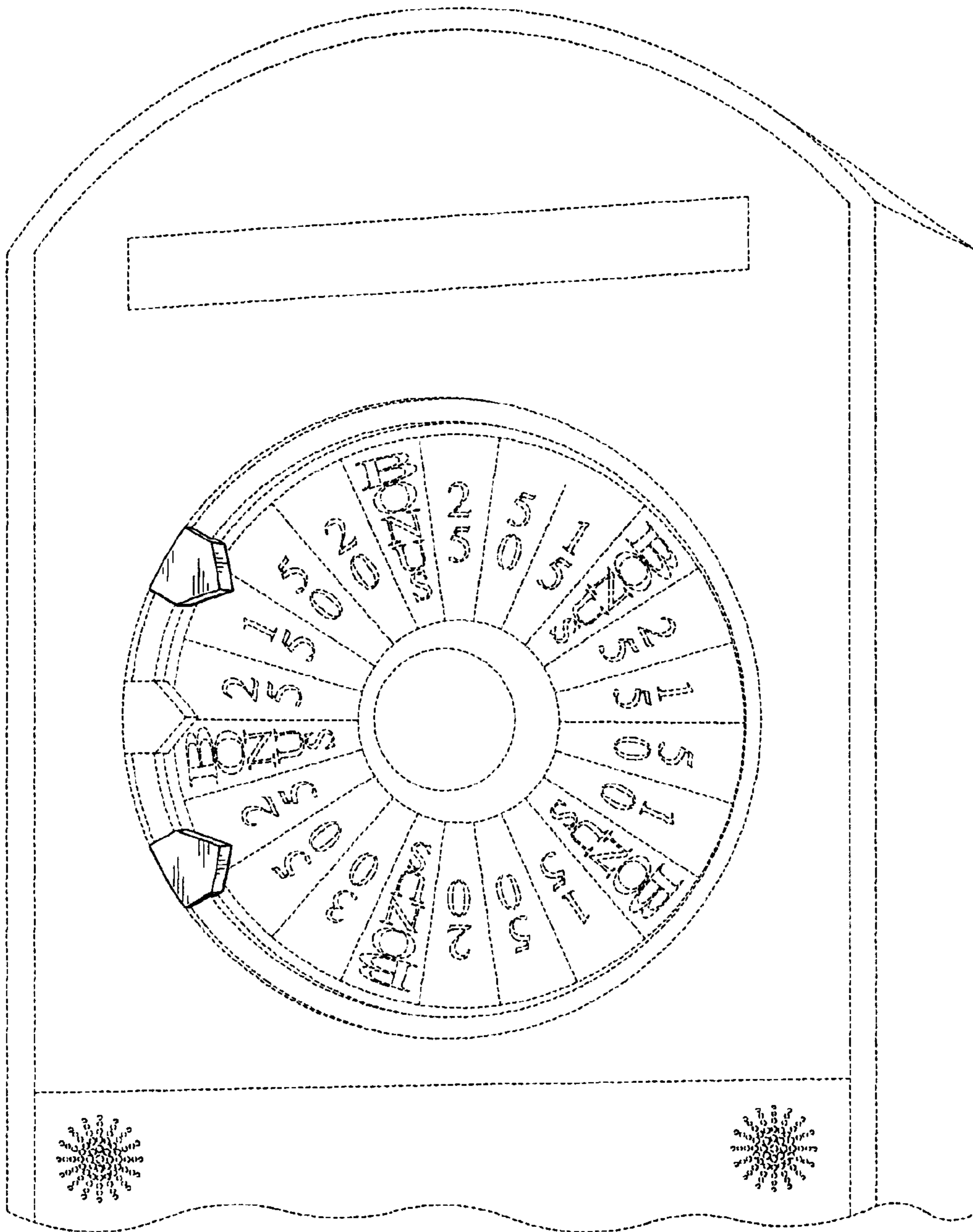

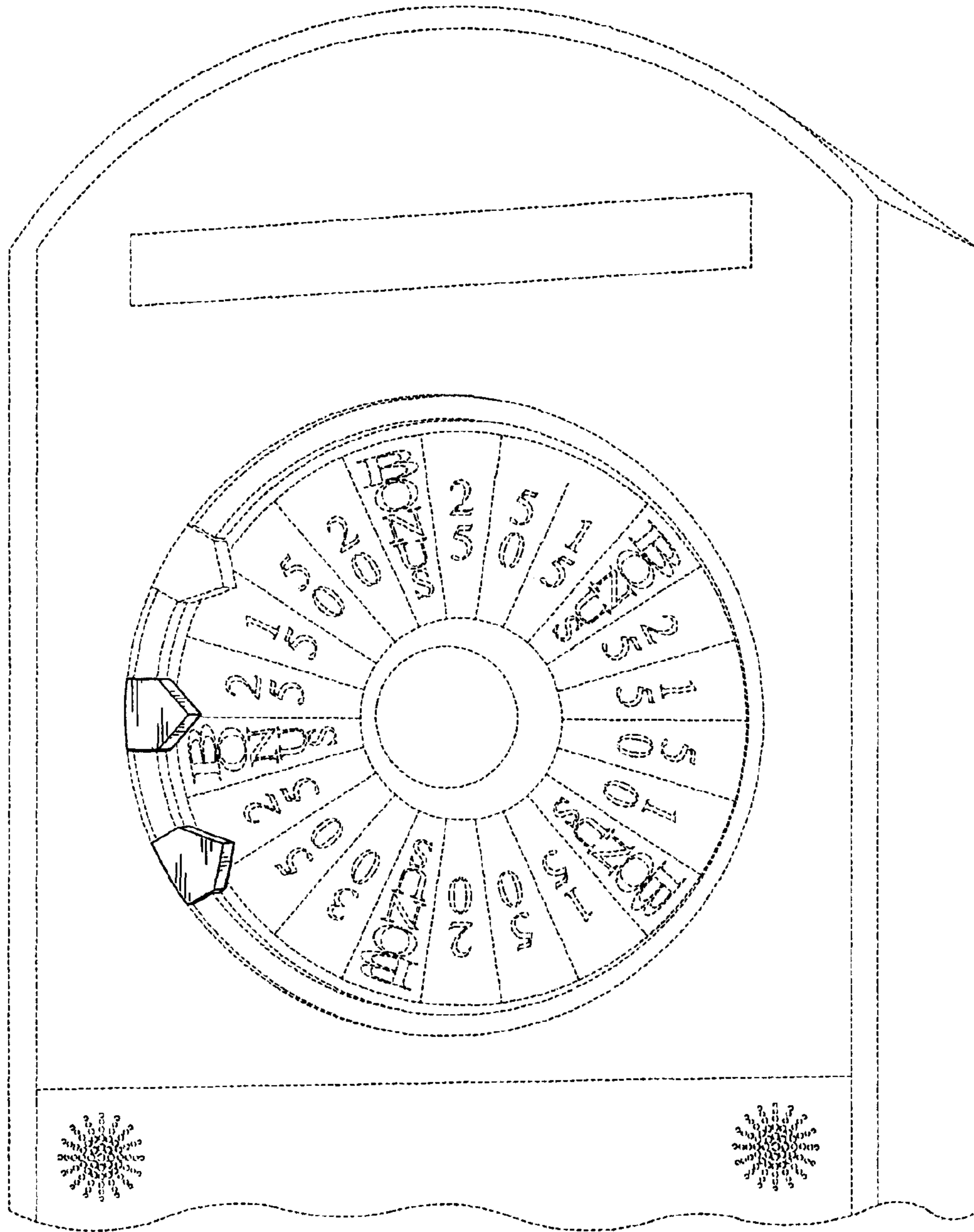

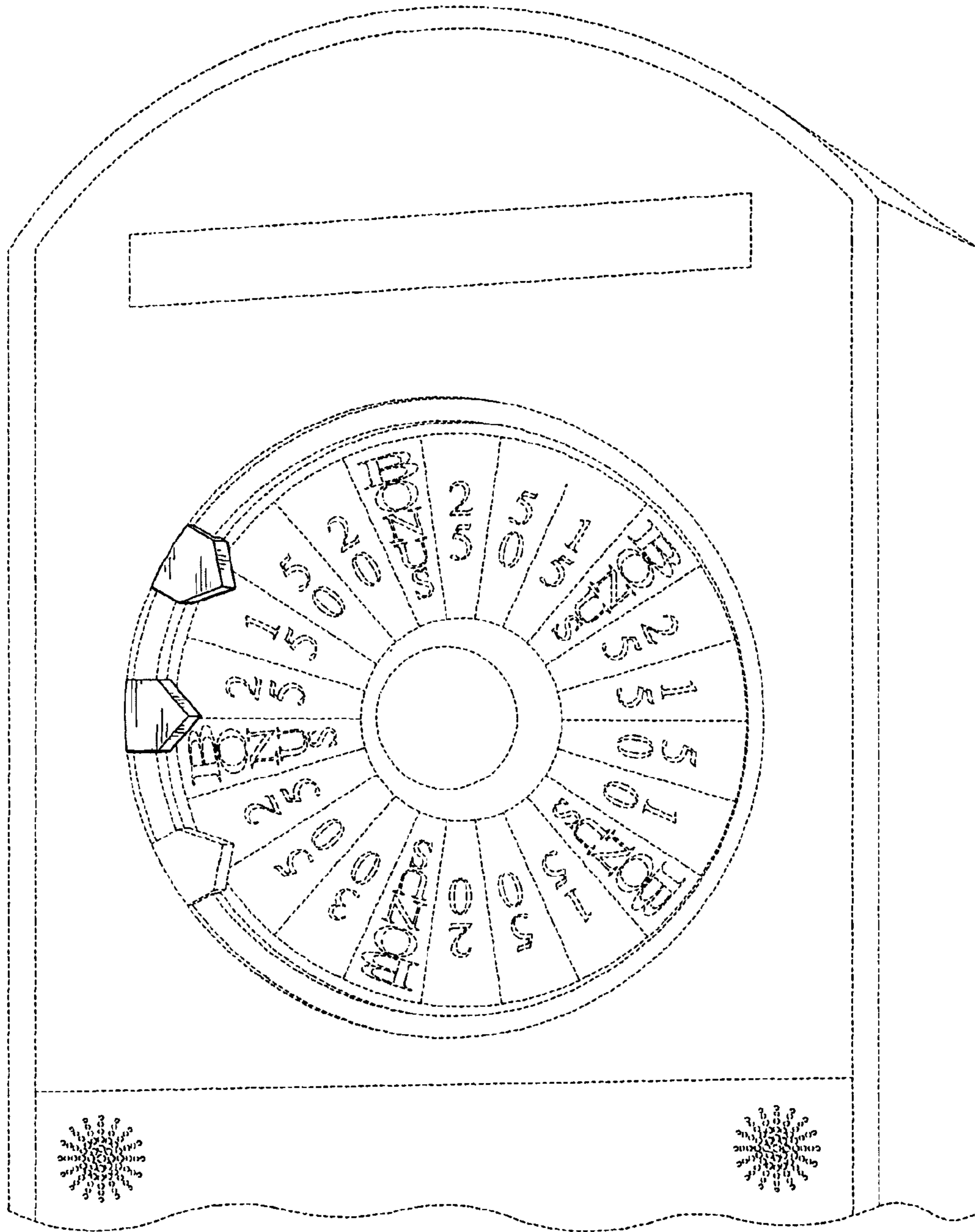

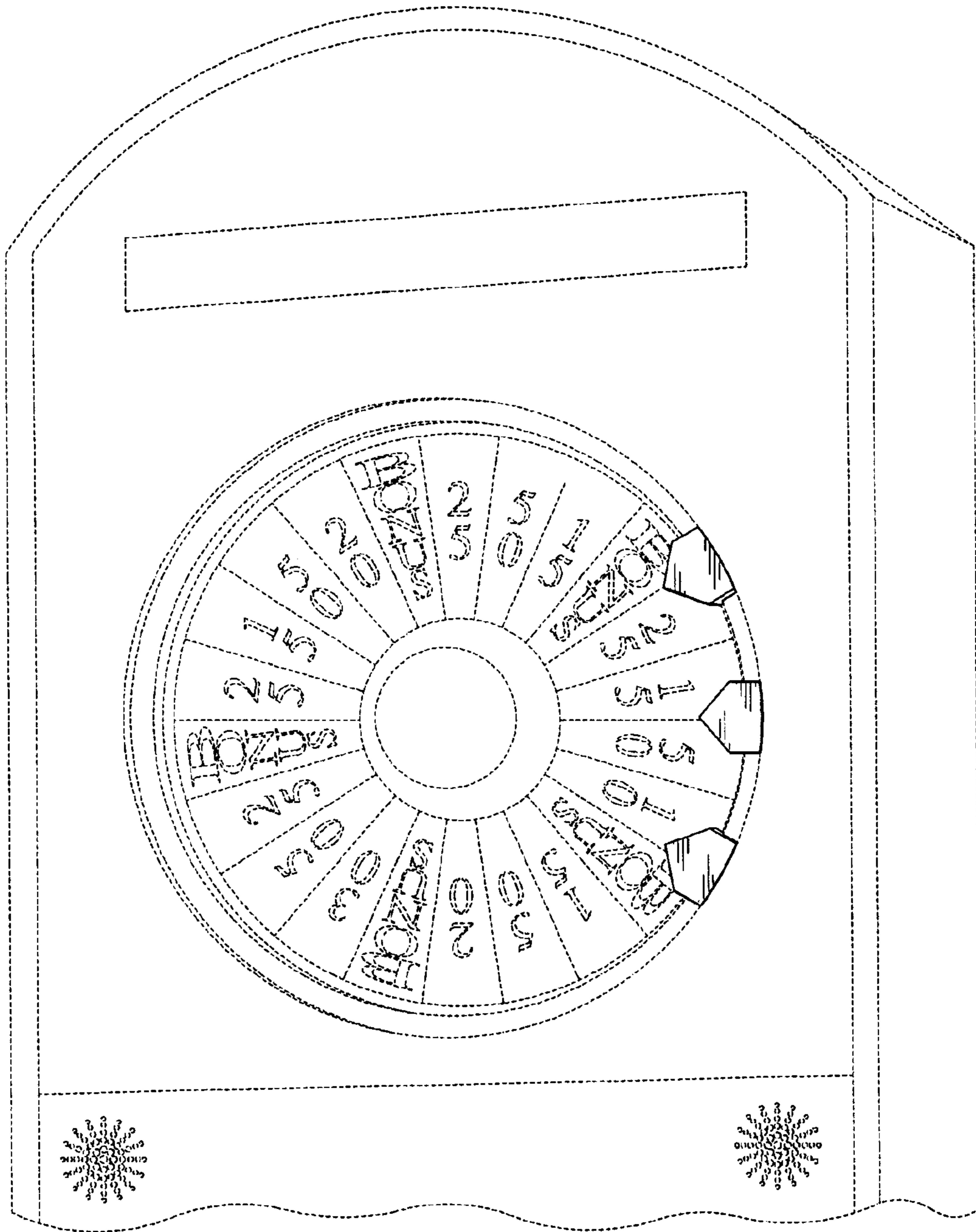

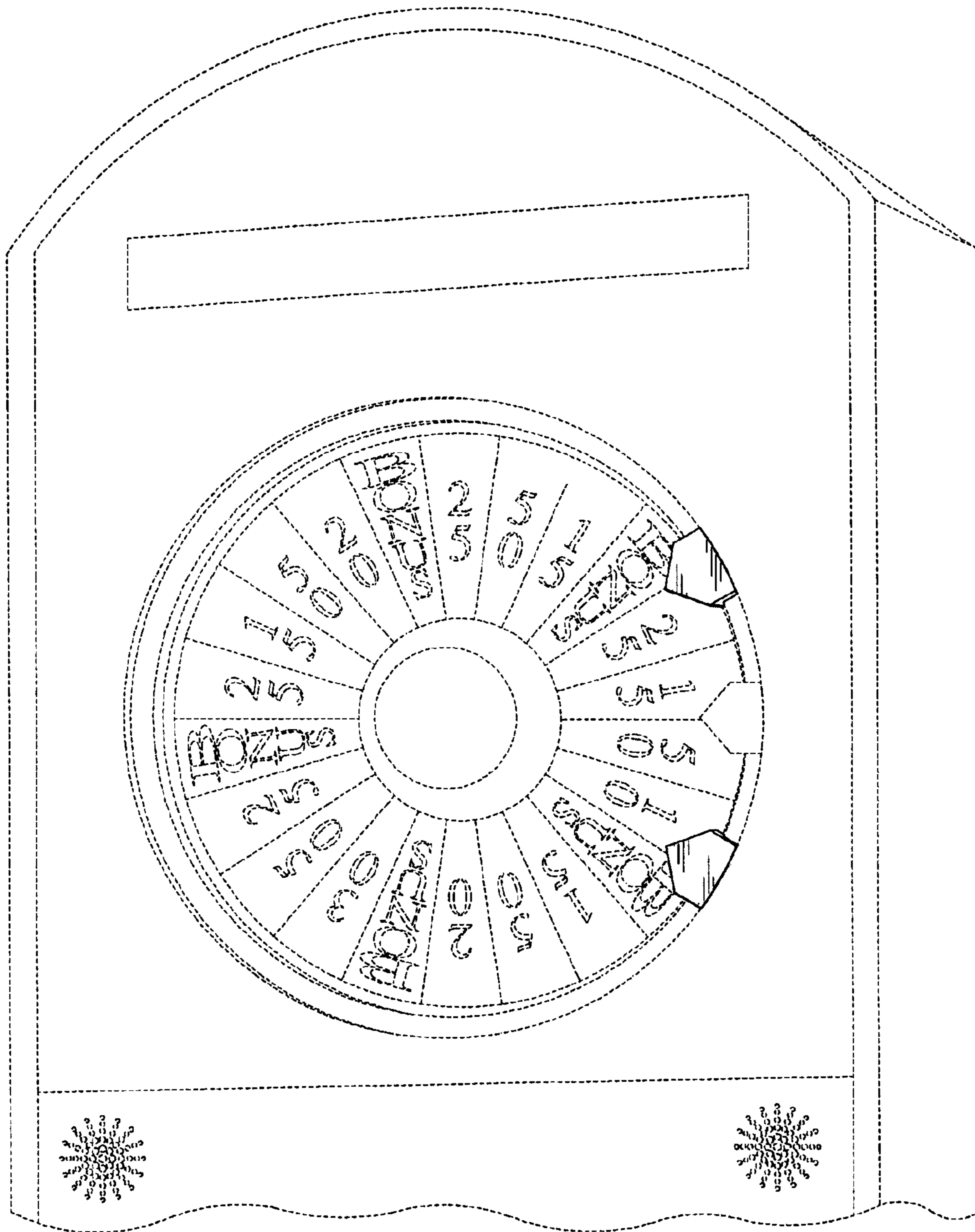

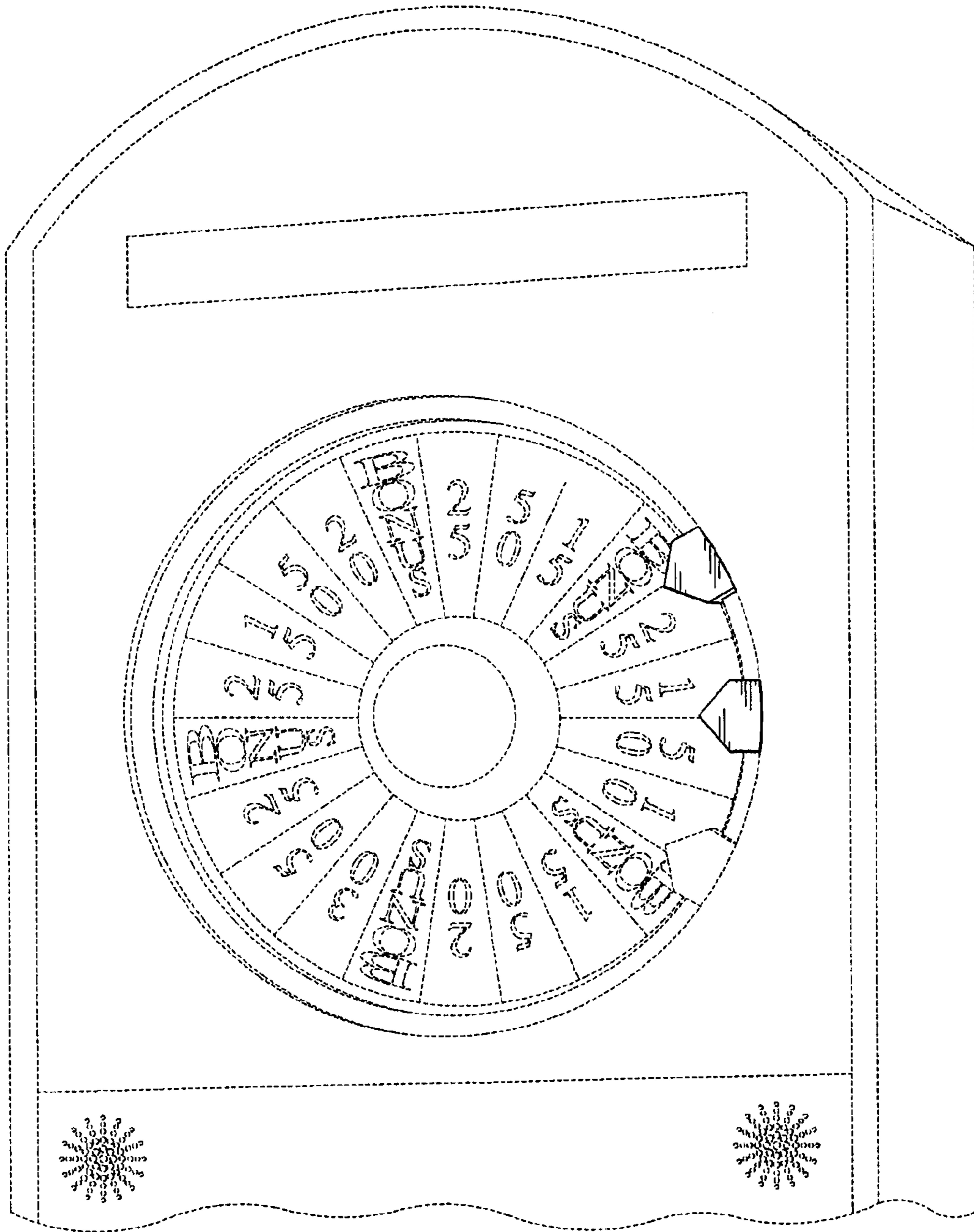
