The ornamental design for a handbag, as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of a handbag showing my new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a left side elevation view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a rear elevation view thereof;

FIG. 6 is a bottom plan view of the design, but showing the handbag in an expanded condition;

FIG. 7 is a front elevation view thereof;

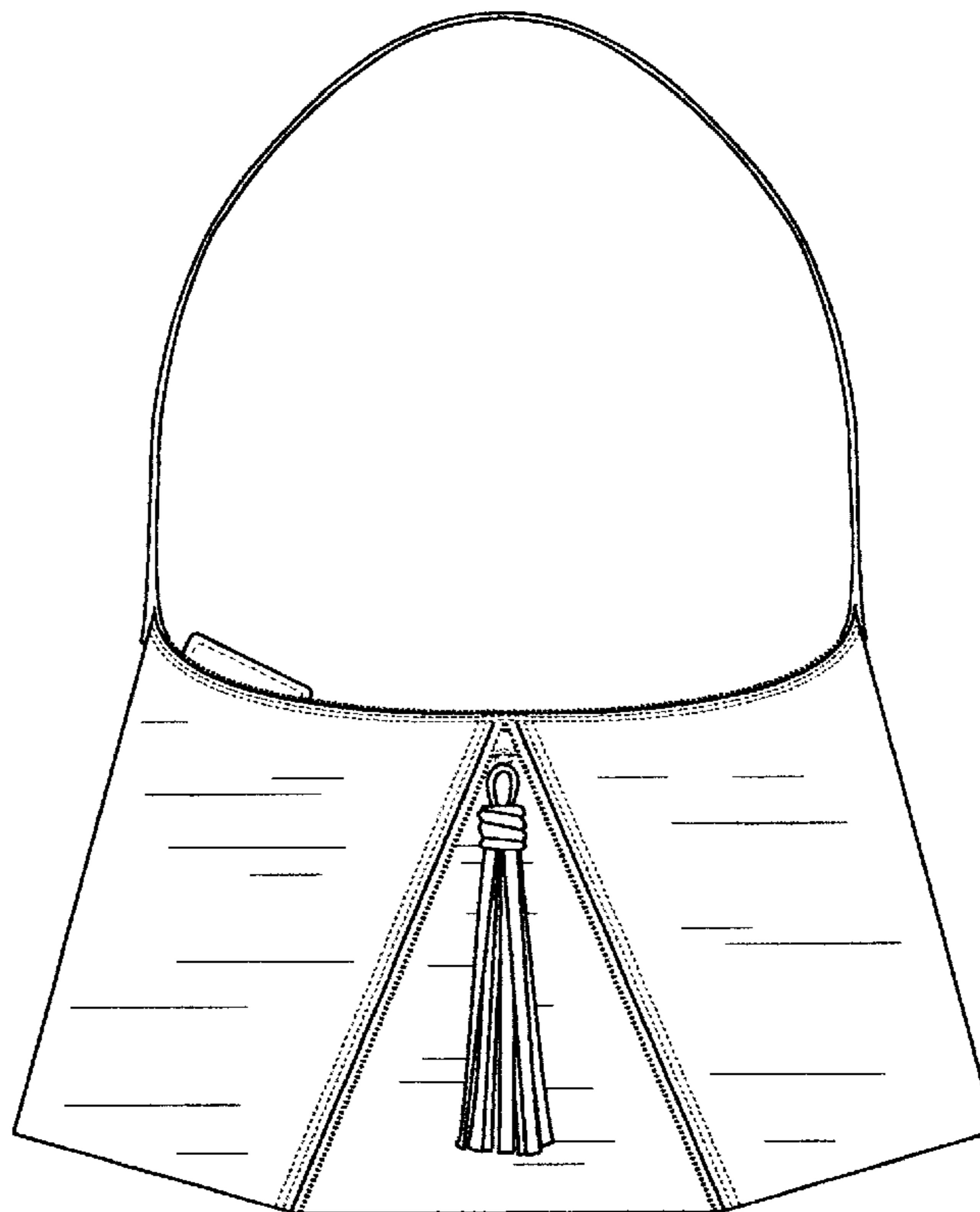
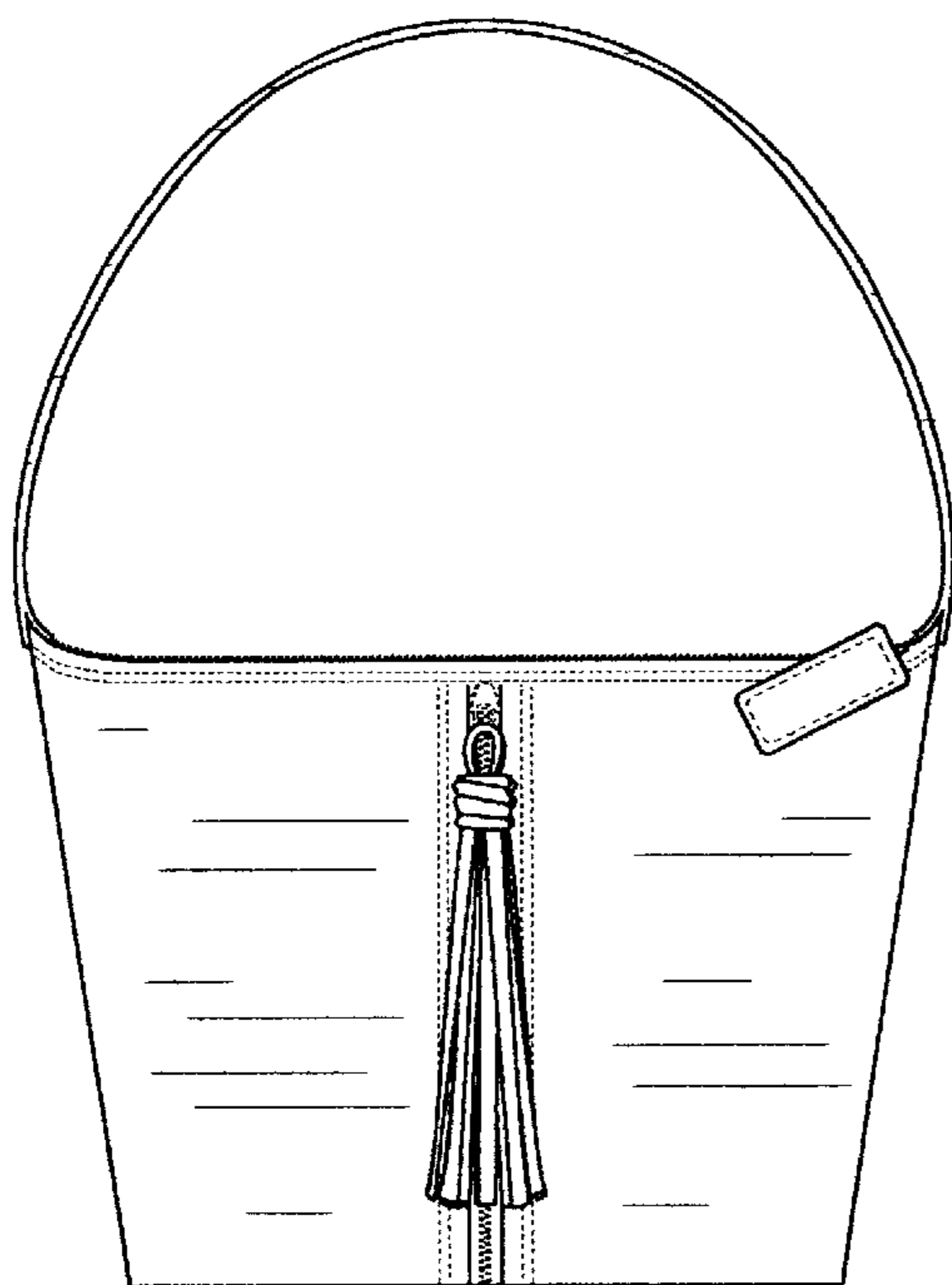
FIG. 8 is a left side elevation view thereof;

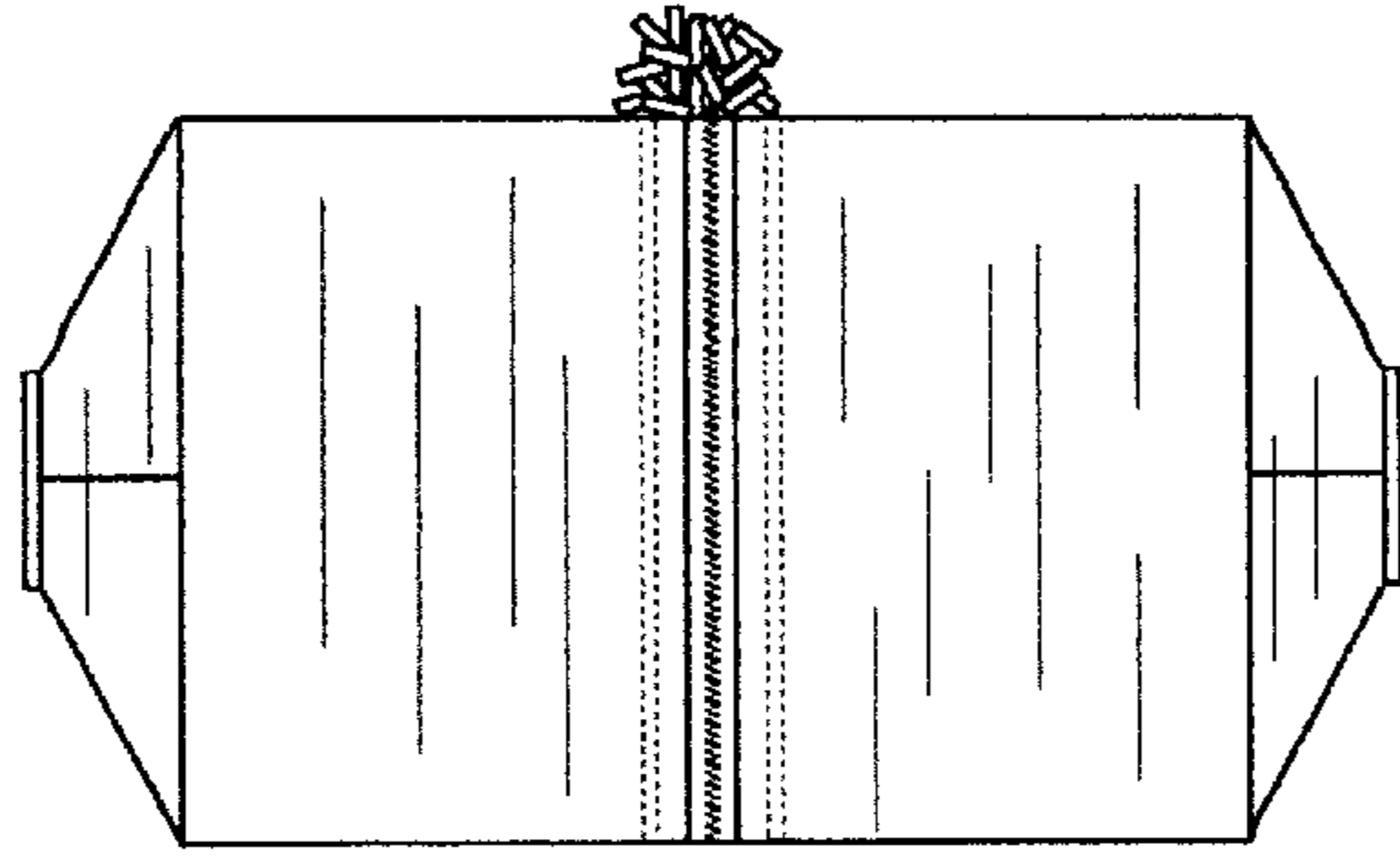

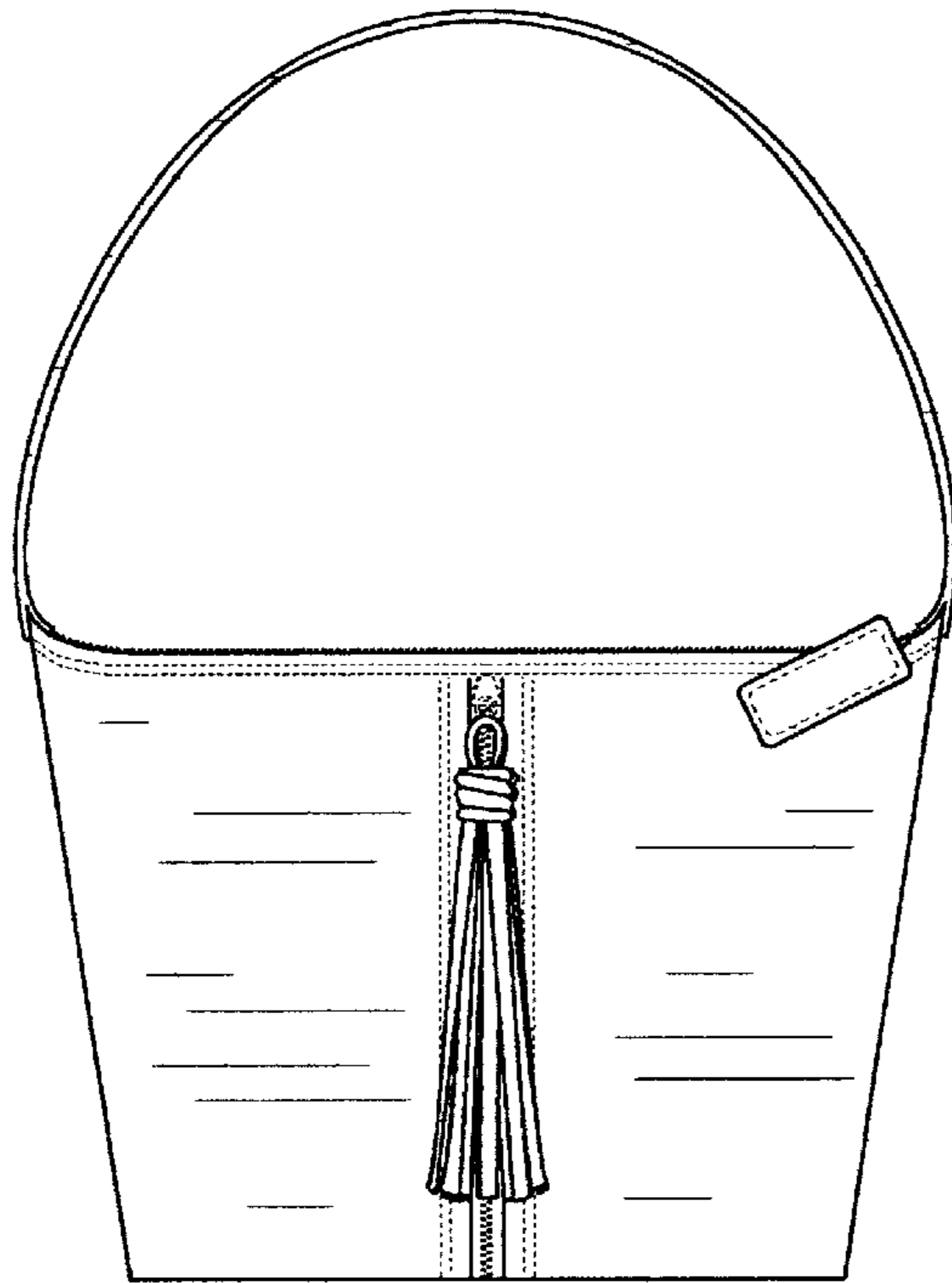

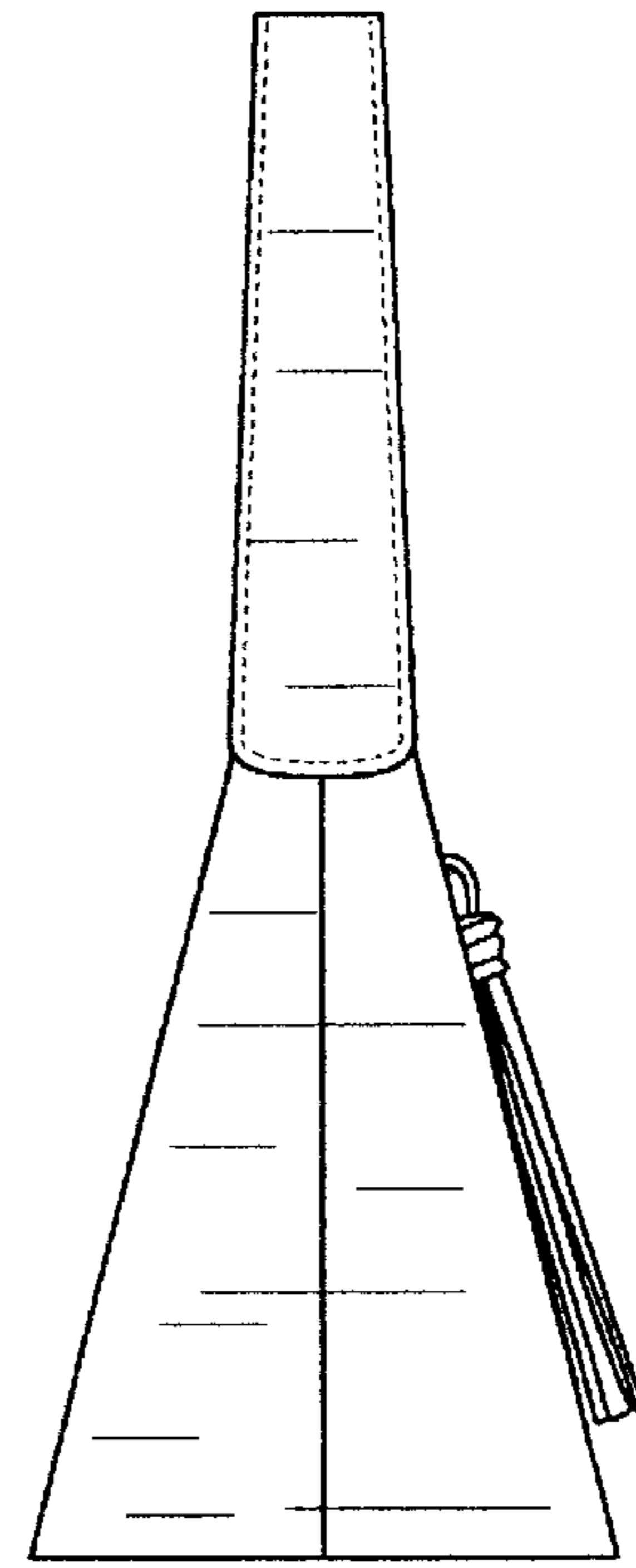

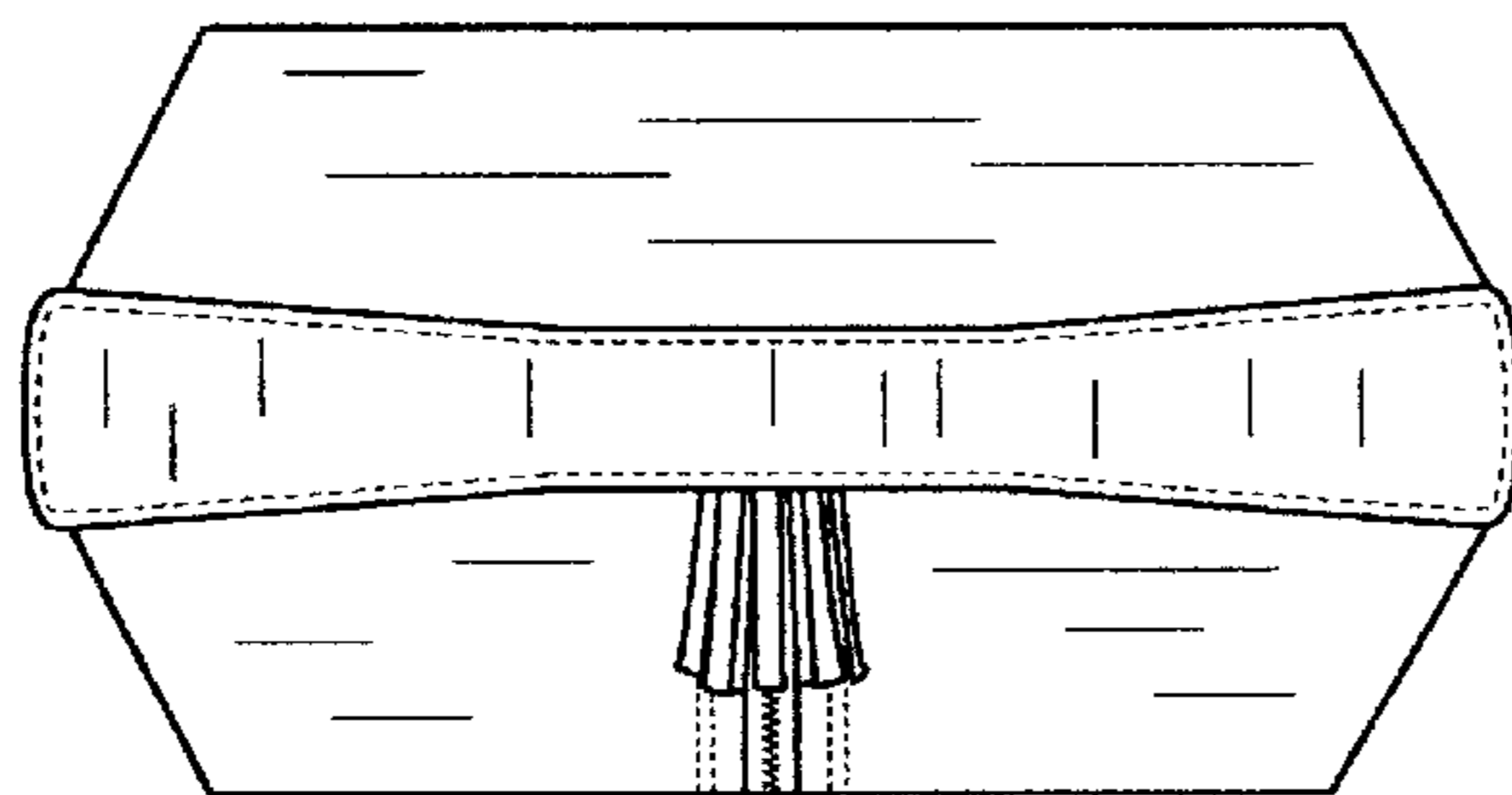

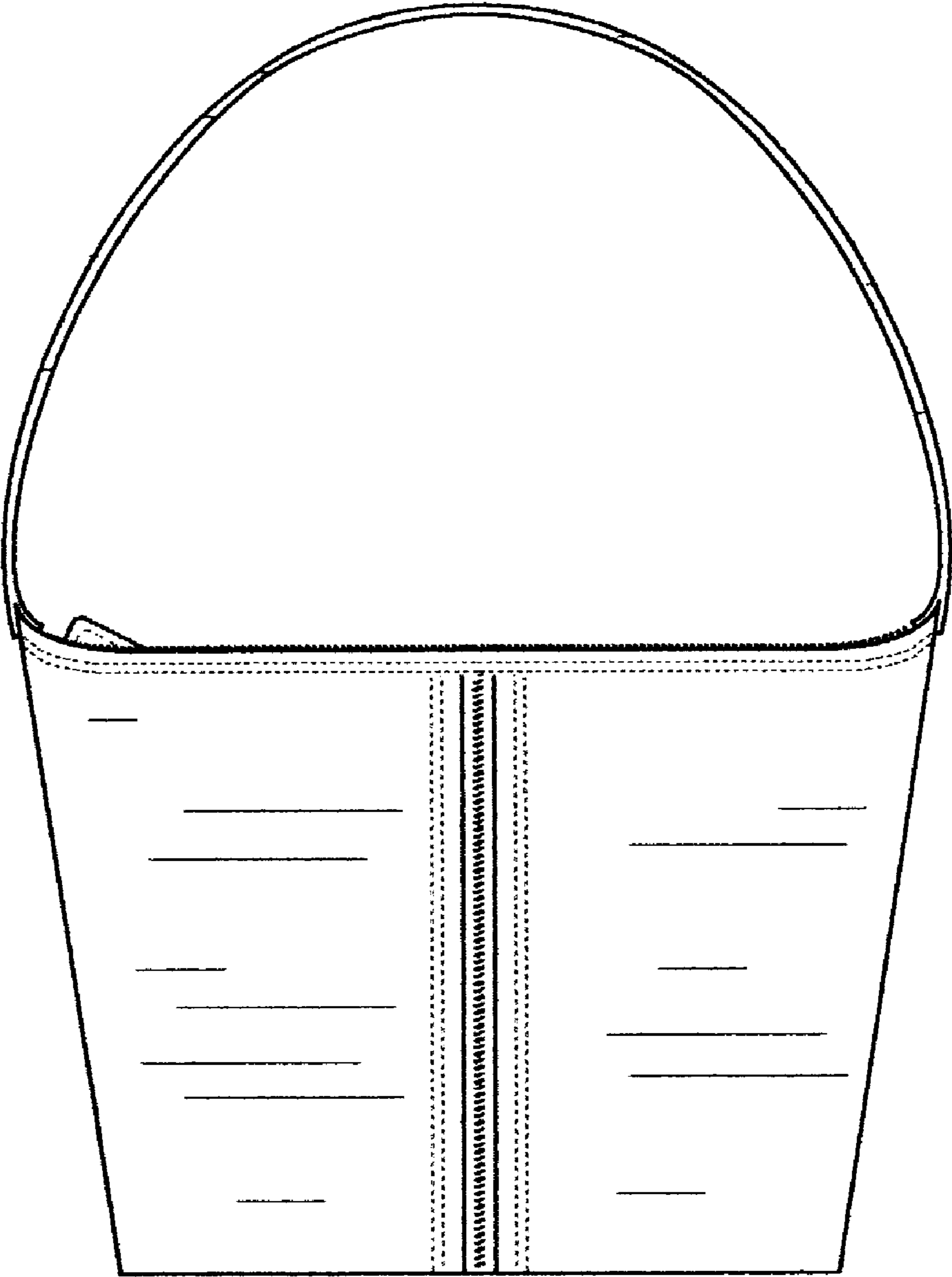

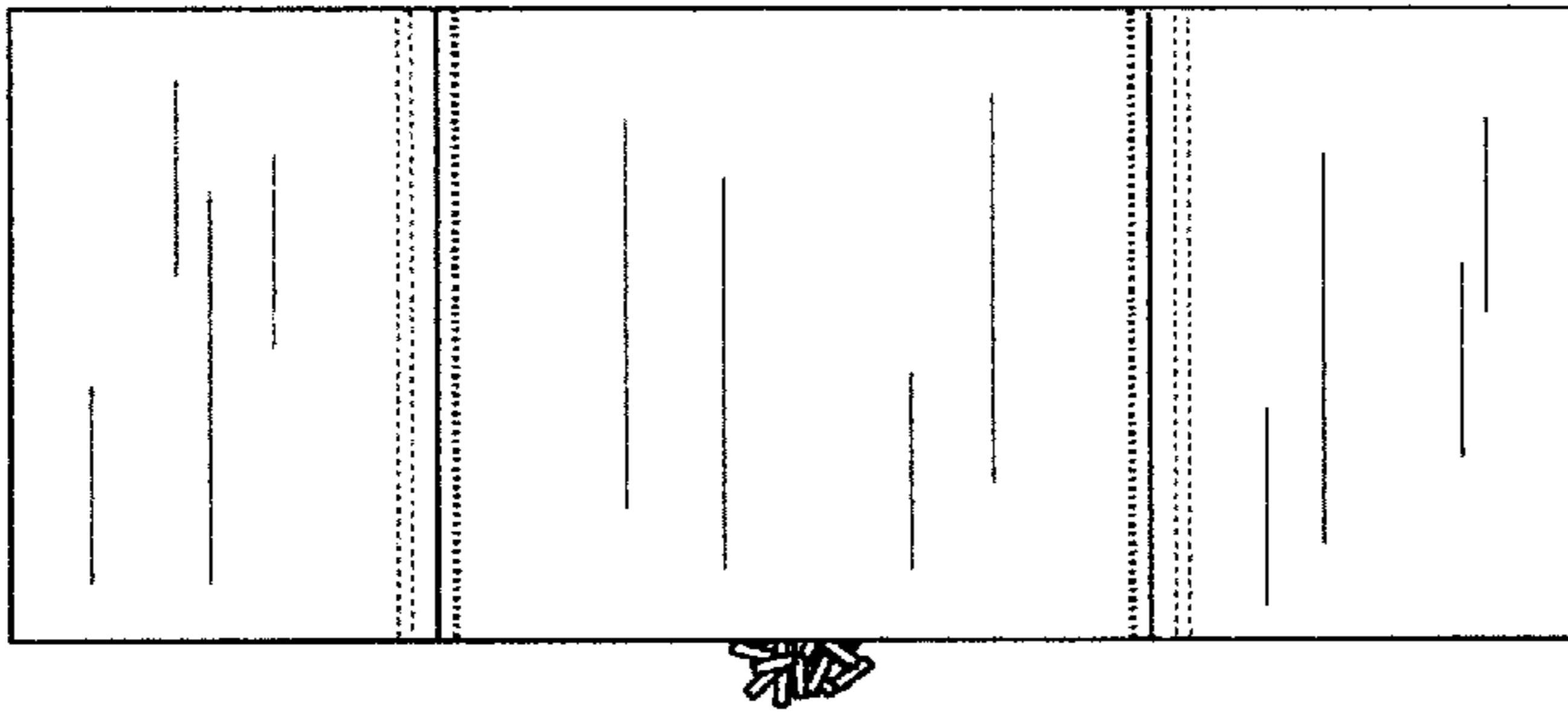

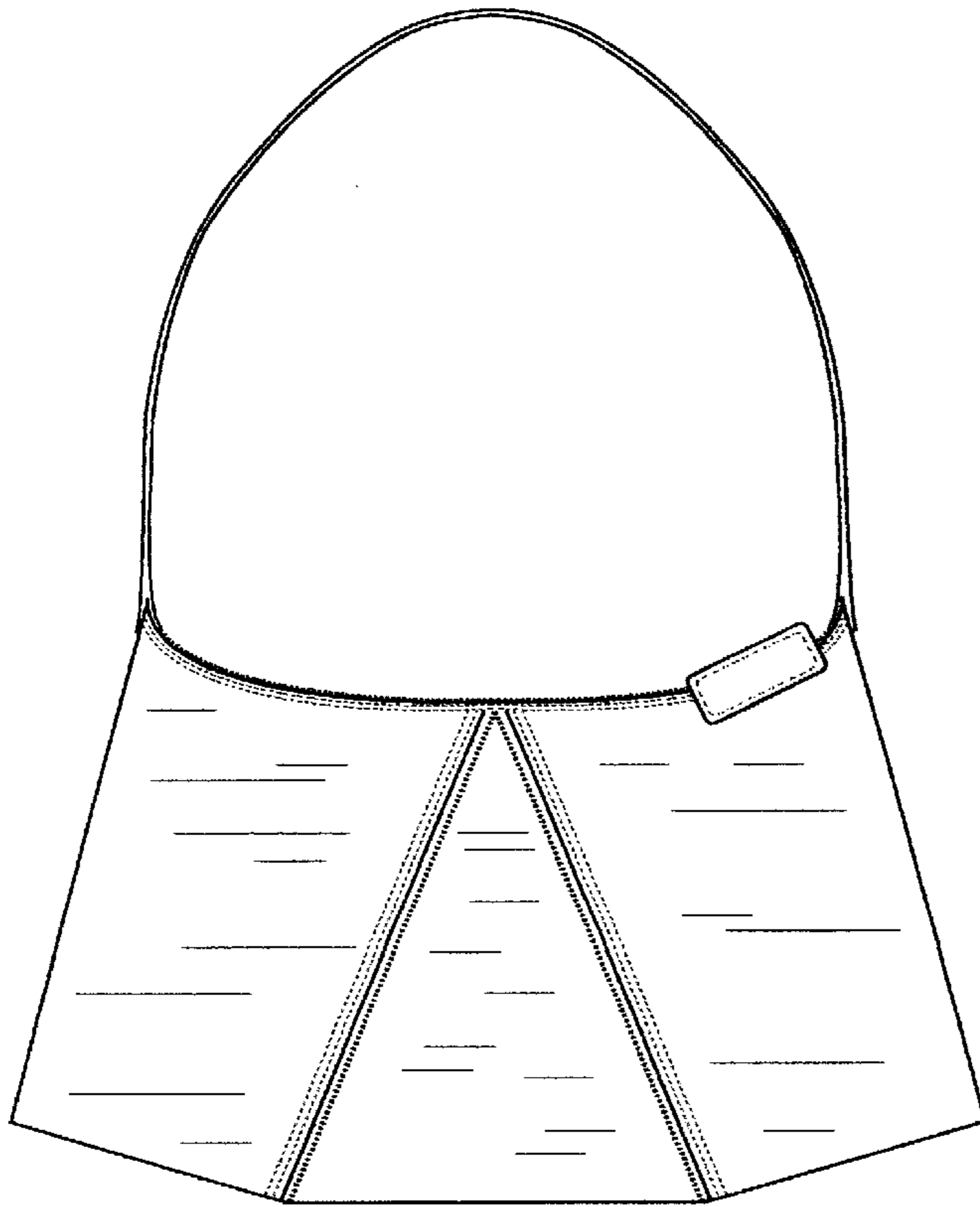

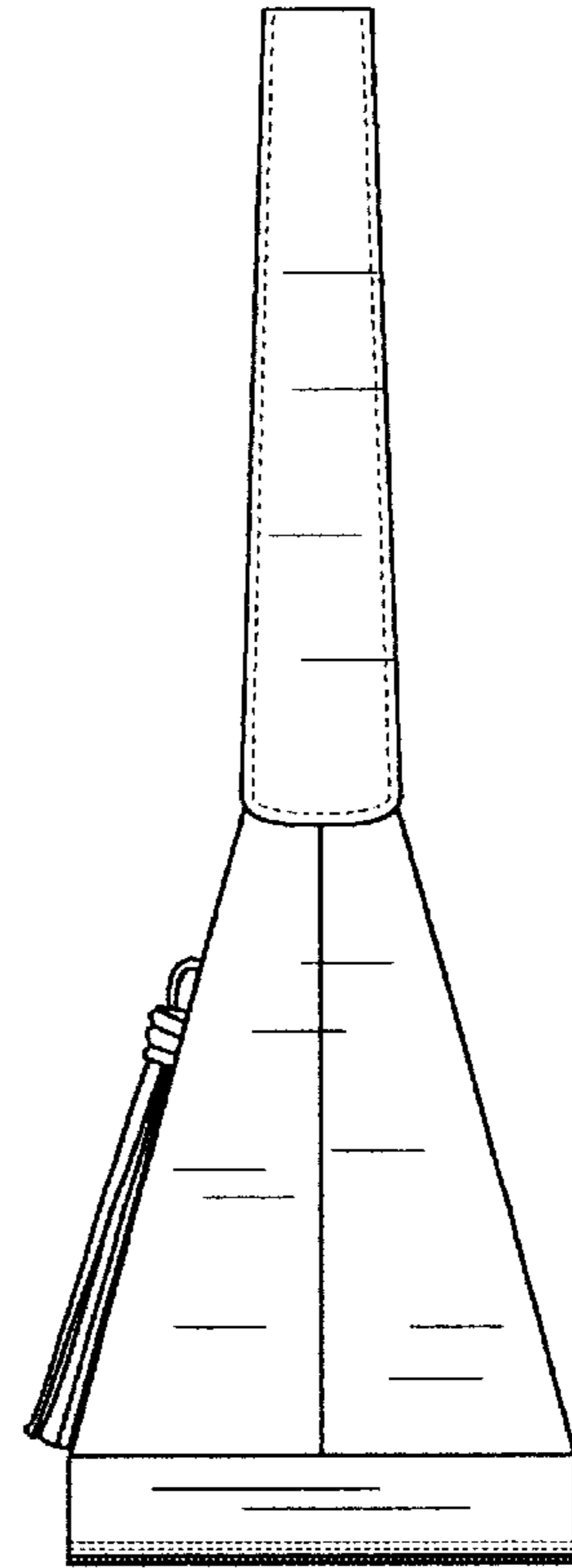

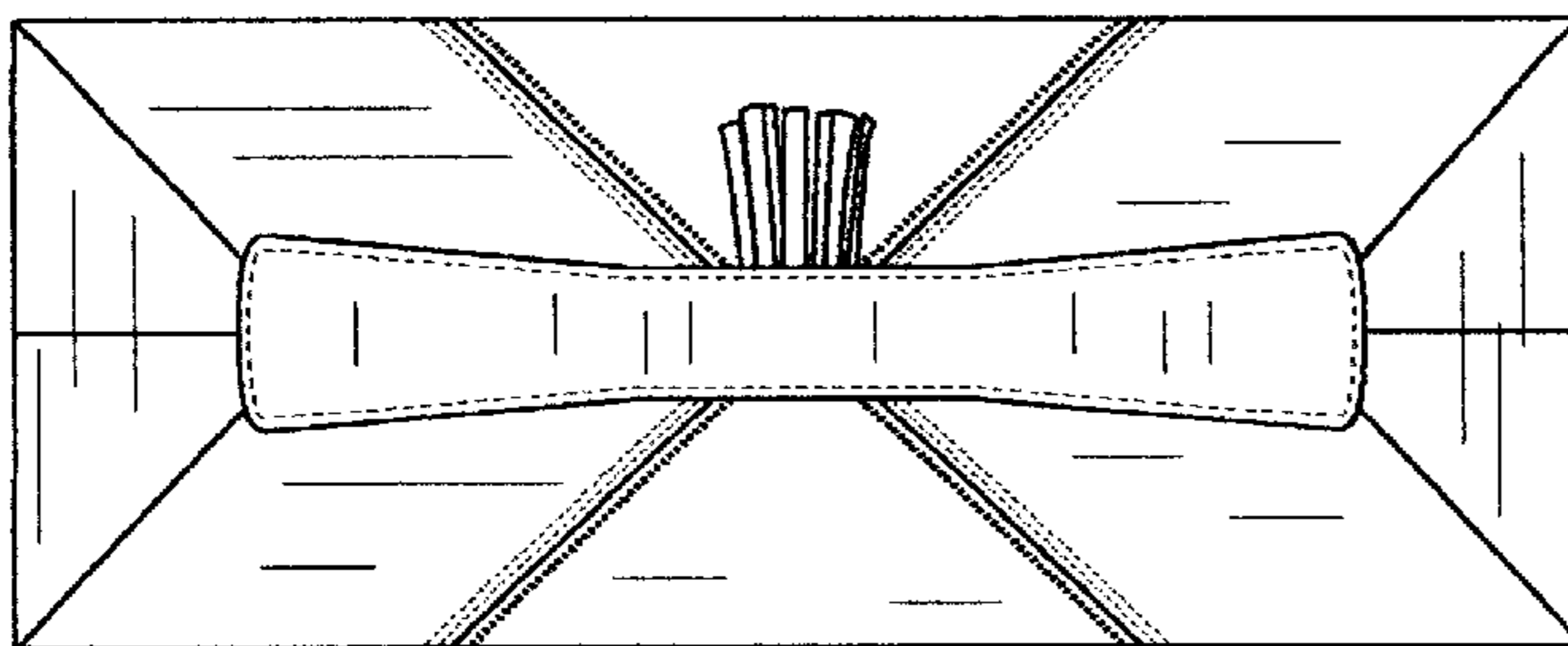

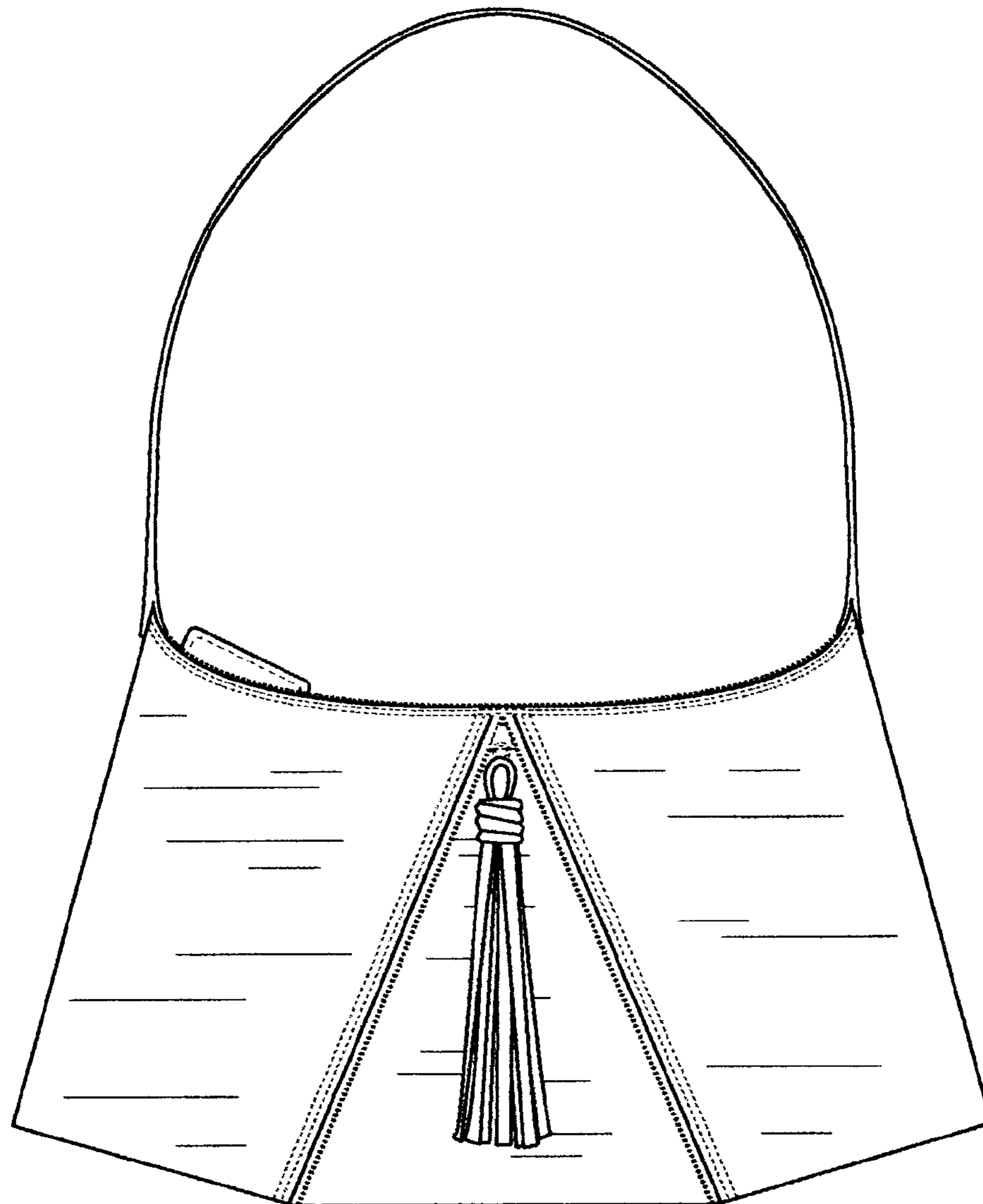
