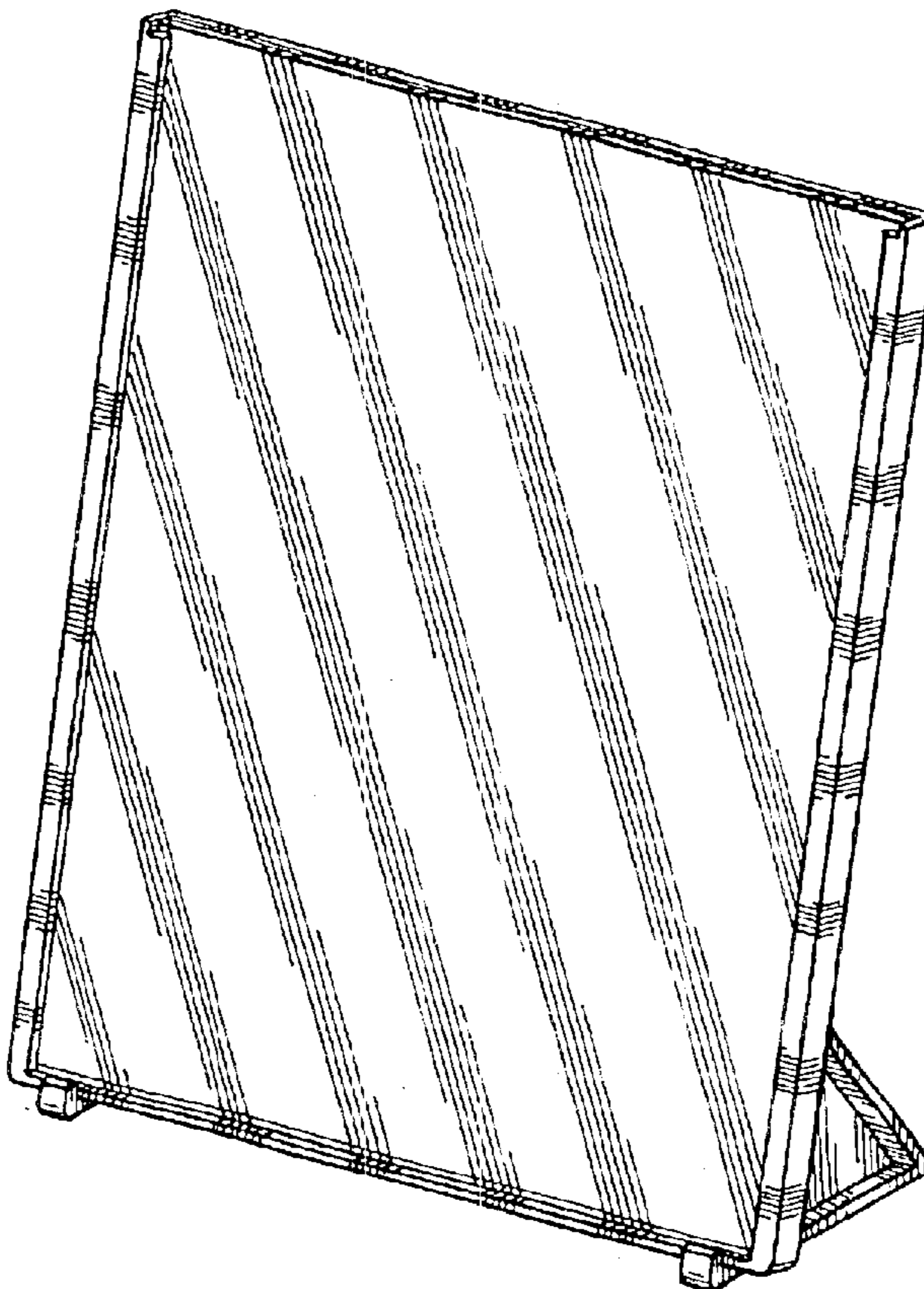

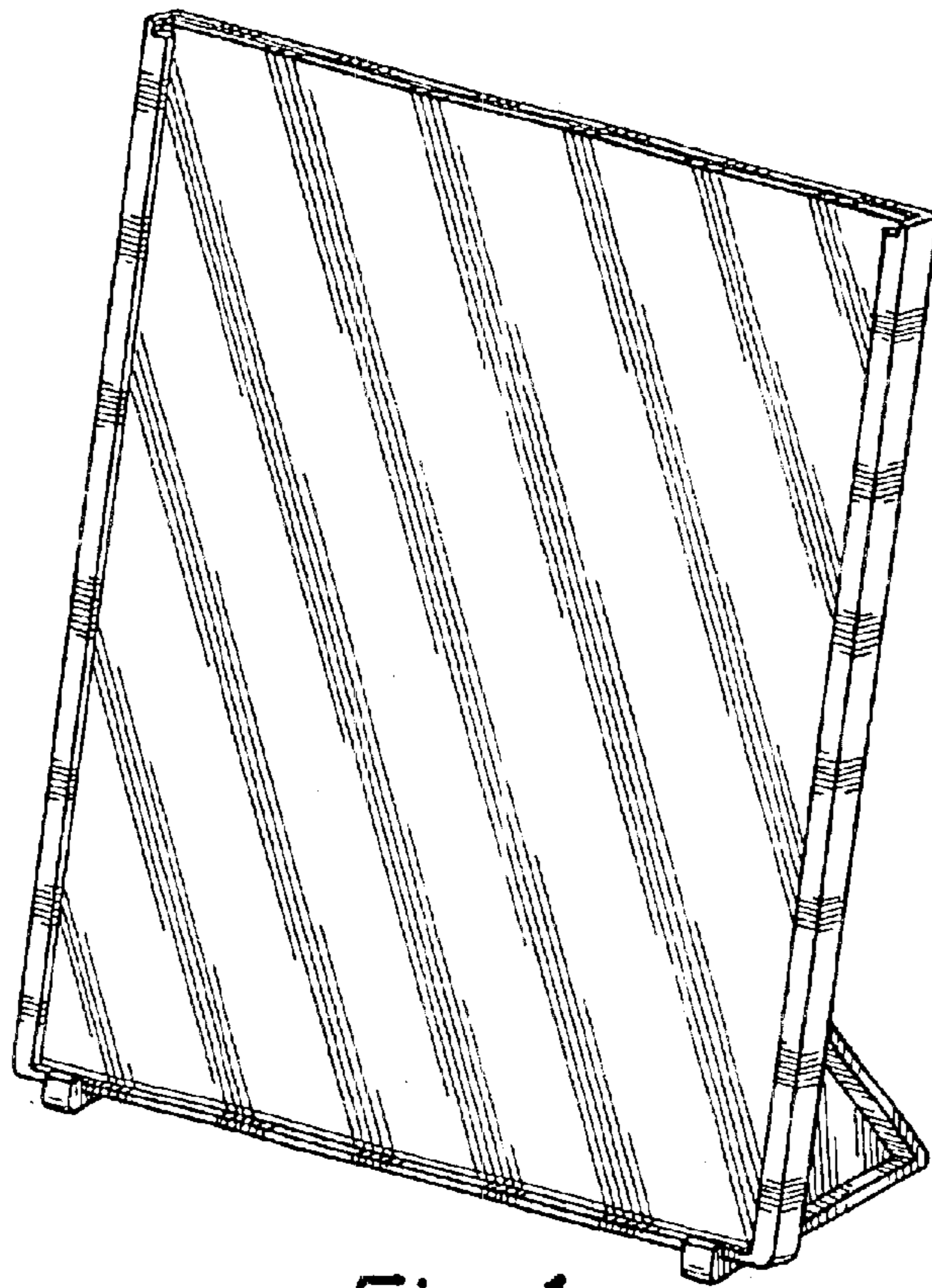
The ornamental design for a display frame, as shown.

**DESCRIPTION**

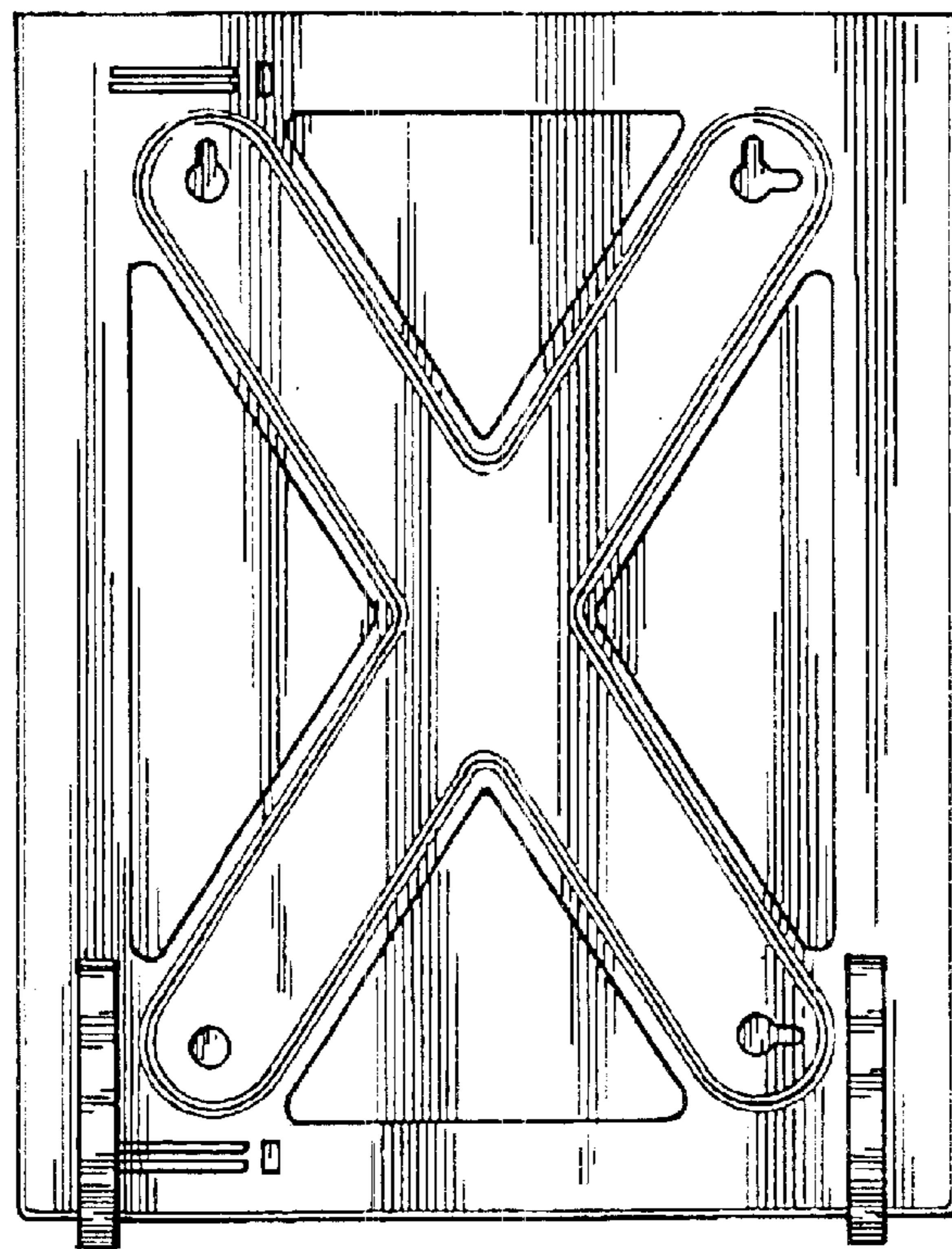
FIG. 1 is a top, front, right side perspective view of a display frame showing my new design;

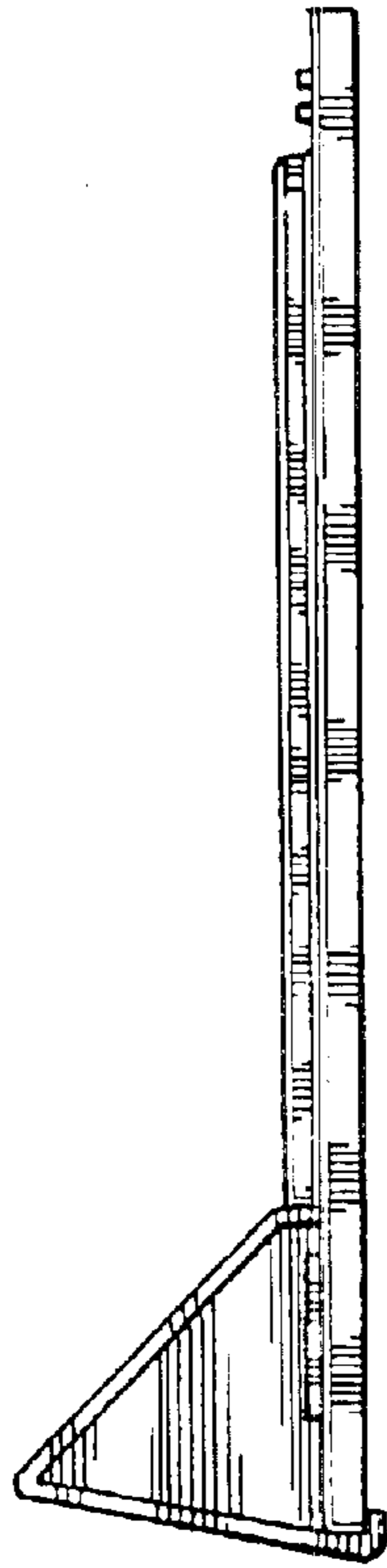




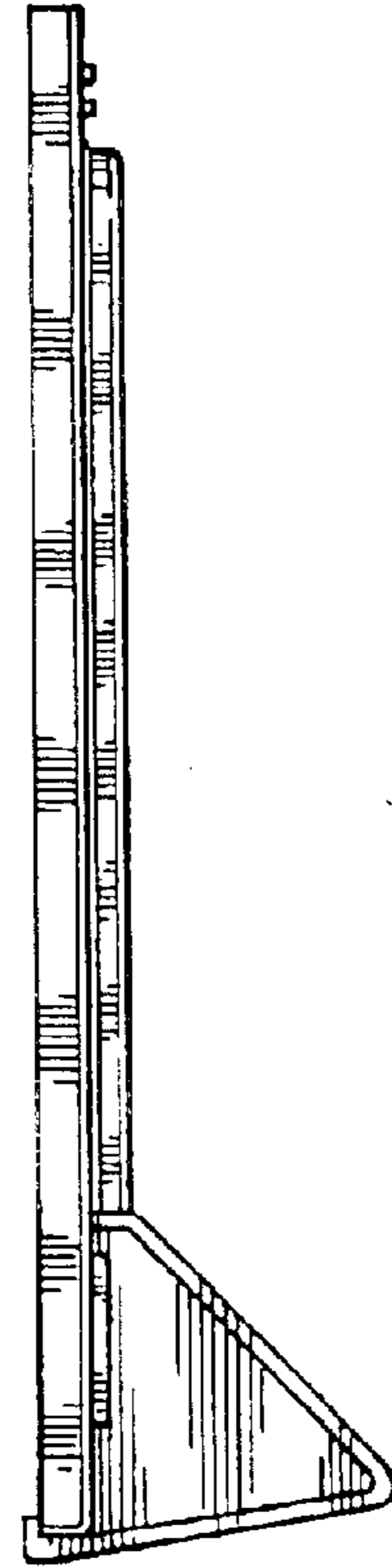

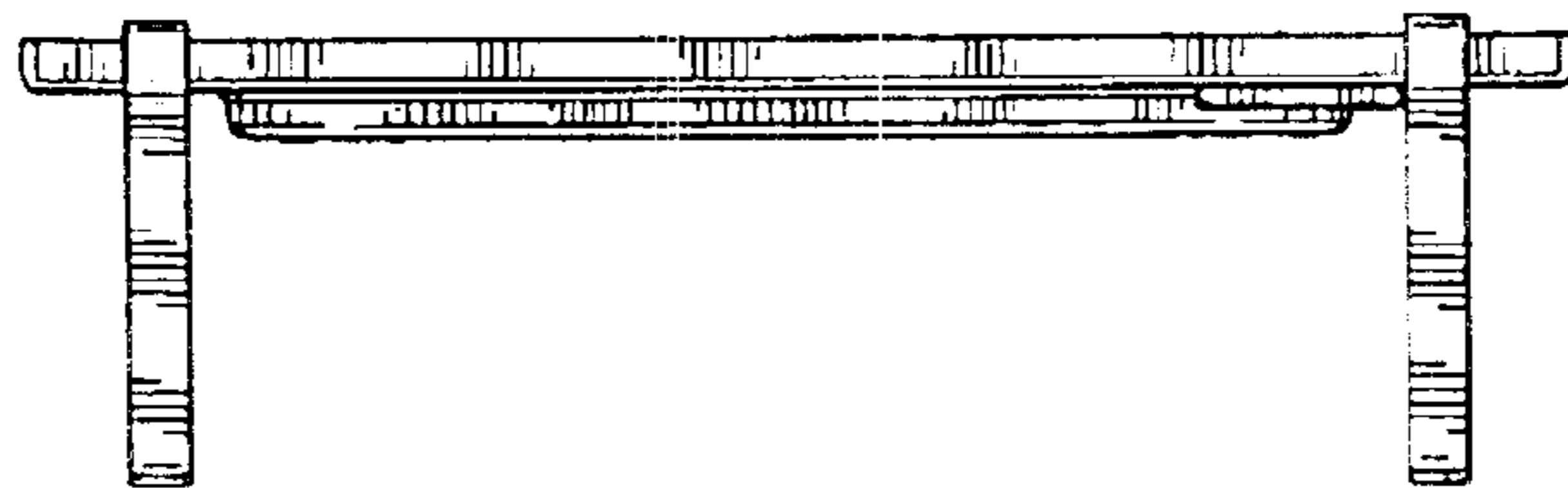
