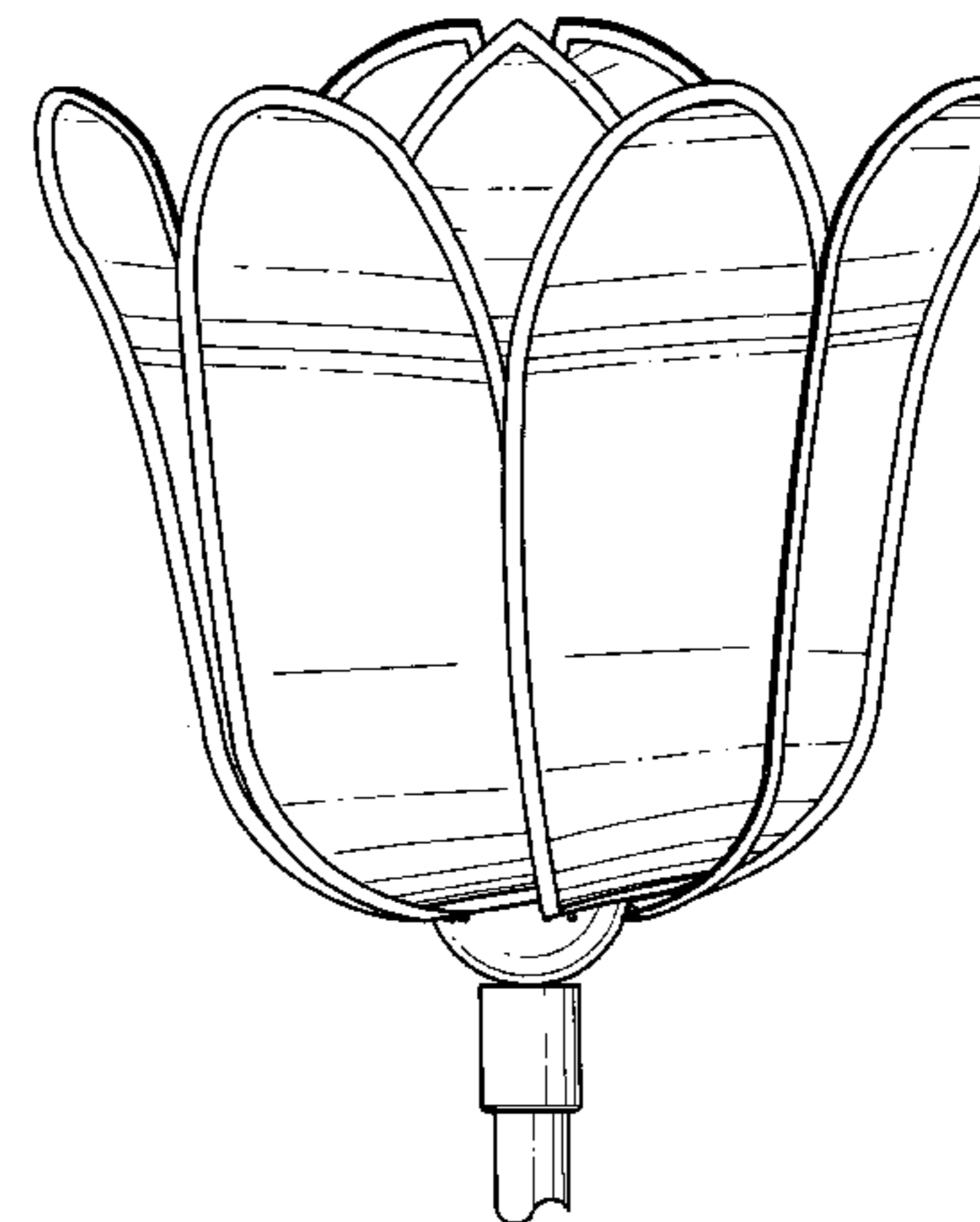
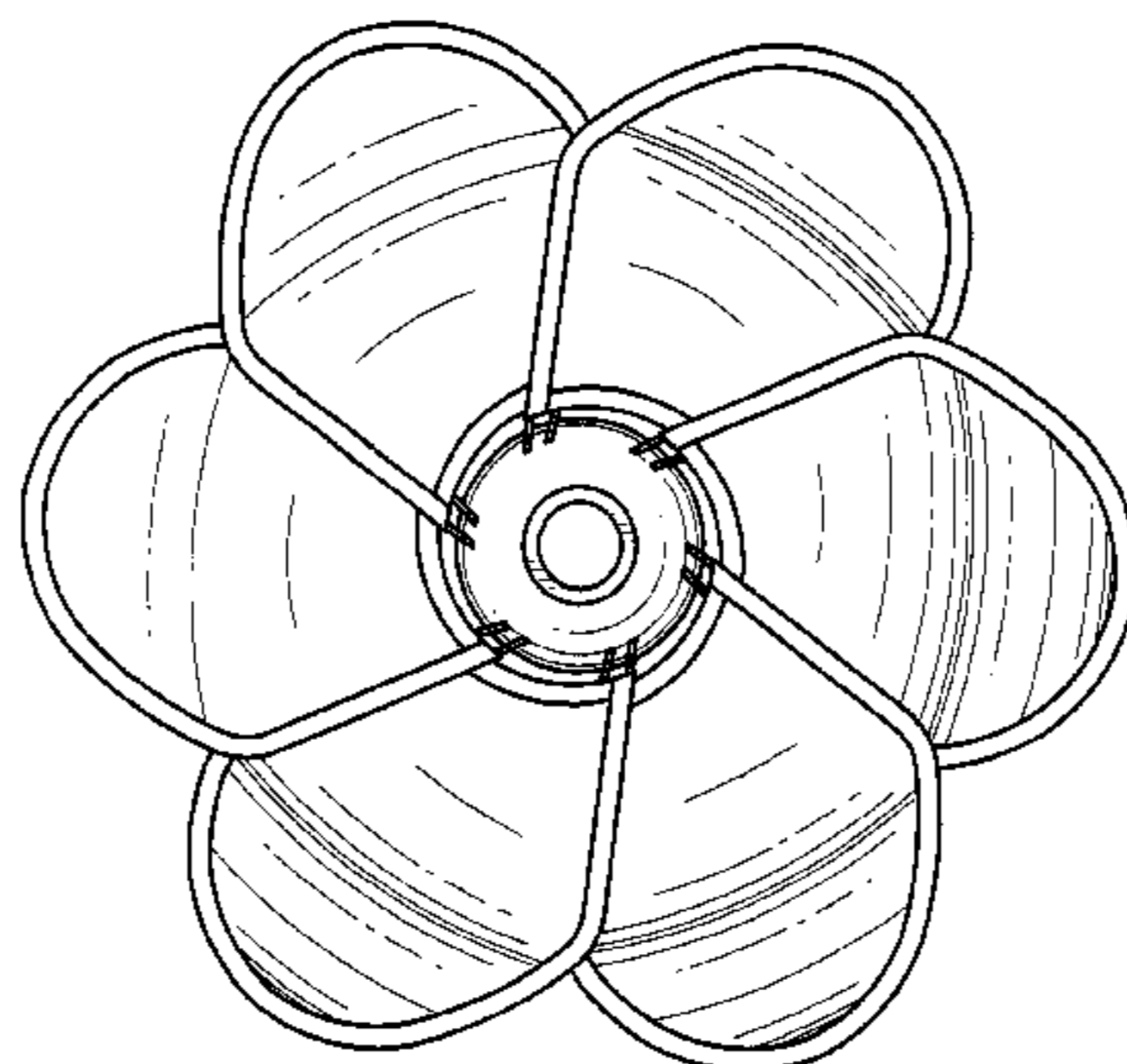
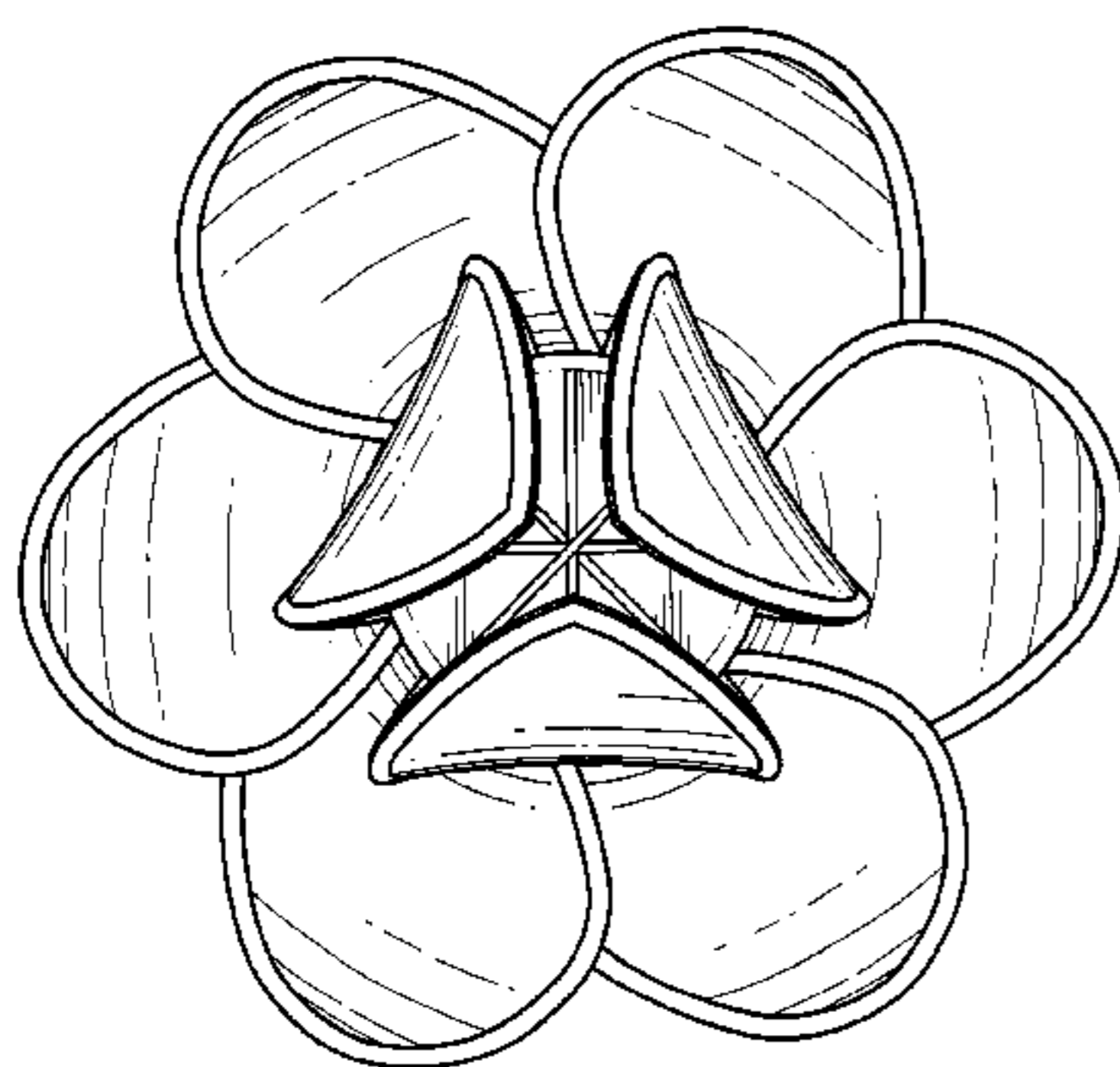
(57) **CLAIM**

The ornamental design for a flower novelty, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of our flower novelty;
FIG. 2 is a bottom view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof; and,
FIG. 5 is a right side elevational view thereof with the left side elevational view being a mirror image thereof.
The stem portion of the design is shown partially broken away in the elevational views to indicate indeterminate length.

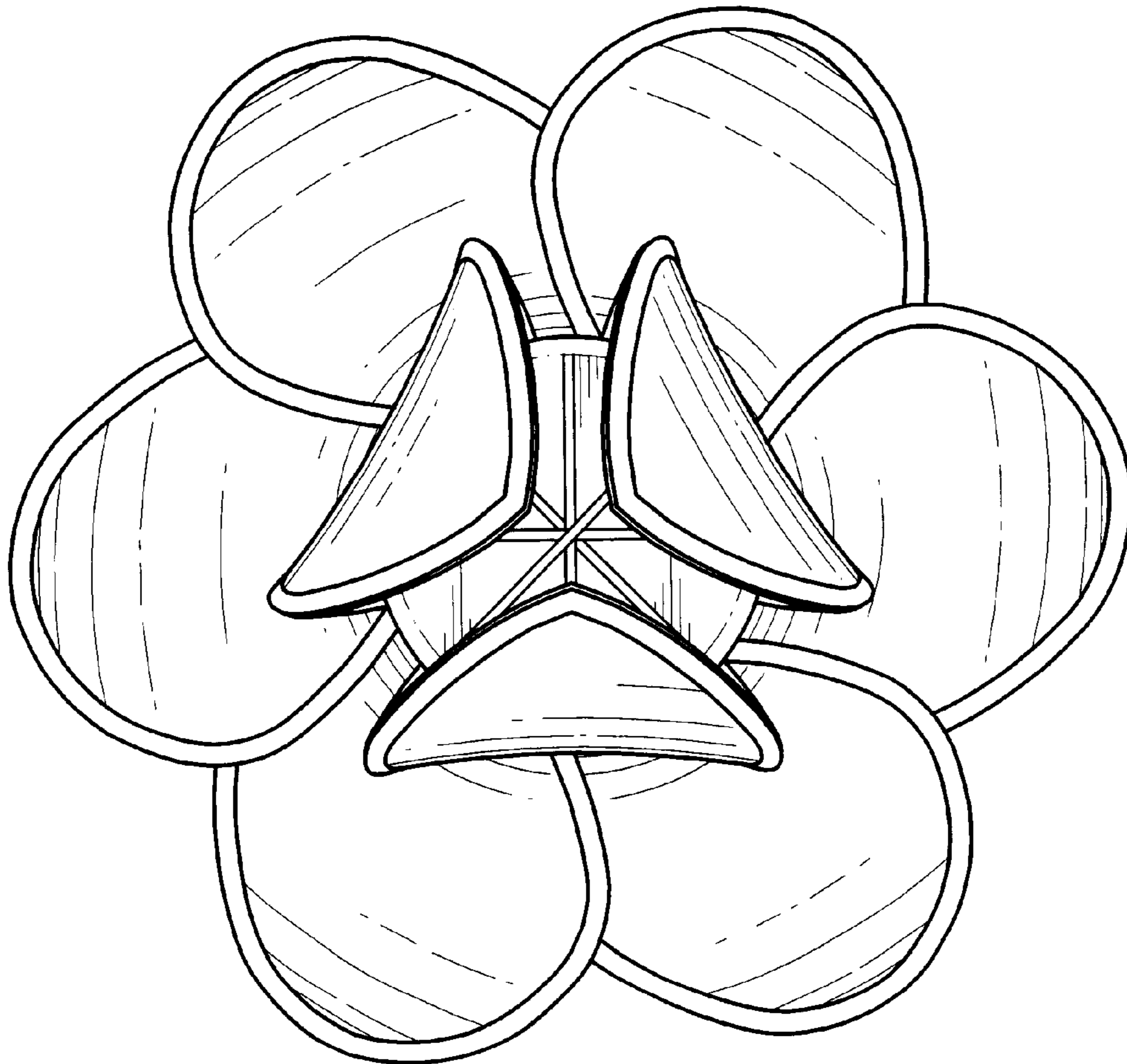

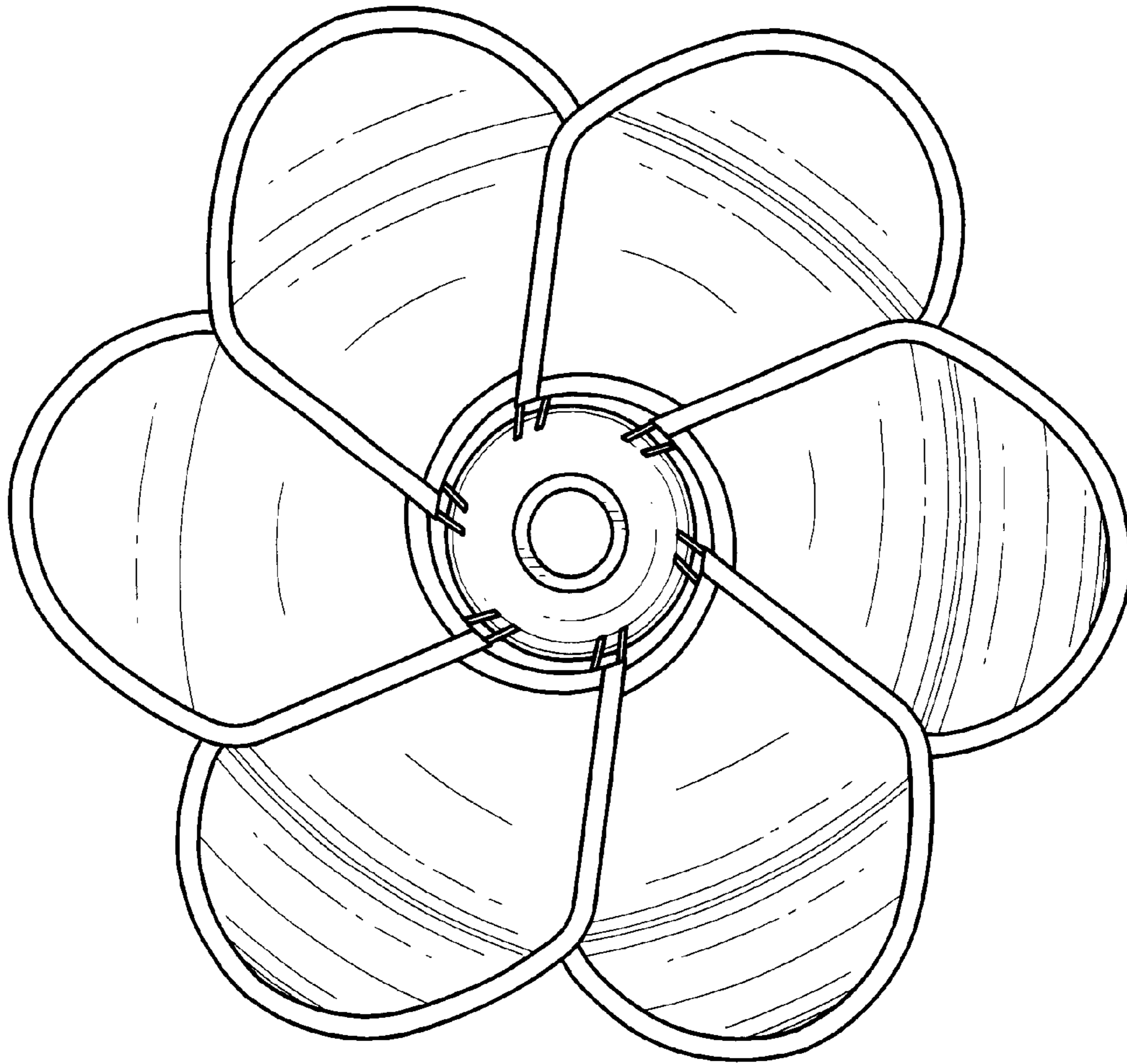

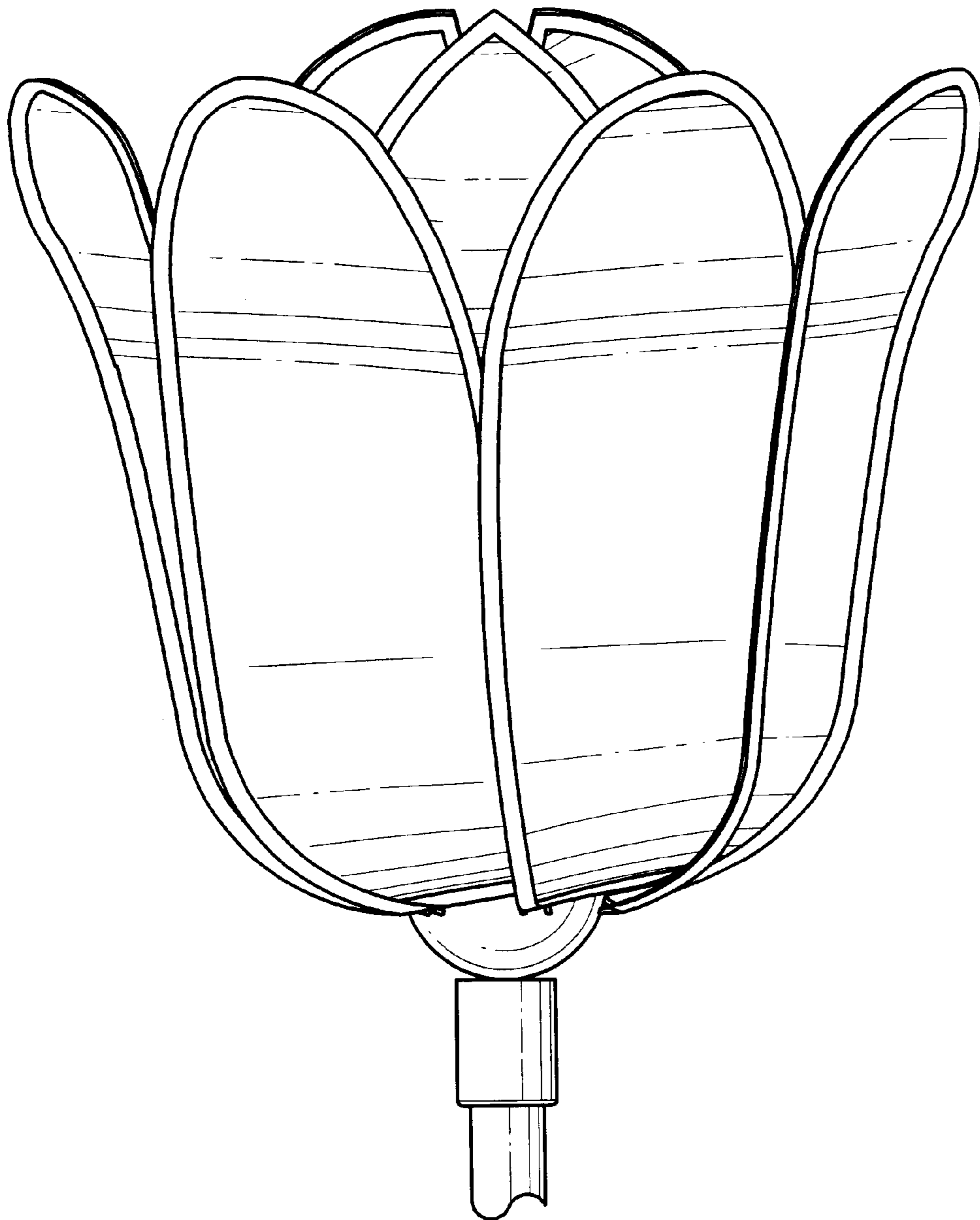

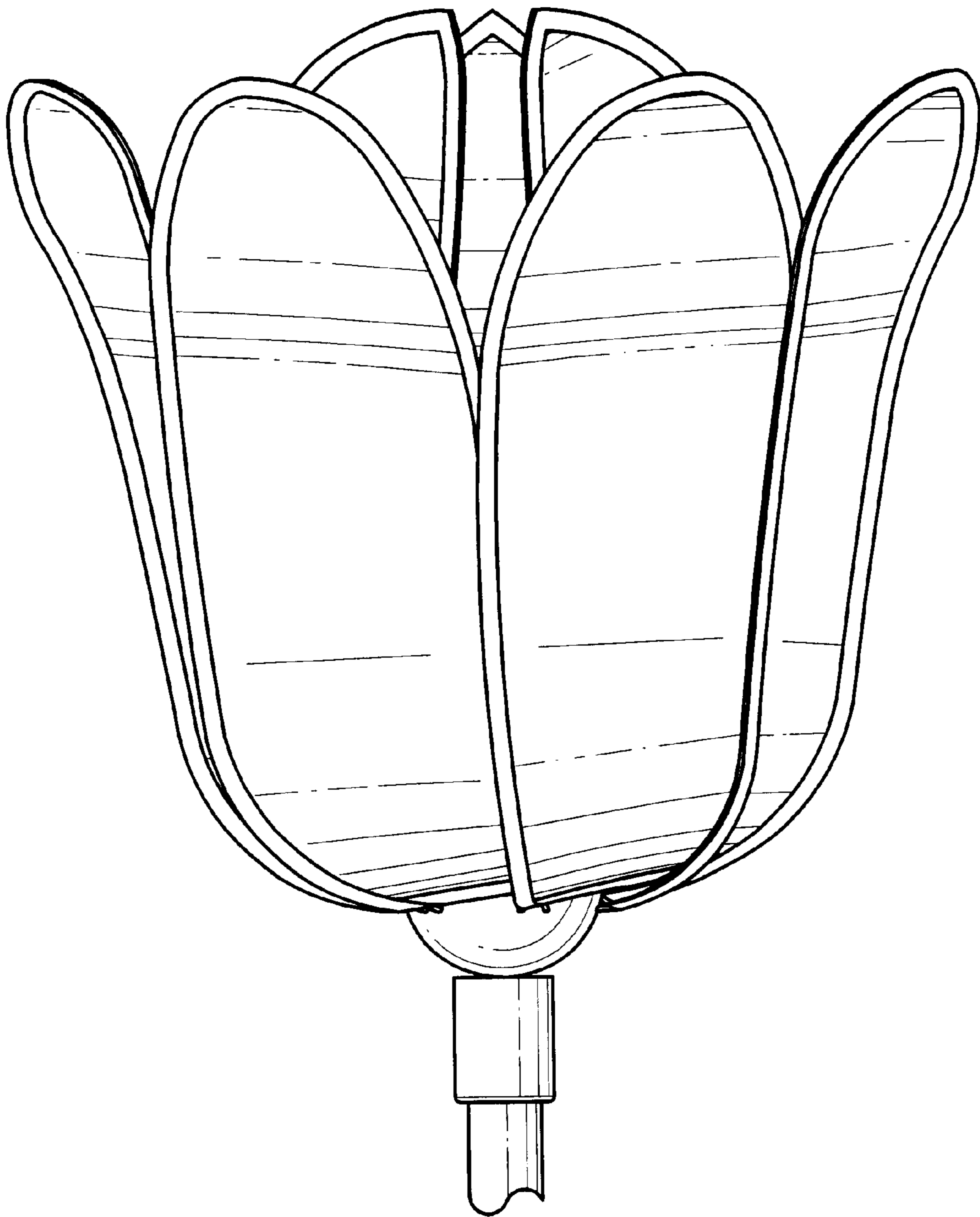

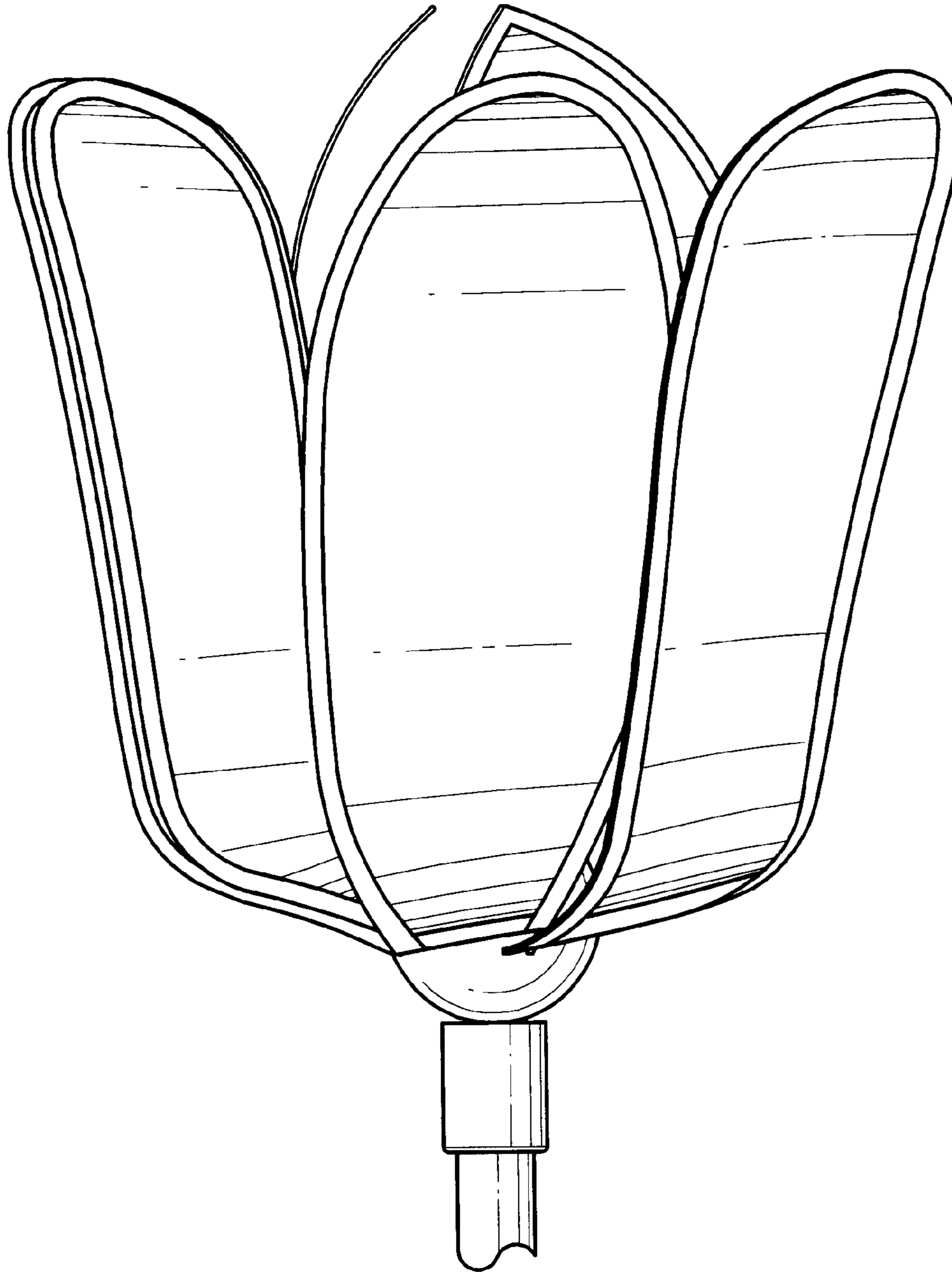
