(57) **CLAIM**

I claim the ornamental design for a writing instrument, as  
shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view showing the design;  
 FIG. 2 is a left-side elevational view of the writing instru-  
 ment of FIG. 1, the right-side elevational view being a  
 mirror image thereof;  
 FIG. 3 is a front elevational view of the writing instrument  
 of FIG. 1;  
 FIG. 4 is a rear elevational view of the writing instrument of  
 FIG. 1;  
 FIG. 5 is a top plan view of the writing instrument of FIG.

 FIG. 6 is a bottom plan view of the writing instrument of

 8;

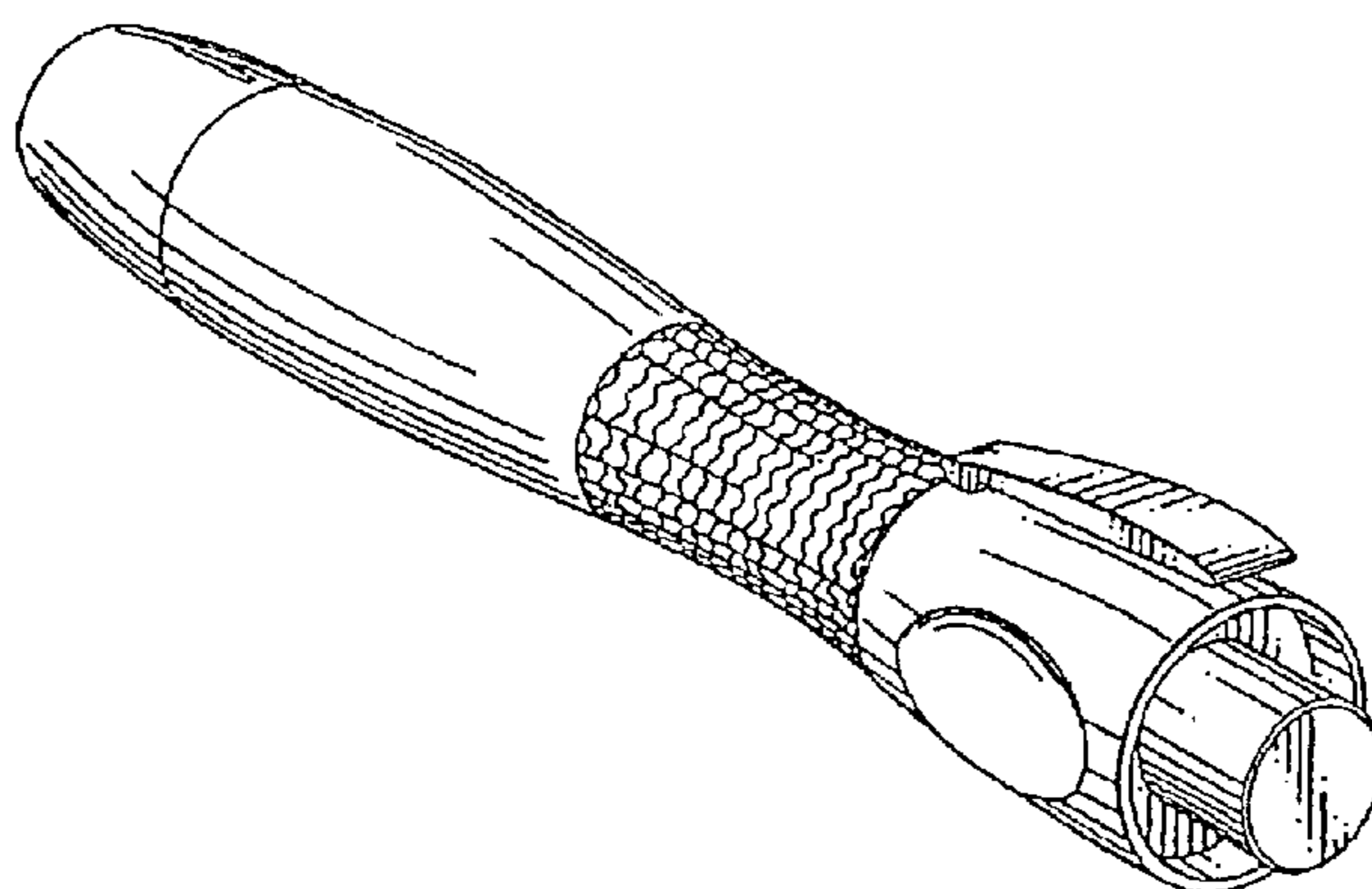


FIG. 13 is a bottom plan view of the writing instrument of FIG. 8;

FIG. 22 is a left-side elevational view of the writing instrument of FIG. 21, the right-side elevational view being a mirror image thereof;

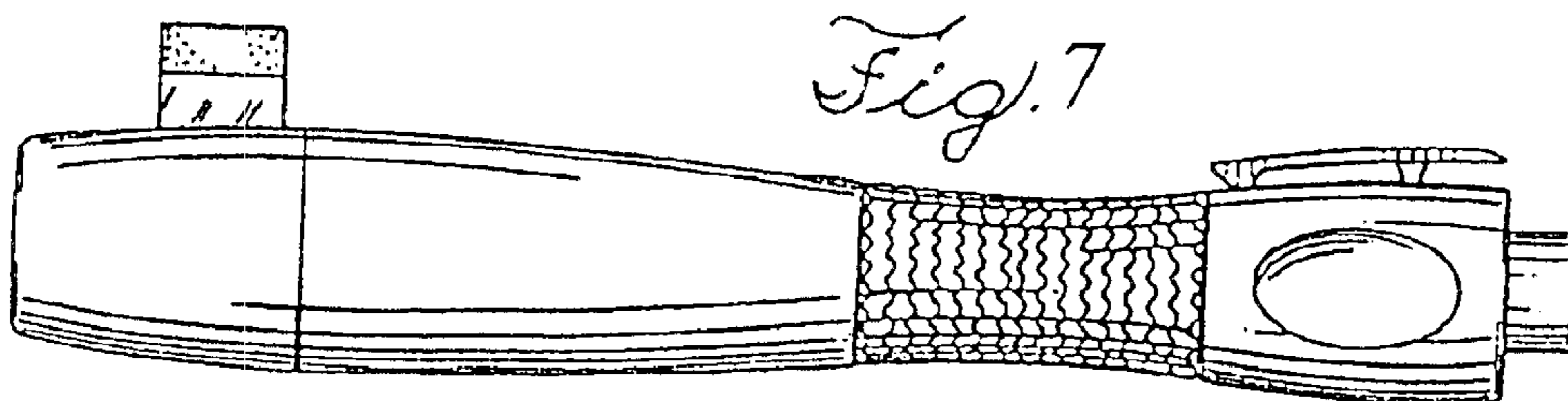
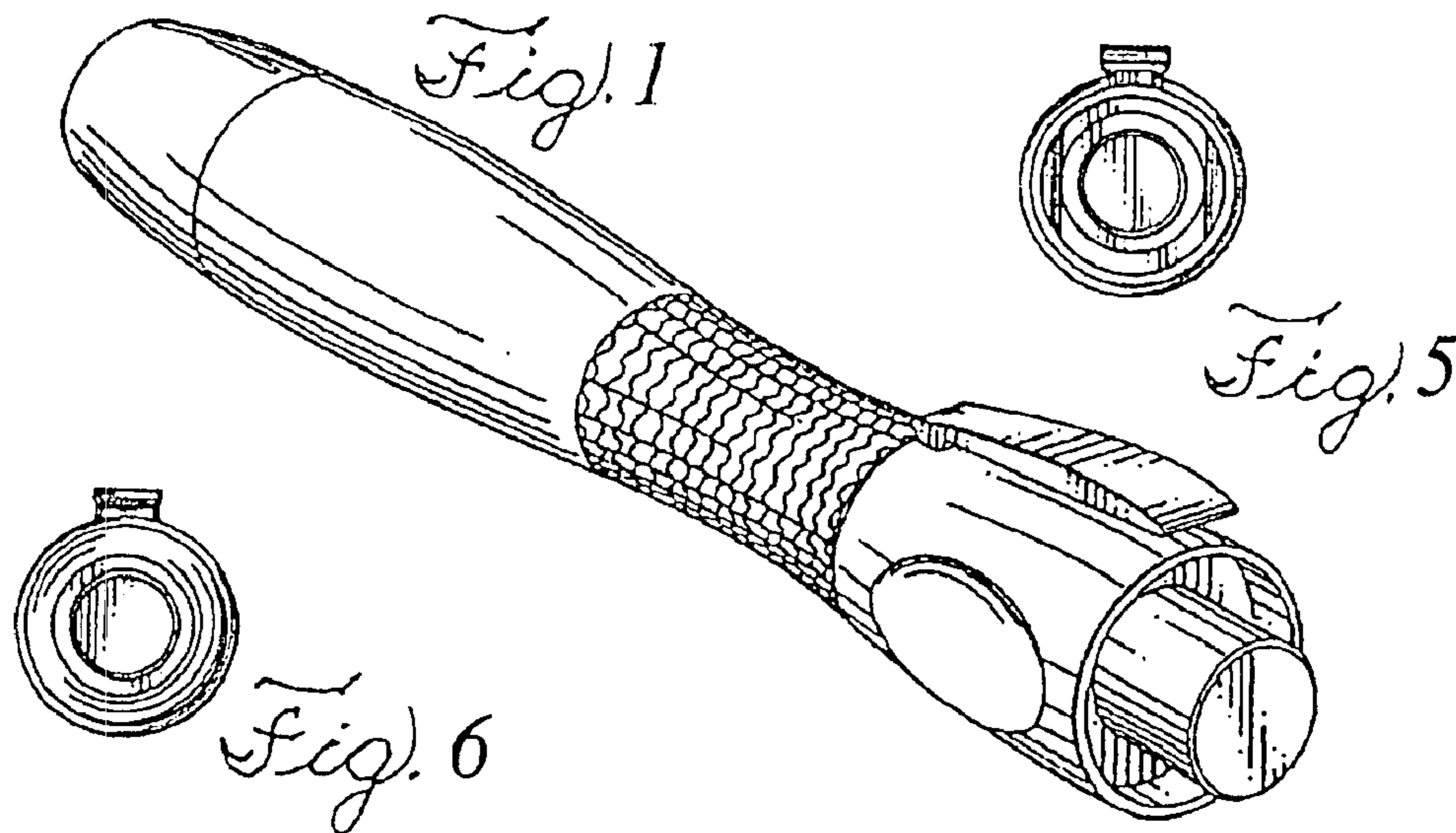
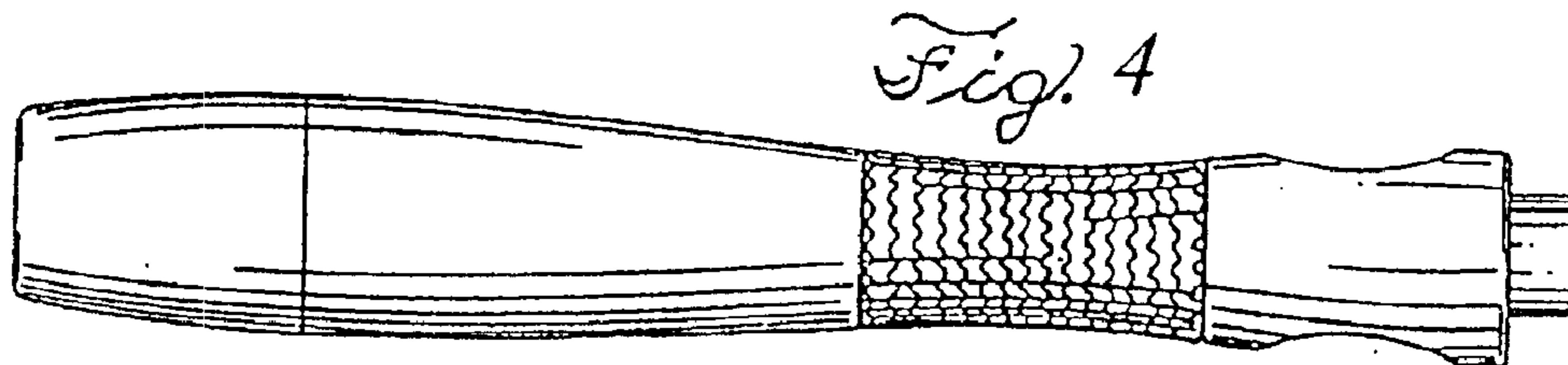
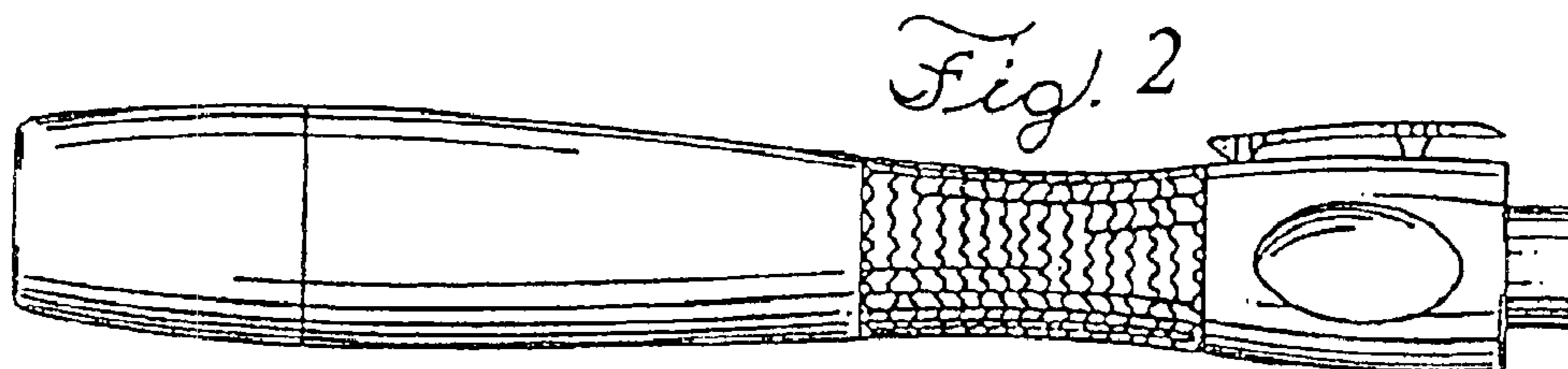
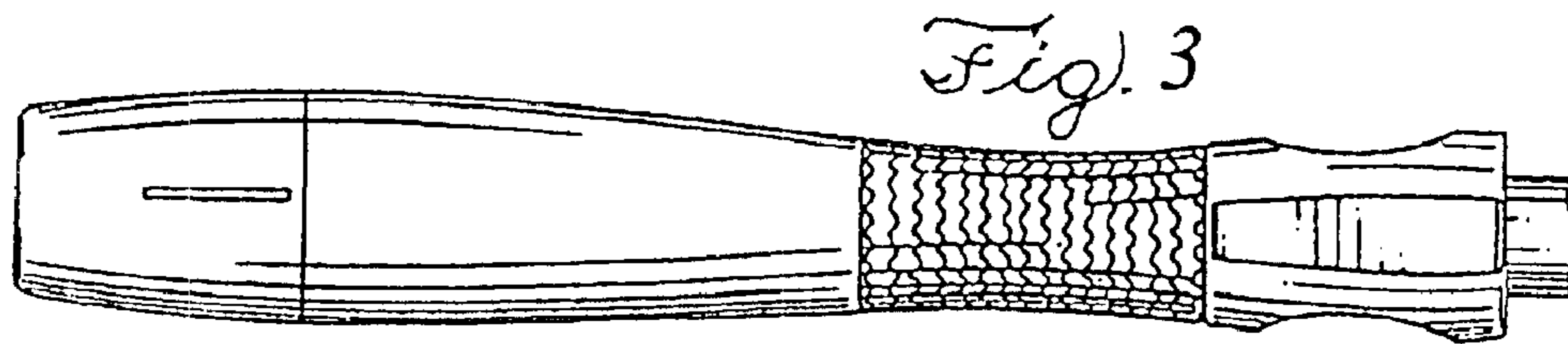
FIG. 23 is a rear elevational view of the writing instrument of FIG. 21;

FIG. 24 is a front elevational view of the writing instrument of FIG. 21;

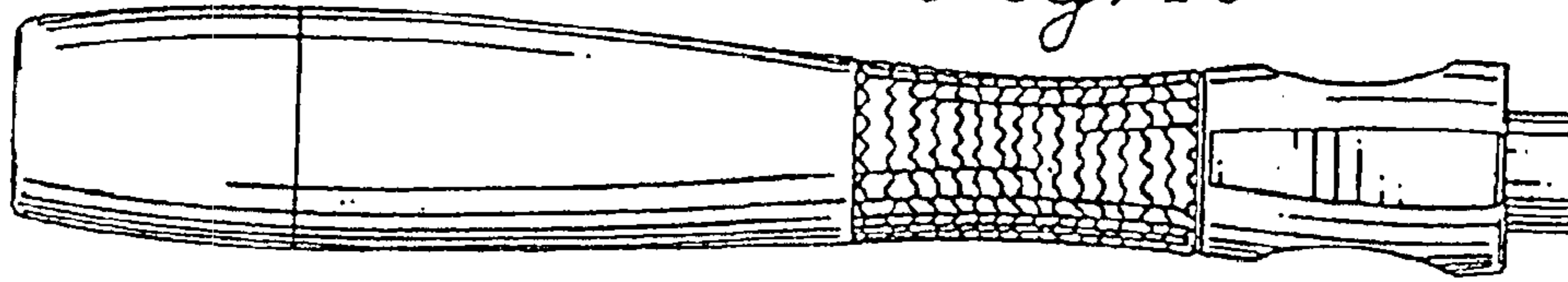
FIG. 25 is a top plan view of the writing instrument of FIG. 21; and,

FIG. 26 is a bottom plan view of the writing instrument of FIG. 21.

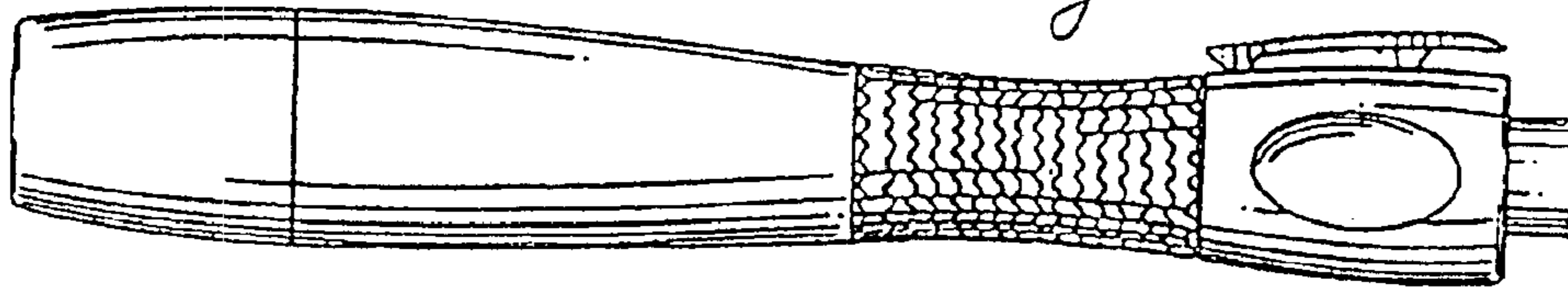

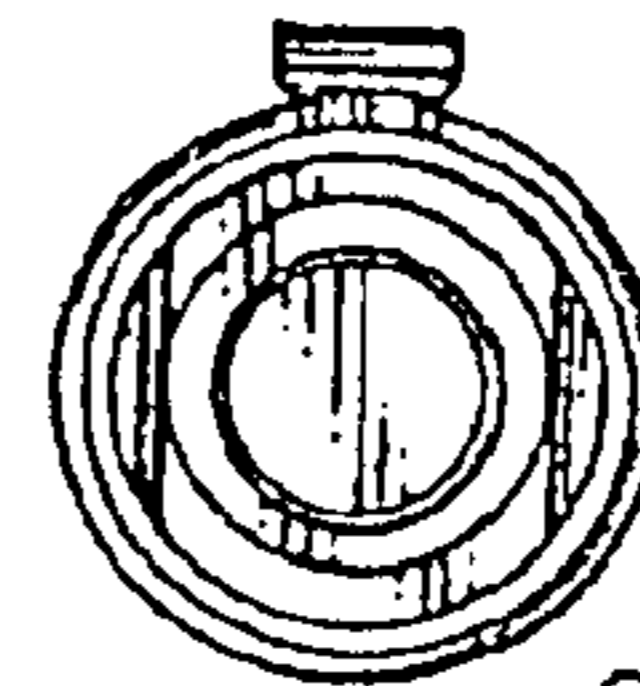
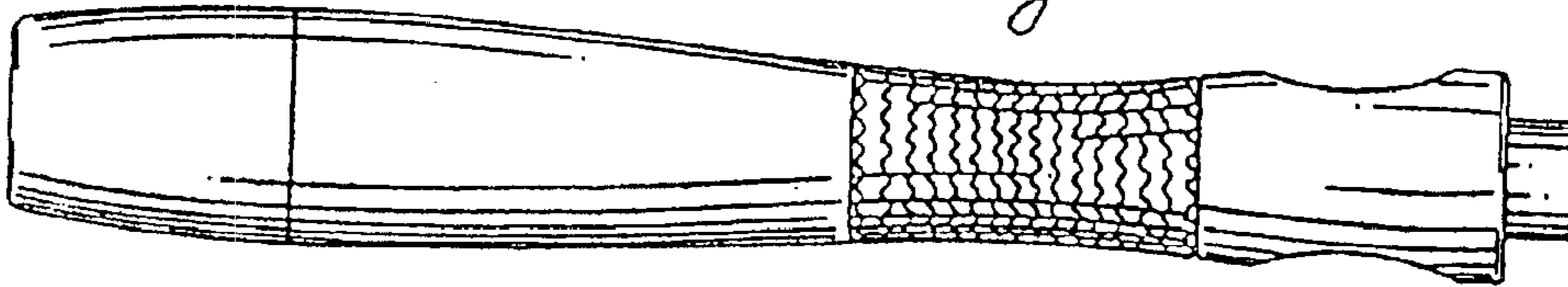

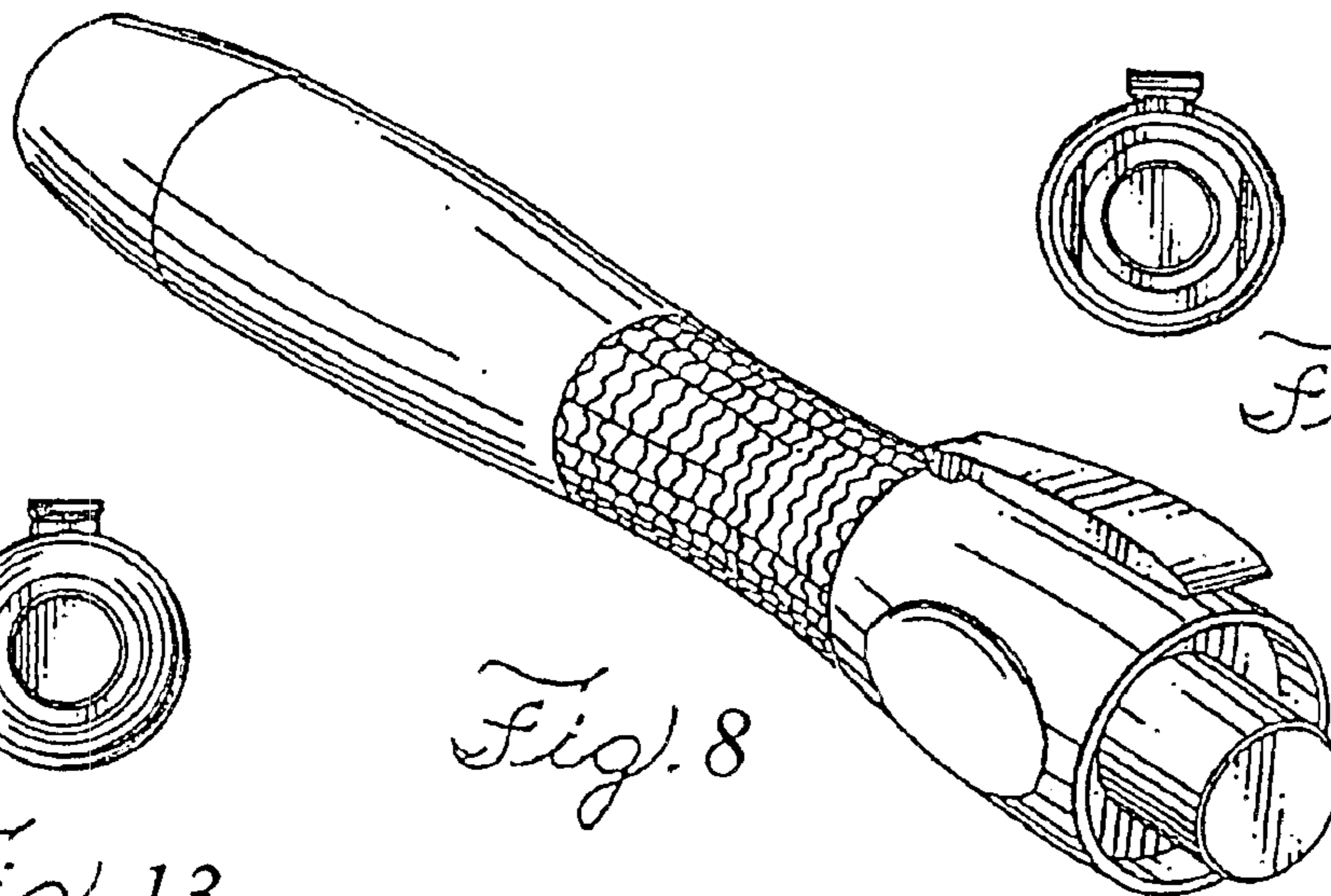

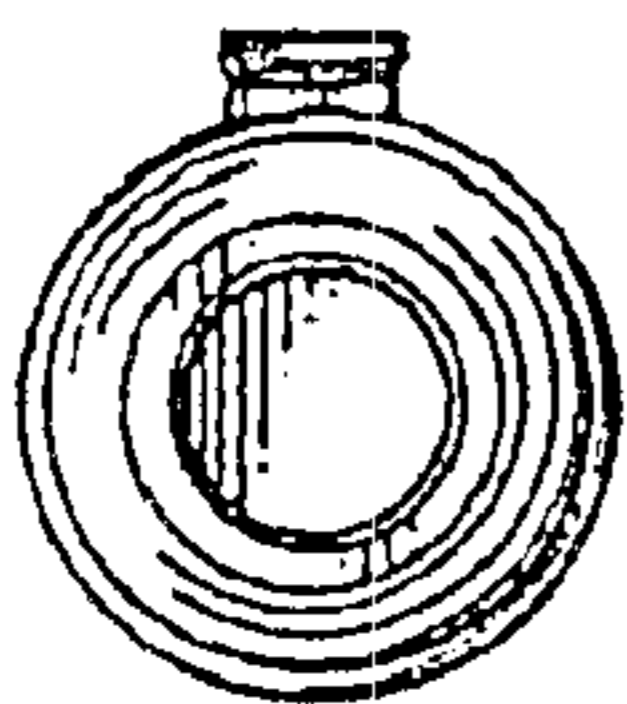

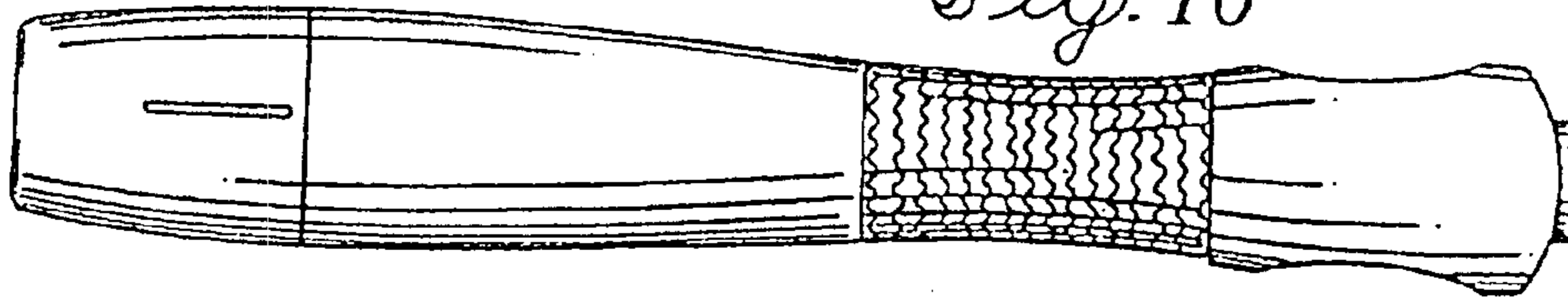

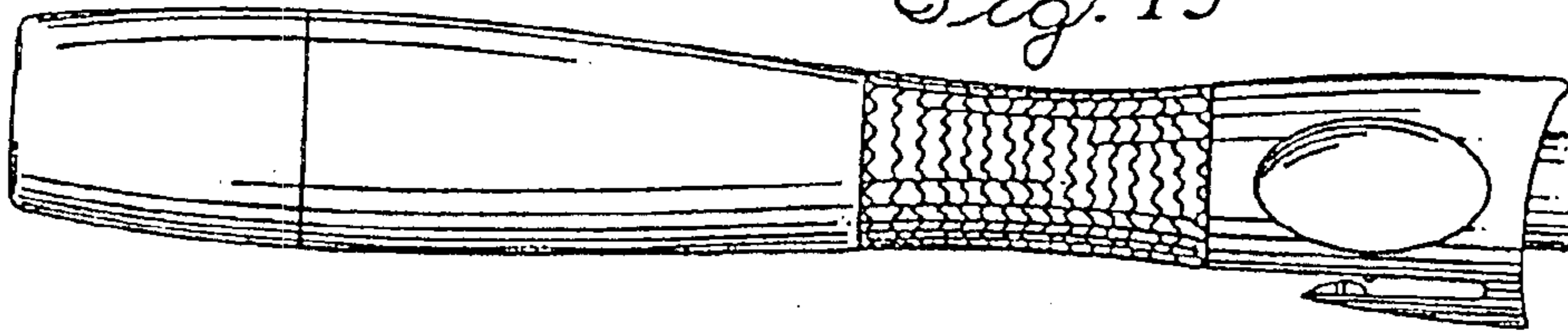

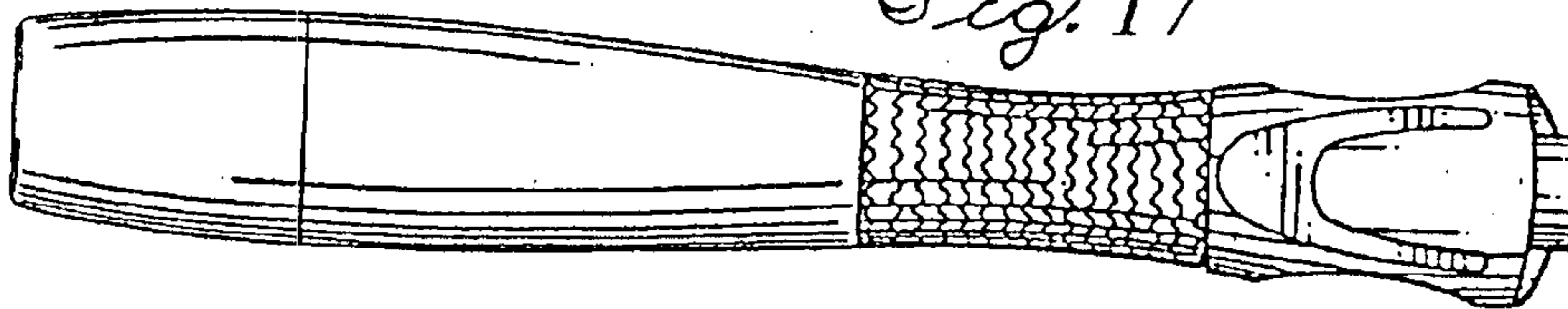

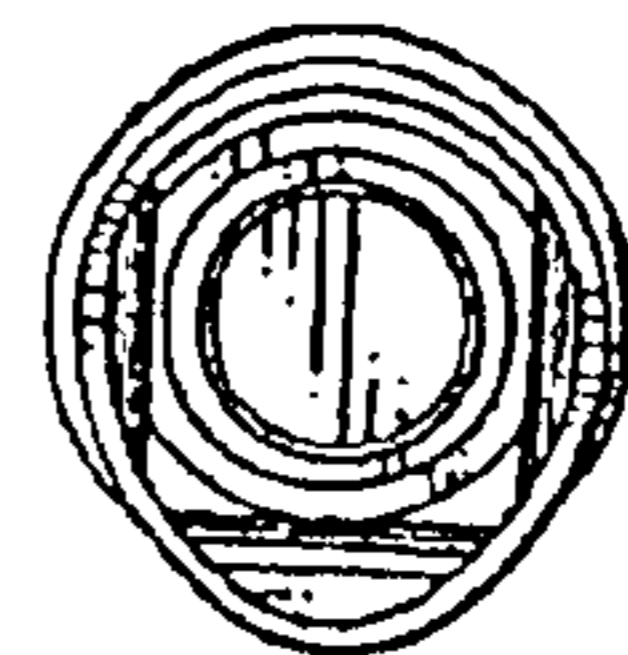
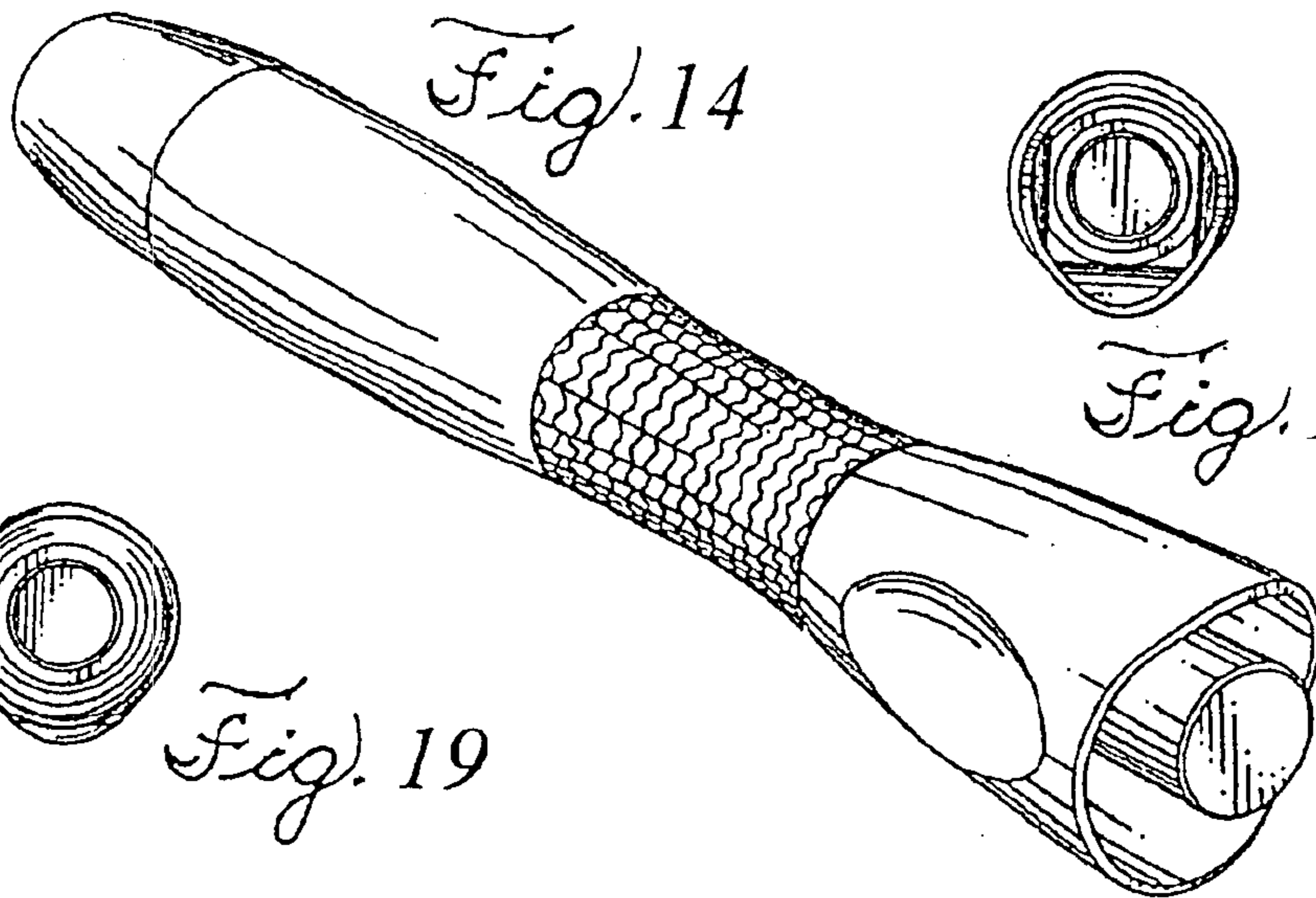

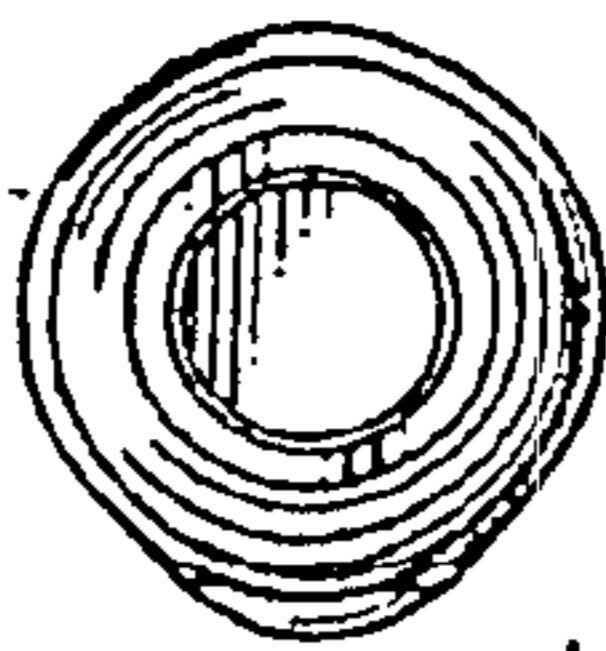

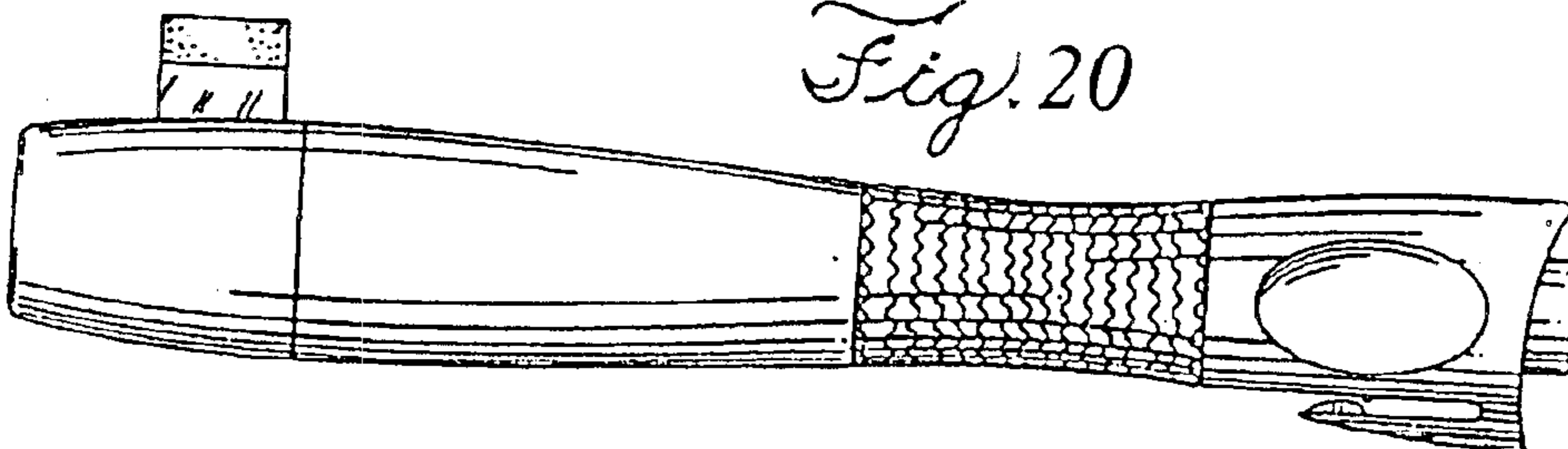

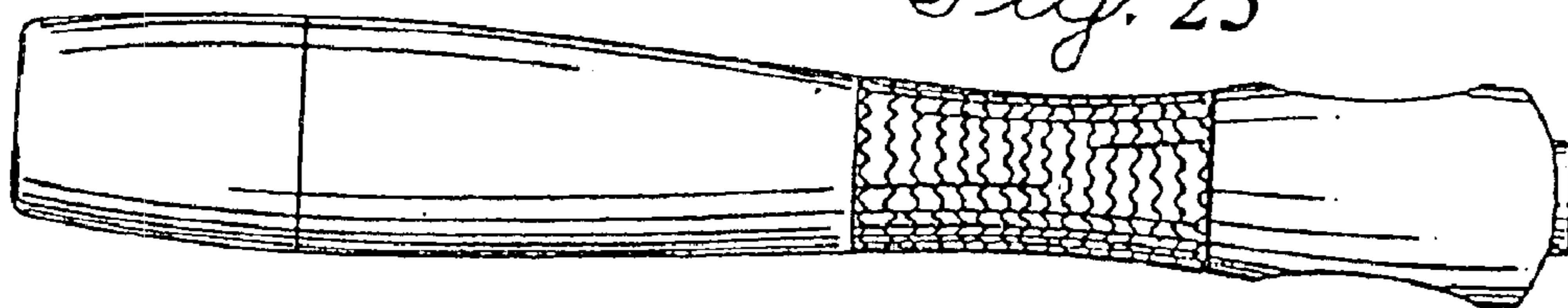

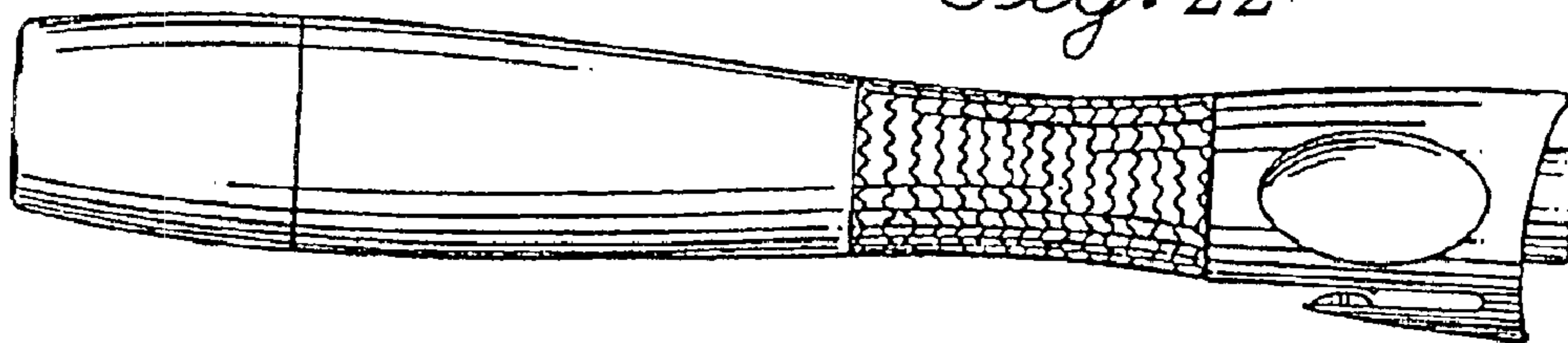

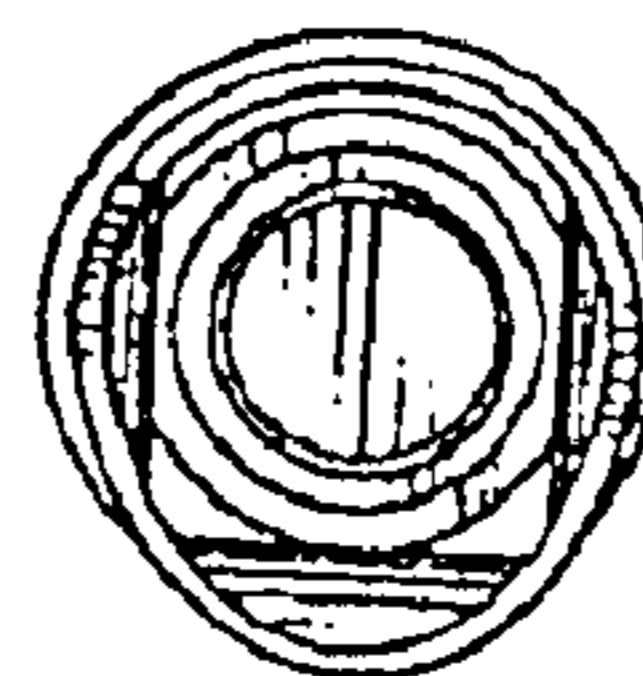
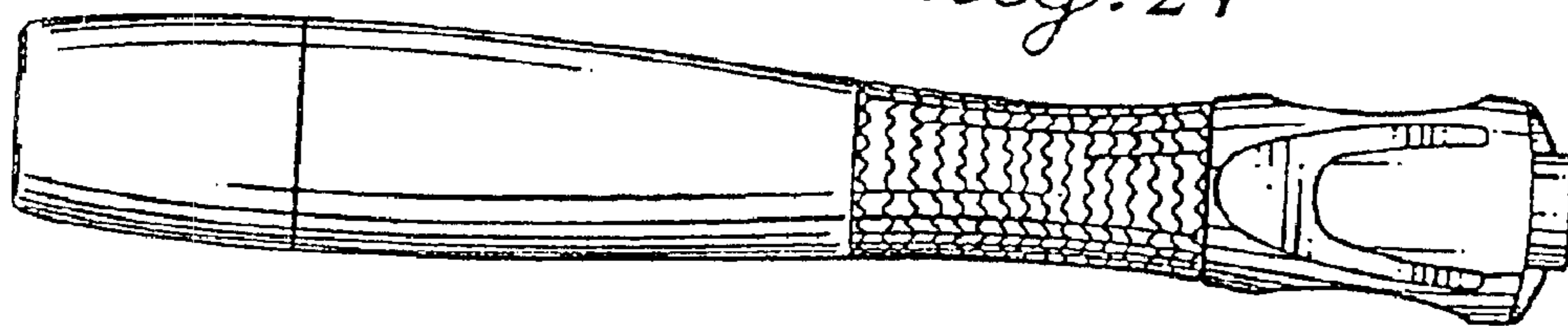

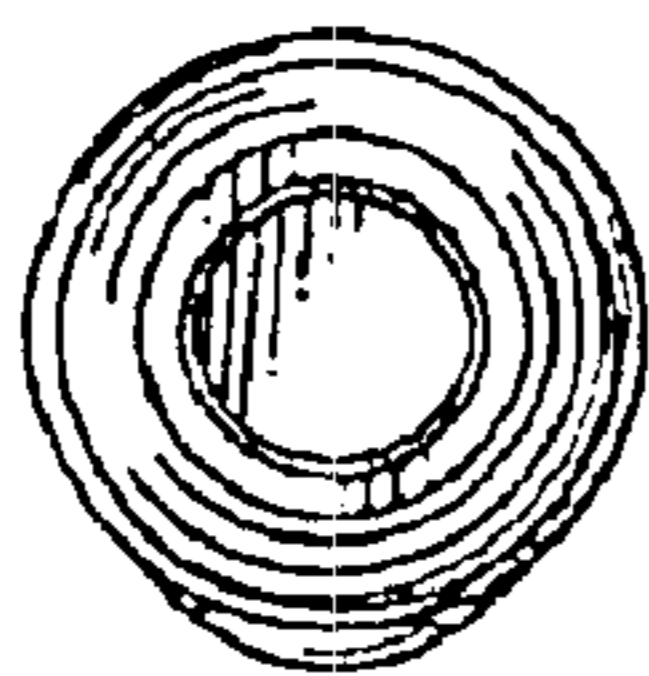
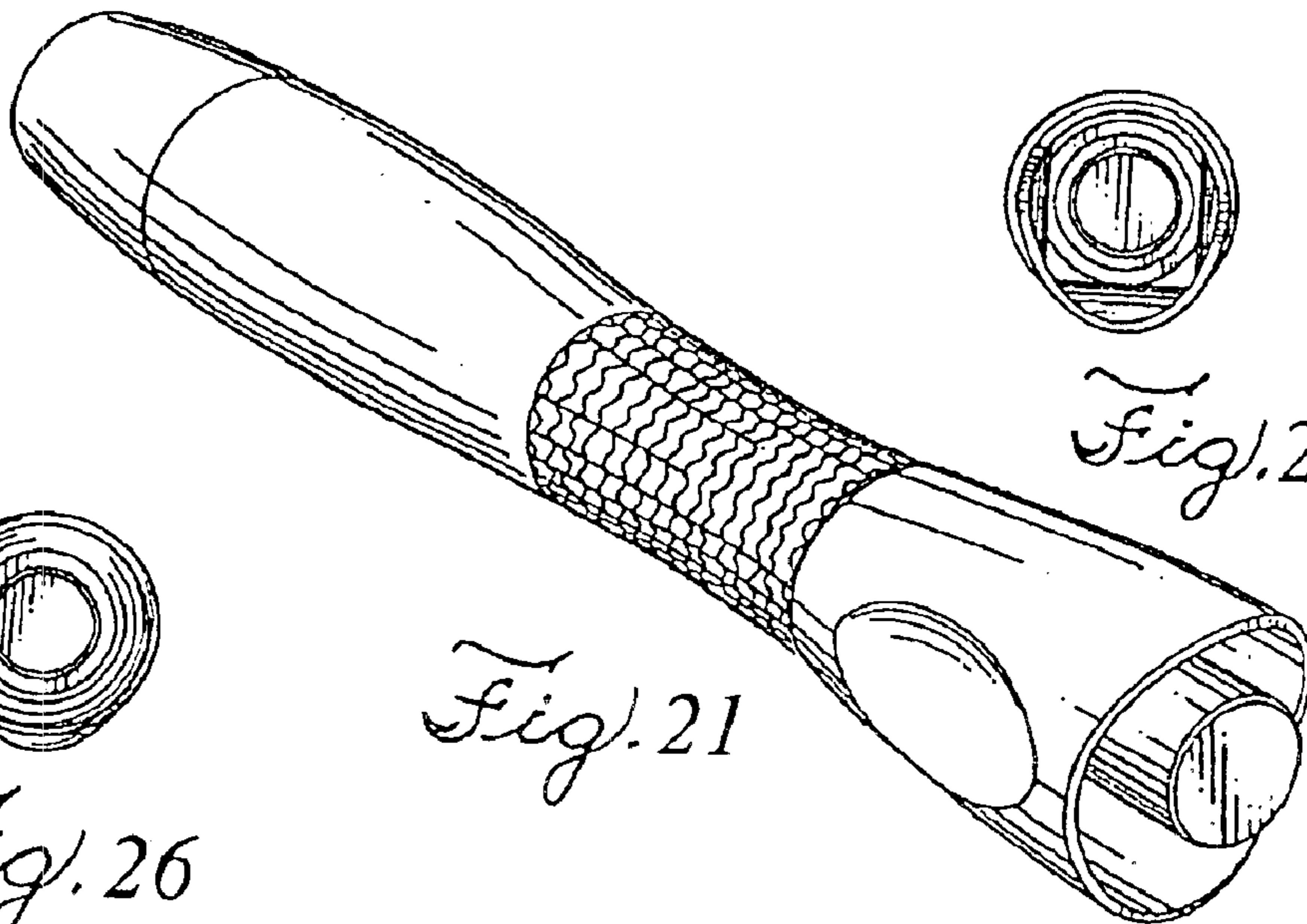
