DESCRIPTION

FIG. 1 is a perspective view taken from the front, side and above showing a first embodiment of our new design;

FIG. 4 is a top plan view thereof;

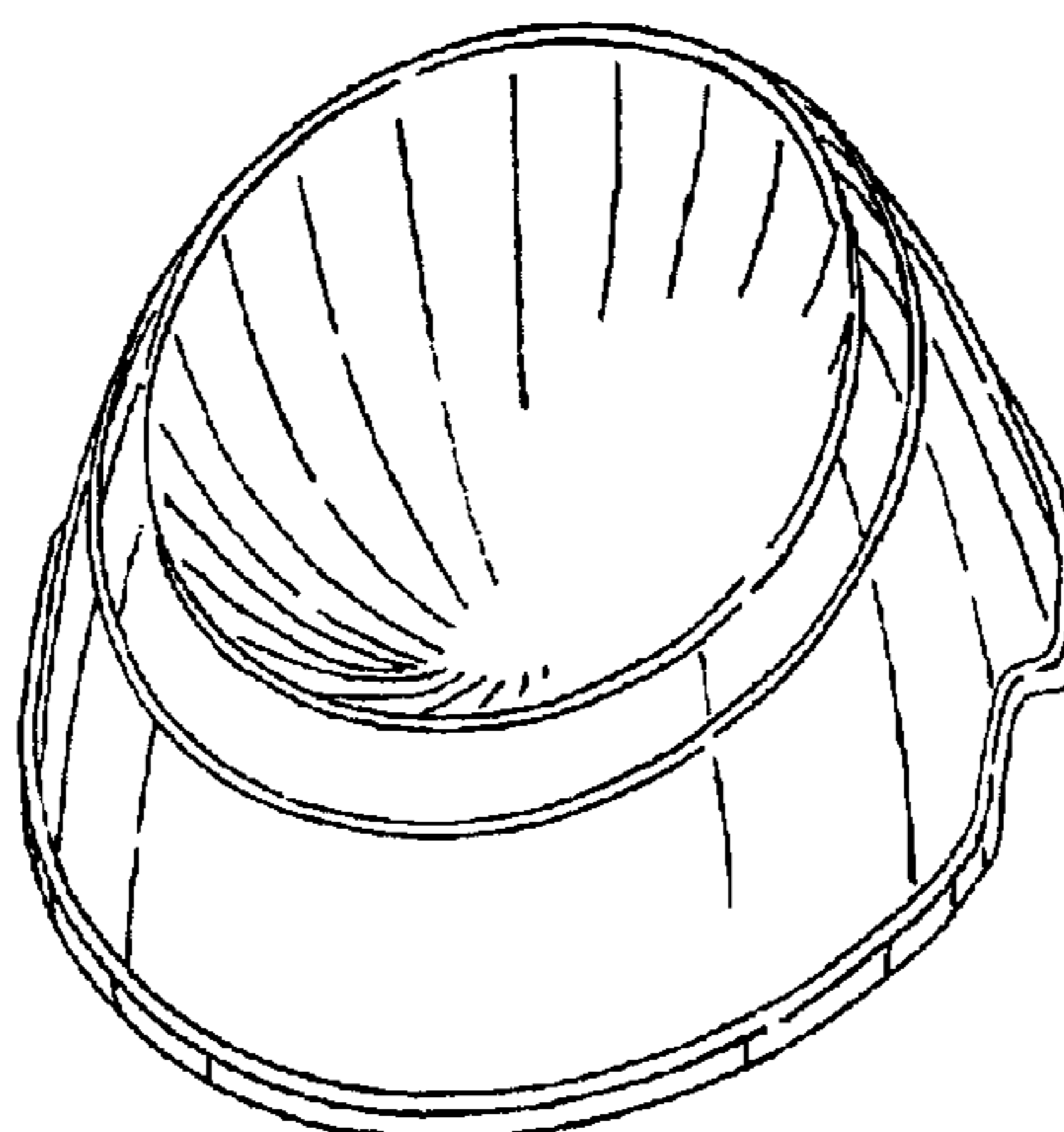
FIG. 5 is a bottom plan view thereof;

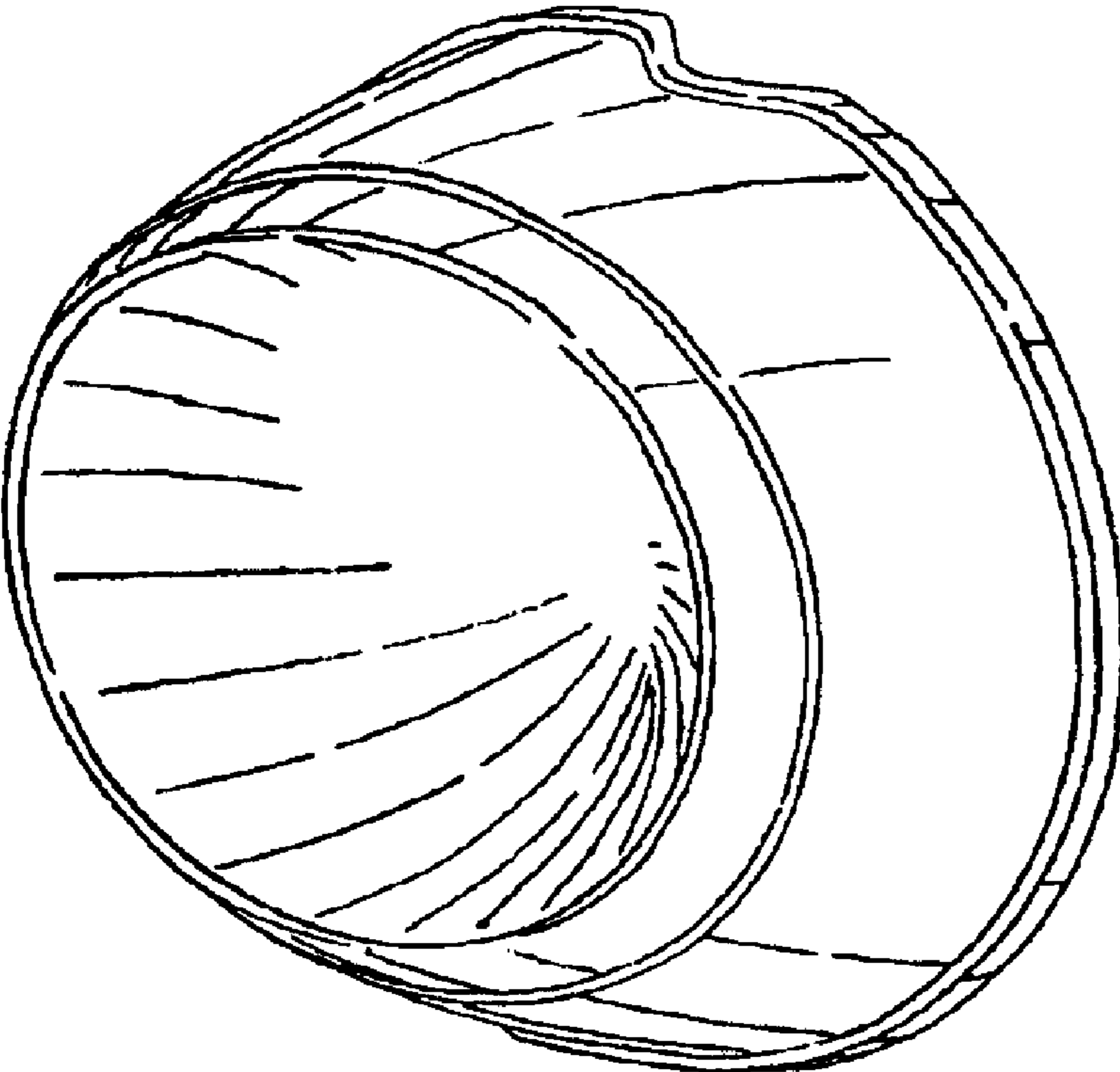

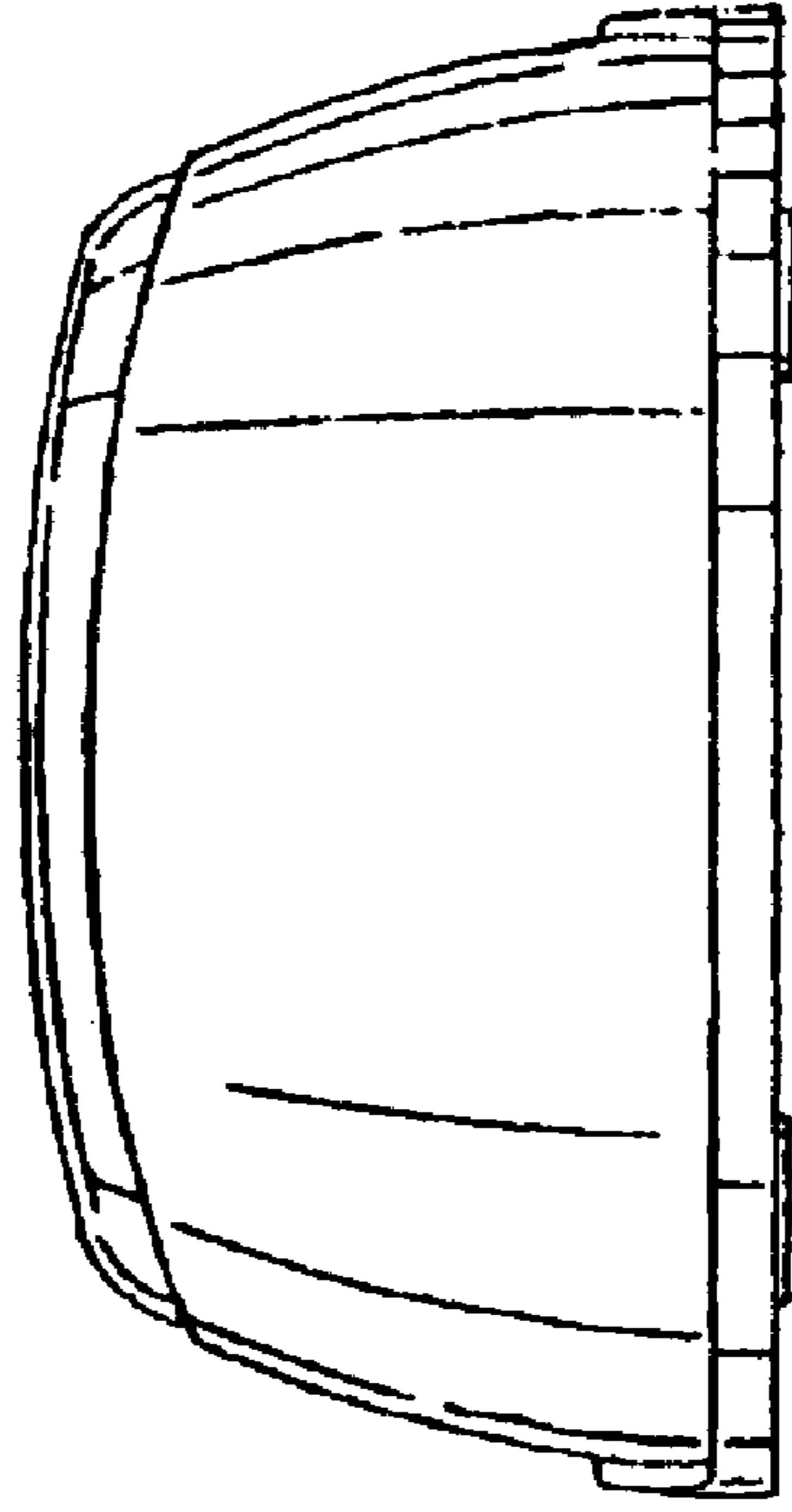

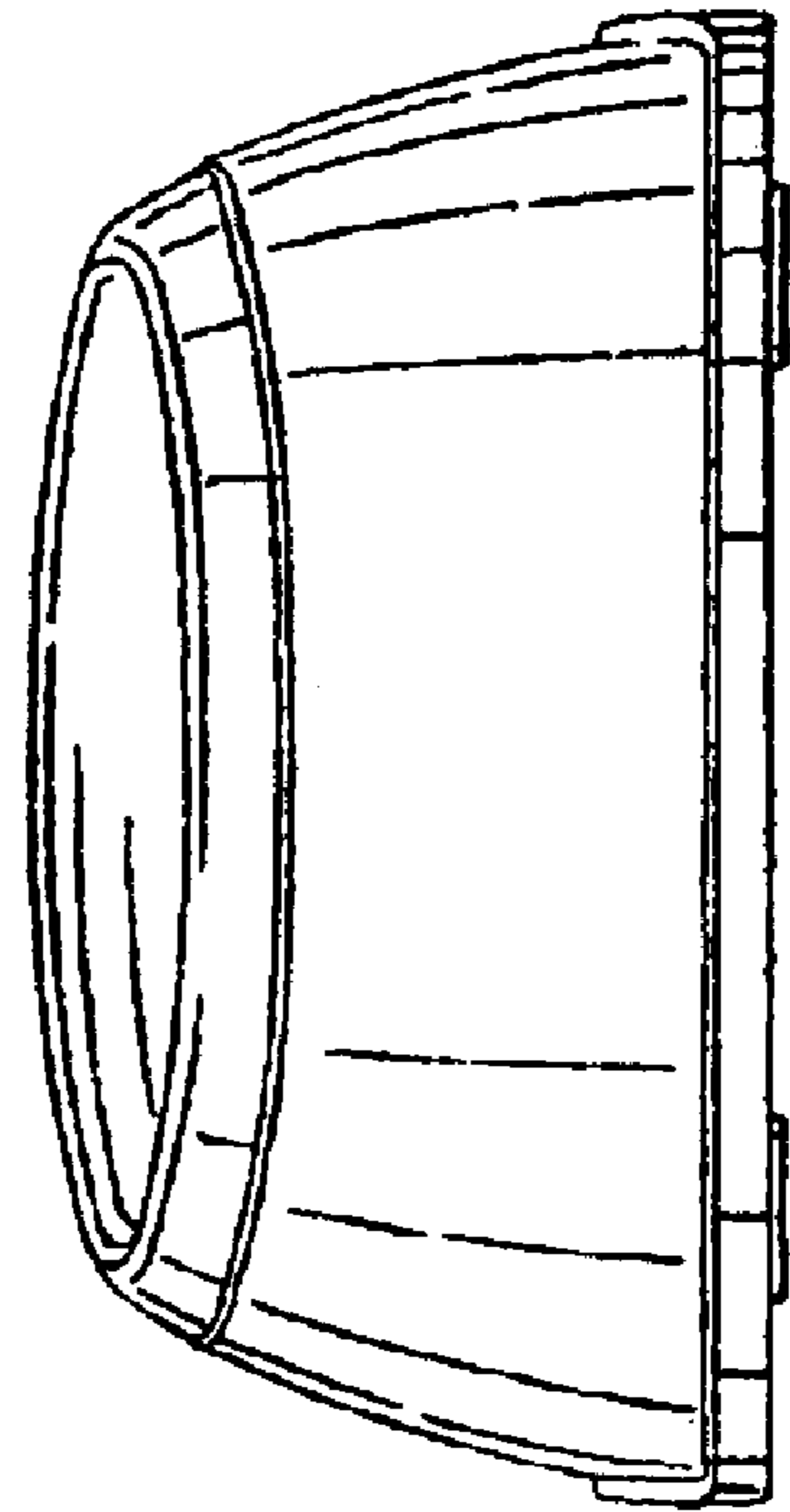

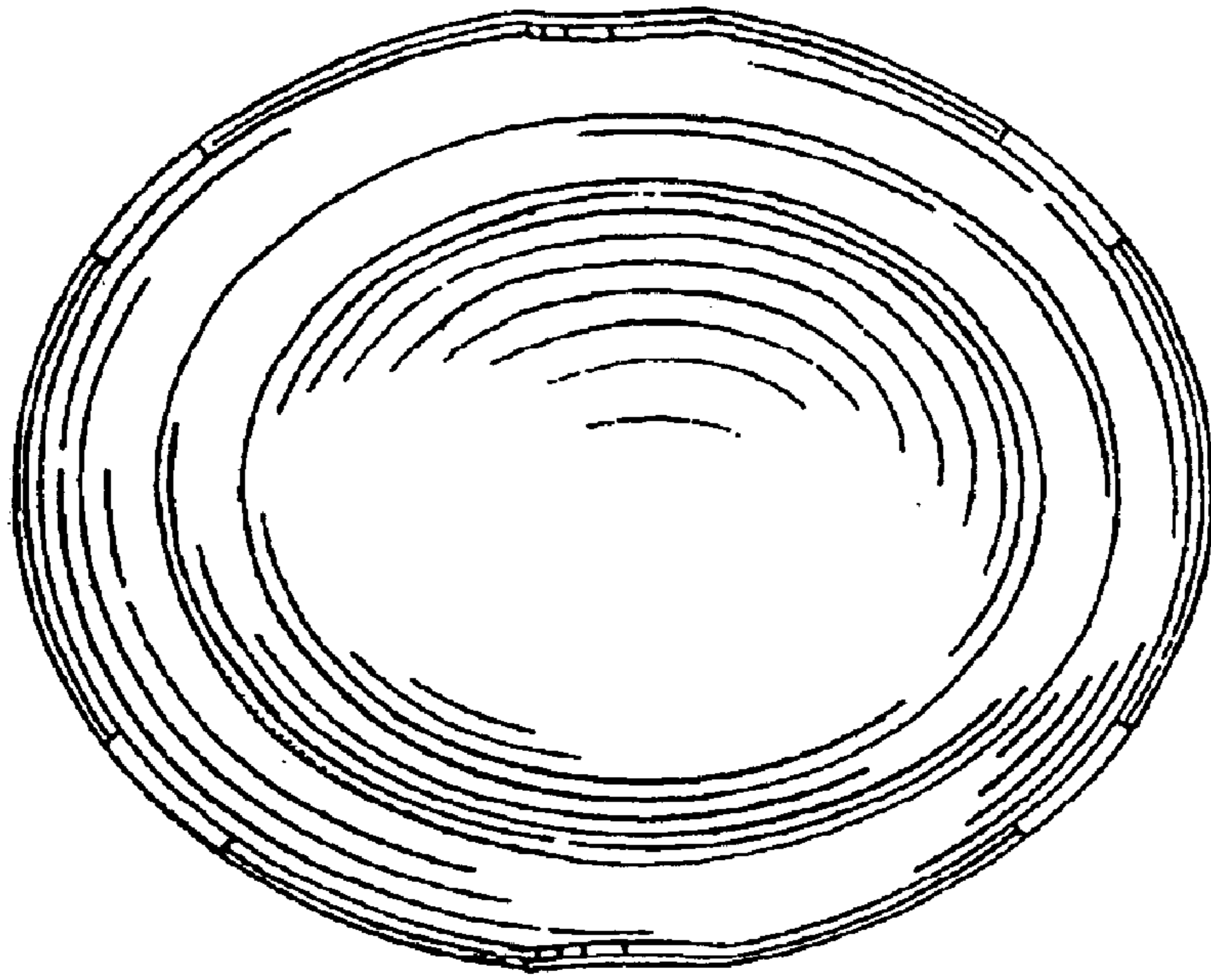

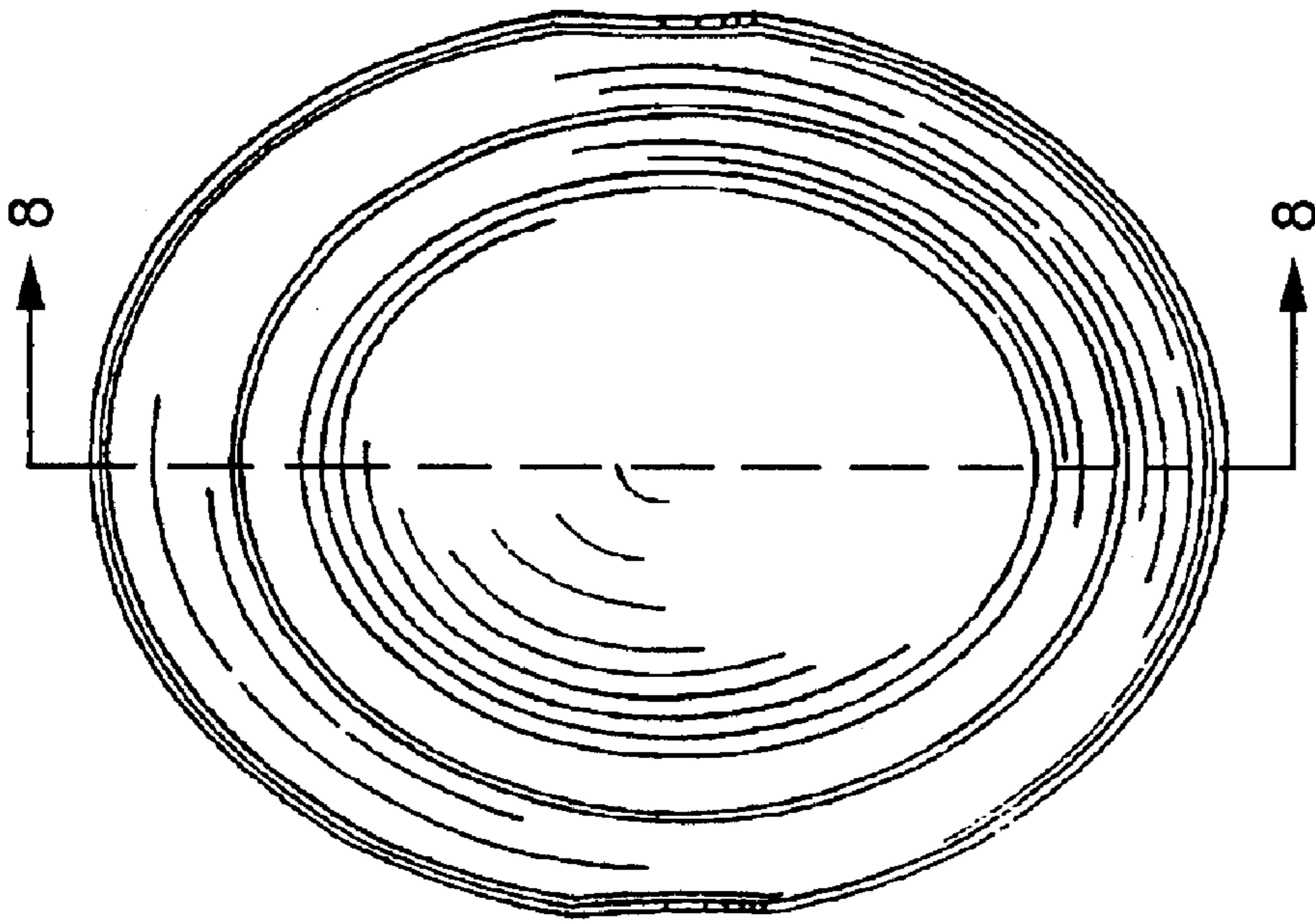

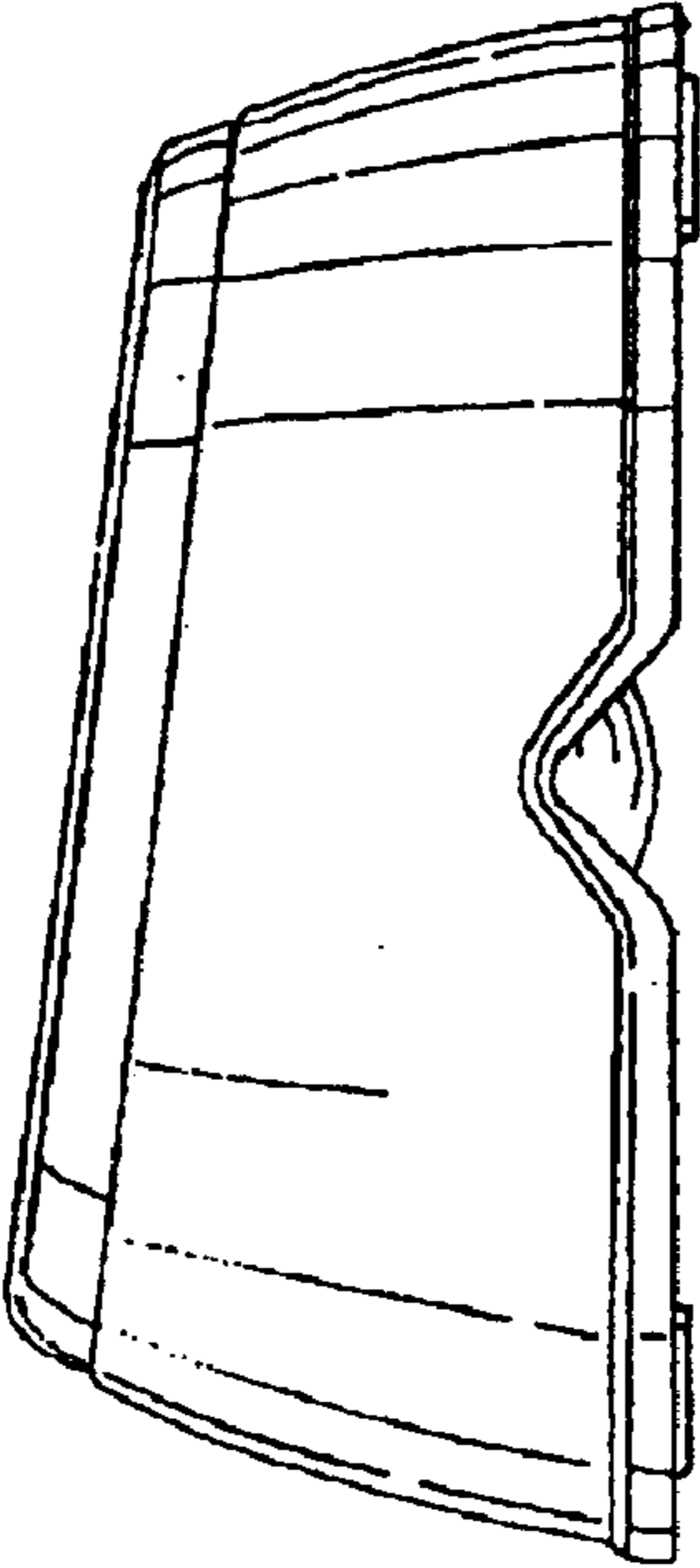

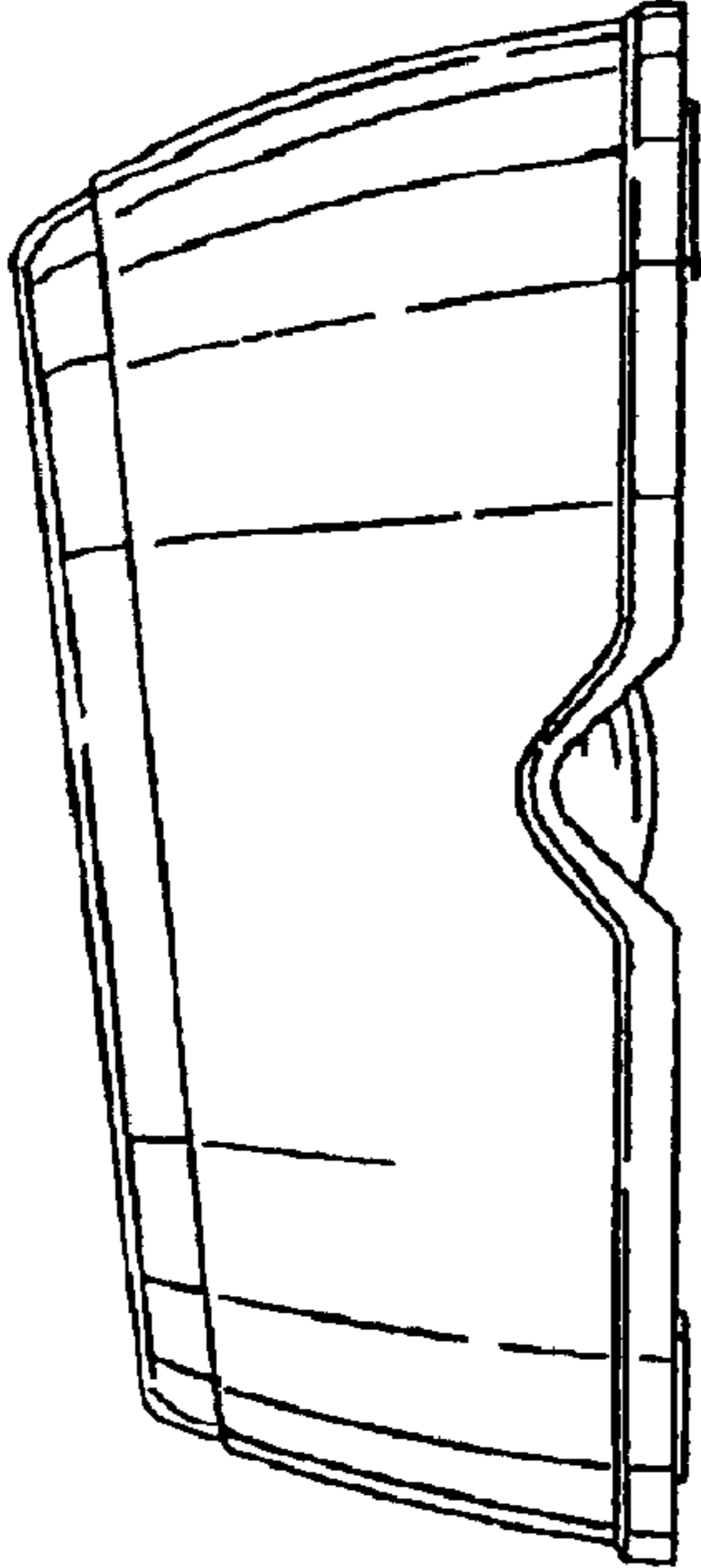

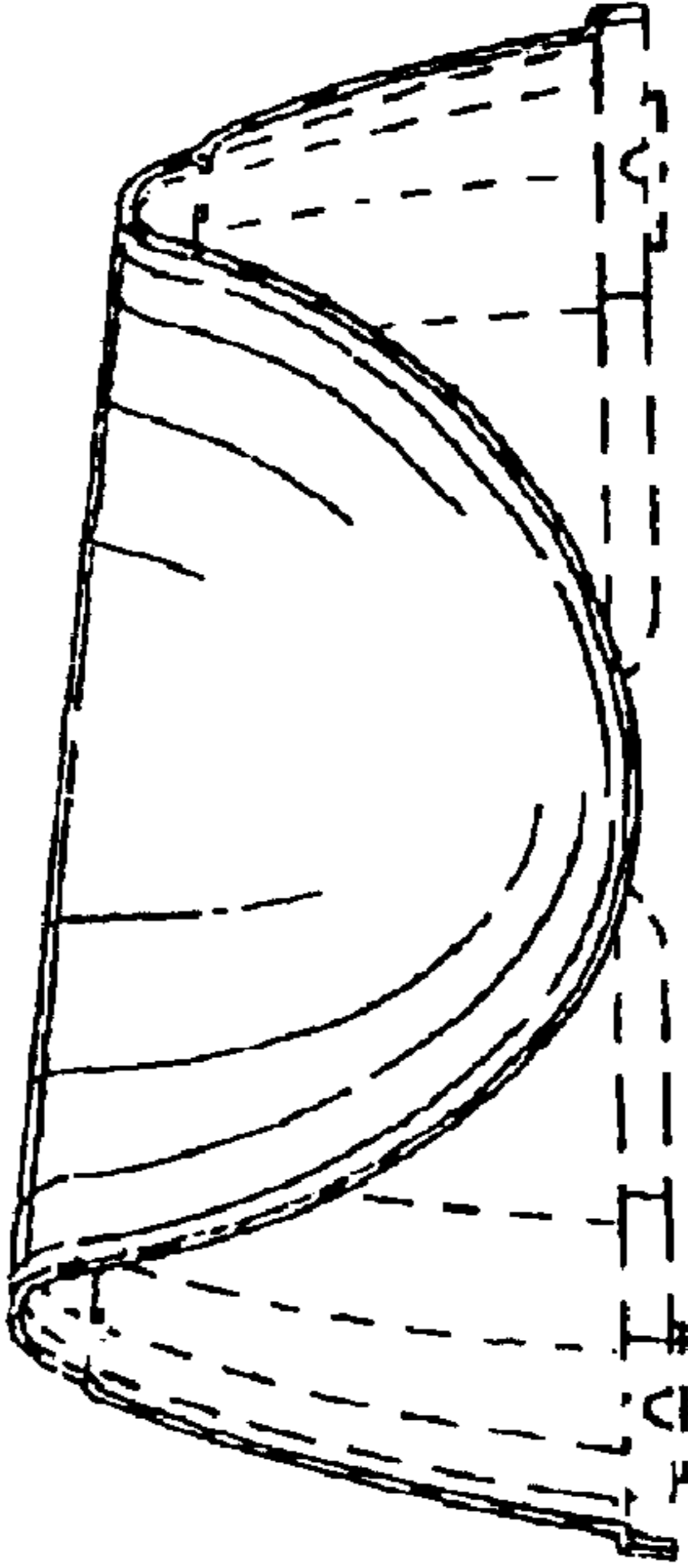
