DESCRIPTION

FIG. 10 is a rear elevational view thereof;

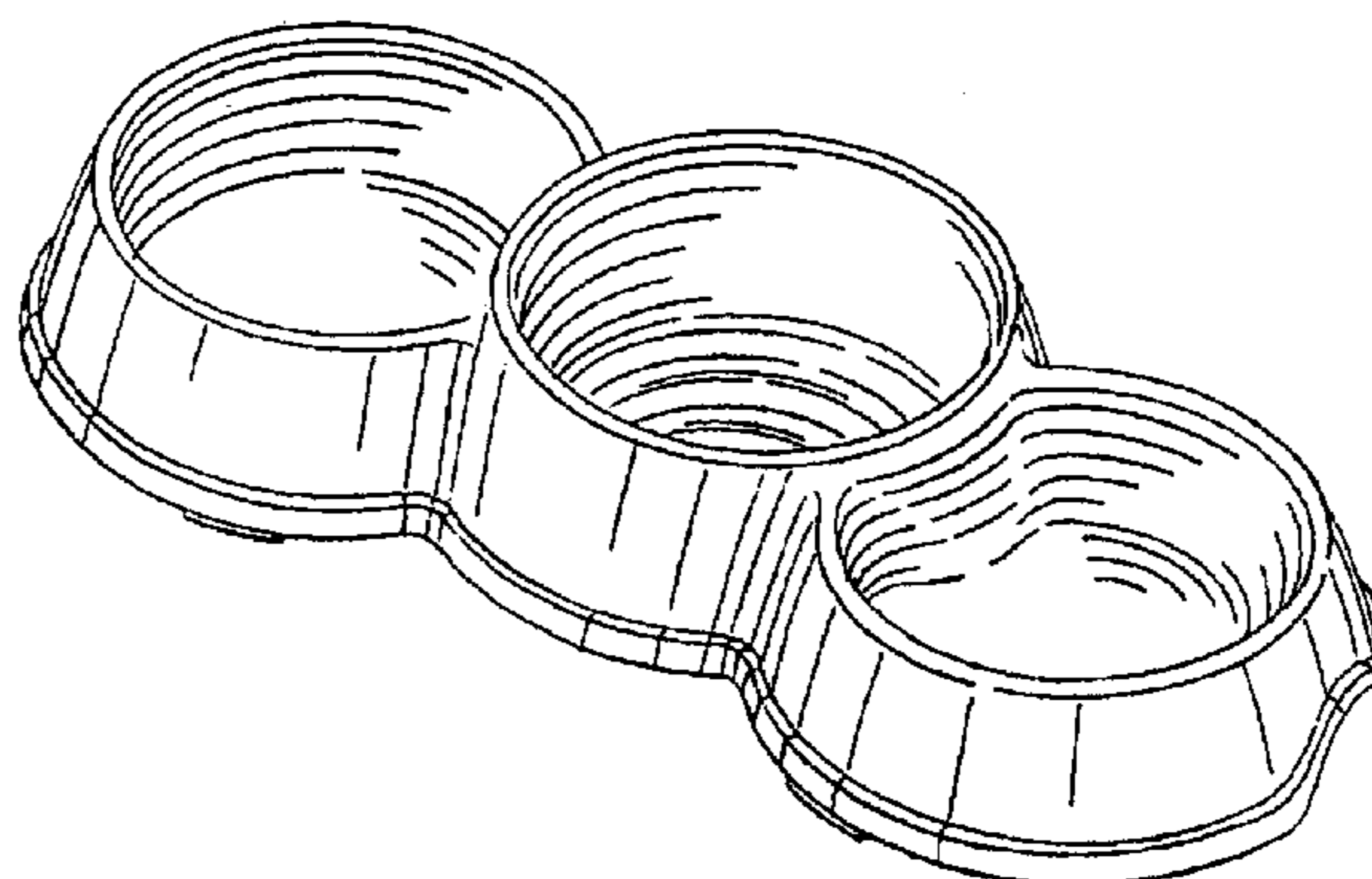
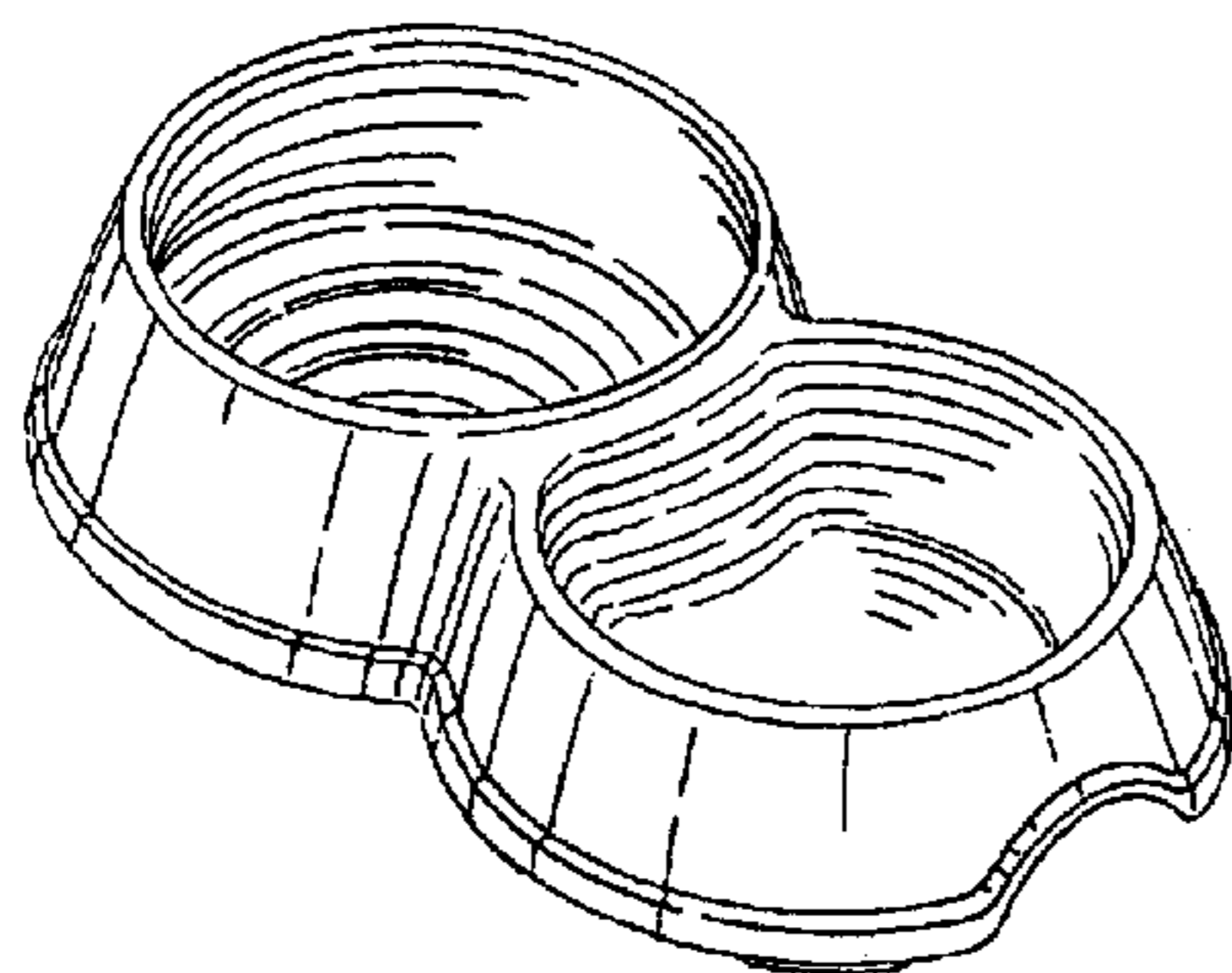
FIG. 11 is a top plan view thereof;

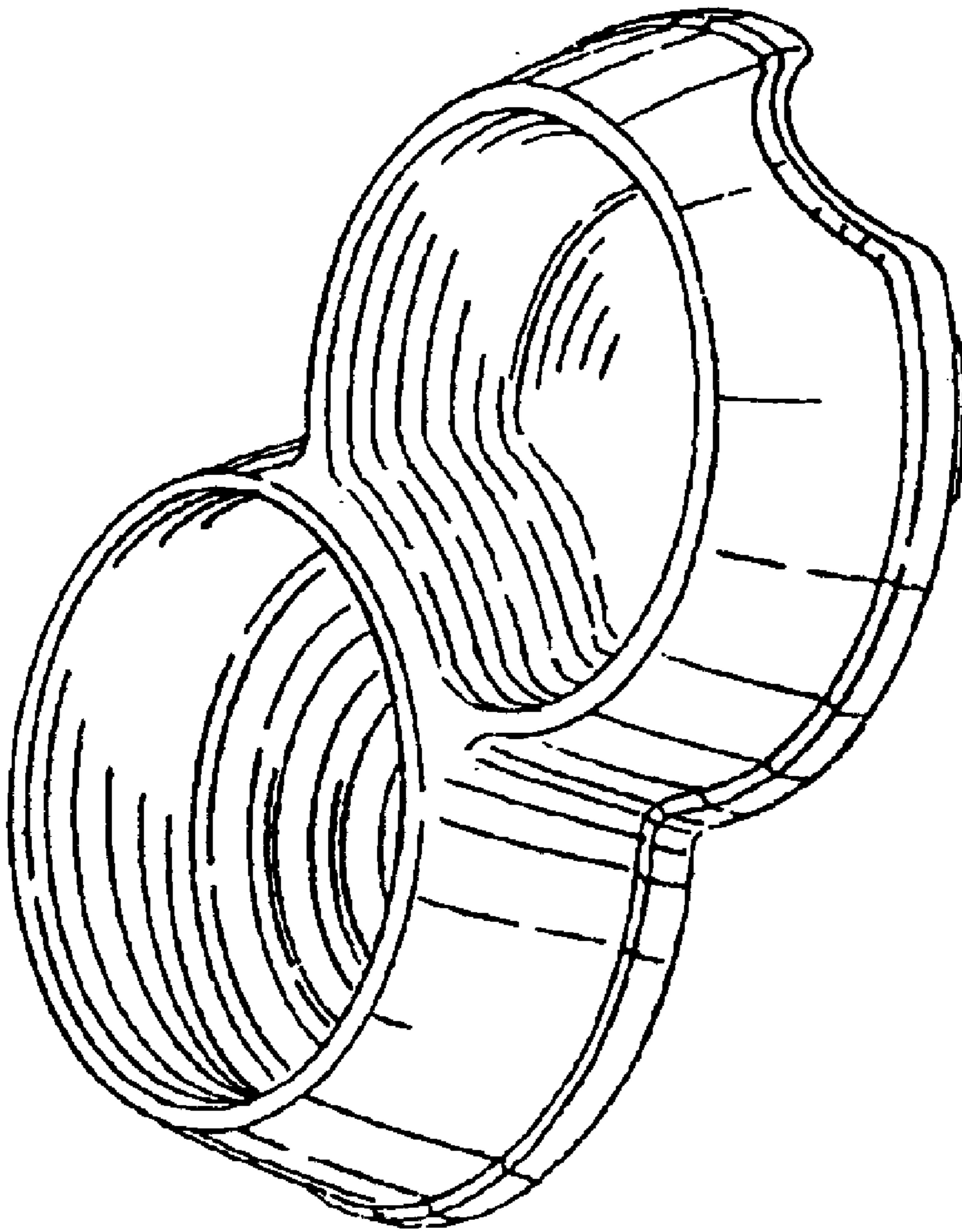

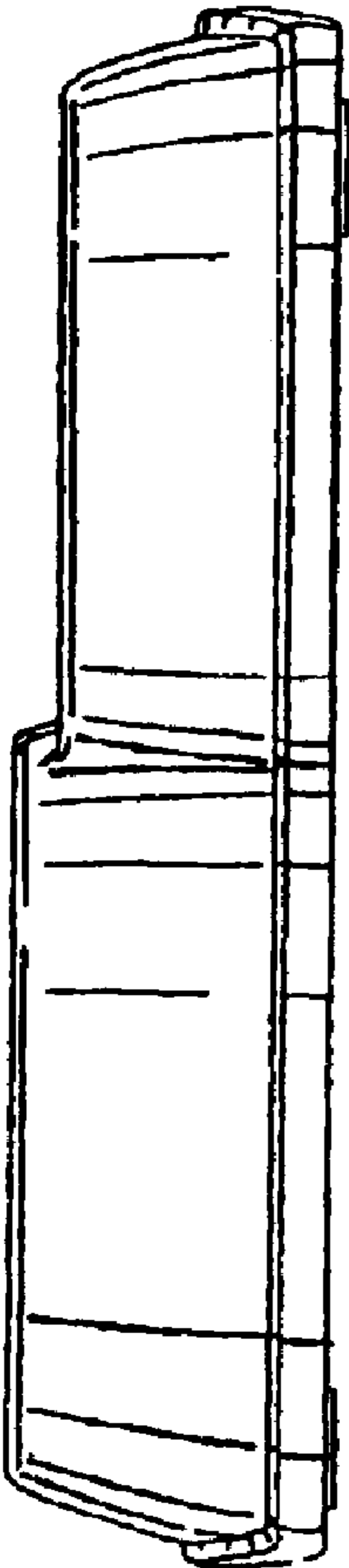

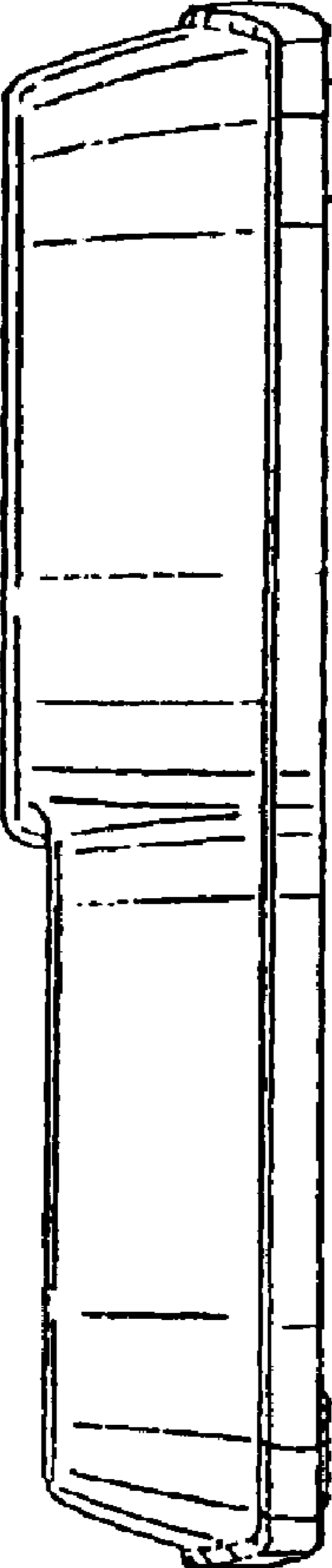

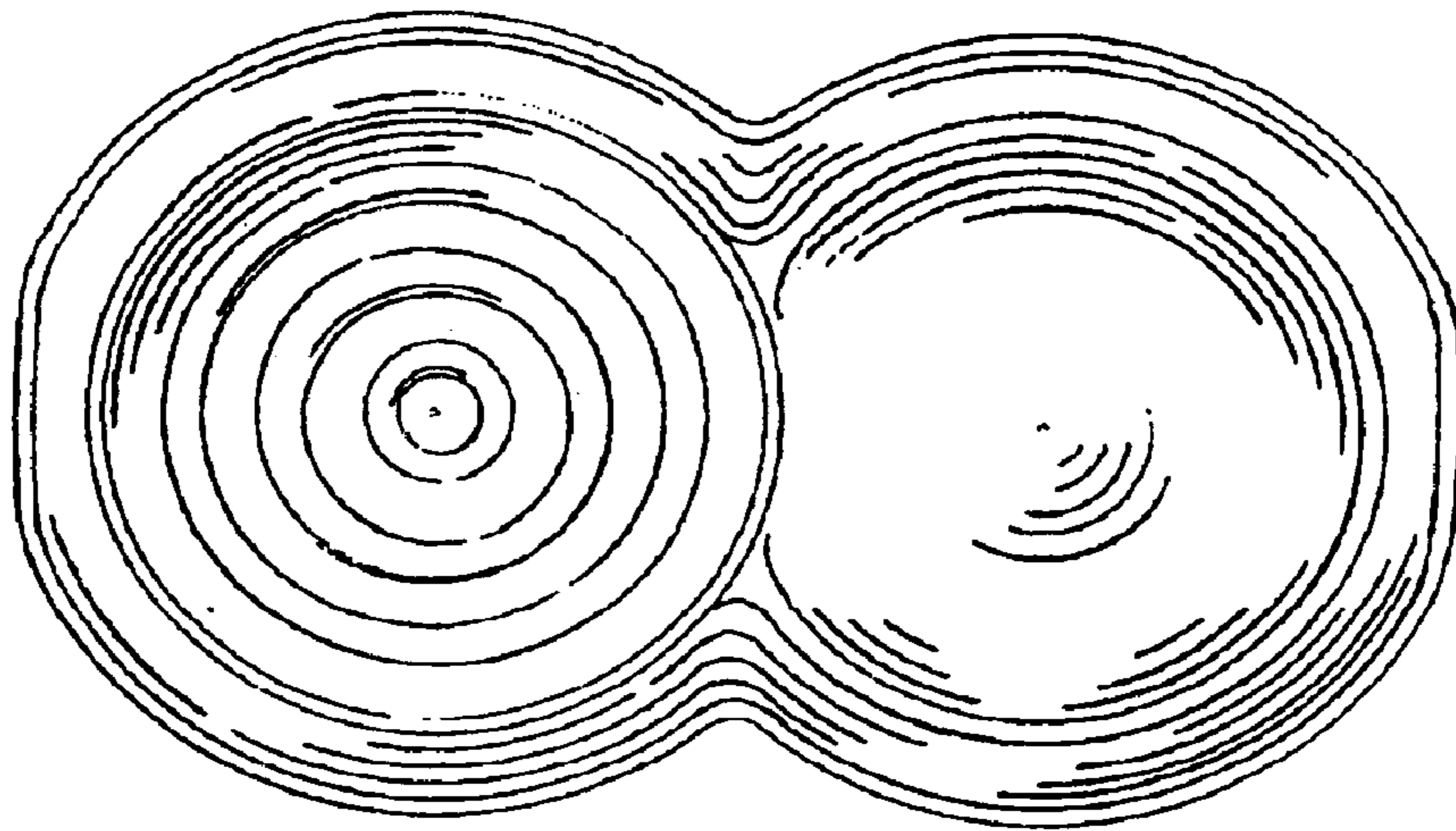

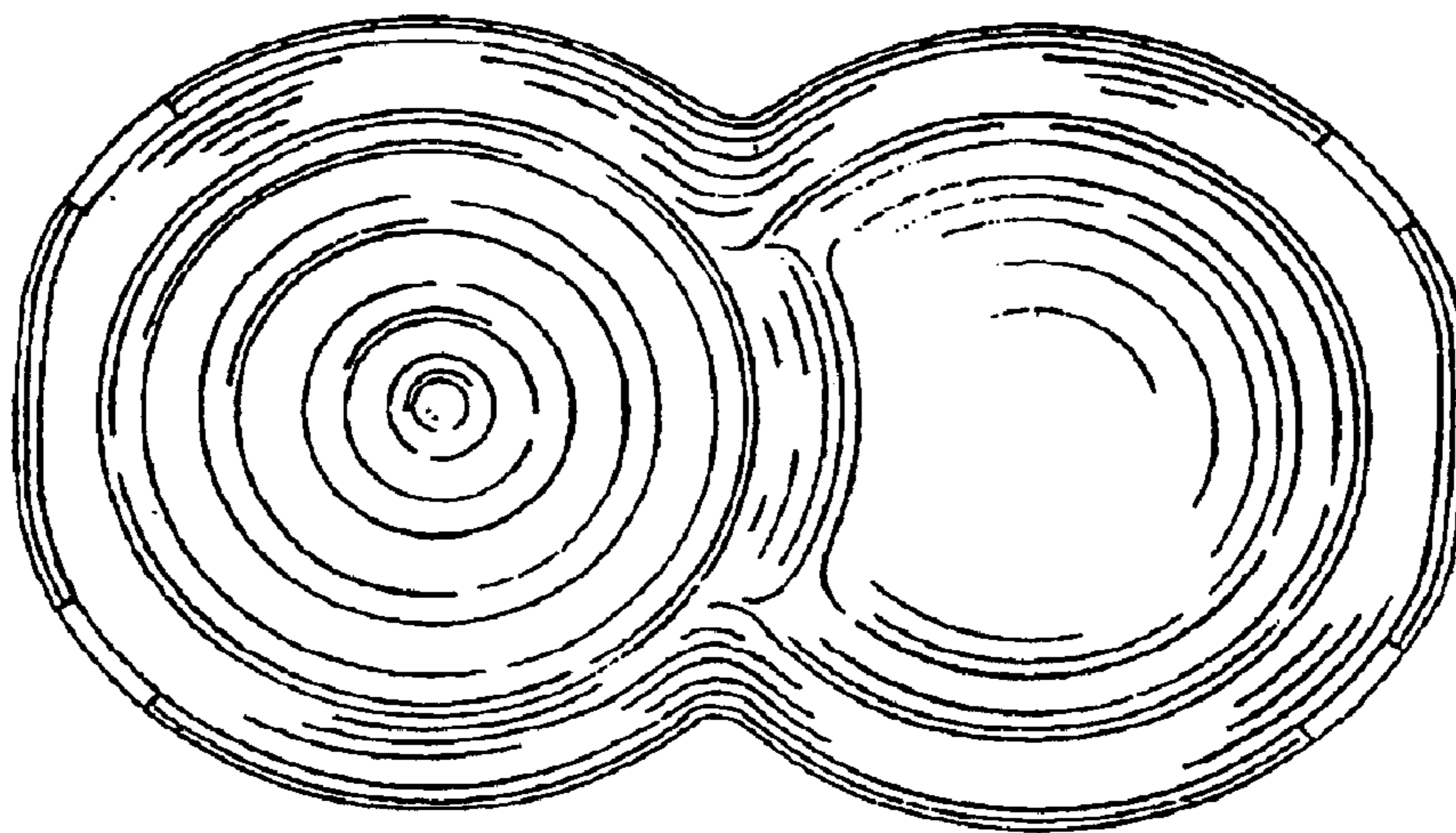

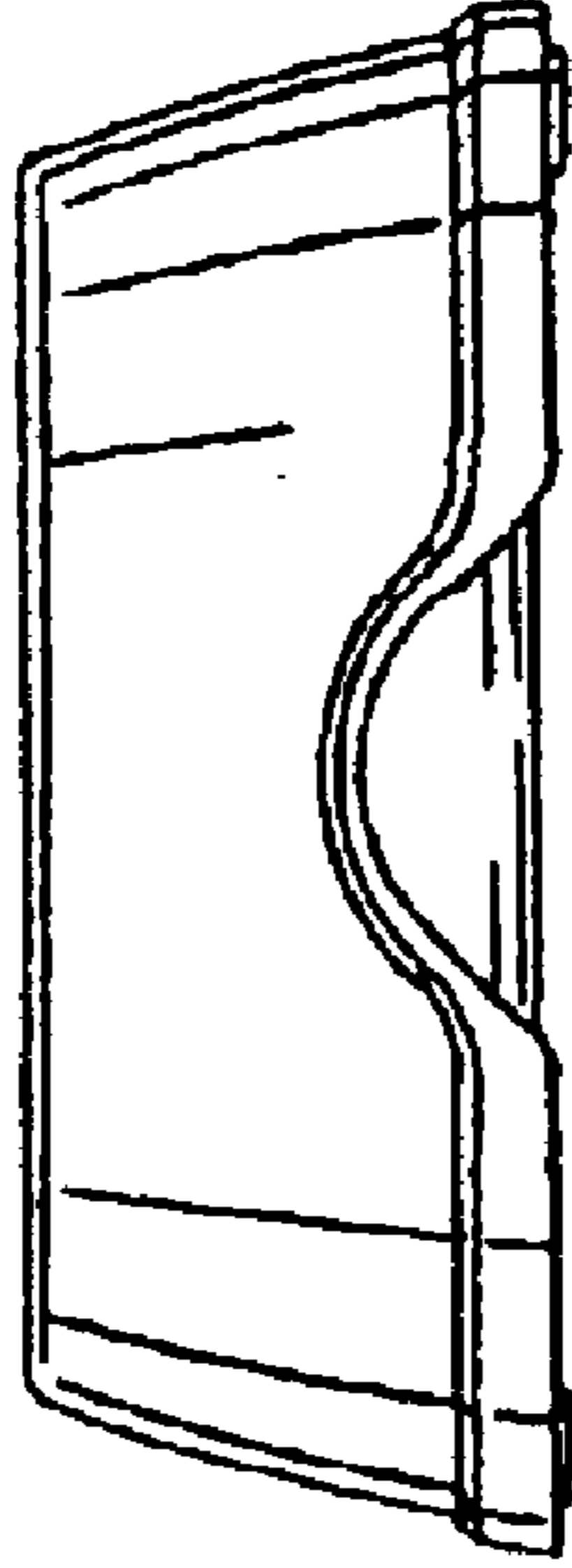

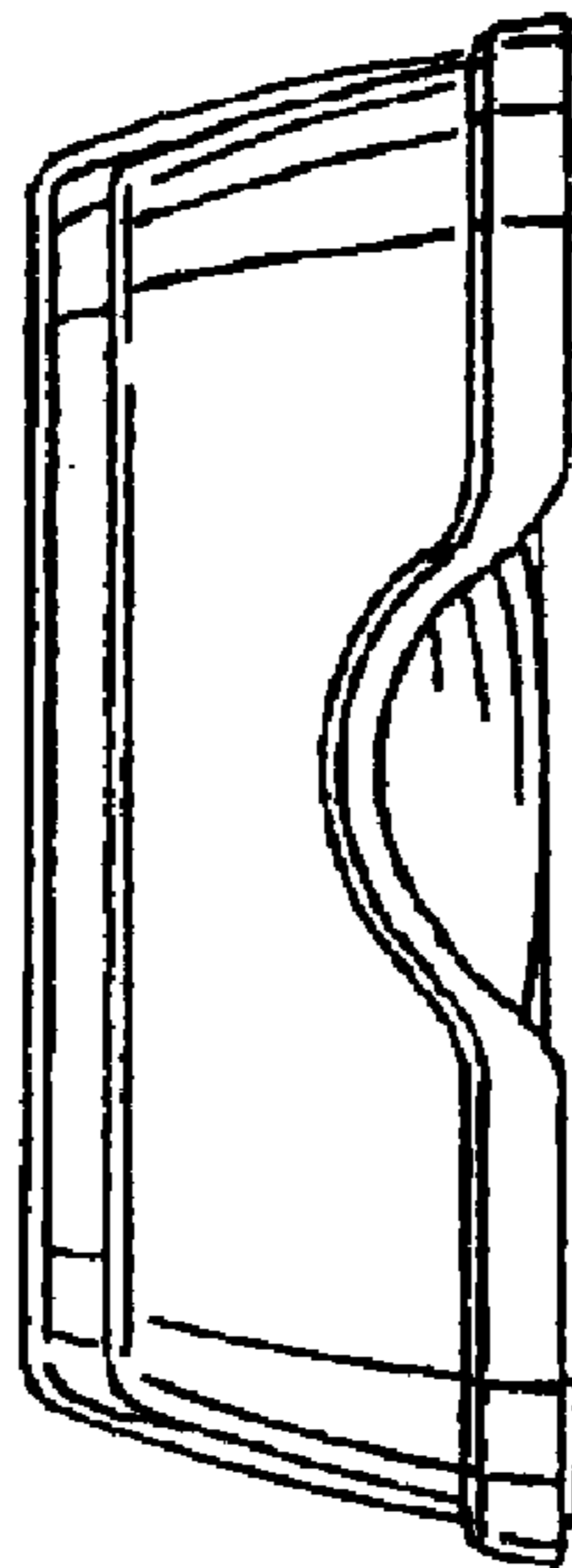

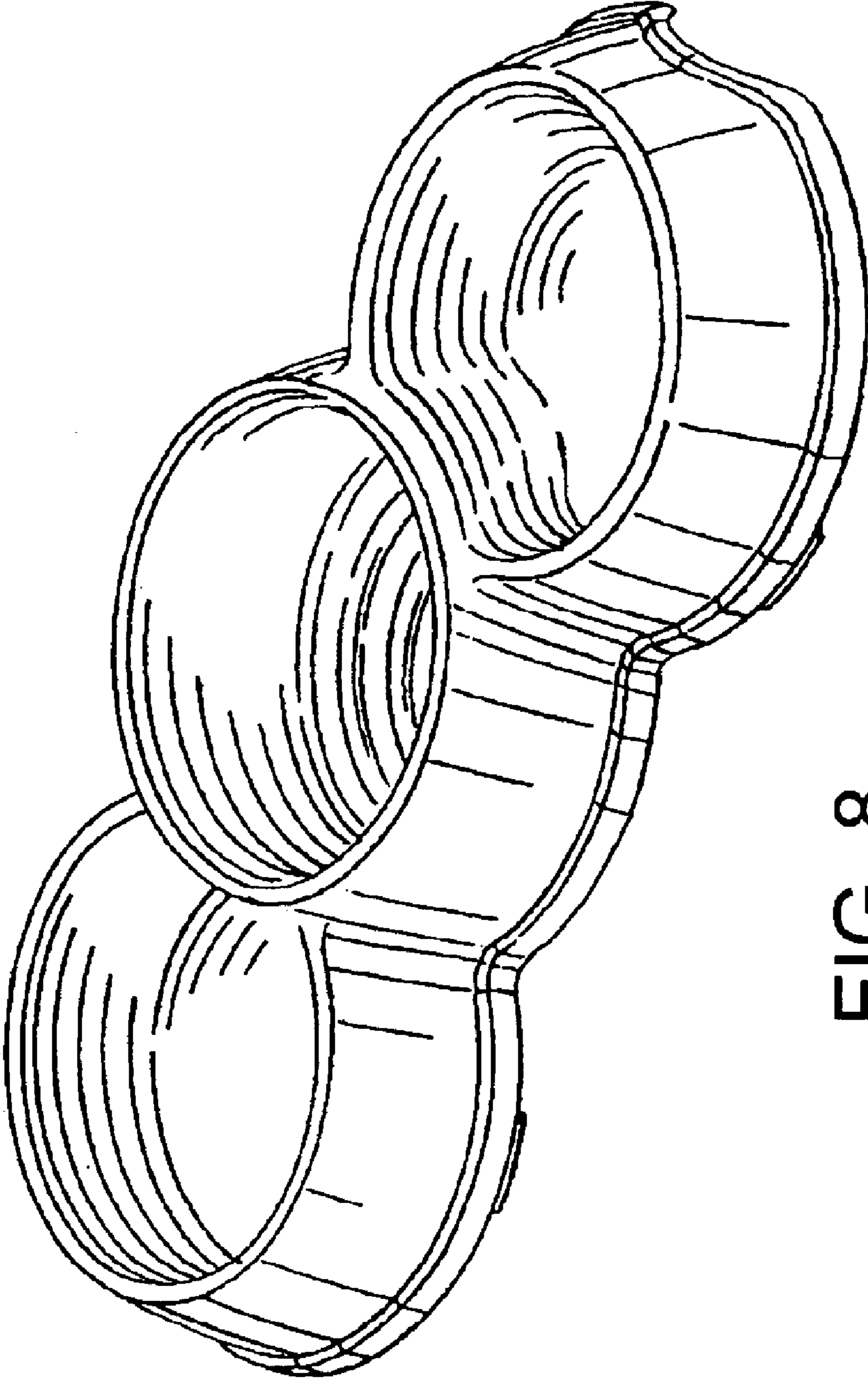

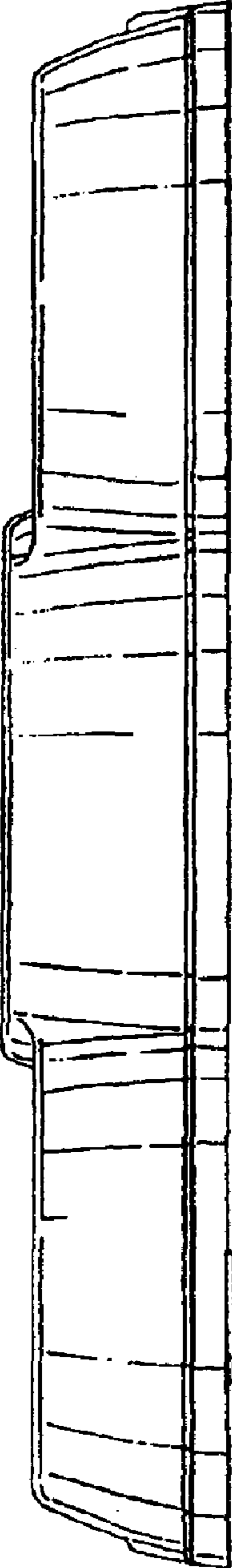

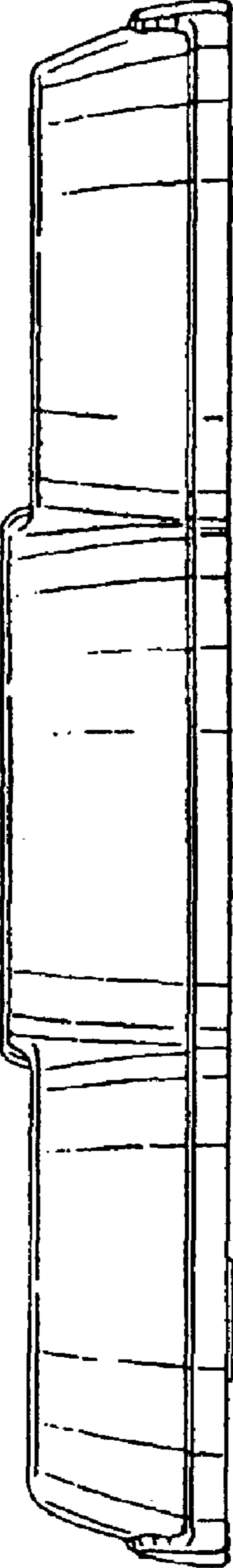

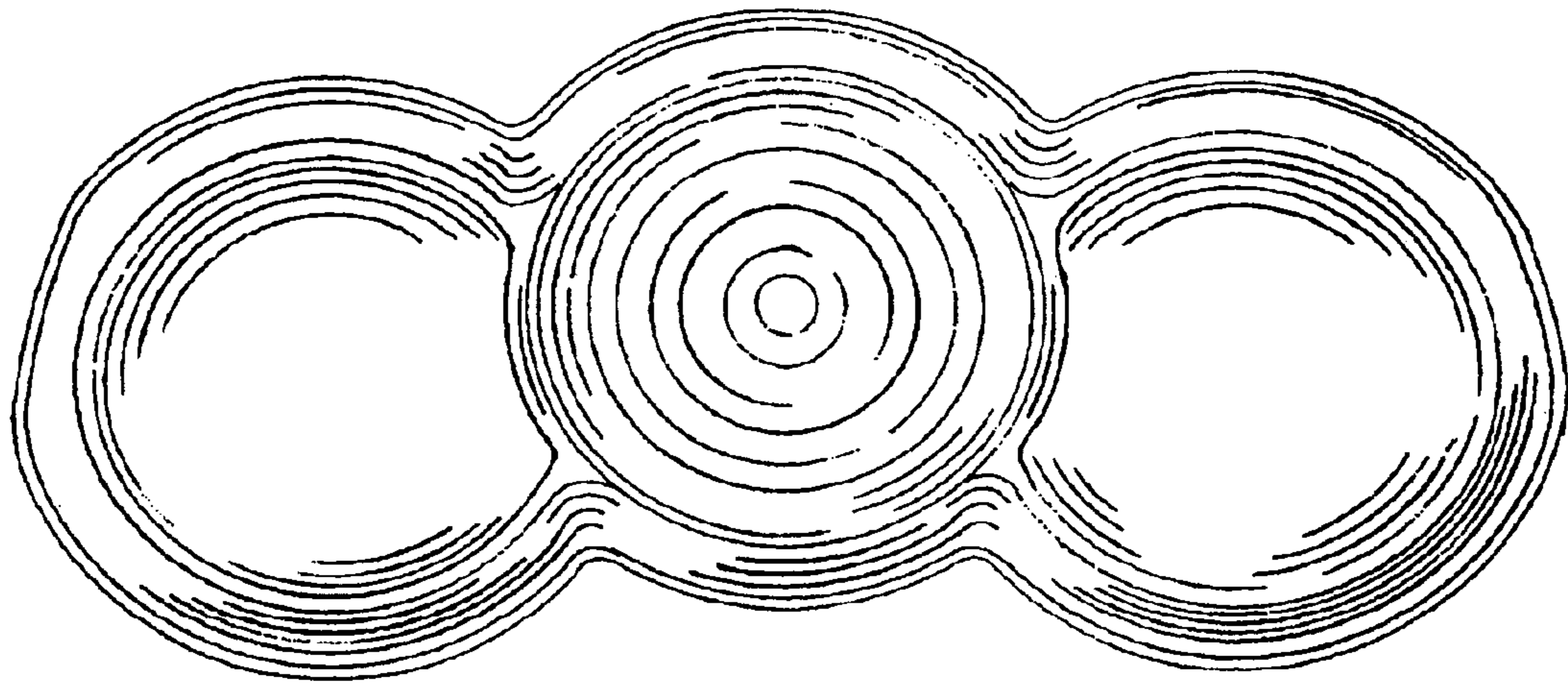

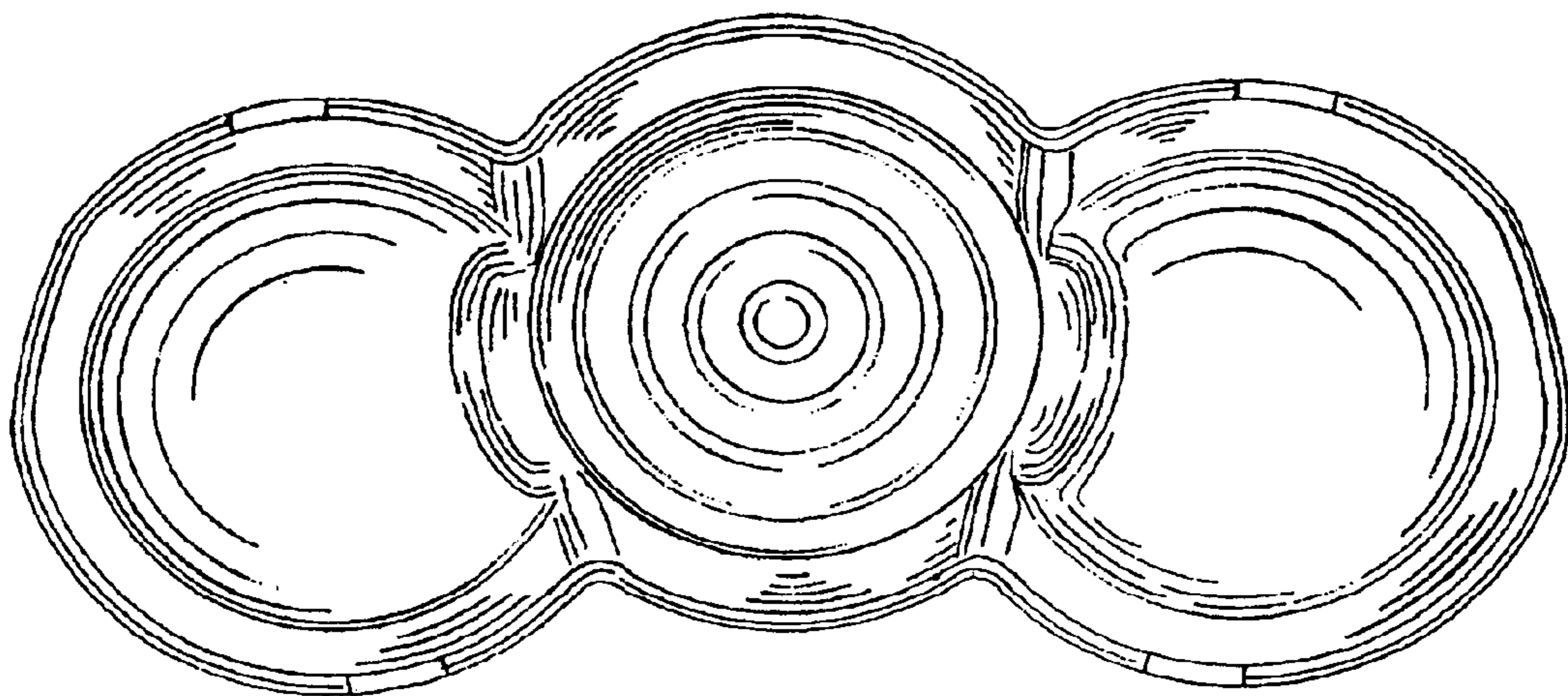

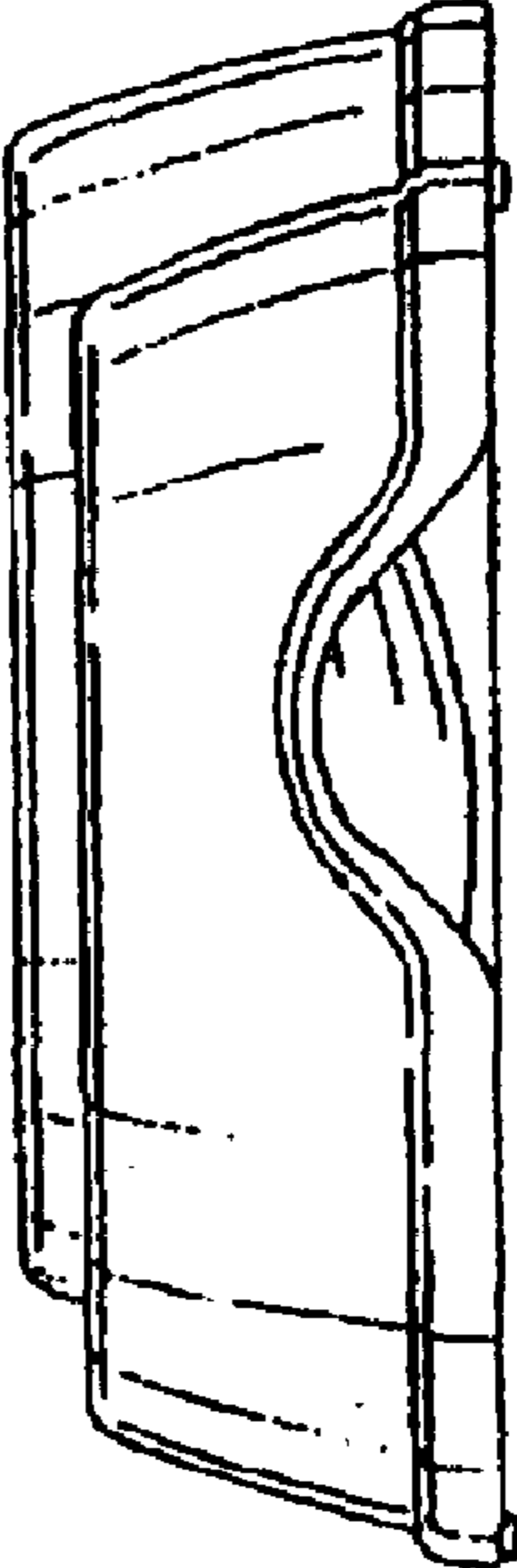

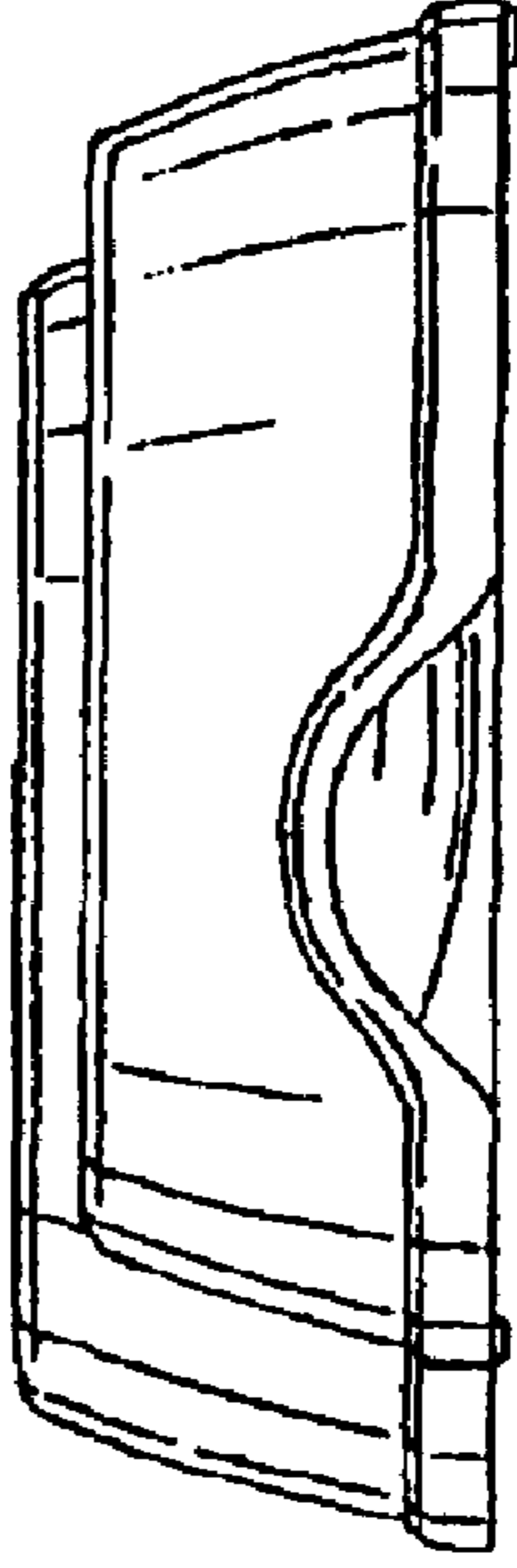
