(57) **CLAIM**

I claim the ornamental design for the wrestling singlet, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the wrestling singlet showing our new ornamental design;

FIG. 2 is a front perspective view of the wrestling singlet shown in FIG. 1;

FIG. 3 is a rear view of the wrestling singlet shown in FIG. 1; and,

FIG. 4 is a rear perspective view of the wrestling singlet shown in FIG. 1.

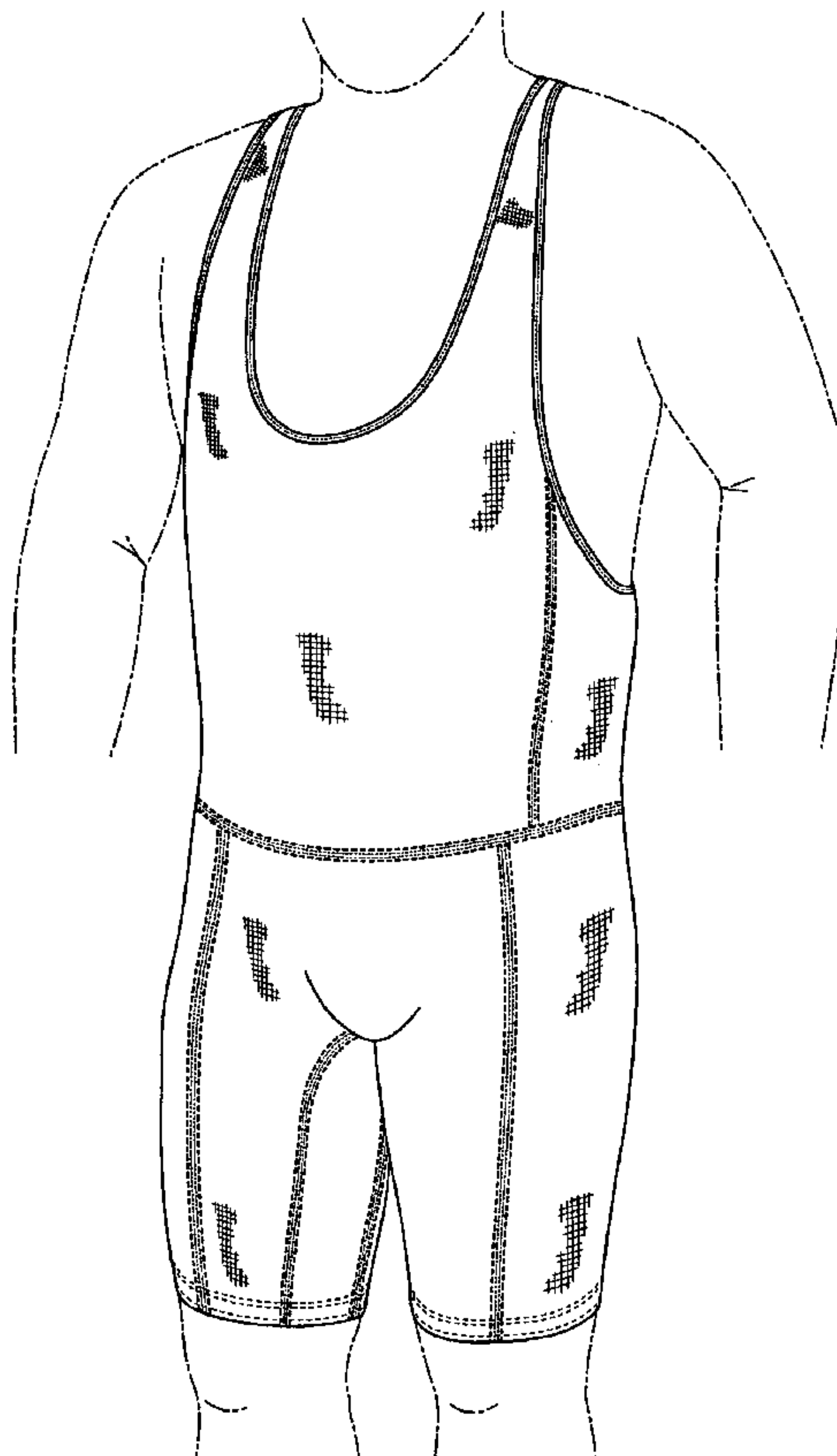

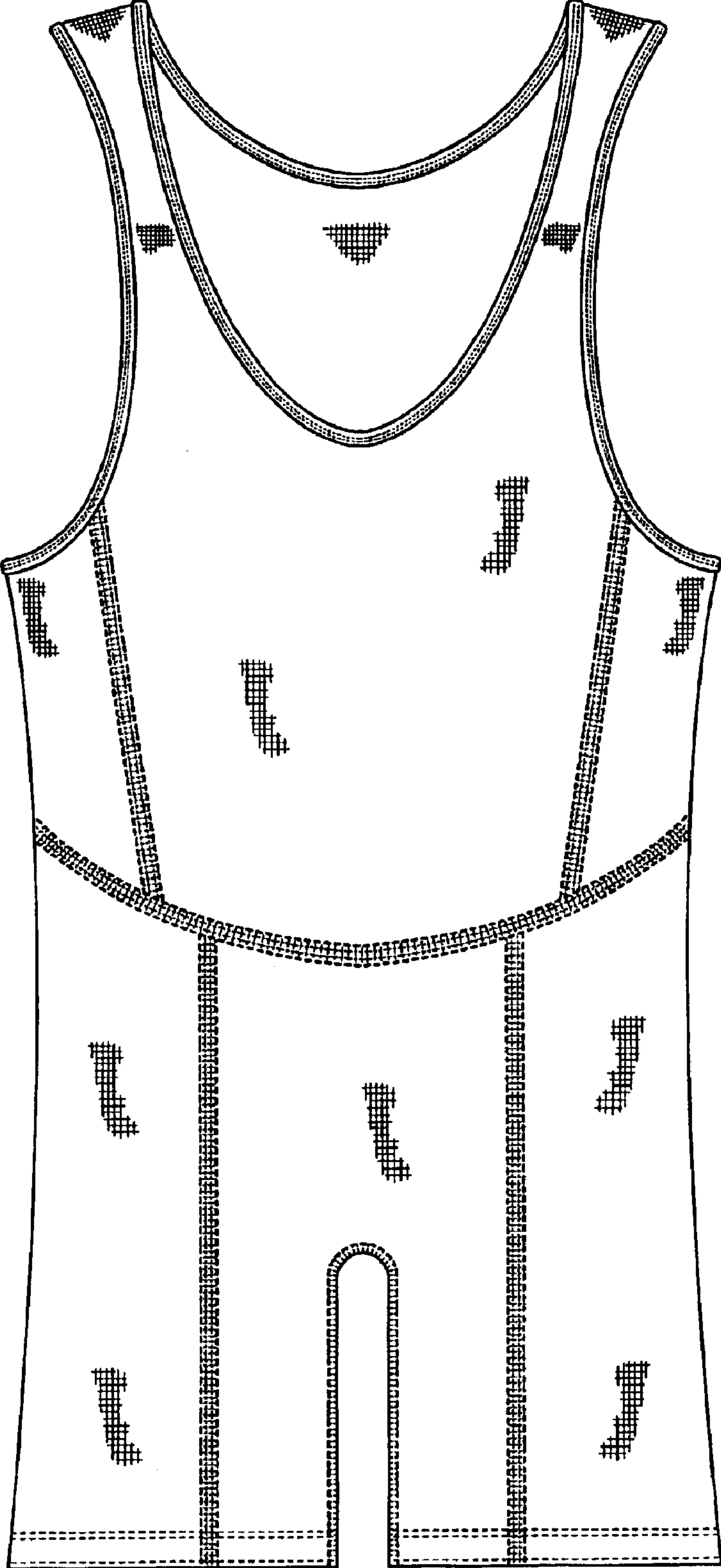

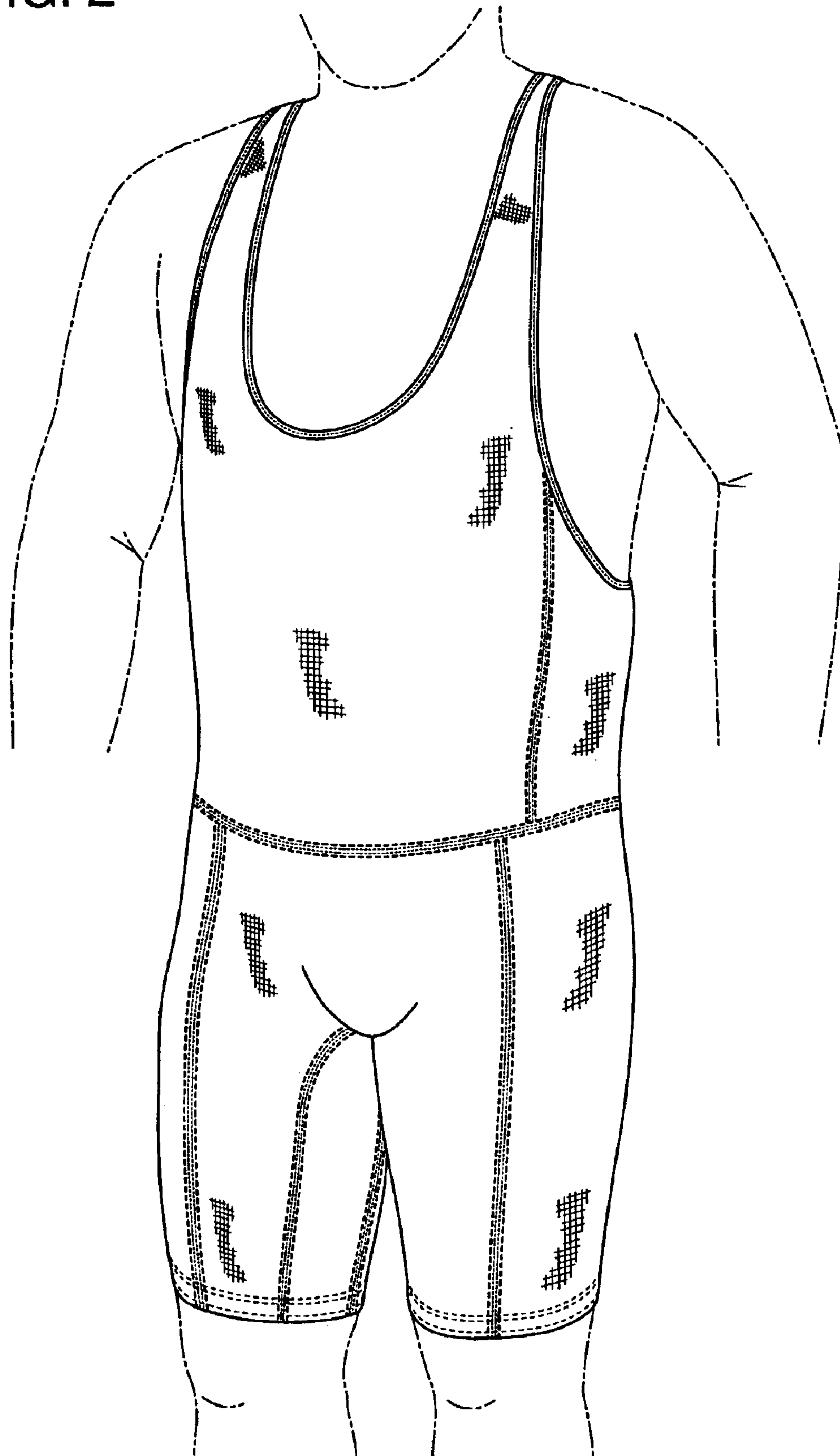

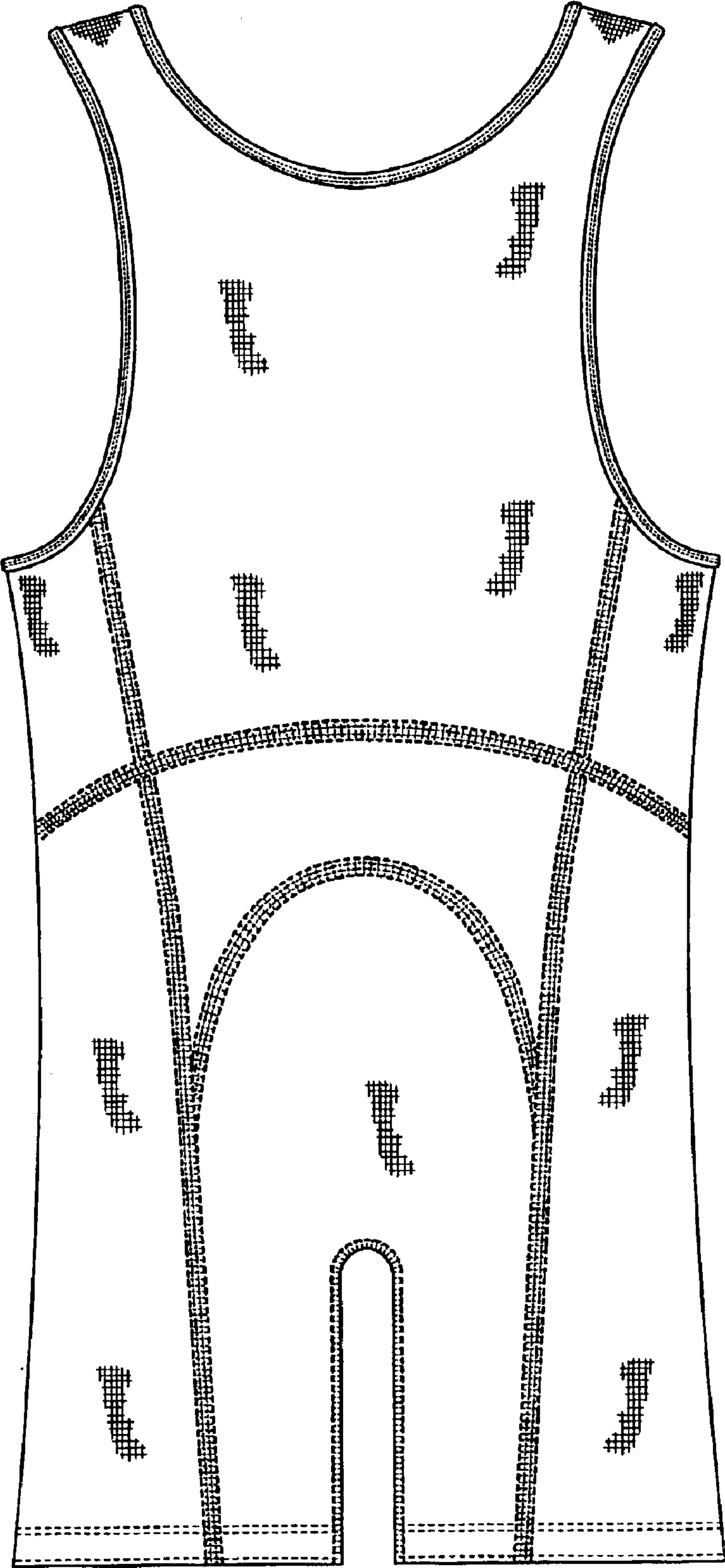
