FIG. 8 is a rear elevation view thereof.

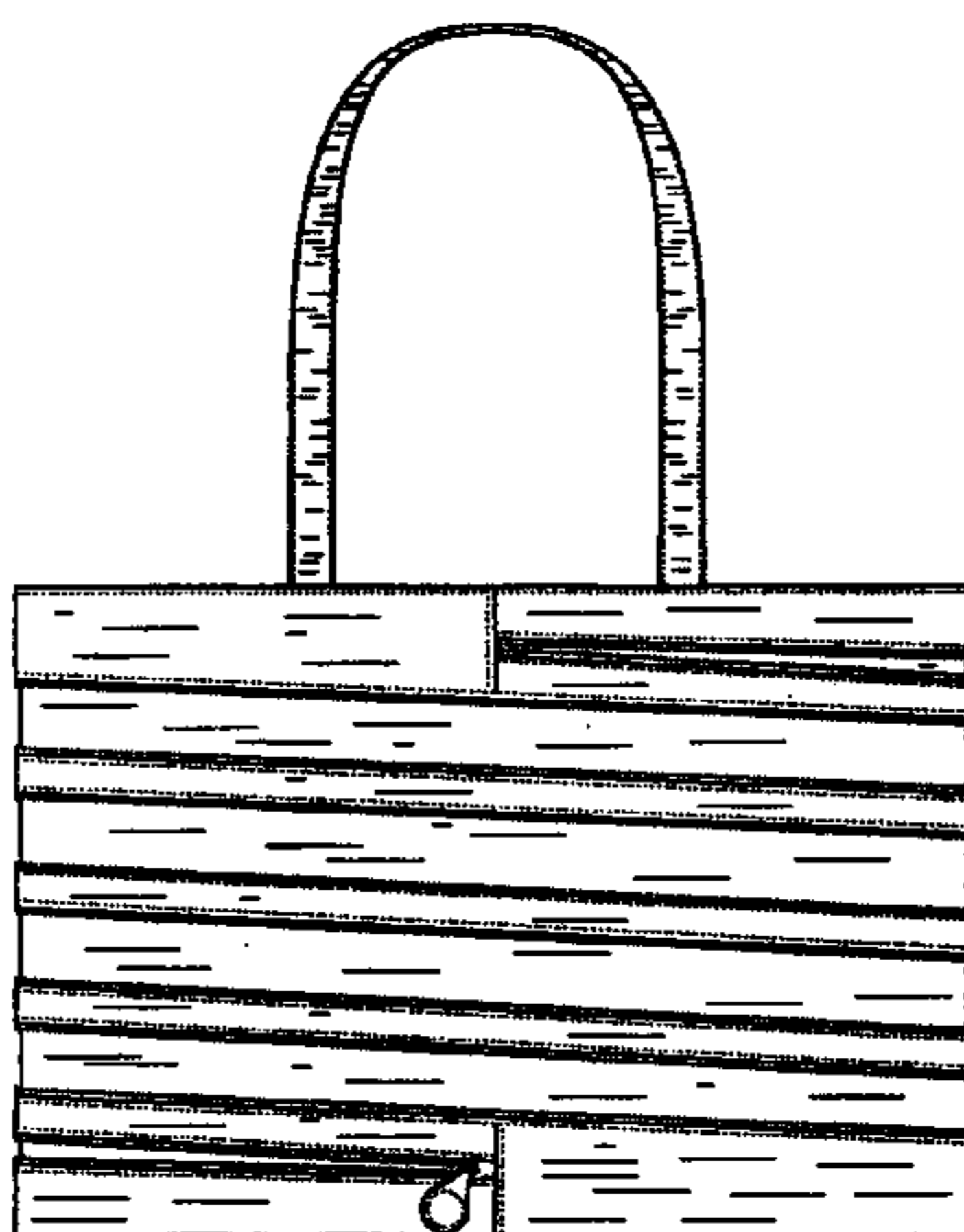
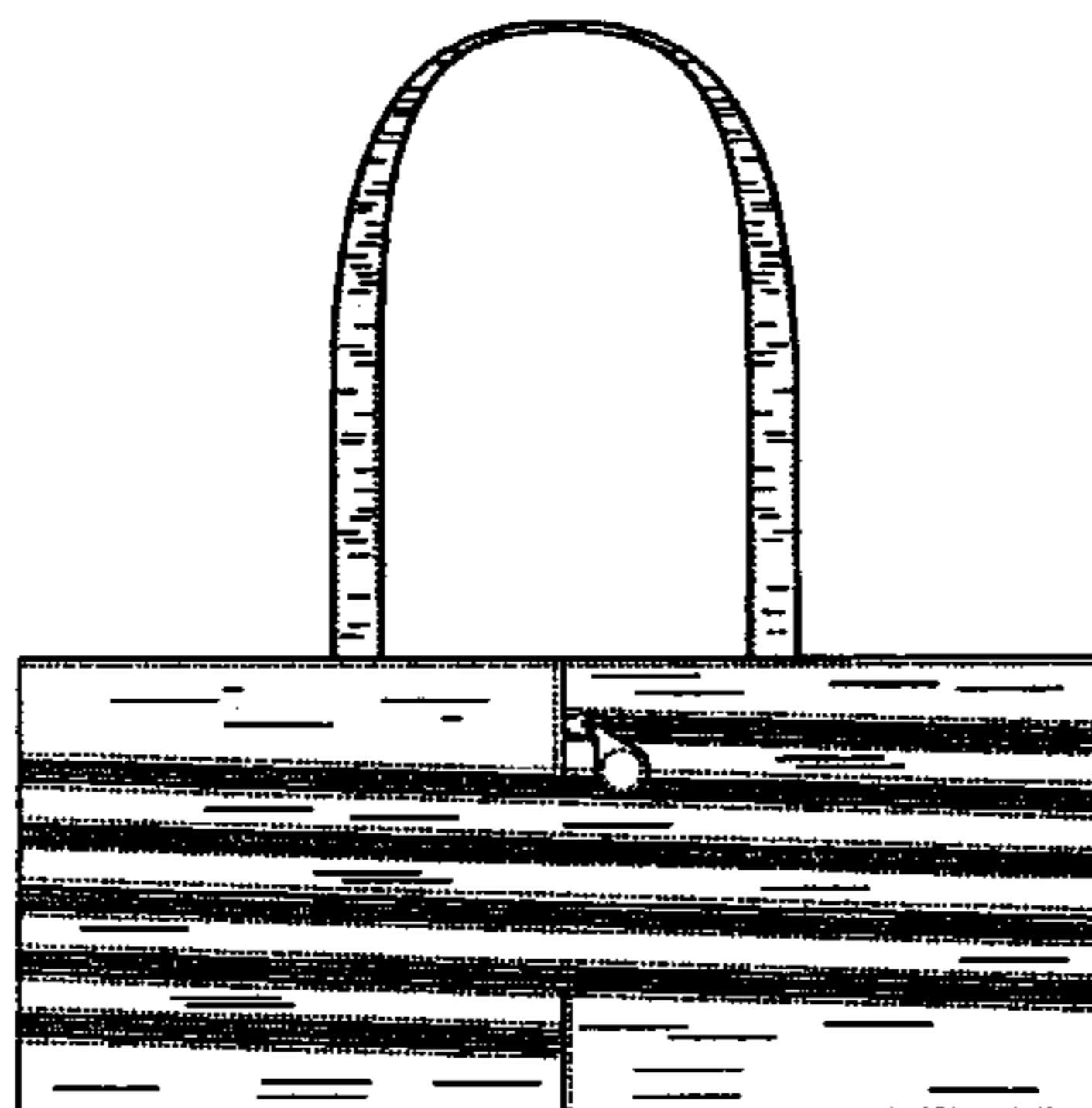
The broken line showing of stitching, in FIGS. 1–8, and a

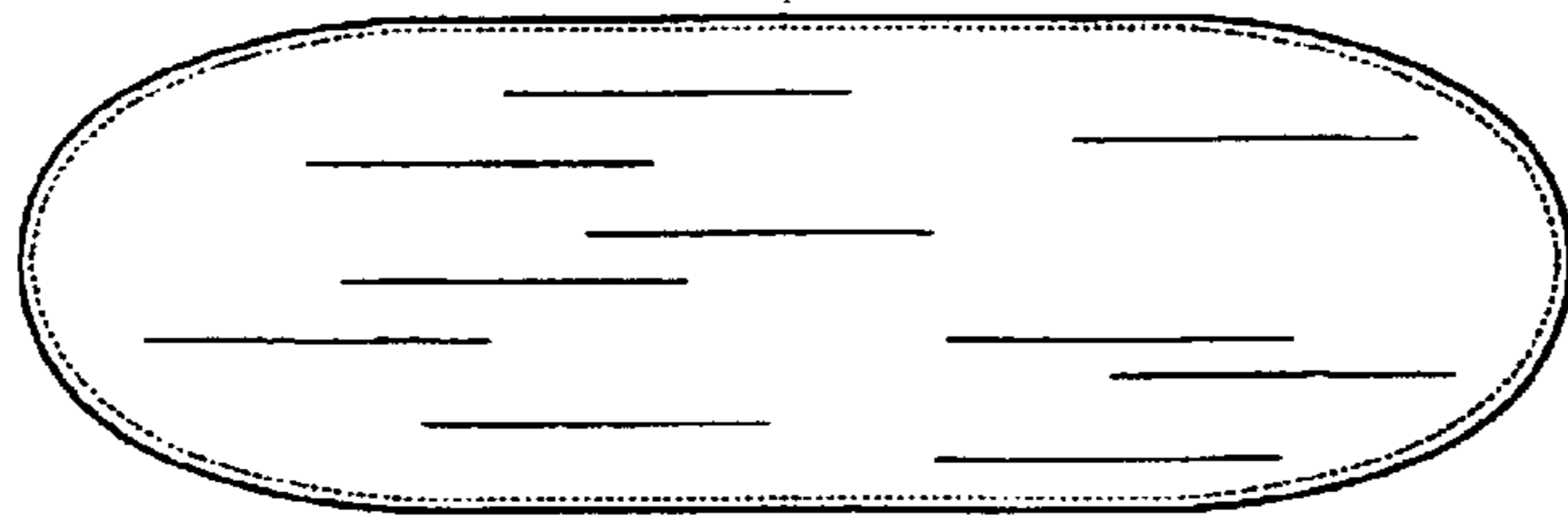

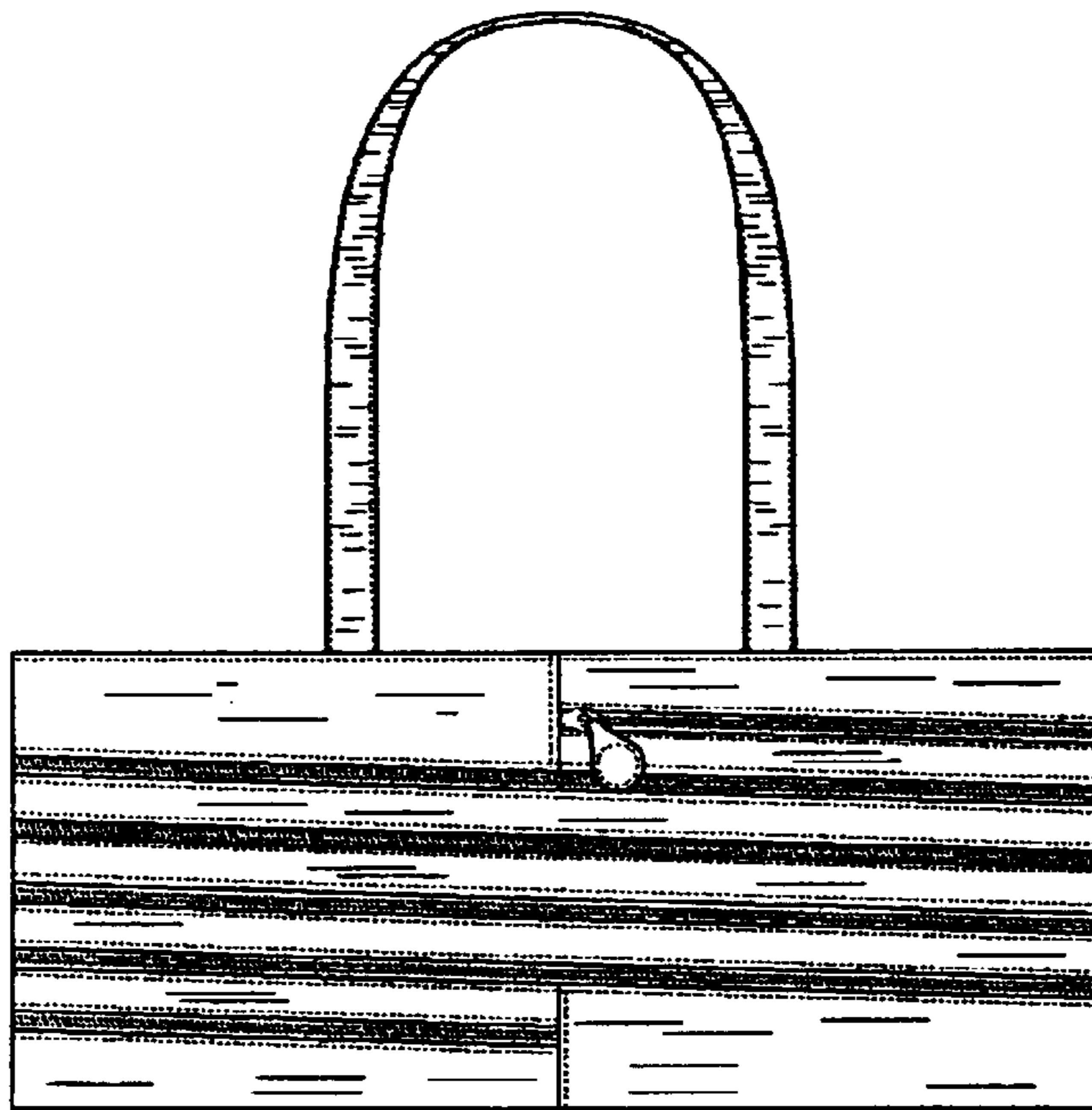

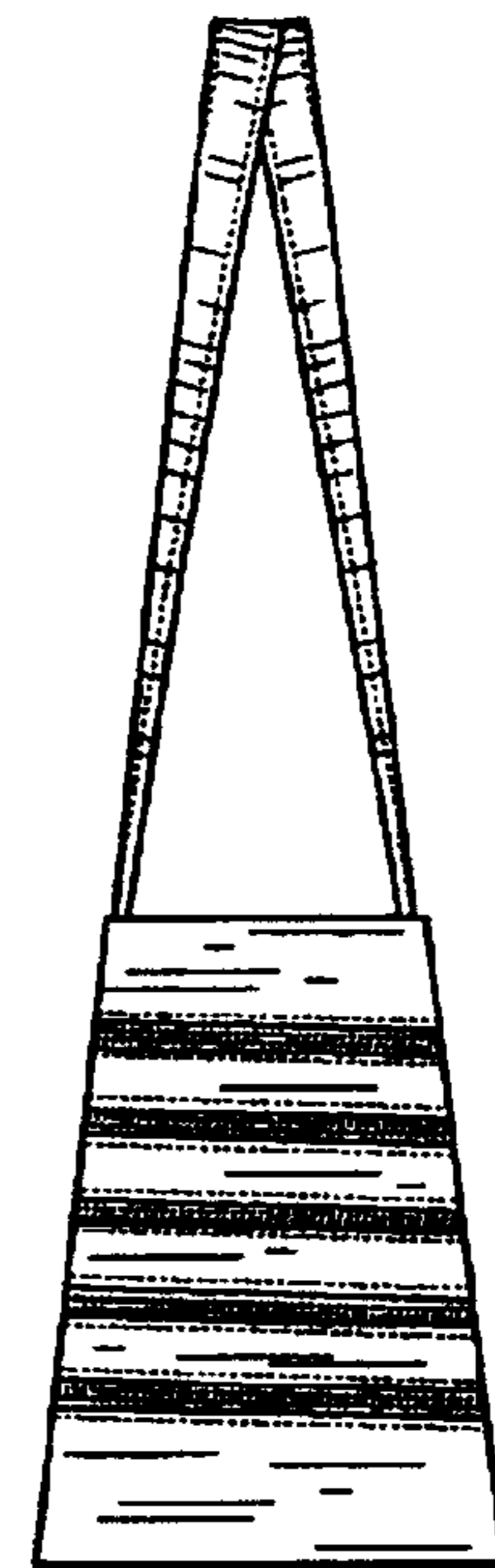

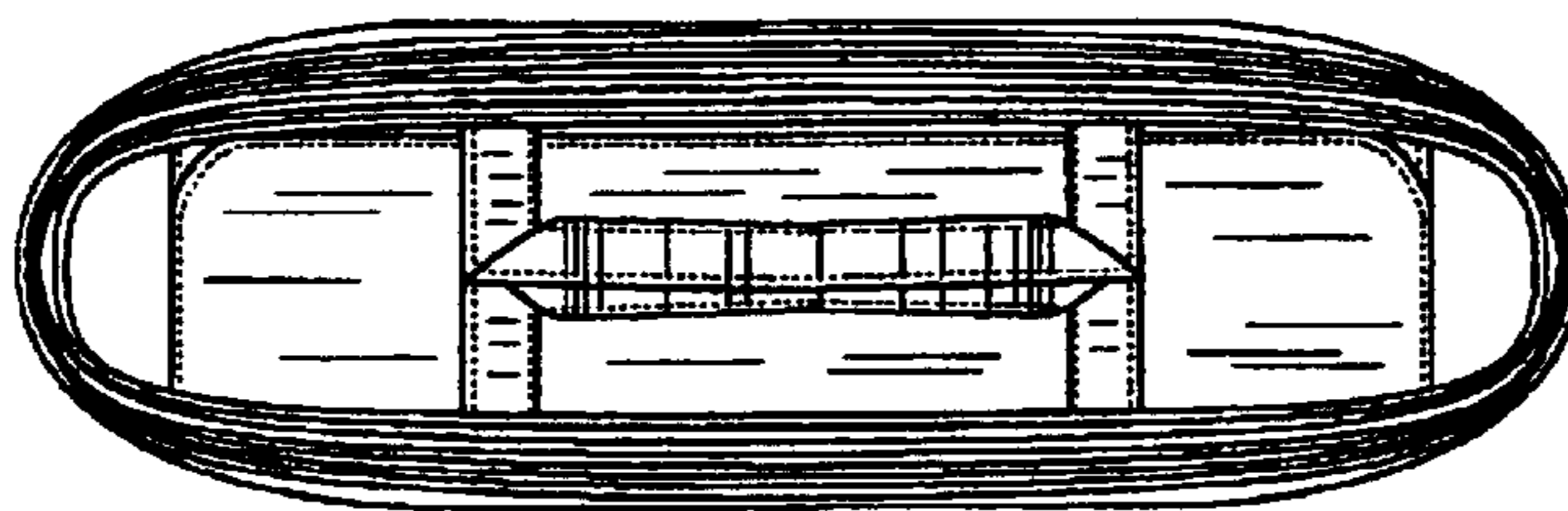

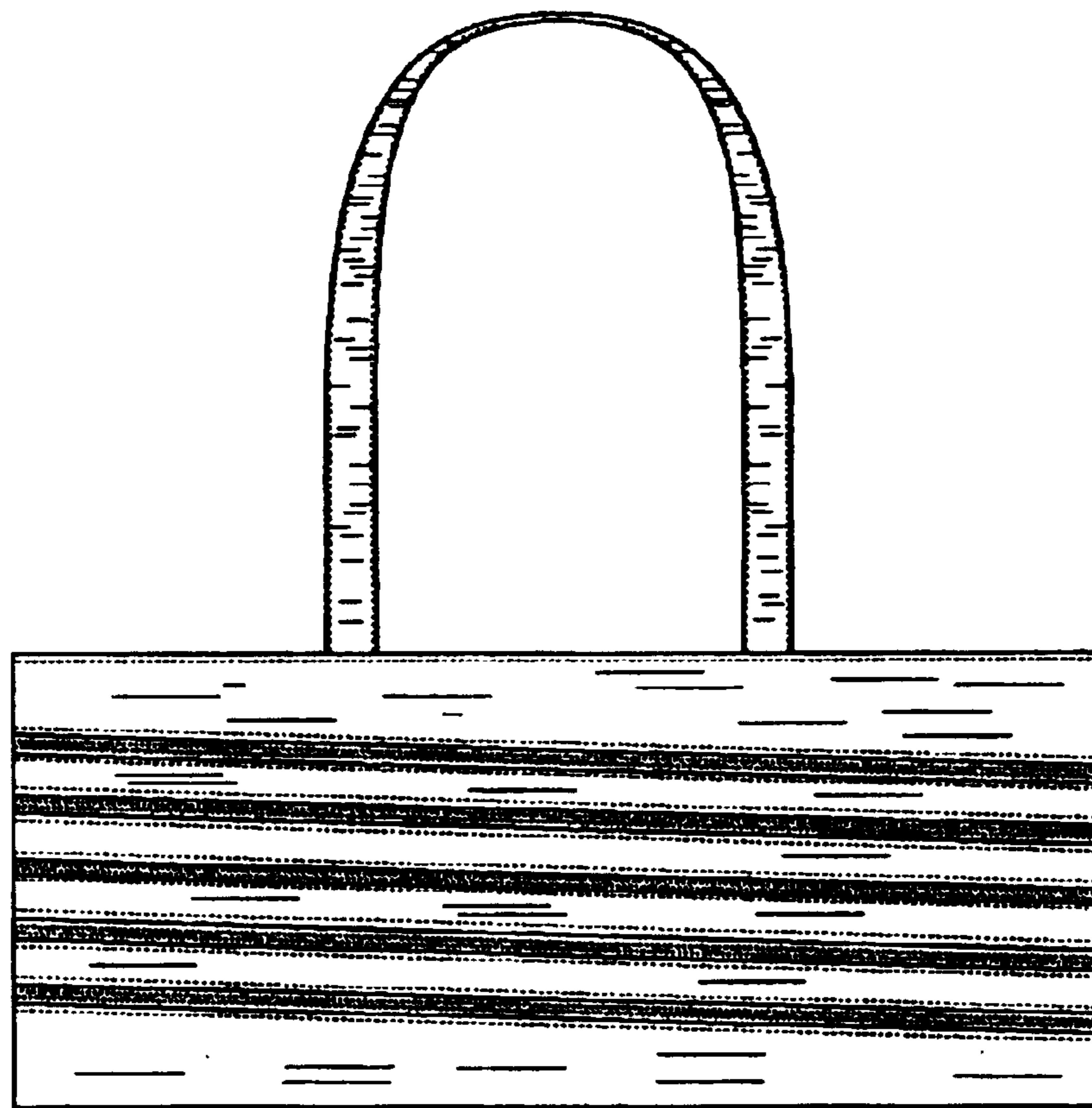

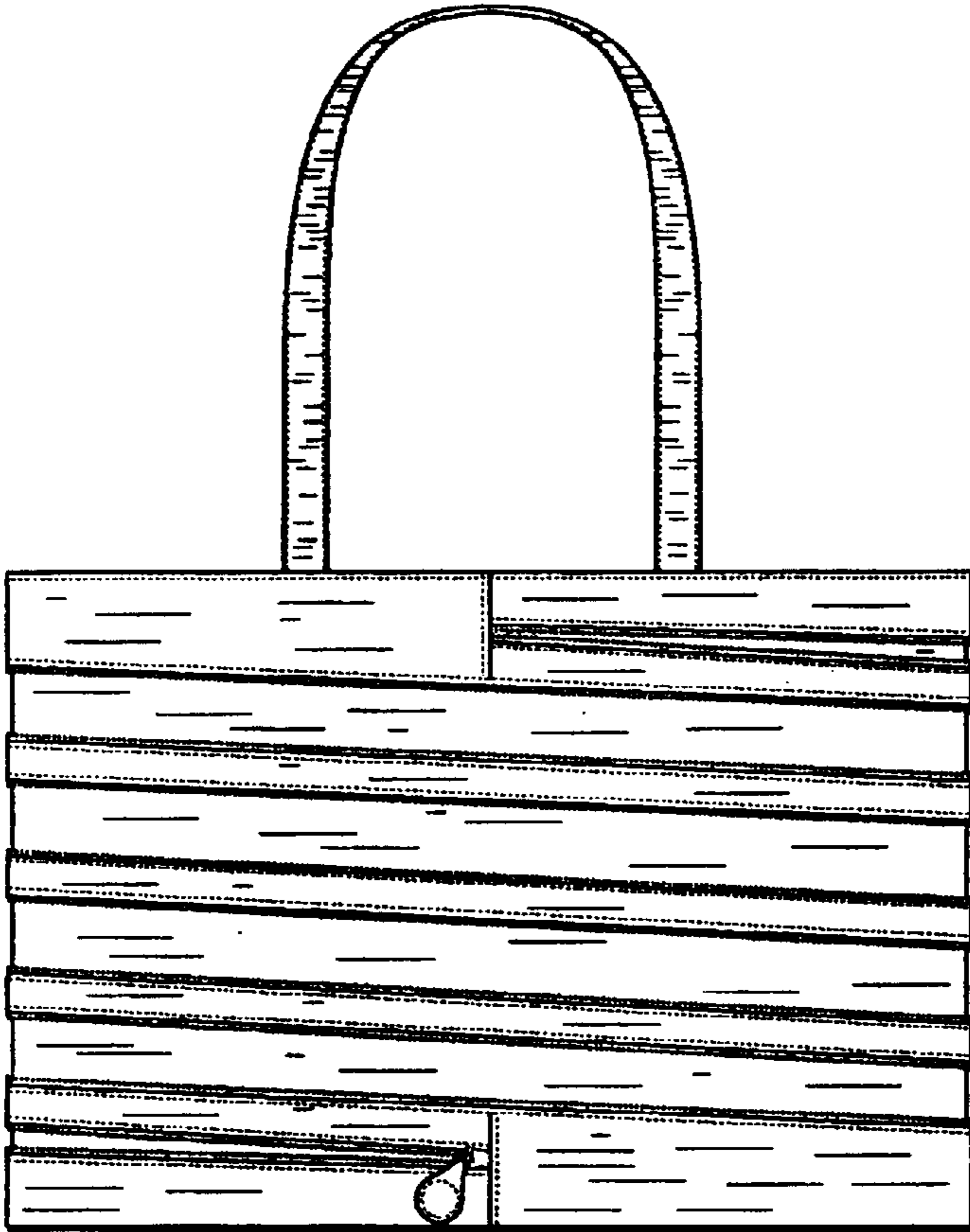

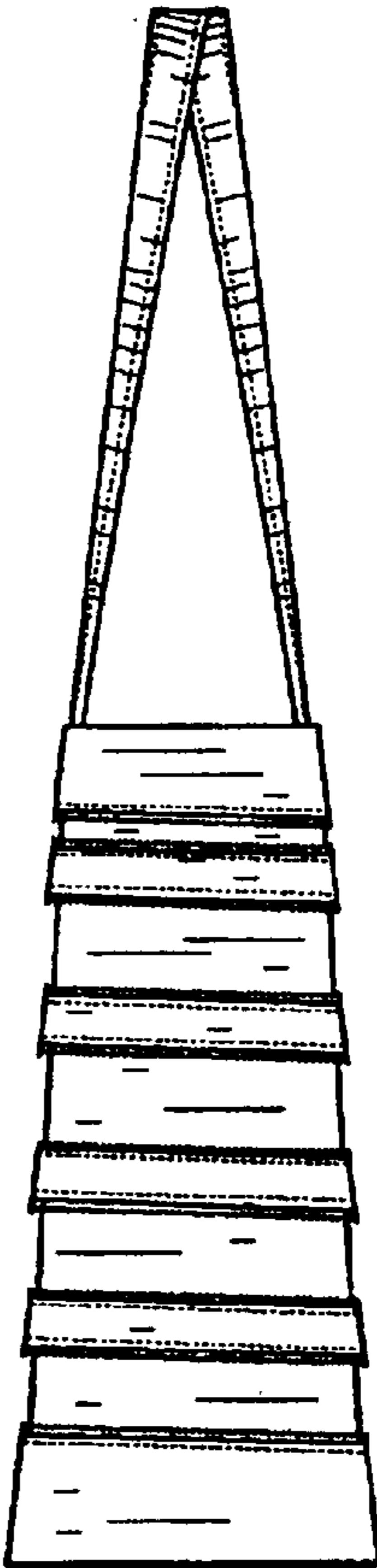

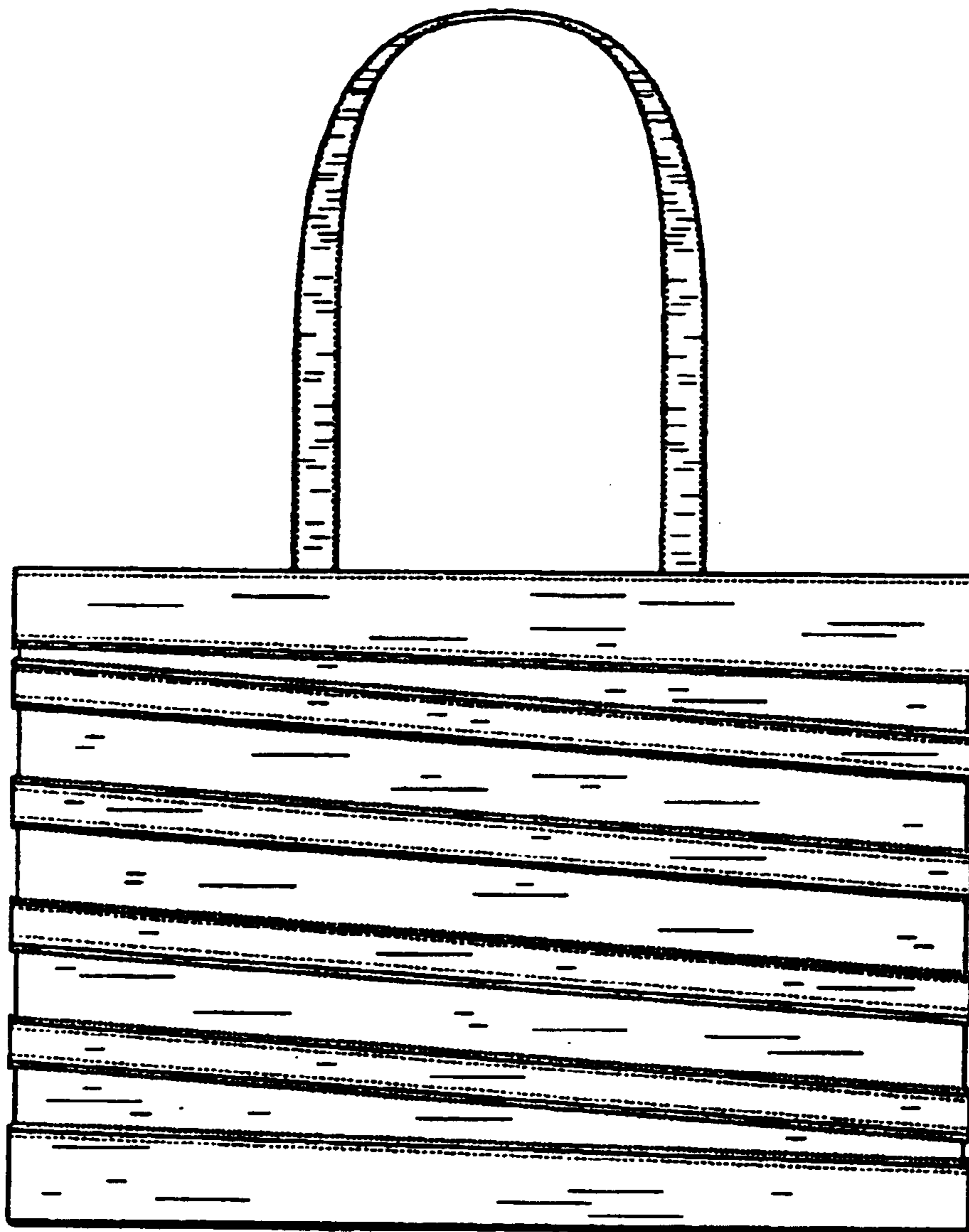
