(57) **CLAIM**

The ornamental design for a sofa, as shown and described.

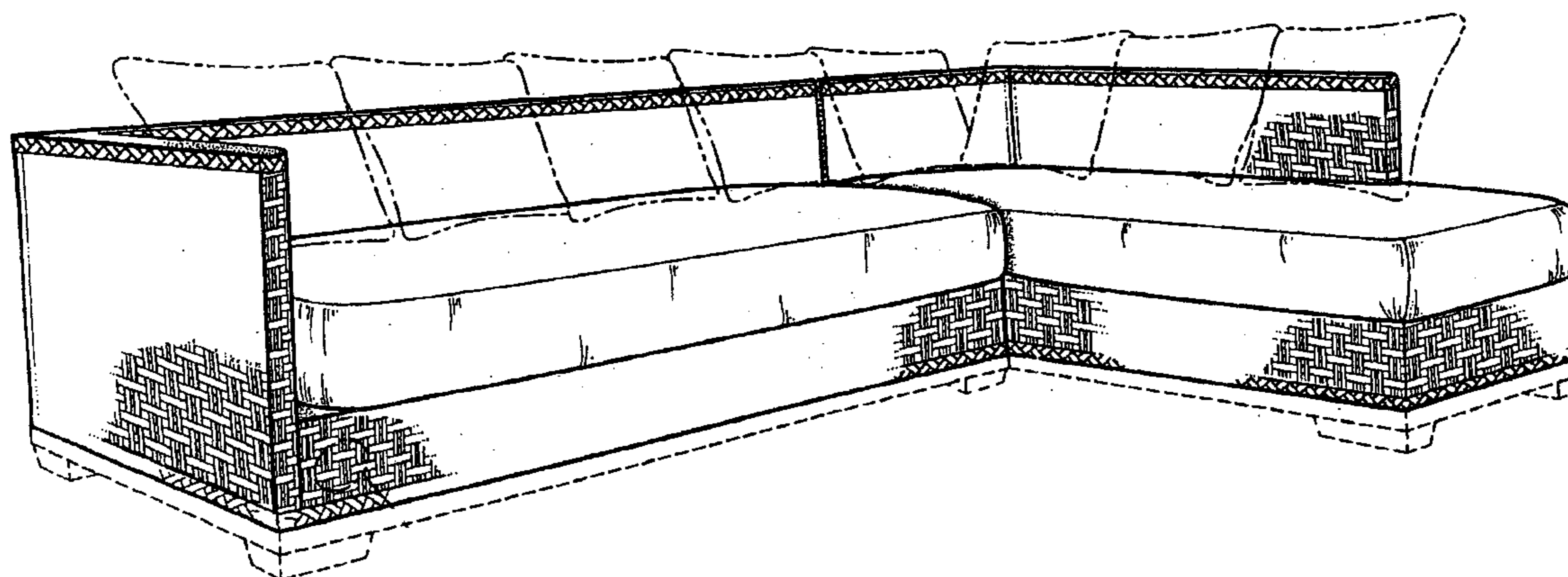
**DESCRIPTION**

FIG. 1 is a front, left perspective view of one embodiment of my new sofa design;  
 FIG. 2 is a close-up view of a portion of the embodiment of FIG. 1;  
 FIG. 3 is a front elevation view of the embodiment of FIG. 1;  
 FIG. 4 is a left, side elevation view of the embodiment of FIG. 1;  
 FIG. 5 is a rear, right side elevation view of the embodiment of FIG. 1; and,  
 FIG. 6 is a rear elevation view of the embodiment of FIG. 1.

The fragmented depiction of a weave pattern on the outside frame portions of the sofa is understood to repeat uniformly throughout the circumscribed areas. The fragmented depiction of woven trim is understood to be continuous throughout the trim bands.

The broken line disclosure is for illustrative purposes only and forms no part of the claimed design.

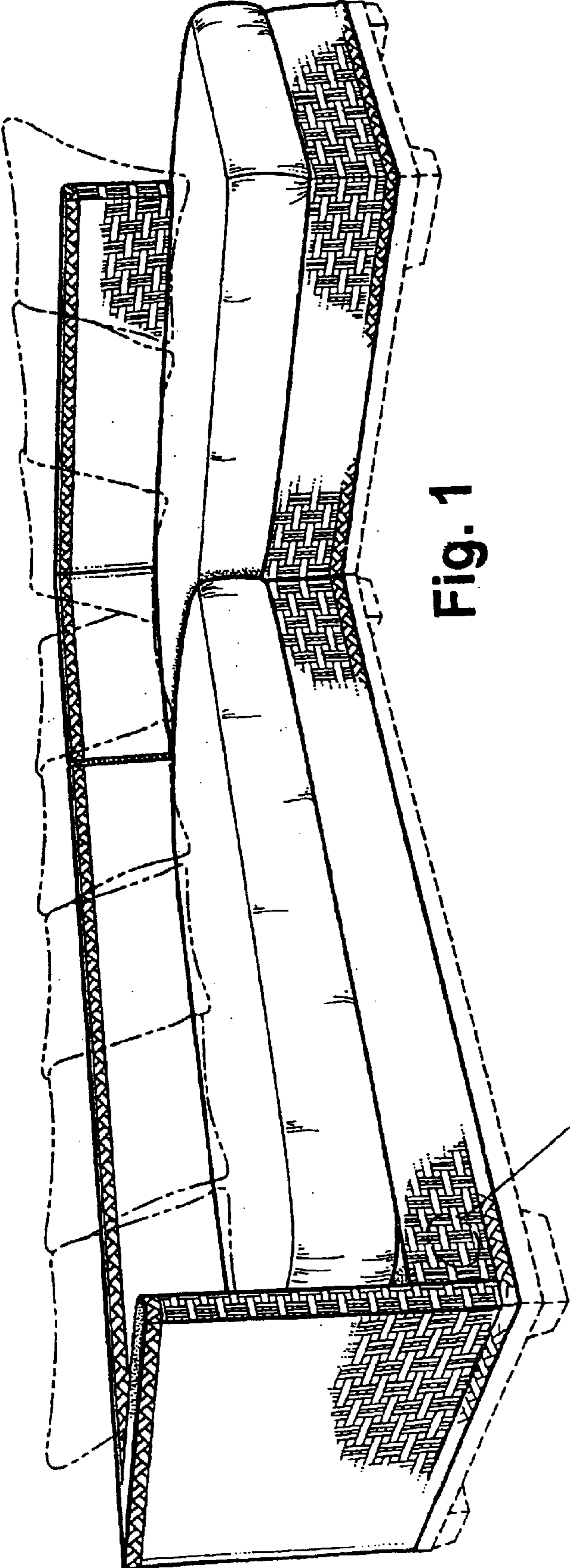

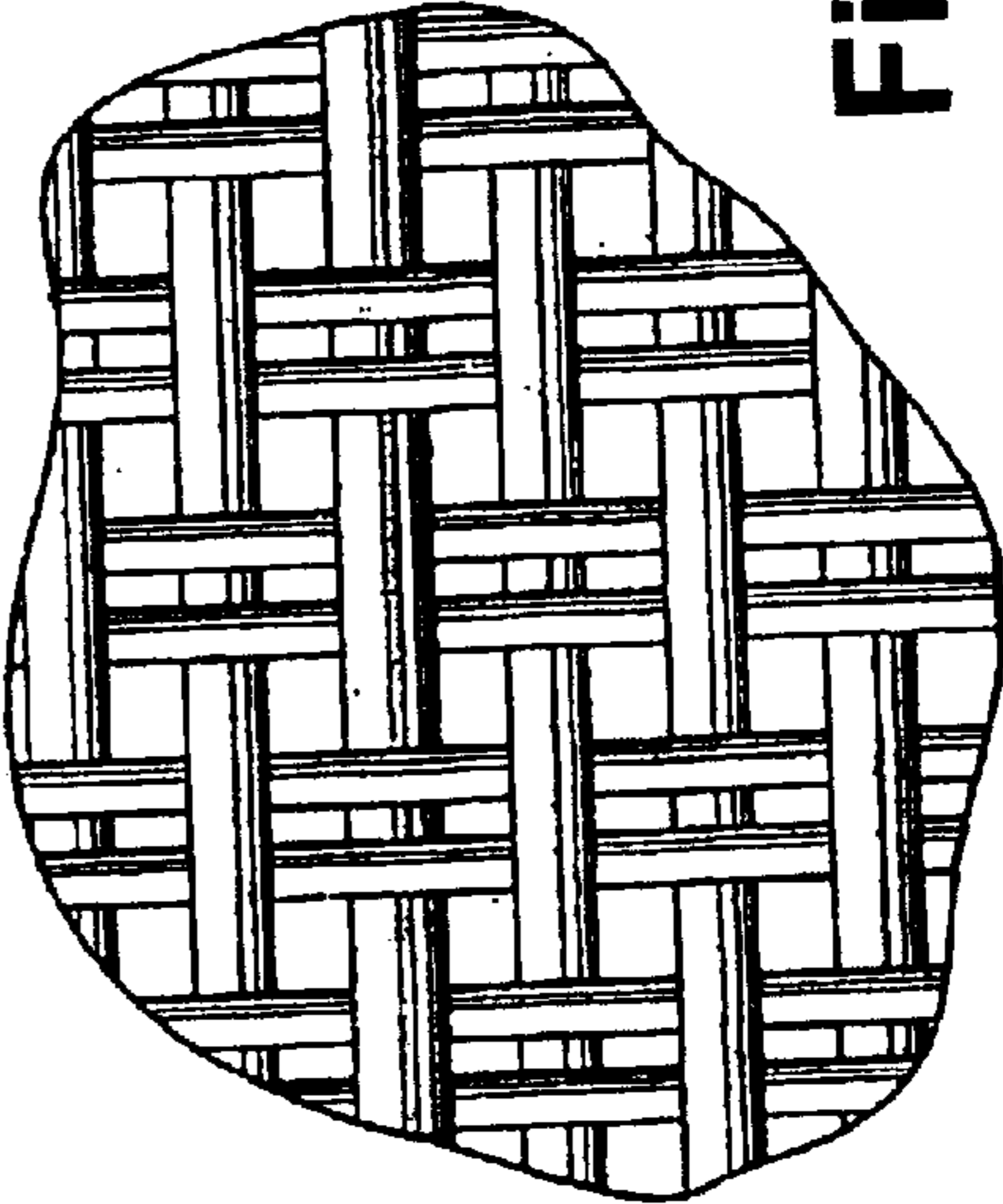
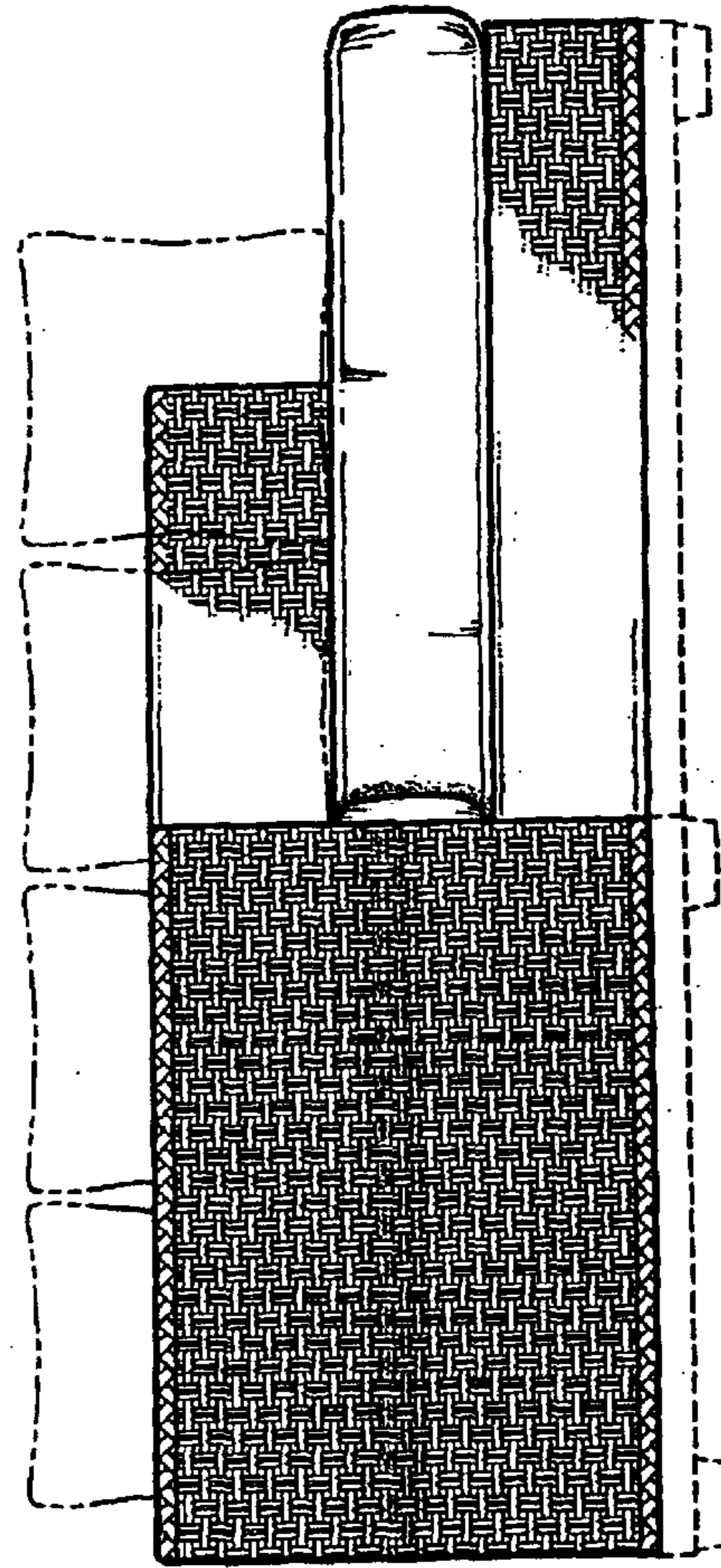
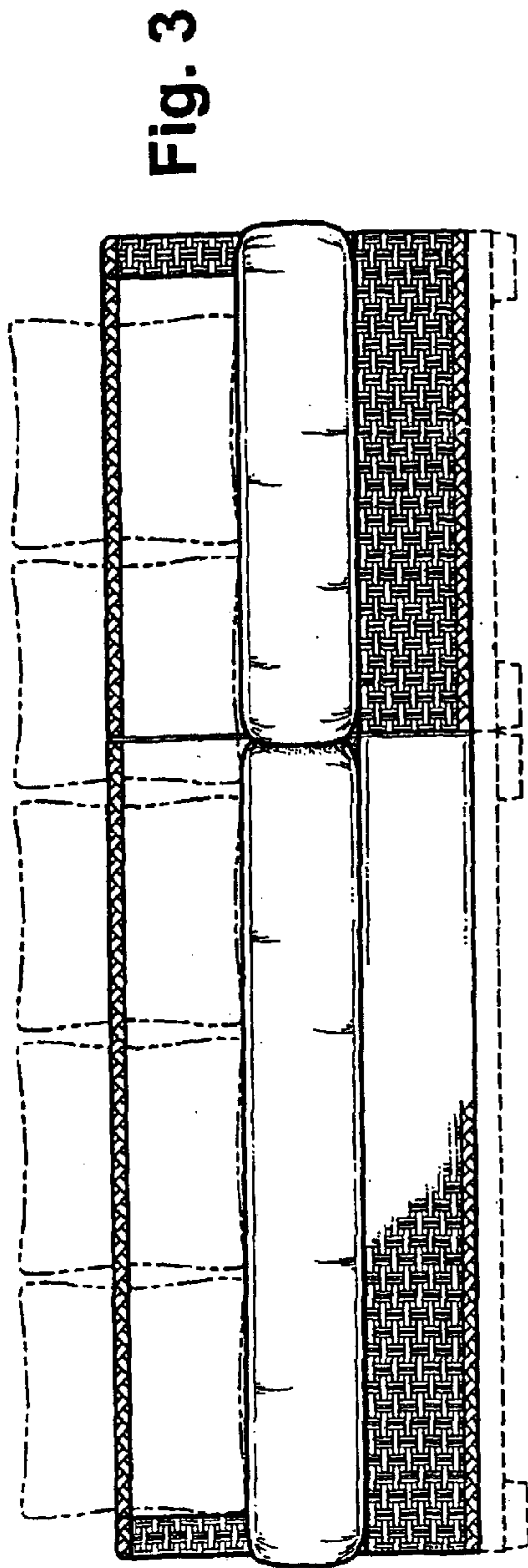

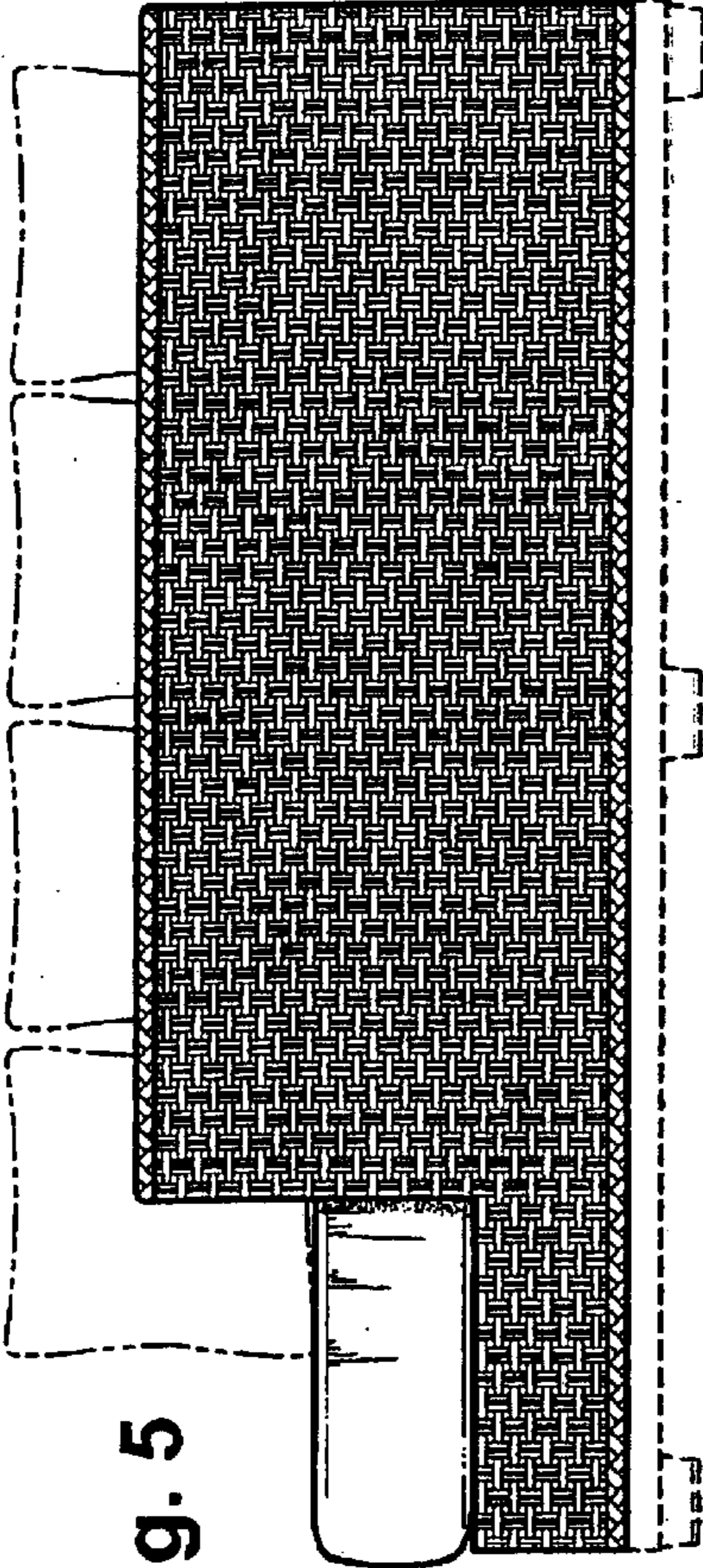

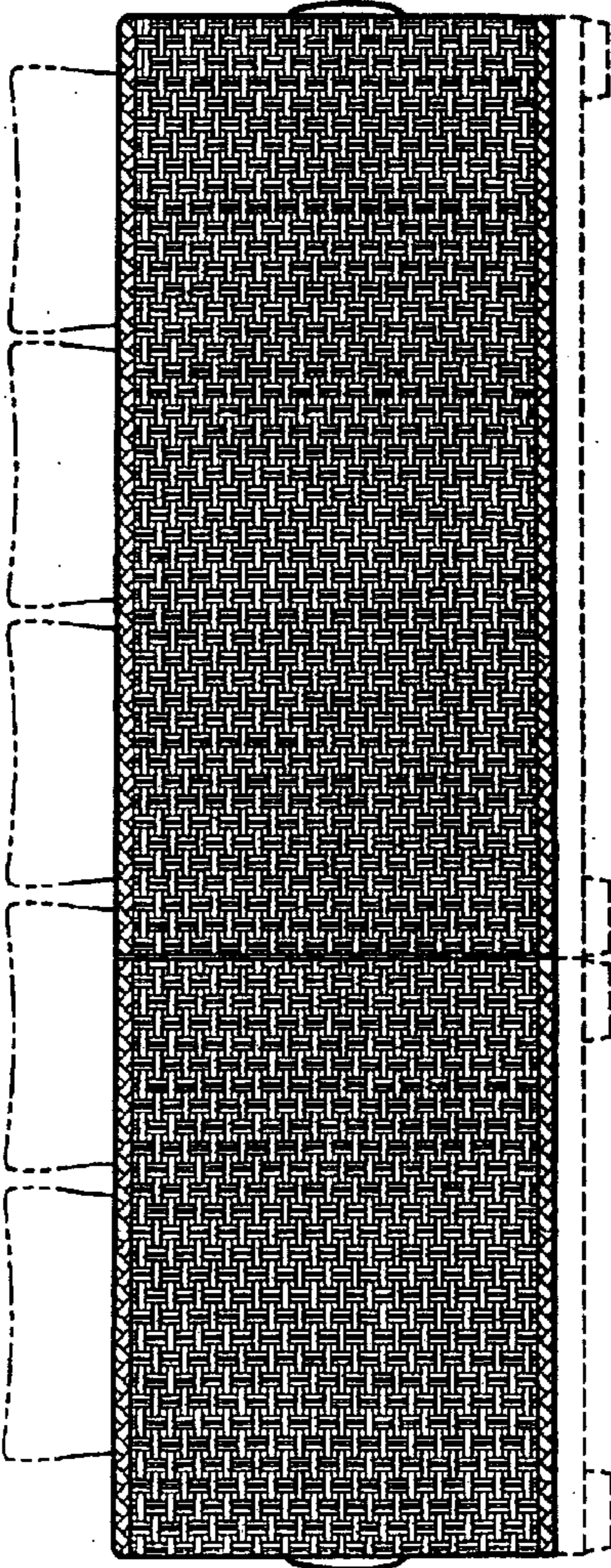
