**DESCRIPTION**

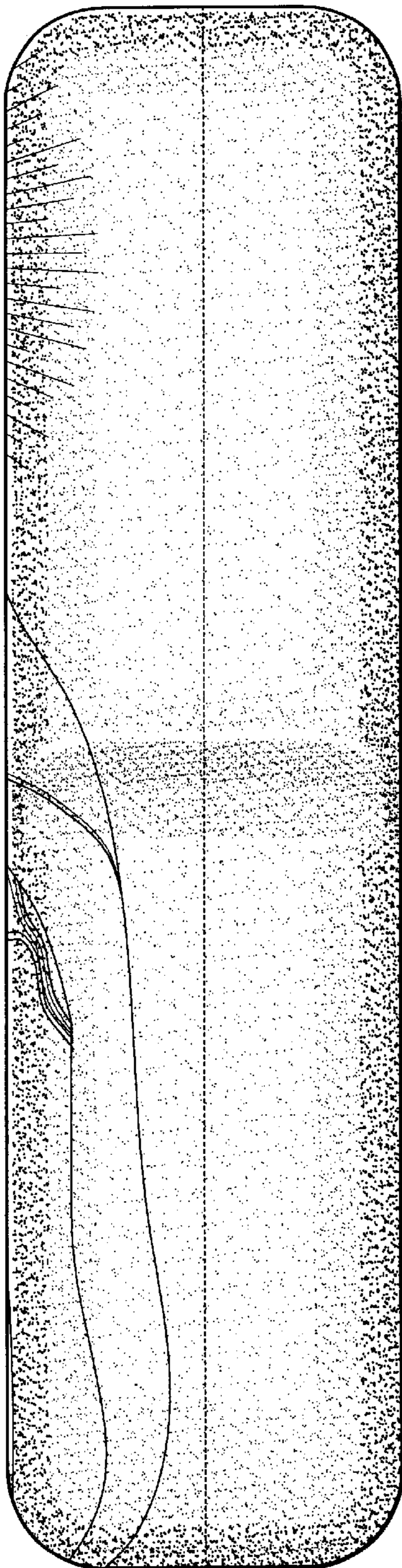

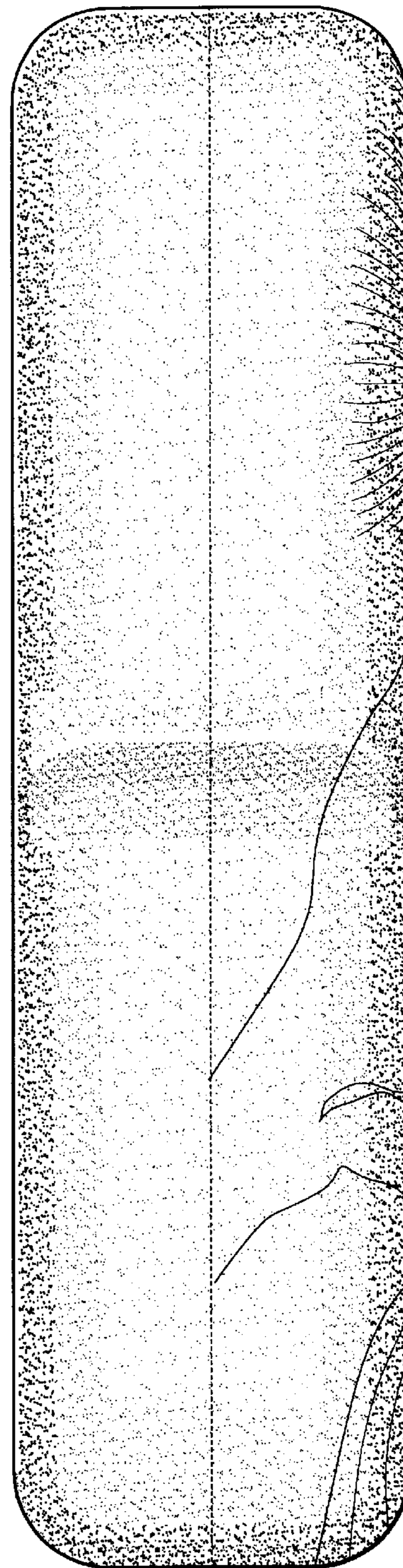

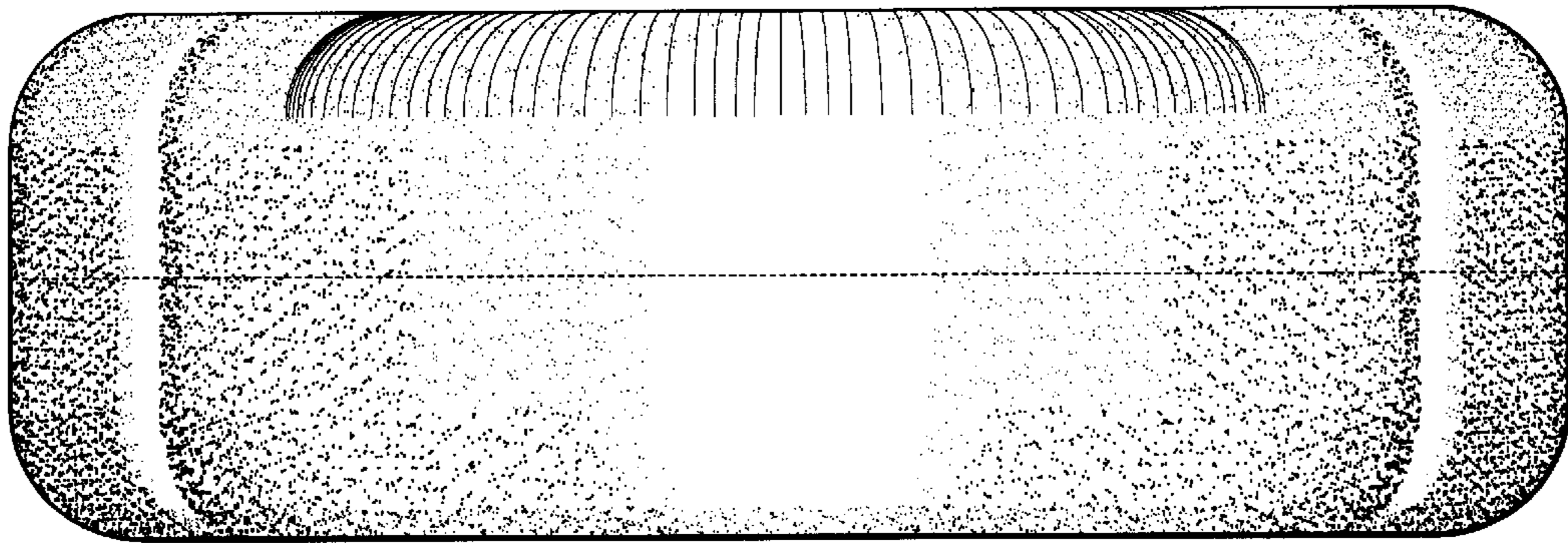




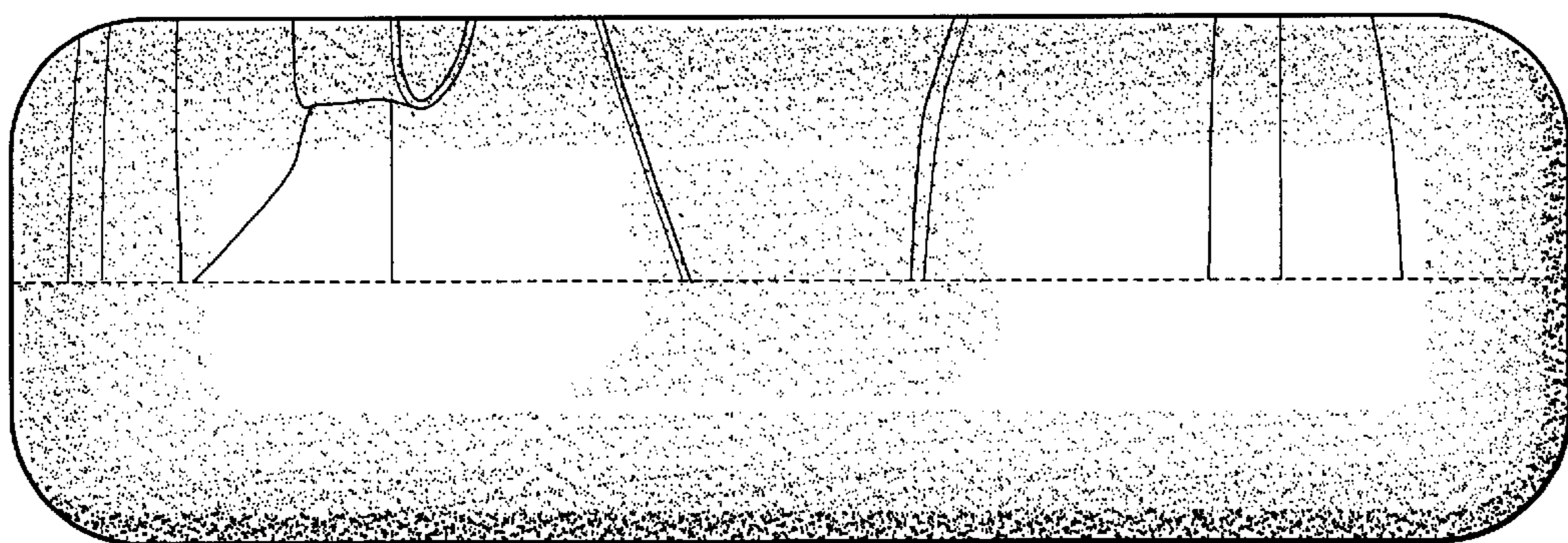
