(57) **CLAIM**

The ornamental design for a decorative bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of the decorative bottle according to the design, made of transparent material;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left-side elevational view thereof, the view from the opposite side being a mirror image;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a perspective view of a second embodiment of the decorative bottle shown in FIG. 1, made of non-transparent material;

FIG. 8 is a front elevational view thereof;

FIG. 9 is a rear elevational view thereof;

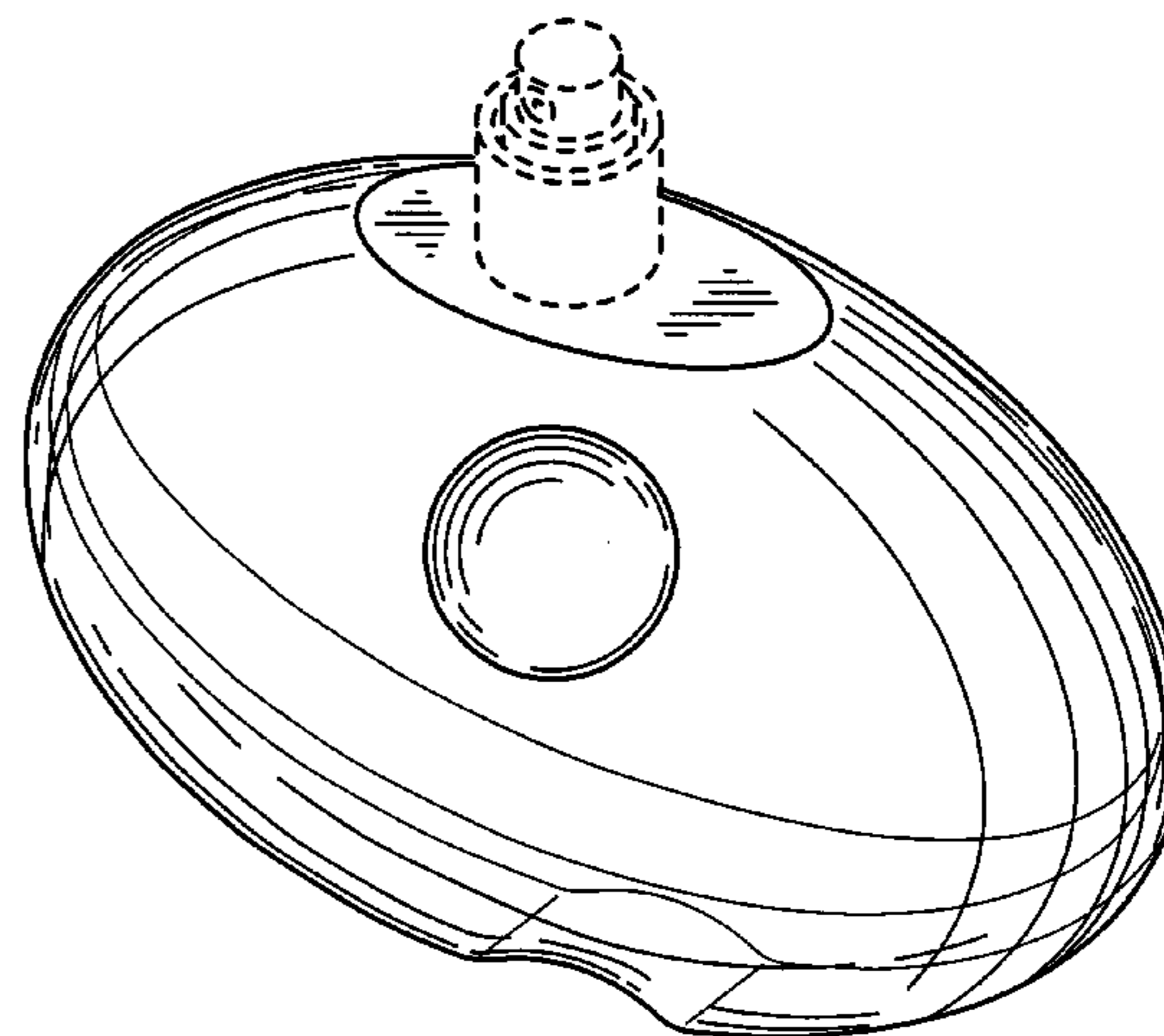
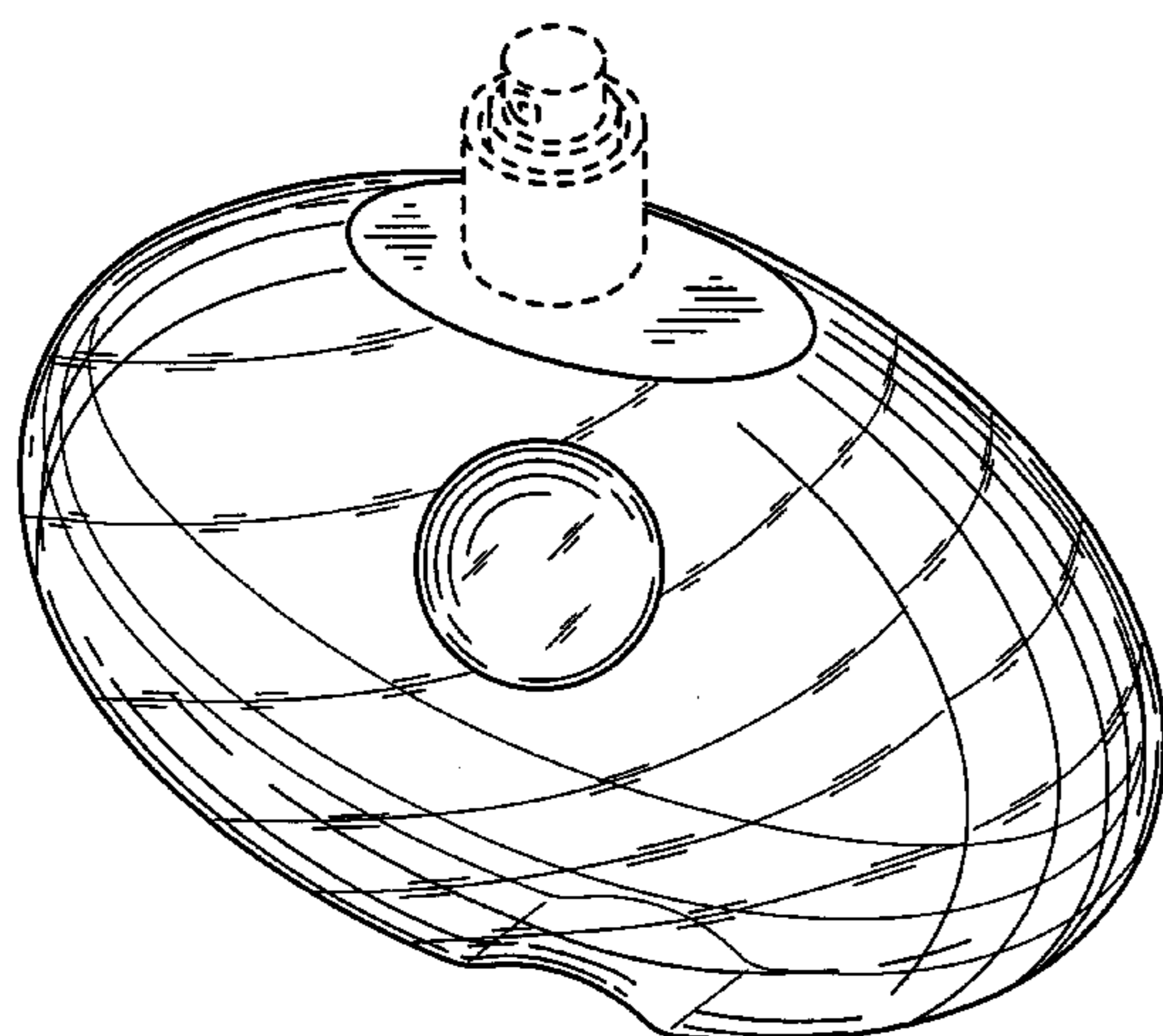
FIG. 10 is a left-side elevational view thereof, the opposite side being a mirror image;

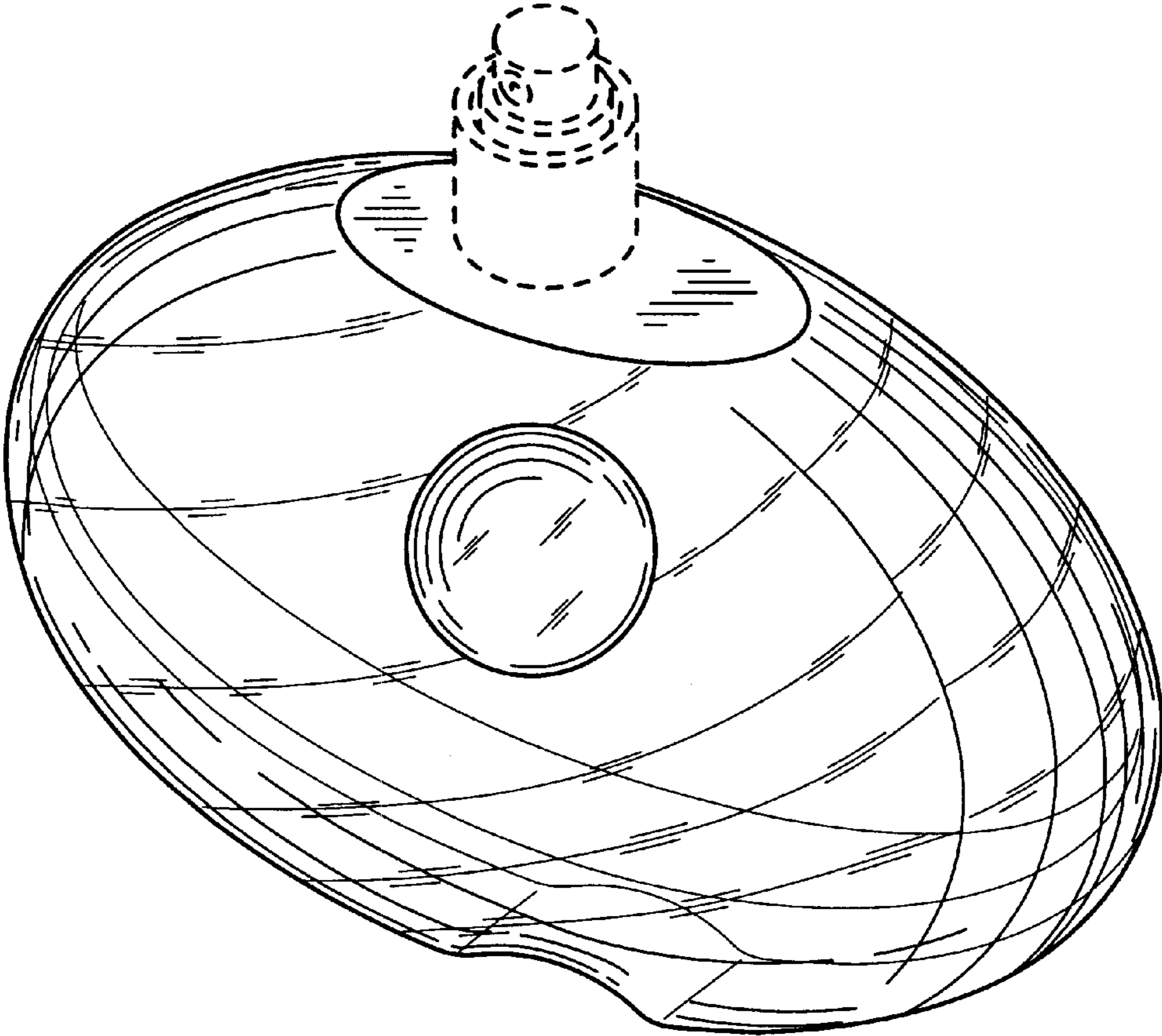

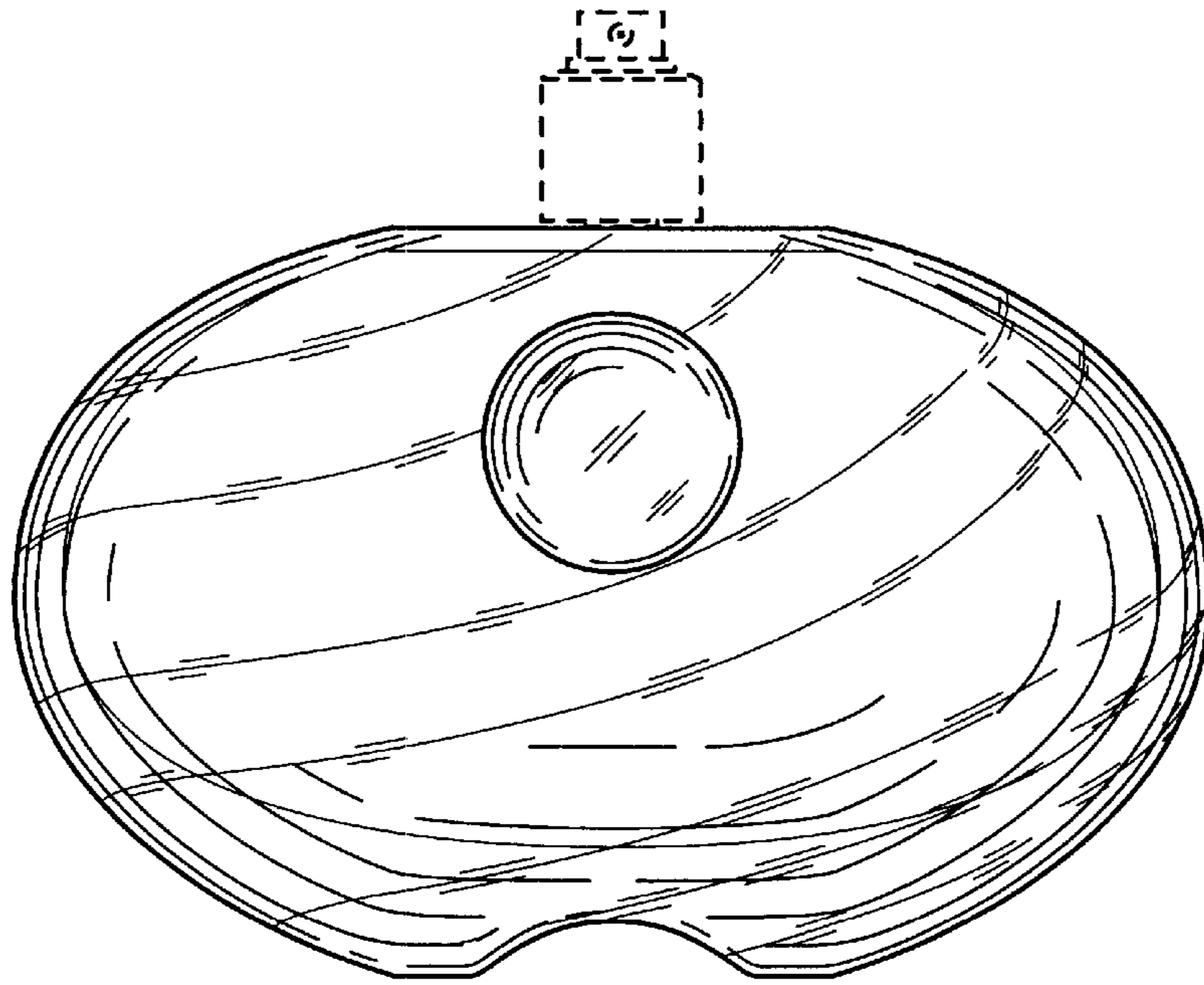

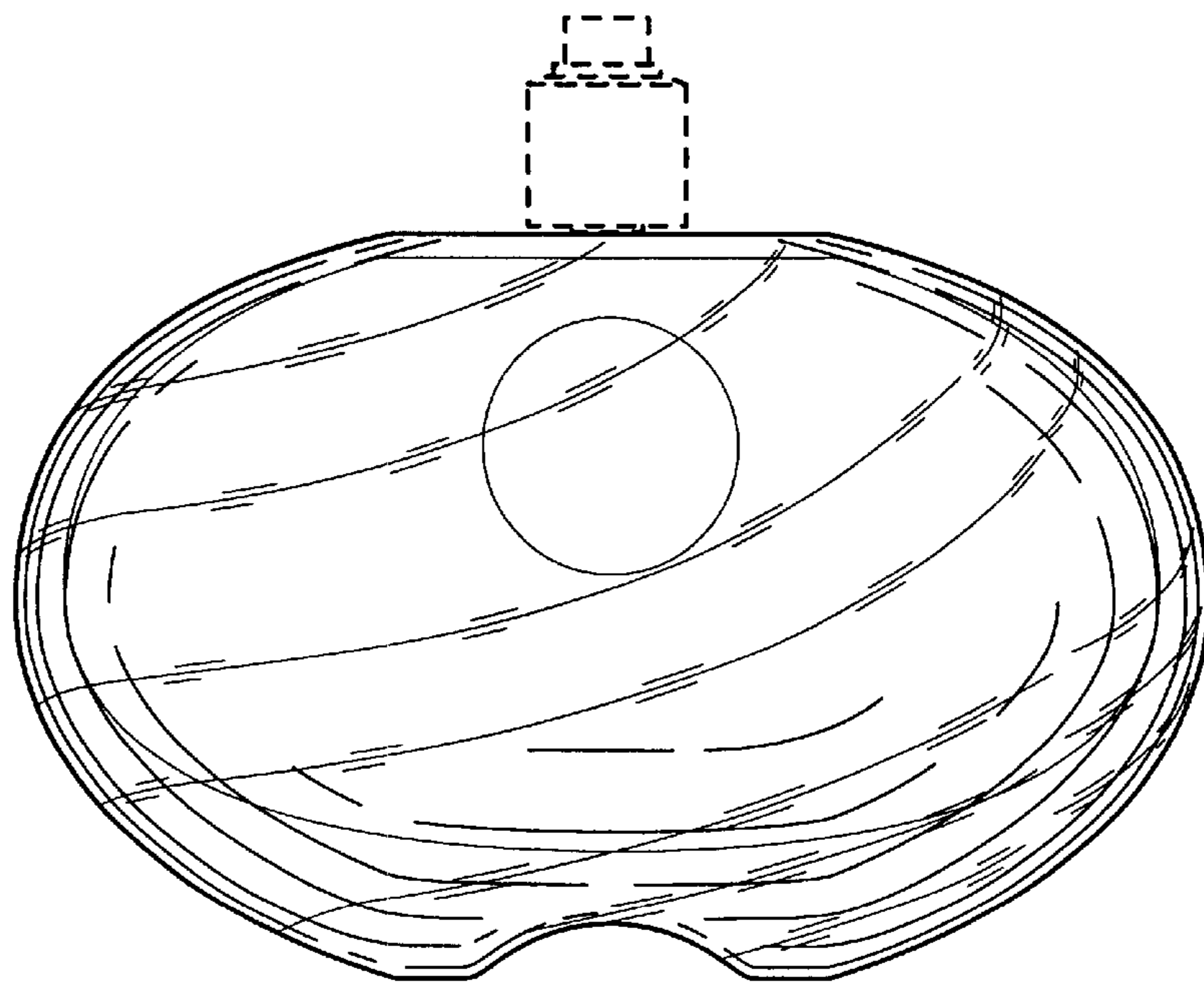

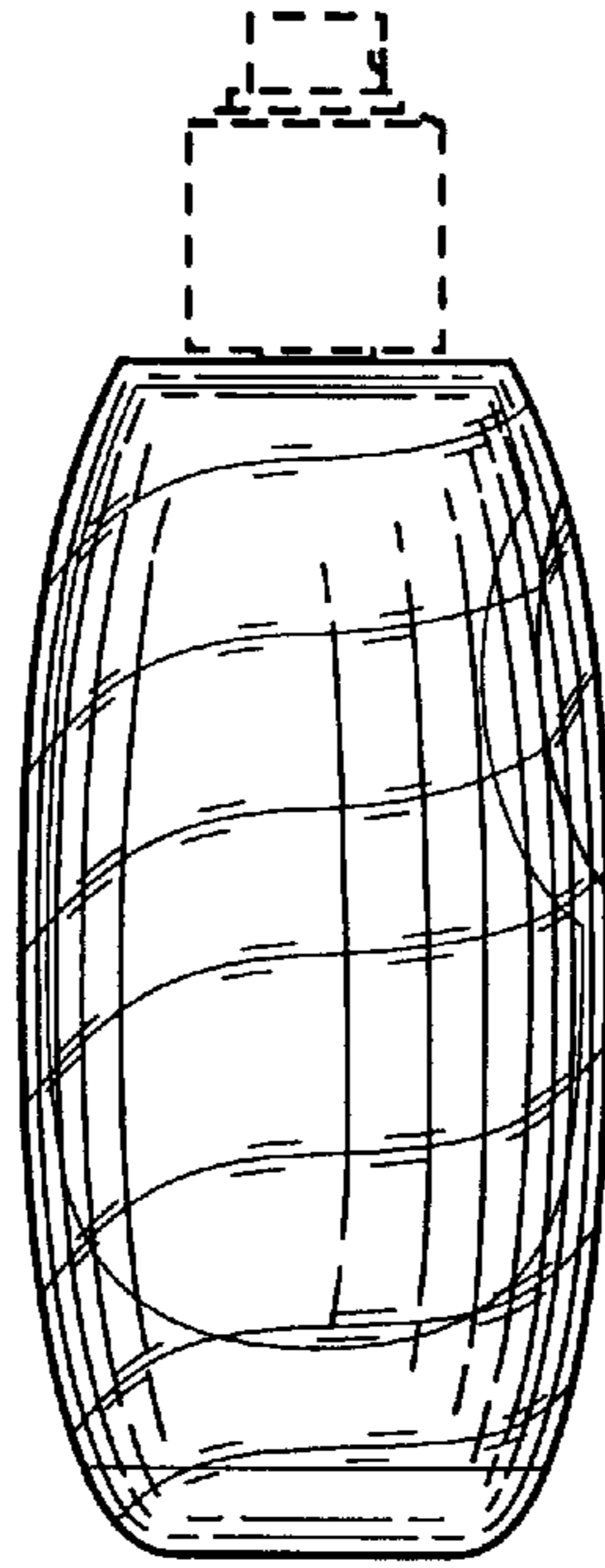

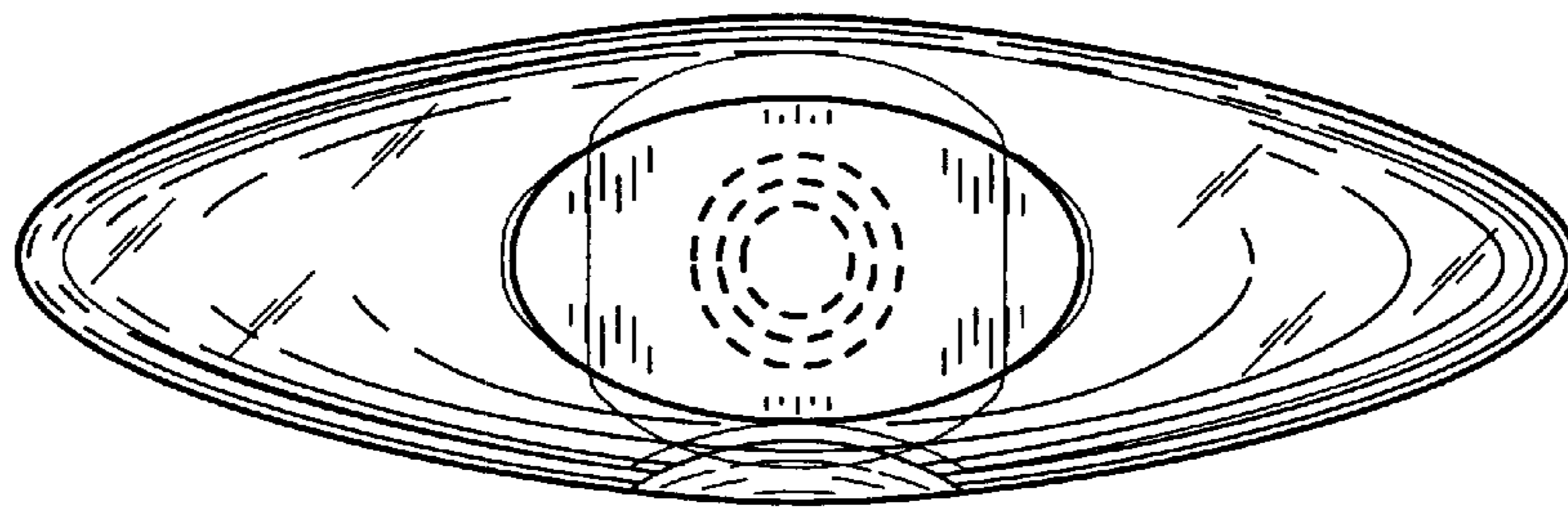

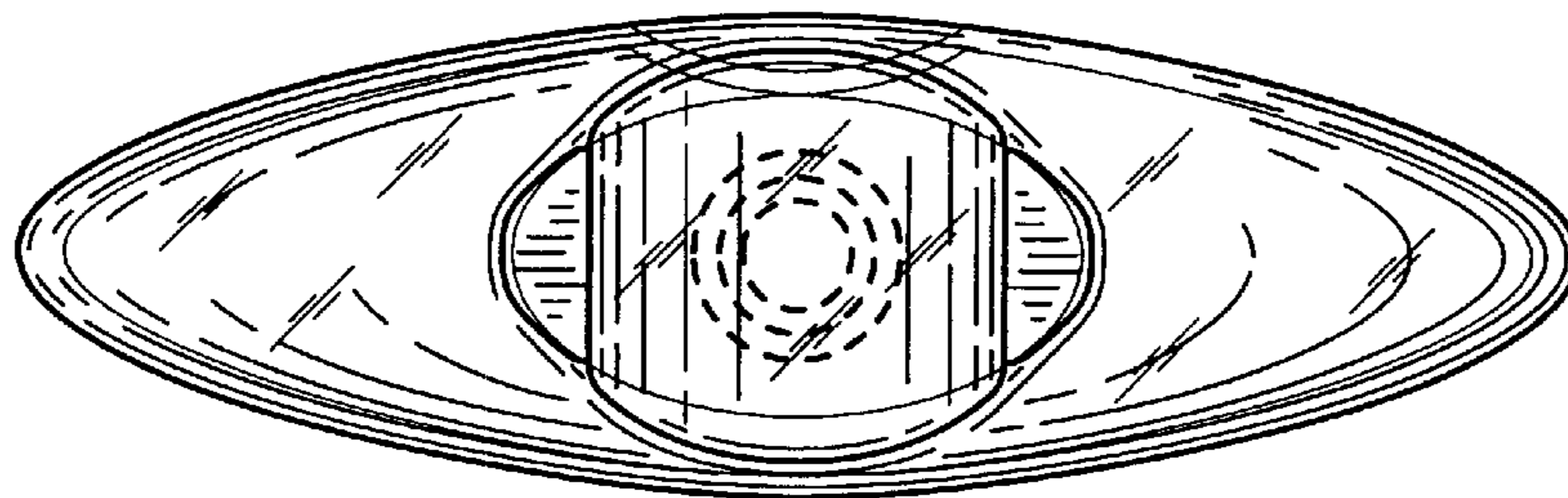

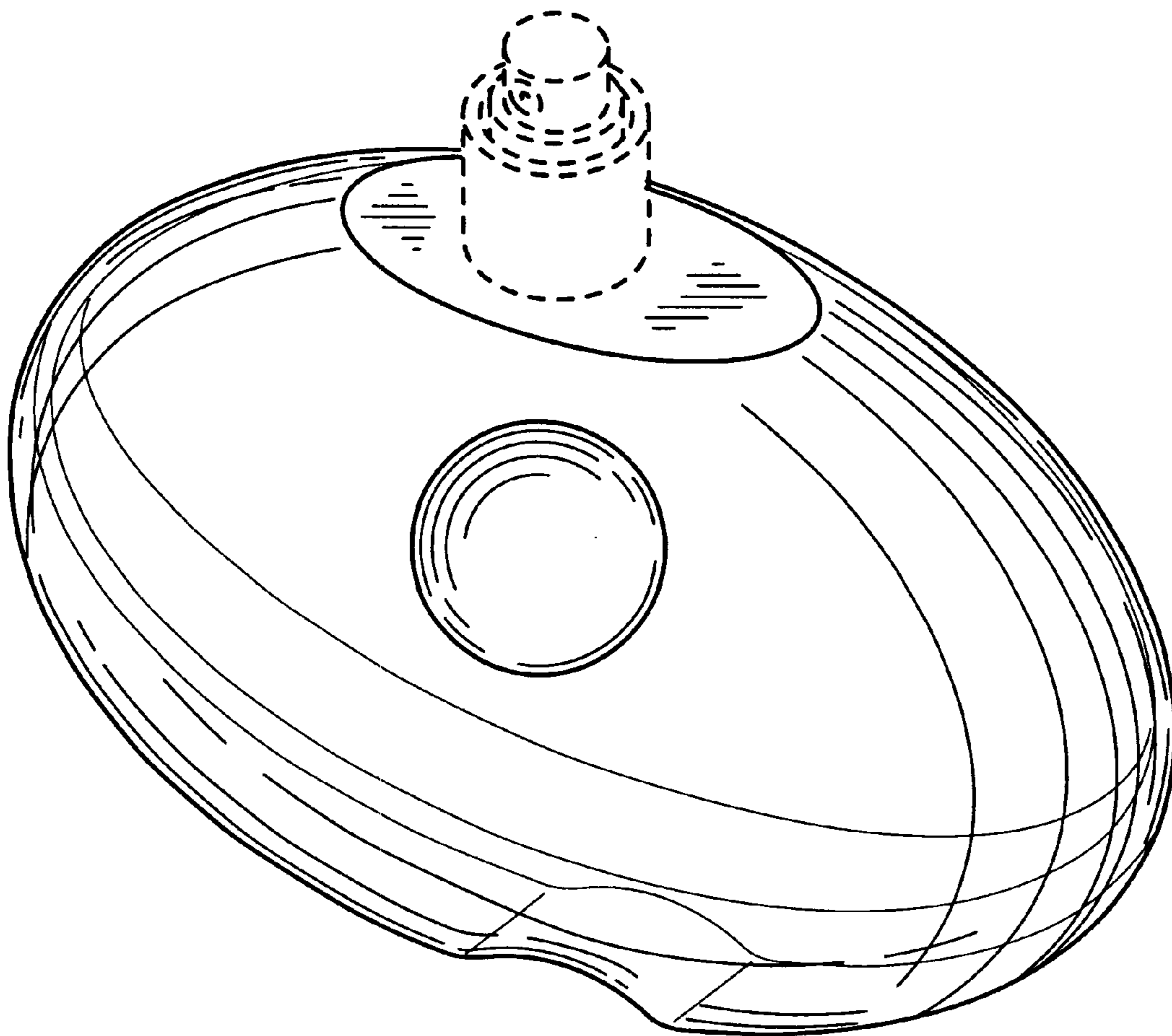

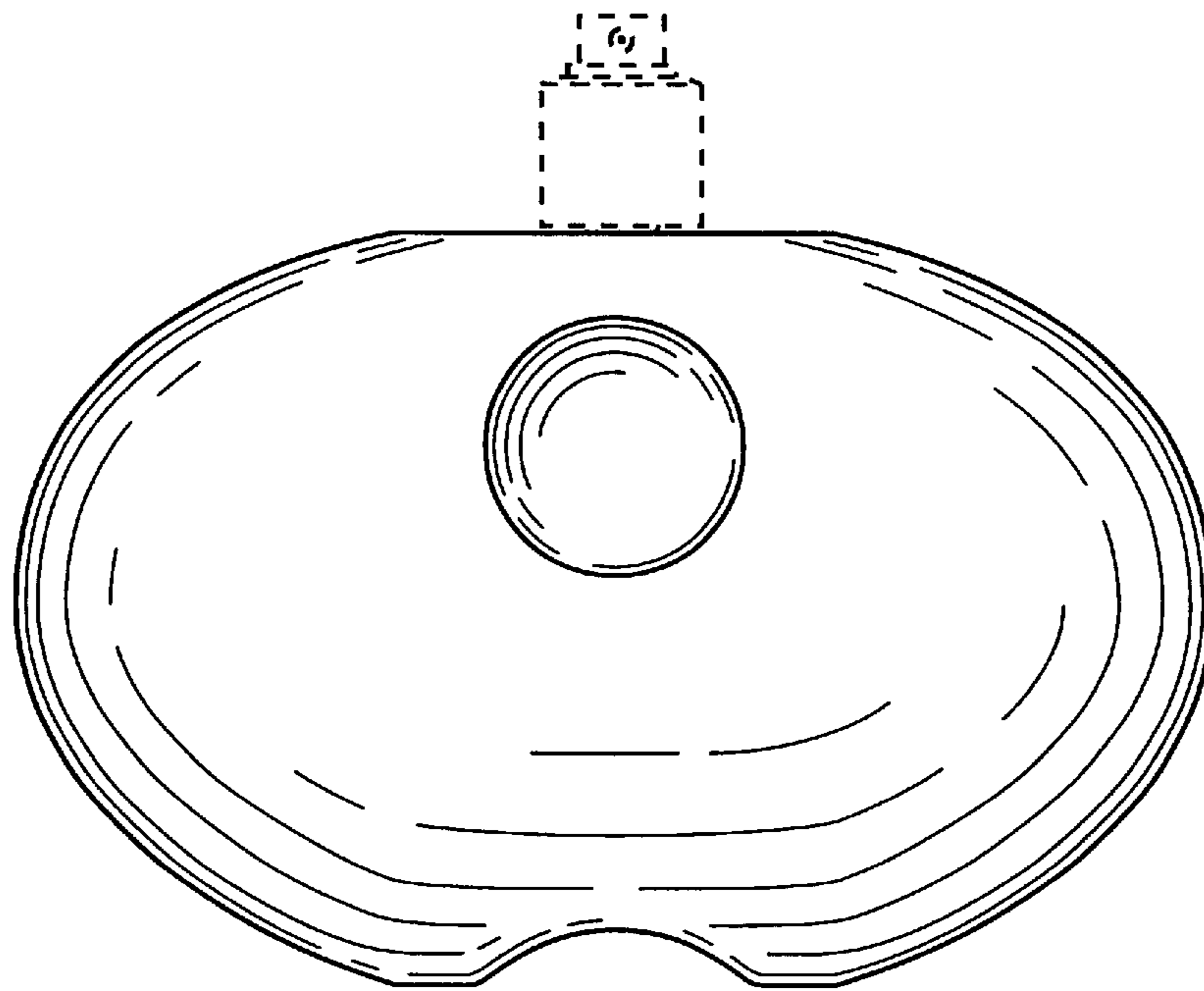

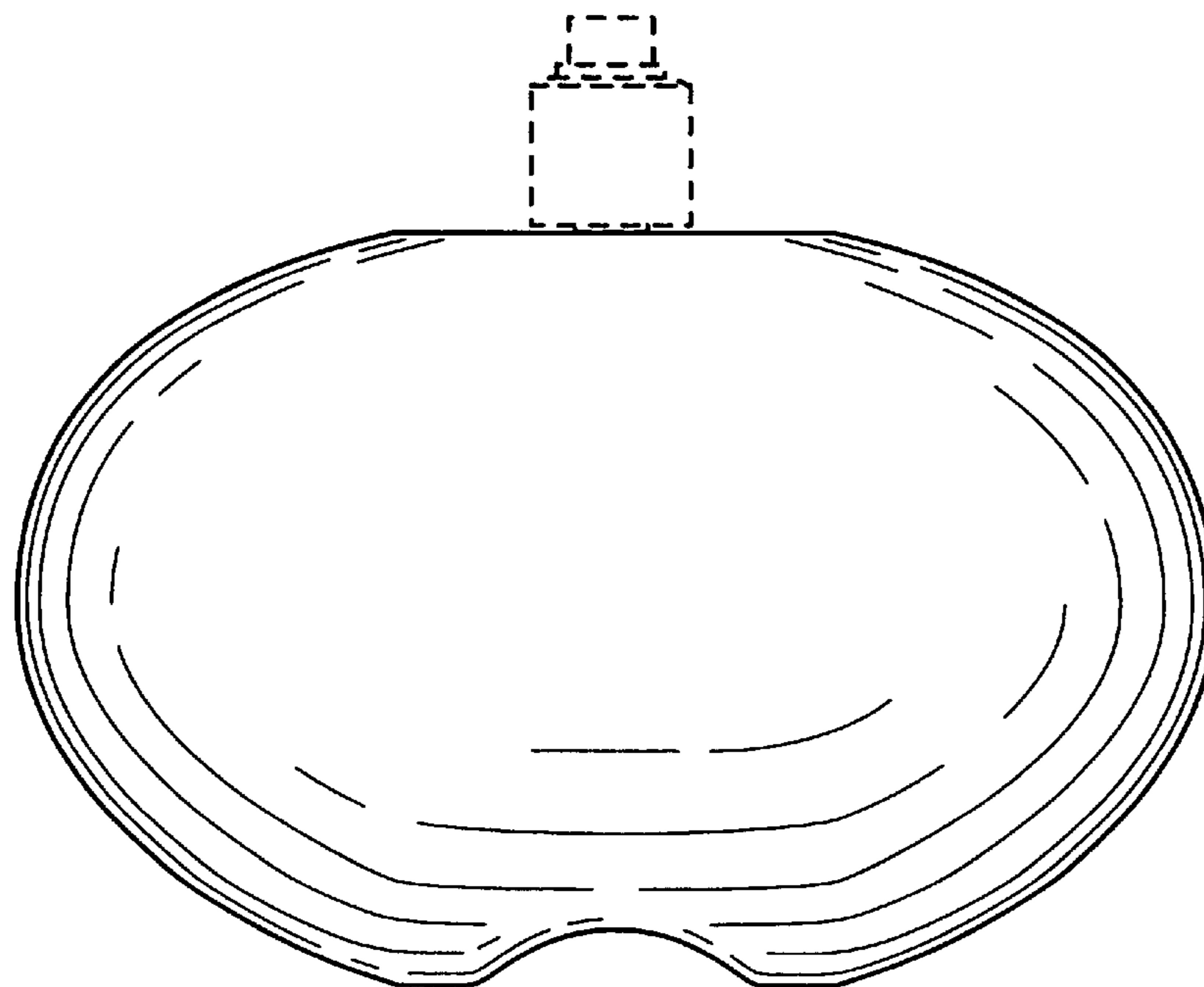

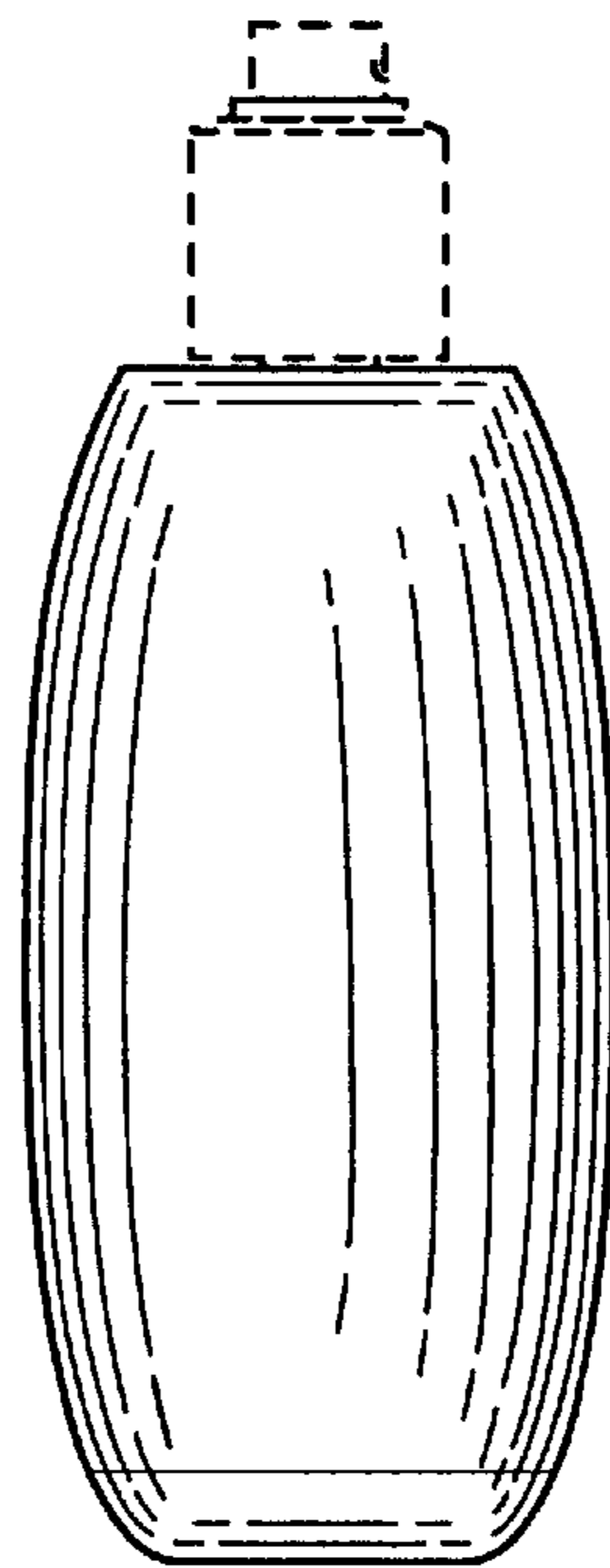

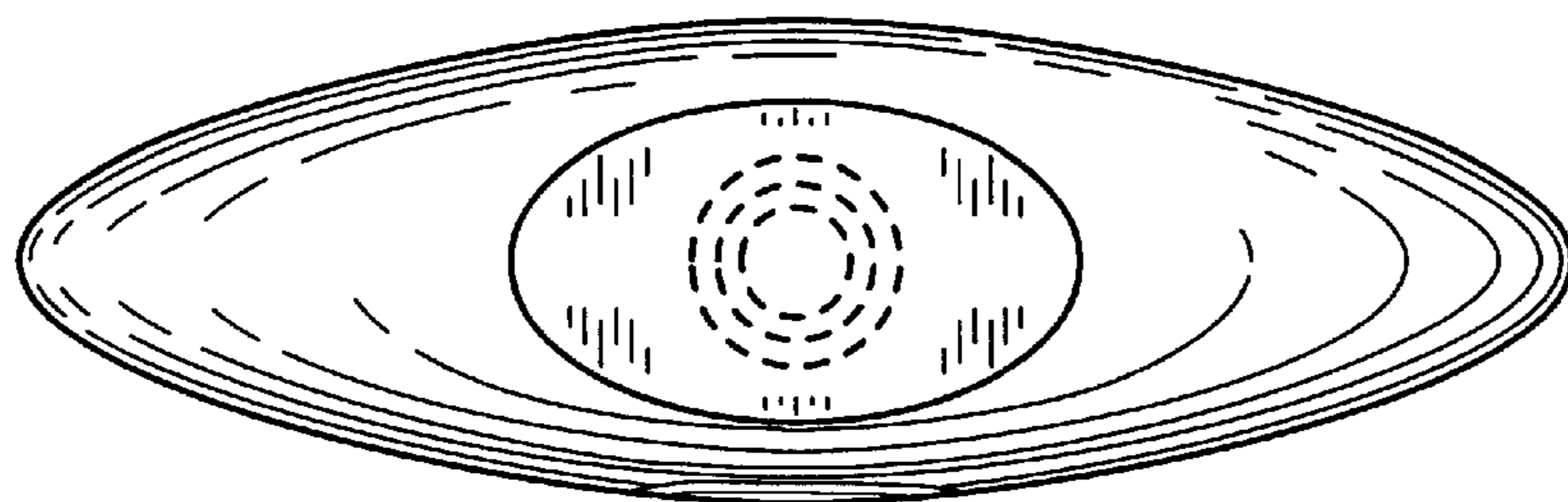

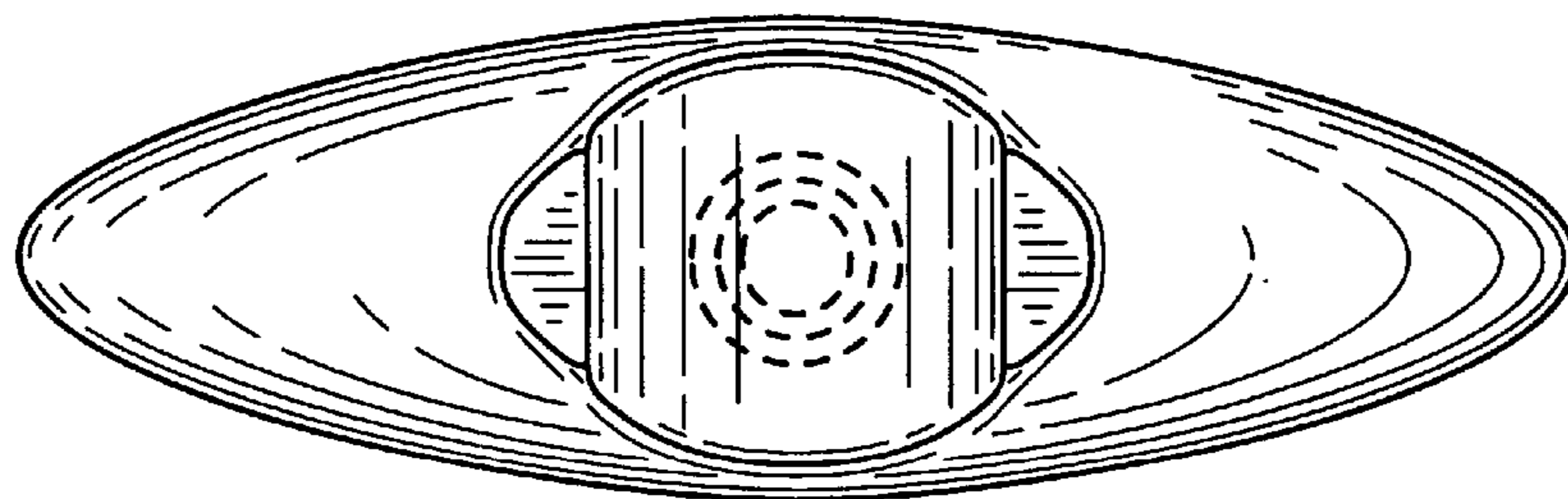
