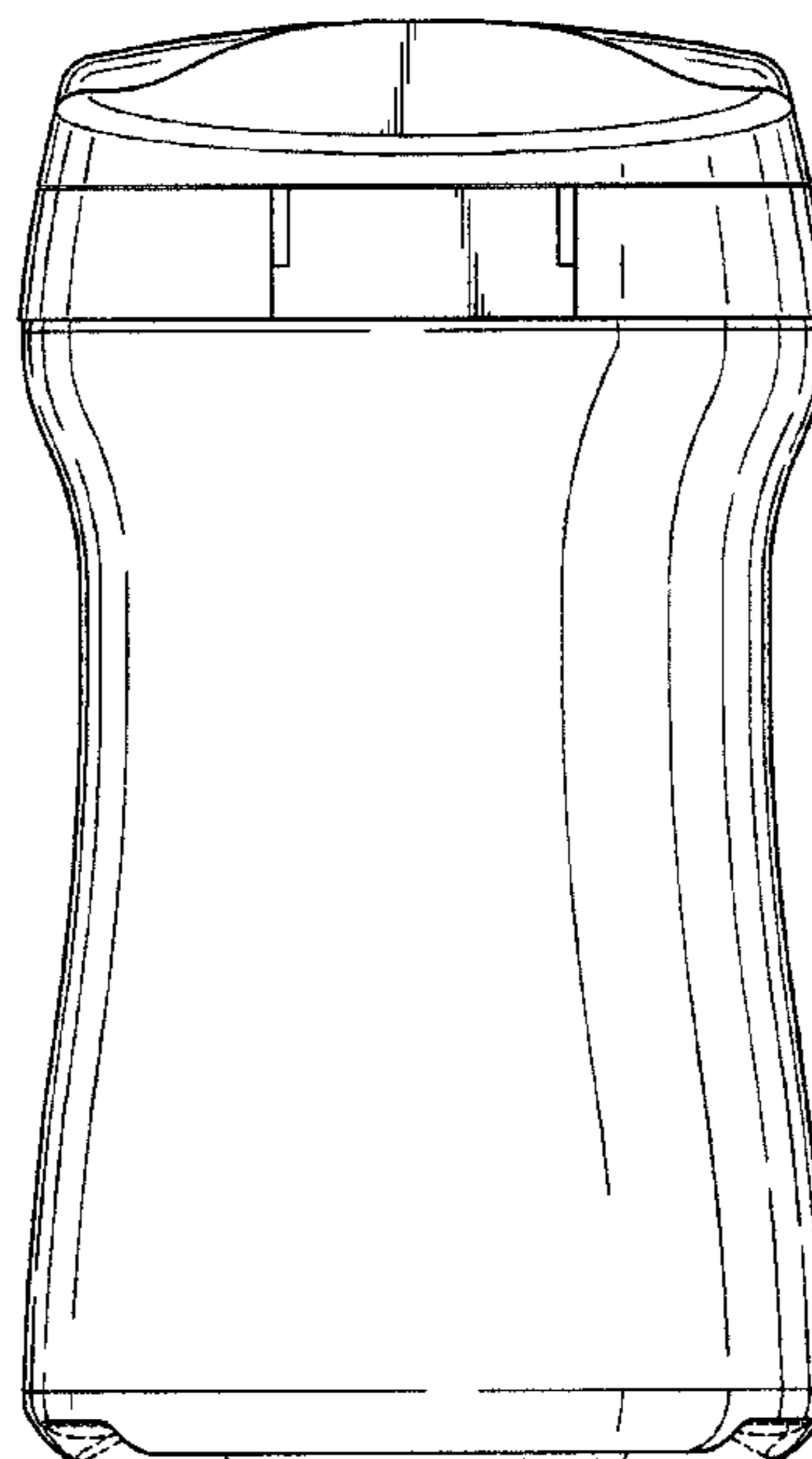
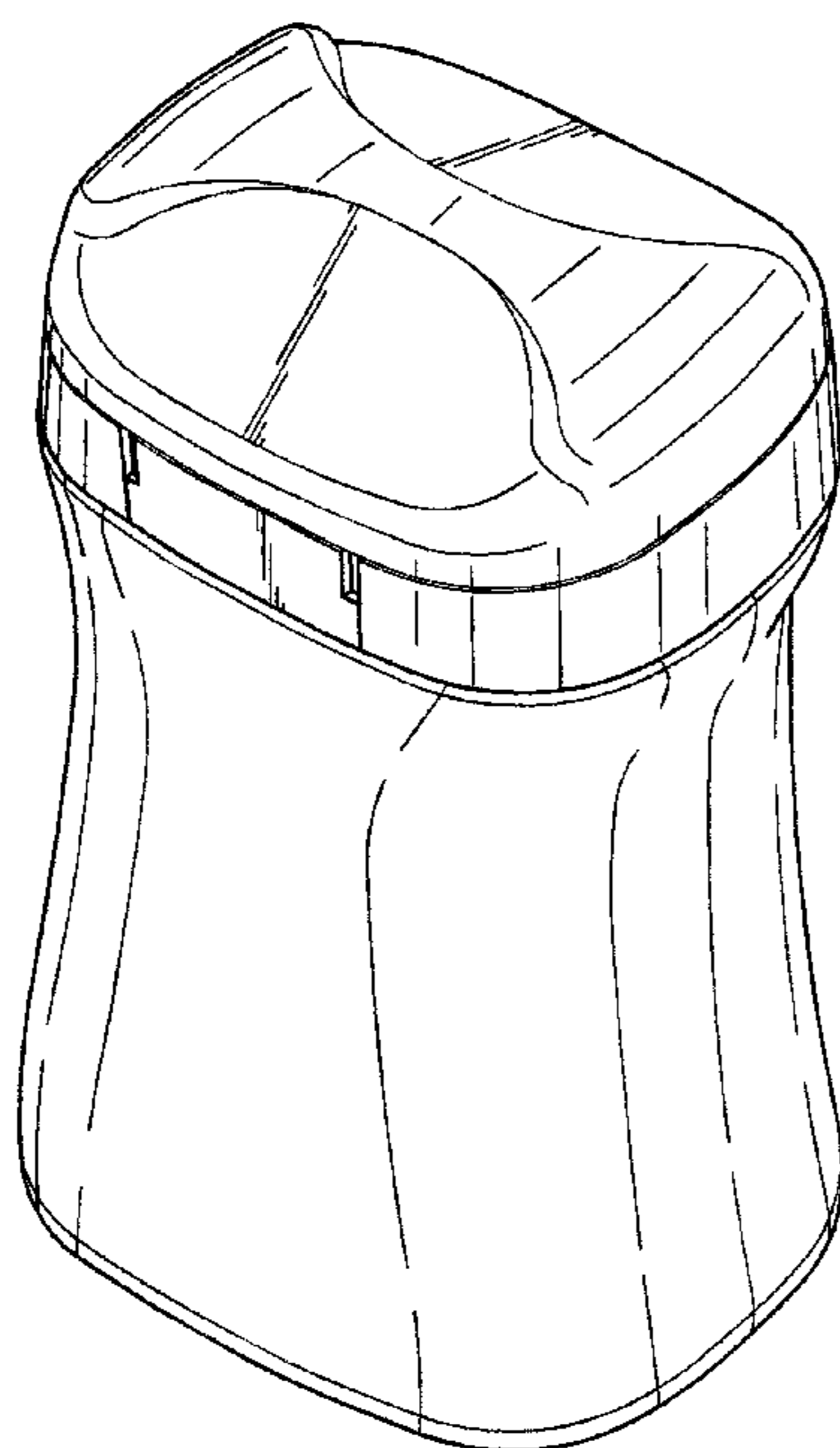
(57) **CLAIM**

The ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the container of the invention;
FIG. 2 is a front view of the container thereof;
FIG. 3 is a rear view of the container thereof;
FIG. 4 is a right side view of the container thereof, the left side view being a mirror image;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is a perspective view of the container thereof, shown with the lid in open condition.
The broken lines shown in the drawings are for illustrative purposes only and form no part of the claimed design.

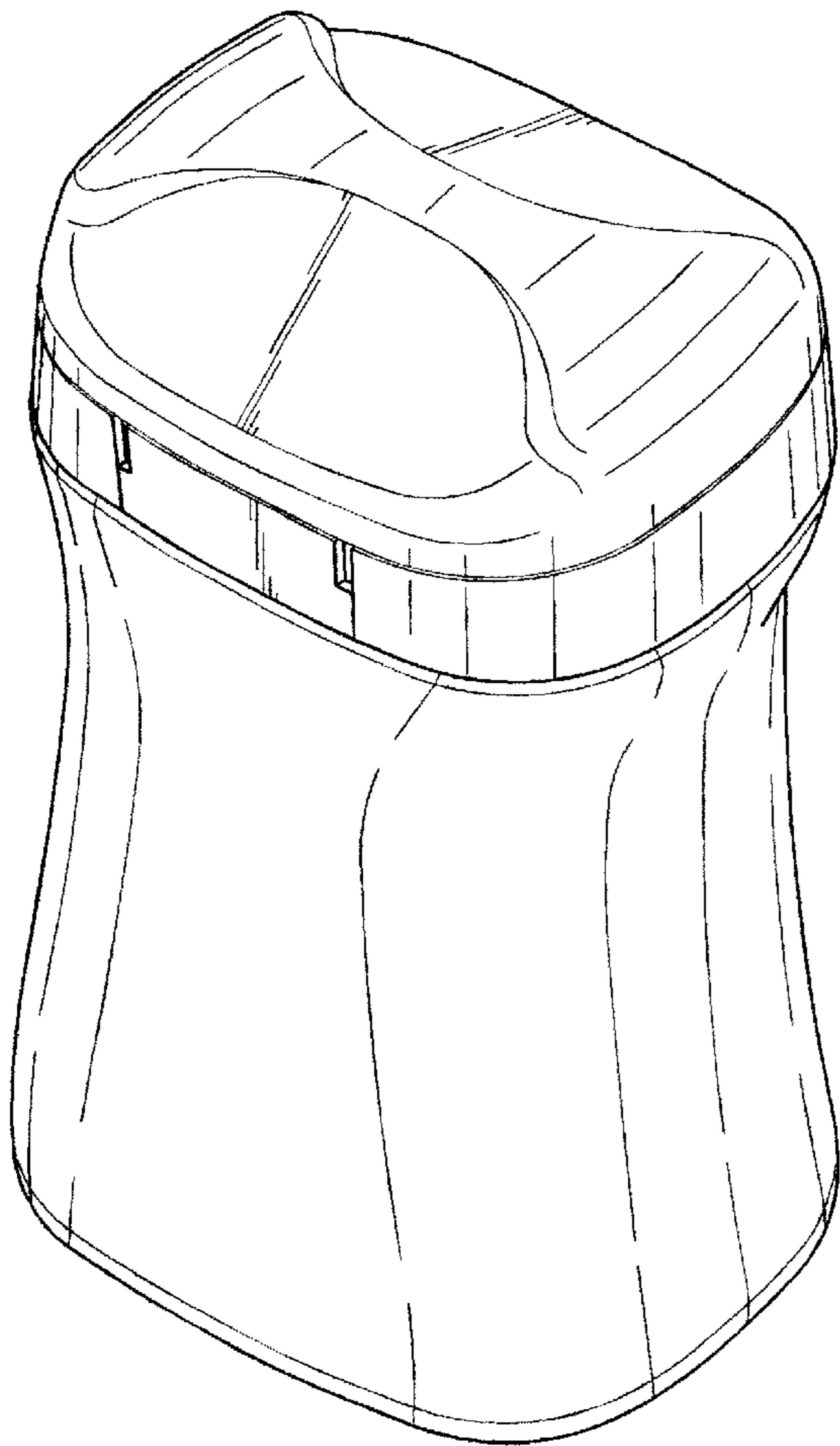

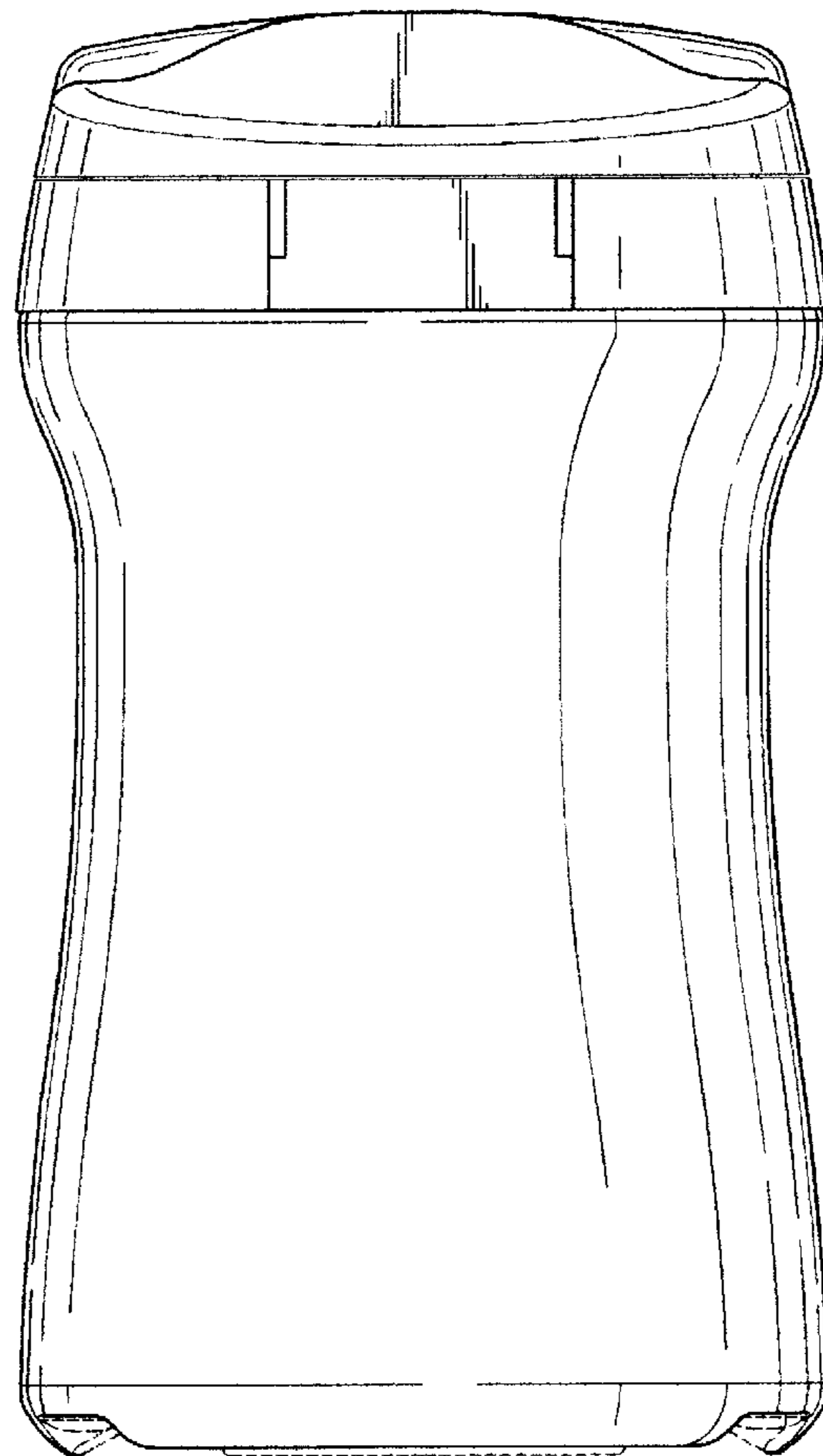

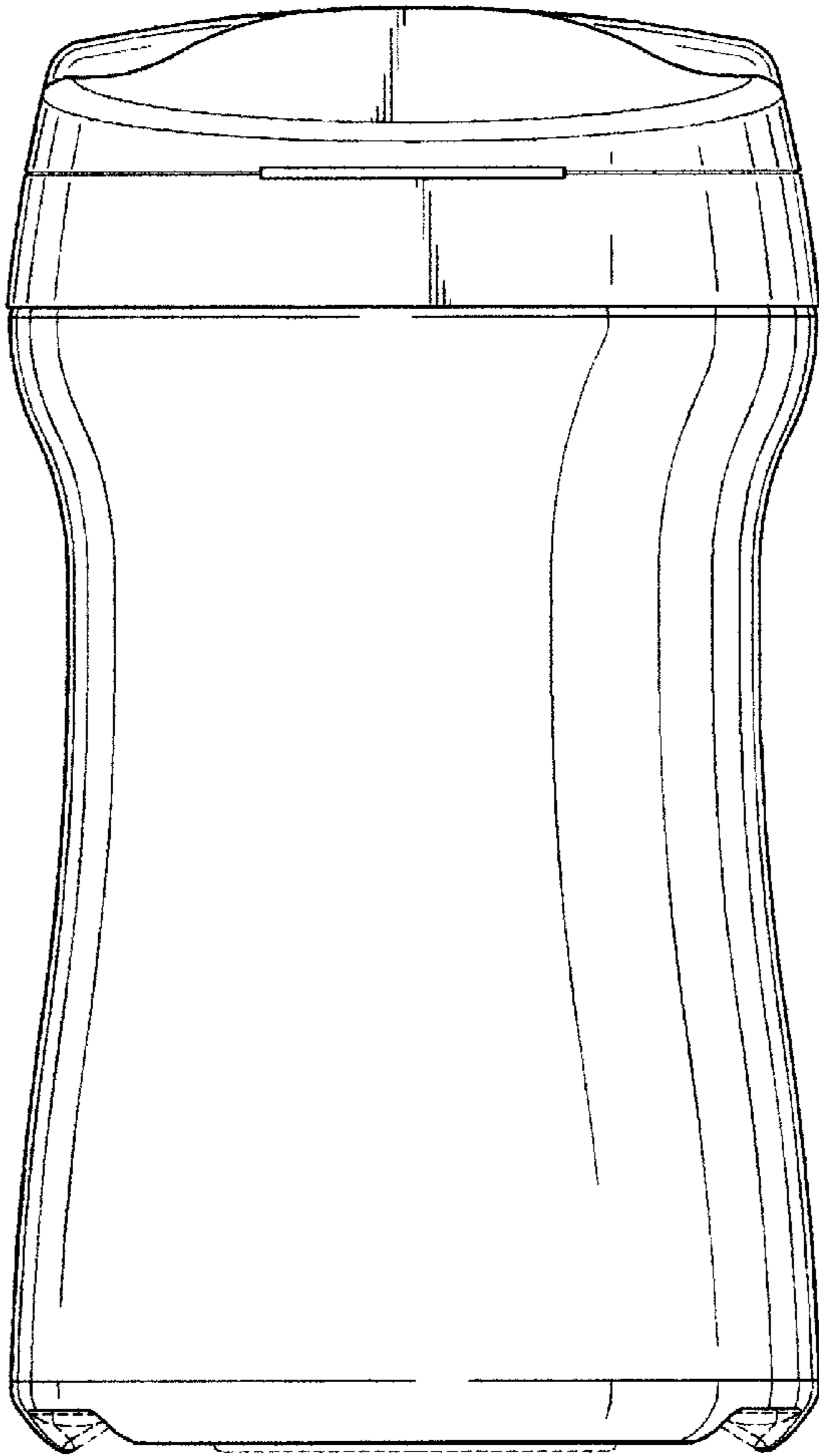

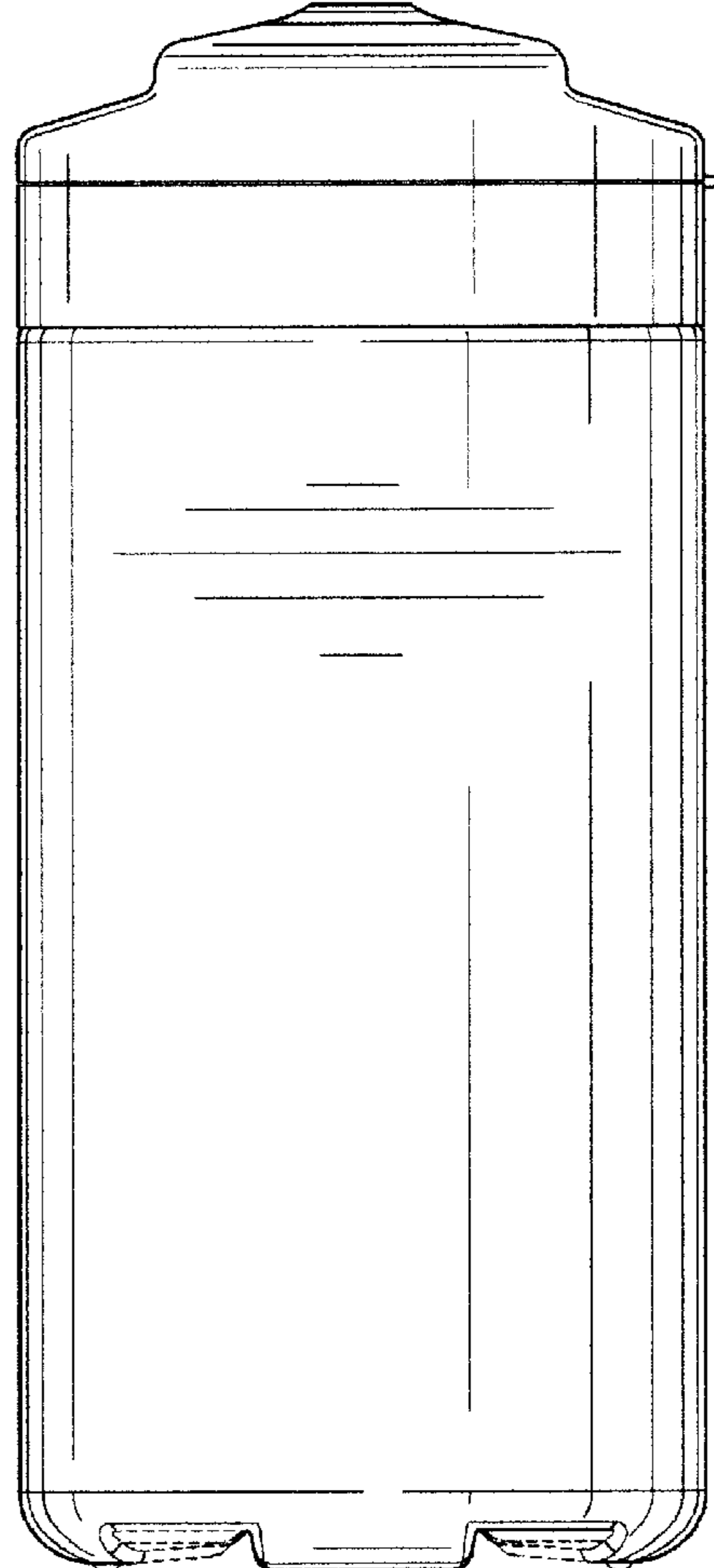

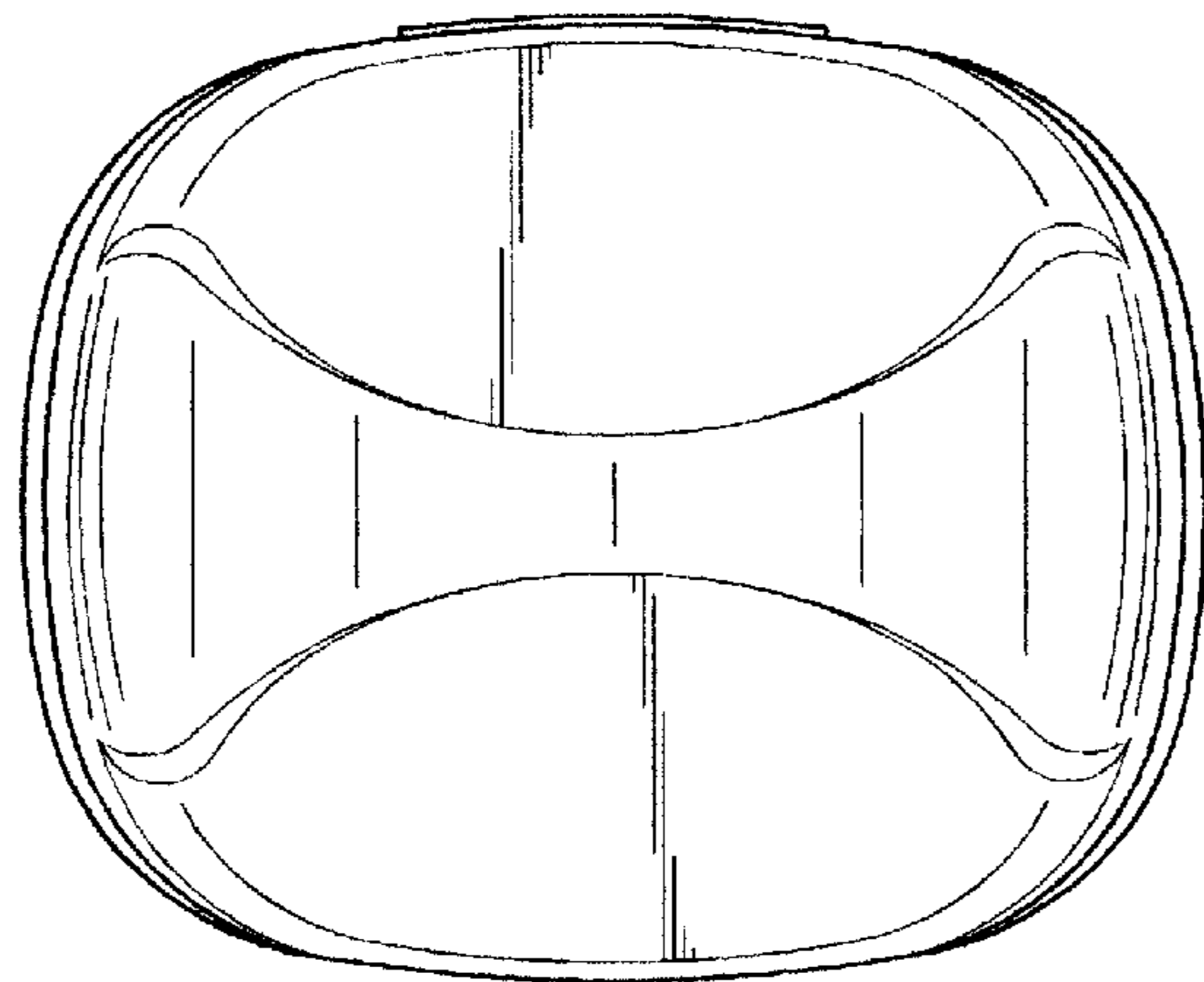

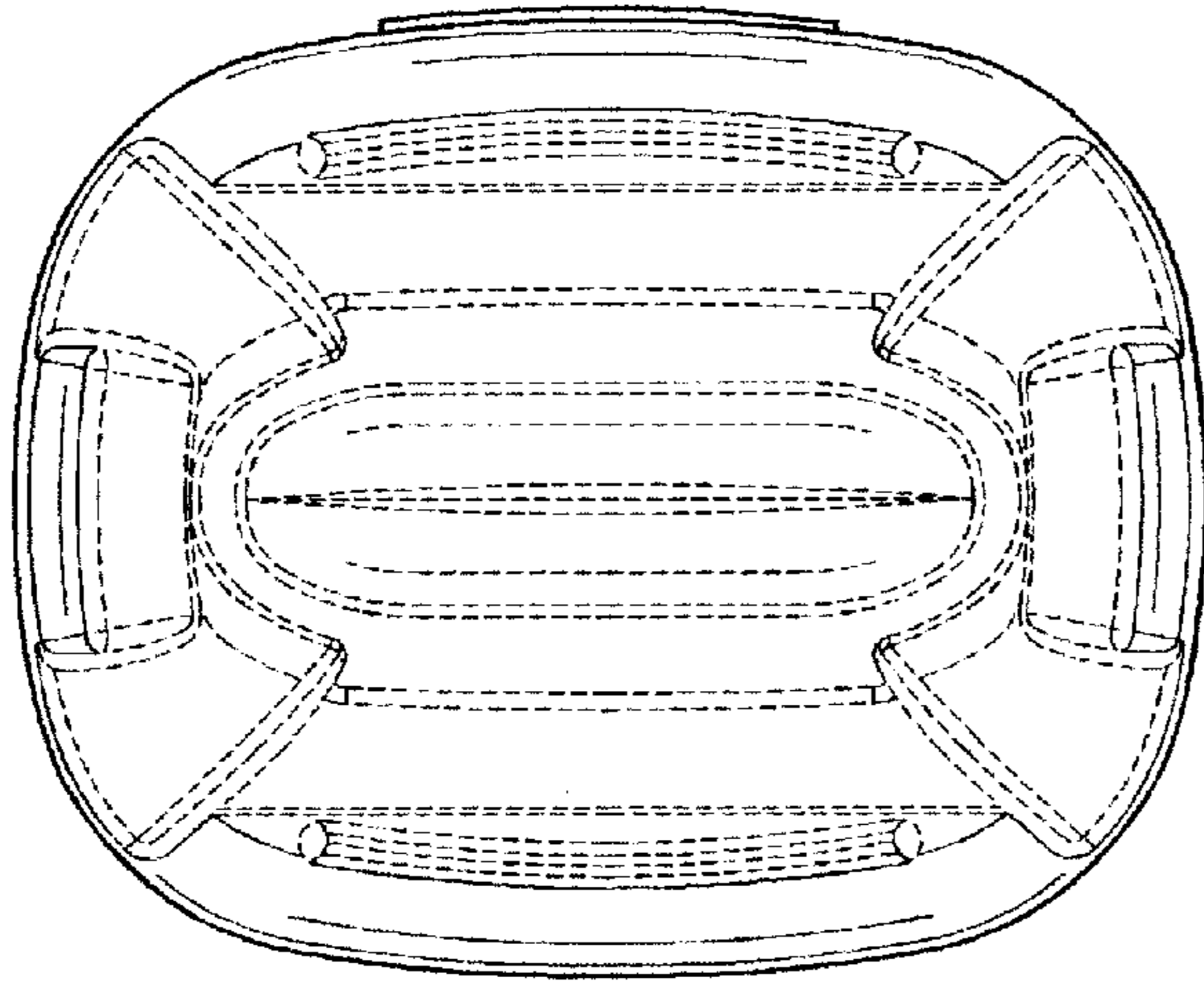

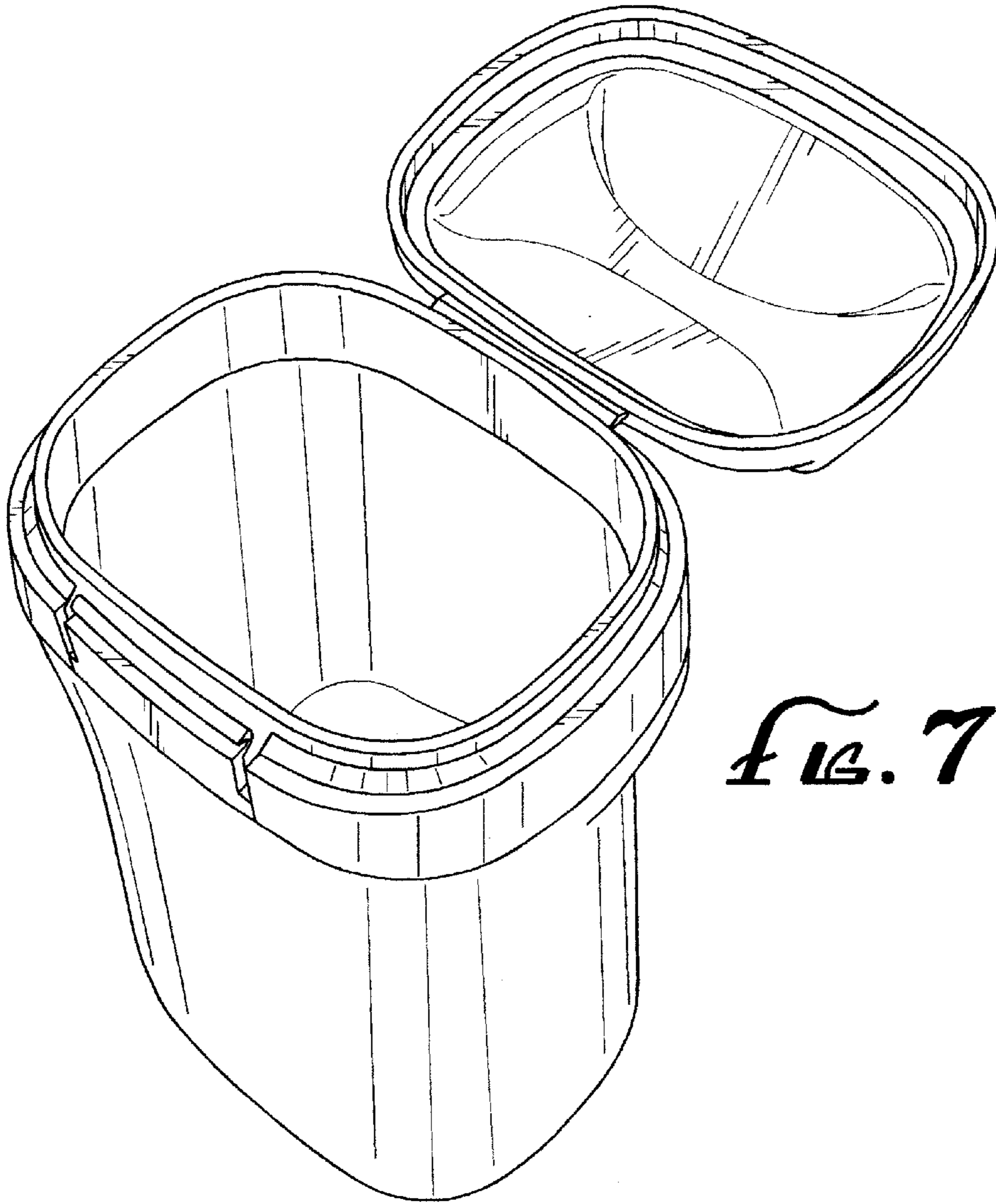
