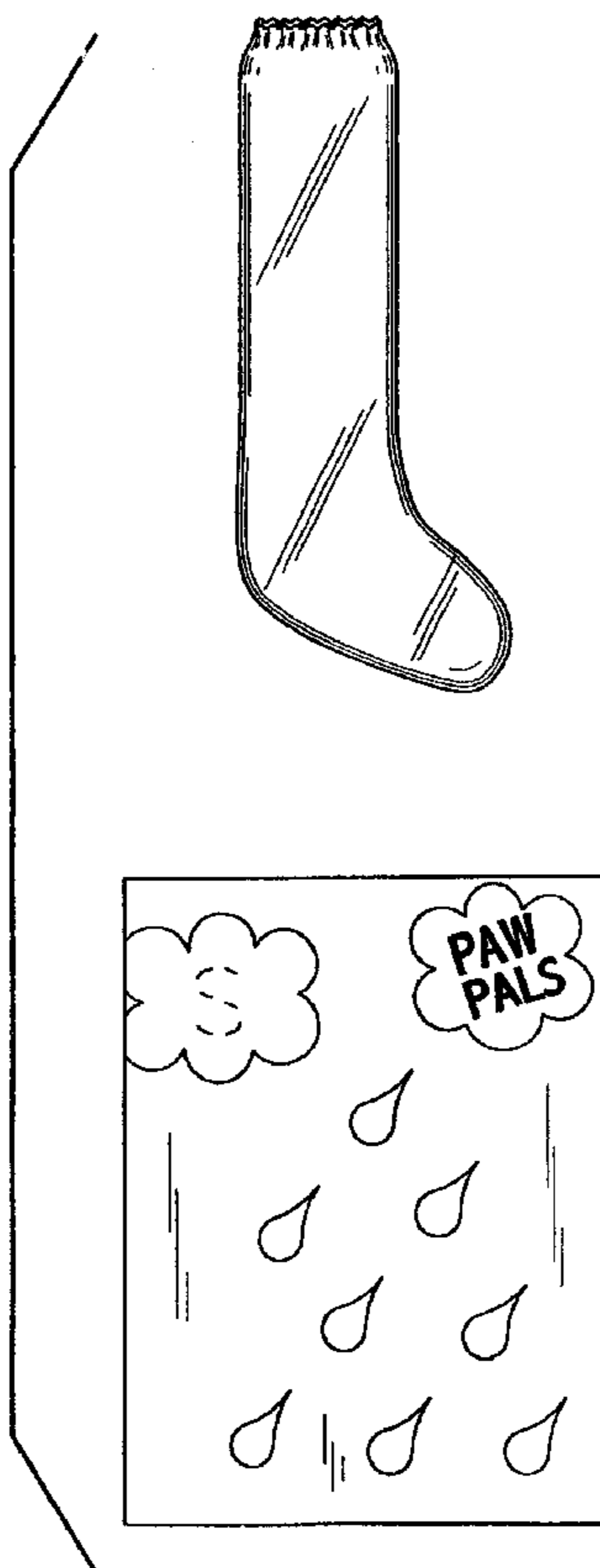
(57) **CLAIM**

The ornamental design for a paw covering and packaging combination, as shown and described.

DESCRIPTION

FIG. 1 is a front elevated view of a paw covering and packaging combination showing my new design; FIG. 2 is a right side elevated view of the paw covering and packaging combination; FIG. 3 is a left side elevated view of the paw covering and packaging combination; FIG. 4 is a top plan view of the paw covering and packaging combination; and, FIG. 5 is a bottom plan view of the paw covering and packaging combination.

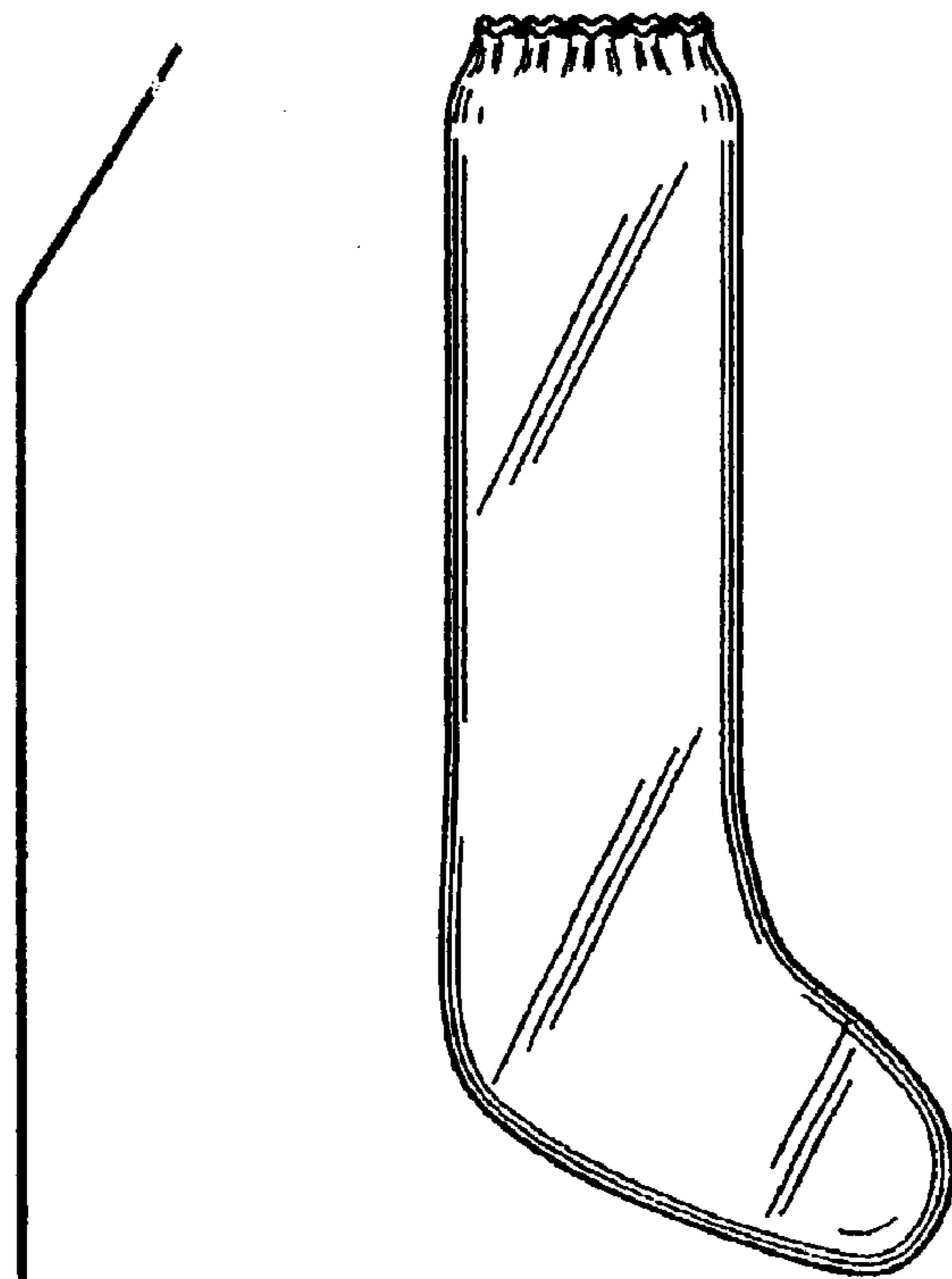

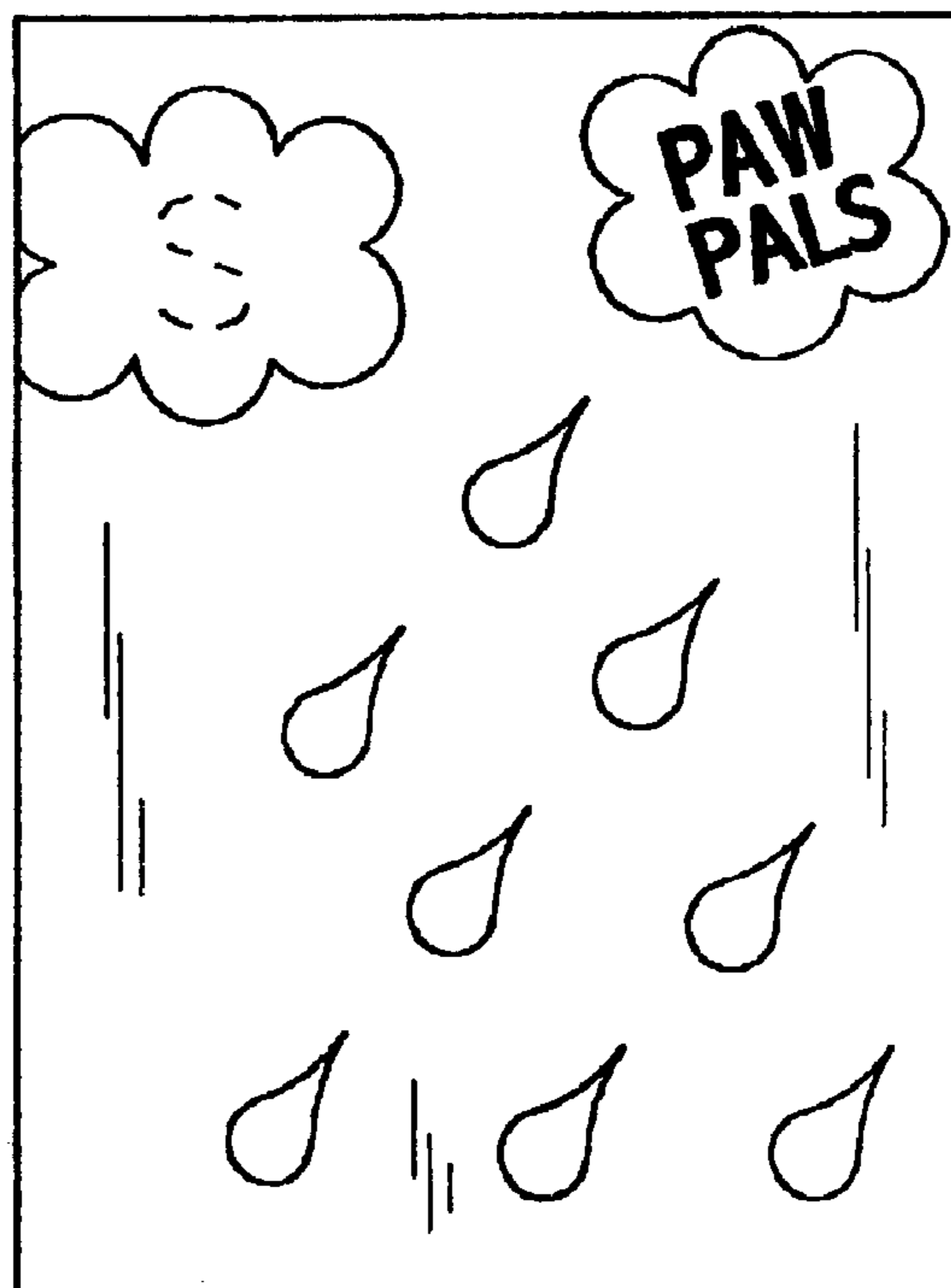
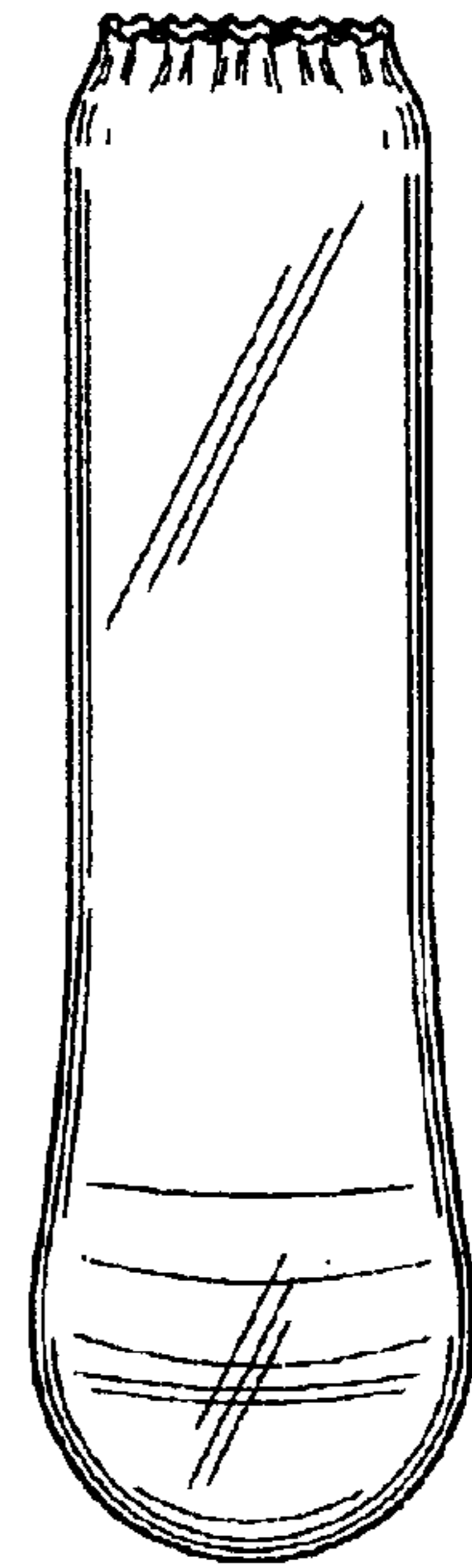
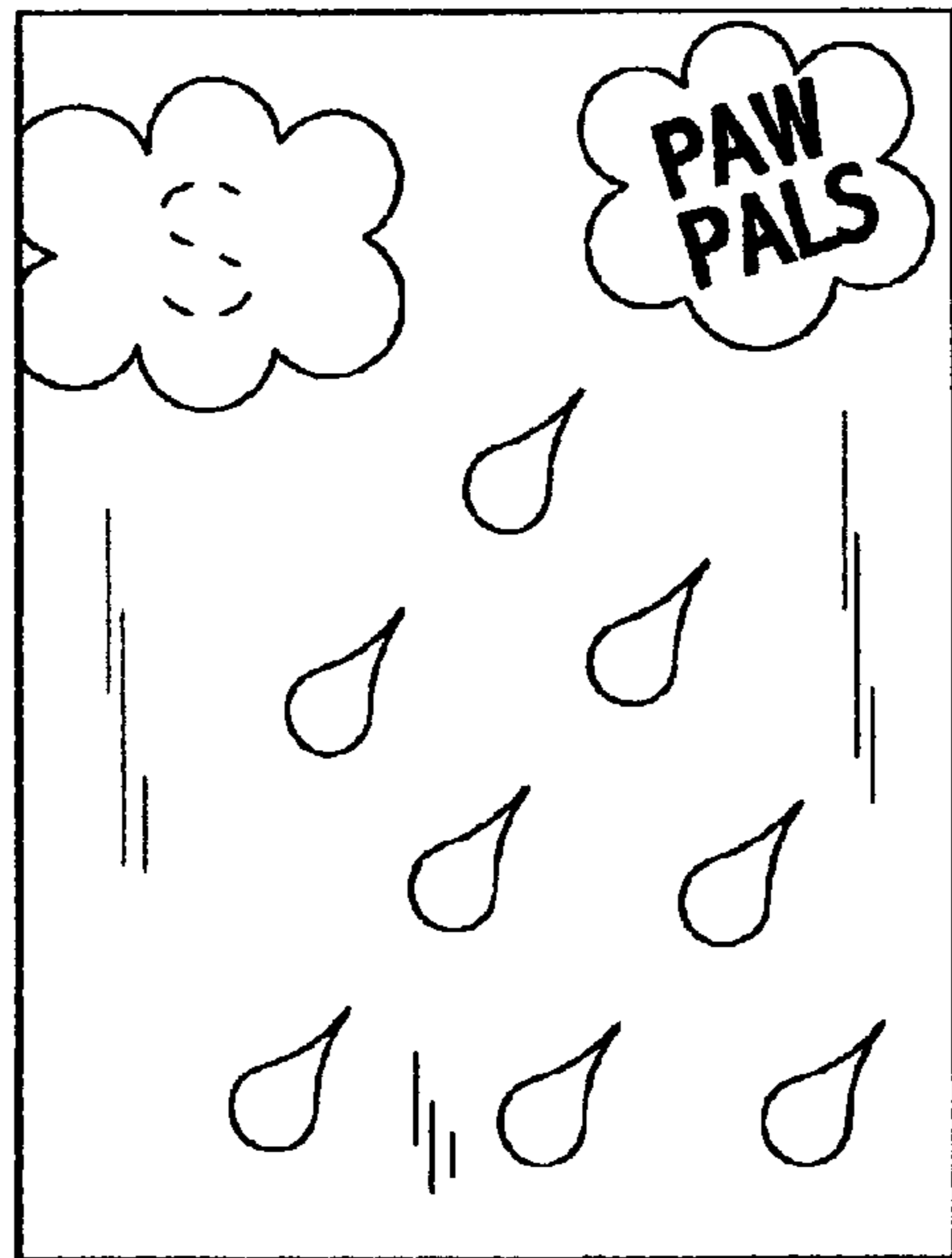

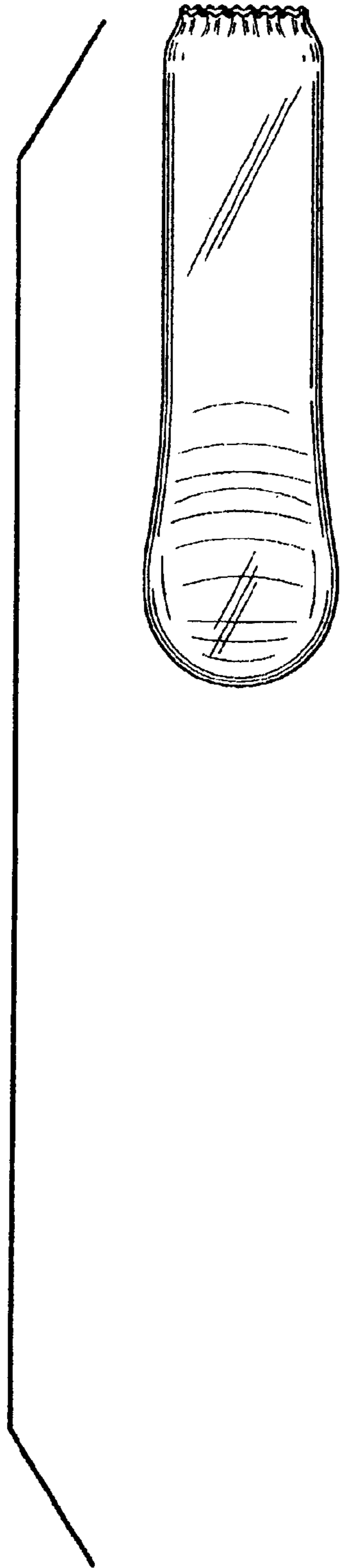

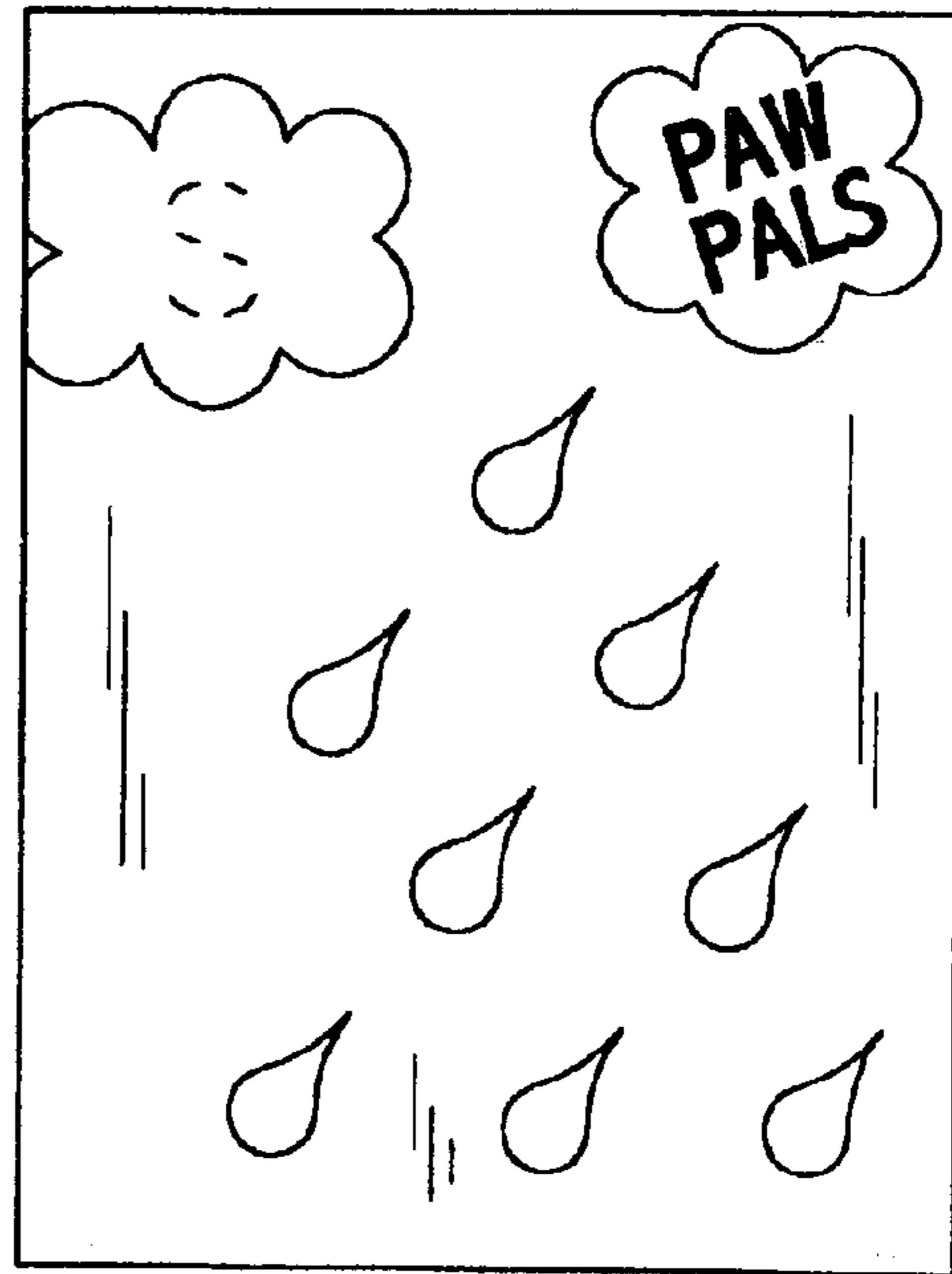

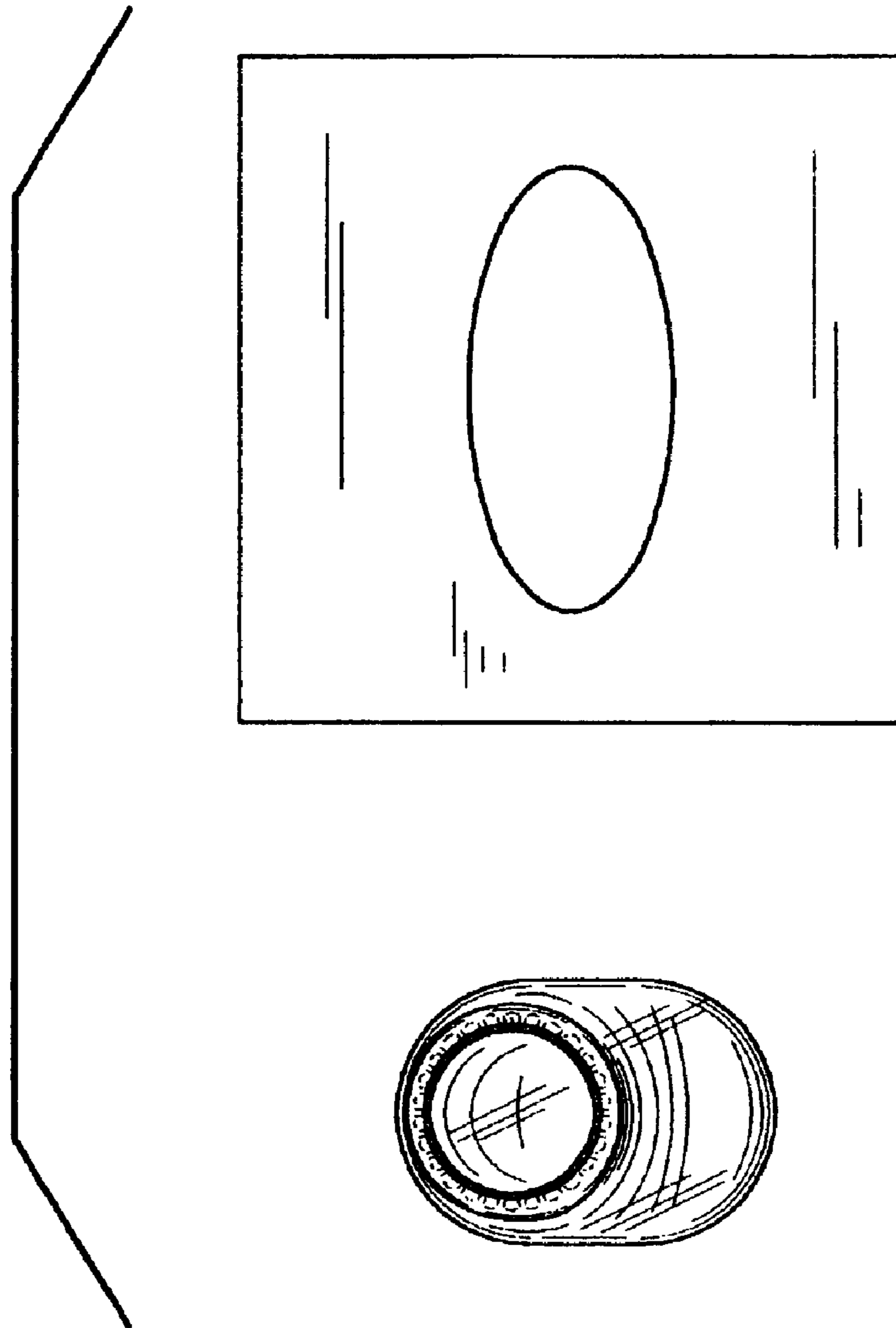
