DESCRIPTION

FIG. 1 is a front elevational view of a watch case in
accordance with the invention;

FIG. 2 is a rear elevational view thereof;

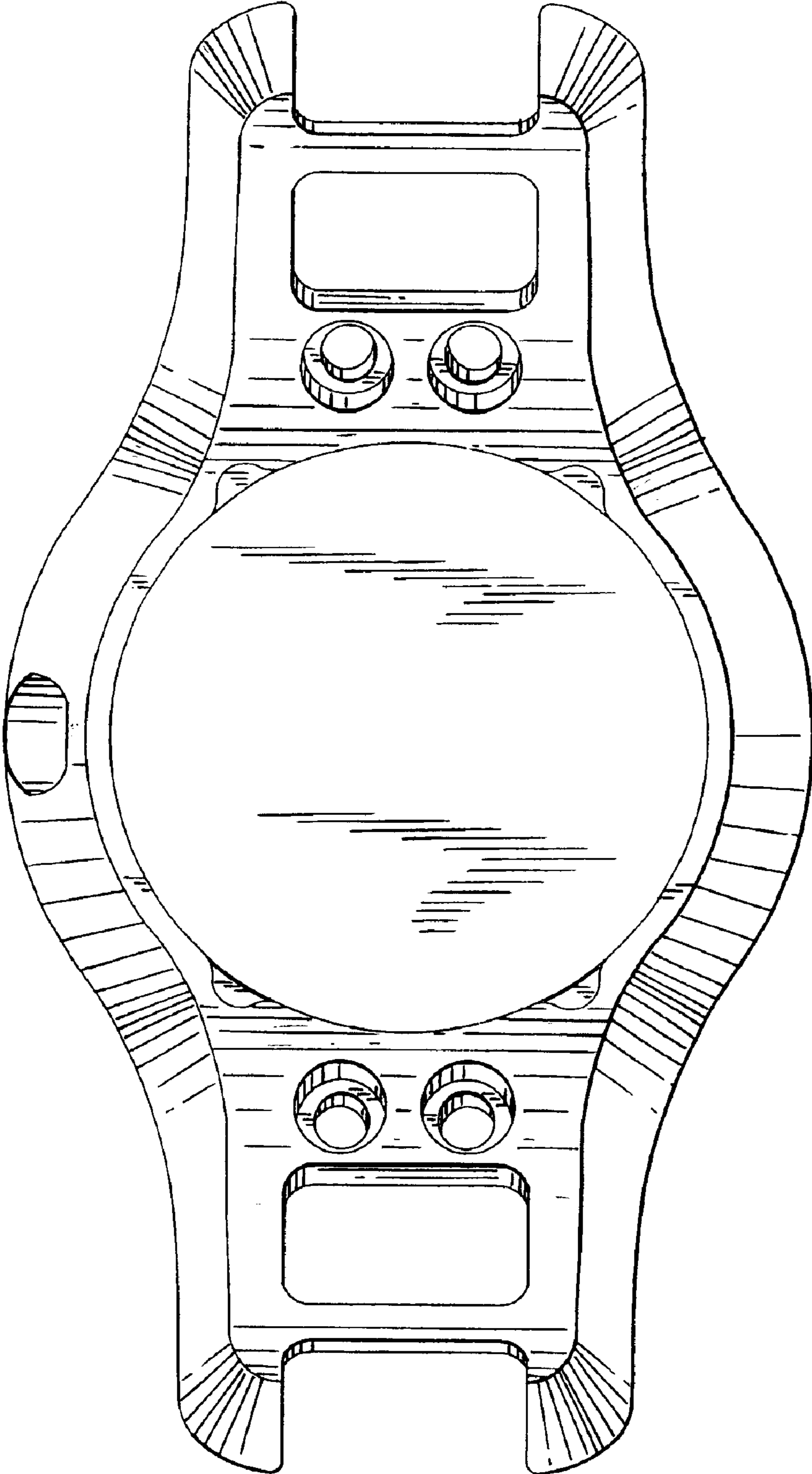

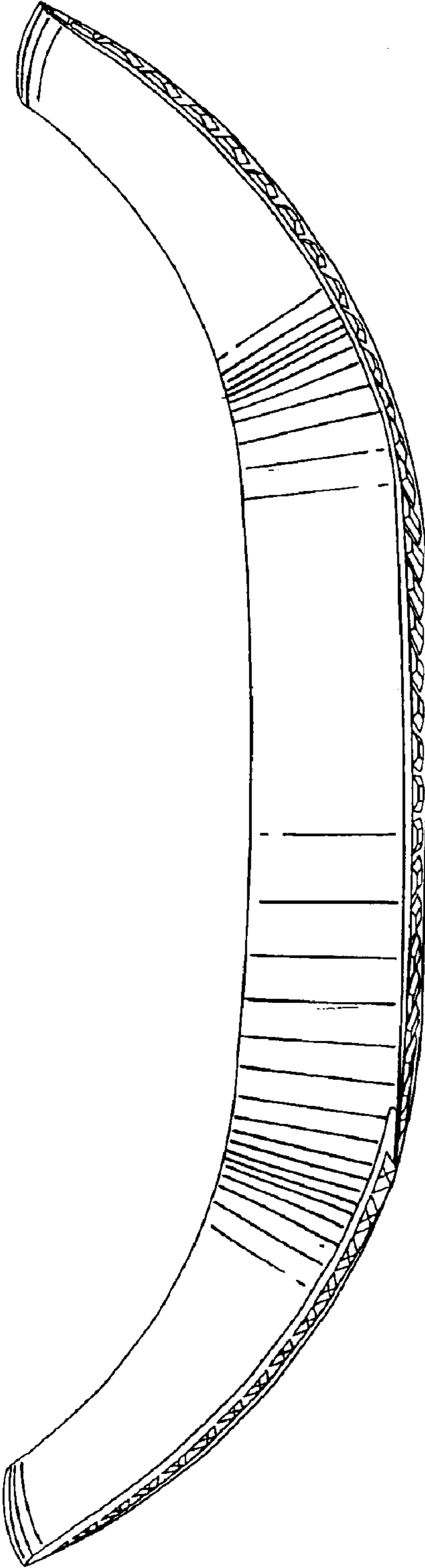

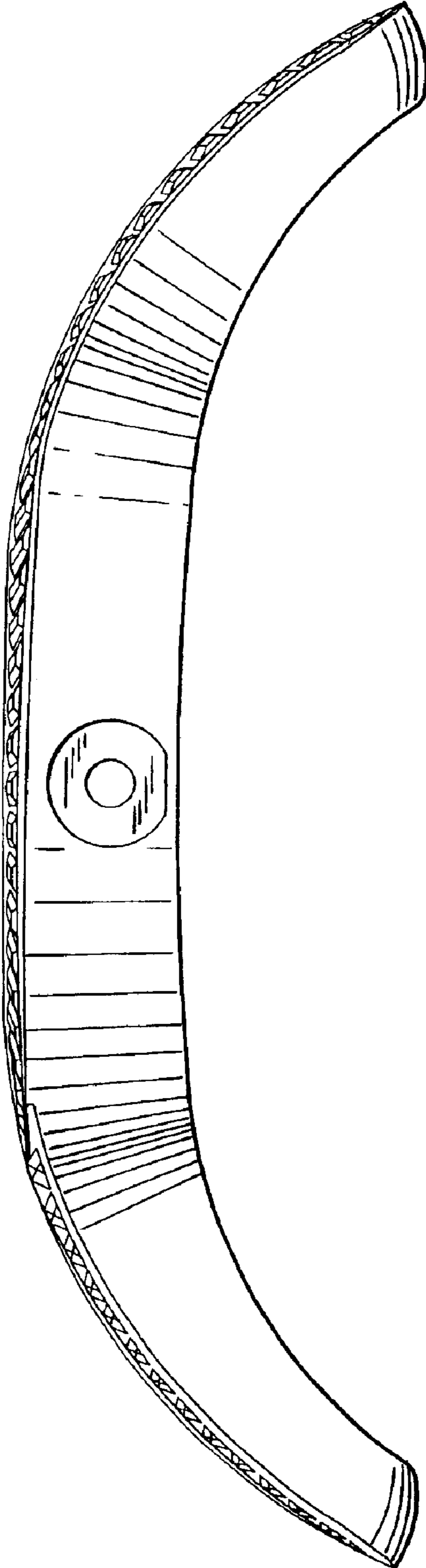

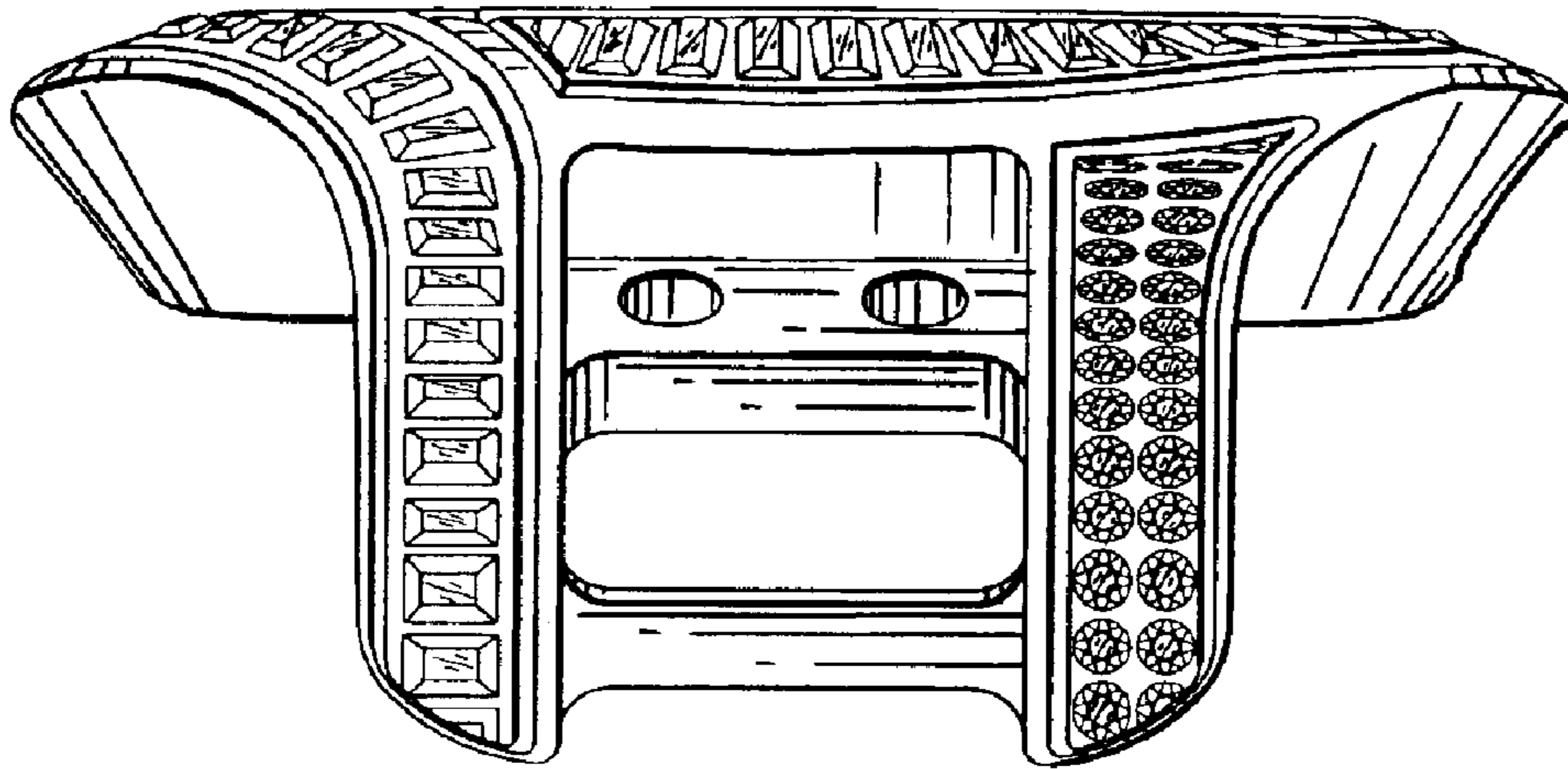

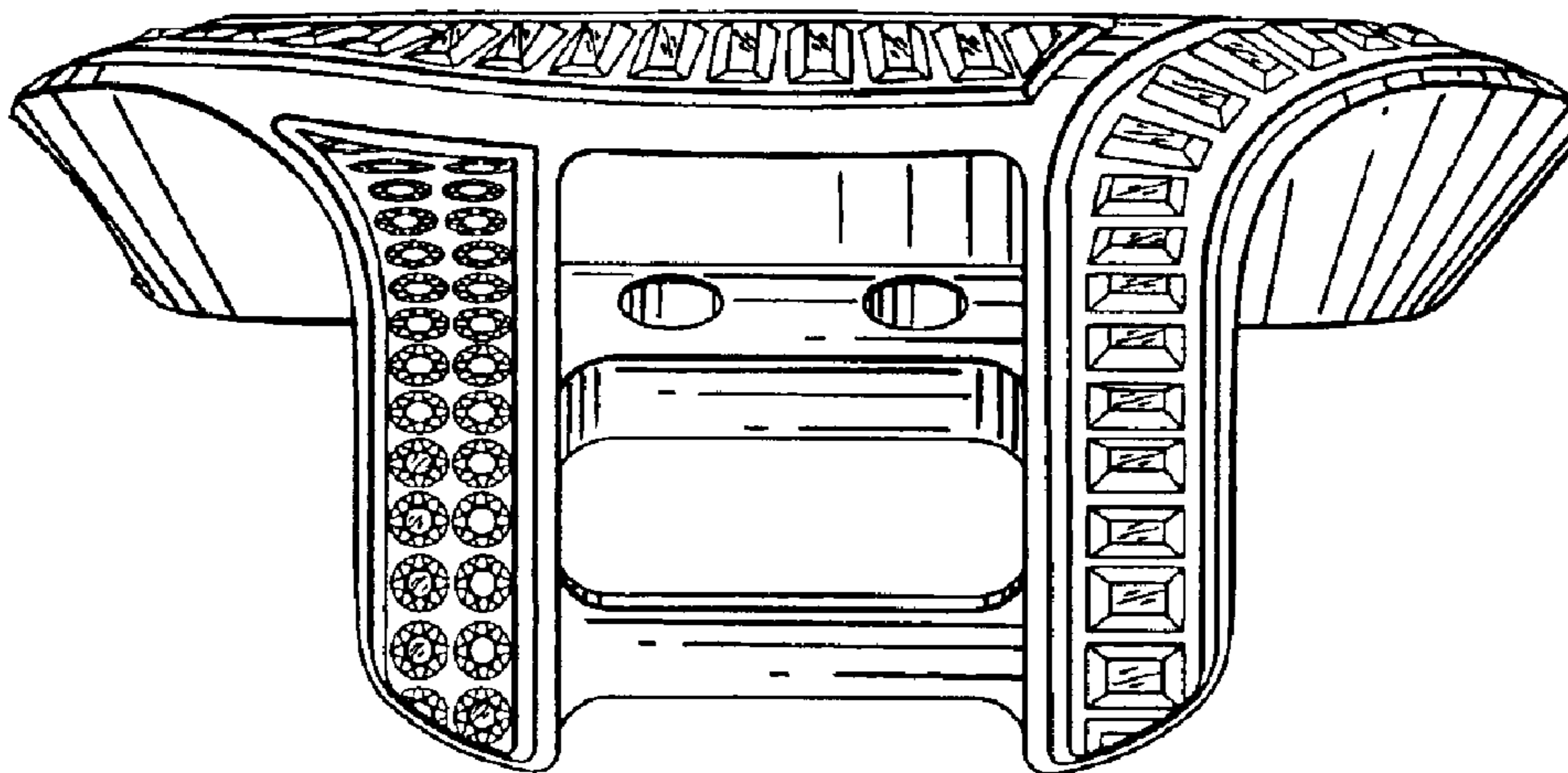
