FIG. 2 is a rear end elevational view of the cargo bed extension for a pick-up truck shown in FIG. 1.

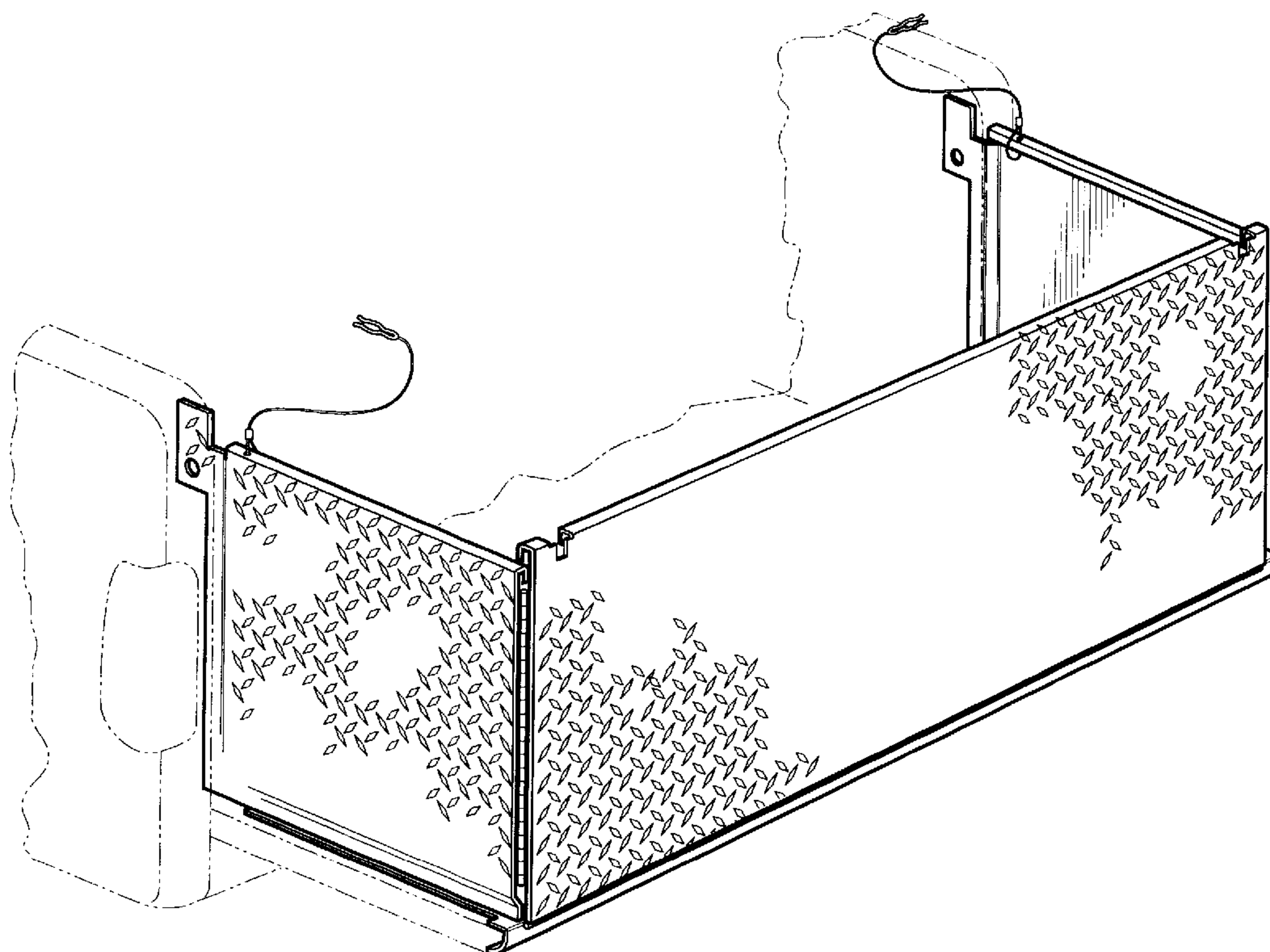
FIG. 3 is a left side view of the cargo bed extension for a pick-up truck shown in FIGS. 1 and 2.

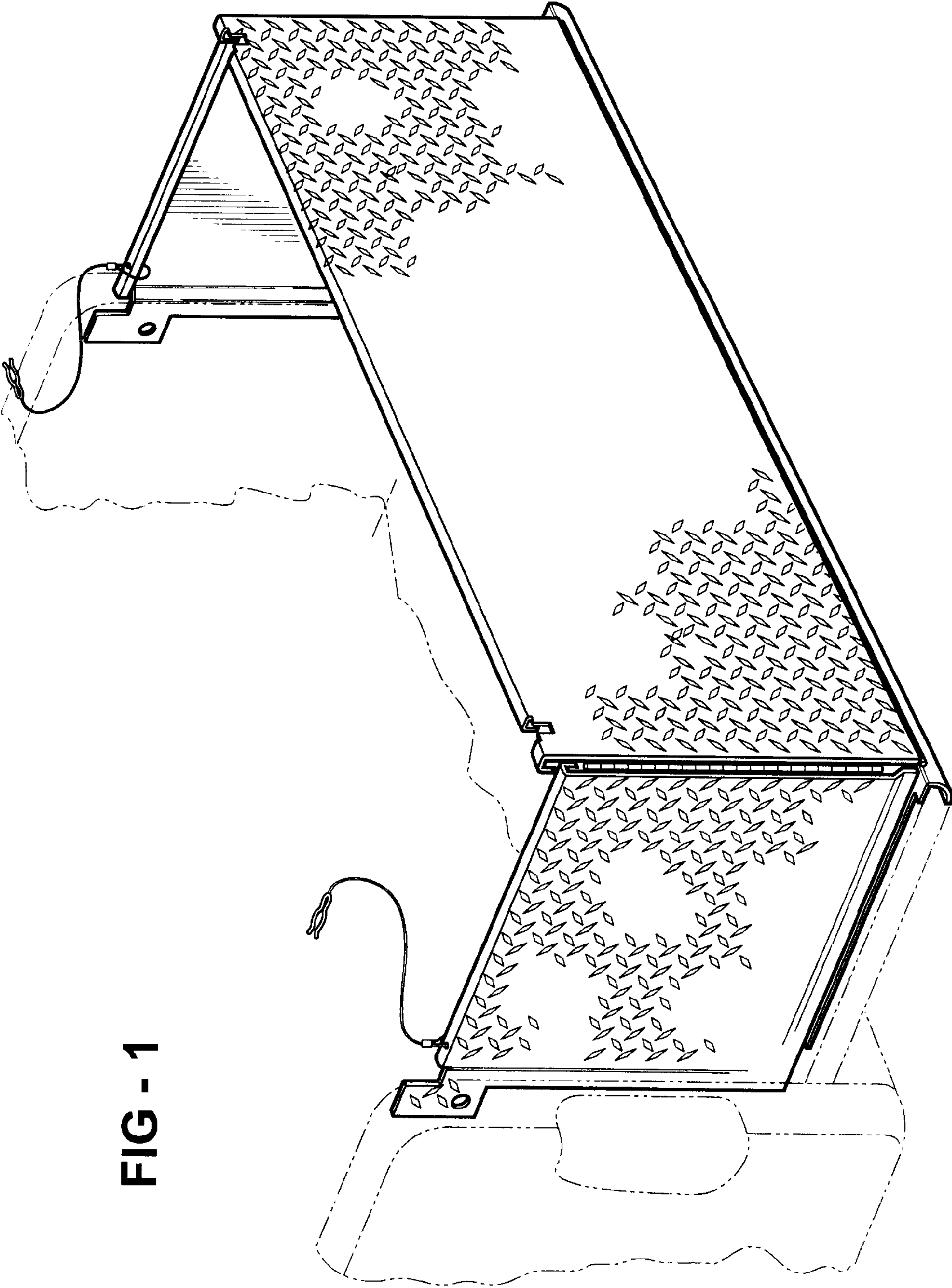

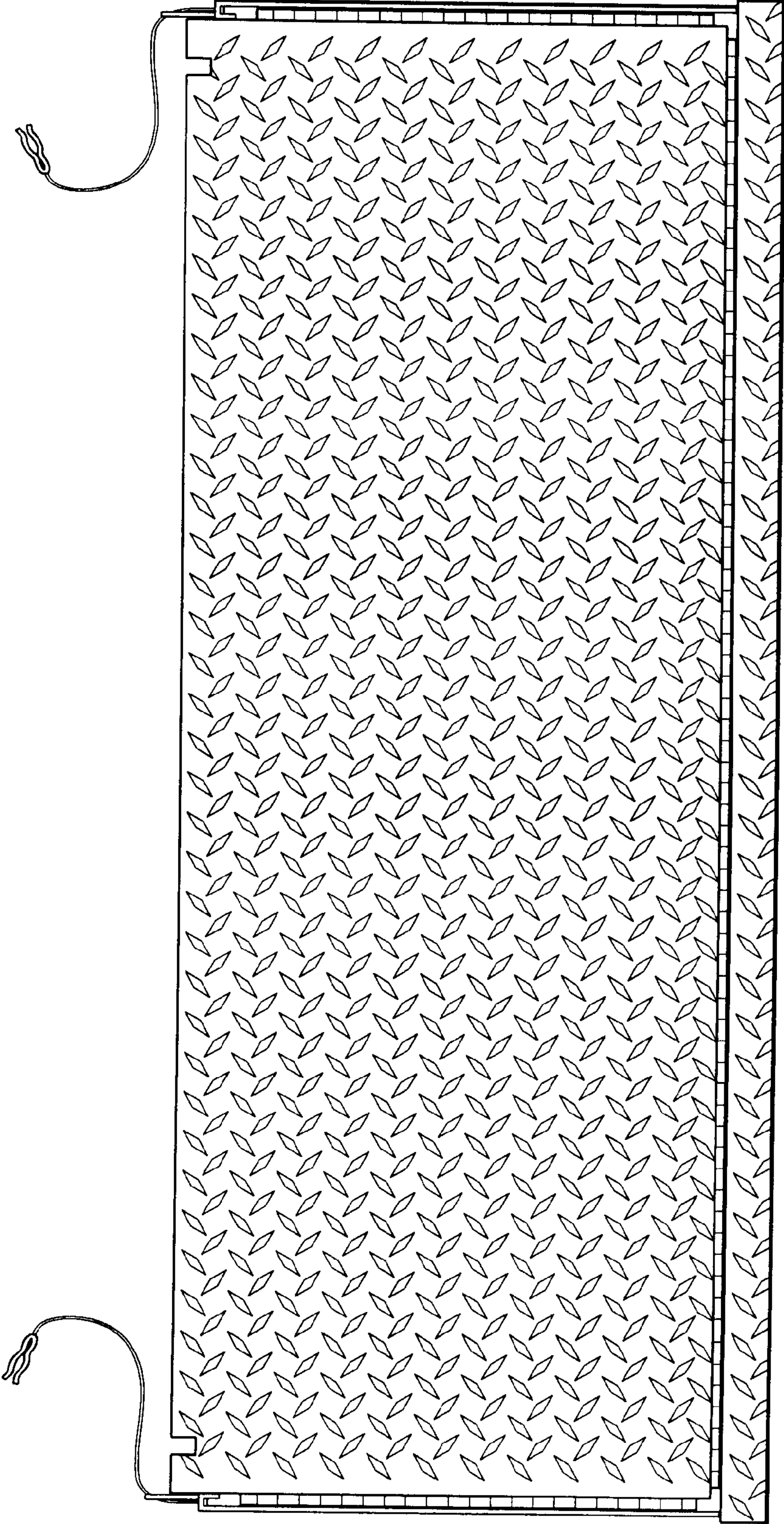
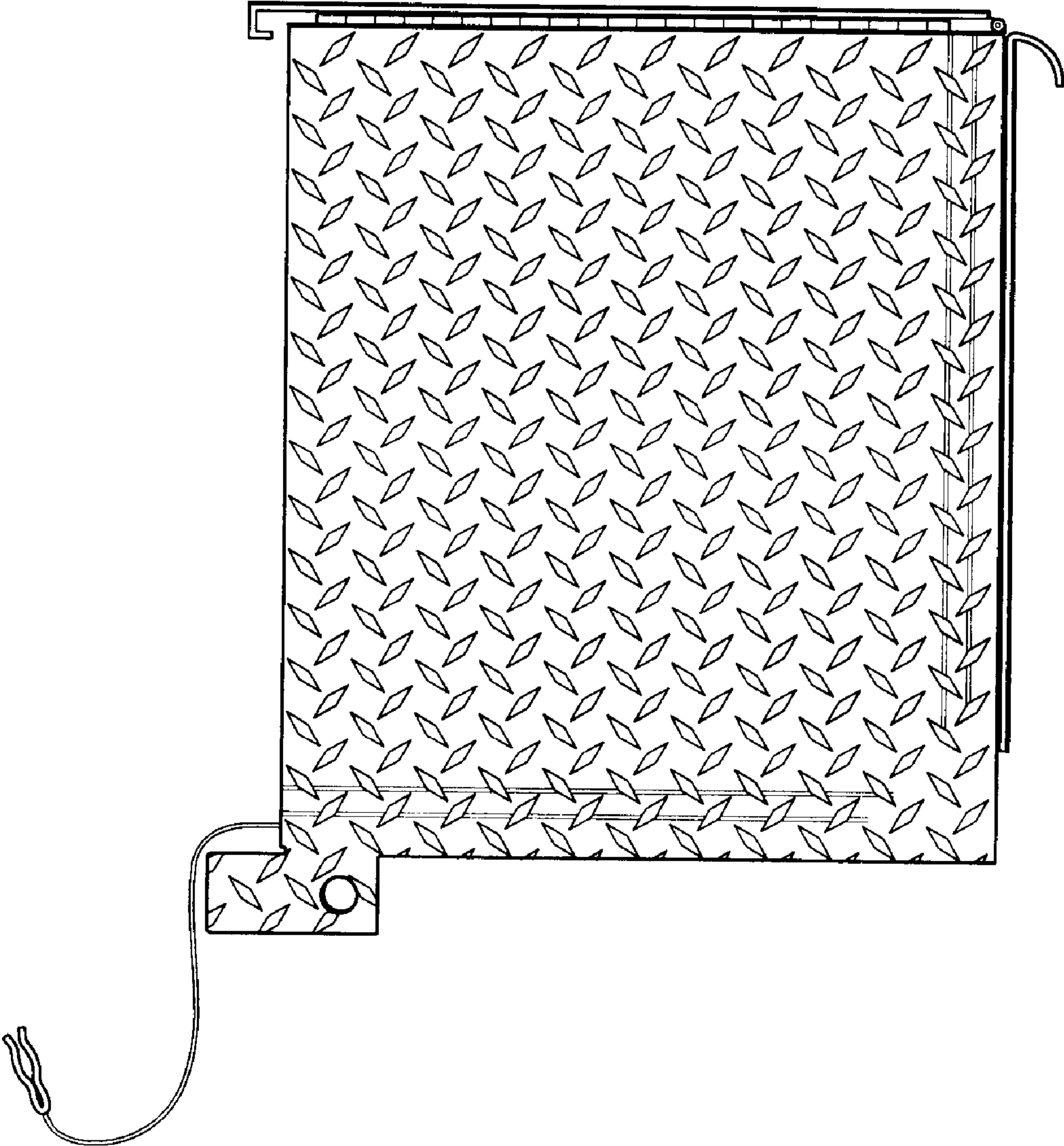

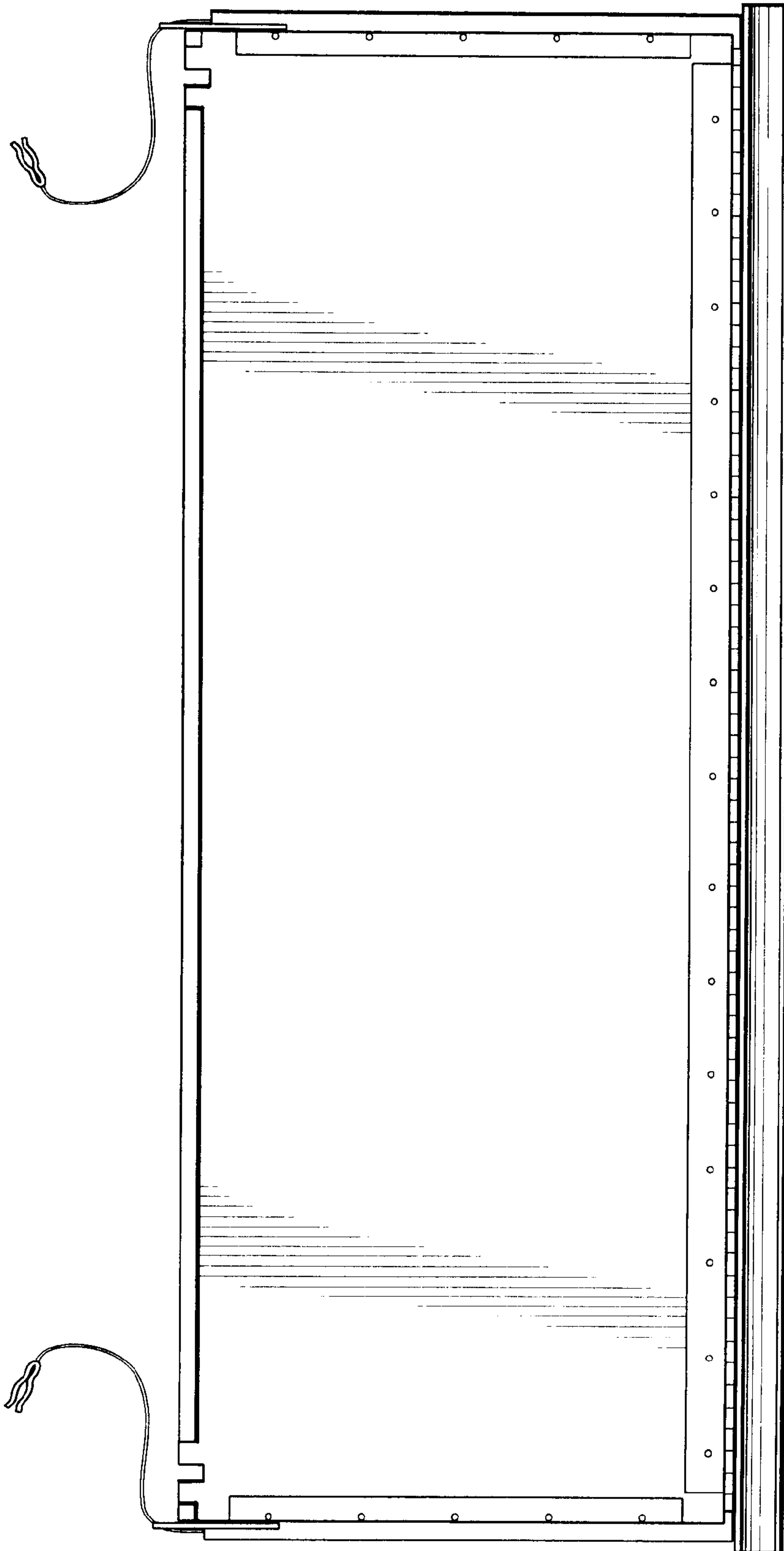

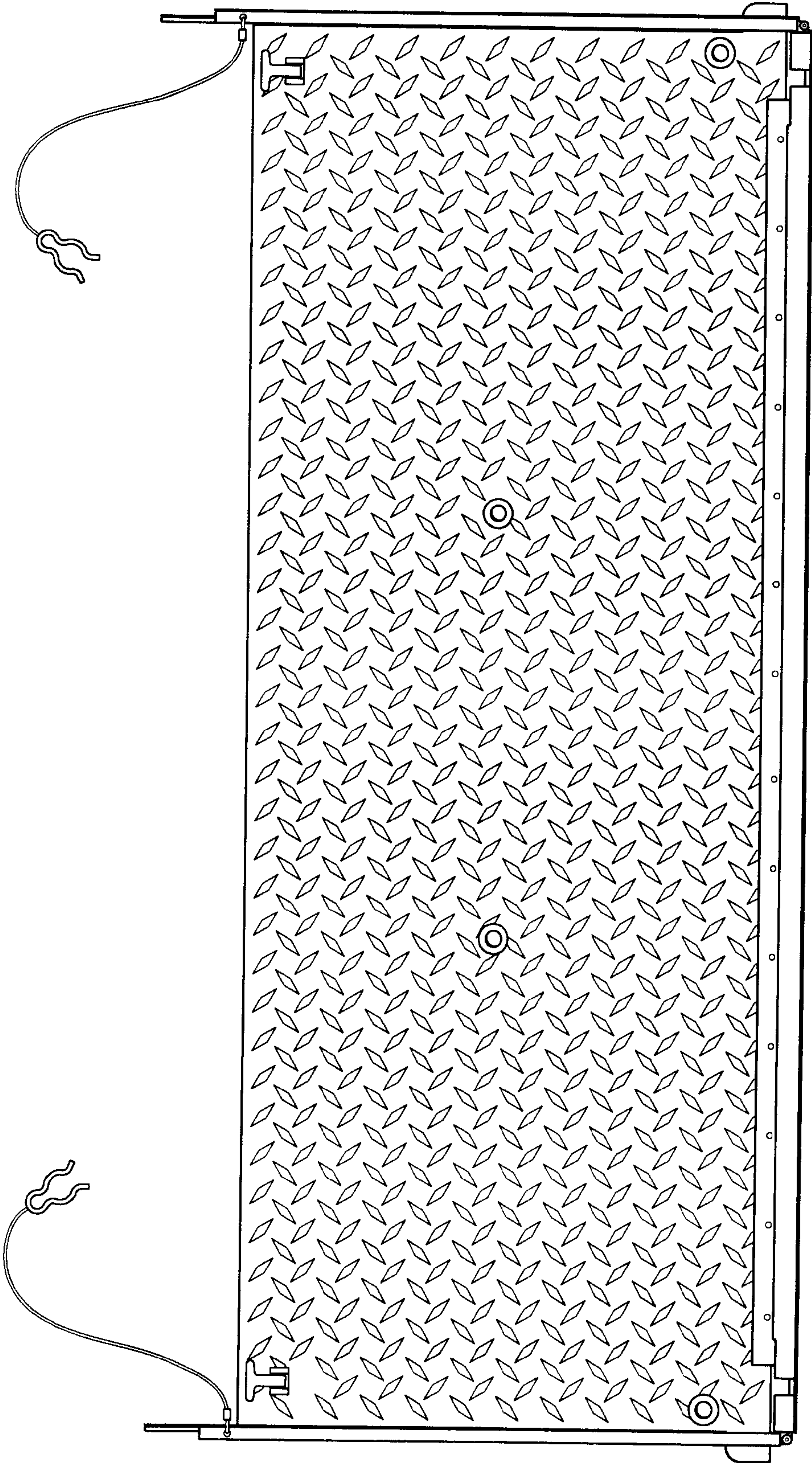

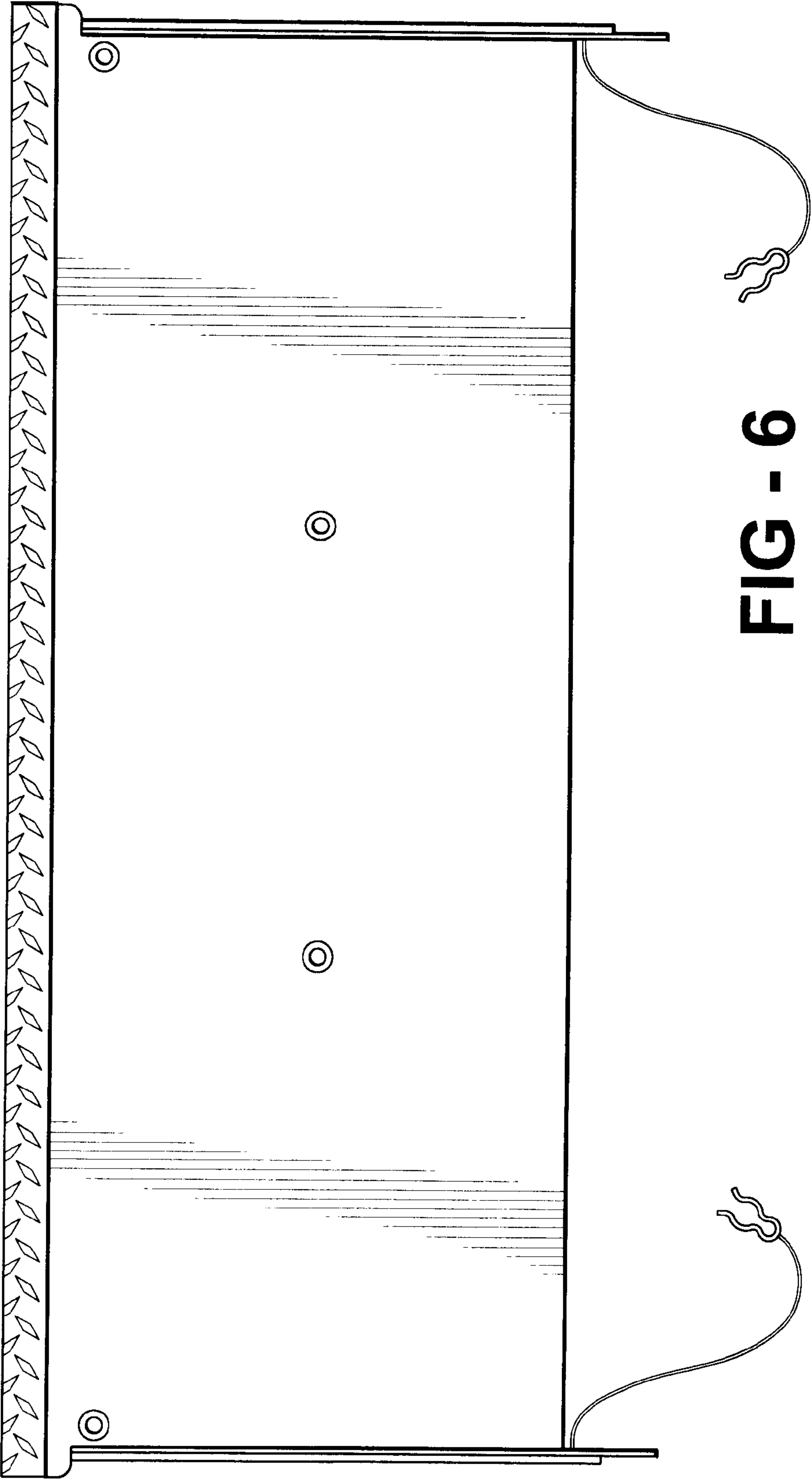
