The ornamental design for a gun, as shown and described.

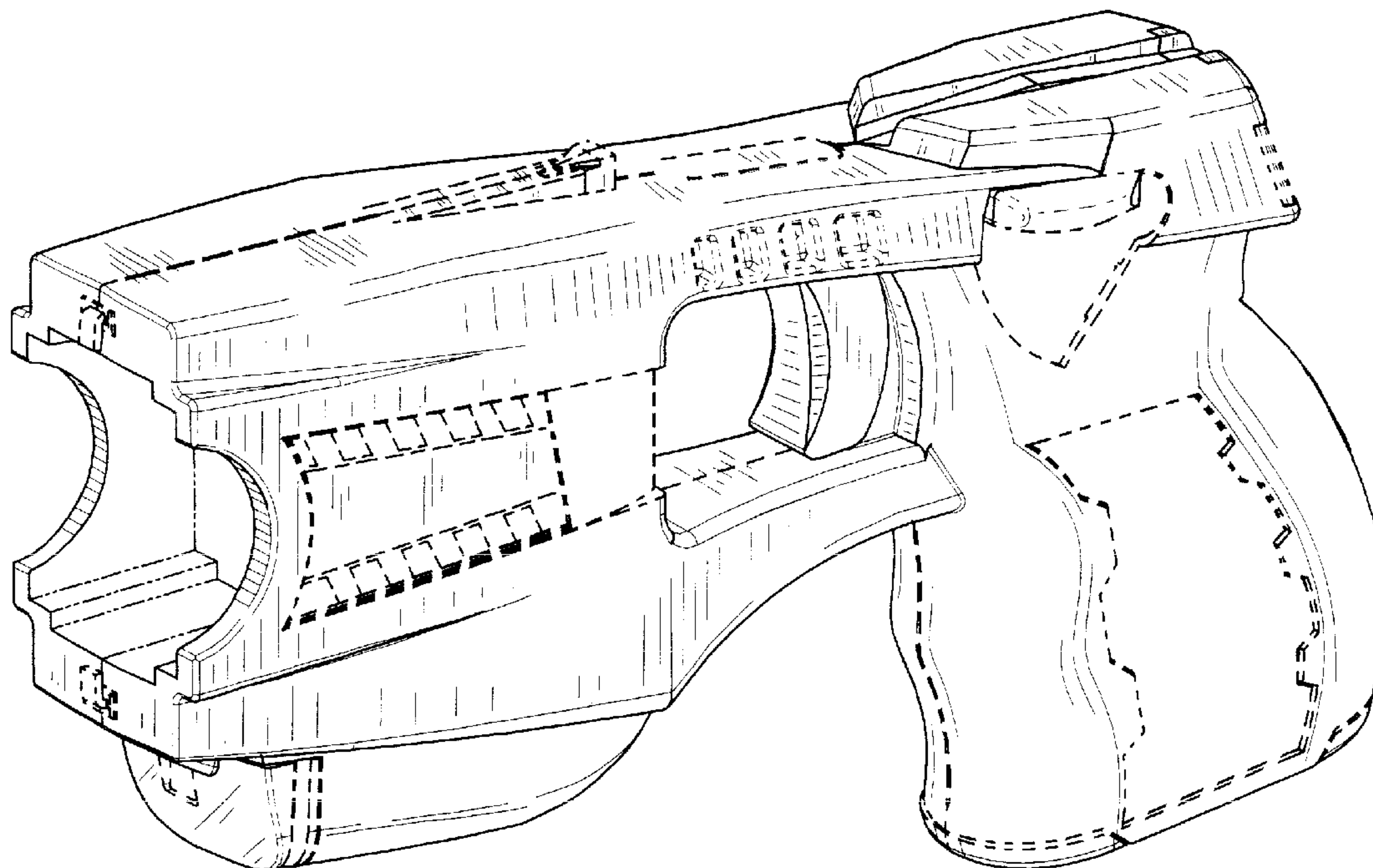
**DESCRIPTION**

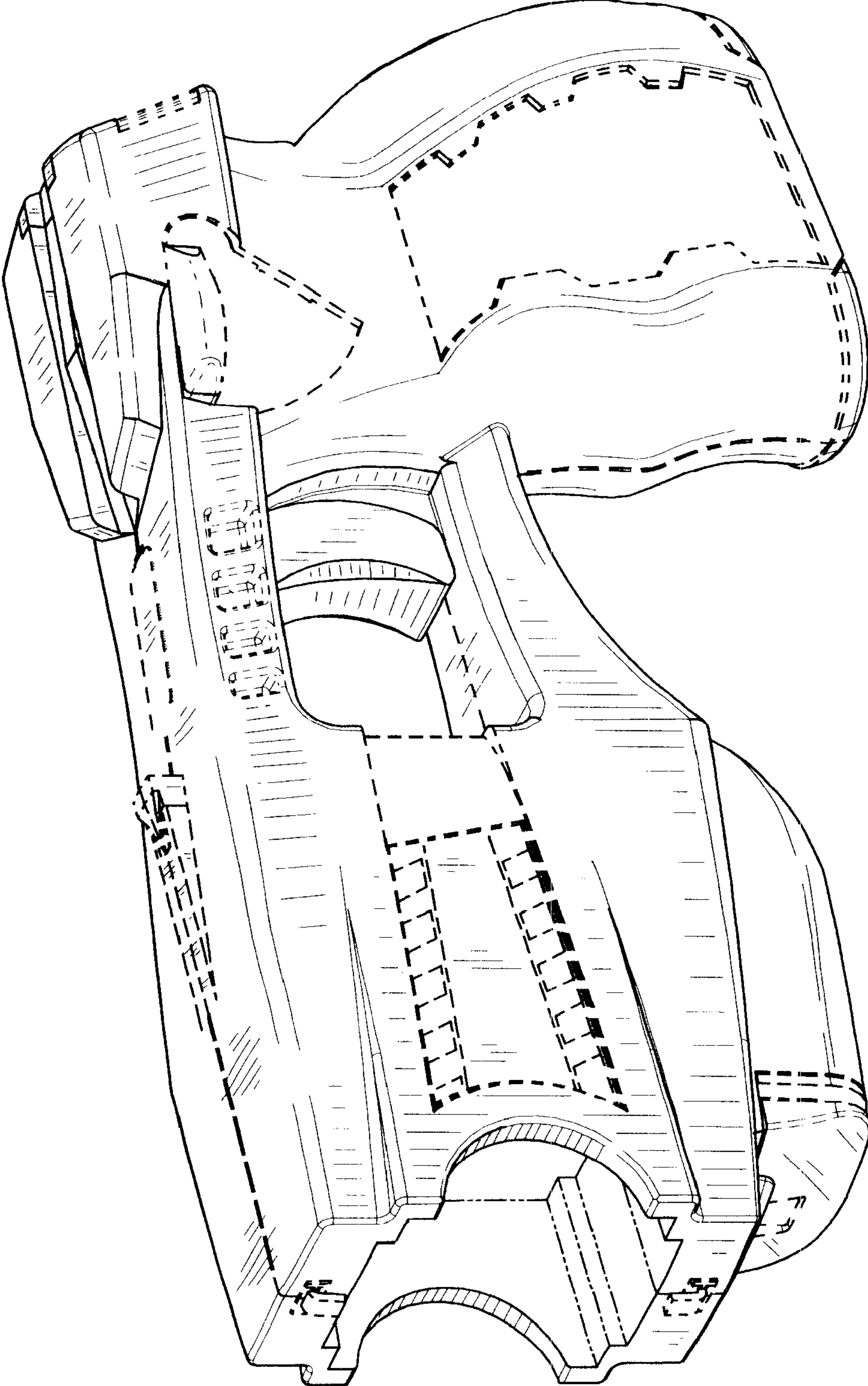

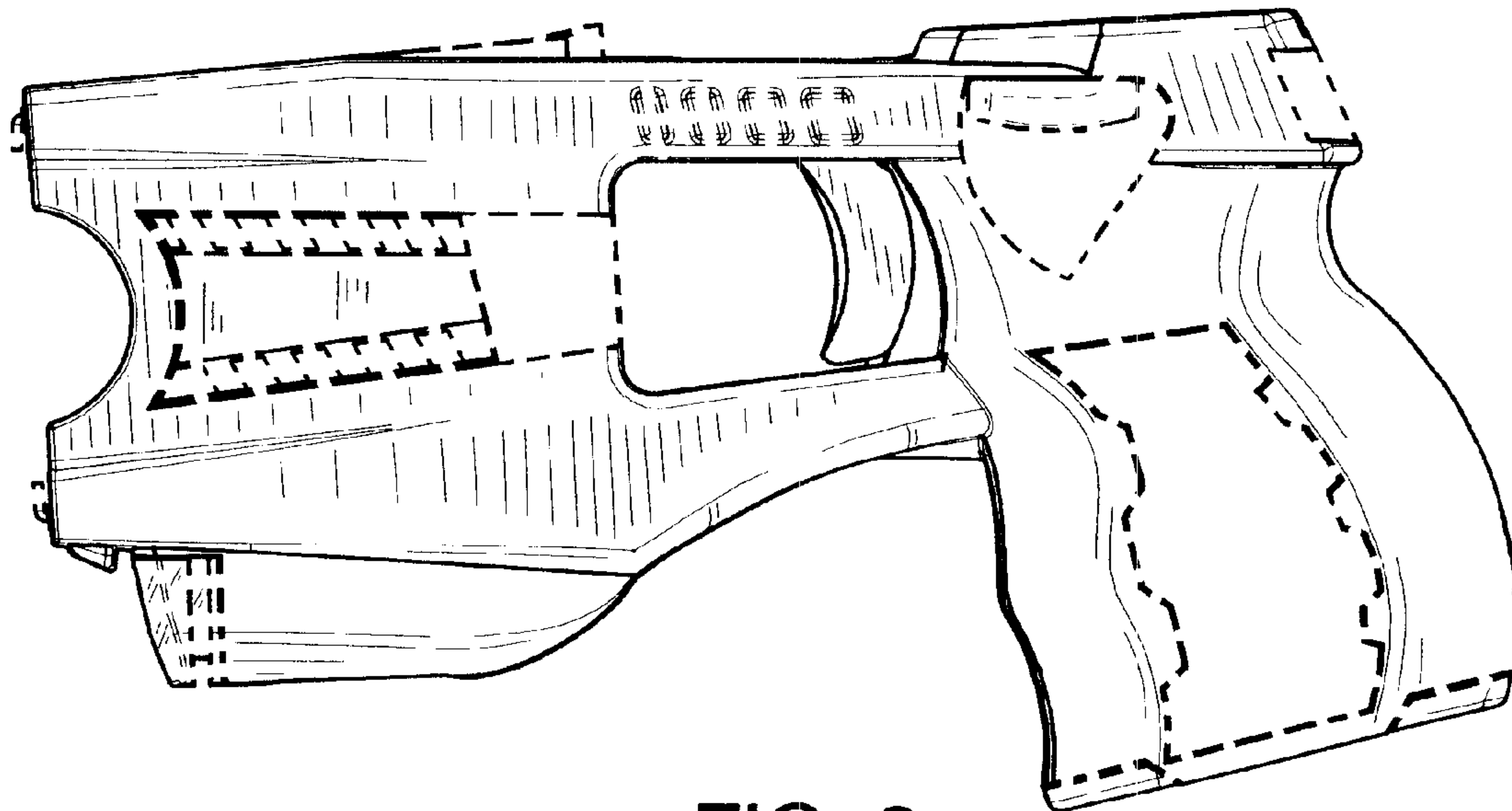

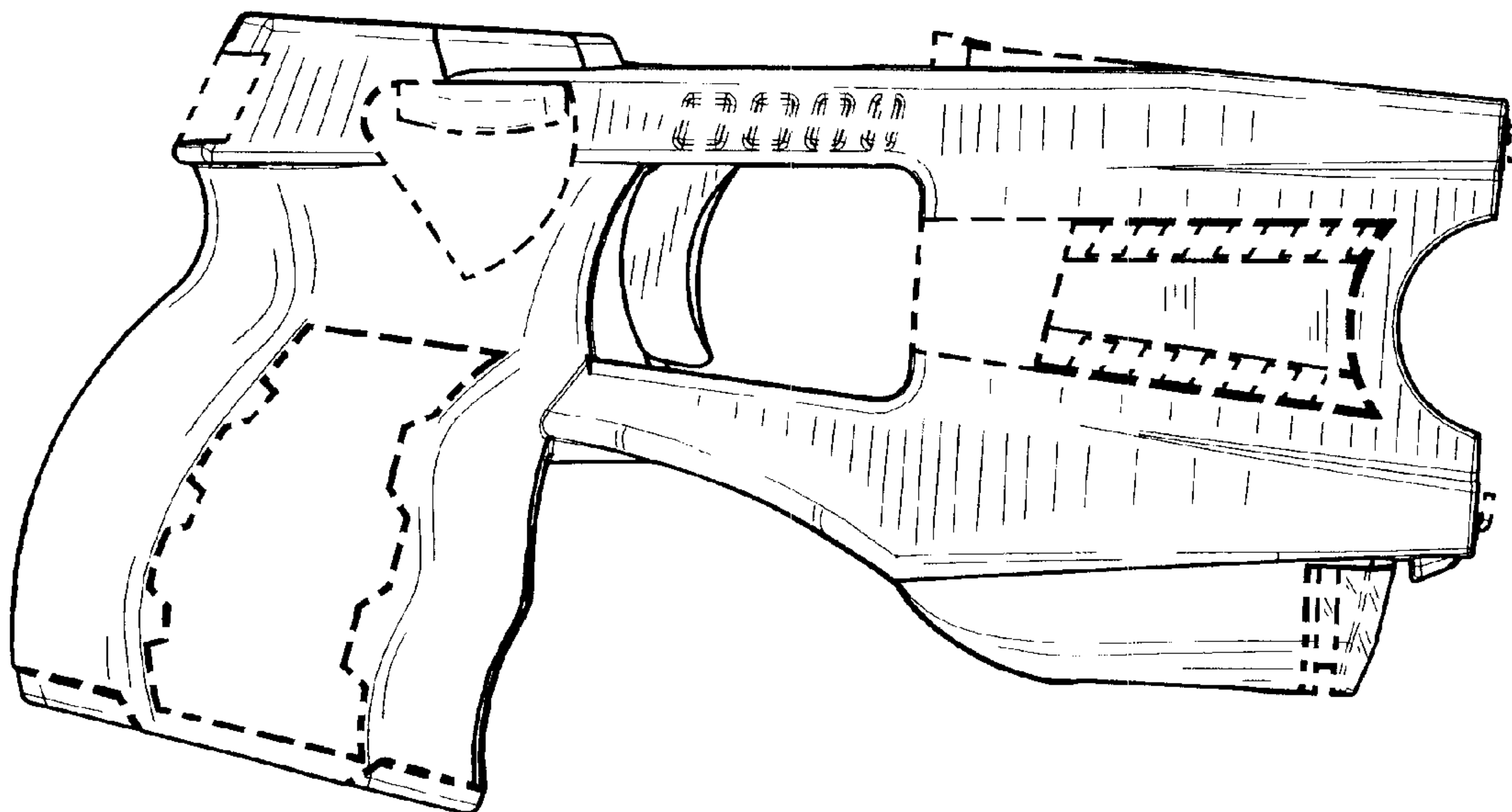

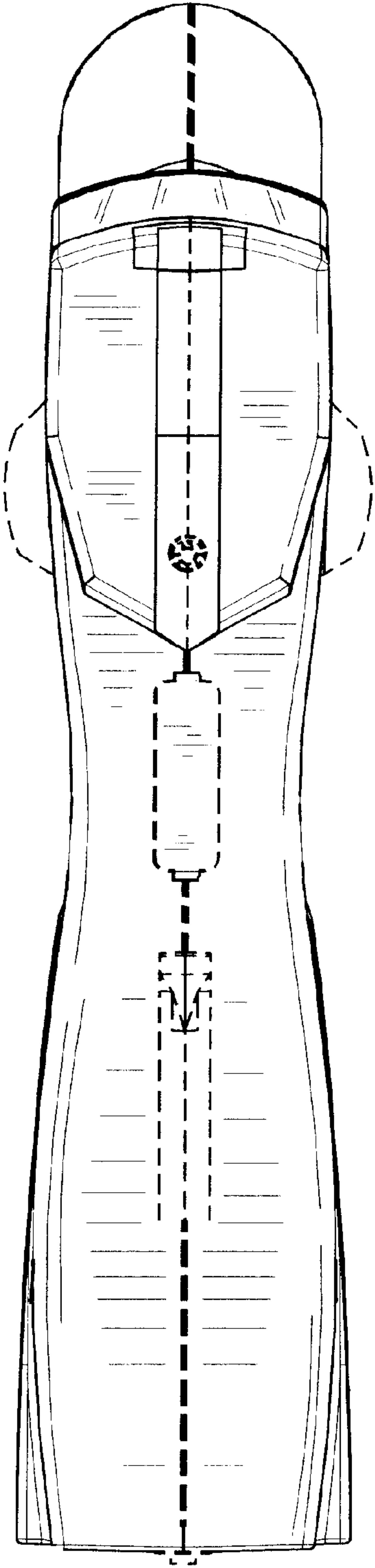

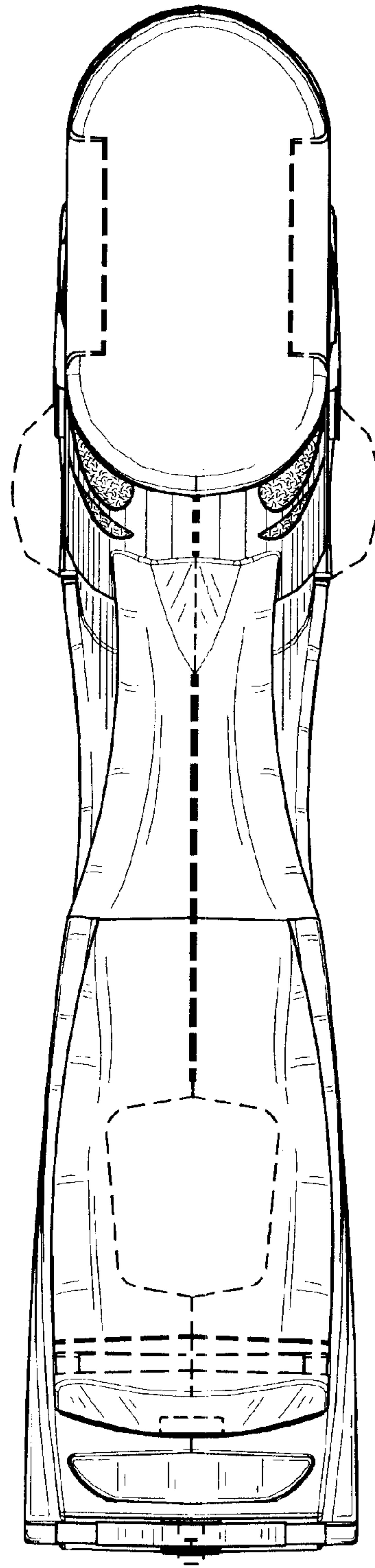

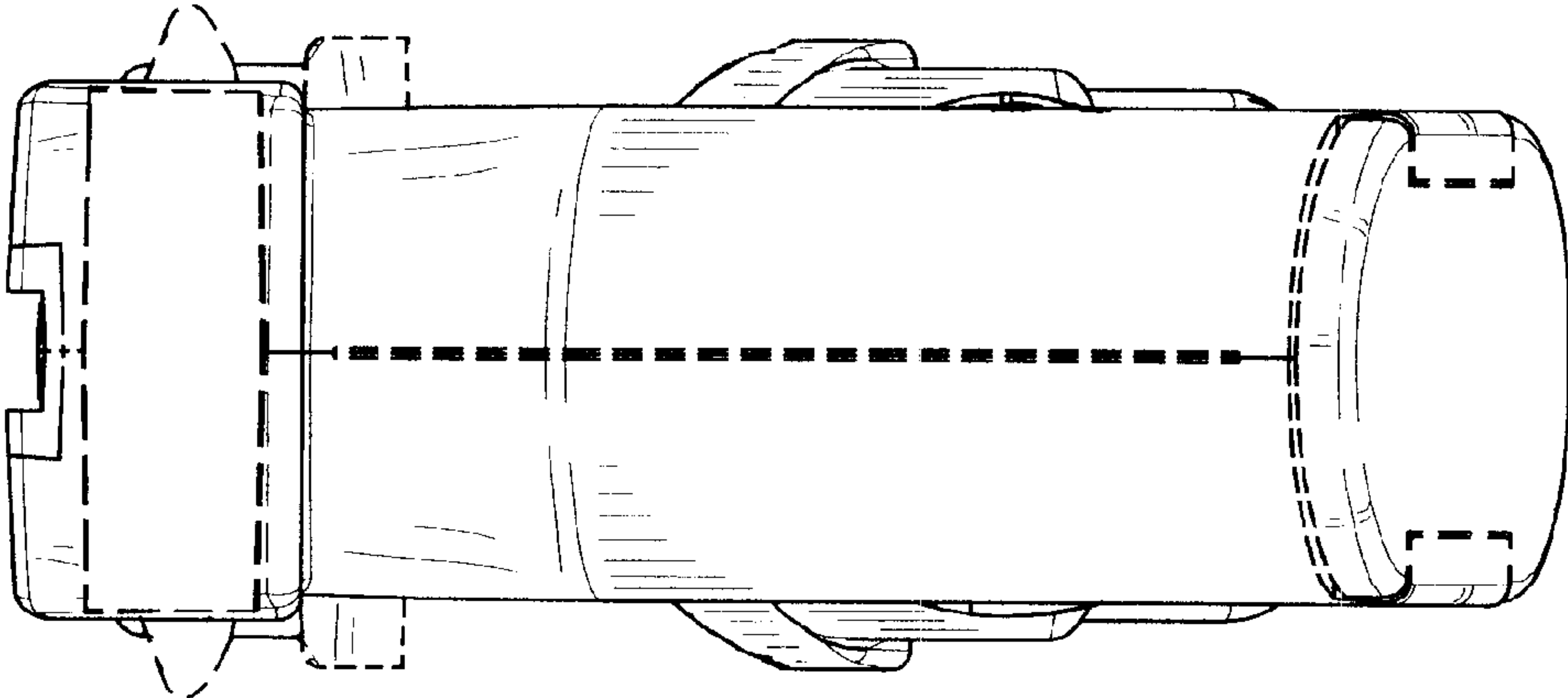

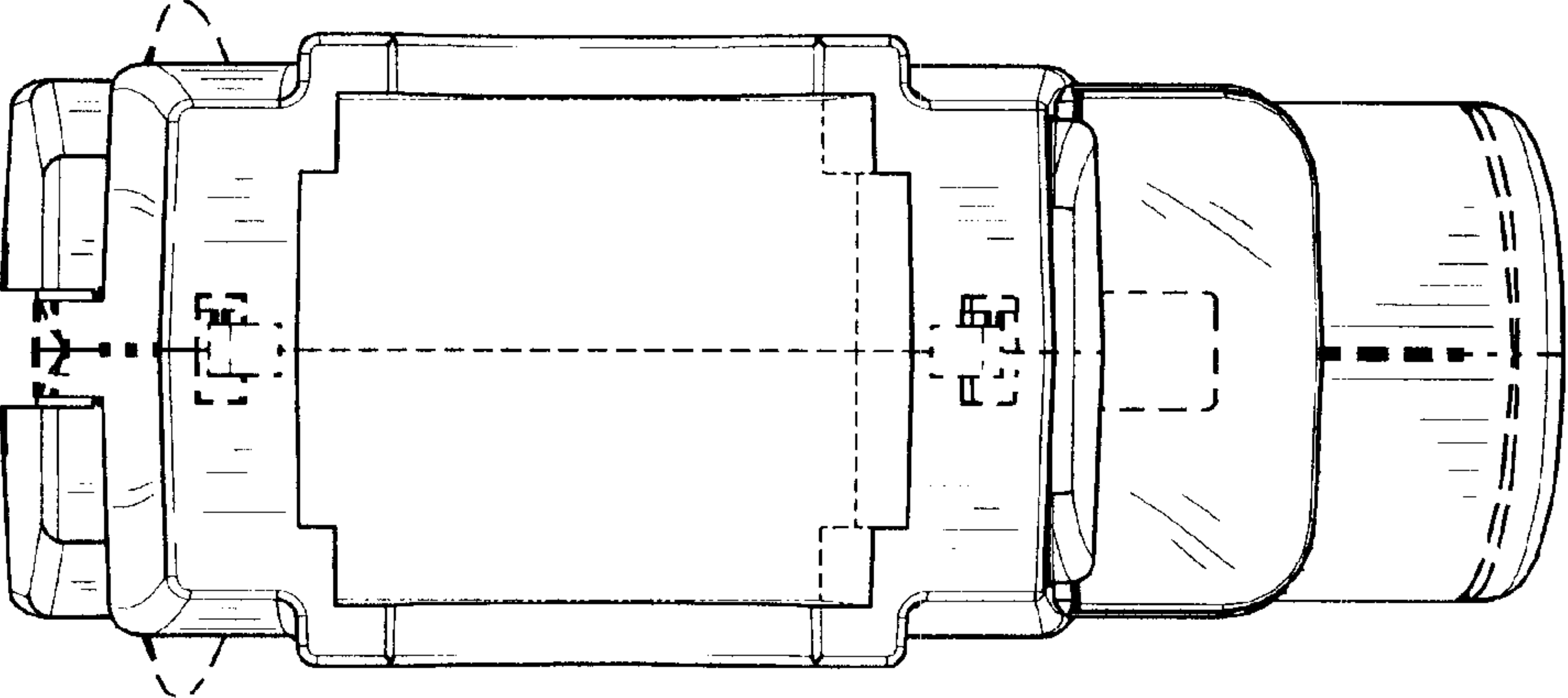
