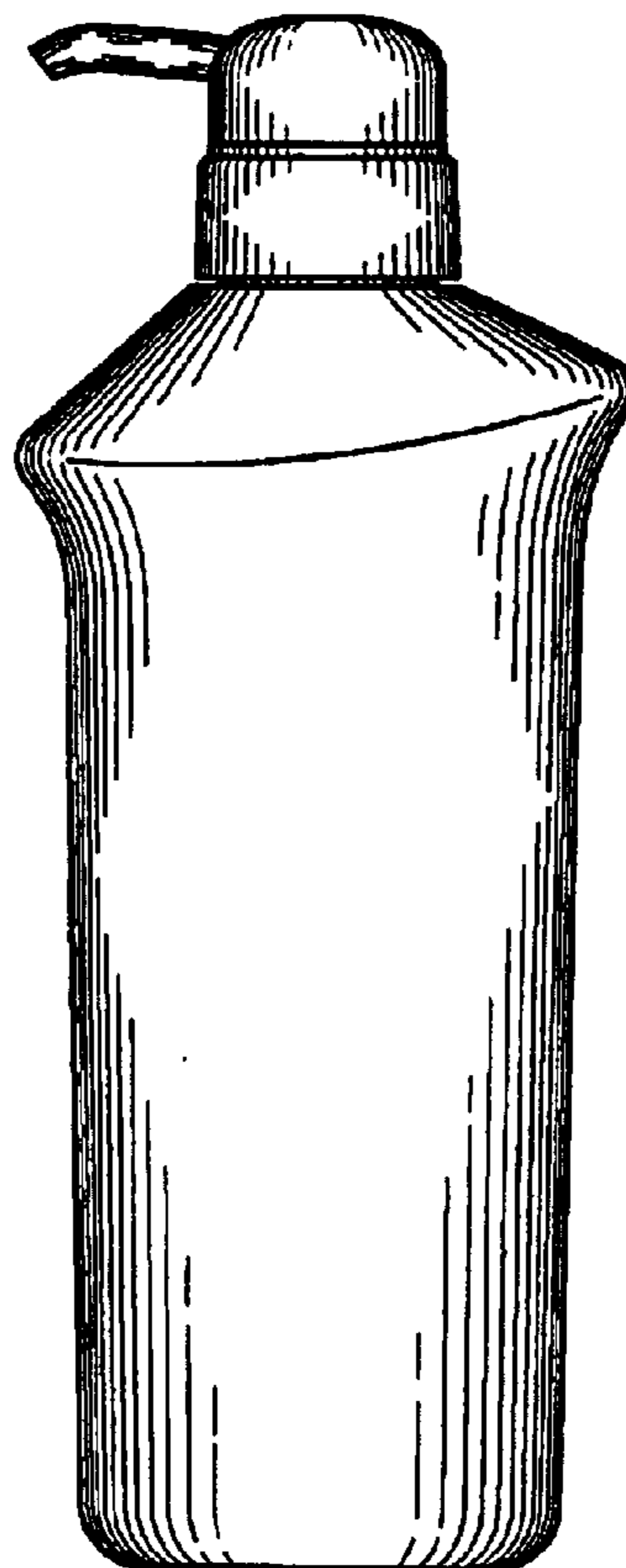
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front view of a pump bottle showing the new design;
FIG. 2 is a back view of the pump bottle shown in FIG. 1;
FIG. 3 is a right view of the pump bottle shown in FIG. 1;
FIG. 4 is a left view of the pump bottle shown in FIG. 1;
FIG. 5 is a top view of the pump bottle shown in FIG. 1; and,

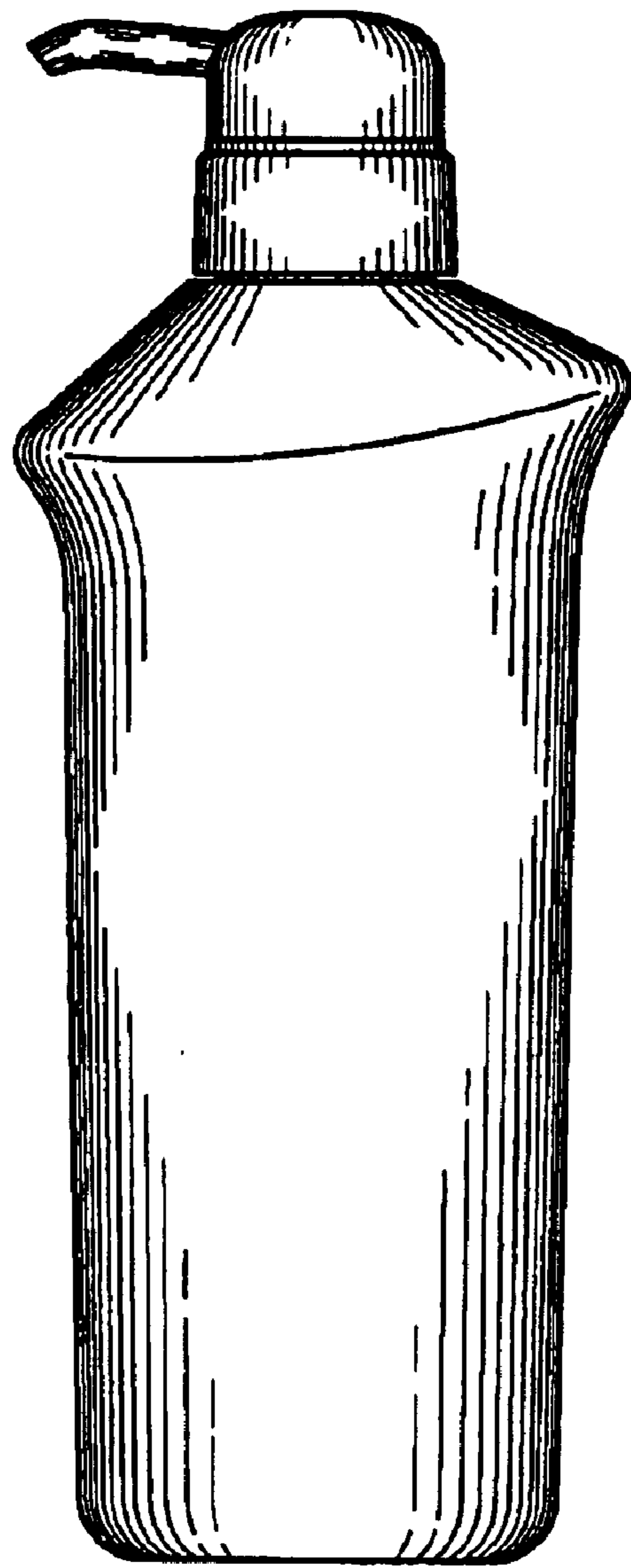

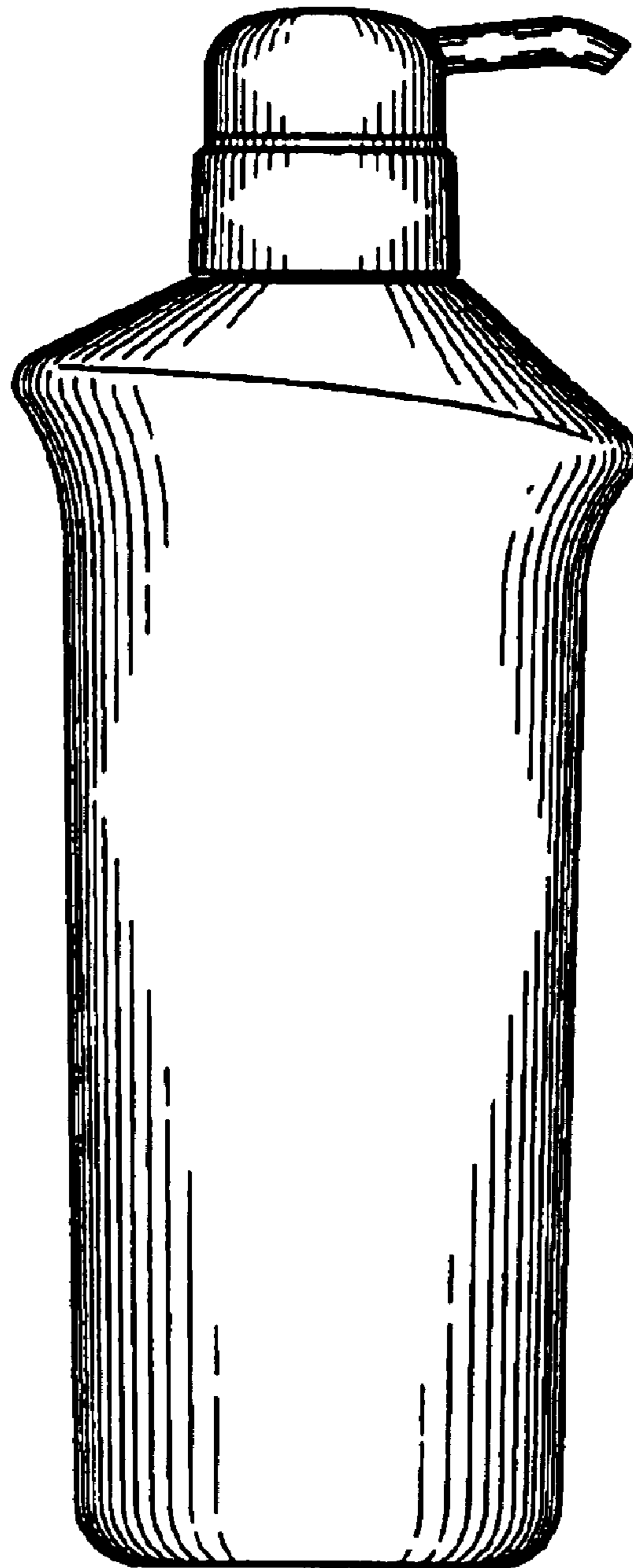

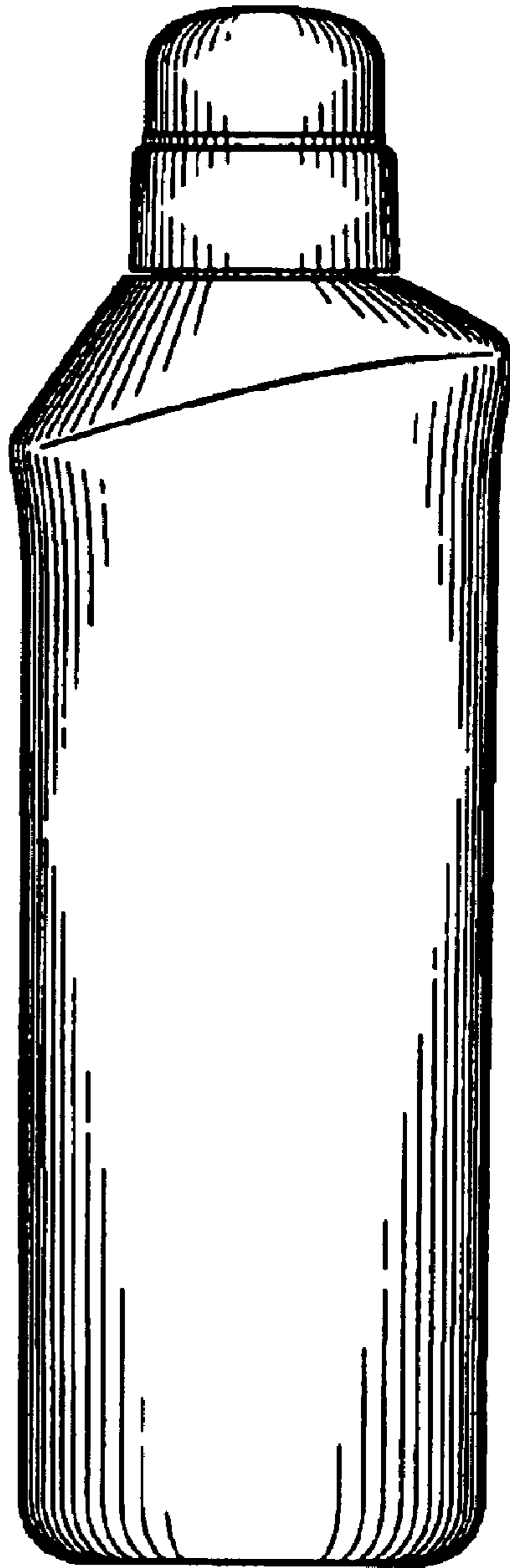

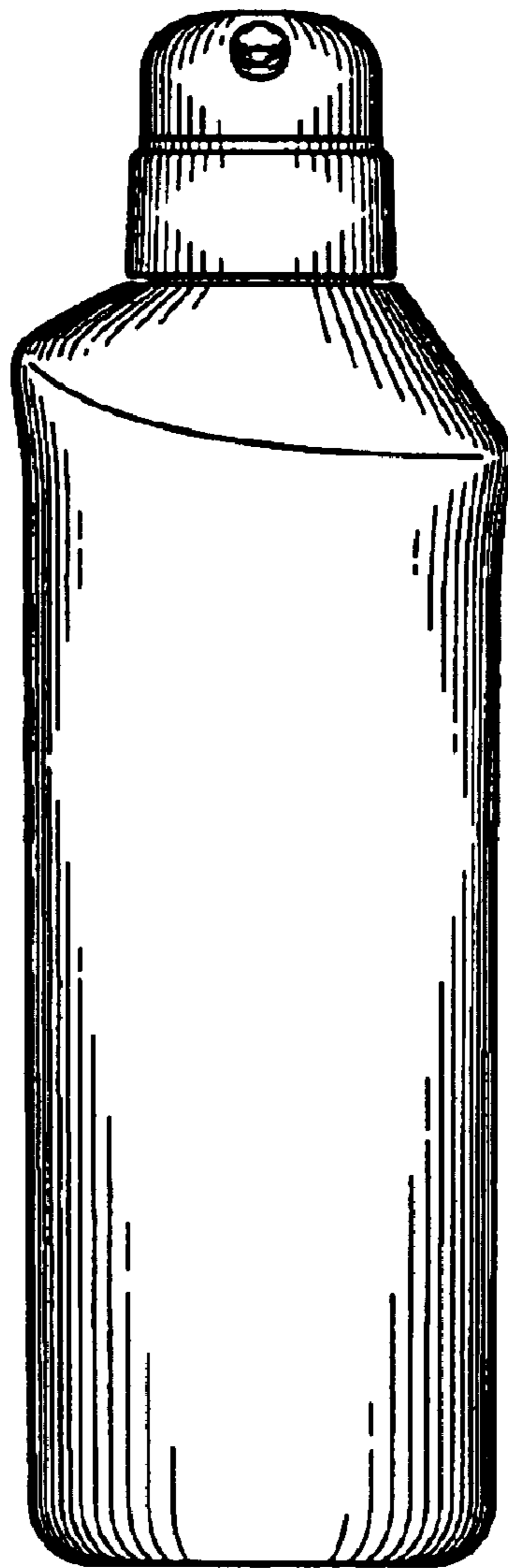

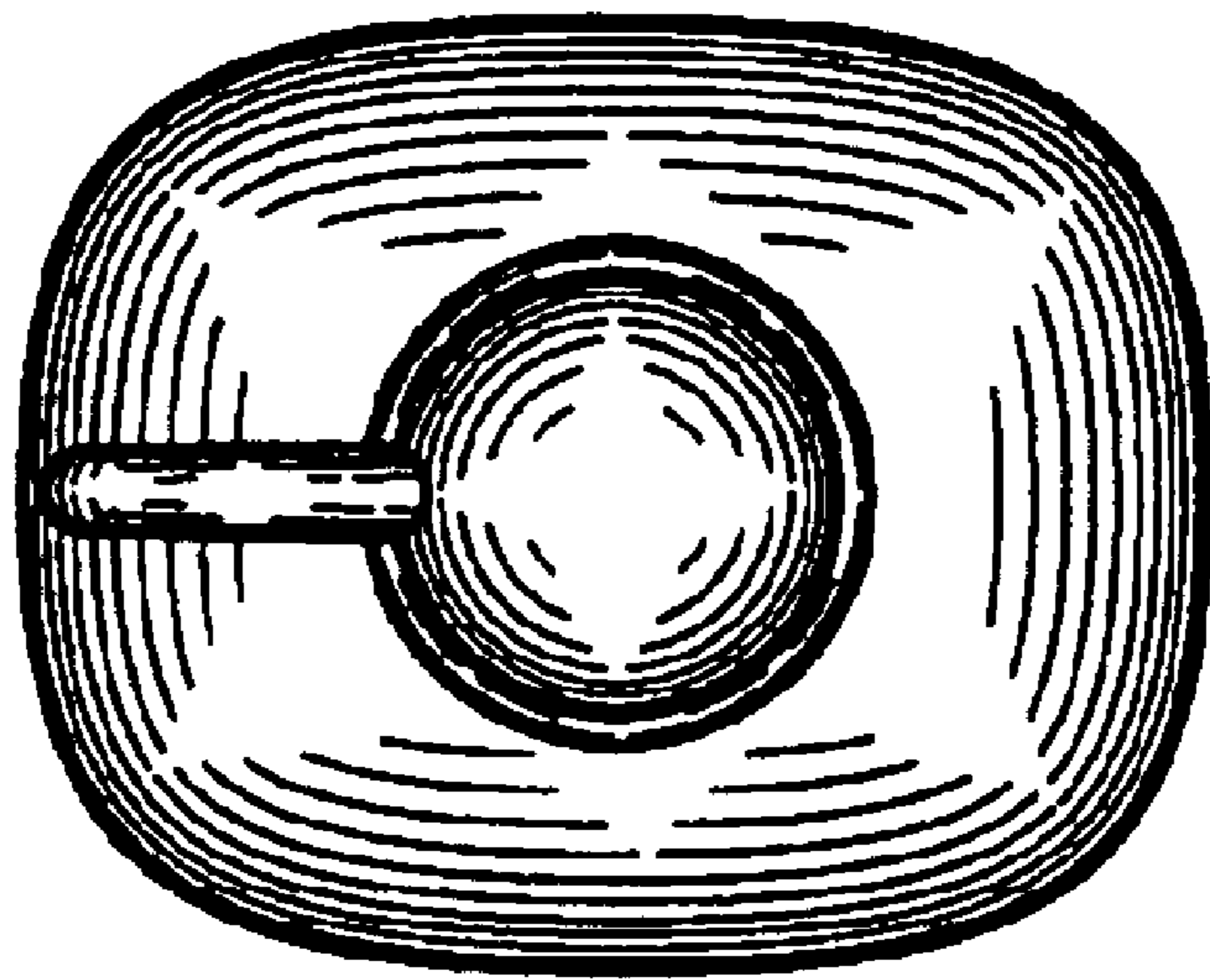

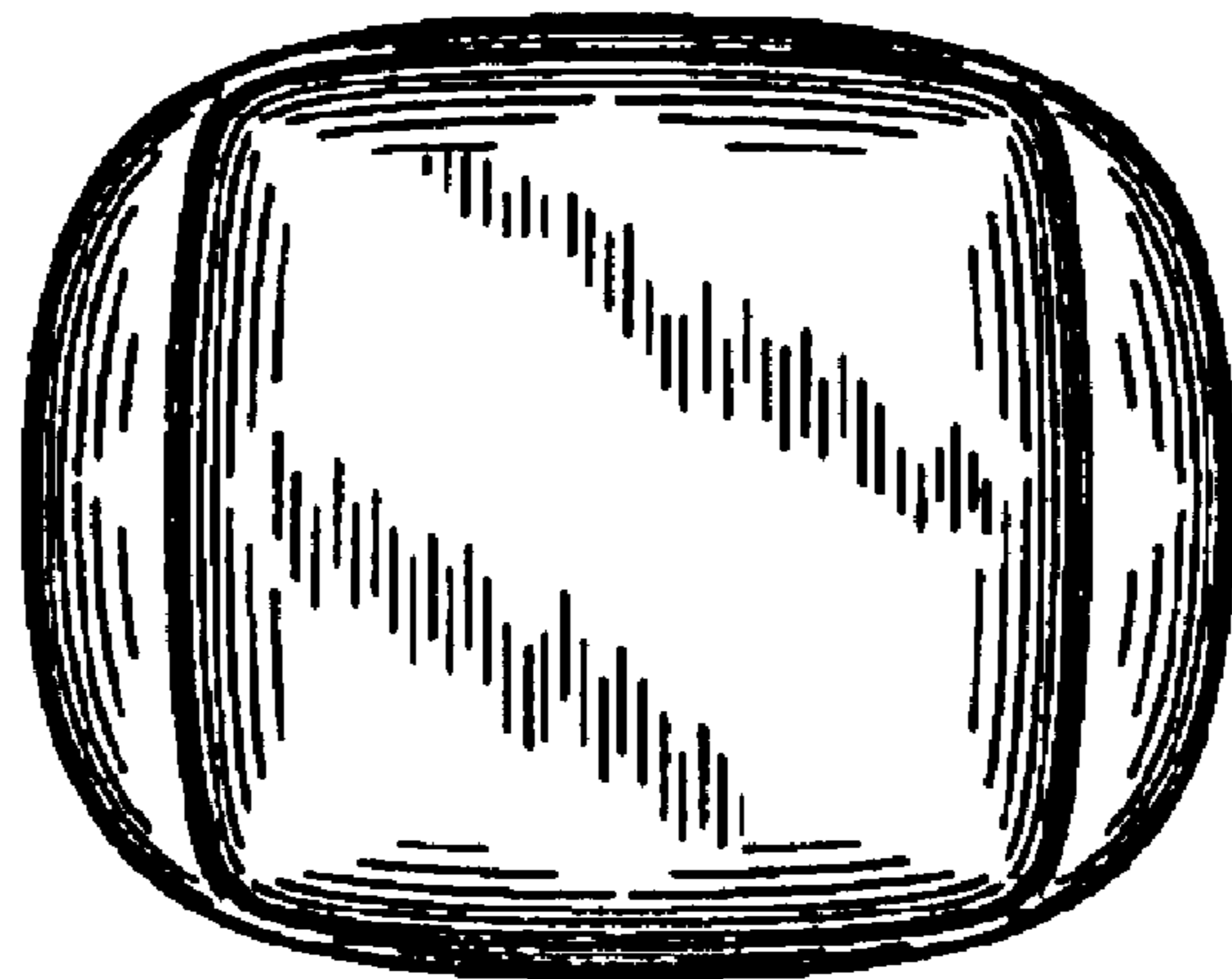
