(57) **CLAIM**

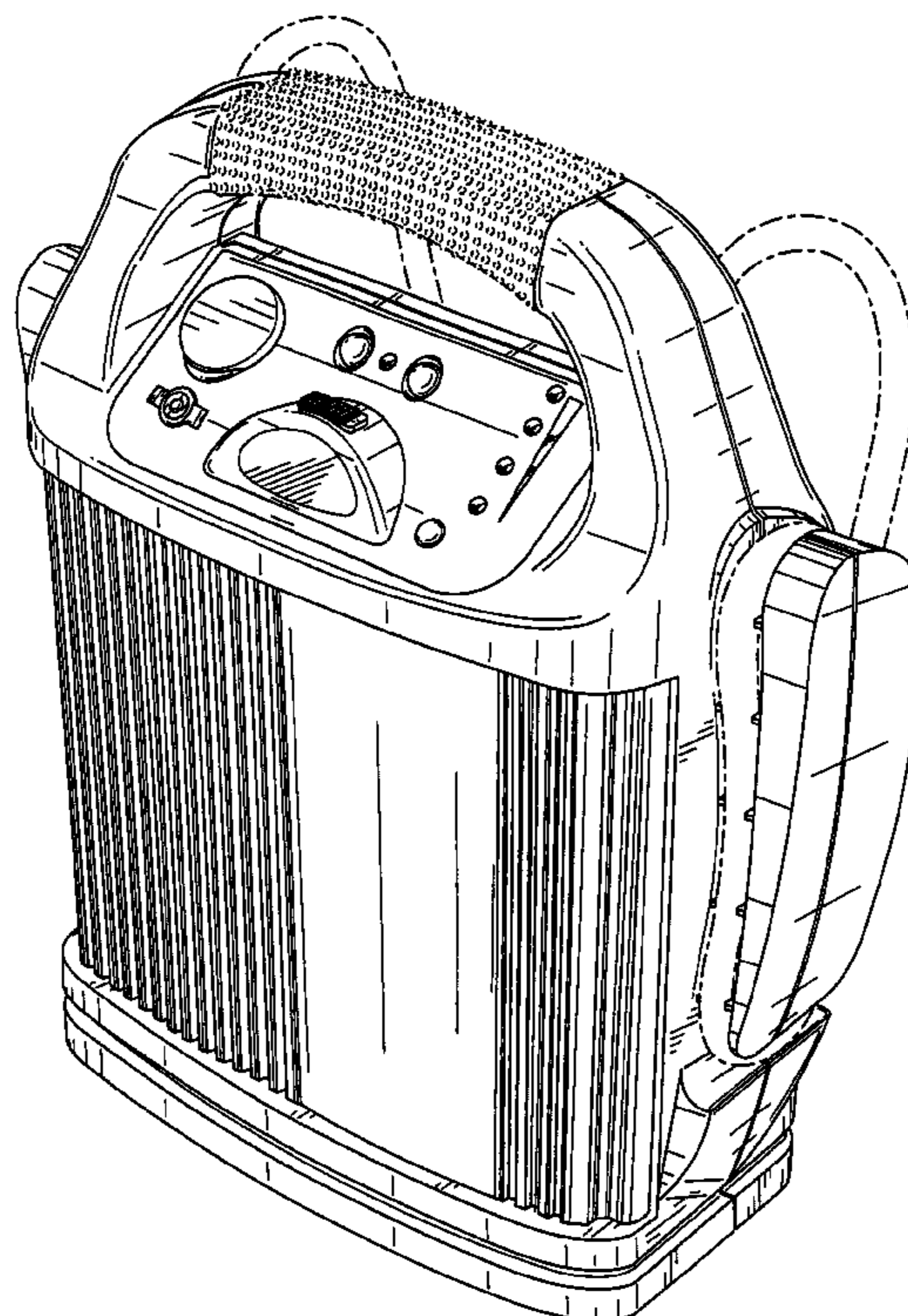
The ornamental design for a jump starter, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from the front-top-right side of the jump starter showing our new design; FIG. 2 is a front view of the design shown in FIG. 1; FIG. 3 is a rear view of the design shown in FIG. 1; FIG. 4 is a left side view of the design shown in FIG. 1; FIG. 5 is a right side view of the design shown in FIG. 1; FIG. 6 is a top view of the design shown in FIG. 1; and, FIG. 7 is a bottom view of the design shown in FIG. 1.

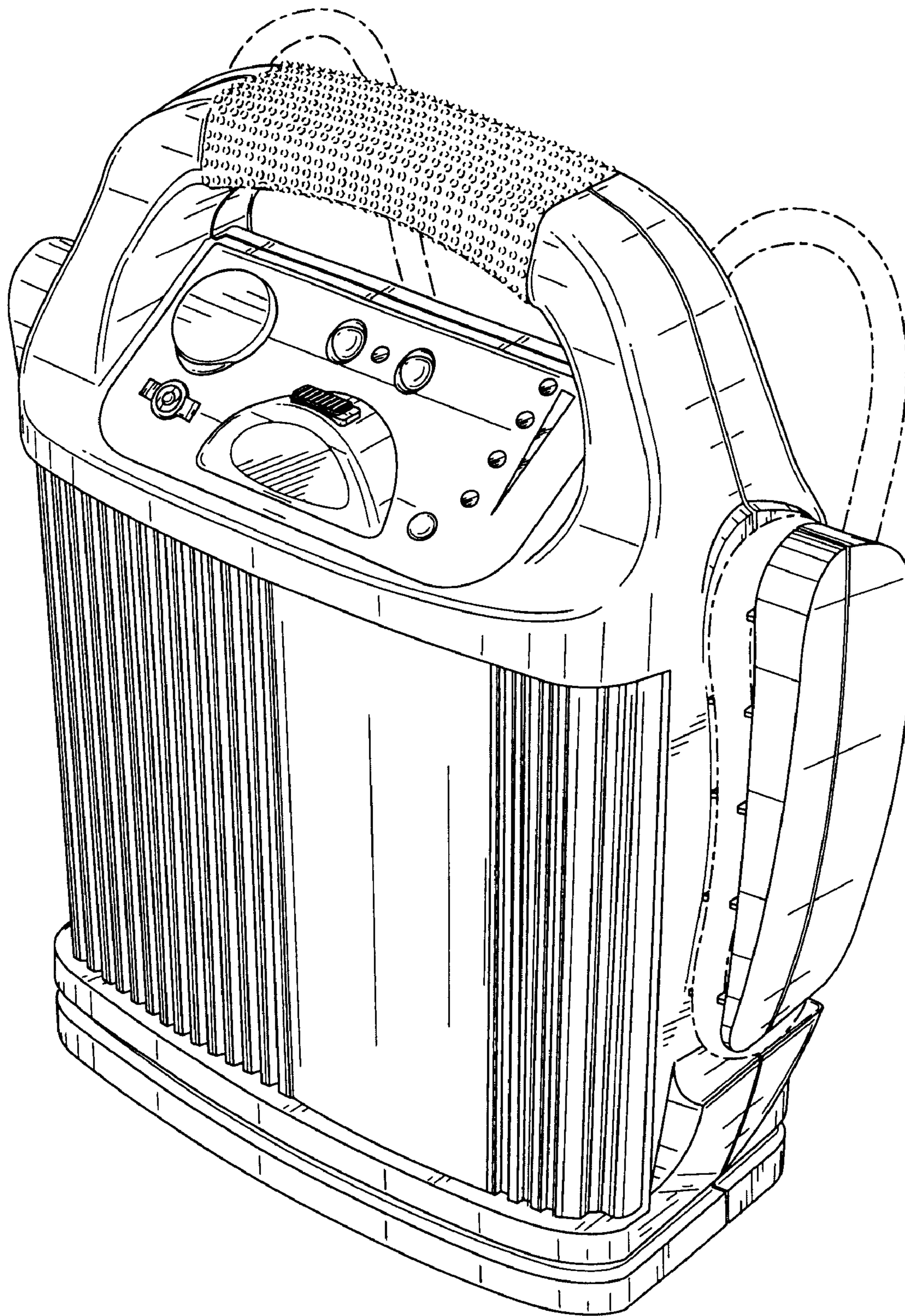

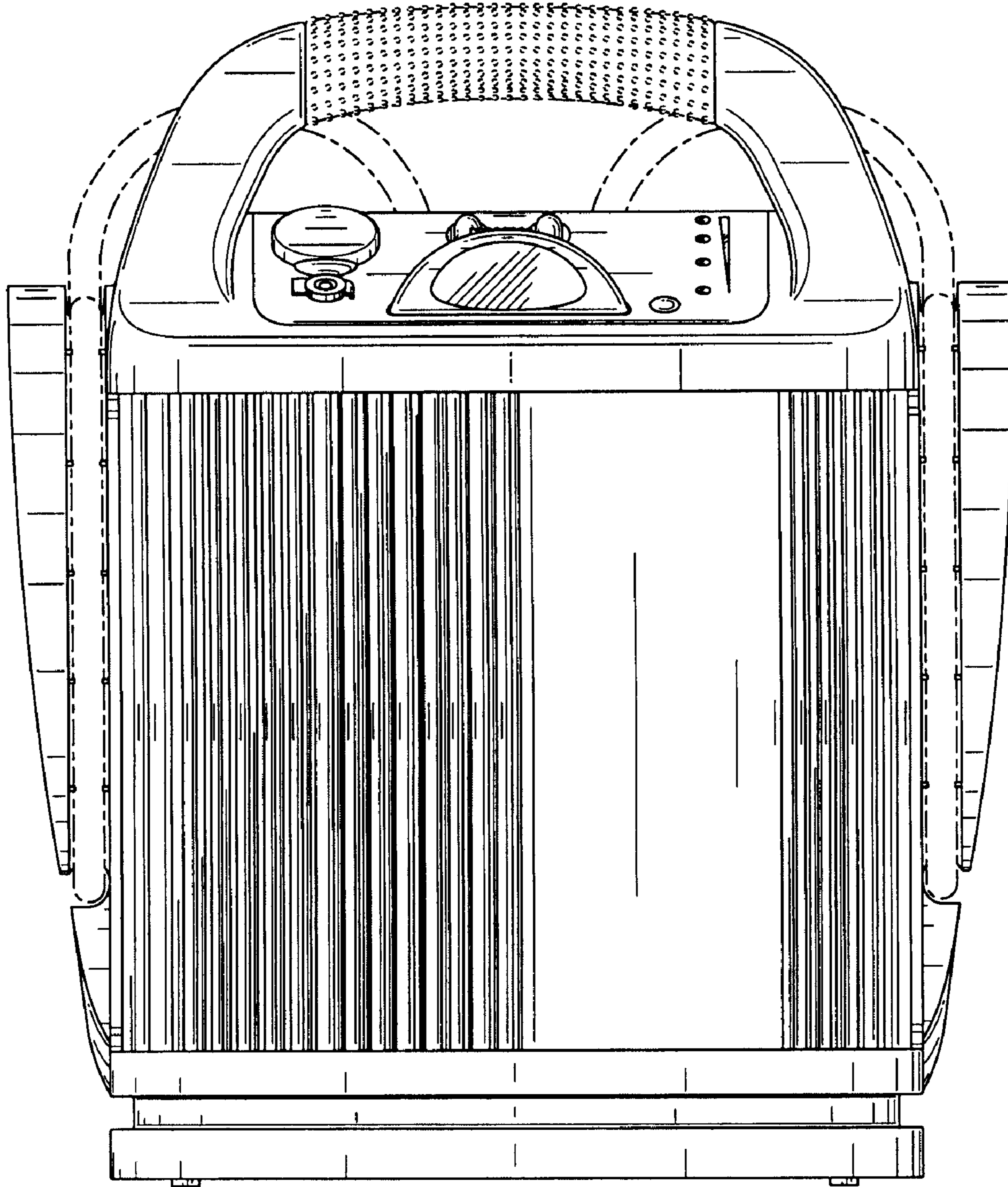

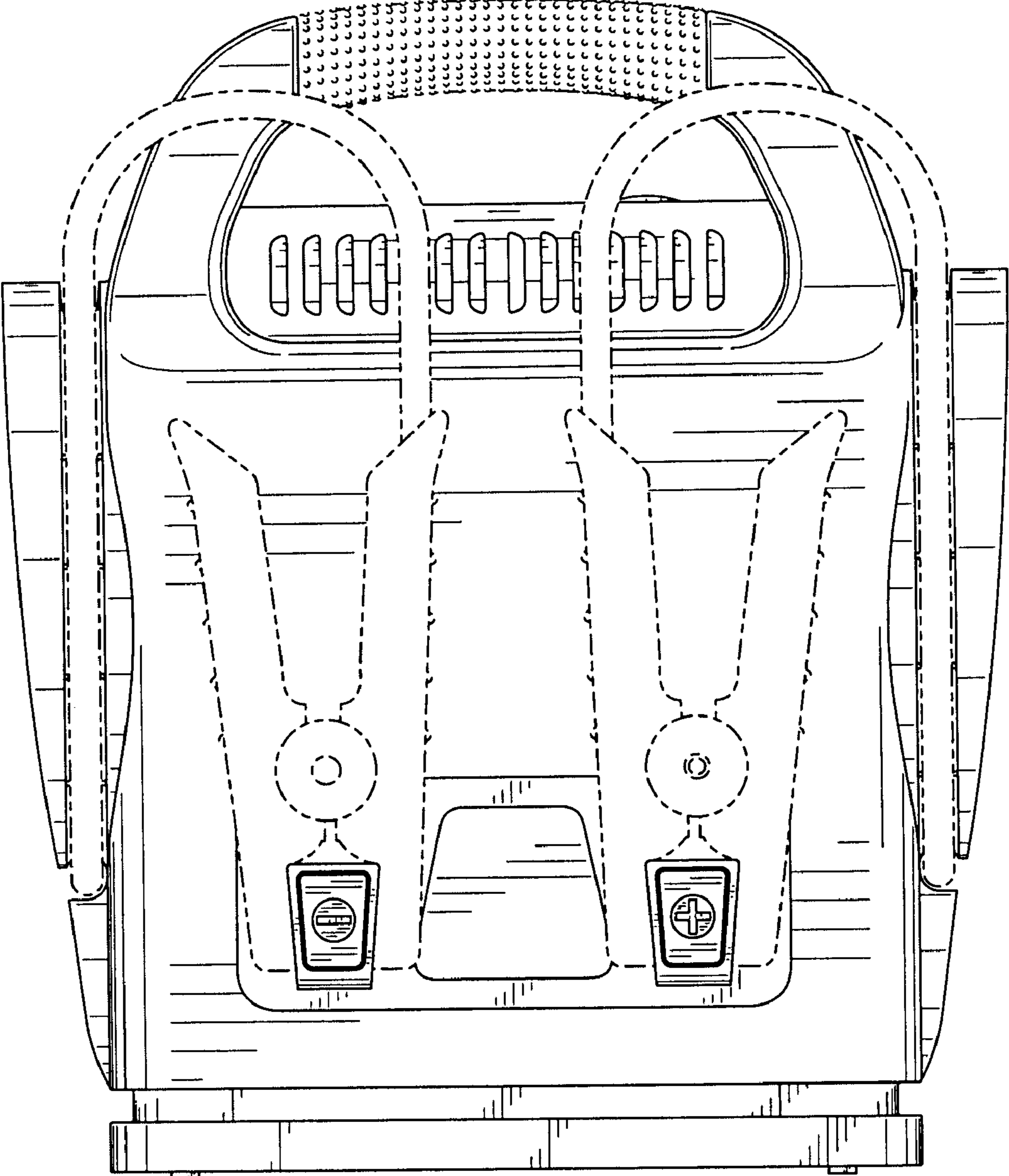

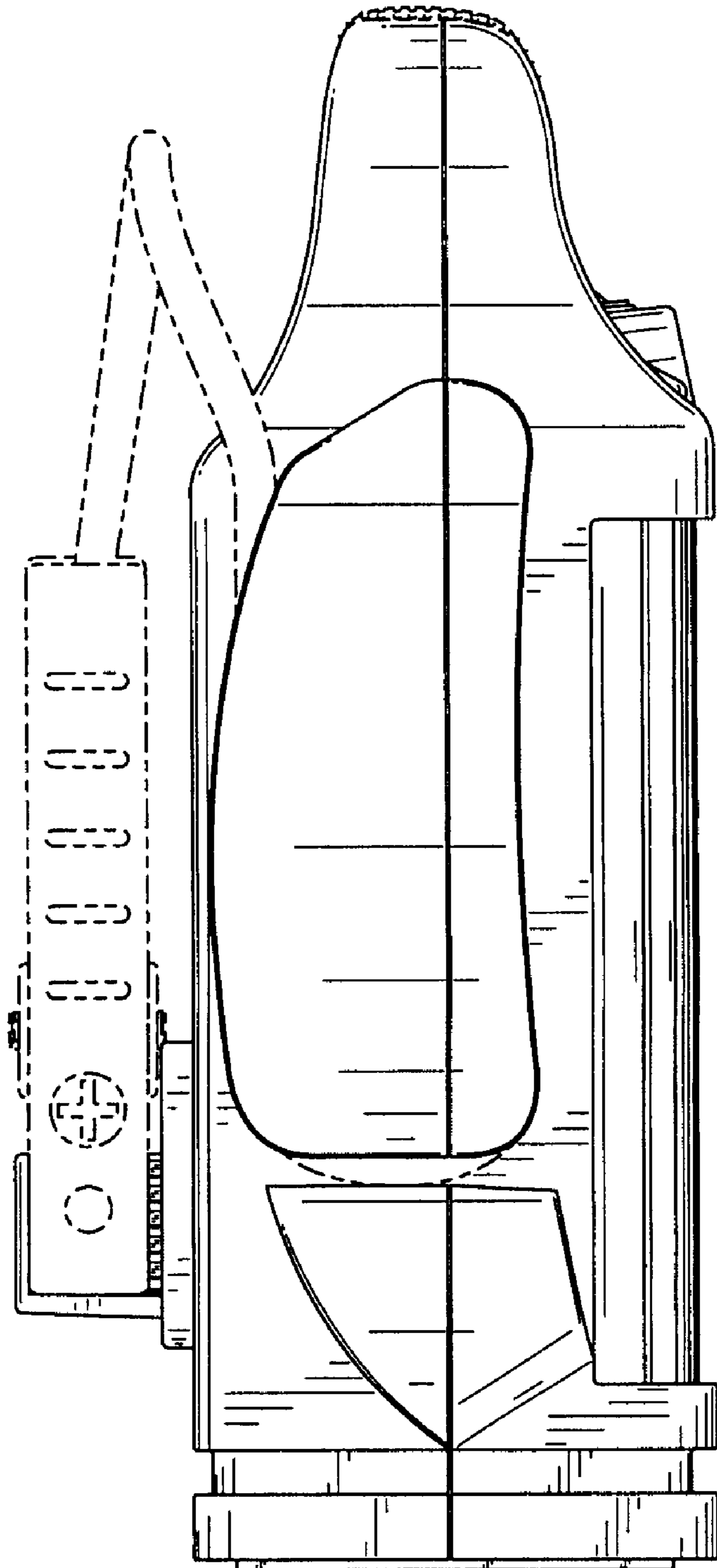

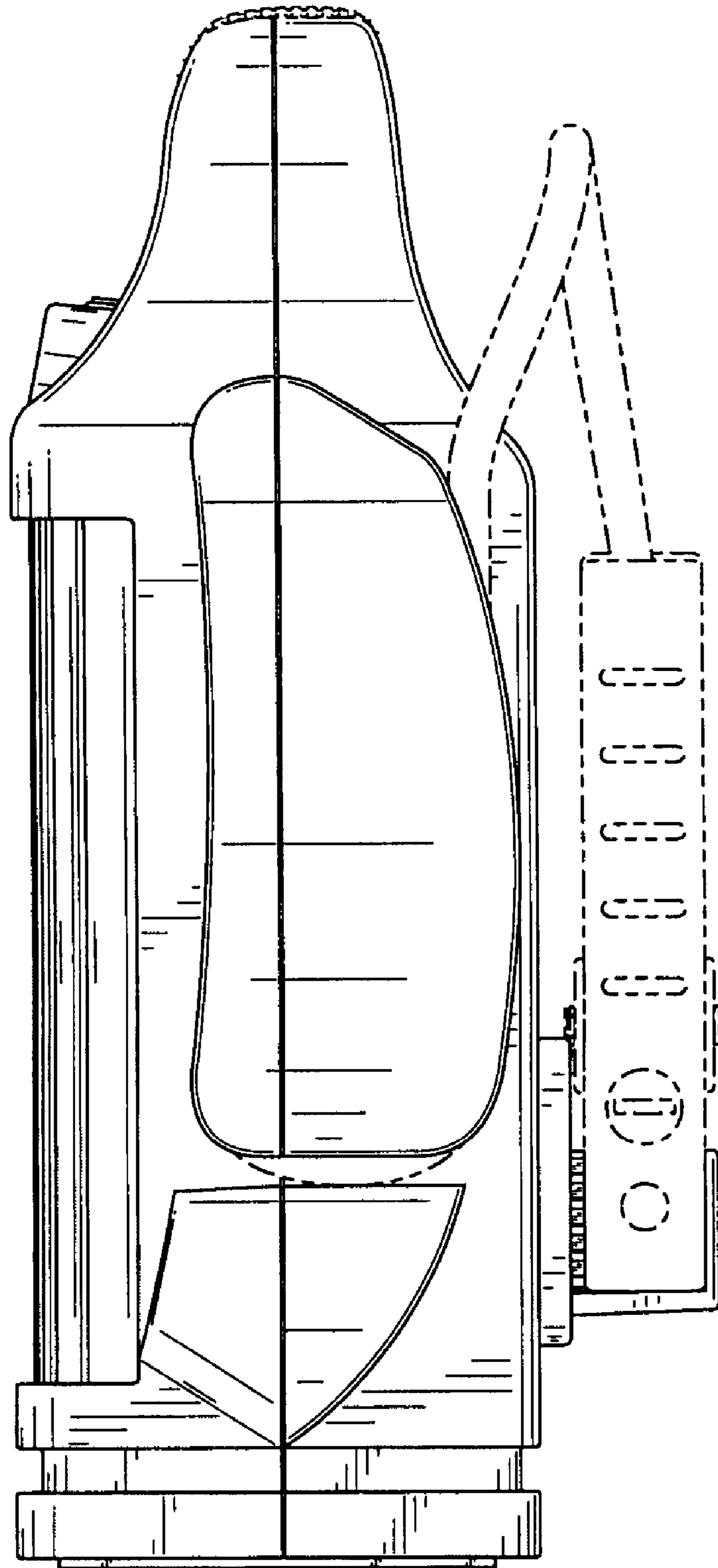

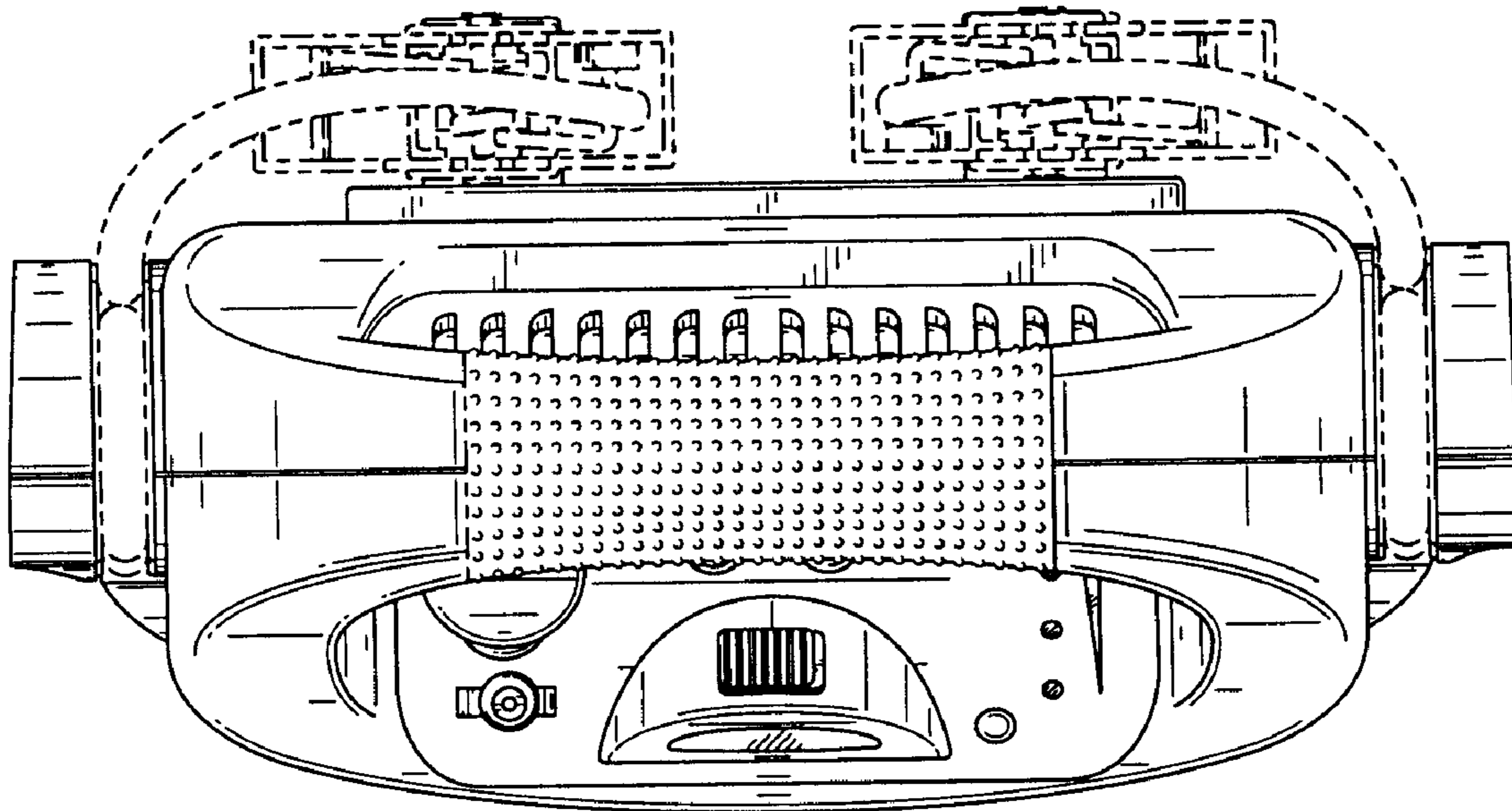

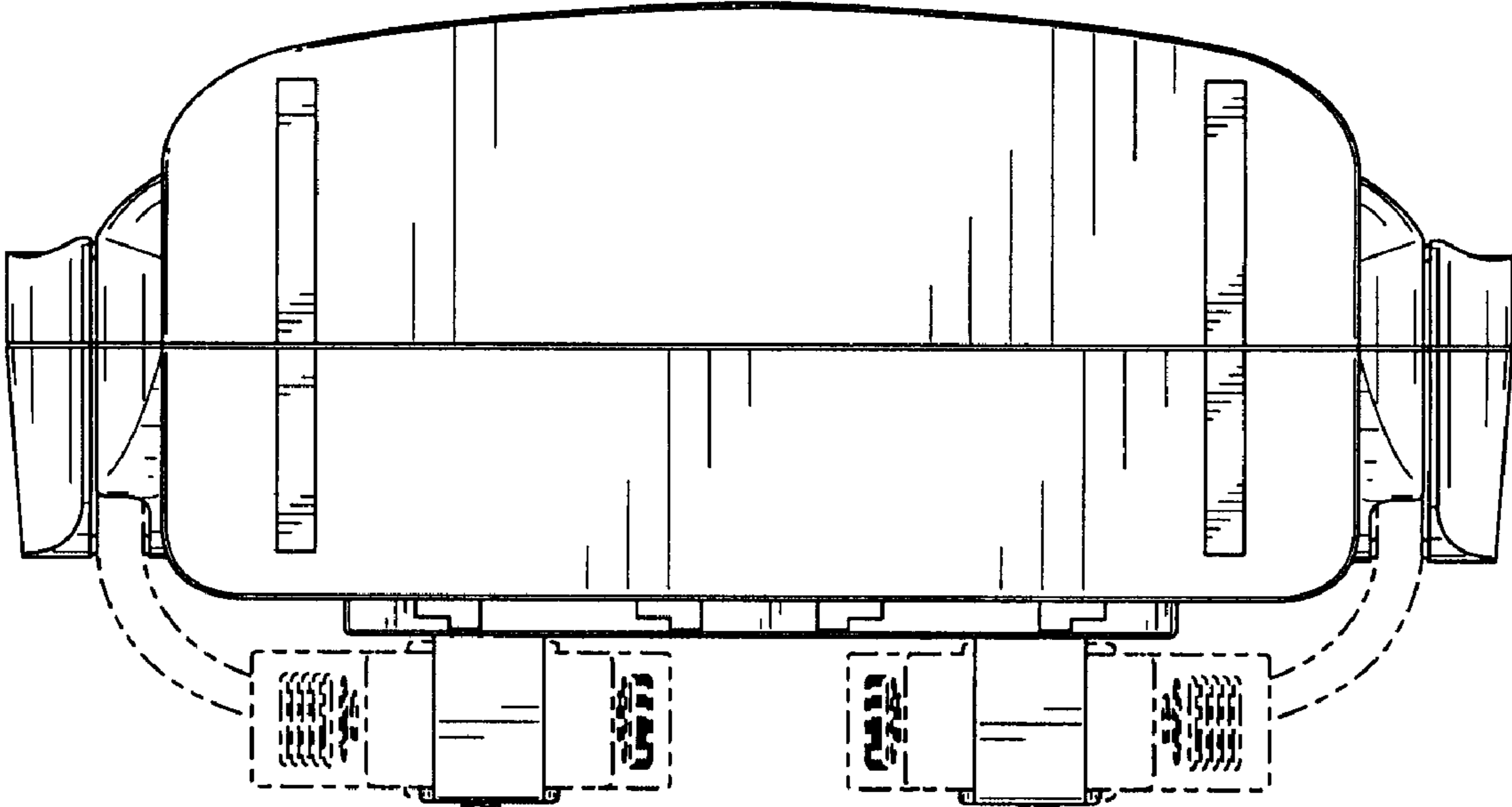
