(57) **CLAIM**

The ornamental design for a vehicle seat, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a vehicle seat according to a first embodiment of the present invention;
 FIG. 2 is a left elevation view of the vehicle seat shown in FIG. 1, with a right elevation view of the vehicle seat shown in FIG. 1 being a mirror image of FIG. 2;
 FIG. 3 is a front elevation view of the vehicle seat shown in FIG. 1;
 FIG. 4 is a rear elevation view of the vehicle seat shown in FIG. 1;
 FIG. 5 is a top plan view of the vehicle seat shown in FIG. 1;
 FIG. 6 is a perspective view of a vehicle seat according to a second embodiment of the present invention;
 FIG. 7 is a left elevation view of the vehicle seat shown in FIG. 6, with a right elevation view of the vehicle seat shown in FIG. 6 being a mirror image of FIG. 7;
 FIG. 8 is a front elevation view of the vehicle seat shown in FIG. 6;
 FIG. 9 is a rear elevation view of the vehicle seat shown in FIG. 6; and,
 FIG. 10 is a top plan view of the vehicle seat shown in FIG. 6.

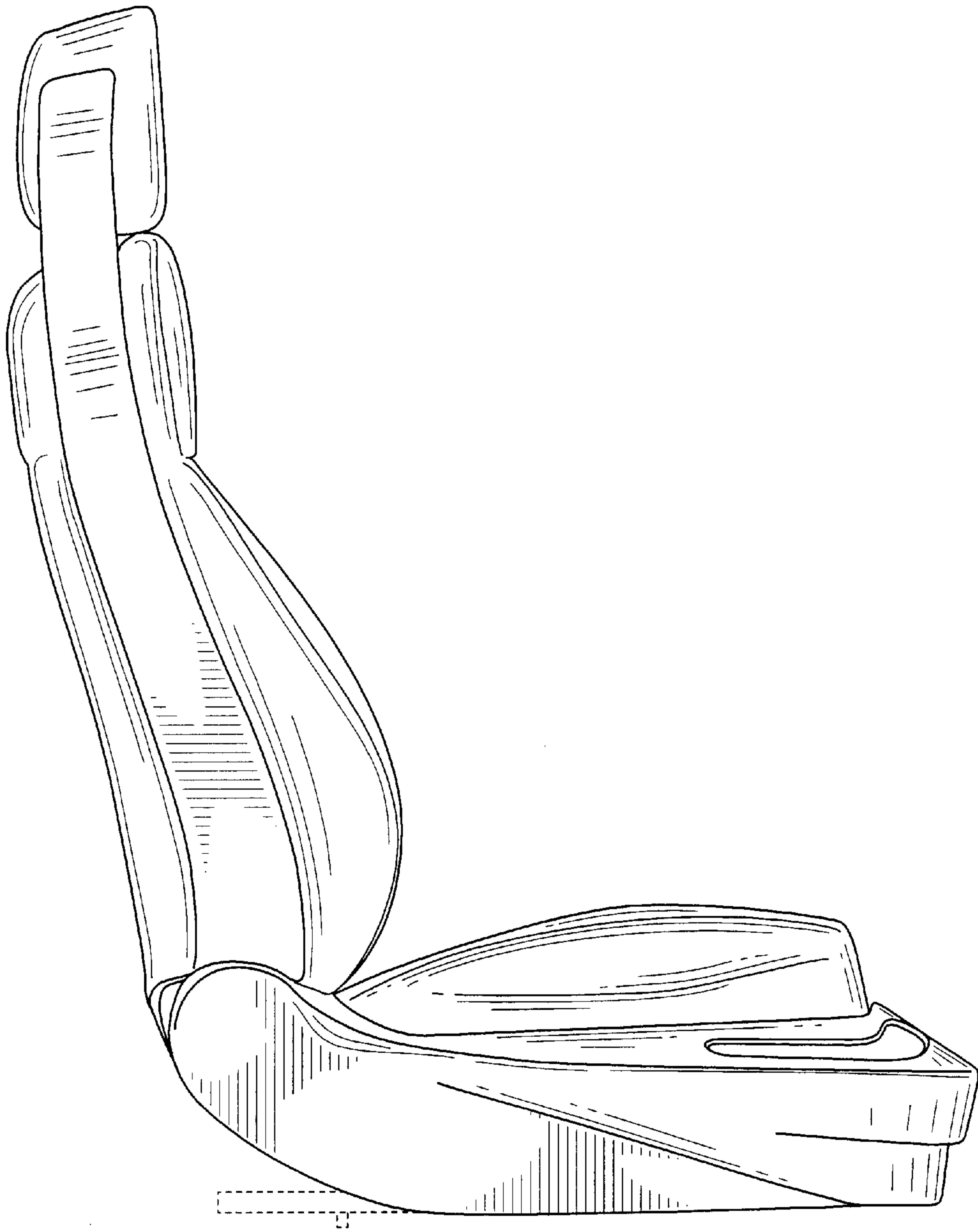

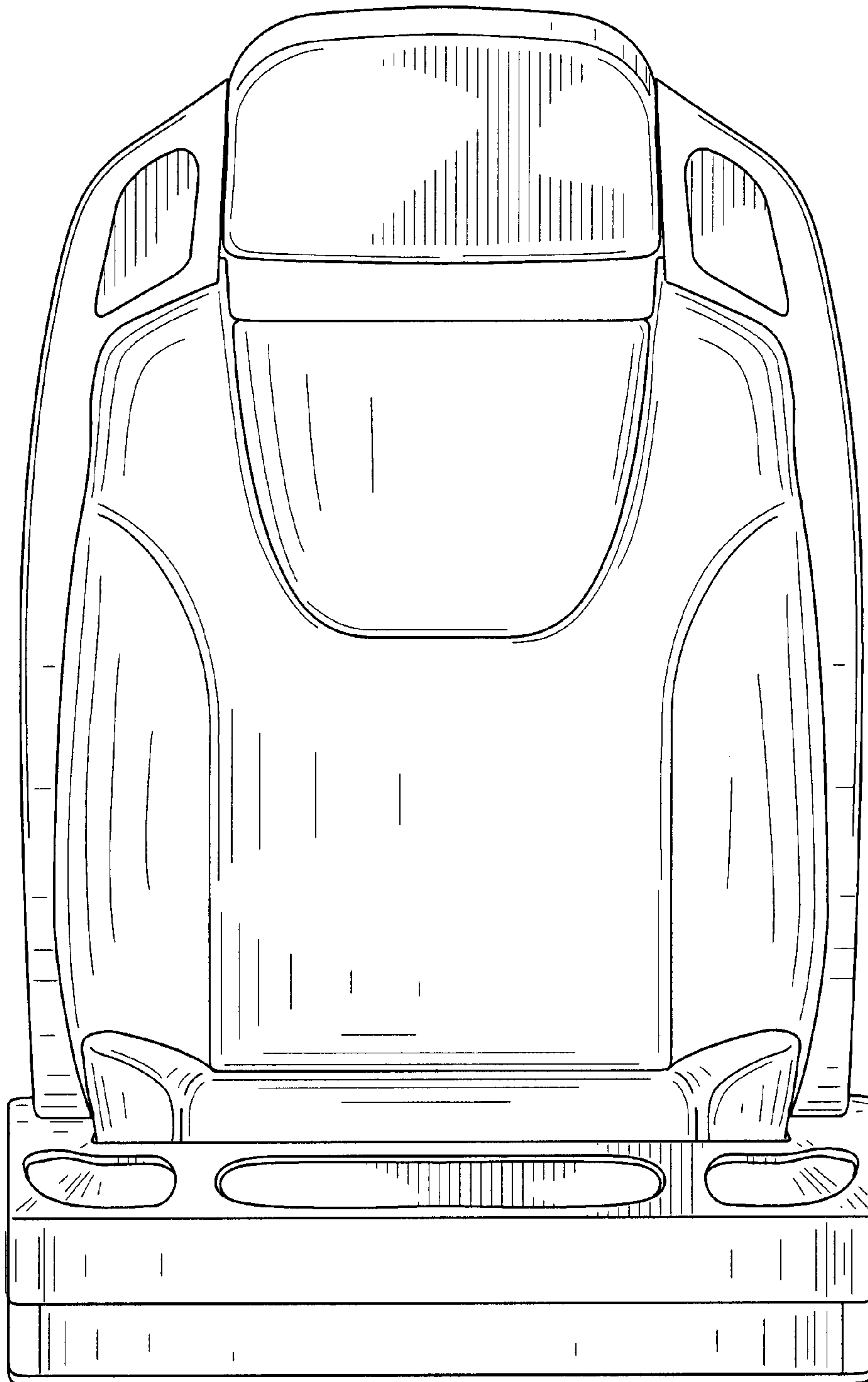

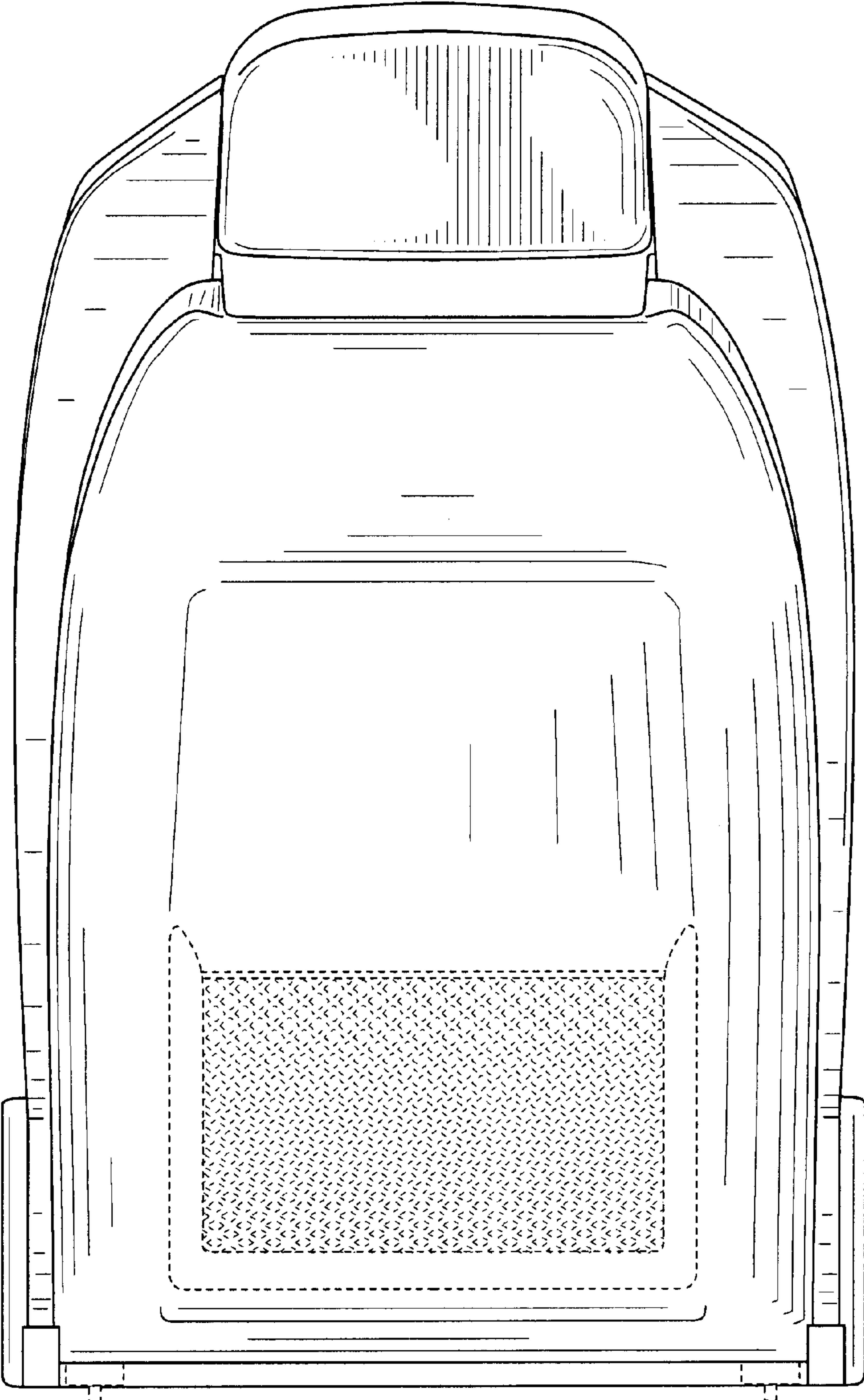

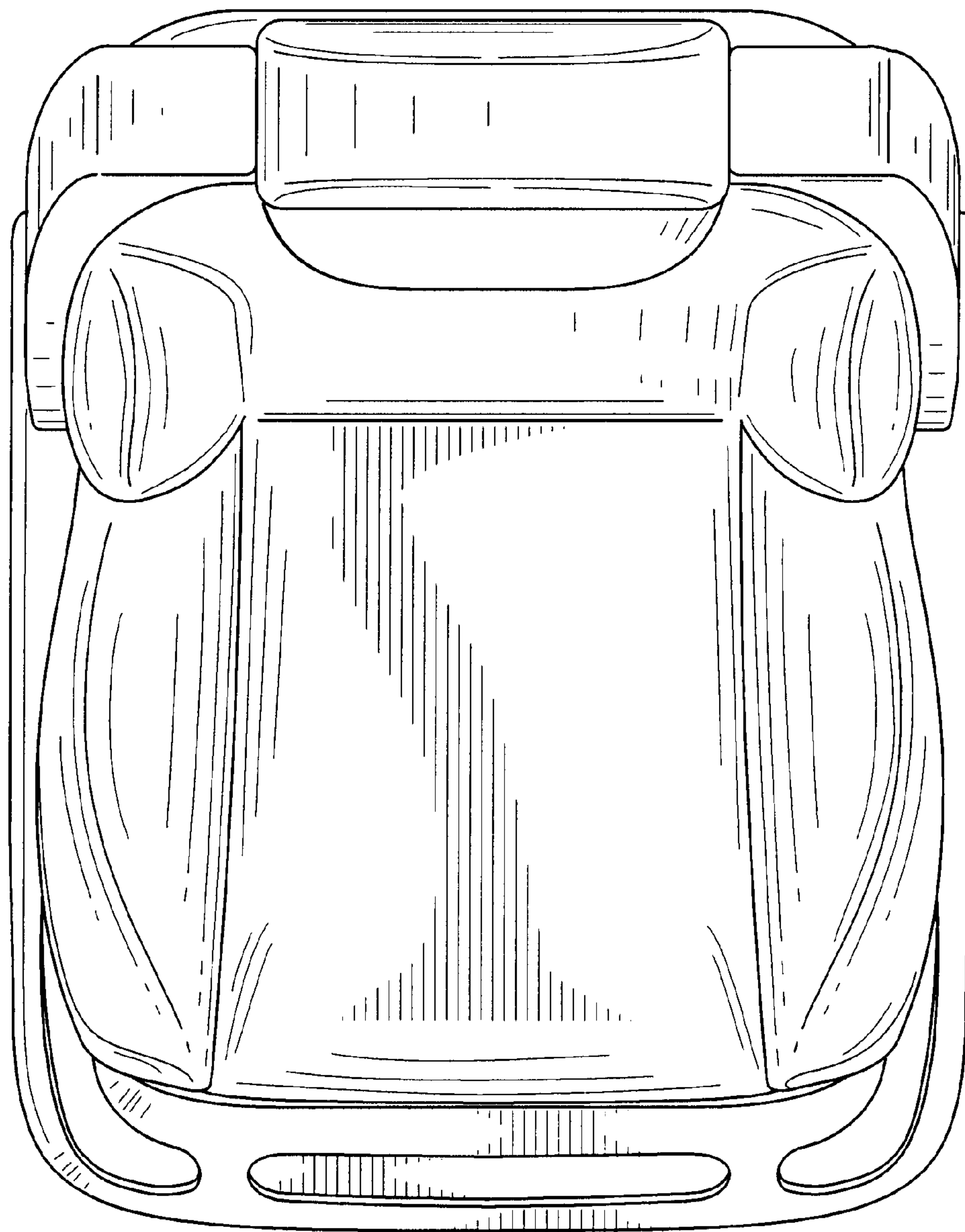

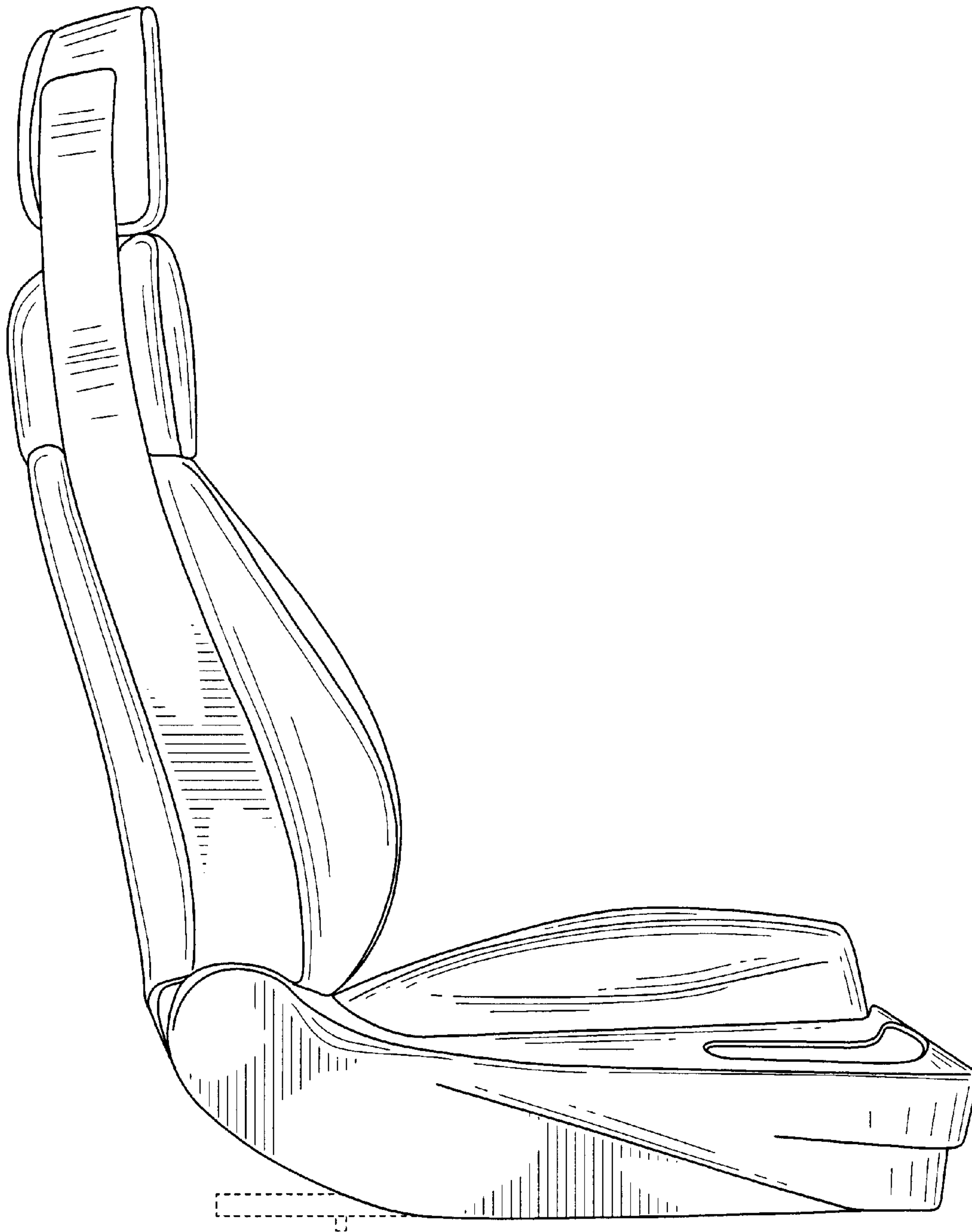

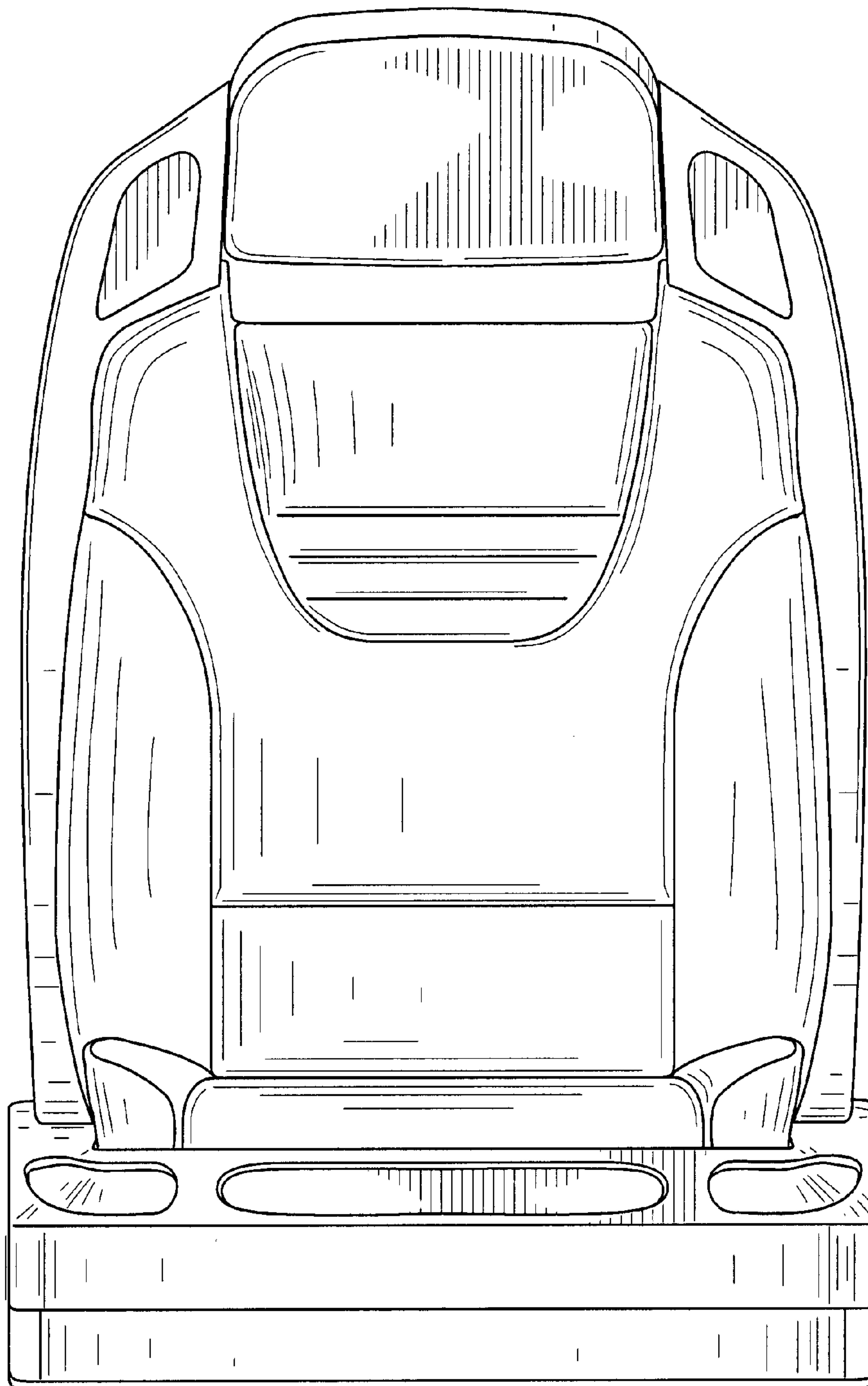

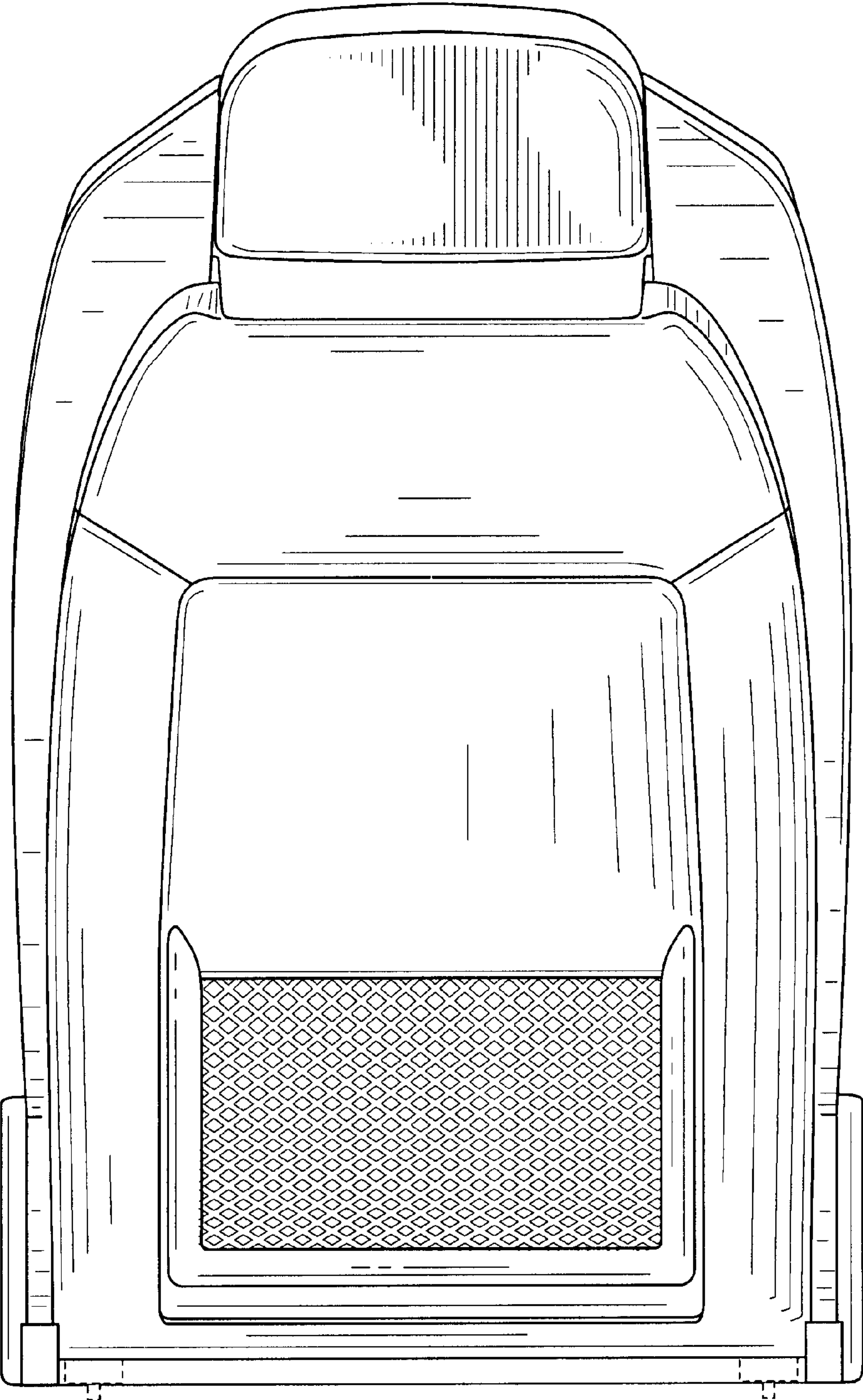

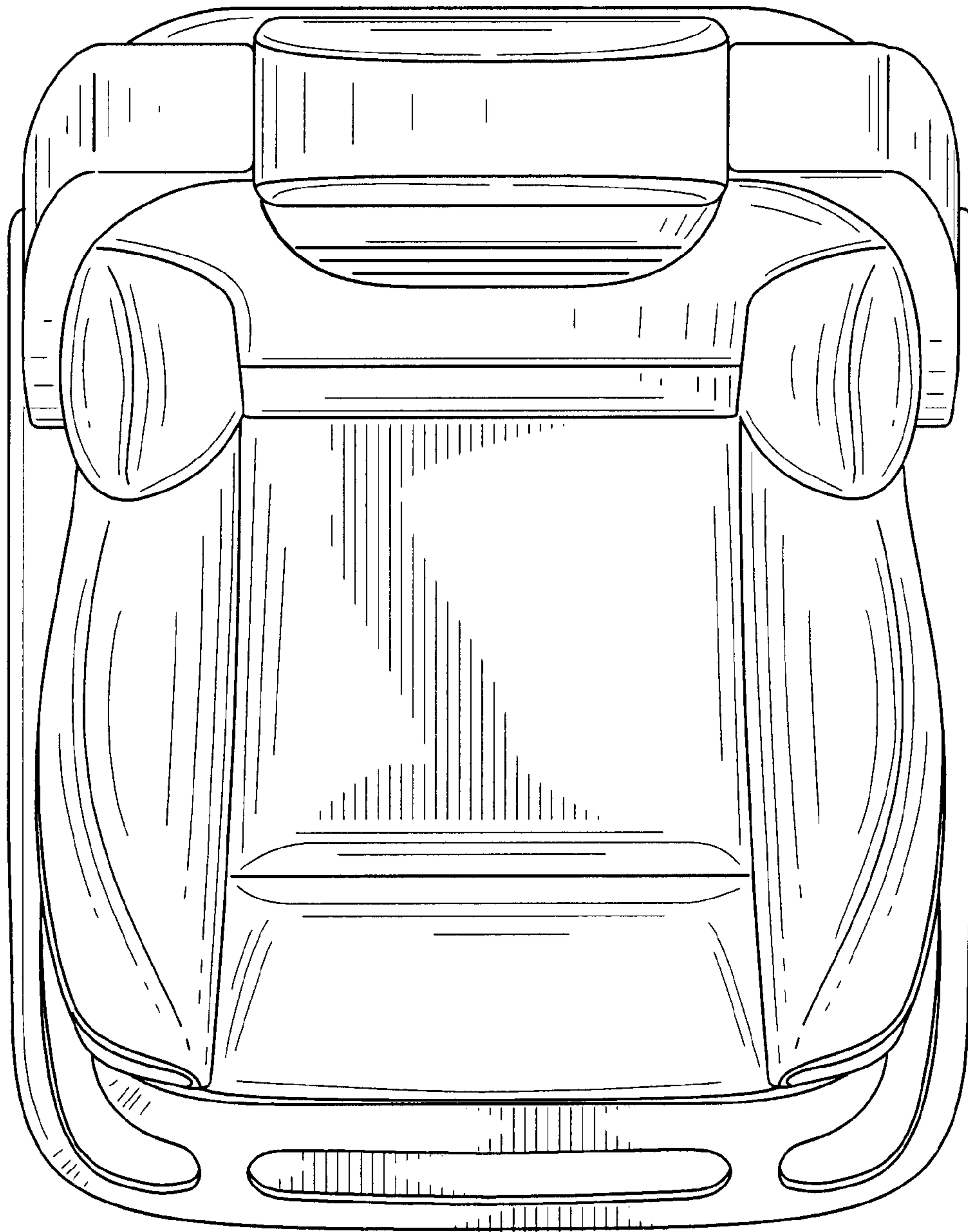
