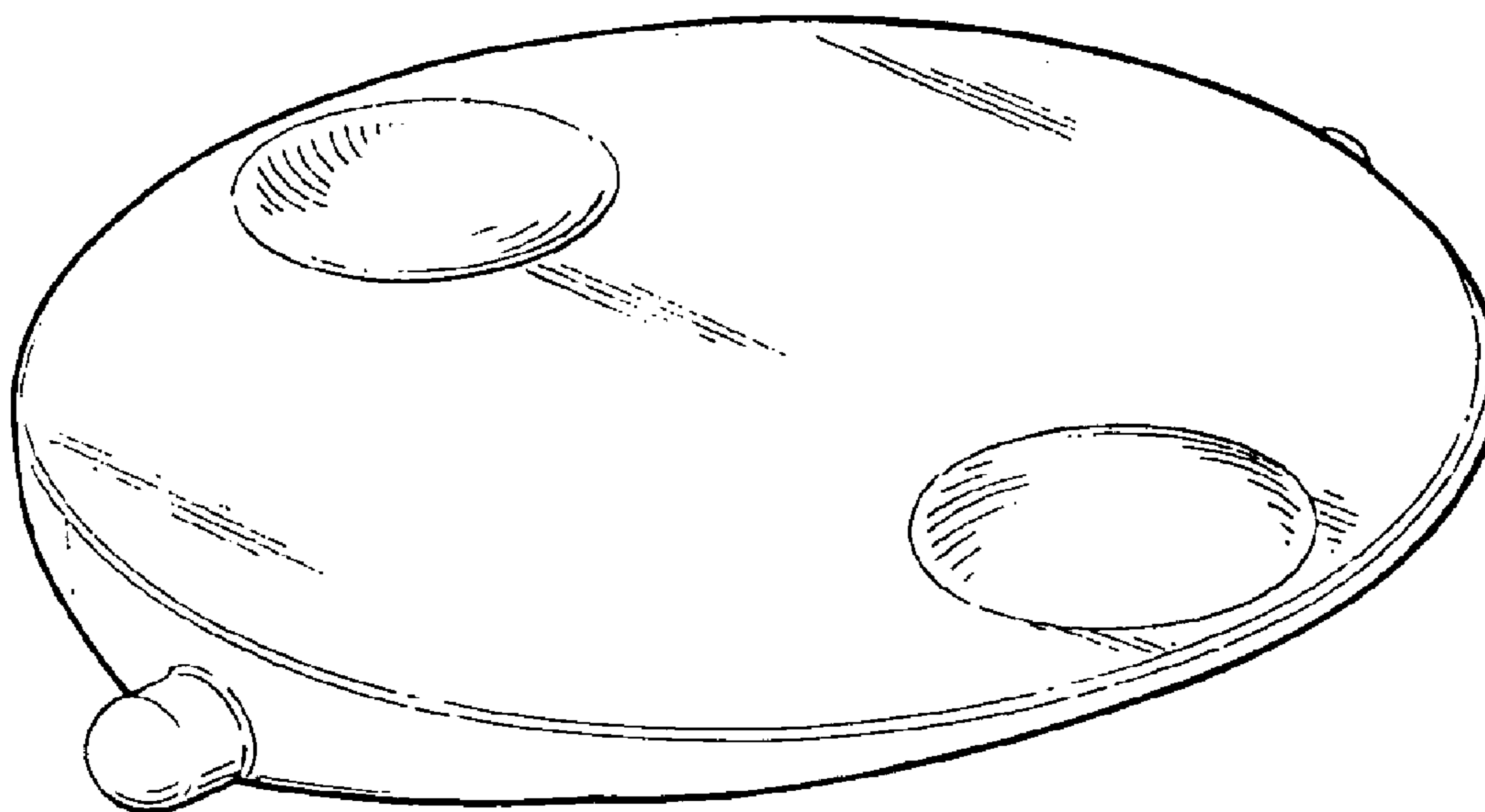
(57) **CLAIM**

The ornamental design for a vent closure device, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a vent closure device showing my new design;
 FIG. 2 is a bottom perspective view thereof;
 FIG. 3 is a top view thereof;
 FIG. 4 is a bottom view thereof;
 FIG. 5 is a front view of the vent closure device shown in FIG. 3 as sighted along arrow 5 of FIG. 3, the rear view being a mirror image;
 FIG. 6 is a right end view of the vent closure device shown in FIG. 3 as sighted along arrow 6 of FIG. 3; and,
 FIG. 7 is a left end view of the vent closure device shown in FIG. 3 as sighted along arrow 7 of FIG. 3.

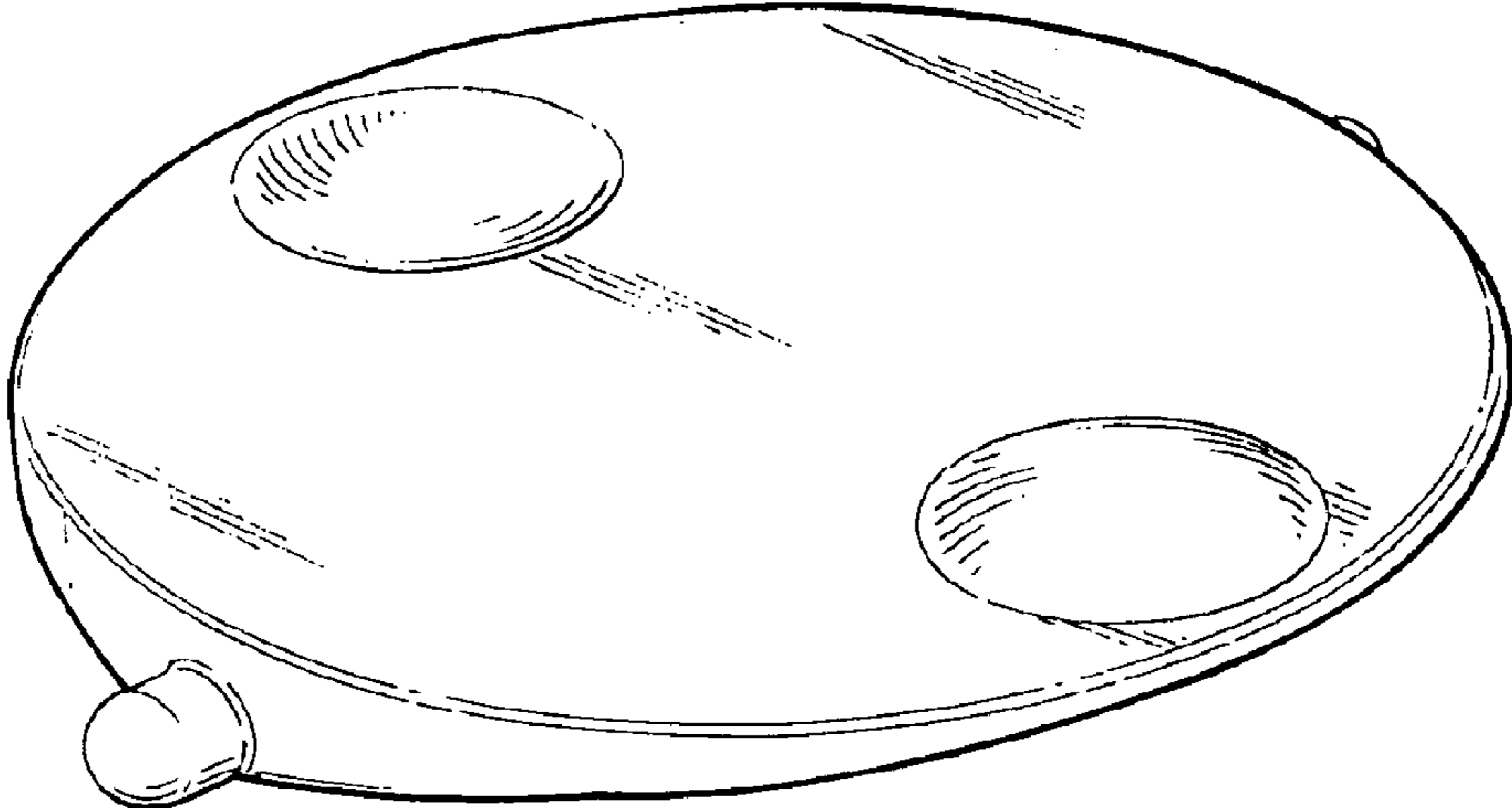

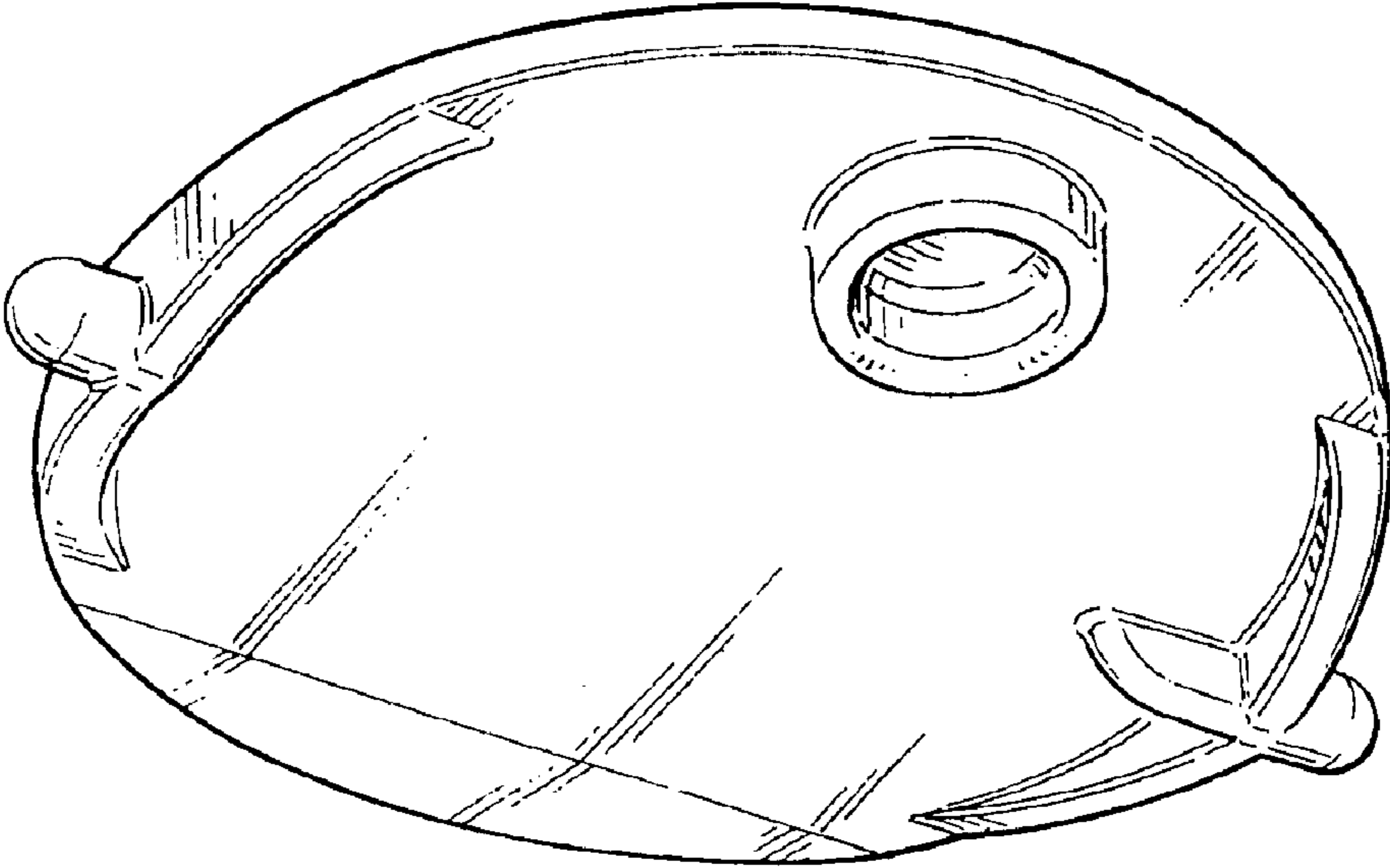

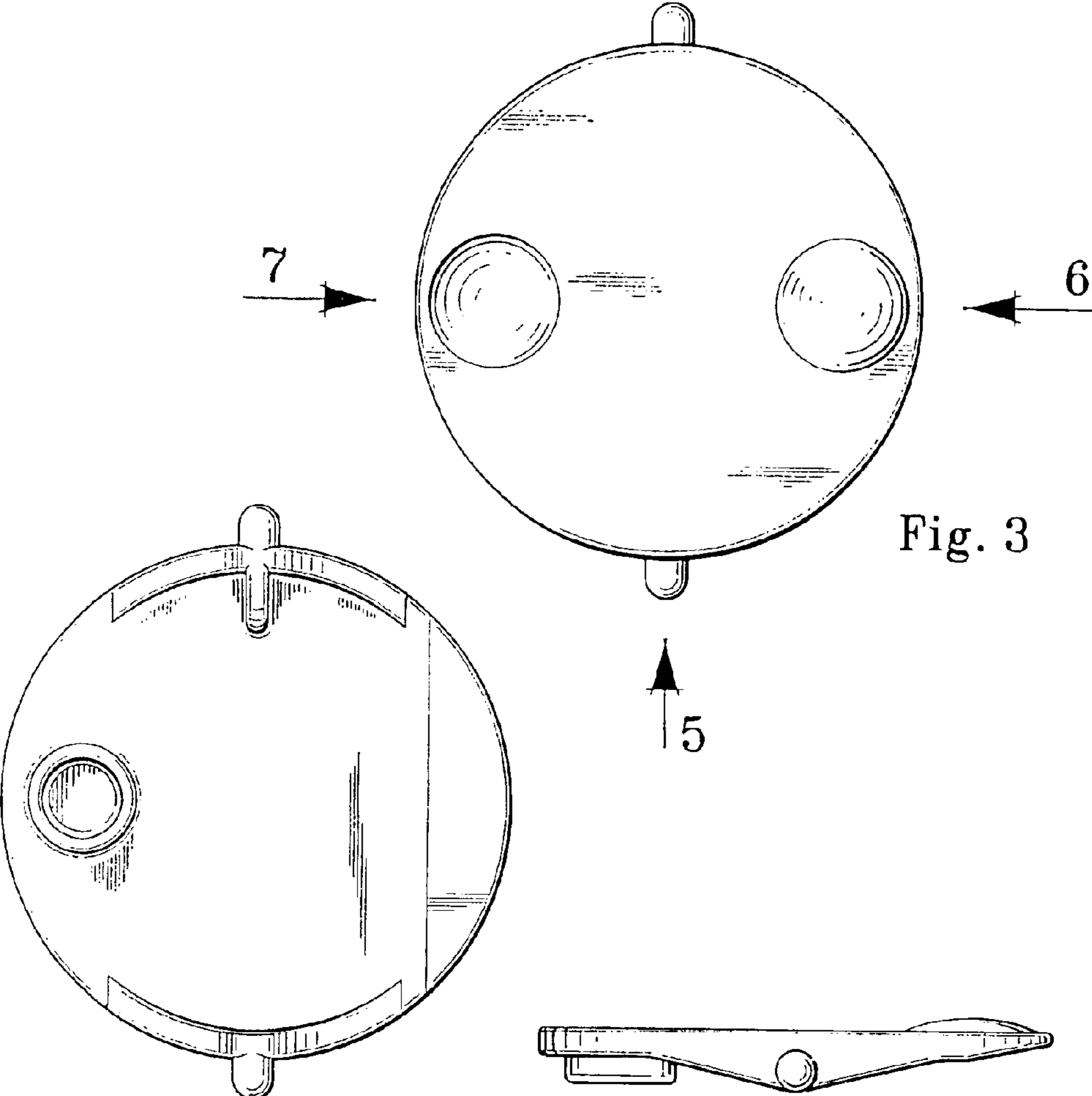

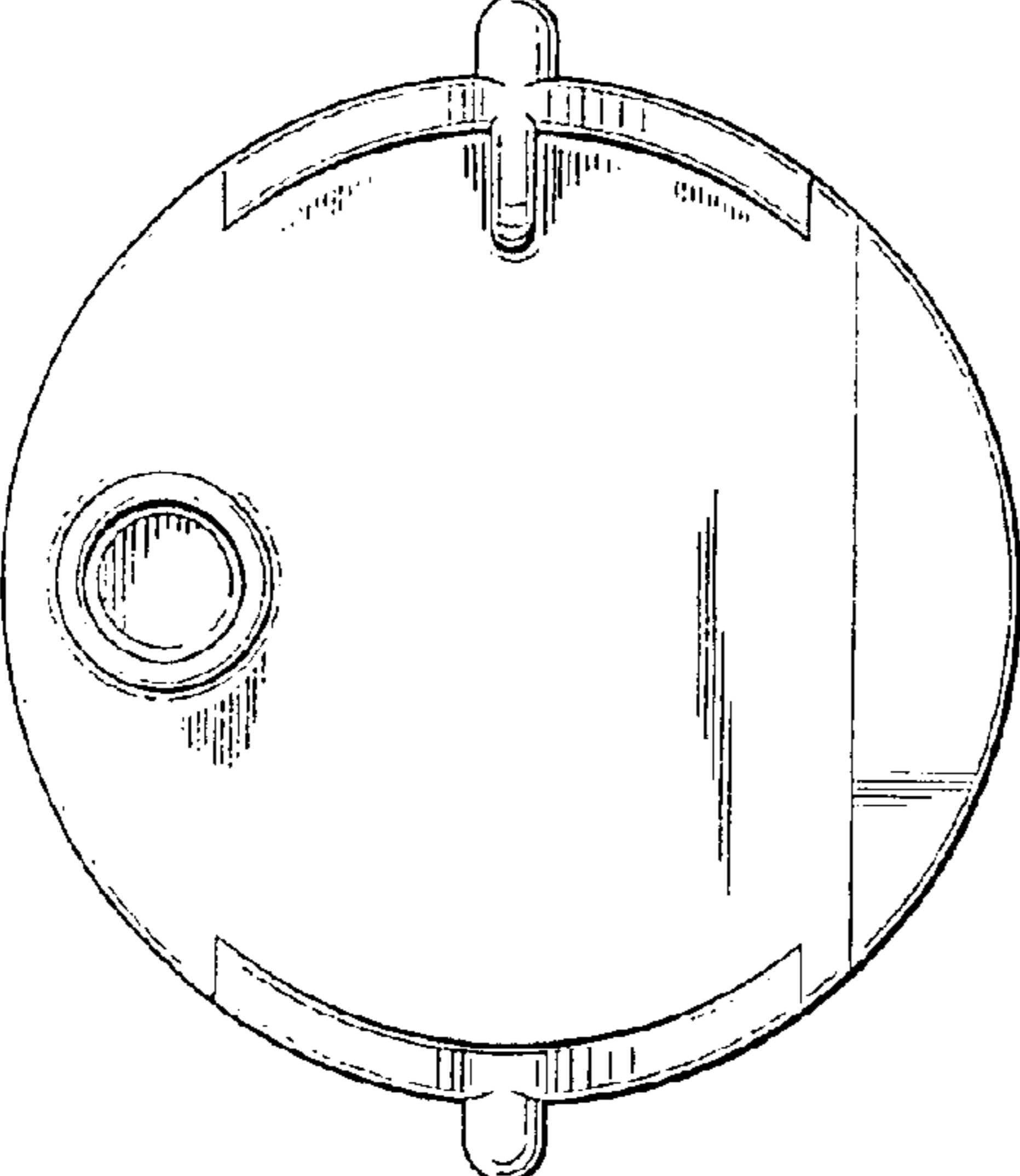

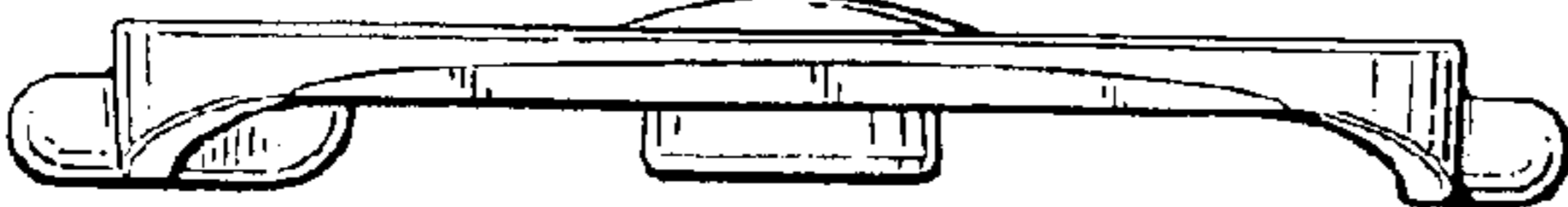

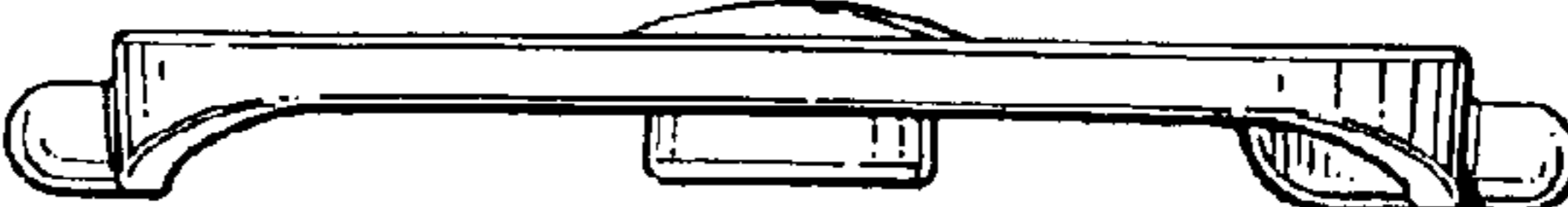
