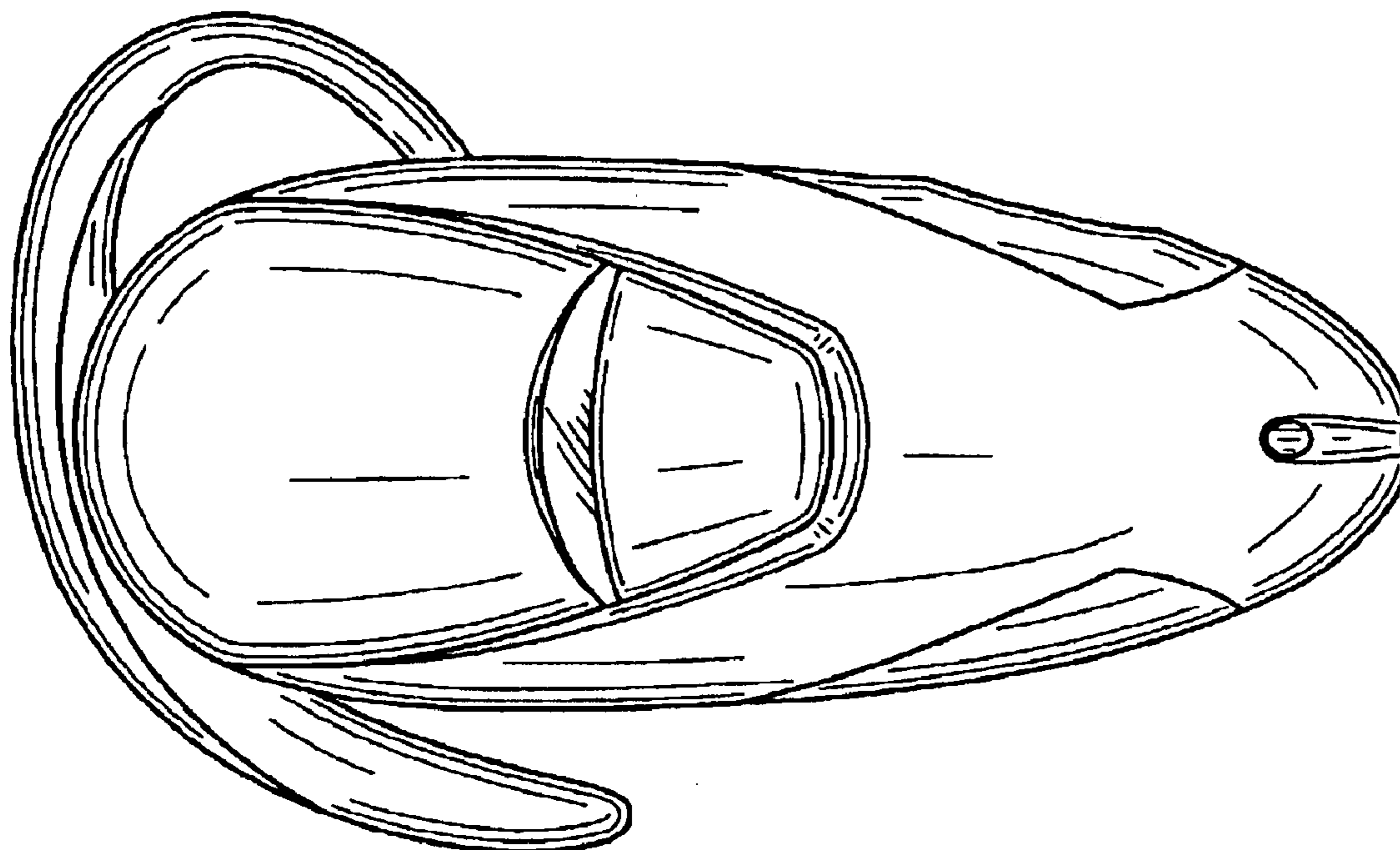
(57) **CLAIM**

The ornamental design for a headset, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a headset showing my new design; FIG. 2 is a rear view thereof; FIG. 3 is a front view thereof having an alternative ear loop element; FIG. 4 is a rear view thereof of the headset of FIG. 3; FIG. 5 is a perspective right front view of the headset of FIG. 1; FIG. 6 is a perspective left front view of the headset of FIG. 1; FIG. 7 is a left side view of the headset of FIG. 1; FIG. 8 is a right side view of the headset of FIG. 1; FIG. 9 is a top plan view of the headset of FIG. 1; and, FIG. 10 is a perspective rear view of the headset of FIG. 1.

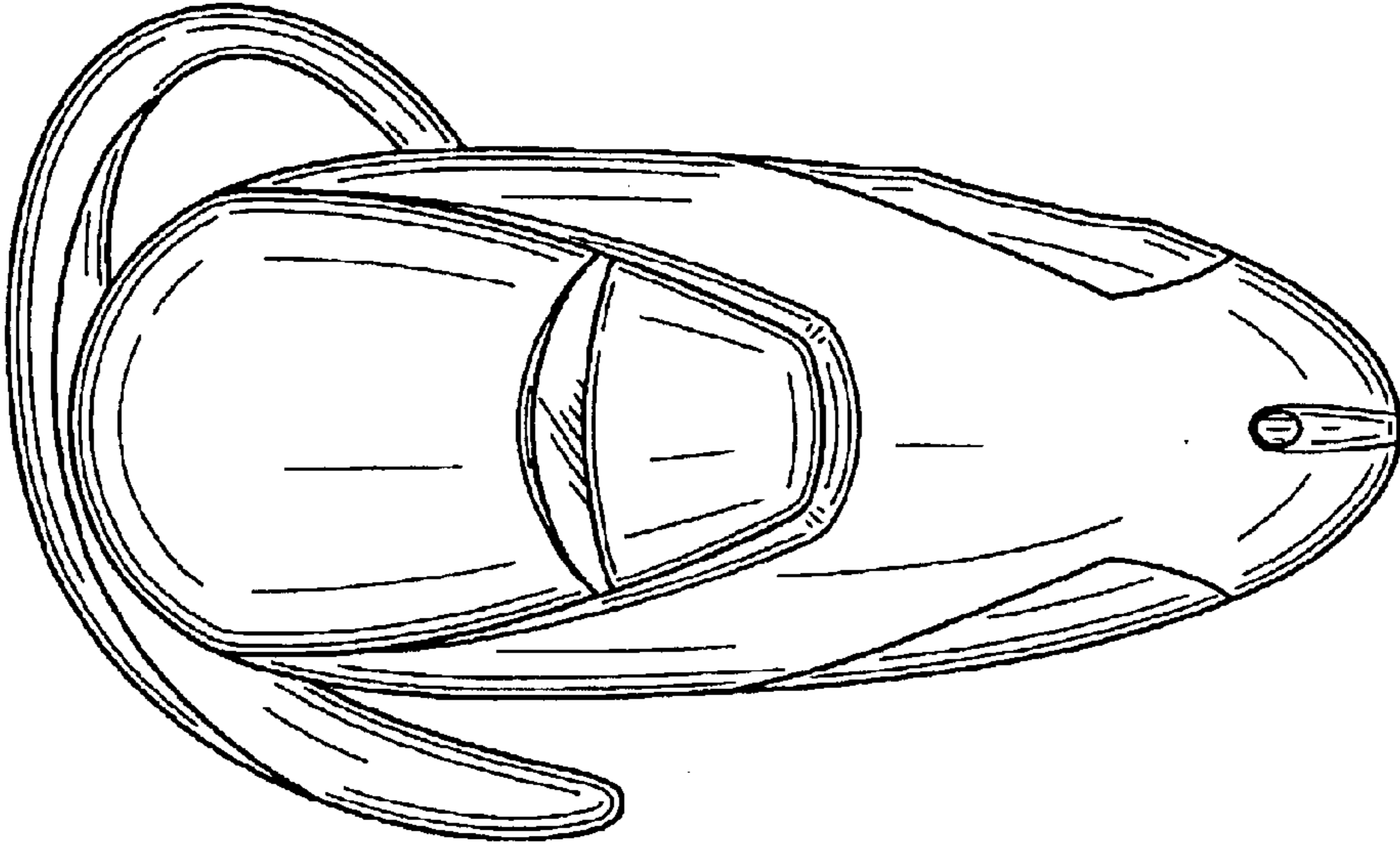

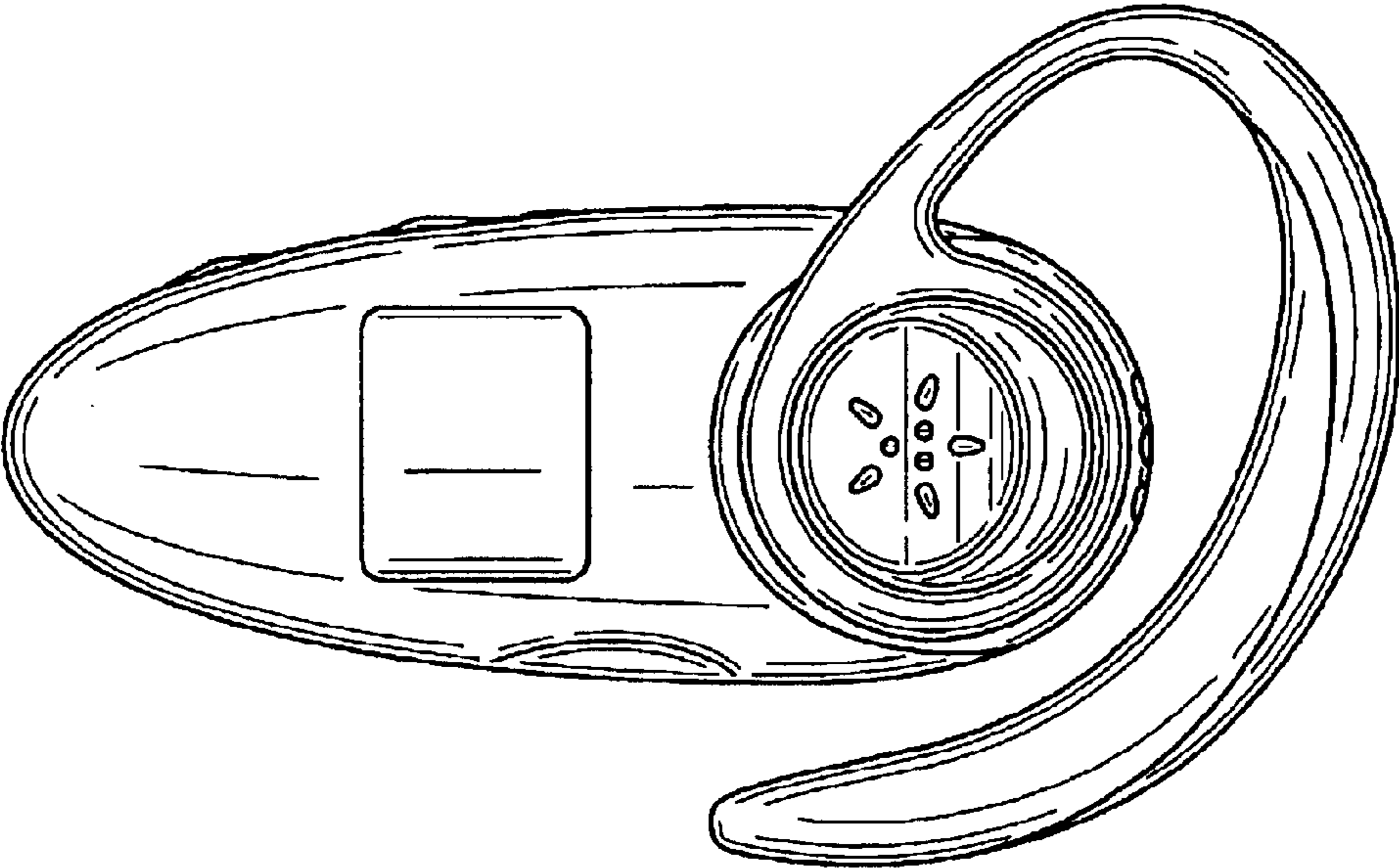

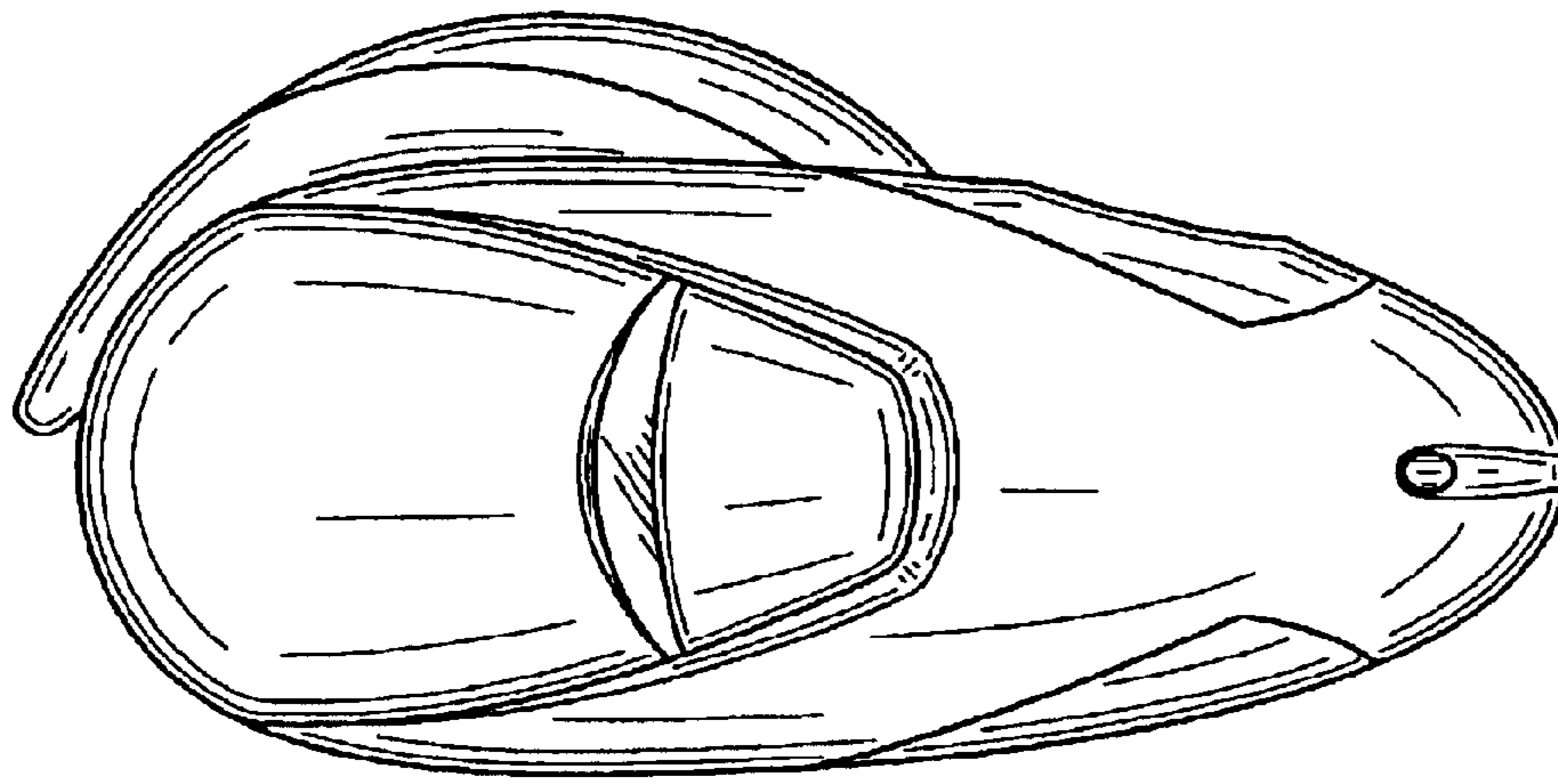

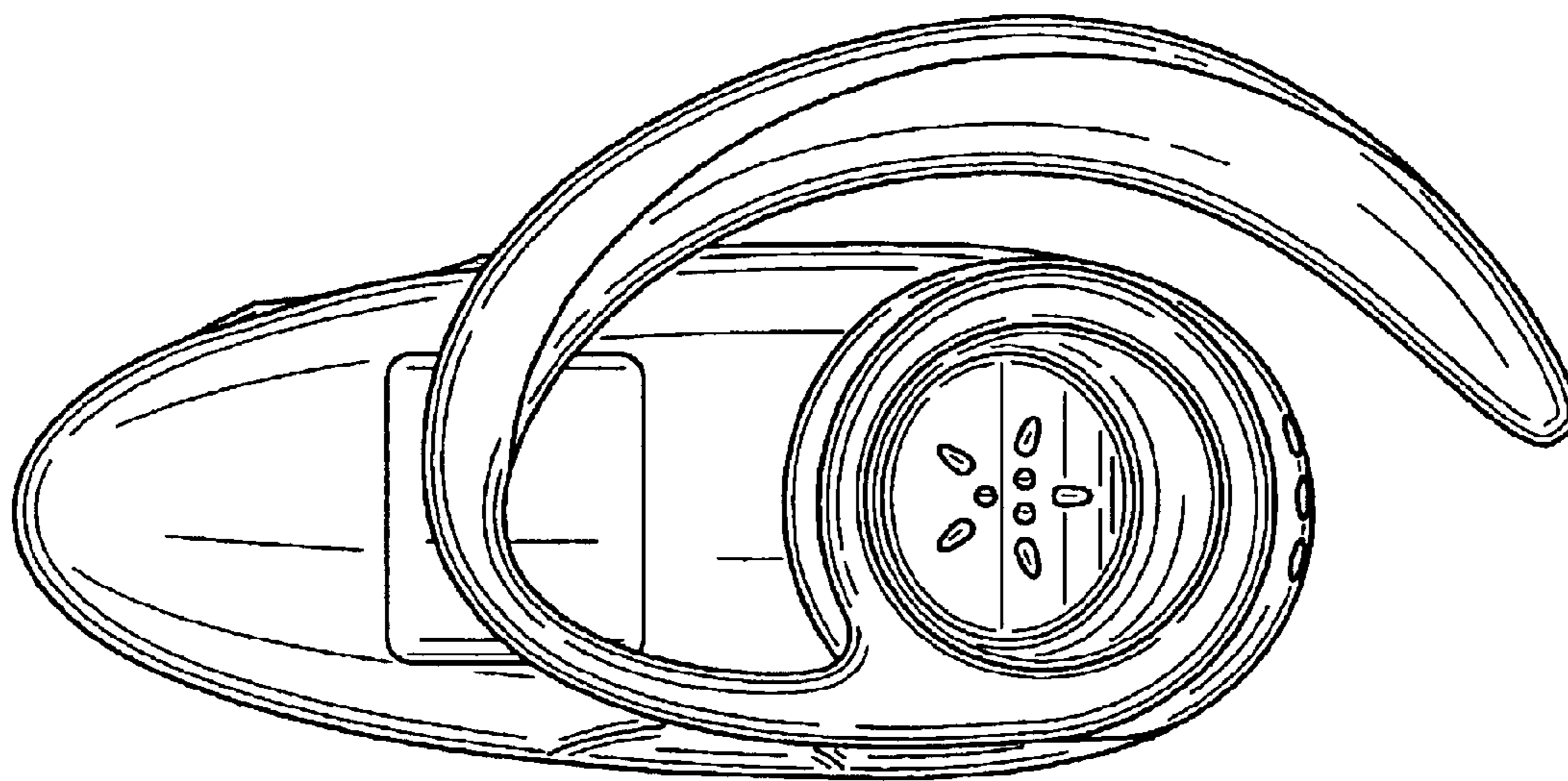

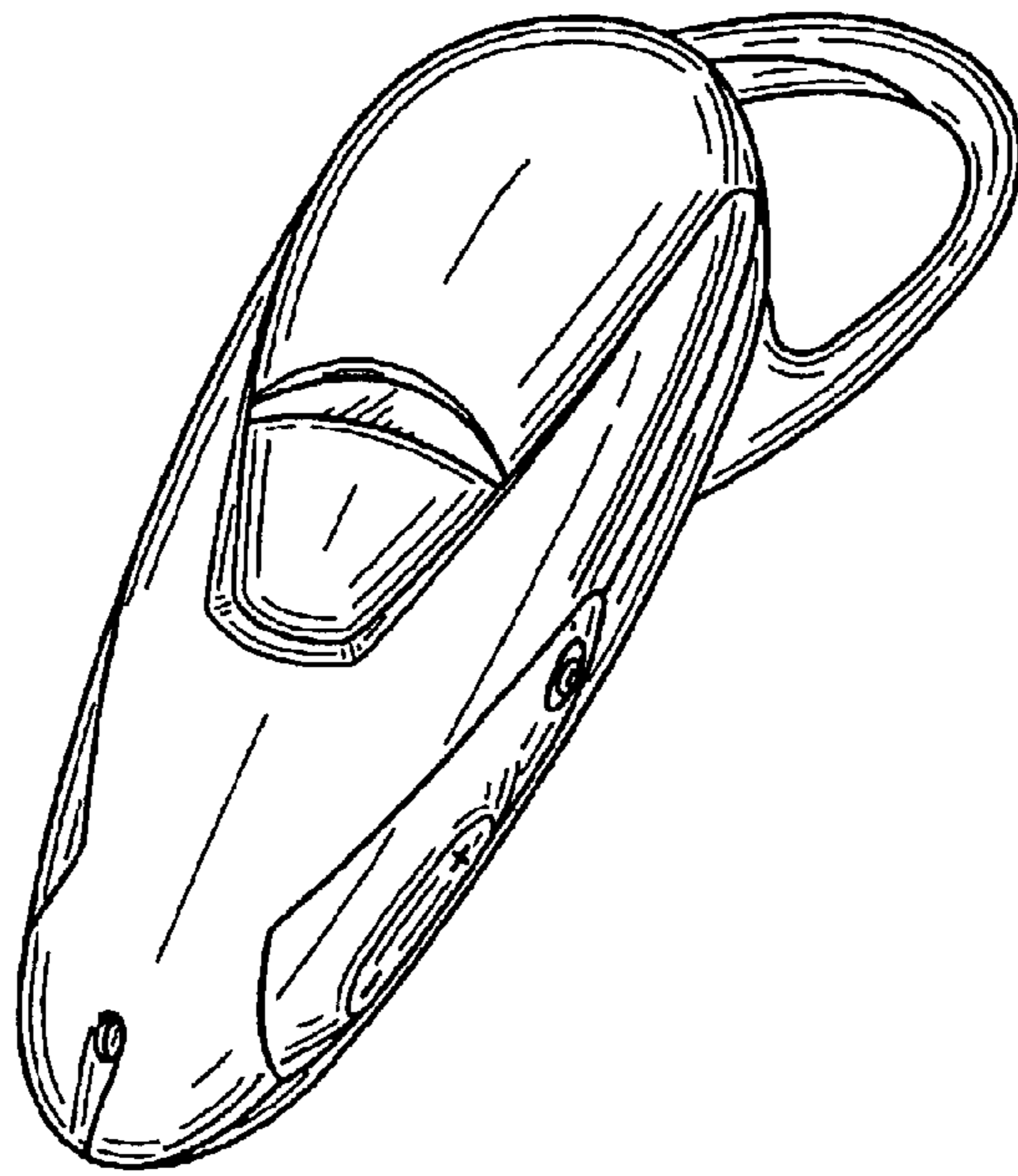

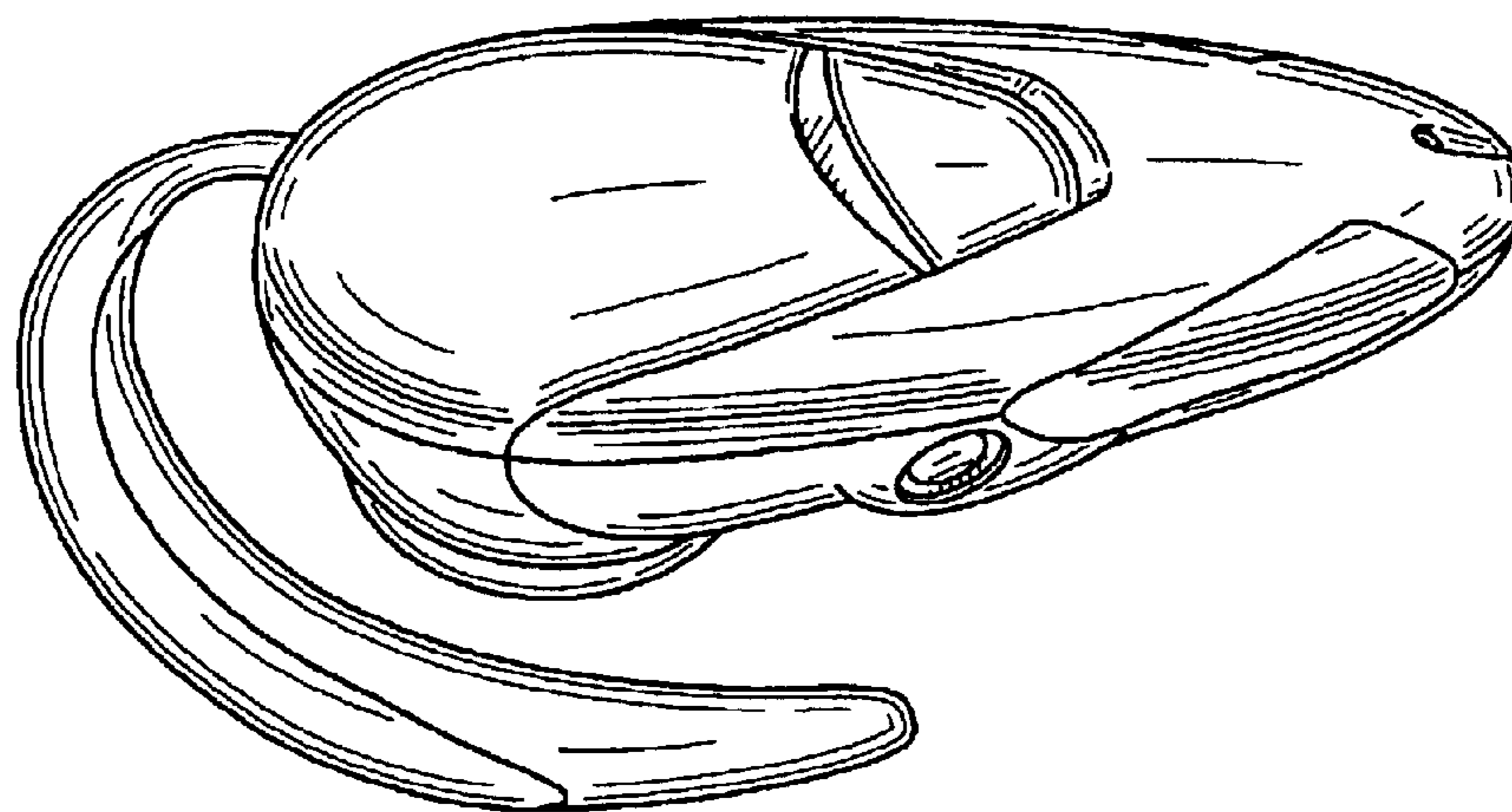

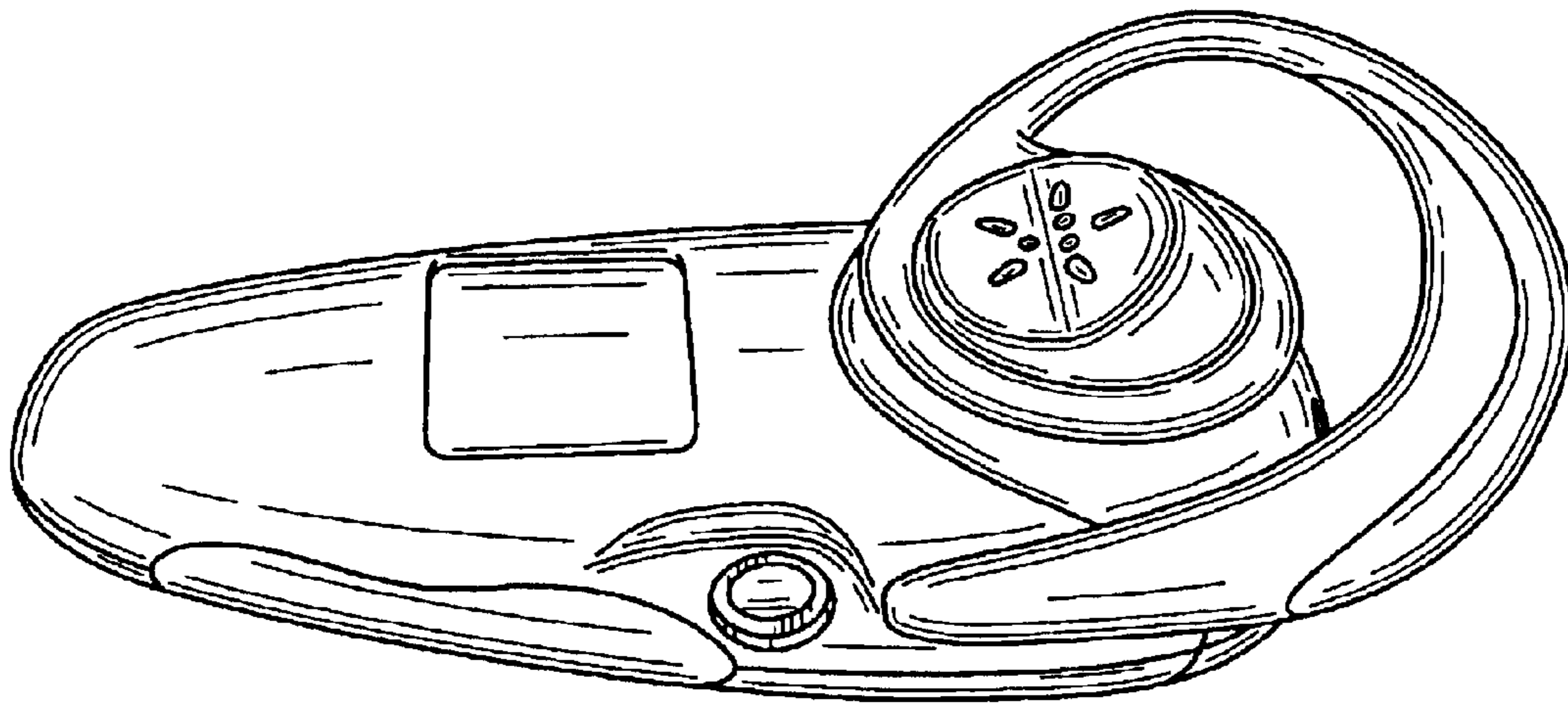

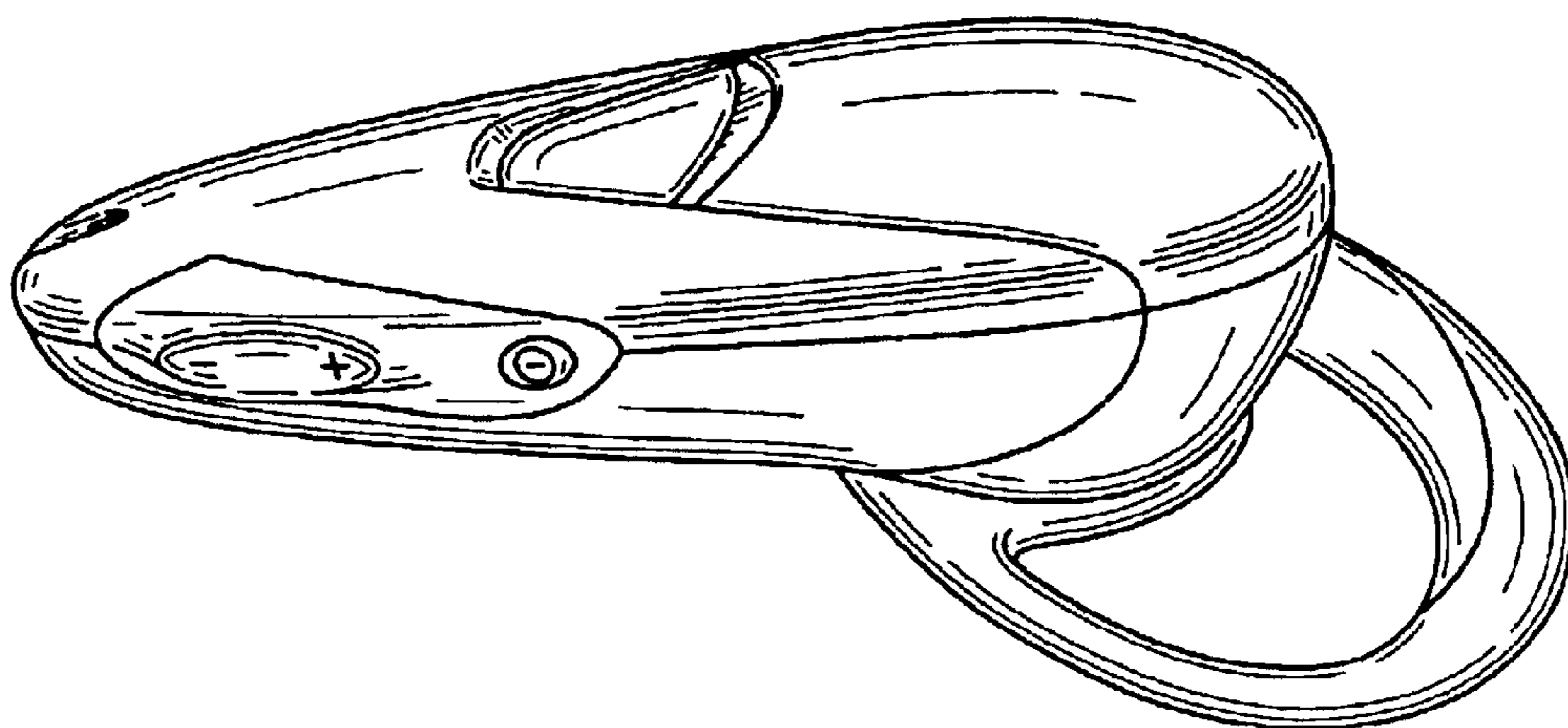

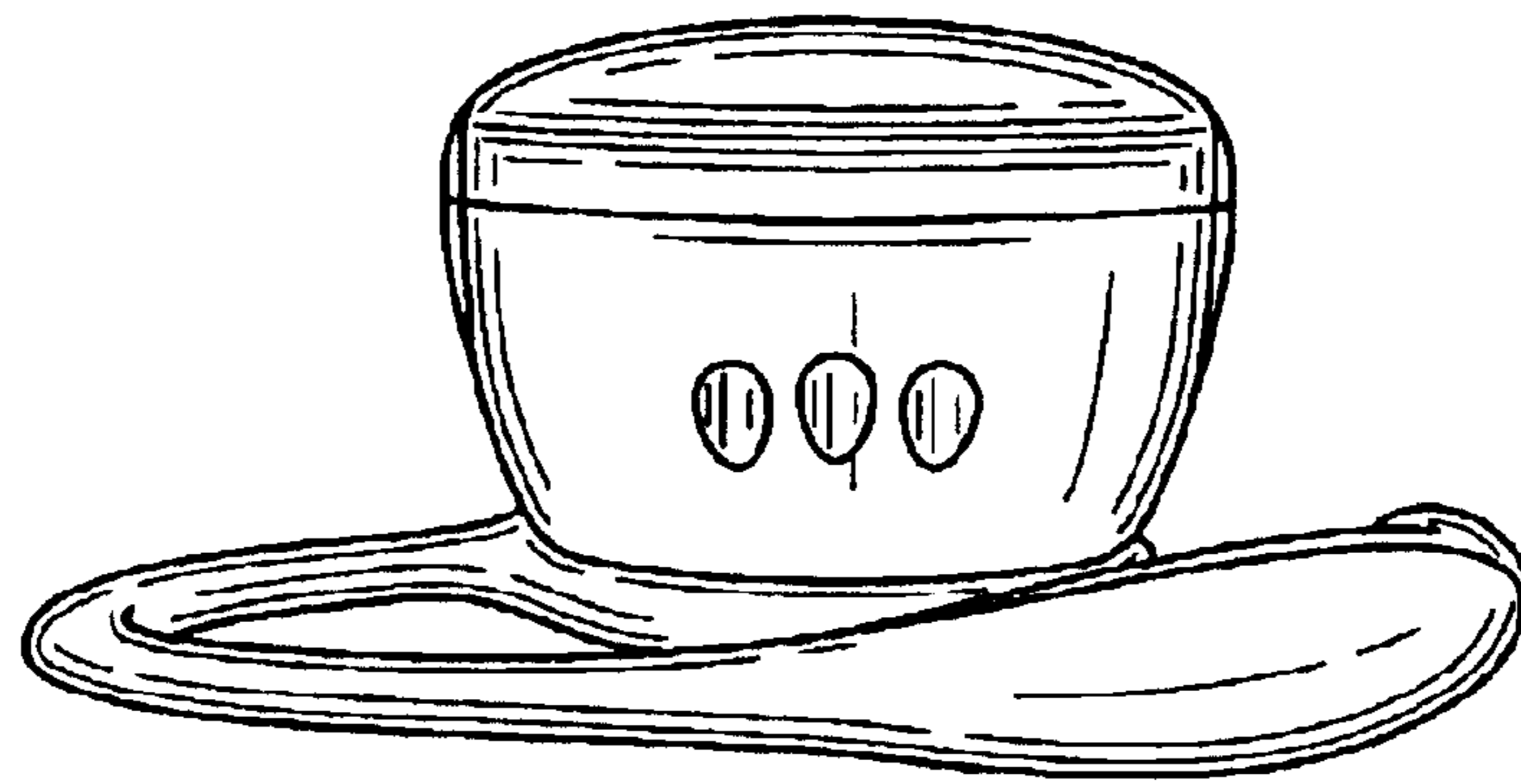

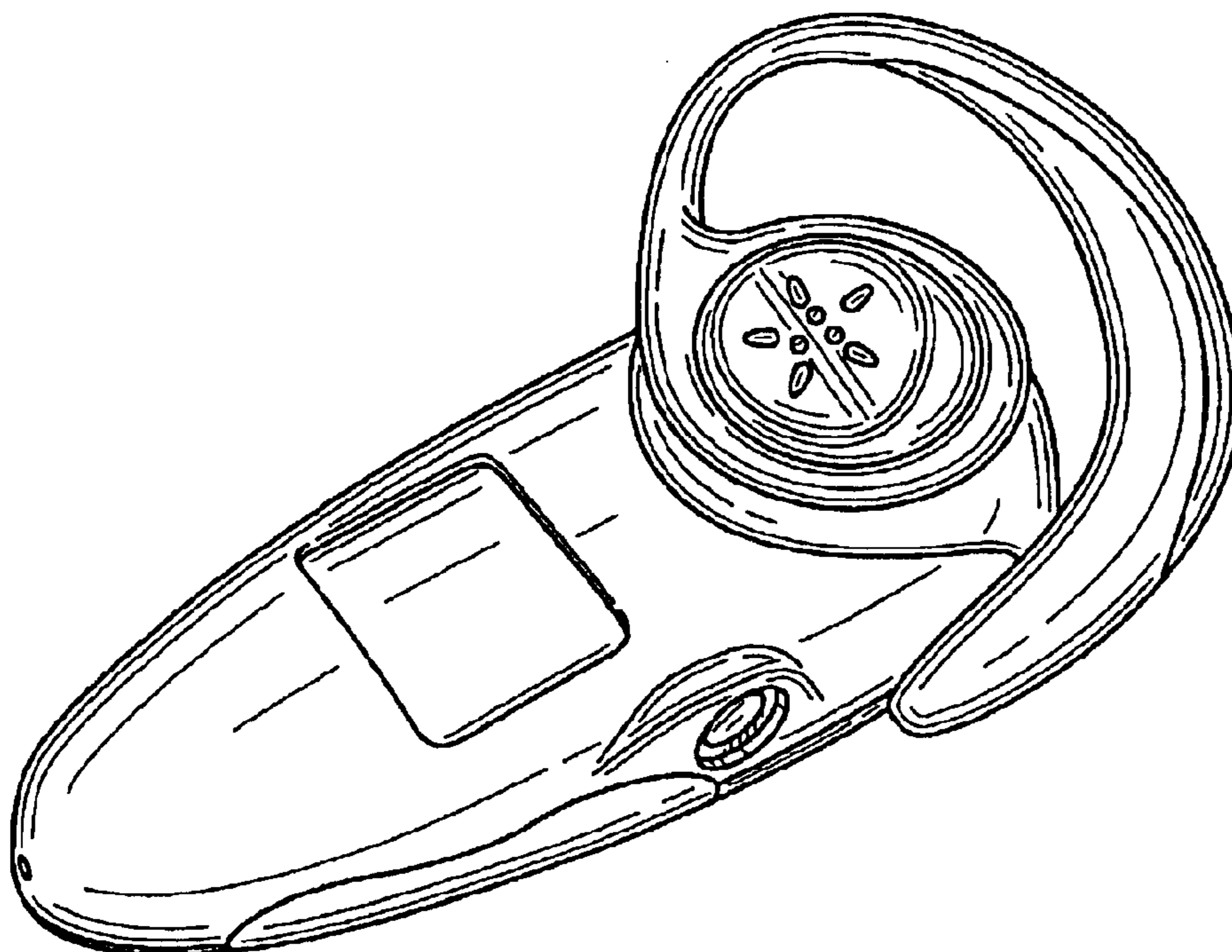
