(57) **CLAIM**

The ornamental design for an adhesively mountable headwear protective device, as shown and described.

DESCRIPTION

FIG. 1 is a front elevated plan view of an adhesively mountable headwear protective device showing my new design;

FIG. 2 is a rear elevated view of the adhesively mountable headwear protective device;

FIG. 3 is a side elevated view of the adhesively mountable headwear protective device;

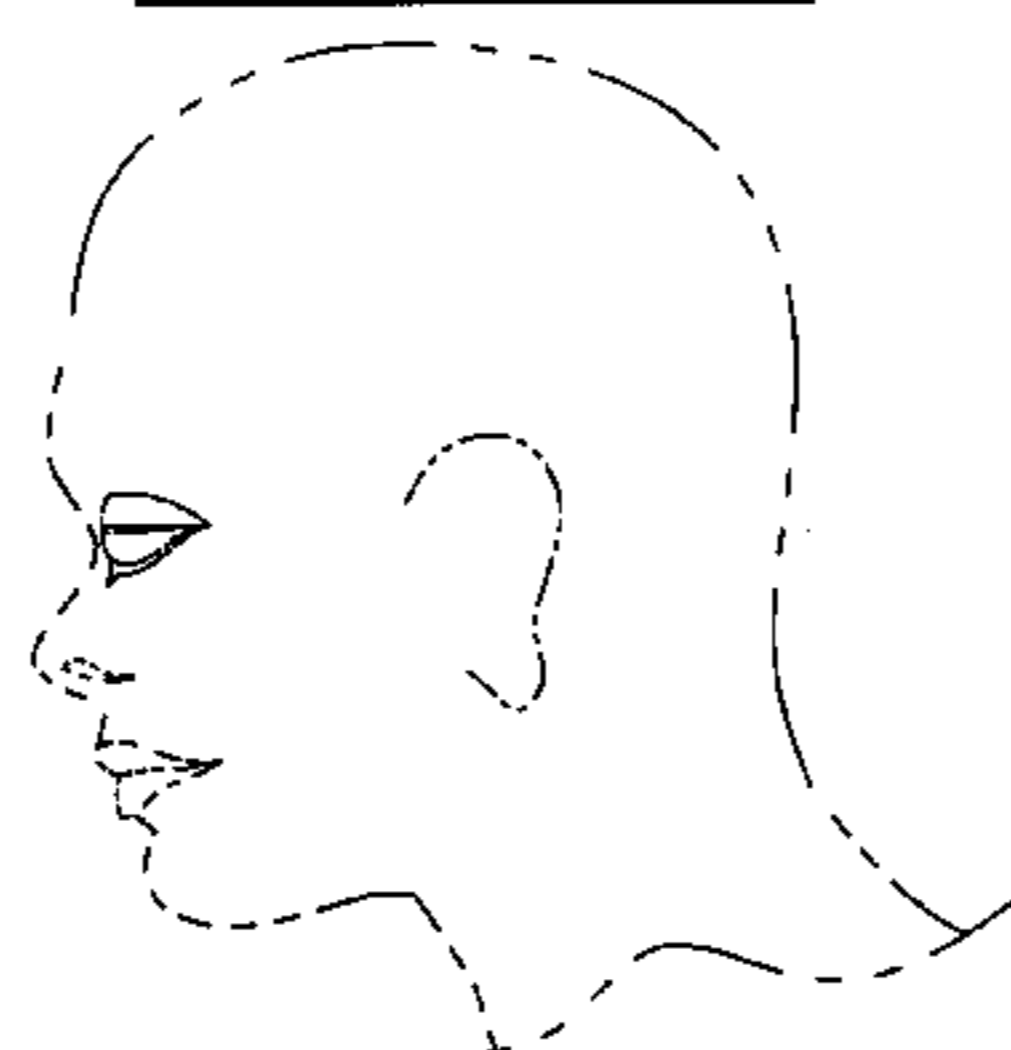
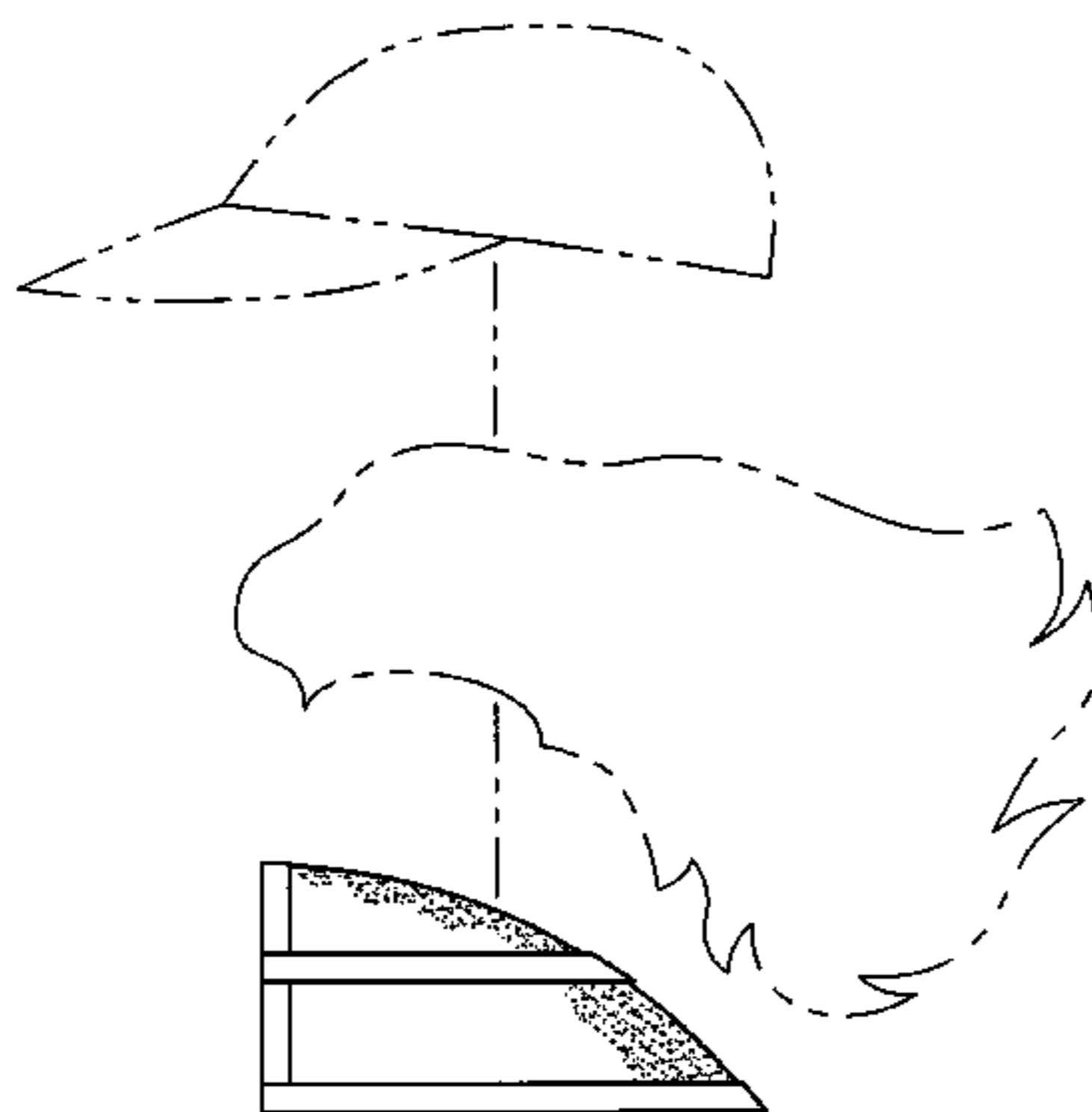
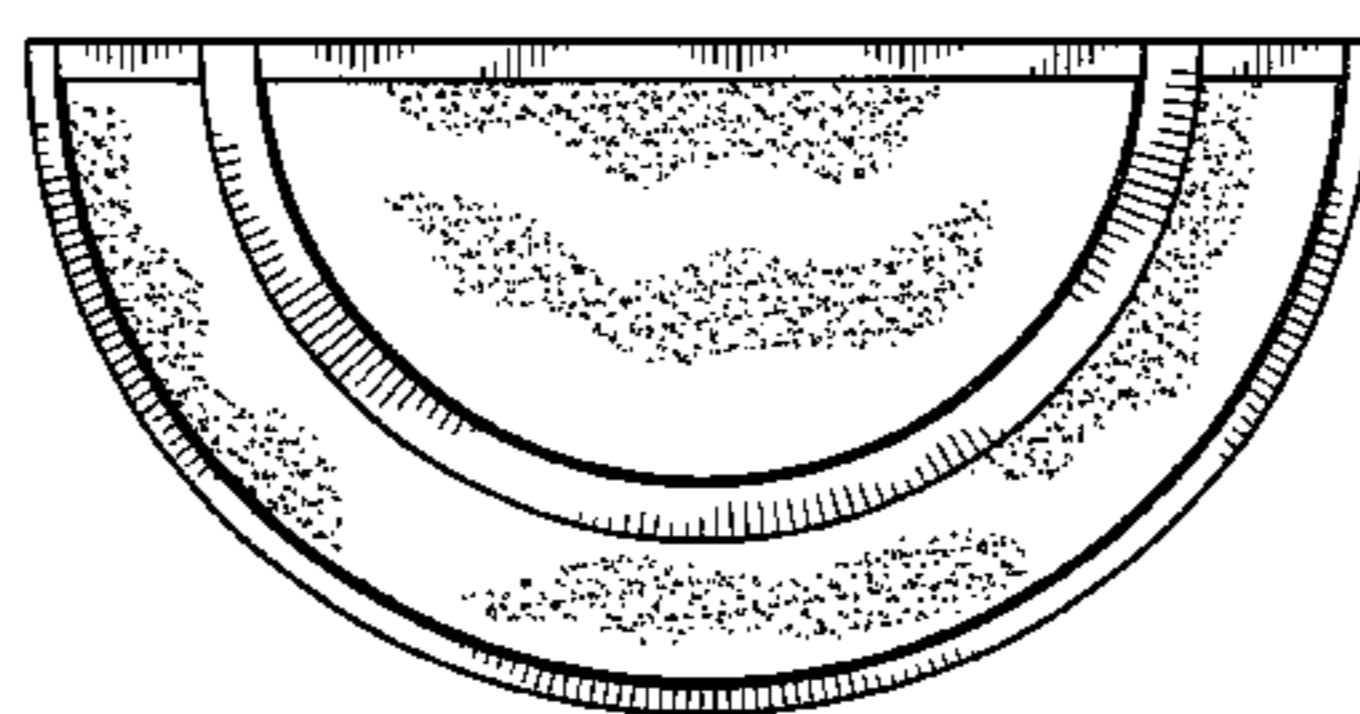
FIG. 4 is a top plan view of the adhesively mountable headwear protective device; and

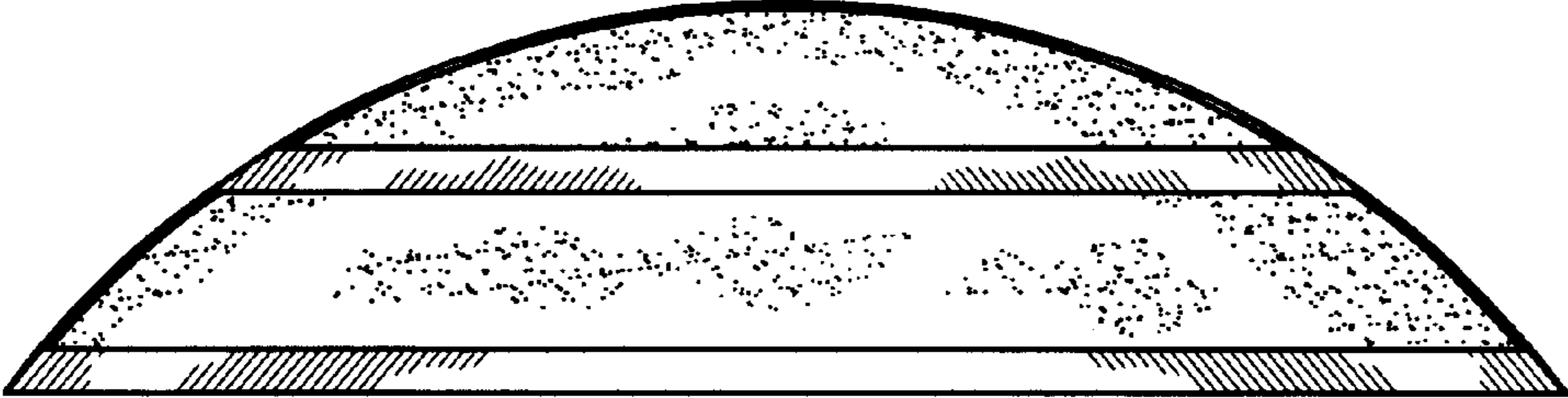

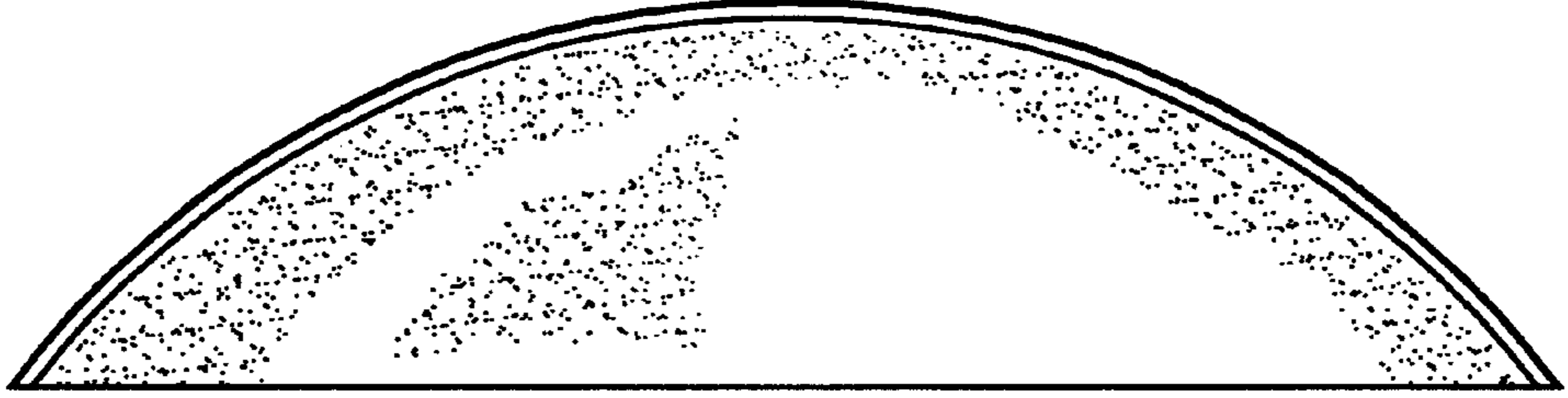

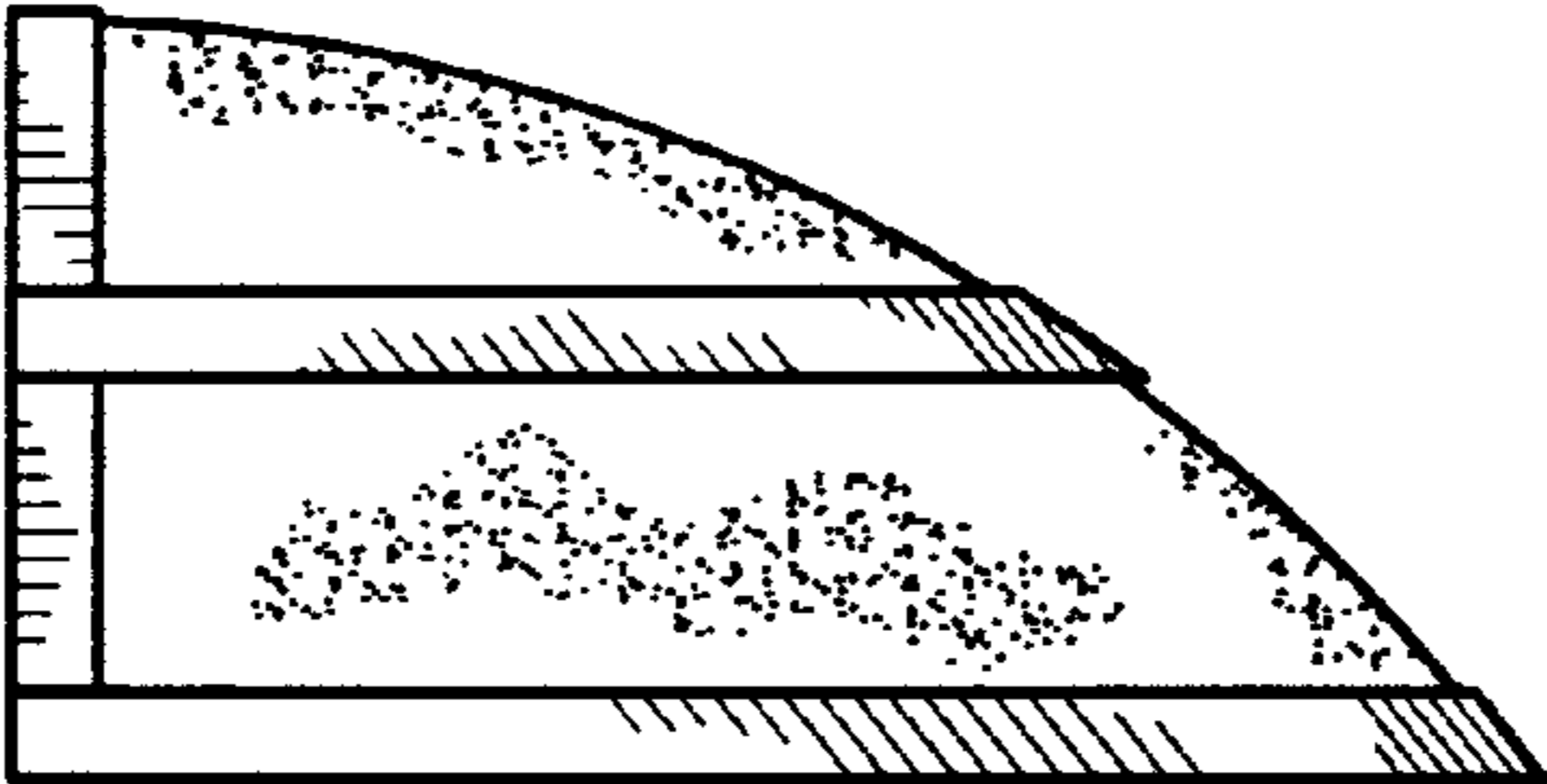

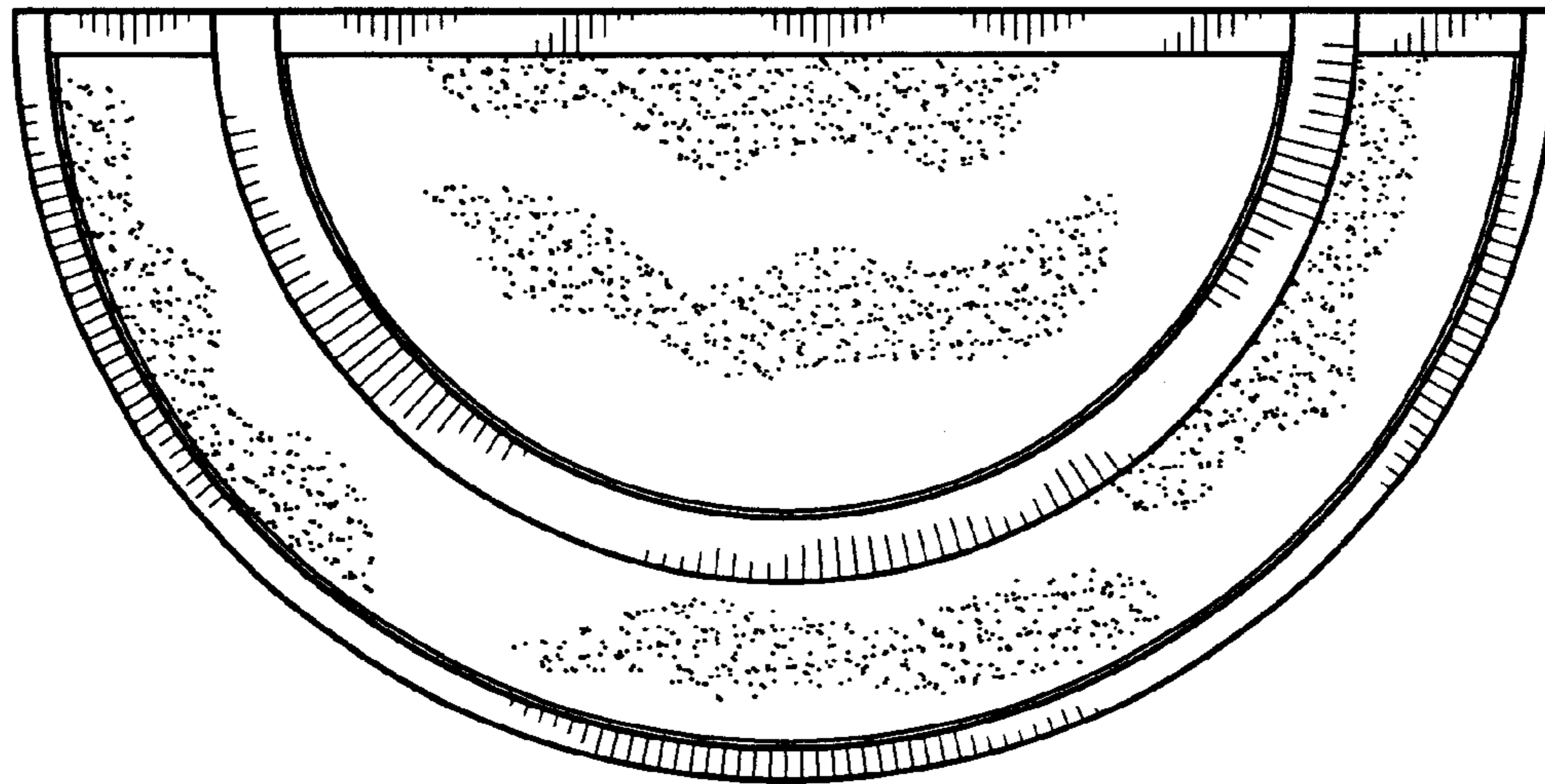

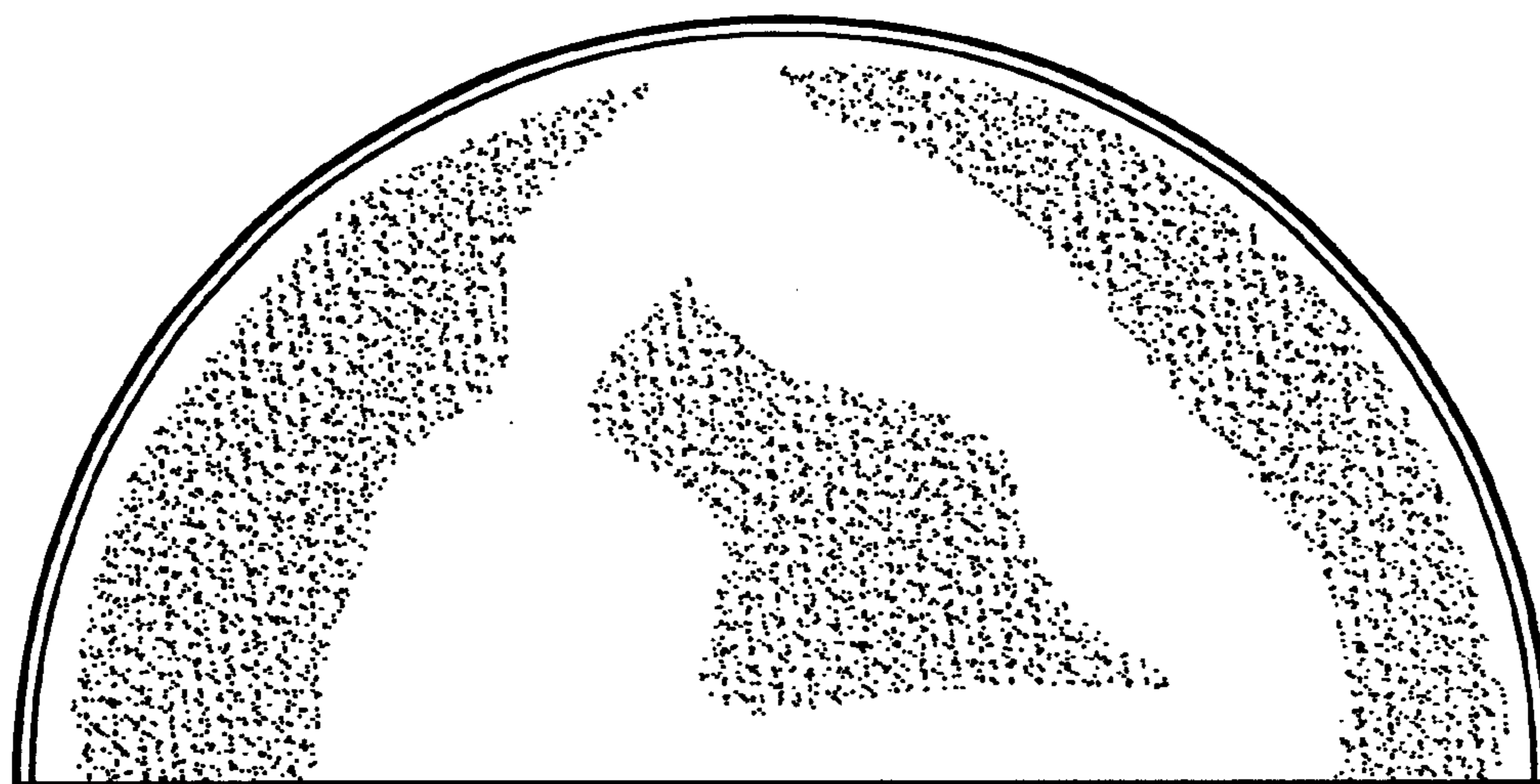

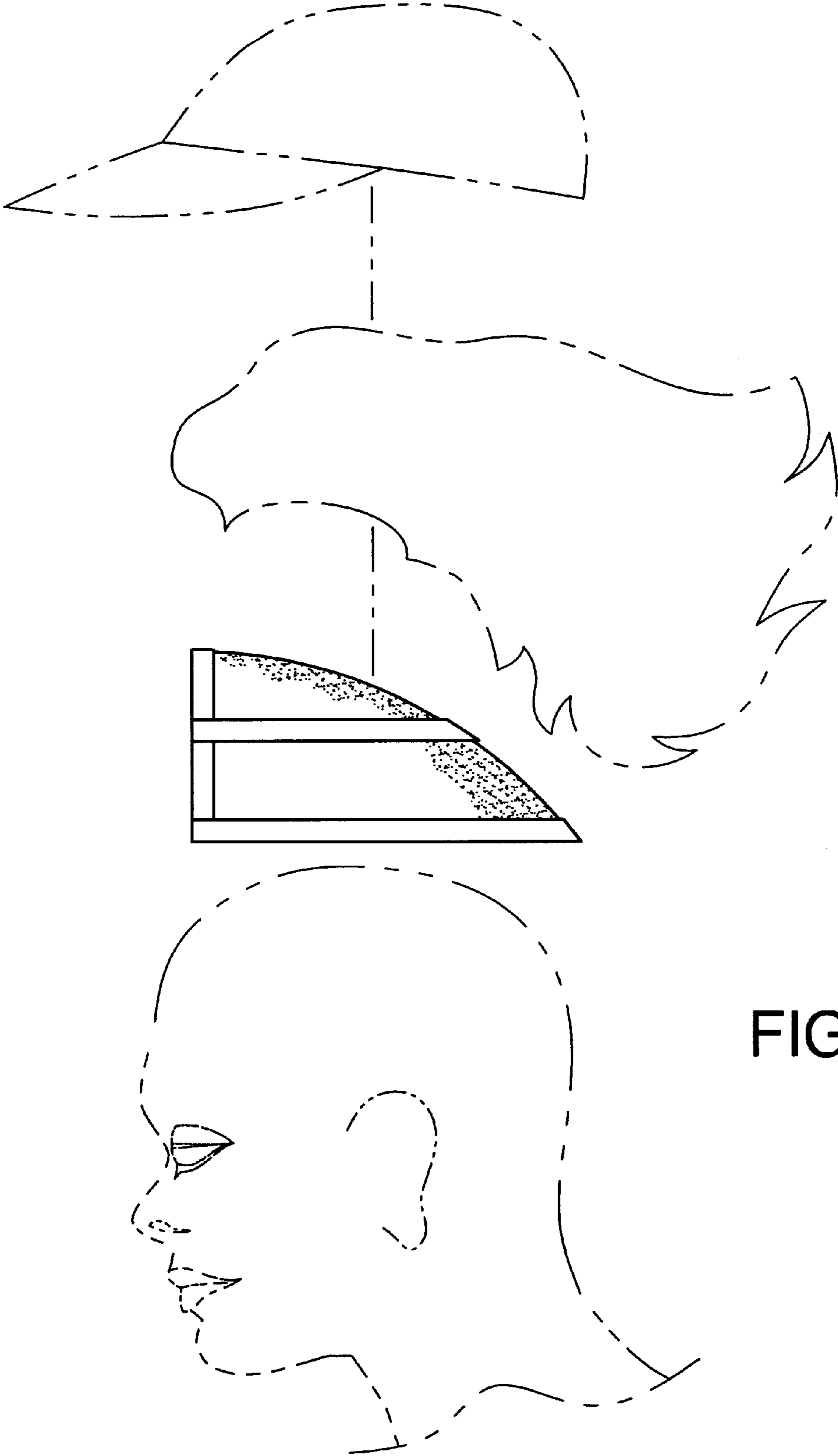
